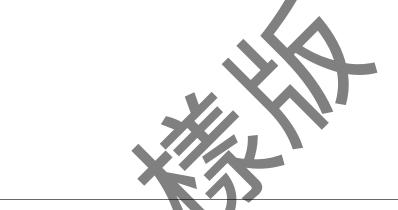

- 以證券持有人(包括香港結算代理人 如適用))的 名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司的證券持有人名册;
- 核實證券持有人身份;
- 確定本公司證券持有人的受益權利,例如股息、供股及紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據及證券持有人資料;
- 披露有關資料以便就權益提出申索;及
- 與上述者有關的任何其他附帶或相關用途及/或讓本公司及香港證券登記處能履行對證券持有人及/或監管機構承擔的責任及/或證券持有人不時同意的任何其他用途。

3. 轉交個人資料

本公司及香港證券登記處所持有關證券持有人的個人 資料將會保密,但本公司及香港證券登記處可在將資 料用作上述任何用途之必要情況下,向下列任何人士 披露,獲取或轉交(不論在香港境內或境外)有關個人 資料:

- 本公司委任的代理,例如財務顧問、收款銀行及海外股份過戶登記總處;
- (如證券申請人要求將證券存於中央結算系統) 香港 結算或香港結算代理人;彼等將會就中央結算系統 的運作使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務運作 有關的行政、電訊、電腦、付款或其他服務的任何 代理、承辦商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或政府部 門或法例、規則或法規所規定者;及
- 證券持有人與之有業務往來或擬有業務往來的任何 人士或機構、例如彼等的銀行、律師、會計師或股 票經紀等。

4. 個人資料的保留

本公司及香港證券登記處將按收集個人資料所需的用 途保留證券申請人及持有人的個人資料。無需保留的 個人資料將會根據條例銷毀或處理。

5. 查閲及更正個人資料

證券持有人有權確定本公司或香港證券登記處是否持 有其個人資料,並有權索取有關資料的副本並更正任 何不準確資料。本公司及香港證券登記處有權就處理 任何查閱資料的要求收取合理費用。
