- 6. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of corporation, must be either under its common seal or under the hand of an officer or attorney duly authorised.
- 7. If more than one of the joint holders be present at the meeting personally or by proxy, that one of the said persons so present whose names stands first on the register in respect of the relevant shares shall also be entitled to vote in respect thereof.
- 8. To be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority, must be deposited at the registered office of the Company of Suite 4901, 49th Floor, Office Tower, Convention Plaza, I Harbour Road, Wanchai, Hong Kong not less than 48 hours before the time for holding the meeting or adjourned meeting (as the case may be).
- 9. Completion and deposit of the form of proxy will not preclude you from attending and voting at the meeting if you so wish.
