If the Issuer becomes insolvent or defaults on its obligations under the warrants or the Guarantor becomes insolvent or defaults on its obligations under the guarantee, investors may not be able to recover all or even part of the amount due.

An application will be made to the stock exchange for the listing of and permission to deal in, the warrants on the stock exchange. The date of commencement of dealings in the warrants is expected to be 30 April 2014.

The Issuer is not regulated by any of the bodies referred to in rule 15A.13(2) or (3) of the stock exchange rules.
