Sino Resources Group Limited (carrying on business in Hong Kong as Sino Gp Limited) (stock code: 223) is principally engaged in investing and developing unconventional gas business, coal and metals trading business and provision of agency services and trading of commodities.

The Group has been managing the following businesses:

UNCONVENTIONAL GAS BUSINESS

During the year, The Heilongjiang Development and Reform Commission (“HDRC”) has already approved the project for the cooperation between Multi Century Energy Technology (Beijing) Limited (“MCT (BJ)”) and Coalfield Geology Reconnaissance Design and Research Institute of Heilongjiang Province (“HCI”) to set up a project to demonstrate the technology of the two sets of imported equipment (“Equipment”) for the CBM stimulation work in the cities of Hegang (鶴崗), Jixi (雞西) and Yilan (依蘭) (the “Project”). The Project allow MCT (BJ) to get tax exemption on import duties, however, the import VAT only can be used to set off the output VAT on sales in future. The Equipment will ship to Heilongjiang for demonstration and testing in the third quarter of 2014.

神州資源集團有限公司 (以Sino Gp Limited名稱在香港經營業務) (股票編號：223) 之主要業務乃投資及發展非常規天然氣業務、煤炭與金屬買賣業務及提供代理服務與買賣商品。

本集團管理以下之業務：

非常規天然氣業務

於本年度，黑龍江省發展和改革委員會 (「黑龍江發改委」) 已經批准創紀傑仕能源科技 (北京) 有限公司 (「創紀傑仕 (北京)」) 與黑龍江省煤田地質勘察設計研究院 (「黑煤院」) 合作成立一個項目，以就煤層氣增產改造工程於鶴崗市、雞西市及依蘭市進行兩組進口設備 (「該設備」) 技術示範 (「該項目」)。該項目讓創紀傑仕 (北京) 獲得進口關稅之稅項豁免，然而，進口增值稅部份只可留作抵扣未來銷售之銷項增值稅。該設備將於二零一四年第三季度運到黑龍江，以進行演示及測試。

COAL AND METALS TRADING BUSINESS

The Group has been conducting coal and metals trading business in the PRC.

During the year ended 31 March 2014, the coal inventory of power plants, cement plants and ports in China has maintained relatively high level. The price of coal in China dropped slightly and demand for coal remained weak. Thus management continued to take a more cautious and conservative approach towards sales orders of coal trading.

Heilongjiang Derong Coal Industrial Co., Ltd (“Derong”) an indirect non-wholly owned subsidiary of the Company has been involved in two civil claims since March 2013 and Derong’s bank account has been frozen due to court orders. Since the civil claims against Derong remain unresolved and shall continue incurring financials and legal costs. The trading business for Derong has been affected and the profit guarantee cannot be achieved for year ended 31 December 2013. The Company disposed Wealthy Wing Limited including its subsidiaries, Western Spark Limited and Derong on 31 March 2014 (the “Disposal”). The Disposal can reduce the financial burden and the number of litigations concerning the Group. After the Disposal, the Group only focuses coal trading business on Zhan Sheng Investments Limited and its subsidiaries (“Zhan Sheng Group”). The Disposal shall enable the Group to reallocate and concentrate its internal resources to one single coal trading platform, which shall enhance the Group’s overall cost effectiveness and management efficiency. Please refer to Note 40 for details of the Disposal.

On 11 December 2013, the Company and the vendor, Advanced Elation Holdings Limited (the “Vendor”), Mr. Fung Denny Kin Tak, Ms. Wang Hui and Mr. Lai Kin Kong have entered into the fifth supplemental agreement (the “Fifth Supplemental Agreement”) to amend certain terms and conditions of the sale and purchase agreement on 31 August 2012 in respect of the acquisition of Zhan Sheng Group. Under the Fifth Supplemental Agreement, there are amendments on consideration, payment method and extension of the profit guarantee period. The EGM has been passed all related resolutions on 14 February 2014 and the Fifth Supplemental Agreement was become effective on 21 February 2014. Please refer to Note 22 for the details of the terms under the Fifth Supplemental Agreement.

The Board is of the view that the new terms under the Fifth Supplemental Agreement shall provide more incentives to the Vendor to contribute to Zhan Sheng Group’s business developments in order to be released of the total escrow shares, on the bases that: (i) the new issue price of HK\$0.139 for the total escrow shares is more comparable to the recent share price performance of the Company than the previous issue price of HK\$0.30, the cost per share is thus more reasonable from the Vendor’s point of view; (ii) the new consideration adjustments are more realistic and achievable; and (iii) the new business model involving diversification of the Zhan Sheng Group’s business scope and geographical coverage shall provide large room for business referral by the Vendor.

煤炭與金屬買賣業務

本集團在中國從事煤炭與金屬買賣業務。

於截至二零一四年三月三十一日止年度，中國發電廠、水泥廠及港口之煤炭儲量均維持於相對較高的水平。中國煤炭價格輕微下跌，需求仍然疲弱。因此，管理層在煤炭買賣的銷售訂單方面繼續採取較審慎及保守的方針。

本公司之間接非全資附屬公司黑龍江德融煤業有限公司（「德融」）自二零一三年三月起涉及兩項民事索償，而德融之銀行賬目已因法院頒令被凍結。由於德融煤業之民事索償仍未解決，並將繼續產生財務及法律費用。德融之貿易業務備受影響，截至二零一三年十二月三十一日止年度之溢利保證不能達到。本公司於二零一四年三月三十一日已出售富永有限公司（包括其附屬公司西星投資有限公司及德融）（「出售事項」）。出售事項可減輕本集團之財務負擔及減少本集團所涉及之訴訟案件數目。出售事項後，本集團只集中其煤炭買賣業務至展昇投資有限公司及其附屬公司（「展昇集團」）。出售事項將有助本集團重新分配及集中內部資源至一項單一煤炭買賣平台，從而加強本集團之整體成本效益及管理效能。有關出售事項之詳情，請參閱附註40。

於二零一三年十二月十一日，本公司與賣方Advanced Elation Holdings Limited（「賣方」）、馮建德先生、王輝女士及黎建江先生已訂立第五份補充協議（「第五份補充協議」），藉以修訂日期為二零一二年八月三十一日有關收購展昇集團之買賣協議之若干條款及條件。第五份補充協議主要修訂對價、支付方式及延長利潤擔保期。股東特別大會已於二零一四年二月十四日通過了所有有關決議案，而第五份補充協議亦於二零一四年二月二十一日生效。有關第五份補充協議條款之詳情，請參閱附註22。

董事會認為，第五份補充協議之新條款將更有力促使賣方為展昇集團之業務發展作貢獻，以發放總託管股份，理由為：(i)總託管股份之新發行價0.139港元相比先前之發行價0.30港元更接近本公司最近之股價表現，因此賣方認為每股成本更為合理；(ii)新對價調整更切合實際及更易達成；及(iii)涉及多元化展昇集團業務範圍及覆蓋地區之新業務模式將為賣方轉介業務提供更大大空間。

Chairman's Statement

主席報告

Dear Valued Shareholders,

On behalf of the Board, I am delighted to report the Group's audited annual results for the financial year ended 31 March 2014.

BUSINESS REVIEW

During the year under review, the Group has achieved a breakthrough in its unconventional gas business development by cooperating with American Professional Company, the world's largest oilfield services company. On 6 March 2014, the Group's subsidiary and American Professional Company entered into a letter of intent in relation to a strategic cooperation in coalbed methane ("CBM") exploration and developments. Since 2014, the American Professional Company has already conducted several meetings and visits to the Group's CBM operations and provided professional technological supports to the management team. In addition, the management team also conducted site visits to certain PRC CBM projects operated by PetroChina and Sany Heavy Industry to order to enhance the team's practical knowledge in operating CBM projects.

For the coal and metals trading business, as disclosed in the Company's circular dated 28 January 2014, the Group (through its trading arm, Zhan Sheng Investments Limited and its subsidiaries) has adopted a new business model which will extend its limited coal trading business to a diversified and cross-border resources trading business. On 31 March 2014, the Group completed the disposal of another trading arm, Wealthy Wing Limited and its subsidiaries, having considered the underperformance and litigations associated with the disposed companies. Through these transactions, the Group has successfully streamlined its coal trading business, redirected its resources to trading businesses with higher growth potentials and diversified the business horizon of its trading segment.

In the fourth quarter of 2013, the Company completed the acquisition of 30% equity interest in Global Mining Engineer Inc., through which the Group has set foot in the new business segment concerning mine management system and natural resources related global sources direct services. The Group has achieved diversification of business and revenue source following the completion of this transaction.

FUTURE DEVELOPMENTS

For the continuous development of its unconventional gas business, the Group has planned to perform geological research and construction work on the site located in Hegang, which shall include confirmation of well locations, formulation of well drilling plans and other preparation work for exploration in the next stage. The Board expects that the Group's unconventional gas business shall achieve steady growth and shall be able to make more contributions to the Group's success in the foreseeable future.

The Group's other existing businesses, including coal and metals trading and mine management system, is expected to continue generating steady income and serving as a stable platform for further business growth of the Group. The Board shall capture any profitable business opportunities to maintain the sustainable growth of the Group's existing businesses.

尊敬的各位股東：

本人謹代表董事會高興地報告本集團截至二零一四年三月三十一日止財政年度之經審核年度業績。

業務回顧

於回顧年度內，本集團透過與美國專業公司（世界上最大的油田服務公司）合作，已於其非常規天然氣業務發展方面取得了突破。於二零一四年三月六日，本集團之附屬公司與美國專業公司訂立意向書，內容有關於煤層氣（「煤層氣」）勘探及開發之戰略合作。自二零一四年以來，美國專業公司已進行了多次會議，並參觀本集團煤層氣業務，並為管理團隊提供專業技術支援。此外，管理團隊亦實地考察中國石油及三一重工所營運之若干中國煤層氣項目，以增強團隊經營煤層氣項目的實用知識。

於煤炭及金屬買賣業務方面，誠如本公司日期為二零一四年一月二十八日之通函所披露，本集團（透過其貿易部門展昇投資有限公司及其附屬公司）已採用新的業務模式，此舉將把其有限之煤炭買賣業務擴展至多元化及跨境資源買賣業務。於二零一四年三月三十一日，本集團在考慮富永有限公司及其附屬公司之欠佳表現及相關訴訟後，完成出售另一貿易部門富永有限公司及其附屬公司。透過此等交易，本集團已成功精簡其煤炭買賣業務，將其資源重新導向具較高增長潛力之貿易業務，並多元化貿易分部之業務領域。

於二零一三年第四季度，本公司完成收購Global Mining Engineer Inc.之30%股權，據此，本集團已涉足有關礦山管理系統及天然資源相關環球通服務的新業務分部。本集團於是項交易完成後已實現業務及收入來源之多元化。

未來發展

為持續發展非常規天然氣業務，本集團已計劃在位於鶴崗之場地進行地質研究及建築工作，其中將包括確認井位、制定鑽井計劃及前期準備工作，以於下一階段進行勘探。董事會預期，本集團的非常規天然氣業務將實現穩定增長，應能對本集團在可預見將來之成功作出更大貢獻。

預期本集團其他現有業務（包括煤炭與金屬買賣及礦山管理系統）繼續帶來穩定收入，並作為本集團業務進一步增長之穩定平台。董事會應把握任何有利可圖的商機，以維持本集團現有業務之可持續增長。

Apart from internal business growth, the management team of the Group has endeavored to explore suitable acquisition targets in the market and there are several on-going transactions which are under active negotiation. The possible acquisition of hydropower business located in Qinghai Province has proceeded to the due diligence phase, the prospective due diligence results shall provide a solid basis to intensify negotiation between the parties.

On the other hand, the proposed acquisition of coal mining business in Mongolia as announced on 28 March 2014 is approaching to completion, which is currently expected to take place by the end of July 2014 pending finalization of due diligence review. As disclosed previously, the target company has entered into separate memorandums of understanding with the Group's two major subsidiaries for cooperation in coal trading and mine management. The Board believes that the proposed acquisition shall realize the vertical integration of the Group's business into upstream mining segment and create synergies among the Group's existing businesses.

The Company has also entered into a memorandum of understanding on 10 April 2014 for the possible acquisition of iron ore refining business located in Qinhuangdao City of Hebei Province, and has maintained close liaison with the vendor in order to materialize the terms and conditions of the sale and purchase agreement. The Board believes that if the possible acquisition is materialized, the introduction of iron ore refining business to the Group's portfolio shall diversify the revenue sources and enhance the overall profitability of the Group.

OUTLOOK

Looking ahead, in view of the challenging business environment, the Group will continue diversifying its business by pursuing inorganic growth strategy and seeking attractive investment opportunities with growth potentials, whilst it will also focus on cultivating its existing businesses at the same time. The Board will continue their efforts in developing the Group's business and maximizing the shareholders' return in the forthcoming year.

On behalf of the Board, I would like to take this opportunity to express our most sincere gratitude for the continuous supports from our shareholders, business partners as well as our dedicated management team and staff.

除了內部業務增長，本集團之管理團隊努力在市場上探索合適的收購目標，有若干正在積極商談之進行中交易。可能收購位於青海省之水電業務已進入盡職審查階段，前瞻性的盡職審查結果將為深化雙方之間的磋商提供堅實的基礎。


本公司亦於二零一四年四月十日訂立諒解備忘錄，內容有關可能收購位於河北省秦皇島市之鐵礦石提煉業務，並於賣方保持密切聯繫，以落實買賣協議之條款及條件。董事會相信，倘可能收購事項得以落實，為本集團之投資組合引進鐵礦石提煉業務將多元化本集團之收入來源及提升本集團的整體盈利能力。

展望

Management Discussion and Analysis

管理層討論及分析

BUSINESS REVIEW

Sino Resources Group Limited (the “Company”, together with its subsidiaries, the “Group”) will continue to focus its business on the resources and energy related sector.

1. COAL AND METALS TRADING BUSINESS

In 2013, China’s GDP growth rate went down, growth in coal consumption slowdown, downstream inventory continued to remain high, while coal price in the market was at low level, and there was an oversupply in the overall domestic coal market. Facing a declining coal trading market, management has taken a more cautious and conservative approach towards sales orders of coal trading.

2. DISPOSAL OF WEALTHY WING GROUP

The Company acquired the entire issued share capital of Wealthy Wing Limited and its subsidiaries including Western Spark Investments Limited and Derong in November 2011 (the “Wealthy Wing Group”).

Derong has been involved in two civil claims since March 2013 and Derong’s bank account has been frozen due to PRC court orders. The three years profit guarantee was not able to achieve due to downturn of the coal trading business in China and the litigation affects the cashflow of Derong. Based on arm’s length negotiation on normal commercial terms between the Company and Mr. Zheng Xue Feng (“Mr. Zheng”), director of Wealthy Wing Group, the Company completed the disposal of the Wealthy Wing Group to Mr. Zheng on 31 March 2014. The disposal will reduce the financial burden and the number of litigations concerning the Group and shall not impose any material impact on the Group’s overall operational and financial performances whilst it shall benefit the Group with the above-mentioned merits. Despite the disposal, the Company will continue developing its coal trading business through its other subsidiaries.

業務回顧

神州資源集團有限公司(「本公司」，連同其附屬公司統稱「本集團」)將繼續專注其資源及能源相關業務。

1. 煤炭與金屬買賣業務

於二零一三年，中國國內生產總值之增速下降，煤炭消費增長放緩，下游庫存繼續維持高企，而市場煤炭價格處於較低水平，國內整體煤炭市場供過於求。面對煤炭交易市場衰退，管理層已對煤炭買賣之銷售訂單採取較為審慎及保守之態度。

2. 出售富永集團

本公司於二零一一年十一月收購富永有限公司及其附屬公司(包括西星投資有限公司及德融)(「富永集團」)之全部已發行股本。

德融自二零一三年三月以來已涉及兩項民事申索，而德融之銀行賬號因中國法院命令已被凍結。由於中國煤炭貿易業務衰退及訴訟影響德融之現金流，三年溢利保證未能達到。根據本公司與富永集團董事鄭雪峰先生(「鄭先生」)按一般商業條款進行之公平磋商，本公司於二零一四年三月三十一日完成出售富永集團予鄭先生。出售事項將減輕本集團之財務負擔及減少本集團所涉及之訴訟案件數目，且不會對本集團之整體營運及財務表現產生任何重大影響，而出售事項按上述標準將令本集團受益。儘管出售事項，本公司將透過其他附屬公司繼續發展其煤炭買賣業務。

3. PROFIT GUARANTEE UNDER ZHAN SHENG ACQUISITION

With reference to the announcement of the Company dated 31 March 2012, for the acquisition of the Zhan Sheng Investments Limited and its subsidiaries (“Zhan Sheng Acquisition”), the vendor undertakes and guarantees to the Company that (i) the audited distributed profit (the “First Year Distributable Profit”) after tax of Hubei Tiegang for the period commencing from the Completion date (i.e 31 August 2012) up to 31 December 2012 (the “First Year”) prepared in accordance with IFRS will not be less than RMB9 million (the “First Year Consideration Adjustment”); (ii) the audited distributable profits (the “Second Year Distributable Profit”) after tax of Hubei Tiegang for the period commencing from 1 January 2013 to 31 December 2013 (the “Second Year”) prepared in accordance with the IFRS will not be less than RMB16 million (the “Second Year Consideration Adjustment”); and (iii) the audited distributable profits (the “Third Year Distributable Profit”) after tax of Hubei Tiegang for the period commencing from 1 January 2014 to 31 December 2014 (the “Third Year”) prepared in accordance with the IFRS will not be less than RMB23 million (the “Third Year Consideration Adjustment”). The distribution of consideration shares issued under the Zhan Sheng Acquisition is subject to a consideration adjustment (“Tiegang’s Consideration Adjustment”) mechanism based on Hubei Tiegang’s results throughout the three years ending 2014. Based on the audited accounts of Hubei Tiegang, the Second Year profit was RMB124,000 which was far below the Second Year guaranteed by vendor. Accordingly, no consideration shares will be delivered to the vendor for the Second Year.

On 11 December 2013, the Company and the vendor entered into the Fifth Supplemental Agreement. Pursuant to the Fifth Supplemental Agreement, the vendor undertakes and guarantee to the Company that the net gross profit of the Zhang Sheng Group recorded in the management accounts in accordance with IFRS for the period 1 January 2014 to 31 December 2014 (“Year 2014”) will not be less than HK\$10,000,000 and for the period 1 January 2015 to 31 December 2015 (“Year 2015”) will not be less than HK\$10,000,000 respectively. Details please refer to circular dated on 28 January 2014 and the Note 22.

4. UNCONVENTIONAL GAS BUSINESS

During the year, MCT(BJ) cooperate with HCl to set up a project for the “煤層氣特殊儲存增產改造示範項目” (the “Project”) has been approved by HDRC. According to the Project, MCT (BJ) also received the approval from HDRC to enjoy the tax benefit on tax exemption on Customs duties and the import VAT can be used to set off the sales input VAT in future. MCT(BJ) also signed a memorandum with American Professional Company for the cooperation on the development of unconventional gas exploration in China. The American Professional Company can provide solution for MCT(BJ) on the CBM drilling and exploration. MCT(BJ) will deliver the equipment to Shanxi for testing the whole set of the equipment (“Equipment”) on the stimulation work in July 2014. The Company believes that the Equipment could be in full operation in the second half of the 2014.

3. 展昇收購事項之利潤擔保

茲提述本公司日期為二零一二年三月三十一日之公佈，就收購展昇投資有限公司及其附屬公司（「展昇收購事項」）而言，賣方向本公司承諾及保證：(i)湖北鐵港於完成日期（即二零一二年八月三十一日）起至二零一二年十二月三十一日止期間（「首年度」）按照國際財務報告準則編製之經審核除稅後可分配利潤（「首年可分配利潤」）將不少於人民幣9,000,000元（「首年代價調整」）；(ii)湖北鐵港於二零一三年一月一日起至二零一三年十二月三十一日止期間（「次年度」）按照國際財務報告準則編製之經審核除稅後可分配利潤（「次年可分配利潤」）將不少於人民幣16,000,000元（「次年代價調整」）；及(iii)湖北鐵港於二零一四年一月一日起至二零一四年十二月三十一日止期間（「第三年度」）按照國際財務報告準則編製之經審核除稅後可分配利潤（「第三年可分配利潤」）將不少於人民幣23,000,000元（「第三年代價調整」）。根據展昇收購事項所發行代價股份之分配須受一項代價調整（「鐵港之代價調整」）機制所規限，該機制基於湖北鐵港於截至二零一四年止三個年度之業績。根據湖北鐵港之經審核賬目，第二年度溢利為人民幣124,000元，遠低於賣方之第二年度擔保。因此，於第二年度將不會向賣方交付任何代價股份。

於二零一三年十二月十一日，本公司與賣方訂立第五份補充協議。根據第五份補充協議，賣方向本公司承諾及保證，根據國際財務報告準則編製之管理賬目所記錄，於二零一四年一月一日至二零一四年十二月三十一日止期間（「二零一四年度」），展昇集團之毛利淨額將不少於10,000,000港元，而於二零一五年一月一日至二零一五年十二月三十一日止期間（「二零一五年度」），將不少於10,000,000港元。有關詳情，請參閱日期為二零一四年一月二十八日之通函及附註22。

4. 非常規天然氣業務

於本年度，創紀傑仕（北京）與黑龍院合作成立一個項目，即煤層氣特殊儲存增產改造示範項目（「該項目」），該項目已獲黑龍江發改委批准。根據該項目，創紀傑仕（北京）亦獲黑龍江發改委批准享受海關關稅免稅之稅收利益，而進口環節增值稅可用於抵銷銷售進項增值稅。創紀傑仕（北京）亦與美國專業公司簽訂一份備忘錄，以於中國合作開發非常規天然氣勘探。美國專業公司可為創紀傑仕（北京）之煤層氣鑽井及勘探提供解決方案。創紀傑仕（北京）將於二零一四年七月把設備付運至山西，以對增產改造工程整套設備（「該設備」）進行測試。本公司相信，該設備可於二零一四年下半年全面投入運作。

5. LITIGATION OF THE GROUP AND THE COMPANY IN HONG KONG

Detail of the litigation of the Group and the Company as at 31 March 2014 were set out in Note 42 to the consolidated financial statements.

RESULTS ANALYSIS

For the year ended 31 March 2014, the Group recorded turnover of approximately HK\$42,540,000 from continuing operations (2013: approximately HK\$37,084,000), representing a increase of 14.7% over last year. The turnover were contributed by the coal and metals trading and agency fee and trading of commodities segment. Increase of the turnover was mainly due to the coal trading sales from Zhan Sheng Group was contributed full year to the Group whereas it was only covered seven months for the year ended 31 March 2013.

For the year ended 31 March 2014, the Group recorded a loss attributable to shareholders of approximately HK\$46,044,000 (2013: approximately HK\$83,269,000); basic loss per share for continuing operations was approximately HK\$1.9 cents (2013: HK\$4.7 cents). This has included some non-cash items: (i) imputed interest expense of approximately HK\$903,000 (2013: approximately HK\$18,657,000) on convertible notes under finance costs; (ii) net fair value loss on derivative financial assets of approximately HK\$6,968,000 (2013: net fair value gain of approximately HK\$4,925,000) and fair value loss on derivate financial liabilities of approximately HK\$1,806,000 (2013: net fair value gain of approximately HK\$4,722,000); (iii) fair value on share-based payment of HK\$Nil (2013: approximately HK\$3,088,000); (iv) impairment loss of goodwill of HK\$Nil (2013: approximately HK\$46,485,000); and (v) impairment loss of other receivables of approximately HK\$5,679,000 (2013: HK\$Nil). During the year ended 31 March 2014, the Group also recognised loss on disposal of subsidiaries of approximately HK\$12,752,000 (2013: HK\$Nil).

PROSPECT AND OUTLOOK

Despite the slowdown in the PRC economy in 2013 and uncertainties of global economic recovery, which affected the level of demand for coal and minimized the opportunity of the coal trading business in the PRC, the Directors are cautiously optimistic on the future of the coal trading business in the PRC, as positive signs of recovery shown in the domestic economy in the PRC together with the recovery of the downstream industry shall driven the demand for coal.

For the unconventional gas business, the testing and installation of the Equipment will be commenced in the third quarter of 2014. The success of the Projects with HCl will bring a good opportunity for the Group to develop the business with other state-owned enterprises on the stimulation work in the PRC. The Group expects the unconventional business will commence to generate revenue in the next financial year.

The Group will continue to explore investment opportunities in the resources and energy related sector to achieve inorganic growth, on top of its existing unconventional gas and coal and metals trading business platform.

業績分析

截至二零一四年三月三十一日止年度，本集團錄得來自持續經營業務之營業額約42,540,000港元（二零一三年：約37,084,000港元），相當於較去年增加14.7%。營業額由煤炭與金屬買賣分部及代理服務及買賣商品分部貢獻。營業額增加主要由於展昇集團之煤炭買賣銷售全年為本集團作出貢獻，而其於截至二零一三年三月三十一日止年度僅涵蓋七個月。

截至二零一四年三月三十一日止年度，本集團錄得股東應佔虧損約46,044,000港元（二零一三年：約83,269,000港元）；持續經營業務之每股基本虧損約為1.9港仙（二零一三年：4.7港仙）。此包括若干非現金項目：(i) 融資成本下可換股票據之推算利息費用約903,000港元（二零一三年：約18,657,000港元）；(ii) 衍生金融資產之公平值虧損淨額約6,968,000港元（二零一三年：公平值之收益淨額約4,925,000港元）及衍生金融負債之公平值虧損約1,806,000港元（二零一三年：公平值之收益淨額約4,722,000港元）；(iii) 以股份支付之支出之公平值零港元（二零一三年：約3,088,000港元）；(iv) 商譽減值虧損零港元（二零一三年：約46,485,000港元）；及(vi) 其他應收款項之減值虧損約5,679,000港元（二零一三年：零港元）。於截至二零一四年三月三十一日止年度，本集團亦確認出售附屬公司之虧損約12,752,000港元（二零一三年：零港元）。

前景及展望

儘管中國經濟於二零一三年出現放緩及全球經濟復甦存在不確定性，從而影響中國煤炭需求水平及降低煤炭買賣業務之機會，董事對中國煤炭買賣業務之未來持審慎樂觀態度，乃由於中國國內經濟顯示出復甦之正面跡象，連同下游行業之復甦將帶動煤炭的需求。

就非常規天然氣業務而言，設備測試及安裝將於二零一四年第三季開始。與黑煤院合作之項目的成功將為本集團在中國就改造工程與其他國有企業之業務發展帶來良好機遇。本集團預期非常規業務將於下一財政年度開始產生收益。

本集團將利用其現有非常規天然氣以及煤炭及金屬交易業務平台，繼續探尋資源與能源相關行業之投資機會，以取得外延式增長。

FINANCIAL REVIEW

CAPITAL STRUCTURE

On 21 June 2013, the Company placed of 412,470,000 shares at the placing price of HK\$0.08 per share and the net proceeds of approximately HK\$32,655,000 has been received. The proceeds were used for general working capital of the Group and to finance the possible acquisition.

On 27 November 2013, the Company has successfully placed 286,000,000 shares at the placing price of HK\$0.115 each per share and raised net proceeds of approximately HK\$32,880,000. The proceeds were used for general working capital purposes and/or financing any potential investment opportunity arises in the future.

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

The Group derived its working capital mainly from internal cash flow from operating activities and shares placement.

As at 31 March 2014, deficit on shareholders' funds of the Group aggregately amounted to approximately HK\$139,088,000 (2013: approximately HK\$229,136,000). As at 31 March 2014, the Group's assets-liabilities ratio (total liabilities to total assets) was approximately 1.59 times (2013: approximately 1.99 times). Net current liabilities of the Group amounted to approximately HK\$242,086,000 (2013: approximately HK\$351,172,000). Current assets of the Group was approximately HK\$123,120,000 (2013: approximately HK\$101,329,000), of which fixed deposits, cash and bank balances amounted to approximately HK\$26,075,000 (2013: approximately HK\$21,914,000). The following items with an aggregate amount of approximately HK\$349,218,000 (2013: approximately HK\$348,338,000), which are included in current liabilities, are related to the legal proceedings with Mr. Hung in the High Court of Hong Kong (the "High Court"): (i) HK\$158,600,000 (2013: HK\$158,600,000) was consideration payable for the acquisition of Wealth Gain Global Investment Limited and its subsidiary; (ii) approximately HK\$17,118,000 (2013: approximately HK\$16,238,000) was the shareholder's loan plus interest from Mr. Hung; and (iii) convertible notes of HK\$173,500,000 (2013: HK\$173,500,000). The Board considers that the liquidity of the Group is good enough for the year ended 31 March 2014 and the Group would be turned to net assets position to approximately HK\$210,130,000 (2013: approximately HK\$119,202,000) if removal of (i) to (iii). Details refer to Notes 28, 29 and 33 of the consolidated financial statements.

As at 31 March 2014, the Group's gearing ratio (total debts to total equity) was 145.4% (2013: 99.5%).

The Group currently has no foreign exchange rate hedging policy in respect of commercial transactions denominated in foreign currencies. However, the directors monitor exchange rate exposure regularly and will consider hedging significant exchange rate exposure when necessary.

As at 31 March 2014, the Group had a total of 28 employees (2013: 30) in Hong Kong and the PRC. All employees are remunerated according to their performance, experience and the prevailing industry practices.

The Group also participates in retirement benefit schemes for its staff in Hong Kong and the PRC. It adopted a new share option scheme on 8 October 2010, with options to be granted to employees at the discretion of the Board. As at 31 March 2014, 127,796,000 share options are remained outstanding.

MATERIAL ACQUISITION AND DISPOSAL

The Group did not have material acquisition for the year ended 31 March 2014.

On 31 March 2014, the Company duly completed the disposal of the entire issued share capital of the Wealthy Wing Group at a consideration of HK\$9,000,000. Please refer to Note 40 of the consolidated financial statements for details.

Each of the executive directors has respectively entered into a service agreement with the Company for an initial term of three years but is subject to retirement by rotation and is eligible for re-election.

All of the independent non-executive directors and non-executive director have no fixed term of appointment, but are subject to retirement by rotation and is eligible for re-election.

None of the directors has any financial, business, family or other material or relevant relationships among members of the Board.

The Company has received confirmation from each of the INEDs about his independence pursuant to rule 3.13 of the Listing Rules. The Company is of the view that all INEDs meet the independence rules and continues to consider each of them to be independent.

The Board, as led by the Chairman and the Vice Chairman, is collectively responsible for the set up of the Group's overall strategies, operating and financial policies, approval of annual budgets and business plans, evaluation of the performance of the Company's business, and oversight of the management team. The management team is responsible for the day-to-day operations of the Group under the supervision of the Managing Director.

CONTINUOUS TRAINING AND DEVELOPMENT FOR DIRECTORS

The directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The Company would provide a comprehensive induction package covering the summary of the responsibilities and legal obligations of a director of a Hong Kong listed company, the Company's constitutional documents and the Guides on Directors' Duties issued by the Companies Registry to each newly appointed director to ensure that he/she is sufficiently aware of his/her responsibilities and obligations under the Listing Rules and other regulatory requirements.

The company secretary reports from time to time the latest changes and development of the Listing Rules, corporate governance practices and other regulatory regime to the directors with written materials, and the legal advisers of the Company prepare and provide the directors with detailed interpretations and analysis on the revised contents for them to understand the latest developments in a timely and accurate manner and to perform their duties in accordance with relevant laws and regulatory requirements.

During the year, all directors were provided with regular updates on the Group's business and operations. The Company has arranged for the directors to update the Directors on the amendments on the Listing Rules and guidelines on disclosure of insider information and connected transactions.

The Chairman and the Vice Chairman lead the Board and oversees the functioning of the Board to ensure that the Board acts in the best interests of the Company and its shareholders, and Board meetings are planned and conducted effectively. The Chairman is primarily responsible for the approval of the agenda prepared by the Company Secretary for each Board meeting, and taking into account, where appropriate, matters proposed by members of the Board and including them in the agenda. With the support of the Vice Chairman, other executive directors and the Company Secretary, the Chairman seeks to ensure that all directors are properly briefed on issues arising at Board meetings and receive sufficient and reliable information in a timely manner before the Board meetings. The Chairman and the Vice Chairman also actively encourage directors to engage in the Board's affairs and make contribution to the Board's decisions.

The Chief Executive Officer is responsible for the day-to-day management of the Group's businesses, the formation and implementation of operating and financial policies among the Group and accountability to the Board for all the Group's operations. The Chief Executive Officer together with the management team ensure that the Company's business plans are consistent with the strategies and objectives established by the Board. In addition, the Chief Executive Officer ensures that the Company meets its funding requirements and closely monitors the operating and financial results against the Company's business plans and budgets, and takes remedial actions if necessary. The Chief Executive Officer is also responsible for the establishment and maintenance of an effective management team to assist him in the day-to-day management of the Group's businesses.

BOARD PRACTICES

Regular Board meetings are scheduled in advance to give all directors an opportunity to attend in person. Eleven regular Board meetings had been held during the year ended 31 March 2014. APPOINTMENTS, RE-ELECTION AND REMOVAL OF DIRECTORS

In accordance with article 86(3) of the Articles, any director appointed by the Board to fill a casual vacancy should be subject to election by Shareholders at the first general meeting of the Company. In accordance with articles 87(1) of the Articles, every director (including those appointed for a specific term or holding office as Chairman of the Board or the Managing Director of the Company) shall be subject to retirement by rotation at least once every three years.

Under the CG Code, non-executive directors should be appointed for specific terms, subject to re-election. Currently, the independent non-executive Directors have no set term of office but are subject to retirement by rotation at annual general meetings of the Company in accordance with the Company's articles of association.

MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS OF LISTED ISSUERS (THE "MODEL CODE")

The Company adopted a code of conduct regarding directors' securities transactions as set out in the Model Code in Appendix 10 of the Listing Rules on the terms no less exacting than the required standard set out in the Model Code throughout the year ended 31 March 2014. If the Board fail to convene the EMG as requisitioned by the shareholders within 21 days after the date of requisition was received, all reasonable expenses incurred by the requisitioner(s) as a result of the failure of the Board shall be reimbursed to the requisitioner(s) by the Company.

Shareholders have the right to send their enquiries and concerns to the Board or make proposals at the shareholders' meeting by addressing them to the Company Secretary of the Company by mail at the Company's correspondence address in Hong Kong or by email to the Company's official email address. The Company Secretary forwards all enquiries and proposals relating to ordinary business matters, such as suggestions, inquiries and consumer complaints to the Board.

Save as disclosed in the share option scheme as set out in Note 38 to the consolidated financial statements, at no time during the year was the Company, its holding company or any of its subsidiaries a party to any arrangement to enable the Company's directors, their respective spouse or children under 18 years of age to acquire benefits by means of the acquisition of shares in or debentures of the Company or any other body corporate.

SHARE OPTION SCHEME

Details of the Company's share option scheme are set out in Note 38 to the consolidated financial statements.

As at 31 March 2014, 127,796,000 share options are remained outstanding.

SHARE AWARD SCHEME

The Board has approved the adoption of the share award scheme ("Scheme") on 11 February 2011 ("Adoption Date"), pursuant to which existing shares will be purchased by the Bank of East Asia (Trustees) Limited ("Trustee") from the market at the cost of the Company and be held in trust for the relevant selected participants ("Selected Participants"). Selected Participants may cover any Director (including executive and non-executive Director), employee, officer, agent, advisor or consultant of the Company and of its subsidiaries.

The purpose of the Scheme are (i) to recognise the contributions by the Selected Participants and to give incentives thereto in order to retain them for the continuing operation and future development of the Group; and (ii) attract suitable personnel for further development of the Group.

If the Board selects a Director as the Selected Participant, the grant of the Awarded Shares to the Director may constitute a connected transaction of the Company. However, since the grant of awarded shares to Director forms part of the remuneration of the relevant Director under his/her service contract, such grant of awarded shares is exempted from all the reporting, announcement and independent Shareholder's approval requirement under Rules 14A.31(6) of the Listing Rules.

For the award of Shares to Selected Participants who are connected persons (excluding Directors), the Company will comply with the relevant provisions of the Listing Rules in relation to the reporting, announcement and independent Shareholders approval requirements. However, any grant to any Director or senior management of the Company must first be approved by the Remuneration Committee.

Subject to any early termination as may be determined by the Board pursuant to the rules relating to the Scheme, the Scheme shall be valid and effective for a term of 10 years commencing on the Adoption Date provided that no further contribution to the Trust shall be made by the Company on or after the 10th anniversary date of the Adoption Date.

During the year ended 31 March 2014, no award shares have been released to Selected Participants.

ISSUE OF CONVERTIBLE NOTES AND PLACING OF NEW SHARES

For the HK\$15,000,000 convertible notes (the “Convertible Notes 2012”) issued on 6 July 2012, the principal amount of HK\$5,325,000 was early redeemed during the year ended 31 March 2013.

On 18 July 2013, the note holder transferred the Convertible Notes 2012 to the subscriber. As at 10 July 2013, the interest payable and the redeemed principal amounts to HK\$7,332,360 (the “Outstanding Sum”) have not yet been settled by the Company. On 25 July 2013, the Company and the subscriber entered into the supplemental agreement in respect of proposed amendments to the terms and conditions of the Convertible Notes 2012. On 16 August 2013, shareholders approved the proposed amendments (the “Proposed Amendments”). The Outstanding Sum has been settled by way of issuance and allotment of 56,840,000 ordinary shares at HK\$0.129 per share (the “Replacement Shares”) and the subscriber is entitled to exercise 75,000,000 ordinary shares at HK\$0.129 per share (the “New Conversion Shares”). On 23 August 2013, the subscriber exercised all the conversion rights attaching to the Convertible Notes 2012. The Company has issued and allotted 56,840,000 Replacement Shares and 75,000,000 conversion shares to the subscriber.

On 21 June 2013, the Company placed of 412,470,000 shares at the placing price of HK\$0.08 per share and the net proceeds of approximately HK\$32,655,000 has been received. The proceeds were used for general working capital of the Group and to finance the possible acquisition.

On 27 November 2013, the Company has successfully placed 286,000,000 shares at the placing price of HK\$0.115 each per share and raised net proceeds of approximately HK\$32,880,000. The proceeds were used for general working capital purposes and/or financing any potential investment opportunity arises in the future.

Without qualifying our opinion, we draw attention to Note 3(a) in the consolidated financial statements which indicates that the Group incurred a net loss of approximately HK\$54,251,000 during the year ended 31 March 2014 and, as of that date, the Group had net current liabilities of approximately HK\$242,086,000 and net liabilities of approximately HK\$139,088,000. These conditions, along with other matters as set forth in Note 3(a) in the consolidated financial statements, indicate the existence of a material uncertainty that may cast significant doubt about the Group's ability to continue as a going concern.

1. CORPORATE INFORMATION

Sino Resources Group Limited (the “Company”) is a limited liability company incorporated in the Cayman Islands and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The registered office of the Company is located at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is located at Suite 2502, 25/F, No. 9 Queen’s Road Central, Central, Hong Kong.

The principal activity of the Company is investment holding. The principal activities of its subsidiaries are engaged as investing and developing in unconventional gas business, coal and metals trading business and provision of agency services and trading of commodities. The principal activities, other particulars of its subsidiaries are set out in Note 18 to the consolidated financial statements.

The consolidated financial statements are presented in Hong Kong dollars, which is the same as the functional currency of the Company and all values are rounded to the nearest thousand (HK\$’000) except when otherwise indicated.

Except for the amendments to HKAS 1, the application of these new HKFRSs has no material impact on the results and the financial position of the Group.

The nature of the impending changes in accounting policy are described below.

Amendments to HKAS 1 Presentation of Items of Other Comprehensive Income

The amendments to HKAS 1 are effective for annual periods beginning on or after 1 July 2012.

The amendments to HKAS 1 introduce new terminology for the statement of comprehensive income and income statement. Under the amendments to HKAS 1, a statement of comprehensive income is renamed as a statement of profit or loss and other comprehensive income and an income statement is renamed as a statement of profit or loss. The amendments to HKAS 1 retain the option to present profit or loss and other comprehensive income in either a single statement or in two separate but consecutive statements. However, the amendments to HKAS 1 require items of other comprehensive income to be grouped into two categories in the other comprehensive income section: (a) items that will not be reclassified subsequently to profit or loss and (b) items that may be reclassified subsequently to profit or loss when specific conditions are met. Income tax on items of other comprehensive income is required to be allocated on the same basis. The amendments do not change the option to present items of other comprehensive income either before tax or net of tax.

HKFRS 10 Consolidated Financial Statements

HKFRS 10 replaces the parts of HKAS 27 Consolidated and Separate Financial Statements that deal with consolidated financial statements and HK(SIC) Int-12 Consolidation — Special Purpose Entities. HKFRS 10 changes the definition of control such that an investor has control over an investee when (a) it has power over the investee, (b) it is exposed, or has rights, to variable returns from its involvement with the investee and (c) has the ability to use its power to affect its returns. All three of these criteria must be met for an investor to have control over an investee. Previously, control was defined as the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. Additional guidance has been included in HKFRS 10 to explain when an investor has control over an investee. Some guidance included in HKFRS 10 that deals with whether or not an investor that owns less than 50% of the voting rights in an investee has control over the investee is relevant to the Group.

香港會計準則第1號的修訂本於全面收益表及收益表引入新術語。根據香港會計準則第1號的修訂本，「全面收益表」易名為「損益及其他全面收益表」，而「收益表」則易名為「損益表」。香港會計準則第1號的修訂本保留以單一報表或兩個獨立但連續的報表呈列損益及其他全面收益的選擇權。然而，香港會計準則第1號的修訂本規定於其他全面收益部分將其他全面收益項目分為兩類：(a)不會於其後重新分類至損益的項目；及(b)於符合特定條件時可能於其後重新分類至損益的項目。其他全面收益項目的所得稅須按相同基準分配。該等修訂並無改變按除稅前或除稅後呈列其他全面收益項目的選擇權。

香港財務報告準則第10號「綜合財務報表」

香港財務報告準則第10號取代香港會計準則第27號「綜合及獨立財務報表」中處理綜合財務報表的部份及香港(常設詮釋委員會)詮釋第12號「綜合—特殊目的實體」。香港財務報告準則第10號更改控制權的定義，致使於投資者(a)對投資對象擁有權力；(b)對所參與投資對象的可變動回報承擔風險或擁有權利；及(c)有能力利用其權力以影響其回報，即對投資對象擁有控制權。投資者必須符合該三項準則方對投資對象擁有控制權。控制權先前乃界定為有權規管實體的財務及營運政策以從其業務中獲益。香港財務報告準則第10號已加入額外指引，以解釋投資者何時對投資對象擁有控制權。香港財務報告準則第10號載有若干與本集團相關指引，以處理擁有投資對象的投票權不足50%的投資者是否有權控制投資對象。

HKFRS 12 Disclosure of Interests in Other Entities

HKFRS 12 is a new disclosure standard and is applicable to entities that have interests in subsidiaries, joint arrangements, associates and/or unconsolidated structured entities. In general, the application of HKFRS 12 has resulted in more extensive disclosures in the consolidated financial statements.

HKFRS 13 Fair Value Measurement

The Group has applied HKFRS 13 for the first time in the current year. HKFRS 13 establishes a single source of guidance for fair value measurements and disclosures about fair value measurements. The scope of HKFRS 13 is broad; the fair value measurement requirements of HKFRS 13 apply to both financial instrument items and non-financial instrument items for which other HKFRSs require or permit fair value measurements and disclosures about fair value measurements, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are within the scope of HKAS 17 Leases, and measurements that have some similarities to fair value but are not fair value (e.g. net realisable value for the purposes of measuring inventories or value in use for impairment assessment purposes).

HKFRS 13 defines the fair value of an asset as the price that would be received to sell an asset (or paid to transfer a liability, in the case of determining the fair value of a liability) in an orderly transaction in the principal (or most advantageous) market at the measurement date under current market conditions. Fair value under HKFRS 13 is an exit price regardless of whether that price is directly observable or estimated using another valuation technique. Also, HKFRS 13 includes extensive disclosure requirements.

HKFRS 13 requires prospective application from 1 January 2013. In addition, specific transitional provisions were given to entities such that they need not apply the disclosure requirements set out in the standard in comparative information provided for periods before the initial application of the standard. In accordance with these transitional provisions, the Group has not made any new disclosures required by HKFRS 13 for the 2013 comparative period. Other than the additional disclosures, the application of HKFRS 13 has not had any material impact on the amounts recognised in the consolidated financial statements.

香港財務報告準則第13號「公平值計量」

於本年度，本集團已首次應用香港財務報告準則第13號。香港財務報告準則第13號為有關公平值計量及披露的指引提供單一來源。香港財務報告準則第13號範圍廣泛。香港財務報告準則第13號的公平值計量規定適用於其他香港財務報告準則要求或允許作出公平值計量及作出有關公平值計量的披露的金融工具項目及非金融工具項目，惟香港財務報告準則第2號「以股份支付」範圍內以股份為基礎之付款交易、香港會計準則第17號「租賃」範圍內的租賃交易及與公平值類似但並非公平值的計量（如就計量存貨而言的可變現淨值或就減值評估而言的使用價值）除外。

香港財務報告準則第13號將資產的公平值界定為於現行市況下於計量日期在主要市場（或最有利的市場）進行的有序交易出售資產可收取（或於釐定負債公平值的情況下，轉讓負債須支付的）價格。香港財務報告準則第13號項下的公平值指平倉價，不論該價格是否直接可觀察或使用另一估值技術估計所得。此外，香港財務報告準則第13號包括作出廣泛披露的規定。

香港財務報告準則第13號規定自二零一三年一月一日起作前瞻性應用。此外，已就有關實體頒佈特定過渡條文，致使該等實體毋須應用該項準則所載的披露規定提供首次應用此項準則之前期間的比較資料。根據該等過渡條文，本集團並無就二零一三年比較期間作出香港財務報告準則第13號規定的任何新披露。除額外披露外，應用香港財務報告準則第13號並無對綜合財務報表已確認的金額造成任何重大影響。

HKFRS 9 Financial Instruments

HKFRS 9 issued in 2009 introduced new requirements for the classification and measurement of financial assets. HKFRS 9 was amended in 2010 to include requirements for the classification and measurement of financial liabilities and for derecognition.

Key requirements of HKFRS 9 are described below:

- All recognised financial assets that are within the scope of HKAS 39 *Financial Instruments: Recognition and Measurement* to be subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent reporting periods. All other debt investments and equity investments are measured at their fair values at the end of subsequent accounting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- With regard to the measurement of financial liabilities designated as at fair value through profit or loss, HKFRS 9 requires that the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is presented in other comprehensive income, unless the recognition of the effects of changes in the liability's credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value of financial liabilities attributable to changes in the financial liabilities' credit risk are not subsequently reclassified to profit or loss. Previously, under HKAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss was presented in profit or loss.

The date when entities would be required to apply HKFRS 9 was previously stated at 1 January 2015. This mandatory effective date has been removed to provide sufficient time for preparers of financial statements to make the transition to the new requirements, which will now become effective from a later date yet to be announced.

The directors anticipate that the adoption of HKFRS 9 in the future may have a significant impact on the amounts reported in respect of the Group's financial assets and financial liabilities (e.g. the Group's available-for-sale investments may have to be measured at fair value at the end of subsequent reporting periods, with changes in the fair value being recognised in profit or loss). Regarding the Group's financial assets, it is not practicable to provide a reasonable estimate of that effect until a detailed review has been completed.

香港財務報告準則第9號「金融工具」

於二零零九年頒佈的香港財務報告準則第9號引入金融資產分類及計量的新規定。香港財務報告準則第9號於二零一零年作出修訂以加入金融負債的分類及計量以及取消確認的規定。

香港財務報告準則第9號的主要規定載述如下：

- 屬香港會計準則第39號金融工具：確認及計量範圍內的所有已確認金融資產，其後均須按攤銷成本或公平值計量。具體而言，目的為收集合約現金流量的業務模式內所持有以及合約現金流量僅為償還本金及尚未償還本金所產生利息的債務投資，一般於其後報告期末按攤銷成本計量。所有其他債務投資及股本投資均於其後會計期間末按公平值計量。此外，根據香港財務報告準則第9號，實體可作出不可撤回選擇以於其他全面收益呈列股本投資（並非持作買賣）的其後公平值變動，而一般僅於損益內確認股息收入。
- 就指定為按公平值計入損益的金融負債的計量而言，香港財務報告準則第9號規定，因金融負債信貸風險有變而導致其公平值變動的款額乃於其他全面收益呈列，除非於其他全面收益確認負債的信貸風險變動影響會導致或擴大於損益的會計錯配。金融負債信貸風險變動應佔的金融負債公平值變動其後不會重新分類至損益。過往，根據香港會計準則第39號，指定為按公平值計入損益的金融負債公平值變動的全部金額於損益內呈列。

實體須應用香港財務報告準則第9號的日期先前定為二零一五年一月一日。此強制性生效日期已剔除，以為財務報表的編製者提供足夠時間過渡至新規定，新規定現將由有待公佈的較後日期起生效。

董事預期，日後採納香港財務報告準則第9號可能會對就本集團的金融資產及金融負債（例如，本集團的可供出售投資或會於其後報告期間按公平值計量，而公平值變動於損益中確認）所呈報的數額構成重大影響。在詳細審閱完成前就本集團的金融資產提供有關影響的合理估計並不可行。

Amendments to HKFRS 7 and HKAS 32 – Offsetting Financial Assets and Financial Liabilities and the related disclosures

The amendments to HKAS 32 clarify existing application issues relating to the offset of financial assets and financial liabilities requirements. Specifically, the amendments clarify the meaning of “currently has a legally enforceable right of set-off” and “simultaneous realisation and settlement”.

The amendments to HKFRS 7 require entities to disclose information about rights of offset and related arrangements (such as collateral posting requirements) for financial instruments under an enforceable master netting agreement or similar arrangement.

The amendments to HKFRS 7 are effective for annual periods beginning on or after 1 January 2013 and interim periods within those annual periods. The disclosures should be provided retrospectively for all comparative periods. However, the amendments to HKAS 32 are not effective until annual periods beginning on or after 1 January 2014, with retrospective application required.

The directors anticipate that the application of these amendments to HKAS 32 and HKFRS 7 may result in more disclosures being made with regard to offsetting financial assets and financial liabilities in the future.

Amendments to HKAS 36 – Impairment of Assets: Recoverable Amount Disclosure for Non-Financial Assets

The amendments to HKAS 36 are to remove certain unintended disclosure requirements which may be introduced by the consequential amendments to HKAS 36 when HKFRS 13 was issued. Furthermore, these amendments require the disclosure of additional information about the fair value measurement when the recoverable amount of impaired assets is based on fair value less costs of disposal. The amendments to HKAS 36 are effective for annual periods beginning on or after 1 January 2014. Earlier application is permitted. However, an entity may not apply those amendments in periods (including comparative periods) in which it does not also apply HKFRS 13.

The directors anticipate that the application of these amendments to HKAS 36 will have no material impact on the Group’s financial performance and positions.

香港財務報告準則第7號(修訂本)於二零一三年一月一日或之後開始的年度期間以及該等年度期間內的中期期間生效，亦須就所有比較期間作出追溯披露。然而，香港會計準則第32號(修訂本)於二零一四年一月一日或之後開始的年度期間方始生效，並須追溯應用。

香港會計準則第36號(修訂本)剔除於香港財務報告準則第13號頒佈時可能由香港會計準則第36號的後續修訂引入的若干非計劃披露規定。此外，有關修訂規定，於減值資產的可收回金額乃根據公平值減出售成本計算時，須披露公平值計量的其他資料。香港會計準則第36號(修訂本)於二零一四年一月一日或之後開始的年度期間生效，並可提早應用。然而，實體於其亦不得無應用香港財務報告準則第13號的期間(包括比較期間)應用有關修訂。

Amendments to HKFRS 10, HKFRS 12 and HKAS 27 (2011) – Investment Entities

The investment entities amendments apply to a particular class of business that qualify as investment entities. The term ‘investment entity’ refers to an entity whose business purpose is to invest funds solely for returns from capital appreciation, investment income or both. An investment entity must also evaluate the performance of its investments on a fair value basis. Such entities could include private equity organisations, venture capital organisations, pension funds, sovereign wealth funds and other investment funds.

Under HKFRS 10, reporting entities were required to consolidate all investees that they control (i.e. all subsidiaries). Preparers and users of financial statements have suggested that consolidating the subsidiaries of investment entities does not result in useful information for investors. Rather, reporting all investments, including investments in subsidiaries, at fair value, provides the most useful and relevant information.

In response to this, the amendments provide an exception to the consolidation requirements in HKFRS 10 and require investment entities to measure particular subsidiaries at fair value through profit or loss, rather than consolidate them. The amendments also set out disclosure requirements for investment entities.

The amendments are effective from 1 January 2014 with early adoption permitted in order to allow investment entities to apply the amendments at the same time they first apply the rest of HKFRS 10.

The directors anticipate that the application of these amendments to HKFRS 10, HKFRS 12 and HKFRS 27 (2011) will have no material impact on the Group’s financial performance and positions.

Amendments to HKAS 39 – Novation of Derivatives and Continuation of Hedge Accounting

The narrow-scope amendments will allow hedge accounting to continue in a situation where a derivative, which has been designated as a hedging instrument, is novated to effect clearing with a central counterparty as a result of laws or regulation, if specific conditions are met (in this context, a novation indicates that parties to a contract agree to replace their original counterparty with a new one).

This relief has been introduced in response to legislative changes across many jurisdictions that would lead to the widespread novation of over-the-counter derivatives. These legislative changes were prompted by a G20 commitment to improve transparency and regulatory oversight of over-the-counter derivatives in an internationally consistent and non-discriminatory way.

香港財務報告準則第10號、香港財務報告準則第12號及香港會計準則第27號 (二零一一年) (修訂本) — 投資實體

投資實體修訂本適用於符合資格作為投資實體的特定業務類別。「投資實體」一詞所指實體指其業務宗旨是純粹為獲得資本增值回報、投資收入或兩者兼得的實體。投資實體亦須按公平值基準評估其投資表現。該等實體可包括私募股權機構、創業投資機構、退休基金、主權財富基金及其他投資基金。

根據香港財務報告準則第10號，報告實體須將其控制的所有投資對象 (即全部附屬公司) 綜合入賬。財務報表的編製者及使用者均指出，將投資實體的附屬公司綜合入賬不會得出對投資者有用的資料。相反，按公平值報告所有投資 (包括於附屬公司的投資) 可提供最合用且相關的資料。

有見及此，有關修訂本對香港財務報告準則第10號的綜合入賬規定提供了例外情況，規定投資實體按公平值計入損益以計量特定附屬公司，而並非將該等附屬公司綜合入賬。有關修訂本亦載列適用於投資實體的披露規定。

有關修訂本由二零一四年一月一日起生效，可提前採納，以供投資實體在首次應用香港財務報告準則第10號的其餘規定時可同時應用有關修訂本。

董事預計應用此等香港財務報告準則第10號、香港財務報告準則第12號及香港財務報告準則第27號 (二零一一年) 修訂本，將不會對本集團的財務表現及狀況構成重大影響。

香港會計準則第39號 (修訂本) — 衍生工具更替及對沖會計法的延續

適用範圍較窄的有關修訂本於衍生工具 (已指定為對沖工具) 其於法例或規例而作出契約更替與中央對手方進行結算的情況下，將容許繼續使用對沖會計法，惟前提是須符合特定條件。就此而言，更替乃指合約各訂約方同意以新對手方取代原有對手方。

此放寬措施就應對於多個司法管轄區可能導致場外衍生工具大量合約更替的法律變動作出。該等法律變動乃由二十國集團承諾以國際統一及非歧視方式提高場外衍生工具的透明度及監管而促成。

The amendments will be effective for annual periods beginning on or after 1 January 2014 and applied retrospectively. Earlier application is permitted.

The directors anticipate that the application of these amendments to HKAS 39 will have no material impact on the Group’s financial performance and positions.

HK (IFRIC)-Int 21 Levies

HK (IFRIC)-Int 21 is an interpretation of HKAS 37 and addresses how an entity should account for liabilities to pay levies imposed by governments, other than income taxes, in its financial statements. The principal question raised was about when the entity should recognise a liability to pay a levy. It clarifies that the obligating event that gives rise to a liability to pay a levy is the activity described in the relevant legislation that triggers the payment of the levy. HK(IFRIC)-Int 21 is effective for annual periods beginning on or after 1 January 2014 with earlier application permitted.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The consolidated financial statements have been prepared in accordance with all applicable HKFRSs, which is a collective term that includes all applicable individual HKFRSs, Hong Kong Accounting Standards (“HKASs”), and Interpretations issued by the HKICPA and accounting principles generally accepted in Hong Kong. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”) and by the Hong Kong Companies Ordinance.

香港 (國際財務報告詮釋委員會) – 詮釋第21號是對香港會計準則第37號的詮釋，並論述實體應如何於其財務報表中說明用於支付政府所徵收稅項 (所得稅除外) 的負債。所提出主要問題在於實體應何時確認支付徵稅的負債。其澄清因導致支付徵稅的負債之責任事件為引致支付徵稅的相關法律所述活動。香港 (國際財務報告詮釋委員會) – 詮釋第21號於二零一四年一月一日或之後開始的年度期間生效，可提前應用。

以下為編製此等綜合財務報表時應用之主要會計政策。除另有指明外，此等政策已於所呈列之各年度貫徹應用。

此等綜合財務報表已按照所有適用之香港財務報告準則及香港普遍採納之會計原則而編製。香港財務報告準則為一項統稱，其包括香港會計師公會頒佈之所有適用之各項香港財務報告準則、香港會計準則 (「香港會計準則」) 及詮釋。此外，綜合財務報表包括聯交所證券上市規則 (「上市規則」) 及香港公司條例之適用披露規定。

(a) Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

(a) 編製基準

綜合財務報表乃根據歷史成本法編製，惟誠如下述會計政策所解釋，於各報告期末，若干財務工具乃按公平值計量。

歷史成本一般基於為交換貨品及服務而給予之代價之公平值。

公平值乃指市場參與者之間在計量日進行的有序交易中出售一項資產所收取的價格或轉移一項負債所支付的價格，無論該價格乃直接觀察到的結果，或是採用其他估值技術作出的估計。在對資產或負債的公平值作出估計時，本集團考慮了市場參與者在計量日為該資產或負債進行定價時將會考慮的該等特徵。於此等綜合財務報表中計量及／或披露的公平值均按此基準予以釐定，惟香港財務報告準則第2號範圍內的以股份為基礎的支付交易、香港會計準則第17號範圍內的租賃交易及與公平值類似但並非公平值的計量（例如香港會計準則第2號中的可變現淨值或香港會計準則第36號中的使用價值）除外。

此外，就財務報告而言，公平值計量根據公平值計量的輸入數據可觀察程度及公平值計量的輸入數據對其整體的重要性分類為第一級、第二級或第三級，詳情如下：

- 第一級輸入數據乃實體於計量日可取得的相同資產或負債於活躍市場之報價（未經調整）；
- 第二級輸入數據乃就資產或負債直接或間接地可觀察之輸入數據（第一級內包括的報價除外）；及
- 第三級輸入數據乃資產或負債的不可觀察輸入數據。

主要會計政策載列如下。

(a) Basis of preparation (continued)

In preparing the consolidated financial statements, the directors of the Company have given careful consideration to the future liquidity of the Group in light of the Group's net loss of approximately HK\$54,251,000 for the year ended 31 March 2014 (2013: HK\$83,576,000), the Group's net current liabilities and net liabilities of approximately HK\$242,086,000 (2013: HK\$351,172,000) and HK\$139,088,000 (2013: HK\$229,136,000) at 31 March 2014 respectively. In preparing the consolidated financial statements, the directors of the Company have given careful consideration to the impact of the current and anticipated future liquidity of the Group and the ability of the Group to attain profitable and positive cash flows operations in the immediate and longer term.

Moreover, the substantial shareholders of the Company have agreed to provide continuing financial support to the Group.

In the opinion of the directors, after taking into account of the above procedures, the Group will have sufficient working capital for its current requirement. Accordingly, the directors consider that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Should the Group be unable to continue as a going concern, adjustments would have to be made to restate the values of assets to their recoverable amounts, to provide for any further liabilities which might arise and to classify non-current assets and liabilities as current assets and liabilities respectively. The effects of these potential adjustments have not been reflected in these consolidated financial statements.

(b) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities (including structured entities) controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

於編製綜合財務報表時，本公司董事已因應本集團於截至二零一四年三月三十一日止年度之虧損淨額約54,251,000港元(二零一三年：83,576,000港元)、於二零一四年三月三十一日之流動負債淨額及負債淨額分別約242,086,000港元(二零一三年：351,172,000港元)及139,088,000港元(二零一三年：229,136,000港元)而審慎考慮本集團之未來流動資金。於編製綜合財務報表時，本公司董事已審慎考慮本集團現時及預期未來流動資金之影響及本集團即時及長期獲得可盈利及正面現金流量業務之能力。

此外，本公司主要股東已同意向本集團提供持續財政支援。

董事認為，經考慮上述程序，本集團將有足夠營運資金滿足其現時需求。因此，董事認為按持續經營基準編製綜合財務報表屬適當。

倘本集團未能繼續按持續經營基準，則須作出調整，以重列資產價值至彼等之可收回金額，以撥備任何可能產生之進一步負債及將非流動資產及負債分別分類為流動資產及負債。此等潛在調整之影響並無反映於此等綜合財務報表內。

(b) 綜合賬目之基準

本綜合財務報表包括本公司及本公司及其附屬公司控制的實體的財務報表。倘本公司同時符合以下標準，則本公司取得控制權：

- 對被投資方擁有權力；
- 面對或擁有自其參與被投資方產生之可變回報之風險或權利；及
- 有能力行使其權力以影響其回報時。

倘事實及情況表明上述控制之三個要素的其中一項或多項出現變動，則本集團重新評估其是否控制被投資方。

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

倘本公司於被投資方之投票權未能佔大多數，只要投票權足以賦予本公司實際能力可單方面掌控被投資方之相關業務時，本公司即對被投資方擁有權力。在評估本公司於被投資方之投票權是否足以賦予其權力時，本公司考慮所有相關事實及情況，包括：

- 本公司持有投票權之數量，相較其他投票權持有人所持投票權之數量及分散情況；
- 本公司、其他投票權持有人或其他人士持有之潛在投票權；
- 其他合約安排產生之權利；及
- 可表明於需要作出決定時，本公司當前能否掌控相關活動之任何其他事實及情況(包括於過往股東會議上之投票方式)。

當本公司獲得附屬公司之控制權時，即開始對其綜合入賬，而當本公司失去附屬公司之擁有權時，即不再對其綜合入賬。具體而言，本年度收購或出售附屬公司之收入及開支，從本公司獲得附屬公司控制權之日計起，直至本公司不再擁有附屬公司控制權之日止，列入綜合損益及其他全面收益表內。

溢利或虧損及其他全面收益之每一項目，均歸屬於本公司之擁有人及非控股權益。即使附屬公司全面收益總額歸屬於非控股權益會產生虧絀餘額，附屬公司之全面收益總額仍然歸屬於本公司擁有人及非控股權益。

如有需要，本集團會對附屬公司之財務報表作出調整，使其會計政策與本集團之會計政策保持一致。

所有集團內資產及負債、股本、收益、開支及有關集團成員之間交易之現金流量於綜合入賬時悉數對銷。

Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, a gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKAS 39, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

(c) Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 *Income Taxes* and HKAS 19 *Employee Benefits* respectively;

本集團於現有附屬公司之所有權權益變動

本集團於現有附屬公司之所有權權益並無導致本集團失去對該等附屬公司之控制權之變動入賬為股本交易。調整本集團之權益及非控股權益之賬面值，以反映彼等於附屬公司之相對權益之變動。調整非控股權益之金額與已付或已收代價之公平值間之任何差額乃直接於權益內確認，並歸屬於本公司擁有人。

當本集團失去對附屬公司之控制，盈虧乃於損益中確認，並按(i)已收代價公平值及任何保留權益公平值之總和與(ii)資產(包括商譽)的先前賬面值及附屬公司之負債及任何非控股權益之間的差額計算。所有先前於其他全面收益確認之有關該附屬公司之款項，將按猶如本集團已直接出售該附屬公司之相關資產或負債入賬(即按適用香港財務報告準則之規定/許可條文重新分類至損益或轉撥至另一類權益)。於失去控制權當日於前附屬公司保留之任何投資之公平值將根據香港會計準則第39號，於其後入賬時被列作初步確認之公平值，或(如適用)於初步確認時於聯營公司或合營企業之投資成本。

收購業務乃採用收購法入賬。於業務合併中轉讓之代價乃按公平值計量，其計算為本集團所轉讓資產於收購日期之公平值、本集團為被收購方之前擁有人所產生負債及本集團為交換被收購方之控制權而所發行股本權益之總和。收購相關成本一般於產生時在損益中確認。

於收購日期，所收購可識別資產及所承擔負債均按彼等之公平值確認，惟以下情況除外：

- 遞延稅項資產或負債，及與僱員福利安排有關之資產或負債分別根據香港會計準則所得稅及香港會計準則第19號僱員福利確認及計量；

- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 *Share-based Payment* at the acquisition date (see the accounting policy below); and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 *Non-current Assets Held for Sale and Discontinued Operations* are measured in accordance with that standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at their fair value or, when applicable, on the basis specified in another HKFRS.

When the consideration transferred by the Group in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

屬現時所有權權益並賦予彼等之持有人於清盤時按比例分佔該實體之資產淨值之非控股權益可初步按公平值或按非控股權益按比例分佔被收購方之可識別資產淨值之已確認金額計量。計量基準選擇乃按逐項交易基準作出。其他類型之非控股權益均按公平值或(倘適用)按其他香港財務報告準則所規定之基準計量。

倘本集團於業務合併中所轉讓代價包括或然代價安排所引致之資產或負債，則或然代價按收購日期公平值計量，並作為業務合併中所轉讓代價之一部份入賬。合資格作為計量期間調整之或然代價之公平值變動為於「計量期間」(其不可超過收購日期起計一年)所獲得之有關於收購日期存在之事實及情況之額外資料產生之調整。

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured at subsequent reporting dates in accordance with HKAS 39, or HKAS 37 *Provisions, Contingent Liabilities and Contingent Assets*, as appropriate, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control) and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period (see above), or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

(d) Subsidiaries

A subsidiary is an entity controlled by the Company. Control exists when the Company has the power, directly or indirectly, to govern the financial and operating policies of an entity so as to obtain benefits from its activities. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Company control another entity.

In the Company's financial statements, the investments in subsidiaries that are not classified as held for sale are stated at cost less provision for impairment losses. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

不合資作為計量期間調整之或然代價之公平值變動之其後會計處理取決於或然代價如何分類。被分類為權益之或然代價於其後報告日期不會重新計量，而其其後結算於權益內確認。分類為一項資產或一項負債之或然代價於其後報告日期根據香港會計準則第39號或香港會計準則第37號撥備、或然負債及或然資產(如適用)重新計量，而相應收益或虧損於損益中確認。

倘業務合併乃分階段取得，則本集團先前於被收購方持有之股本權益於收購日期(即本集團獲得控制權日期)重新按公平值計量，而就此產生之收益或虧損(如有)於損益中確認。於收購日期前因於被收購方之權益產生且以往已於其他全面收益確認之金額乃重新分類至損益(如出售該權益時有關處理屬適當)。

倘業務合併之初步會計處理於合併發生之報告期末前未完成，則本集團報告會計處理未完成之項目之暫時金額。於計量期間(見上文)調整該等暫時金額，或確認額外資產或負債，以反映所獲得之有關於收購日期存在之事實及情況之新資料(倘獲悉，則應會影響於該日所確認之金額)。

(d) 附屬公司

附屬公司乃由本公司控制之企業。當本公司有權力直接或間接監管一間企業之財務及經營政策，藉此自其業務獲得利益，則存在控制權。在評估本集團是否控制另一企業時，將考慮目前可行使或可轉換的潛在投票權是否存在及其影響。

於本公司之財務報表，並非列為持作銷售之附屬公司投資乃按成本值減去減值虧損準備列賬。附屬公司之業績由本公司根據已收及應收股息入賬。

(e) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for estimated customer returns, rebates and other similar allowance.

Sale of goods

Revenue from the sale of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Agency fee

Agency fee is recognised when the services is rendered.

Interest income

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

收入乃按已收或應收代價之公平值計量。收入就估計客戶退貨、回扣及其他類似折扣作出扣減。

銷售貨品

貨品銷售收入於交付貨品及已轉移所有權時確認，當時符合下列所有條件：

- 本集團已將貨品擁有權之重大風險及回報轉移予買方；
- 本集團並無保留一般與擁有權有關之銷售貨品持續管理權或實際控制權；
- 銷售收入金額能夠可靠地計量；
- 與交易相關之經濟利益很可能流入本集團；及
- 有關交易產生或將產生之成本能夠可靠地計量。

代理費

代理費乃於提供服務時予以確認。

利息收入

在經濟利益可能流入本集團及收入金額能夠可靠地計量之情況下，金融資產之利息收入會被確認。利息收入乃參照未償還本金按適用之實際利率（即準確貼現金融資產預計年內估計未來現金收入至資產於初始確認時之賬面淨值之利率）按時間比例計算。

Property, plant and equipment held for use in the production or supply of goods or services, or for administrative purposes, are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and their useful lives.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

(g) Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) that is expected to benefit from the synergies of the combination.

A cash-generating unit to which goodwill has been allocated is tested for impairment annually, or more frequently when there is indication that the unit may be impaired. If the recoverable amount of the cash-generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit on a pro-rata basis based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the profit or loss on disposal.

持作生產或供應貨品或服務或作行政用途之物業、廠房及設備按成本減其後累計折舊及其後累計減值於綜合財務狀況表內列賬。

折舊按其估計可使用年期並計入其估計餘值以直線法撇銷其成本。估計可使用年期、餘值及折舊方法於每個報告期間末進行檢討，而估算任何變動之影響按未來適用基準入賬。

根據融資租約持有之資產按彼等之預計可使用年期按自有資產相同之基準進行折舊。然而，當無法合理確定於租期結束前將獲得所有權，則資產按租期及彼等之可使用年期兩者之較短者進行折舊。

物業、廠房及設備項目於出售時或當繼續使用該資產預期不會產生任何日後經濟利益時取消確認。出售或報廢物業、廠房及設備項目所產生之任何收益或虧損按該資產之出售所得款項與賬面值間之差額釐定，並於損益中確認。

(g) 商譽

自收購業務產生之商譽以於收購業務日期所確定之成本(見上述會計政策)減累計減值虧損(如有)列賬。

就減值測試而言，商譽分配至預期將受惠於合併協同效益之各本集團現金產生單位(或現金產生單位組別)。

獲分配商譽之現金產生單位於每年(或如有跡象顯示該單位可能已經減值時，曾更頻繁地)進行減值測試。當現金產生單位之可收回金額少於該單位之賬面值時，減值虧損首先分配作減低該單位獲分配之任何商譽之賬面值，其後根據該單位中各項資產賬面值之比例分配予該單位之其他資產。商譽之任何減值虧損直接於損益賬中確認。商譽之減值虧損不會於隨後期間撥回。

於出售相關現金產生單位時，釐定出售損益金額時計入應佔商譽之金額。

(h) Investment in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting, except when the investment, or a portion thereof, is classified as held for sale, in which case it is accounted for in accordance with HKFRS 5. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 Impairment of Assets as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs to sell) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

(h) 於聯營公司之投資

聯營公司為本集團對其有重大影響力之實體。重大影響力指有權參與決定被投資方財務及營運政策，惟並無控制或共同控制該等政策。

聯營公司之業績以及資產及負債已採用權益會計法計入綜合財務報表內，惟倘投資或其一部分被分類為持作出售，則會根據香港財務報告準則第5號入賬。根據權益法，於聯營公司之投資初步以成本值於綜合財務狀況表內確認，其後予以調整以確認本集團於聯營公司應佔溢利或虧損及其他全面收益。倘本集團應佔聯營公司虧損超出本集團於聯營公司之權益(包括實質上構成本集團於聯營公司之投資淨額部分之任何長期權益)，則本集團終止進一步確認應佔虧損。僅當本集團產生法定或推定責任或代表該聯營公司付款時，方會確認額外虧損。

於聯營公司之投資乃自該被投資方成為聯營公司之日起採用權益法入賬。於收購聯營公司投資時，該投資成本超出本集團分佔該被投資方之可識別資產及負債之公平淨值之任何部份乃確認為商譽，該商譽計入該投資之賬面值。本集團分佔可識別資產及負債之公平淨值超過該投資成本之任何部份經重新評估後即時於收購該投資期間之損益中確認。

香港會計準則第39號之規定獲應用，以釐定是否有必要就本集團於聯營公司之投資確認任何減值虧損。於必要時，根據香港會計準則第36號資產減值作為單一資產對該投資(包括商譽)之全部賬面值進行減值測試，方法為比較其可收回金額(使用價值與公平值減出售成本兩者之較高者)與其賬面值，所確認之任何減值虧損構成該投資賬面值之一部份。倘該投資之可收回金額其後增加，則根據香港會計準則第36號確認該減值虧損之任何撥回。

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate, or when the investment (or a portion thereof) is classified as held for sale. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with HKAS 39. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing of a part interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the equity method is discontinued.

The Group continues to use the equity method when an investment in an associate becomes an investment in a joint venture or an investment in a joint venture becomes an investment in an associate. There is no remeasurement to fair value upon such changes in ownership interests.

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a group entity transacts with an associate of the Group (such as a sale or contribution of assets), profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

倘本集團削減其於聯營公司之擁有權益而本集團繼續應用權益法，若有關收益或虧損會於出售相關資產或負債時重新分類至損益，則本集團會將先前已於其他全面收益確認與削減擁有權益有關之收益或虧損部分重新分類至損益。

倘集團實體與本集團之聯營公司進行交易（例如出售或注入資產），僅在聯營公司之權益與本集團無關之情況，與聯營公司進行交易所產生之溢利及虧損，方會於本集團綜合財務報表中確認。

(i) Financial instruments

Financial assets and financial liabilities are recognised on the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instruments. Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in consolidated statement of comprehensive income.

i. Financial assets

The Group's financial assets are classified into loans and receivables and available-for-sale financial assets. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales of financial assets that requires delivery of assets within the time frame established by regulation or convention in the marketplace. The accounting policies adopted in respect of each category of financial assets are set out below.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees on points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset, or, where appropriate, a shorter period.

Income is recognised on an effective interest basis for debt instruments other than those financial assets designated as at fair value through profit or loss, of which interest income is included in net gains or losses.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. At the end of each reporting period subsequent to initial recognition, loans and receivables including trade receivables, other receivables, amount due from a director, deposits with banks and cash and cash equivalents are carried at amortised cost using the effective interest method, less any identified impairment losses (see accounting policy on impairment loss on financial assets below).

當一家集團企業成為財務工具合約其中一方時，於綜合財務狀況表內確認為財務資產或財務負債。財務資產及負債初步以公平值計量。直接歸於收購或發行財務資產或負債之交易成本（按公平值計入損益賬之財務資產及財務負債除外），於初步確認時計入財務資產或負債之公平值或從中扣減。收購按公平值計入損益賬之財務資產或財務負債直接應佔的交易成本即時於綜合全面損益賬內確認。

i. 財務資產

本集團之財務資產劃分為貸款及應收款項及可供出售金融資產。財務資產之所有正常購買及出售均按交易日期基準確認及取消確認。正常購買及銷售乃指須按規定或市場慣例規定之時間內交收財務資產。每類財務資產採用之會計政策說明如下。

實際利息法

實際利息法為計算財務資產之攤銷成本以及分配於有關期間的利息收入之方法。實際利率是將財務資產於預計可用年期或（倘適用）在較短期間內的估計未來現金收入（包括所支付或收取能構成整體實際利率之所有費用、交易成本及其他溢價或折讓）準確折算的利率。

就債務文據而言，利息收入按實際利率基準確認，惟指定按公平值計入損益賬之財務資產除外，其利息收入乃計入淨收益或虧損。

貸款及應收款項

貸款及應收款項乃固定或可釐定付款，並未於活躍市場掛牌之非衍生財務資產。於初步確認後之每個報告期完結日，貸款及應收款項包括應收款項、其他應收款項、應收一名董事款項、銀行存款以及現金及現金等值項目，按實際利率法計算之攤銷成本減任何可識別之減值虧損（見下文有關財務資產減值虧損之會計政策）入賬。

Available-for-sale financial assets

Available-for-sale financial assets are non-derivatives that are either designated or not classified as any of the other categories. At the end of each reporting period subsequent to initial recognition, available-for-sale financial assets are measured at fair value. Changes in fair value are recognised in equity, until the financial asset is disposed of or is determined to be impaired, at which time, the cumulative gain or loss previously recognised in equity is removed from equity and recognised in consolidated statement of comprehensive income. Any impairment losses on available-for-sale financial assets are recognised in consolidated statement of comprehensive income. Impairment losses on available-for-sale equity investments will not reverse in subsequent periods. For available-for-sale debt investments, impairment losses are subsequently reversed if an increase in the fair value of the investment can be objectively related to an event occurring after the recognition of the impairment loss.

For available-for-sale equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured, they are measured at cost less any identified impairment losses at the end of each reporting period subsequent to initial recognition. An impairment loss is recognised in consolidated statement of comprehensive income when there is objective evidence that the asset is impaired. The amount of the impairment loss is measured as the difference between the carrying amount of the asset and the present value of the estimated future cash flows discounted at the current market rate of return for a similar financial asset. Such impairment losses will not reverse in subsequent periods.

Impairment of financial assets

Financial assets, other than those at financial assets at fair value through profit or loss, are assessed for indicators of impairment at the end of each reporting period. Financial assets are impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been impacted.

For all other financial assets, objective evidence of impairment could include:

- (i) significant financial difficulty of the issuer or counterparty; or
- (ii) default or delinquency in interest or principal payments; or
- (iii) it becoming probable that the borrower will enter bankruptcy or financial re-organisation.

可供出售金融資產為指定或並無分類為任何其他類別之非衍生工具。於初步確認後之各個報告期末，可供出售金融資產乃按公平值計量。公平值變動於權益內確認，直至金融資產被出售或被釐定出現減值，屆時，先前於權益內確認之累計收益或虧損由權益剔除，並於綜合全面收益表內確認。可供出售金融資產之任何減值虧損乃於綜合全面收益表內確認。可供出售股本投資之減值虧損於其後期間將不會撥回。就可供出售債務投資而言，倘投資之公平值之增加可與確認減值虧損後發生之任何事件客觀聯繫，則減值虧損其後予以撥回。

就於活躍市場上並無市場報價及其公平值不能可靠計量之可供出售股本投資而言，彼等於初步確認後之各個報告期末乃按成本減任何已識別減值虧損計量。當有客觀證據表明資產出現減值時，減值虧損乃於綜合全面收益表內確認。減值虧損金額乃按資產賬面值與按類似金融資產之現時市場回報率貼現之估計未來現金流量之現值間之差額計量。有關減值虧損於其後期間將不會撥回。

財務資產減值

於各報告期完結日評估財務資產有否減值跡象，惟按公平值計入損益賬之財務資產除外。倘有客觀證據顯示財務資產首次確認後發生的一項或多項事件導致相關投資之估計未來現金流量被削弱，則財務資產視為已減值。

就所有其他財務資產而言，減值之客觀證據可以包括：

- (i) 發行人或交易對手出現重大財政困難；或
- (ii) 拖欠或不支付利息或本金；或
- (iii) 借貸方很可能破產或進行財務重組。

For certain categories of financial asset, such as trade receivables, assets that are assessed not to be impaired individually are subsequently assessed for impairment on a collective basis. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the average credit period over 180 days, observable changes in national or local economic conditions that correlate with default on receivables.

For financial assets carried at amortised cost, an impairment loss is recognised in profit or loss when there is objective evidence that the asset is impaired, and is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the original effective interest rate.

For financial assets carried at cost, the amount of impairment loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the current market rate of return for a similar financial asset. Such impairment loss will not be reversed in subsequent periods.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets with the exception of trade receivables, where the carrying amount is reduced through the use of an allowance account. Changes in the carrying amount of the allowance account are recognised in profit or loss. When a trade receivable is considered uncollectable, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited to profit or loss.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment losses was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

Impairment losses on available-for-sale equity investments will not be reversed in profit or loss in subsequent periods. Any increase in fair value subsequent to impairment loss is recognised directly in equity.

就若干類別之財務資產(例如貿易應收款項)而言,被評為不會單獨作出減值之資產會於其後彙集一併評估減值。應收款項組合出現減值之客觀證據包括本集團之收款記錄、組合內延遲付款之拖欠期超過180日平均信貸期之宗數上升,以及國家或地區經濟狀況出現明顯變動導致應收款項未能償還。

就按已攤銷成本列賬之財務資產而言,當有客觀證據證明資產已減值,減值虧損於損益賬確認,並按資產賬面值與按原實際利率貼現之估計日後現金流量現值之差額計算。

就按成本列賬之財務資產而言,減值虧損金額乃資產賬面值與估計未來現金流折現計算的現值兩者之間的差額,而折現率為同類財務資產之現時市場回報率。該減值虧損不可在往後期間撥回。

所有財務資產之減值虧損會直接於財務資產之賬面值中作出扣減,惟貿易應收款項除外,貿易應收款項之賬面值會透過撥備賬作出扣減。撥備賬內之賬面值變動會於損益賬確認。當貿易應收款項被視為不可回收時,將於撥備賬撇銷。先前已撇銷的款項如其後收回,將撥回損益賬。

就按攤銷成本計量之財務資產而言,倘減值虧損額於其後期間減少,而有關減少在客觀上與確認減值後發生之事件有關,則先前已確認之減值虧損將透過損益賬予以撥回,惟該資產於減值被撥回當日之賬面值不得超過未確認減值時應有之已攤銷成本。

可供出售股本投資之減值虧損於其後期間將不會於損益中撥回。減值虧損後公平值之任何增加直接於權益中確認。

ii. Financial liabilities and equity

Financial liabilities and equity instruments issued by a group entity are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

An equity instrument is any contract that evidences a residual interest in the assets of the group after deducting all of its liabilities. The Group's financial liabilities are classified into other financial liabilities. The accounting policies adopted in respect of financial liabilities and equity instruments are set out below.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments through the expected life of the financial liability, or, where appropriate, a shorter period.

Interest expense is recognised on an effective interest basis other than those financial liabilities designated as at fair value through profit or loss, of which the interest expense is included in net gains or losses.

Other financial liabilities

Other financial liabilities including trade payables, accrued liabilities and other payables, amount(s) due to a shareholder(s), borrowings, obligations under finance leases and promissory note, are subsequently measured at amortised cost, using the effective interest rate method.

Convertible notes

Convertible notes issued by the Company that contain both financial liability and equity components are classified separately into respective liability and equity components on initial recognition. On initial recognition, the fair value of the liability component is determined using the prevailing market interest rate of similar non-convertible debts. The difference between the gross proceeds of the issue of the convertible loan notes and the fair value assigned to the liability component, representing the embedded call option for the holder to convert the notes into equity, is included in equity (convertible notes equity reserve). Transaction costs that relate to the issue of the convertible notes are allocated to the liability and equity components in proportion to the allocation of the gross proceeds.

由一間集團實體發行之財務負債及權益工具，乃依據所簽署合約安排之內容，以及對財務負債及權益工具之界定進行歸類。

一項權益工具乃證明於集團資產之剩餘權益(扣減其所有負債後)之任何合約。本集團之財務負債列為其他財務負債。就財務負債及權益工具所採納的會計政策如下。

實際利息法

實際利息法為計算財務負債之攤銷成本以及分配於有關期間的利息開支之方法。實際利率是將財務負債在預計年期或(倘適用)在較短期間內的估計未來現金付款準確折算的利率。

利息開支按實際利率基準確認，惟指定按公平值計入損益賬之財務負債除外，其利息開支乃計入淨收益或虧損。

其他財務負債

其他財務負債包括貿易應付款項、累計負債及其他應付款項、應付股東款項、借貸、融資租約責任及承兌票據，乃採用實際利率法計算攤銷成本入賬。

可換股票據

In subsequent periods, the liability component of the convertible notes is carried at amortised cost using the effective interest method. The equity component, representing by the option to convert the liability component into ordinary shares of the Company, will remain in convertible notes reserve until the embedded option is exercised (in which case the balance stated in convertible notes equity reserve will be transferred to share capital and share premium). Where the option remains unexercised at the expiry date, the balance stated in convertible loan notes equity reserve will be released to retained profits. No gain or loss is recognised in consolidated statement of comprehensive income upon conversion or expiration of the option.

If the conversion option of convertible notes exhibits characteristics of an embedded derivative, it is separated from its liability component. On initial recognition, the derivative component of the convertible notes is measured at fair value and presented as part of derivative financial instruments. Any excess of proceeds over the amount initially recognised as the derivative component is recognised as the liability component. Transaction costs are apportioned between the liability and derivative components when the instruments are initially recognised. The portion of the transaction costs relating to the liability component is recognised initially as part of the liability. The portion relating to the derivative component is recognised immediately in the consolidated statement of comprehensive income.

Derivative financial instruments

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss immediately unless the derivative is designated and effective as a hedging instrument, in which case the timing of the recognition in profit or loss depends on the nature of the hedge relationship.

Warrants

Warrants issued by the Company that will be settled by other than a fixed amount of cash for a fixed number of the Company's own equity instruments are derivative financial instruments. Warrants classified as derivative financial instruments are recognised at their fair values at the date of issue. Changes in fair values in subsequent periods are recognised through profit or loss.

Warrants issued by the Company that will be settled by a fixed amount of cash for a fixed number of the Company's own equity instruments are equity instruments. The net proceeds received from the issue of warrants is recognised in equity (warrant reserve). The warrant reserve will be transferred to share capital and share premium accounts upon the exercise of the warrants. When the warrants are still not exercised at the expiry date, the amount previously recognised in the warrant reserve will be transferred to accumulated losses.

iii. Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs. Repurchases of the Company's own equity instruments is recognised and deducted directly in equity.

iv. Derecognition

Financial assets are derecognised when the rights to receive cash flows from the assets expire or, the financial assets are transferred and the Group has transferred substantially all the risks and rewards of ownership of the financial assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised directly in equity is recognised in consolidated statement of comprehensive income.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid or payable is recognised in consolidated statement of comprehensive income.

(i) Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the consolidated statement of profit or loss and other comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

現時稅項

現時應付的稅項乃根據本年度的應課稅溢利計算。應課稅溢利與綜合損益表所載「除稅前溢利」有所不同，乃由於應課稅溢利不包括於其他年度的應課稅或可予扣減的收入或開支項目，而該等項目為永遠毋須課稅或扣減的項目。本集團現時稅項之負債乃採用於報告期末前已實行或大致實行之稅率計算。

遞延稅項

遞延稅項確認為在綜合財務報表內資產與負債的賬面值與採用應課稅溢利計算的相應稅基的暫時差額。遞延稅項負債一般就所有應課稅暫時時差確認入賬，而遞延稅項資產一般則會在預期應課稅溢利可供用作抵銷可予扣減暫時時差時確認為所有可扣減暫時時差額。倘暫時時差乃因商譽或因一項交易涉及的其他資產及負債進行初步確認時（不包括業務合併）產生，而不會影響應課稅溢利或會計溢利，則不會確認該等遞延資產及負債。

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

(k) Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events and it is probable that the Group will be required to settle the obligation, and a reliable estimate of the amount of the obligation can be made.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

當結算撥備所需之部份或全部經濟利益預期可自第三方收回時，倘大致確定將可獲償付及應收款項金額可作可靠估算，則將應收款項確認為資產。

(l) Contingent liabilities and contingent assets

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amount of obligation cannot be measured reliably. A contingent liability is not recognised but is disclosed in the notes to the financial statements. When a change in the probability of an outflow occurs so that outflow is probable, they will then be recognised as a provision.

A contingent asset is a possible asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. A contingent asset is not recognised but is disclosed in the notes to the financial statements when an inflow of economic benefits is probable. When inflow is virtually certain, an asset is recognised.

(m) Dividends distribution

Final dividend proposed by the directors are classified as a separate allocation of retained profits within the equity section of the consolidated statement of financial position, until they have been approved by shareholders in a general meeting. When these dividends have been approved by the shareholders and declared, they are recognised as a liability in the Group's financial statements.

Interim dividends are recognised as a liability when they are proposed and declared.

(n) Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for:

- exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings;

中期股息於建議及宣派時確認為負債。

(n) 外幣

於編製各個別集團實體之財務報表時，以該實體功能貨幣以外之貨幣(外幣)進行之交易均按交易日期之適用匯率確認。於各報告期末，以外幣定值之貨幣項目均按該日之適用匯率重新換算。按公平值以外幣定值之非貨幣項目乃按於公平值釐定當日之適用匯率重新換算。按外幣過往成本計量之非貨幣項目毋須重新換算。

貨幣項目之匯兌差額均於彼等產生期間內在損益中確認，惟以下各項除外：

- exchange differences on transactions entered into in order to hedge certain foreign currency risks (see the accounting policies below); and
- exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on repayment of the monetary items.

For the purposes of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of foreign currency translation reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that includes a foreign operation that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e. partial disposals of associates or joint arrangements that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments to identifiable assets acquired and liabilities assumed through acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

就呈列綜合財務報表而言,本集團之海外業務之資產及負債乃按於各報告期末之適用匯率換算為本集團之列賬貨幣(即港元)。收入及支出項目乃按該期間之平均匯率進行換算,除非匯率於該期間內出現大幅波動,於此情況下,則採用於交易當日之適用匯率。所產生之匯兌差額(如有)於其他全面收益確認並於匯兌儲備下之權益累計(歸入非控股權益(如適用))。

(o) Employee benefits

i. Paid leave carried forward

The Group provides paid annual leave to its employees under their employment contracts on a calendar year basis. Under certain circumstances, such leave which remains untaken as at the end of the reporting period is permitted to be carried forward and utilised by the respective employees in the following year. No accrual is made at the end of the reporting period for the expected future cost of such paid leave earned during the year by the employees and carried forward as the amount is immaterial.

ii. Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefits scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operates in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The contributions are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the central pension scheme.

(p) Equity-settled share-based payment transaction

Share Options Scheme and Share Award Scheme

The fair value of share options and awarded shares granted to employees in an equity-settled share based payment transaction is recognised as an employment cost with a corresponding increase in the employee share-based compensation reserve within equity. In respect of share options, the fair value is measured at grant date using the Binomial option pricing model, taking into account the terms and conditions upon which the options were granted. In respect of awarded shares, the fair value is based on the closing price at the grant date. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share options and awarded shares, the total estimated fair value of the share options and awarded shares is spread over the vesting period, taking into account the probability that the share options and awarded shares will vest.

(o) 僱員福利

i. 有薪假期結轉下年度

本集團根據僱員合約，按曆年基準向僱員提供有薪年假福利。在若干情況，有關僱員在報告期完結日尚餘之有薪假期可結轉下一個曆年並由僱員動用。基於涉及之款額微不足道，故在報告期完結日並未就此等僱員年內應計及結轉下年度之有薪假期之預期未來累計成本列賬。

ii. 退休福利計劃

本集團根據強制性公積金計劃條例設立界定供款強制性公積金退休福利計劃（「強積金計劃」）供合資格參與強積金計劃之有關僱員參與。根據強積金計劃之規則，供款額為僱員基本薪金之某個百分比，並於應繳付時在綜合全面損益賬扣除。強積金計劃之資產與本集團之資產分開持有，並由獨立運作之基金管理。本集團之僱主供款於對強積金計劃供款時全數歸於僱員。

於中國內地經營之本集團附屬公司之僱員須參與由當地市政府設立之中央退休福利計劃。根據中央退休福利計劃之規則，供款乃當其應繳付時於綜合全面損益賬扣除。

(p) 以權益結算並以股份為基礎之付款交易

認股權計劃及股份獎勵計劃

於股本償本之股份為本交易賦予員工的認股權及獎授股份之公允價值被確認為員工成本，並在股東權益內的以股份為本之僱員補償儲備作相應的增加。有關認股權之公允價值乃採用二項式期權定價模式，按認股權授予日及授予認股權的條款而計算。至於獎授股份方面，其公允價值是已支付之代價。當僱員須符合歸屬期條件才可無條件享有該等認股權及獎授股份，認股權及獎授股份的預計公允價值總額在歸屬期內攤分入賬，並已考慮認股權及獎授股份歸屬的或然率。

During the vesting period, the number of share options and awarded shares that is expected to vest is reviewed. Any adjustment to the cumulative fair value recognised in prior years is charged/credited to the statement of comprehensive income for the year of the review, with a corresponding adjustment to the employee share-based compensation reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of share options and awarded shares that vest (with a corresponding adjustment to the employee share-based compensation reserve).

The equity amount for the share options is recognised in the employee share-based compensation reserve until either the option is exercised (when it is transferred to the share premium account) or the option expires (when it is released directly to retained profits).

Where the shares of the Company are acquired under the Share Award Scheme, the consideration paid, including any directly attributable incremental costs, is presented as "Shares held for Share Award Scheme" and deducted from total equity.

When the awarded shares are transferred to the awardees upon vesting, the related weighted average cost of the awarded shares vested are credited to "Shares held for Share Award Scheme", and the related employment costs of the awarded shares vested are debited to the employee share-based compensation reserve. The difference between the related weighted average cost and the related employment costs of the awarded shares is transferred to retained profits.

Where the Shares held for Share Award Scheme are revoked and the revoked shares are disposed of, the related gain or loss is transferred to retained profits, and no gain or loss is recognised in the consolidated statement of comprehensive income.

Where the cash or non-cash dividend distribution is declared in respect of the shares held for Share Award Scheme, the cash or fair value of the non-cash dividend is transferred to retained profits, and no gain or loss is recognised in the consolidated statement of comprehensive income.

A related party is a person or entity that is related to the Group if:

(A) A person or a close member of that person's family is related to the Group if that person:

- (i) has control or joint control over the Group;
- (ii) has significant influence over the Group; or
- (iii) is a member of the key management personnel of the Group or of a parent of the Group.

(B) An entity is related to the Group if any of the following conditions applies:

- (i) The entity and the Group are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
- (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- (iii) Both entities are joint ventures of the same third party.

(r) Cash and cash equivalents

Cash and cash equivalents include cash at bank and on hand, demand deposits and short-term, highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

(s) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(t) Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessee

Assets held under finance leases are initially recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as a finance lease obligation.

Lease payments are apportioned between finance expenses and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in profit or loss, unless they are directly attributable to qualifying assets, in which case they are capitalised in accordance with the Group's general policy on borrowing costs (Note 3(s)). Contingent rentals are recognised as expenses in the periods in which they are incurred.

Operating lease payments are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

(r) 現金及現金等值項目

現金及現金等值項目包括銀行及手頭上現金、活期存款及可隨時轉換為已知數額的現金、並無重大價值變動風險及一般於購入後三個月內屆滿的短期高流動投資，減去須按要求償還之銀行透支，並構成本集團現金管理之整體部份。

(s) 借貸成本

直接歸屬於收購、建造或生產合資格資產(為需用較長時間才可作擬定用途或出售的資產)的借貸成本計入該等資產之成本，直至資產大致可用於其擬定用途或出售時為止。

有待於合資格資產支銷之有關特定借貸暫時投資所賺取之投資收入，自合資格資本化之借貸成本中扣除。所有其他借貸成本乃於其所產生期間於損益表確認。

(t) 租賃

倘在租賃有效期內，資產所有權之絕大部份風險及回報均轉讓予承租人，該租賃即被列為融資租賃。其他租賃均被列為經營租賃。

本集團作為承租人

根據融資租約持有之資產初步按彼等於租約開始時之公平值或(倘更低)最低租約付款額之現值確認為本集團之資產。對出租人之相應責任作為融資租約責任計入綜合財務狀況表。

租約付款額乃於融資費用及租約責任減少間分攤，以取得責任餘下結餘之不變利率。融資租約即時於損益中確認，除非彼等直接歸屬於合資格資產，則另當別論，於此情況下，彼等根據本集團有關借貸成本之一般政策(附註3(s))予以資本化。或然租金於產生期間內確認為開支。

經營租約付款額乃以直線法按租期確認為一項開支，惟倘另一系統基準更能代表租賃資產之經濟利益被消耗之時間模式，則除外。經營租約產生之或然租金於產生期間內確認為一項開支。

倘收取租約獎勵以訂立經營租約，則有關獎勵確認為一項負債。獎勵利益總額以直線法確認為租金費用之扣減，惟倘另一系統基準更代表租賃資產之經濟利益被消耗之時間模式，則除外。

(u) Segment reporting

Operating segments, and the amounts of each segment item reported in the financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type of class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

4. CRITICAL ACCOUNTING JUDGMENTS AND SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in Note 3 to the consolidated financial statements, management is required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgments in applying accounting policies

The followings are the critical judgments, apart from those involving estimations, that management has made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

(i) Income taxes

The Group is subject to income taxes in numerous jurisdictions. Significant judgment is required in determining the worldwide provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

(u) 分部呈報

經營分部及財務資料所呈報之各分部項目之金額，乃從為向本集團各項業務及地理位置分配資源及評估其業績而定期向本集團最高行政策者提供之財務報表當中加以識別。

就財務報告而言，將不會併入個別重要經營分部，除非該分部的產品及服務性質、生產工序性質、客戶類型或階層、分銷產品或提供服務方法及監管環境的性質等方面的經濟特性類似。倘個別不重要的經營分部符合上述大部份條件，則可併為一個報告分部。

於應用綜合財務報表附註3所載本集團之會計政策時，管理層須就從其他來源不顯而易見之資產及負債賬面值作出判斷、估計及假設。該等估計及相關假設乃以經驗及認為屬有關之其他因素而作出。實際結果可能有別於該等估計。

估計及相關假設按持續基準審閱。倘若會計估計修訂僅影響該期間，有關修訂會在修訂估計期間確認。倘若有關修訂影響當期及未來期間，有關修訂會在修訂期間及未來期間確認。

應用會計政策之關鍵判斷

除該等涉及估計之判斷外，以下關鍵判斷為董事於應用本集團之會計政策時所作出，並對綜合財務報表內已確認金額構成最重大影響。

(i) 所得稅

本集團須繳納多個司法權區之所得稅。於釐定世界各地之所得稅準備時需作出重要判斷。於正常業務過程中，有許多交易及計算均難以明確作出最終稅務釐定。本集團須估計未來是否會繳納額外稅項，從而確認對預期稅務審核事宜之責任。倘該等事宜之最終稅務結果與起初錄得之金額不同，差額將影響稅務釐定期內之所得稅及遞延稅項準備。

(ii) *Impairment of assets*

The Group tests annually whether the assets have suffered any impairment. The recoverable amount of an asset or a cash generating unit is determined based on value-in-use calculations which require the use of assumptions and estimates.

(iii) *Estimated impairment of goodwill*

The Group performs annual tests on whether there has impairment of goodwill in accordance with the accounting policy stated in Note 21. The recoverable amounts of cash generating units are determined based on value-in-use calculations. These calculations require the use of estimates and assumptions made by management on the future operation of the business, pre-tax discount rates, and other assumptions underlying the value-in-use calculations.

(iv) *Share-based payment*

The valuation of the fair value of share options granted requires judgment in determining the expected volatility of the share price, the dividends expected on the shares, the risk free interest rate during the life of the options and the number of share options that are expected to become exercisable, details of which are set in Note 38 to the consolidated financial statements. Where the actual outcome of the number of exercisable options is different from the previously estimated number of exercisable options, such difference will have impact on the consolidated statement of comprehensive income in the subsequent remaining vesting period of the relevant share options.

(v) *Estimated impairment of trade and other receivables*

When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, impairment loss may arise. As at 31 March 2014, the carrying amount of trade receivables and other receivables are approximately HK\$1,321,000 (2013: approximately HK\$21,381,000) and approximately HK\$95,725,000 (2013: approximately HK\$58,034,000) respectively.

(vi) *Fair value of derivatives and other financial instruments*

The fair values of derivative financial instruments are determined by using valuation techniques. The Group uses its judgment to select an appropriate valuation method and makes assumption that are mainly based on market conditions existing at the transaction date and each reporting date with reference to the valuation performed by APAC Asset Valuation and Consulting Limited (2013: Savills Valuation and Professional Services Limited), an independent firm of professional valuers. The valuation model requires the input of subjective assumptions, including the selection of relevant stock price, expected volatility, expected dividend yield, risk free rate and expected life. Changes in subjective input assumptions can materially affect the fair value estimate.

(ii) *資產減值*

本集團每年就資產有否減值進行測試。資產或現金產生單位之可回收金額，乃根據需要用上假設及估計之在用價值計算釐定。

(iii) *商譽之估計減值*

本集團分別根據財務報表附註21所載之會計政策，每年測試商譽是否出現任何減值。現金產生單位之可回收金額乃根據使用價值計算釐定。該等計算需要管理層對未來業務營運作出估計及假設、使用稅前折現率及其他有關使用價值計算之假設。

(iv) *以股份為基礎之付款*

評估已授出購股權之公平值時需要作出判斷，以釐定股價之預期波幅、股份之預計股息、購股權有效期內的無風險利率，以及預期可以行使之購股權的數目，有關詳情載於綜合財務報表附註38。若可行行使購股權之實際數目有別於原先估計，差額將影響有關購股權之其後餘下歸屬期的綜合損益賬。

(v) *貿易及其他應收款項之估計減值*

若出現減值虧損之客觀憑證，本集團將考慮有關未來現金流之估計。減值虧損之金額，是指資產賬面值與估計未來現金流（不包括尚未產生之未來信貸虧損）以財務資產的原訂實際利率（即初步確認時計算之實際利率）貼現之現值之間的差額。若未來現金流之實際金額低於預期，則可能出現減值。於二零一四年三月三十一日，貿易及其他應收款項之賬面值分別約為1,321,000港元（二零一三年：約21,381,000港元）及95,725,000港元（二零一三年：約58,034,000港元）。

(vi) *衍生工具及其他財務工具之公平值*

衍生金融工具的公平值乃採用估值技術釐定。本集團通過判斷來選擇適當的估值方法，並主要根據於交易日期及各報告日期存在之市況經參考由獨立專業估值師行亞太資產評估及顧問有限公司（二零一三年：第一太平戴維斯估值及專業顧問有限公司）進行的估值作出假設。估值模型需要輸入主觀假設（包括有關股價的選擇、預期波幅、預期股息收益率、無風險利率及預期可使用年期）。主觀輸入假設之變動可對公平值估計產生重大影響。

(vii) *Property, plant and equipment*

In accordance with HKAS 16, the Group estimates the useful lives of property, plant and equipment in order to determine the amount of depreciation expenses to be recorded. The useful lives are estimated at the time the asset is acquired based on historical experience, the expected usage, wear and tear of the assets, as well as technical obsolescence arising from changes in the market demands or service output of the assets. The Group also perform annual reviews on whether the assumptions made on useful lives continue to be valid.

5. FINANCIAL RISK MANAGEMENT

Financial risk management objectives and policies

The Group's major financial instruments include borrowings and cash and cash equivalents. Details of these financial instruments are disclosed in respective notes. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

Market risk

(i) *Foreign currency risk*

The Group operates mainly in the People's Republic of China (the "PRC") and Hong Kong and majority of transactions are denominated in Hong Kong dollars ("HK\$") and Renminbi ("RMB"). The Group is exposed to limited foreign exchange risk as most of the commercial transactions, assets and liabilities are denominated in a currency same as the functional currency of each entity of the Group. Therefore the Group will only exposed to foreign exchange risk arising from the assets and liabilities which are denominated in currencies other than the functional currency of the entity to which related. The conversion of RMB into foreign currencies is subject to the rules and regulations of foreign exchange control promulgated by the PRC government. The Group currently does not have a foreign currency hedging policy in respect of foreign currency assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(ii) *Price risk*

At the end of the reporting period, the Group did not have any financial assets and liabilities which are measured at fair value. The Group does not have significant exposure to price risk.

(iii) *Interest rate risk*

At the end of the reporting period, the Group did not have any financial assets and liabilities which are at floating rate of interests. The Group does not have significant exposure to interest rate risk.

(vii) *物業、廠房及設備*

根據香港會計準則第16號，本集團估計物業、廠房及設備之可使用年期，以釐定將予記賬之折舊開支之金額。本集團乃於購入資產時根據以往經驗、預期用途、資產之耗損以及因市場需求改變或運用資產提供服務而產生之技術性過時而估計可使用年期。本集團亦每年作出檢討，衡量對可使用年期所作假設是否仍然有效。

5. 財務風險管理

財務風險管理目標及政策

本集團之主要財務工具包括借貸以及現金及銀行結餘。該等財務工具之詳情乃於相關附註披露。與該等財務工具有關之風險及如何減低該等風險之政策載於下文。管理層會管理及監察該等風險，以確保可及時有效地實行適當措施。

市場風險

(i) *外匯風險*

本集團主要在中華人民共和國（「中國」）及香港經營業務，且大部份交易以港元（「港元」）及人民幣（「人民幣」）計值。由於大部份商業交易、資產及負債是以與本集團各實體功能貨幣相同之貨幣計值，本集團面對之外匯風險有限。因此，本集團將僅面對以該實體相關之功能貨幣以外之貨幣定值之資產及負債產生之外匯風險。人民幣兌換為外幣須遵守中國政府頒佈之外匯管制法規。本集團現時並無任何外國流動資產及負債之外幣對沖工具。本集團將密切監管其外幣風險，並於必要時考慮對沖重大外匯風險。

(ii) *價格風險*

價格風險於報告期完結日，本集團並無任何以公平值計量之財務資產及負債。本集團並無重大價格風險。

(iii) *利率風險*

於報告期末，本集團並無按浮動利率計息之任何金融資產及負債。本集團並無面臨重大利率風險。

Credit risk

As at 31 March 2014, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In this regards, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group's credit risk is primarily attributable to trade or other receivables. The Group has no significant concentrations of credit risk. The exposures to these credit risks are monitored on an ongoing basis.

The credit risk on liquid funds is limited because the counterparties are banks which are reputable in the opinion of management.

Liquidity risk

The Group manages liquidity risk by maintaining adequate cash and cash equivalents, monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

The liquidity risk is under continuous monitoring by management. Reports with maturity dates of borrowings and thus the liquidity requirement are provided to management for review periodically. Management will raise or refinance borrowings whenever necessary.

The table below analyses the Group's financial liabilities that will be settled into relevant maturity groupings based on the remaining period at the end of the reporting period to the contractual maturity date. The amounts disclosed in the table are based on the contractual undiscounted payments, as follows:

於二零一四年三月三十一日，因交易對方未能履行責任而可為本集團帶來財務虧損之本集團最大信貸風險，乃來自綜合財務狀況表所列各項已確認財務資產之賬面值。

為將信貸風險降至最低，本集團之管理層訂有信貸批准及其他監管程序，以確保採取跟進行動追收逾期債務。就此而言，本公司董事認為本集團之信貸風險已大幅降低。

Capital risk management

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of debts which includes amount(s) due to a shareholder(s), borrowings, obligations under finance leases, convertible notes and promissory note, cash and cash equivalents, and equity attributable to owners of the Company, comprising issued share capital and reserves.

The directors of the Company review the capital structure on an annual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital.

The Group monitors capital using gearing ratio, which is calculated as either total borrowings divided by total capital or net borrowings divided by total capital. The gearing ratios as at the end of the reporting period are as follows:

The recoverable amount of this cash-generating unit is determined based on a value-in-use calculation which uses cash flow projections based on financial budgets approved by the directors covering a five-year period, and a discount rate of 24% per annum.

Cash flow projections during the budget period are based on the same expected gross margins throughout the budget period. The cash flows beyond that five-year period have been extrapolated using a steady 3% per annum growth rate. The growth rate does not exceed the long-term average growth rate for the market. The directors believed that any reasonably possible change in the key assumptions on which the recoverable amount is based would not cause the carrying amount of the unit to exceed the aggregate recoverable amount of the cash generating unit.

The key assumptions used in the value-in-use calculations for the unconventional gas business are as follows:

The conversion option is therefore accounted for as an equity instrument and is determined after deducting the liability component and the derivative component from the total proceeds.

The embedded derivatives relating to the Company's early redemption option in Note (b) above which are not closely related to the host contract shall be separately measured and included together with the liabilities component as a financial liability. The fair value of the derivative component is determined based on the valuation using binomial option pricing model. The fair value of the liabilities component is determined based on the valuation performed by an independent valuer, Savills Valuation and Professional Services Limited, using discounted cash flow method. The effective interest rate of the host contract is determined to be 10.5%. The residual amount is assigned as the equity component for the conversion option and was included in the convertible notes equity reserve.

The liability component is carried as a current liability on the amortised cost basis until extinguished or conversion or redemption. The derivative component of the Convertible Notes 2008 is subsequently measured at fair value with changes recognised in the consolidated statement of comprehensive income. On 18 July 2013, GAHL transferred the Convertible Notes 2012 and all rights in respect thereof to Mr. Lin Long (the "Subscriber") pursuant to the captioned terms and conditions therein. An extraordinary meeting held on 16 August 2013, it has been approved the changes of terms and condition as well as the allotment and issue of the Replacement Shares and New Conversion Shares. At each reporting date, the embedded derivative component is remeasured and the change in fair value of that component is recognised in the consolidated statement of profit or loss and other comprehensive income. The fair value of the embedded derivatives have been determined by APAC Asset Valuation and Consulting Limited, an independent firm of professional valuer.

The Company's contributed surplus represents the excess of the fair value of the shares of the subsidiaries acquired pursuant to the Group reorganisation during the year ended 31 March 2002, over the nominal value of the Company's shares issued in exchange therefore and the capitalisation of the 30,000,000 shares allotted and issued nil paid. Under the Companies Law (2001 Second Revision) of the Cayman Islands, the contributed surplus account is distributable to the shareholders of the Company under certain circumstances. The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and/or rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants of the Scheme include any directors and employees of the Company, including all executive directors of the Company and its subsidiaries. The Scheme became effective on 8 October 2010 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period is limited to 1% of the shares of the Company in issue at any time. Any further grant of share option in excess of this limit is subject to shareholders' approval in a general meeting.

The share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their subsidiaries, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 28 days from the date of the offer, upon payment of a nominal consideration of HK\$1 in total by the grantee. The exercise period of the share options granted would be determined by the directors.

The exercise price of the share options would be determined by the directors, but may not be less than the higher of (i) the Stock Exchange closing price of the Company's shares on the date of the offer of the share options, which must be a business day; and (ii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately preceding the date of the offer, provided that the subscription price shall not be lower than the nominal value of the shares.

40. DISPOSAL OF SUBSIDIARIES

On 21 March 2014, the Company entered into a disposal agreement (the "Disposal Agreement") with Mr. Zheng Xuefeng ("Mr. Zheng") whereby the Company agreed to sell and Mr. Zheng agreed to purchase from the Company of the entire issued share capital of Wealthy Wing Limited (the "Sale Share") at the consideration of HK\$9,000,000. The disposal was completed on 31 March 2014. The Company through its subsidiary, has received the first instalment of the consideration of HK\$1,000,000. The Group ceased to have any interest in the Wealthy Wing Group and the financial results of the Wealthy Wing Group were no longer consolidated into the financial statements of the Group from 31 March 2014 onwards.

In accordance with the terms of the Disposal Agreement, Mr. Zheng as charger executed a share charge dated 31 March 2014 (the "Share Charge") in favor of the Company as charge whereby Mr. Zheng charged the Sale Share to the Company as security for his payment obligations in respect of balance of the consideration in the amount of HK\$8,000,000 under the Disposal Agreement. Pursuant to the Disposal Agreement, Mr. Zheng is required to settle the balance in full within six months after the completion date (i.e. 30 September 2014). The Share Charge will be released within five business days upon full settlement of the balance by Mr. Zheng.

(a) Claim made by the Company against Hung (the "Action")

As disclosed in the Company's announcements dated 16 December 2009 and 8 January 2010, the Company has commenced proceedings against Mr. Hung at the High Court with regards to a breach of contract by Mr. Hung, in connection with a sale and purchase agreement dated 25 September 2007 made between the Company and Mr. Hung (the "Agreement"). The Company sought advice from its legal advisers and formed the view that Mr. Hung had failed to perform one or more of the terms of the Agreement and is of the view that Mr. Hung is in breach of numerous representations and warranties under the Agreement. The Company claims against Mr. Hung, among other things, for all payments made by the Company to Mr. Hung under the Agreement and/or damages arising from the breach of the Agreement.

On 1 February 2010, the Company filed a statement of claim at the High Court against Mr. Hung, Mega Wealth and Webright (together referred to as the "Defendants") in connection with the Agreement, for, inter alia, rescission of the Agreement. Particulars of the Statement of Claim are summarised as follows:

- (1) The Company claims against Mr. Hung for:
 - (i) rescission of the Agreement;
 - (ii) the 76,640,000 shares of the Company ("Shares") at an issue price of HK\$0.5 per share;
 - (iii) the convertible note, issued to Mr. Hung pursuant to the Agreement, in the principal amount of HK\$173,500,000 convertible into ordinary shares of the Company at a conversion price of HK\$0.5 per share (the "Convertible Note");
 - (iv) further or alternatively, all payments made by the Company to Mr. Hung and/or damages arising from the breach of the Agreement;
 - (v) a declaration that Mr. Hung holds the 70,000,000 Shares and the Convertible Note and their traceable equivalent on trust for the Company and that all necessary tracing orders accounts and inquiries be taken as to what had happened to the said Shares and Convertible Note and to ascertain the traceable equivalent thereof;
 - (vi) an order for payment after having the above accounts and inquiries;

- (vii) payment of the legal costs incurred by the Company arising from the investigation and report arising from the matters in connection with the Agreement; and
 - (viii) payment of the costs incurred by the Company for the preparation and execution of the Agreement and supplemental agreements.
- (2) The Company also claims against Mega Wealth, inter alia, for the 100,000,000 Shares issued to Mr. Hung upon exercise of conversion rights of the Convertible Note and which were passed to Mega Wealth at an issue price of HK\$0.5 per Share.
- (3) The Company also claims against Webright, inter alia, for the 98,000,000 Shares issued to Mr. Hung upon exercise of conversion rights of the Convertible Note and which were passed to Webright at an issue price of HK\$0.5 per Share.

On 14 November 2011, the Company filed an amended Statement of Claim to the Court, the Defendants filed amended defence on 16 January 2012. Subsequently, the Company filed amended reply to Defendants' defence on 13 April 2012. The pleading stage of the proceedings is now closed. Now, the Company is preparing the lists of documents to be exchanged with Defendants, after which the parties would have to exchange witness statements.

On 21 August 2013, the Company received a summons from Mr. Hung, seeking leave from the High Court to re-amend Mr. Hung's defence and to add a counter-claim against the Company in the Action. The counter-claim of Mr. Hung to be added is for (i) payment of the unpaid cash consideration under the Agreement in the amount of HK\$158,600,000 plus interest and the outstanding balance of HK\$173,500,000 of the convertible note issued pursuant to the Agreement plus interest, both being part of the consideration under the Agreement; and (ii) repayment of certain loans and advances in the amount of HK\$12,600,000 made by Mr. Hung to the Company together with interest.

The Company maintains the view that Mr. Hung was in breach of the Agreement and is claiming Mr. Hung for, among other reliefs, rescission of the Agreement and/or damages for loss suffered. Accordingly, the Company is of the view that Mr. Hung's counter-claim for consideration under the Agreement is without ground. As to the loans and advances claimed, HK\$3,000,000 originated from the cash consideration paid under the Agreement and for the same reason mentioned the Company is of the view that Mr. Hung's claim is without ground. As to the remaining HK\$9,600,000 claimed, the Company is of the view that its claim in the Action shall extinguish Mr. Hung's counter-claim and has already provided sufficient security for such amount presented by Mr. Hung against the Company.

Up to the date of approval of these consolidated financial statements, no judgment has been made by the High Court. The Board of the Company, based on legal advices, the Company has a good arguable case against the Defendants to have the Agreement rescinded. The Board of the Company will follow closely on the development of the above matters and inform the shareholders of the Company on a timely basis.

(b) Injunction Order Against Hung

On 22 January 2010, the High Court granted an ex parte Injunction Order against the Defendants. The Injunction Order provides, among other things, that: unless with the approval of the High Court, Mr. Hung must not, either by himself, his servants or agents or otherwise howsoever in any way dispose of or deal with or diminish the value of any of the following assets:

- (i) the 76,640,000 Shares issued to Mr. Hung at an issue price of HK\$0.5 per Share;
- (ii) the Convertible Note issued by the Company to Mr. Hung;
- (iii) the 100,000,000 Shares issued to Mr. Hung upon exercise of conversion rights of the Convertible Note and which were passed to Mega Wealth at an issue price of HK\$0.5 per Share;
- (iv) the 98,000,000 of the Shares issued to Mr. Hung upon exercise of conversion rights of the Convertible Note and which were passed to Webright at an issue price of HK\$0.5 per Share;

All being part of the considerations given to Mr. Hung by the Company in respect of the Agreement.

On 29 January 2010, at the return date hearing in relation to the Injunction Order, it was ordered, inter alia, that the Injunction Order will continue subject to a fortification in the amount of HK\$10,000,000 being paid by the Company to the Registrar of the High Court on or before 12 February 2010, failing which the Injunction Order shall be discharged. The Company paid HK\$10,000,000 into the High Court on 10 February 2010 in compliance with the Injunction Order. Following a hearing held at the High Court on 18 March 2010, the High Court delivered its decision on 30 March 2010 to discharge and at the same time re-grant the Injunction Order obtained by the Company on 22 January 2010 against the Defendants. Furthermore, the Court made a cost order nisi that the Company should pay the Defendants' costs related to the discharge of the Injunction Order, which the Court has assessed to be four-fifths of the costs of the hearing. On 13 April 2010, the Defendants took out two summonses respectively for (i) an application for an order to vary the costs order nisi made in the said decision delivered on 30 March 2010, and (ii) an application for an order to have leave to appeal the said decision delivered on 30 March 2010, that the decision to re-grant the Injunction Order was wrong. On 14 May 2010, the Company and Mr. Hung, through their lawyers, entered into a consent summons whereby the hearing of the two summonses returnable on 26 May 2010 was adjourned without a further date of hearing, with liberty to restore.

On 3 September 2010, Mr. Hung through his solicitors applied by way of a Summons to vary the Injunction Order granted by the Honourable Mr. Justice Chung dated 30 March 2010 (the "Application") and the hearing was scheduled to be heard on 20 September 2010. The Court dismissed Mr. Hung's Application by way of summons, for an order to vary the Injunction Order made against the Defendants. The Court ordered costs of the summons be paid by the Defendants to the Company in any event.

On 22 September 2010, the Court of Appeal granted the Defendants leave to appeal to the Court of Appeal and heard the Defendants' appeal on 27 September 2010. Mr. Hung served the statutory demands on the Company in respect of a total outstanding Alleged Indebtedness of HK\$41,722,630 (the "Statutory Demands"). A winding-up petition (the "Winding-up Petition") was presented to the High Court and served on the Company by Mr. Hung on 28 January 2010 in connection with the Alleged Indebtedness. The Company intends to oppose the Winding-up Petition and has appointed legal advisers to handle the matter. The first hearing of the Winding-up Petition was held on 7 April 2010. At the second hearing held in the High Court on 12 April 2010, upon hearing submissions by the parties, the Companies Judge made an order that, among other things, the Winding-up Petition be adjourned to the second Monday after the date of handing down of judgment in connection with the Statement of Claim by which the Company has made a claim against Mr. Hung. On 24 August 2010, the Court made an order by consent of both parties to grant leave to the Petitioner to amend the Winding-up Petition and costs of and occasioned by the amendment of the Winding-up Petition be paid by the Petitioner to the Company in any event. The Petitioner amended the Winding-up Petition, including, among others, a reduction of the Alleged Indebtedness to HK\$9,600,000. The Board of the Company considers that the issue of the Statutory Demands is, of itself, unlikely to have a negative impact on the Group's financial condition. In addition, the Company may seek to set-off against the Alleged Indebtedness claims which the Company is asserting against Mr. Hung under the Statement of Claim.

On 18 February 2014, the Company has reached an agreement with Mr. Hung for the dismissal of the Winding-up Petition. Solicitors for both parties have signed a Consent Summons jointly applying to the Court for an Order that the Winding-up Petition be dismissed upon the Company undertaking to the Court that it shall not in any way dispose of or deal with the sum of HK\$10,658,922.00 deposited (and interest accrued) in the designated interest-bearing account in accordance with a previous undertaking given by the Company to the Court until after determination of the proceedings of HCA2477/2009 or until such other time as may be agreed in writing between the Company and Hung, with no order as to the costs of the Winding-up Petition between the Company and Hung.

On 19 February 2014, Mr. Hung was declared bankrupt by the High Court upon the petition by Toeca National Resources B.V., a substantial shareholder of the Company, based on a judgement debt in the proceeding of HCA1683/2009 of which Mr. Hung was ordered to pay HK\$116,820,000 with interest and costs.

On 24 February 2014, the Court approved the joint application of the Company and Hung to dismiss the Winding-up Petition. The Court further ordered that Hung shall pay the official receiver a sum of HK\$5,300 as the official receiver's costs (exclusive of costs previously awarded).

On 28 March 2014, the Company received a court order for the dismissal of the Winding-up Petition.

On 28 January 2010, by a letter to the High Court, Mr. Hung's solicitors applied for an early date for a first hearing of the application for appointment of provisional liquidators to the Company by Mr. Hung (the "Application"). A hearing in respect of the Application took place on 2 February 2010, at which a date was set down for a further hearing on 5 May 2010. The Company and Mr. Hung, through their lawyers, entered into a consent summons whereby the hearing scheduled on 5 May 2010 for the Application was adjourned without a further date of hearing, with liberty to restore. The Court made an order by consent on 26 April 2010 in this regard. Notwithstanding this, the Company received a letter from Mr. Hung's lawyers dated 15 June 2010 in which, among other things, Mr. Hung requested to set down a date for the hearing of the Application. The Application was scheduled to be heard on 9 November 2010. However, upon the joint application of Mr. Hung (the "Petitioner") and the Company by way of consent summons dated 4 November 2010 and upon the Company undertaking to the Court that:

- (i) On 9 November 2010, deposit the sum of HK\$10,658,922 into a designated interest-bearing bank account opened in the name of Company ("Designated Account") as security for the petitioning debt claimed by the Petitioner in these proceeding and will not use the monies as deposited in the Designated Account until after determination of HCA2477 of 2009 or upon such other condition as may be agreed between the Petitioner and the Company in writing;

On 5 January 2011, Mr. Hung filed a statement of claim against the Company claiming a total sum of HK\$3,407,962.74 plus interest, being, inter alia, (i) arrears of wages (the "Wages Claim") in the amount of HK\$1,668,000 and (ii) reimbursement of expenses (the "Reimbursement Claim") in the amount of HK\$1,739,962.74, allegedly incurred by Mr. Hung whilst he was in the employment of the Company.

The Wages' Claim was in relation to the same subject matter as was previously resolved and settled between the parties by Mr. Hung accepting a total sum of HK\$890,000 from the Company, pursuant to the Order of the Labour Tribunal dated 25 May 2010.

The Company has been advised that re-litigating the Wages' Claim in the High Court, the subject matter of which has already been resolved and settled, constitutes an abuse of process of the Court and is therefore liable to be struck out under the relevant Rules of Court. The Company will defend both the Wages' Claim and the Reimbursement Claim as advised. The Company filed a defence and counterclaim whereby the Company only agreed to pay a sum of HK\$74,221.20 out of Mr. Hung's claim, and counterclaimed against Mr. Hung for repayment of a sum of HK\$67,569 being, inter alia, unauthorised payments incurred by Mr. Hung on the Company's behalf and the value of the Company assets held by Mr. Hung. Mr. Hung has subsequently filed a reply and defence to counterclaim. The Group have filed with the Labour Tribunal a defence and counterclaim which the Group only agreed to pay a sum of approximately HK\$95,000 and counterclaimed against the Claimant for repayment of a sum of approximately HK\$128,000 being the amount of education subsidy received by the Claimant and a sum of an approximately HK\$46,000 being compensation for unauthorized absence from work and outstanding telephone bills. Pursuant to an Order by the Labour Tribunal dated 27 July 2010, the case was transferred to the District Court. At the directions hearing on 17 November 2010. The Court ordered that: (i) The Claimant do file and serve the Statement of Claim on or before 22 December 2010; (ii) The Sino Talent do file and serve the Defence and Counterclaim, if any, on or before 26 January 2011; (iii) The Claimant do file and serve the Reply and Defence to Counterclaim on or before 2 March 2011; and (iv) The costs of this directions hearing, assessed summarily in the sum of HK\$800 be costs in the cause. 45. EVENTS AFTER THE REPORTING PERIOD

Save as disclosed in Note 41 Litigations and Contingent Liabilities above and elsewhere in these consolidated financial statements, the Group has the following events occurred subsequent to the end of the reporting period:

- (i) On 21 March 2014, the Company, Mr. Zheng and the placing agent entered into the Tri-Party Agreement pursuant to which, among others, the parties agreed that the placing agent shall place 270,000,000 unreleased consideration shares to not less than six independent places at the placing price of HK\$0.188 per share on a best effort basis. On 30 May 2014, the parties to the Tri-Party Agreement entered into the second supplemental agreement to the Tri-Party Agreement to extend the long-stop date from 31 May 2014 to 31 July 2014.
- (ii) On 27 March 2014, a wholly-owned subsidiary of the Company (the "Purchaser"), Mr. Hu Pigang and Bao Sheng Ventures Limited (the "Vendors") entered into the sale and purchase agreement whereby the Purchaser conditionally agreed to acquire from the Vendors of 9% and 1.5% respectively of total issued shares of and total voting securities in Sino United Energy Investment Co., Ltd ("Sino United") at the consideration of HK\$150,000,000, which will be satisfied as to (a) HK\$89,500,000 by the issue of an aggregate of 500,000,000 consideration shares at the issue price of HK\$0.179 each by the Company to the Vendors; and (b) HK\$60,500,000 by the issue of the promissory notes by the Purchaser to the Vendors.

Sino United is an investment holding company incorporated in the BVI with limited liability and holds the entire issued share capital of Zhong Lian International Mining Industry Investment Co., Ltd ("Zhong Lian"), which in turns holds the entire issued share capital of LOVONKO Co. Ltd ("LOVONKO"). Zhong Lian and LOVONKO are companies incorporated in Mongolia. Sino United and its subsidiaries covers exploration, utilization and trading of mining resources.

Upon the completion of the sale and purchase agreement, Sino United will be held as to 10.5% by the Company via the Purchaser.

At the date of this report, the acquisition has not yet been completed. For further details, please refer to the Company's announcement dated 28 March, 11 & 30 April 2014.

- (iii) On 10 April 2014, the Company and Fortune Map Investments Limited ("Fortune Map") entered into the memorandum of understanding (the "MOU") whereby the Company and the Vendor agreed to negotiate in good faith to enter into the formal agreement on the possible acquisition.

Under the MOU, the Company will acquire certain % of the issued share capital of Wisdom Orchid Limited (the "Wisdom Orchid") from Fortune Map ("the Possible Acquisition"). Wisdom Orchid is an investment holding company incorporated in the BVI. Fortune Map also holds a Hong Kong Company, Wisdom Mega Inc Limited ("Wisdom Mega"). It is proposed that Wisdom Orchid and Wisdom Mega will undergo reorganisation involving (a) the acquisition of the entire issued share capital Wisdom Mega by Wisdom Orchid; and (b) the acquisition of the entire registered capital of Qinglong Manchu Autonomous County Shuangxin Mining Co., Ltd ("SX Mining") by Wisdom Mega ("Target Group Reorganisation").

SX Mining is a company established in the PRC and is principally engaged in iron ore refining by way of magnetic separation process in Qinhuangdao City, Hebei Province, the PRC.

Upon completion of the Target Group Reorganisation, the Possible Acquisition will comprise Wisdom Orchid, Wisdom Mega and SX Mining.
