#### 主席報告書 Chairman's Statement

#### 財政業績

本人欣然宣布本集團截至二零一四年三月三十一日止年度之經審核業績。於本年度,本集團之投資物業估值變動前的經營溢利為港幣502,700,000元,較上一財政年度上升約15.4%。該上升主要是國際廣場於本財政年度之租金收入較上一財政年度增加所致。

截至二零一四年三月三十一日止財政年度,投資物業估值盈利為港幣965,500,000元,較上一財政年度下跌約港幣1,403,600,000元。該估值盈利只會影響本集團在會計上的溢利或虧損,而不會對其現金流量造成影響。

本 集 團 之 權 益 股 東 應 佔 溢 利 為 港 幣 1,382,300,000 元,而上一財政年度則為港幣 2,733,600,000元。

#### 業務回顧及財政業績之評論

國際廣場是一個設有零售商舖、娛樂消遣場所和餐廳的綜合商舖中心。截至二零一四年三月三十一日止財政年度,國際廣場的租金收入約達港幣603,100,000元,較上一財政年度上升約16.8%。於二零一四年三月三十一日,國際廣場的出租率為100%,於二零一三年三月三十一日則約為97.8%。

#### 資本結構及流動資金

於二零一四年三月三十一日,本集團之權益總額為港幣13,441,300,000元,於二零一三年三月三十一日則為港幣12,455,000,000元。

本公司已於二零一三年十月償還其於二零零六年十月二十日簽訂之融資協議中港幣200,000,000元的銀行貸款餘額。於二零一三年十月七日,本公司與一間銀行訂立一份新融資協議,當中包括一筆為期三年,合共港幣200,000,000元的定期貸款和一筆為期三年,合共港幣100,000,000元的循環貸款。於二零一四年三月三十一日,本集團已動用的銀行信貸額達港幣200,000,000元,資本負債比率(以銀行貸款總額除以權益總額計算)為1.5%。

#### Financial Results

I am pleased to report the audited results of the Group for the year ended 31 March 2014. During the year, the Group achieved a profit from operations before valuation changes in investment properties of HK\$502.7 million, representing an increase of approximately 15.4% compared with the previous financial year. The increase was mainly due to increase of rental income from iSQUARE compared to the previous financial year.

Valuation gains on investment properties for the financial year ended 31 March 2014 amounted to HK\$965.5 million, representing a decrease of approximately HK\$1,403.6 million compared with the previous financial year. The valuation gains will only affect the accounting profit or loss but not the cash flow of the Group.

The Group recorded a profit attributable to equity shareholders of HK\$1,382.3 million, compared with a profit attributable to equity shareholders of HK\$2,733.6 million for the previous financial year.

# Business Review and Commentary on Financial Results

iSQUARE is a commercial complex housing retail, entertainment, food and beverage establishments. Rental income from iSQUARE amounted to approximately HK\$603.1 million for the financial year ended 31 March 2014, representing an increase of approximately 16.8% compared with the previous financial year. The occupancy rate at 31 March 2014 was 100% compared with approximately 97.8% at 31 March 2013.

#### Capital Structure and Liquidity

The total equity for the Group at 31 March 2014 was HK\$13,441.3 million, compared with HK\$12,455.0 million at 31 March 2013.

The Company repaid HK\$200 million in October 2013 for the remaining balance of the bank loan granted by the facility agreement entered on 20 October 2006. On 7 October 2013, the Company entered into a new facility agreement with a bank comprising of a 3-year term loan facility of up to HK\$200 million and a 3-year revolving loan facility of up to HK\$100 million. At 31 March 2014, the banking facilities were utilised to the extent of HK\$200 million and the Group's gearing ratio was 1.5% (calculated as total bank loans over total equity).

#### 商業模式及策略

本集團的業務是在香港進行物業投資。本集團投 資該物業市場以營造和保留其價值。

為此,本集團透過審慎的管理,致力推動其現有物業增長。除保持其謹慎、且務實的物業投資作風外,本集團亦尋求開拓未來的商機。為獲得穩定和經常性收益,本集團已採納非常嚴格的投資準則,並只著重探研高質素的項目和投資。

本集團明白,穩健的財務狀況對維持持續性增長 及未來發展的重要,因此,擁有充裕的現金流量 及低資本負債比率的資產負債表乃本集團之首要 策略。

#### 展望

鑑於零售業務受外在經濟環境、訪港旅客量及其 消費模式影響,管理層將審慎評估其對國際廣場 的影響。為提升國際廣場之租務表現,本集團將 採取適當的租務策略,以確保具有合適的租戶。 在無不可預見的情況下,管理層預計,下一財政 年度的國際廣場租金收入及本集團經營業績將繼 續令人滿意。

#### **Business Model and Strategies**

The Group's business is property investment in Hong Kong. The Group generates and preserves its value through being an investor in the property market.

To accomplish this, the Group strives to nurture growth from its existing properties through prudent management. Whilst the Group generally maintains a prudent and conservative approach towards property investment, it also seeks to exploit opportunities for future development. With the aim of securing stable and recurring returns, the Group has adopted very stringent investment criteria and targets only high quality projects and investments.

The Group recognises the importance of sound financial strength to support sustainable growth and future development and hence, its fundamental strategy is to maintain a solid balance sheet with strong cash flow and a low gearing ratio.

#### Outlook

Considering retail business could be affected by external economic environment, volume of visitor arrival and their spending habits, management will carefully evaluate their impact on iSQUARE. The Group will adopt appropriate leasing strategies for securing suitable tenants to enhance the leasing performance of iSQUARE. Barring unforeseen circumstances, it is anticipated that rental income from iSQUARE and the results from operations of the Group will continue to be satisfactory for the coming financial year.

#### 股東周年大會

#### 股息

董事會欣然建議派發截至二零一四年三月三十一 日止年度末期股息每股港幣0.60元(二零一三年: 每股港幣0.55元)。本公司已於本年度派發中期 股息每股港幣0.55元(二零一三年:每股港幣 0.45元), 連同建議派發的末期股息, 本年度將 共派息每股港幣1.15元(二零一三年:每股港幣 1.00元)。倘若建議分派的末期股息獲股東於 即將舉行的股東周年大會通過,本公司將於 二零一四年九月十日星期三起至二零一四年九月 十二日星期五止(首尾兩天包括在內)暫停辦理 股東登記手續,以便確認有權獲派末期股息之股 東,任何股份在該期間內均不得進行過戶。所有 過戶文件連同有關股票務須在二零一四年九月 八日星期一下午四時三十分或之前送抵本公司 股票登記處 一 香港灣仔皇后大道東183號合和 中心17樓1712-1716室香港中央證券登記有限公 司。建議派發之末期股息經股東周年大會通過 後,將於二零一四年九月二十二日星期一派付予 於二零一四年九月十二日星期五名列於股東名冊 之股東。

#### **Annual General Meeting**

The Annual General Meeting of shareholders of the Company will be held on Wednesday, 3 September 2014. For the purpose of determining the identity of members who are entitled to attend and vote at the forthcoming Annual General Meeting, the register of members of the Company will be closed from Monday, 1 September 2014 to Wednesday, 3 September 2014, both days inclusive, during which period no transfer of shares will be effected. All transfers accompanied by the relevant share certificates must be lodged with the Company's share registrars, Computershare Hong Kong Investor Services Limited, Shops 1712–1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 pm on Friday, 29 August 2014.

#### Dividend

The Board is pleased to recommend a final dividend of HK\$0.60 per share for the year ended 31 March 2014 (2013: HK\$0.55 per share). As the Company paid an interim dividend of HK\$0.55 per share during the year (2013: HK\$0.45 per share), the total distribution will be HK\$1.15 per share for the year (2013: HK\$1.00 per share). Subject to the shareholders' approval on the proposed final dividend at the forthcoming Annual General Meeting, the register of members of the Company will be closed for the purpose of determining entitlement to the said final dividend from Wednesday, 10 September 2014 to Friday, 12 September 2014, both days inclusive, during which period no transfer of shares will be effected. All transfers accompanied by the relevant share certificates must be lodged with the Company's share registrars, Computershare Hong Kong Investor Services Limited, Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 pm on Monday, 8 September 2014. The proposed final dividend will be paid on Monday, 22 September 2014 to shareholders whose names appear on the register of members on Friday, 12 September 2014 following approval at the Annual General Meeting.

#### 物業概覽 Properties

#### 國際廣場

國際廣場位處尖沙咀中心地帶,坐落於彌敦道和 北京道交界,是區內首個與尖沙咀港鐵站直接相 連的大型綜合娛樂及購物中心。國際廣場面積達 56,000平方米,包括商場低座、戲院和高座大樓 三個部分。

商場低座滙聚各類型時裝及生活時尚品牌,並設有5間星級電影院,包括設置448個座位的IMAX數碼影院:高座則進駐有高級食府及生活時尚服務。

#### **iSQUARE**

iSQUARE is located in the heart of Tsim Sha Tsui at the intersection of Nathan Road and Peking Road. It is the first one-stop shopping and entertainment complex linked to Tsim Sha Tsui MTR station. This complex provides 56,000 square metres of space comprising a shopping podium, cinema box and tower.

The podium is a vibrant new hub for world-class fashion and lifestyle brands, complemented by five grand cineplexes, including a 448-seat digital IMAX theatre. iSQUARE also features fine-dining restaurants and lifestyle services in its iconic tower.

## 企業管治報告 Corporate Governance Report

#### 企業管治常規

本公司明白其對股東的責任,故致力維持高水平 的企業管治。為此,本公司已檢討其常規和程 序,並確認及制訂合適的措施和政策。

於截至二零一四年三月三十一日止財政年度,本公司均有遵守《香港聯合交易所有限公司證券上市規則》(「上市規則」)附錄十四所載的《企業管治守則》(「企管守則」)中所有適用之守則條文,惟下文所披露者除外:

守則條文第A.1.8條:應就董事可能面 對的法律行動作適當的投保安排

本公司現時並無就其董事可能面對的法律行動作 投保安排。董事會相信,在現有內部監控制度及 管理層密切監管下,各董事因本公司董事身份而 被控告或牽涉於訴訟之風險偏低。儘管如此,董 事會將不時檢討投保需要。

守則條文第A.2.1條:主席和行政總裁的角色須分開,並由兩位不同人士擔任

鍾輝煌先生現時為本公司主席和行政總裁。董事會認為現時的公司結構對本公司並無任何負面影響,且相信該結構能令本集團迅速和有效率地作出及執行決策。

#### Corporate Governance Practices

The Company recognises its responsibilities to shareholders and is therefore committed to maintaining a high standard of corporate governance. To accomplish this, the Company has reviewed its practices and procedure, and identified and formalised appropriate measures and policies.

Throughout the financial year ended 31 March 2014, the Company complied with all the code provisions, where applicable, set out in the Corporate Governance Code ("CG Code") in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules"), except for the deviations as disclosed hereunder:

Code Provision A.1.8: Appropriate insurance cover in respect of legal action against directors should be arranged

Currently, the Company does not have insurance cover for legal action against its Directors. The Board believes that with the current internal control system and the close supervision of the management, the Directors' risk of being sued or getting involved in litigation in their capacity as Directors of the Company is relatively low. Nevertheless, the Board will review the need for insurance cover from time to time.

Code Provision A.2.1: The roles of chairman and chief executive should be separated and performed by two individuals

Mr Cheong Hooi Hong is both the Chairman and chief executive of the Company. The Board of Directors considers that the current structure does not have any adverse effect on the Company and believes that this structure enables the Group to make and implement decisions promptly and efficiently.

#### 企業管治常規(續)

守則條文第A.6.7條:獨立非執行董事 及其他非執行董事不僅應透過定期出 席董事會及其出任成員之任何委員會 會議和積極參與會務,就其技能、專 業知識和不同背景及資格作出貢獻, 亦應出席股東大會,以充份掌握公司 股東的意見

於本年度,本公司之獨立非執行董事及非執行董 事出席董事會會議、董事會轄下之委員會會議及 股東周年大會之比率整體上令人滿意,惟一名獨 立非執行董事因突發商務安排而未能出席本公司 於二零一三年九月三日舉行之股東周年大會。

# 守則條文第B.1.5條:應在年報內按薪酬等級披露高層管理人員之酬金詳情

本公司沒有在年報內按薪酬等級披露高層管理人員之酬金詳情。董事會指出,各高層管理人員均無參與其薪酬之決議,與薪酬委員會成員(彼等獲授權共同決定高層管理人員之薪酬)亦沒有任何關係;該等資料的披露或會引起員工之間不適當的比較和不滿,且會在不必要的情況下將高度敏感及機密的資料提供予競爭對手及有意招聘高層管理人員的其他第三者。有見及此,董事會認為,該等資料的披露既不能就促進企業管治提供相關資料,亦不符合股東利益。

# 守則條文第F.1.3條:公司秘書應向董事會主席及/或行政總裁滙報

公司秘書並無按規定向本公司主席(亦即本公司行政總裁)滙報,而是直接向副主席報告。董事會認為,由於主席與副主席一直就本公司業務保持緊密聯繫和商議,特別指與企業管治和財務相關之事宜,現有之滙報途徑無礙主席/行政總裁對本公司業務運作的了解和管理,亦沒有對其履行職責造成影響。

#### Corporate Governance Practices (Continued)

Code Provision A.6.7: Independent non-executive directors and other non-executive directors should not only give the board and any committees on which they serve the benefit of their skills, expertise and varied backgrounds and qualifications through regular attendance and active participation, but also attend general meetings and develop a balanced understanding of the views of shareholders

The attendance of the independent non-executive directors and non-executive director of the Company at Board meetings, Board committee meetings and annual general meeting during the year was in general satisfactory except that one of the independent non-executive directors was unable to attend the annual general meeting of the Company held on 3 September 2013 due to an unexpected business engagement.

# Code Provision B.1.5: Remuneration details of senior management should be disclosed by band in annual reports

The remuneration details of the senior management are not disclosed by band in the annual report. The Board of Directors notes that none of the senior management members is involved in deciding his/her own remuneration or related to the remuneration committee members (who are authorised to collectively determine the remuneration of the senior management). Also, the disclosure of such information may cause undue comparison and discontent among staff members, and would unnecessarily provide highly sensitive and confidential information to competitors and other third parties looking to recruit the senior management. In light of the above, the Directors are of the view that the disclosure of such information would neither provide pertinent information in furtherance of corporate governance, nor be in the interests of the shareholders.

# Code Provision F.1.3: The company secretary should report to the board chairman and/or the chief executive

Instead of reporting to the Chairman (who is also the chief executive of the Company), the company secretary reports directly to the deputy chairman. The Board considers that this reporting line does not prevent the Chairman/ chief executive from understanding/managing the operation of the Company or discharging his duties, for the Chairman and deputy chairman have ongoing discussion on business affairs, in particular corporate governance and financial issues.

#### 董事的證券交易

Mr Cheong Hooi Hong (who is both the Chairman and chief executive of the Company), Mr Cheong Kheng Lim, Mr Cheong Keng Hooi and Mr Cheong Sim Lam are brothers. Miss Cheong Chong Ling is the daughter of Mr Cheong Kheng Lim and the niece of Messrs Cheong Hooi Hong, Cheong Keng Hooi and Cheong Sim Lam. Some of the Directors who are members of the Cheong family own businesses outside the Group together.

#### 董事會(續)

根據企業管治架構,董事會須共同就本集團之表 現向其股東負責。董事會負責領導和管治本集 團,包括制訂目標、具體策略及業務計劃,並監 督本集團財務及管理表現、企業管治及內部監控。

為能更專注於特定範疇,董事會已成立三個委員會,分別為審核委員會、薪酬委員會和提名委員會。非執行董事因應其個人經驗及技能可為本集團帶來的益處而獲邀參加該等董事會轄下的委員會。為協助委員會恰當地履行其角色,各委員會均備有一份委員會政策,為其成員就決策提供指引。各委員會的職權範圍亦已詳細闡明其各自的職責和職權。該等委員會須定期向董事會滙報,以確保董事會充分得悉其工作及調查結果。

為使營運更具效率,董事會依賴管理層處理本集團業務的日常運作。管理層須推行董事會已制訂的目標、策略及計劃,並向董事會定期滙報。董事會負責監察管理層的工作,而管理層則為董事會運作和本集團發展提供必不可少的支援。鑑於董事會與管理層間的緊密合作關係,本公司已清楚釐定,並以書面形式詳列其各自的職責、權力和職能。

將職能和職權轉授予董事會轄下的委員會和管理 層不會免除董事會對本集團管治的整體責任。董 事會在任何時候均須就本集團之管理和營運負上 最終責任。

#### Board of Directors (Continued)

Under the corporate governance structure, the Board of Directors is as a whole accountable to its shareholders in the Group's performance. It is responsible for the leadership and control of the Group, which include formulation of objectives, overall strategies and business plans; and overseeing the financial and management performance, corporate governance and internal control of the Group.

With the objective of focusing more attentively on specific areas, the Board has established three committees, namely the audit committee, the remuneration committee and the nomination committee. Non-executive Directors are invited to serve on these Board committees according to the benefits brought by their participation in view of their individual experience and skills. To assist the committees in discharging their roles adequately, each committee is provided with a committee policy, setting out guidelines for its members to follow in decision-making. Duties and authorities of the committees are also set out in their respective terms of reference. To keep the Board fully informed of their works and findings, these committees are required to report to the Board on a regular basis.

For the purpose of efficient operation, the Board relies on the management for the day-to-day operation of the Group's business. The management has to implement the objectives, strategies and plans adopted by the Board and report to the Board regularly. The Board monitors the work of the management whilst the management provides an indispensable support to the Board operation and Group's development. Given the close collaboration between the Board and the management, the duties, power and functions of the Board and the management are clearly laid down and defined in writing.

Delegating its functions and authorities to the Board committees and the management does not absolve the Board from its overall responsibility for the governance of the Group. The Board at all times assumes the ultimate responsibility for the Group's management and operation.

The Directors of the Company are accountable for keeping proper records which reflect with reasonable accuracy at any time the financial position of the Group. #### 非執行董事和獨立非執行董事

# Non-executive Director and Independent Non-executive Directors

The Non-executive Director is appointed for a term of one year whilst Independent Non-executive Directors are appointed for the period commencing from the conclusion of one annual general meeting to the conclusion of the following annual general meeting. According to the Company's Articles of Association, they are required to retire by rotation, but remain eligible for re-election, at least once every three years.

The Company has received confirmation from each Independent Non-executive Director about his independence as set out in Rule 3.13 of the Listing Rules and considers each of them to be independent. One of the Independent Non-executive Directors possesses appropriate professional qualifications or accounting or related financial management expertise as required under the Listing Rules.

#### **Board Committees**

The Board has established three committees, namely the remuneration committee, the nomination committee and the audit committee, each with its written terms of reference. Each committee is required to report back to the Board and keep the Board fully informed of its decisions and recommendations unless there are legal or regulatory restrictions on its ability to do so.

#### Remuneration Committee

The primary objective of the Group's remuneration policy is to retain Directors and staff of suitable calibre by remunerating them at a competitive level. In order to achieve this, the Board has established a remuneration committee. Under the Group's remuneration policy, no Director or his/her associates are allowed to be involved in decisions relating to his/her own remuneration.

The main duties of the remuneration committee are to review and make recommendations to the Board on the terms of reference of the committee; to assist the Company in formulating remuneration policy and structure for Directors and senior management; to review and approve the management's remuneration proposals; to determine, with delegated responsibility, the remuneration packages of individual Executive Directors and senior management; to make recommendations to the Board on the remuneration of the Non-executive Director and Independent Non-executive Directors; to consider salaries paid by comparable companies, time commitment and responsibilities and employment conditions elsewhere in the Group; to review and approve compensation payable to Executive Directors and senior management for any loss or termination of office or appointment; and to review and approve compensation arrangements relating to dismissal or removal of Directors for misconduct. Details of the remuneration committee's authority and duties are set out in the terms of reference. The said terms of reference are published on the websites of the Company and Hong Kong Exchanges and Clearing Limited (the "HKEx") and are also available upon written request to the company secretary.

Remuneration of individual Executive Directors and senior management is determined, with delegated responsibility, by the remuneration committee on the recommendations of the chief executive (except Mr Cheong Hooi Hong whose remuneration package is determined by the remuneration committee alone) on an annual basis. The remuneration committee also makes recommendations to the Board on the review of remuneration of Non-executive Director and Independent Non-executive Directors annually. For all other staff, it is the Executive Directors who fix their remuneration packages on the recommendations of their respective department heads on an annual basis.

The said terms of reference are published on the websites of the Company and the HKEx and are also available upon written request to the company secretary.

During the financial year ended 31 March 2014, the nomination committee held three meetings and reviewed and made recommendations to the Board on the nomination policy, the terms of reference of the committee, the Board diversity policy, the need of setting measurable objectives for implementing the Board diversity policy and the necessary mix required on the Board; made recommendations to the Board on the structure, size and composition of the Board; assessed the independence of the Independent Non-executive Directors; and made recommendations to the Board on the re-appointments of the Independent Non-executive Directors, Non-executive Director and Directors who were subject to retirement by rotation.

On making recommendations to the Board for re-appointment of a Director, the nomination committee needs to consider not only the skills and experience of the Director concerned, but also his/her value to the Company, so as to ensure that there is a balanced composition of the Board. Board diversity is a key consideration in Board selection process. For the Company, it is more than an issue of gender, it also focuses on age and professional experience. Selection of female candidates or candidates of a particular age group or qualifications to join the Board is, in part, dependent on the pool of candidates possessing necessary skills, knowledge and experience. Board appointment is mainly based on merit and contribution likely brought by the chosen candidates. The Company believes that, with the benefits of diversity, it can have a better understanding to the needs and expectations of its stakeholders, in particular shoppers and tenants.

To reflect the above, the Company has adopted a Board diversity policy, in which the nomination committee is required to assess the mix in terms of gender, age and qualifications required on the Board; and to recommend to the Board any matters in relation to Board diversity or implementation of the policy.

Although the Board supports the principle of diversity, it currently does not intend to fix a diversity quota for Board appointment or set a short term objective on gender diversity, for such policies may compromise on the calibre of Directors.

The process for re-election of a Director is set out in the Company's Articles of Association, which requires that (i) every Director should be subject to retirement by rotation at least once every three years and a retiring Director shall be eligible for re-election; and (ii) Directors who are appointed by the Board as an addition to the Board shall retire at the next annual general meeting whilst those appointed to fill casual vacancies shall retire at the next general meeting (instead of the next annual general meeting) and Directors so appointed are eligible for re-election.

#### 企業管治職能

Given the importance of good corporate governance to the success of the Company, the Board is directly responsible for performing corporate governance duties. The duties set out in the Code Provision D.3.1 of the CG Code are included in its terms of reference.

Among the six board meetings held during the financial year ended 31 March 2014, two of the meetings covered issues relating to corporate governance. At the meetings, the Board reviewed the general code of conduct for employees and Directors; monitored the training and continuous professional development of Directors and senior management; considered and monitored corporate governance policies and practices with particular regard to the compliance with legal and regulatory requirements; and reviewed the Company's compliance with the CG Code and disclosure in the corporate governance report.

#### 核數師酬金

於截至二零一四年三月三十一日止財政年度,本公司核數師 — 畢馬威會計師事務所向本集團提供價值約港幣685,000元的核數服務和價值約港幣226,000元之非核數服務。非核數服務費用包括分別為港幣53,000元和港幣168,000元的税務服務和中期審閱服務。

#### 內部監控

董事會須對本公司的內部監控制度及檢討其成效 負責。本公司已制定程序和系統,務使其資產免 在未經准許的情況下被使用或處置:並確保本公 司會計記錄得以妥善保存、財務資料準確及遵守 適用的法規、條例及規則。除此以外,員工的角 色、職責及滙報途徑亦已清楚界定。然而,該等 程序和系統旨在減少及緩和因運作失誤及無法達 到本公司目標所產生的危機而設,故只能合理 地,而非絕對防範錯誤、損失或訛騙。

在本公司審核委員會的協助下,董事會已在截至 二零一四年三月三十一日止財政年度內,就本集 團內部監控制度的成效進行檢討。該檢討涵蓋所 有重要監控範疇,包括財務監控、運作監控、合 規監控和風險管理功能。董事會認為本公司在會 計及財務滙報職能方面的資源充足,相關員工具 備足夠的資歷和經驗,而本公司為該等員工提供 的培訓課程及有關預算亦合適。董事會沒有察覺 須就任何重要事項向股東作出交待。

#### Auditor's Remuneration

During the financial year ended 31 March 2014, the Auditor of the Company, KPMG, provided audit services of a value of approximately HK\$685,000 to the Group. KPMG also provided non-audit services of a value of approximately HK\$226,000 to the Group, which included HK\$53,000 and HK\$168,000 being charges for tax services and the interim review respectively.

#### Internal Control

The Board is responsible for the Company's internal control system and reviewing its effectiveness. Procedures and systems are in place to safeguard assets against unauthorised use or disposition; to maintain proper accounting records and to ensure accuracy of financial information and compliance with applicable statutes, rules and regulations. Defined roles, responsibilities and reporting lines have been established. However, these procedures and systems are designed to minimise and mitigate the risk of failure in operation and achievement of the Company's objectives and can only provide reasonable but not absolute assurance against errors, losses or fraud.

The Board, with the assistance of the audit committee of the Company, conducted a review of the effectiveness of the system of internal control of the Group during the financial year ended 31 March 2014. The review covered all material controls, including financial, operational and compliance controls, and risk management functions. The Board considers that the resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function are adequate. The Board is not aware of any significant areas of concern which should be brought to the attention of the shareholders.

#### 提供資料

本公司之公司通訊均以中、英文撰寫、並以淺白 的語言編製,務使文件易於理解。該等文件會在 適當的時候寄發予股東及於公共平台發布。

本公司組織章程細則詳列股東權益,可於本公司及交易所網站查閱。除因新《公司條例》中若干推定條文於二零一四年三月三日生效而自動衍生的變動外,於截至二零一四年三月三十一日止財政年度,本公司並無就其組織章程細則作出任何修訂。然而,隨著新《公司條例》的實施,董事會建議於二零一四年九月三日舉行之股東周年大會上尋求股東批准採納本公司新組織章程細則,務使本公司的章程符合新《公司條例》之條文及其他規定。

有關本公司現有組織章程細則之建議修訂全文載 於二零一四年七月二十四日之通函的附錄IV內, 並連同本年報一起寄予股東。

股東可於任何時候以書面方式向公司秘書索取已 公開之本公司資料。

To enhance its accountability and promote transparency, the Company is committed to maintaining channels for communication with its shareholders.

#### Providing information

Corporate communications are prepared in both English and Chinese versions and in plain language so as to make the documents understandable. Such documents are despatched to shareholders and released to the public domain in a timely manner.

Information released by the Company to the HKEx is posted on the Company's website (http://aihl.etnet.com.hk/ca-calendar-e.html) thereafter.

The Articles of Association of the Company which spell out shareholders' rights can be found on the websites of the Company and the HKEx. During the financial year ended 31 March 2014, other than those changes arising automatically as a result of certain deeming provisions contained in the new Companies Ordinance which came into effect on 3 March 2014, there have been no changes made to the Articles of Association of the Company. However, following the implementation of the new Companies Ordinance, the Directors propose to seek approval of the shareholders at the annual general meeting to be held on 3 September 2014 for the adoption of the new Articles of Association of the Company to, among other things, bring the constitution of the Company in line with provisions of the new Companies Ordinance.

The proposed amendments to the existing Articles of Association of the Company are set out in full in Appendix IV to the circular dated 24 July 2014 which is despatched to shareholders together with this annual report.

Shareholders may at any time make a written request to the company secretary for the Company's information to the extent that such information is publicly available.

#### 召開股東周年大會

- 本公司每年舉行一次股東大會作為其股東周 年大會,一般於9月舉行。
- 倘若本公司於以下情況發生後仍未舉行股東 周年大會(此情況幾乎不可能發生),則任何 股東均可向香港法院提出申請,並由法院召 開或下令召開本公司股東周年大會:
  - (a) 從上次股東周年大會日期起計15個月 後(對二零一四年而言);或
  - (b) 自二零一五年始,本公司財政年度完 結日起計6個月後。

The Company's annual general meeting provides a forum for face-to-face communication between shareholders and the Board. Shareholders are encouraged to participate in general meetings or to appoint proxies to attend, speak and vote at meetings for and on their behalf if they are unable to attend. Board members, in particular, the Chairman of the Board and chairmen of the Board committees, or their delegates, appropriate management staff and the Company's external auditor normally attend annual general meetings to answer shareholders' questions.

Shareholders are also provided with means by which their inquiries can be put forward to the Board. Such channels, including designated email address (aihlcosec@tianteckgroup.com), correspondence address, fax number and telephone number, are made available on the Company's website. Queries relating to shareholders' own shareholdings should be directed to the Company's share registrars, Computershare Hong Kong Investor Services Limited at Shops 1712–1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong.

Subject to applicable legislation and regulations, in particular the Hong Kong Companies Ordinance, the Listing Rules and the Articles of Association of the Company as amended from time to time, shareholders of the Company ("Shareholders", and each a "Shareholder") may convene general meetings and put forward proposals at general meetings. The relevant procedure is set out below:

#### To convene an Annual General Meeting ("AGM")

- The Company holds a general meeting as its AGM every year. This is usually held in September.
- If the Company fails to hold an AGM (which is unlikely to occur) after:
  - (a) 15 months have elapsed since the date of the previous AGM for the year 2014; or
  - (b) 6 months have elapsed since the end of the Company's financial year from the year 2015 onwards;

any Shareholder may apply to the court in Hong Kong which, on such application, may call or direct the calling of an AGM of the Company.

- The request must:
  - (a) be sent in hard copy form to the Deputy Chairman of the Board at 9th Floor, iSQUARE, 63 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong, the registered office of the Company;
  - (b) identify the proposed resolution;
  - (c) be signed by all the Shareholder(s) concerned; and
  - (d) be received by the Company not later than 6 weeks before the AGM to which the request relates or if later, the time at which the notice of AGM is despatched.
- The request will be verified with the Company's share registrars and upon their confirmation that the request is proper and in order, the company secretary will request the Board to include the resolution in the agenda for the AGM. On the contrary, if the request is verified as not in order, the Shareholder(s) concerned will be advised of this outcome and accordingly, the proposed resolution will not be included in the agenda for the AGM.

  - (b) may include the text of a resolution that may properly be moved and is intended to be moved at the meeting;
  - (c) may consist of several documents in like form;
  - (d) must be sent in hard copy form to the Deputy Chairman of the Board at 9th Floor, iSQUARE, 63 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong, the registered office of the Company; and
  - (e) must be signed by all the Shareholder(s) concerned.
- The request will be verified with the Company's share registrars and upon their confirmation that the request is proper and in order, the company secretary will request the Board to convene a GM by serving sufficient notice in accordance with the statutory requirements to all the registered Shareholders. On the contrary, if the request is verified as not in order, the Shareholder(s) concerned will be advised of this outcome and accordingly, a GM will not be convened as requested.
- Directors must call a GM within 21 days after the date on which they
  become subject to the requirement and the meeting so called must
  be held on a date not more than 28 days after the date of the notice
  convening the meeting.
- If the Directors do not convene a GM as required, the Shareholder(s) concerned or any of them representing more than one half of the total voting rights of all of them, may themselves call a GM, and the meeting so convened must be called for a date not more than 3 months after the date on which the Directors become subject to the requirement to call a GM. The Company must reimburse any reasonable expenses incurred by the Shareholder(s) requesting the GM by reason of the failure of the Directors duly to call a GM.

- To enable the Company to inform Shareholders of the foregoing proposal, the written notices as mentioned above shall be accompanied by (i) the information of the nominated person as required to be disclosed under Rule 13.51(2) of the Listing Rules and (ii) the written consent of the nominated person to the publication of his/her personal data.
- Relevant procedure and the Lodgement Period for each GM will be set out in the corresponding circular to be despatched to the Shareholders.
- If the notice is received less than 15 clear days prior to the GM, the Company will consider adjourning the GM in order to allow Shareholders at least 14 clear days or 10 clear business days' notice of the proposal, whichever is the longer.

董事會欣然呈報截至二零一四年三月三十一日止 年度的年報及經審核財務報表。 The Board of Directors (the "Board" or the "Directors") have pleasure in submitting their annual report together with the audited financial statements for the year ended 31 March 2014.

#### 主要營業地點

凱聯國際酒店有限公司(「本公司」)是一間在香港 註冊及成立的公司,其註冊辦事處和主要營業地 點設於香港九龍尖沙咀彌敦道63號國際廣場9樓。

## 主要業務

本公司的主要業務為物業投資及投資控股。各 附屬公司的主要業務及其他詳情載於財務報表 附註14。

本公司及各附屬公司(統稱「本集團」)於本財政年度的主要業務和經營地區分析載於財務報表附註4。

#### 主要客戶及供應商

於本年度內,本集團最大客戶和五大客戶的營業額分別佔本集團總營業額的15%和33%。本集團向其五大供應商所進行的採購低於總採購額的30%。

於本年度內任何時間,本公司董事、其聯繫人或 任何股東(據董事會所知悉擁有本公司股本5%以 上)均沒有擁有這些主要客戶的任何權益。

#### Principal Place of Business

The principal activities of the Company are property investment and investment holding. The principal activities and other particulars of the subsidiaries are set out in note 14 to the financial statements.

The analysis of the principal activities and geographical locations of the operations of the Company and its subsidiaries (together referred to as the "Group") during the financial year is set out in note 4 to the financial statements.

#### Major Customers and Suppliers

# Notes to the Financial Statements

#### 1 主要會計政策

#### (a) 合規聲明

本財務報表是按照香港會計師公會 頒布的所有適用的《香港財務報告準 則》(此統稱包括所有適用的個別《香 港財務報告準則》、《香港會計準則》 和詮釋)和香港公認會計原則的規定 編製。本財務報表亦符合香港《公司 條例》的適用要求(按載列於新的香港 《公司條例》(第622章)附表11第76至 87條條文內有關第9部「賬目及審計」 的過渡性及保留安排的規定,本財務 報表於本財政年度及比較期間繼續根 據適用的前《公司條例》(第32章)的規 定而作出披露)。本財務報表同時符 合適用的《香港聯合交易所有限公司 證券上市規則》披露規定。以下是本 集團採用的主要會計政策概要。

香港會計師公會頒布了若干項新的和經修訂的《香港財務報告準則》,該等準則在本集團和本公司當前的會計期間首次生效或可供提早採用。附註2提供有關初始應用這些與本集團相關並已反映於本財務報表內的準則變化所引致當前和以往會計期間的會計政策變動的資料。

# Significant Accounting Policies

#### (a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and accounting principles generally accepted in Hong Kong. These financial statements also comply with the applicable requirements of the Hong Kong Companies Ordinance, which for this financial year and the comparative period continue to be those of the predecessor Companies Ordinance (Cap. 32), in accordance with transitional and saving arrangements for Part 9 of the new Hong Kong Companies Ordinance (Cap. 622), "Accounts and Audit", which are set out in sections 76 to 87 of Schedule 11 to that Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. A summary of the significant accounting policies adopted by the Group is set out below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 2 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these financial statements.

#### (b) 財務報表的編製基準

截至二零一四年三月三十一日止年度 的綜合財務報表涵蓋本公司和各附屬 公司(統稱「本集團」)。

除附註1(d)所載的會計政策所闡釋的 投資物業是按公允價值入賬外,編製 本財務報表時是以歷史成本作為計量 基準。

符合《香港財務報告準則》的財務報表之編製,管理層須就影響政策的應用及呈報資產、負債、收入和支出的數額作出判斷、估計和假設。這些估計和相關假設是根據以往經驗和管理層因應當時情況認為合理的多項其他因素作出的,其結果構成了管理層在無法依循其他途徑即時得知資產與負債的賬面值時所作出判斷的基礎。實際結果可能有別於估計數額。

管理層會不斷審閱各項估計和相關假設。如果會計估計的修訂只是影響某一期間,其影響便會在該期間內確認;如果修訂對當前和未來期間均有影響,則在作出修訂的期間和未來期間內確認。

# 1 Significant Accounting Policies (Continued)

### (b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 March 2014 comprise the Company and its subsidiaries (together referred to as the "Group").

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the investment properties are stated at their fair value as explained in the accounting policies set out in note 1(d).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### (c) 附屬公司

附屬公司是指受本集團控制的實體。 當本集團因參與實體業務而承擔可變動回報的風險或因此有權享有可變動 回報,且有能力透過向實體施加權力 而影響該等回報時,則被視為本集團 控制該實體。在評估本集團是否擁有 上述權力時,只考慮(本集團和其他 方所持有的)實質權利。

集團於附屬公司的投資從取得有關控制權當日至該控制權終止當日均在綜合財務報表中綜合計算。集團內部往來的餘額、集團內部交易和現金流量及其產生的未變現溢利均在編製綜合財務報表時全數抵銷。集團內部交易所產生的未變現虧損的抵銷方法與未變現溢利相同,但抵銷額只限於沒有證據顯示該轉讓資產已出現減值的部分。

除本公司於附屬公司的投資被分類為 持有待售外,於本公司資產負債表內 該投資是按成本減去減值虧損(參閱 附註1(h)(ii))後入賬。

#### c) Subsidiaries

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

In the Company's balance sheet, an investment in a subsidiary is stated at cost less impairment losses (see note 1(h)(ii)), unless the investment is classified as held for sale.

#### (d) 投資物業

投資物業是指為賺取租金收入及/或 為資本增值而擁有或以租賃權益持有 (參閱附註1(f))的土地及/或建築物, 其中包括現時未確定將來用途的土地 及正在建造或發展以供日後用作投資 物業的物業。

投資物業按公允價值記入資產負債表中,但在資產負債表結算日仍處於建造或發展階段,且當時未能可靠地計量其公允價值者則除外。投資物業公允價值的變動,或報廢或處置投資物業所產生的任何盈利或虧損均在損益中確認。投資物業的租金收入是按照附註1(o)(i)所述方式入賬。

如果本集團以經營租賃持有物業權益 以賺取租金收入及/或為資本增值, 有關的權益會按每項物業的基準分類 為投資物業。分類為投資物業的任何 物業權益的入賬方式與以融資租賃持 有(參閱附註1(f))的權益一樣,而其適 用的會計政策也跟以融資租賃出租的 其他投資物業相同。租賃付款的入賬 方式列載於附註1(f)。

#### (e) 其他物業、廠房及設備

其他物業、廠房及設備以成本減去累計折舊(參閱附註1(g))和減值虧損(參 閱附註1(h)(ii))後入賬。

報廢或處置其他物業、廠房及設備項 目所產生的損益以處置所得款項淨額 與項目賬面值之間的差額釐定,並於 報廢或處置當日在損益中確認。

#### (d) Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see note 1(f)) to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment properties are stated in the balance sheet at fair value, unless they are still in the course of construction or development at the balance sheet date and their fair value cannot be reliably measured at that time. Any gain or loss arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss. Rental income from investment properties is accounted for as described in note 1(o)(i).

When the Group holds a property interest under an operating lease to earn rental income and/or for capital appreciation, the interest is classified and accounted for as an investment property on a property-by-property basis. Any such property interest which has been classified as an investment property is accounted for as if it were held under a finance lease (see note 1(f)), and the same accounting policies are applied to that interest as are applied to other investment properties leased under finance leases. Lease payments are accounted for as described in note 1(f).

#### (e) Other properties, plant and equipment

Other properties, plant and equipment are stated at cost less accumulated depreciation (see note 1(g)) and impairment losses (see note 1(h)(ii)).

Gains or losses arising from the retirement or disposal of an item of other properties, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

#### (f) 租賃資產

如果本集團把一項安排(包括一項交易或一系列交易)確定為在協定期間內轉讓一項或一些特定資產的使用權以換取一筆或多筆付款,則這項安排便屬於或包含一項租賃。確定時是以對有關安排的實質所作評估為準,而不管這項安排是否涉及租賃的法律形式。

- (j) 本集團租賃資產的分類 對於本集團以租賃持有的資 產,如果租賃使所有權的絕大 部分風險和回報轉移至本集 團,有關的資產便會分類為以 融資租賃持有;如果租賃不會 使所有權的絕大部分風險和回 報轉移至本集團,則分類為經 營租賃;但下列情況除外:
  - 一 以經營租賃持有但在其他 方面均符合投資物業定義 的物業,會按照每項物業 的基準分類為投資物業。 如果分類為投資物業,其 入賬方式會如同以融資租 賃持有(參閱附註1(d))一 樣:及

#### (f) Leased assets

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

- Classification of assets leased to the Group
  Assets that are held by Group under leases which
  transfer to the Group substantially all the risks and
  rewards of ownership are classified as being held under
  finance leases. Leases which do not transfer substantially
  all the risks and rewards of ownership to the Group
  are classified as operating leases, with the following
  exceptions:
  - property held under operating leases that would otherwise meet the definition of an investment property is classified as an investment property on a property-by-property basis and, if classified as investment property, is accounted for as if held under a finance lease (see note 1(d)); and
  - land held for own use under an operating lease, the fair value of which cannot be measured separately from the fair value of a building situated thereon at the inception of the lease, is accounted for as being held under a finance lease, unless the building is also clearly held under an operating lease. For these purposes, the inception of the lease is the time that the lease was first entered into by the Group, or taken over from the previous lessee.

#### (f) 租賃資產(續)

- (f) Leased assets (Continued)
  - (ii) Assets acquired under finance leases

Where the Group acquires the use of assets under finance leases, the amounts representing the fair value of the leased asset, or, if lower, the present value of the minimum lease payments, of such assets are included in fixed assets and the corresponding liabilities, net of finance charges, are recorded as obligations under finance leases. Depreciation is provided at rates which write off the cost of the assets over the term of the relevant lease or, where it is likely that the Group will obtain ownership of the asset, the life of the asset, as set out in note 1(g). Impairment losses are accounted for in accordance with the accounting policy as set out in note 1(h)(ii). Finance charges implicit in the lease payments are charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period. Contingent rentals are charged to profit or loss in the accounting period in which they are incurred.

#### (iii) Operating lease charges

Where the Group has the use of assets held under operating leases, payments made under the leases are charged to profit or loss in equal instalments over the accounting periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased asset. Lease incentives received are recognised in profit or loss as an integral part of the aggregate net lease payments made. Contingent rentals are charged to profit or loss in the accounting period in which they are incurred.

The cost of acquiring land held under an operating lease is amortised on a straight-line basis over the period of the lease term except where the property is classified as an investment property (see note 1(d)).

For accounts and other receivables carried at amortised cost, the impairment losses of bad and doubtful debts are measured as the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition of these assets), where the effect of discounting is material. This assessment is made collectively where these financial assets share similar risk characteristics, such as similar past due status, and have not been individually assessed as impaired. Future cash flows for financial assets which are assessed for impairment collectively are based on historical loss experience for assets with credit risk characteristics similar to the collective group.

If in a subsequent period the amount of an impairment loss decreases and the decrease can be linked objectively to an event occurring after the impairment loss was recognised, the impairment loss is reversed through profit or loss. A reversal of an impairment loss shall not result in the asset's carrying amount exceeding that which would have been determined had no impairment loss been recognised in prior years.

Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

#### Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated to reduce the carrying amount of the assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

#### (i) Accounts and other receivables

Accounts and other receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for impairment of bad and doubtful debts (see note 1(h)(i)), except where the receivables are interest-free loans made to related parties without any fixed repayment terms or the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less allowance for impairment of bad and doubtful debts.

#### (j) Accounts and other payables

Accounts and other payables are initially recognised at fair value and subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### (k) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement.

(i) Short term employee benefits and contributions to defined contribution retirement plans Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

#### (ii) Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

#### (m) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the balance sheet date, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

In all other cases, the amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the balance sheet date. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each balance sheet date and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Provisions are recognised for liabilities of uncertain timing or amount when the Company or the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

### (o) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follows:

### (i) Rental income from operating leases

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

#### (ii) Interest income

Interest income is recognised as it accrues using the effective interest method.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the balance sheet date. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Balance sheet items are translated into Hong Kong dollars at the closing foreign exchange rates at the balance sheet date. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

### (q) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

Operating segments, and the amounts of each segment item reported in the financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

### 2 會計政策的變動

The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period. Impacts of the adoption of new or amended HKFRSs are discussed below:

(a) Amendments to HKAS 1, Presentation of financial statements — Presentation of items of other comprehensive income

The amendments require entities to present separately the items of other comprehensive income that would be reclassified to profit or loss in the future if certain conditions are met from those that would never be reclassified to profit or loss. The presentation of other comprehensive income in the consolidated statement of comprehensive income in these financial statements has been modified accordingly.

(b) 《香港財務報告準則》第10號 「綜合財務報表」

《香港財務報告準則》第10號取代有關編製綜合財務報表的《香港會計準則》第27號「綜合和獨立財務報表」以及香港(常設詮釋委員會)解釋公告第12號「綜合一特殊目的實體」的規定。這項準則引入單一控制權模式,以釐定被投資方應否予以綜合處理,這視乎有關實體是否有權控制被投資方、是否對參與被投資方業務所得的可變動回報承擔風險或擁有權利、以及能否運用權力影響該等回報金額。

由於採納了《香港財務報告準則》 第10號,本集團已修訂有關釐定是否有權控制被投資方的會計政策。採用這項準則不會改變本集團於二零一三年四月一日就參與其他實體業務所達致的任何有關控制權方面的結論。

### (c) 《香港財務報告準則》第13號 「公允價值計量 |

《香港財務報告準則》第13號就公允價值計量訂立單一指引,取代個別《香港財務報告準則》中的現有指引。《香港財務報告準則》第13號亦包含金融工具和非金融工具之公允價值計量的廣泛披露規定。因應適用於本集團的披露規定,本集團已於附註13(c)提供相關披露。採納《香港財務報告準則》第13號不會對本集團資產和負債的公允價值計量構成任何重大影響。

(b) HKFRS 10, Consolidated financial statements

HKFRS 10 replaces the requirements in HKAS 27, Consolidated and separate financial statements, relating to the preparation of consolidated financial statements and HK-SIC 12 Consolidation — Special purpose entities. It introduces a single control model to determine whether an investee should be consolidated, by focusing on whether the entity has power over the investee, exposure or rights to variable returns from its involvement with the investee and the ability to use its power to affect the amount of those returns.

As a result of the adoption of HKFRS 10, the Group has changed its accounting policy with respect to determining whether it has control over an investee. The adoption does not change any of the control conclusions reached by the Group in respect of its involvement with other entities as at 1 April 2013.

### (c) HKFRS 13, Fair value measurement

HKFRS 13 replaces existing guidance in individual HKFRSs with a single source of fair value measurement guidance. HKFRS 13 also contains extensive disclosure requirements about fair value measurements for both financial instruments and non-financial instruments. To the extent that the requirements are applicable to the Group, the Group has provided those disclosures in note 13(c). The adoption of HKFRS 13 does not have any material impact on the fair value measurements of the Group's assets and liabilities.

The other developments have had no material impact on the Group's financial statements.

Turnover represents gross rental income received and receivable from investment properties.

The Group's customer base is diversified and includes only one customer with whom transactions have exceeded 10% of the Group's revenues. During the year, revenue from this customer amounted to approximately \$89,154,000 (2013: \$67,947,000).

### 4 Segment Information

The Group has a single reportable segment which is "Property leasing". Accordingly, the business segment information for this sole reportable segment is equivalent to the consolidated figures.

No separate geographical information is presented as the Group's revenue and results of property leasing were derived from Hong Kong.

#### (c) Nature and purpose of reserves

The revaluation reserve represents hotel properties revaluation surpluses and other properties revaluation surplus recognised in prior years. The hotel has been redeveloped into iSQUARE. Upon the retirement or disposal of the properties, any related revaluation surplus is transferred from the revaluation reserve to retained earnings. The reserve is non-distributable.

The exchange reserve has been set up and is dealt with in accordance with the accounting policies adopted for foreign currency differences arising from the translation of the financial statements of foreign operations in note 1(p).

The capital reserve represents the net increase in the Group's share of the undistributable reserve in a subsidiary pursuant to the issuance of various classes of preference shares by a subsidiary to preference shareholders.

#### (d) Distributability of reserves

At 31 March 2014, the aggregate amount of reserves available for distribution to equity shareholders of the Company, as calculated under the provisions of Part 6 of the new Hong Kong Companies Ordinance (Cap. 622), was \$1,756,633,000 (2013: \$1,738,153,000). After the balance sheet date the Directors proposed a final dividend of \$0.60 per share (2013: \$0.55 per share), amounting to \$216,000,000 (2013: \$198,000,000) (note 11). This dividend has not been recognised as a liability at the balance sheet date.

#### (e) 資本管理

本集團管理資本的主要目的是保障本 集團持續經營的能力,從而藉着出租 物業和訂定與風險水平相稱的服務價 格以及以合理成本取得融資的方式, 繼續為權益股東帶來回報,並為其他 相關人士帶來利益。

本集團定期檢討和管理其資本結構, 務求在可能以較高的借款水平去爭 取較高的股東回報時,與穩健資本狀 況帶來的優勢和保障取得平衡,並因 應經濟情況轉變而調整資本結構。 截至二零一四年及二零一三年三月 三十一日止年度,本集團的整體策略 維持不變。

本集團經考慮未來財務責任和承擔後,透過審閱資本負債比率及現金流量需求來監察其資本結構。就此而言,本集團界定資本負債比率為銀行貸款總額除以綜合資產負債表所示的權益總額。於二零一四年三月三十一日,本集團的資本負債比率為1.5%(二零一三年:1.6%),而銀行存款及現金超過銀行貸款總額達254,497,000元(二零一三年:201,915,000元)。

#### e) Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for equity shareholders and benefit for other stakeholders, by leasing properties and pricing services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions. The Group's overall strategy remained unchanged during the years ended 31 March 2014 and 2013.

The Group monitors its capital structure by reviewing its gearing ratio and cash flow requirements, taking into account its future financial obligations and commitments. For this purpose, the Group defines gearing ratio as total bank loan over total equity as shown in the consolidated balance sheet. As at 31 March 2014, the Group's gearing ratio was 1.5% (2013: 1.6%) with bank deposits and cash exceeding total bank loan of \$254,497,000 (2013: \$201,915,000).

#### (a) 信貸風險

本集團的信貸風險主要來自應收賬 款。管理層已實施信貸政策,並且不 斷監察所承受的信貸風險。

就應收賬款而言,對於所有要求授出超過一定金額信貸的客戶,本集團會作出個別信貸評估。另外會集中評估客戶過往償還到期賬項的記錄及定數一般至客戶經營所在的經濟環境。與對一般在每月首日到期,還款寬限如一般為十天至十四天,逾期會徵收的人,本集團會在適當的情況下對逾期欠款債務人採取法律行動。本集團收取客戶訂金(參閱附註20)作為應收賬款的抵押品。

本集團並無重大信貸風險集中的情況。不計算所持抵押品,本集團所承受的信貸風險上限為資產負債表中每項金融資產的賬面值(已扣除減值準備)。本集團並無提供可致本集團或本公司承擔信貸風險的任何擔保。

有關本集團因應收賬款而產生信貸 風險承擔的其他量化披露,載述於 附註16。

## 26 Financial Risk Management and Fair Values

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business.

The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

#### (a) Credit risk

The Group's credit risk is primarily attributable to accounts receivable. Management has a credit policy in place and the exposure to this credit risk is monitored on an ongoing basis.

In respect of accounts receivable, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Debts are generally due on the 1st day of each month and 10 to 14 days are allowed for settlement or else interest will be charged. Legal action will be taken against past due debtors whenever the situation is appropriate. The Group obtains deposits from customers (see note 20) as collateral over accounts receivable.

The Group has no significant concentrations of credit risk. The maximum exposure to credit risk without taking account of any collateral held is represented by the carrying amount of each financial asset in the balance sheet after deducting any impairment allowance. The Group does not provide any guarantees which would expose the Group or the Company to credit risk.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from accounts receivable are set out in note 16.

### (b) 流動資金風險

#### (ii) Sensitivity analysis

At 31 March 2014, it is estimated that a general increase/decrease of 25 (2013: 25) basis points in interest rates, with all other variables held constant, would have decreased/increased the Group's profit after tax and retained profits by approximately \$418,000 (2013: \$418,000).

The sensitivity analysis above indicates the instantaneous change in the Group's profit after tax (and retained profits) that would arise assuming that the change in interest rates had occurred at the balance sheet date. In respect of the exposure to cash flow interest rate risk arising from floating rate non-derivative instruments held by the Group at the balance sheet date, the impact on the Group's profit after tax (and retained profits) is estimated as an annualised impact on interest expense of such a change in interest rates. The analysis is performed on the same basis for 2013.

#### (d) Currency risk

The Group has no significant exposure to foreign currency risk as substantially all of the Group's transactions are denominated in Hong Kong dollars.

#### (e) Fair values

All financial instruments are carried at amounts not materially different from their fair values as at 31 March 2014 and 2013.

#### 27 僱員退休福利

#### 27 Employee Retirement Benefits

The Group operates a Mandatory Provident Fund Scheme (the "MPF scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF scheme is a defined contribution retirement plan administrated by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of \$25,000. In addition to the mandatory contribution, the Group makes voluntary contribution at 5% of the employees' monthly relevant income in excess of \$25,000, subject to a maximum monthly income of \$35,000. Mandatory contributions to the plan vest immediately while voluntary contributions to the plan vest at the time the employees reach the retirement range, subject to certain conditions. The staff costs in respect of staff employed by DTZ for building and property management of iSQUARE are reflected in the Group's income statement.

During the year, forfeited contributions of \$5,000 (2013: Nil) was utilised to reduce the contributions payable for the year. No unutilised forfeited contributions (2013: \$1,000) had yet to be applied by the Group at 31 March 2014.

此外,根據新的香港《公司條例》(第622章) 第358條,第9部有關「賬目及審計」的規定 在本公司於二零一四年三月三日之後開始的 首個財政年度生效(即本公司於二零一四年 四月一日開始的財政年度)。本集團正在評 估新修訂的《公司條例》第9部預計在初始應 用期間對綜合財務報表所產生的影響。到目 前為止的結論是所產生的影響幾乎不可能重 大, 並只主要影響本綜合財務報表的資料呈 列和披露。

The Group is in the process of making an assessment of what the impact of these amendments and new standards is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements.

In addition, the requirements of Part 9, "Accounts and Audit", of the new Hong Kong Companies Ordinance (Cap. 622) come into operation from the Company's first financial year commencing after 3 March 2014 (i.e. the Company's financial year which began on 1 April 2014) in accordance with section 358 of that Ordinance. The Group is in the process of making an assessment of the expected impact of the changes in the Companies Ordinance on the consolidated financial statements in the period of initial application of Part 9. So far it has concluded that the impact is unlikely to be significant and will primarily only affect the presentation and disclosure of information in the consolidated financial statements.
