#### **Executive Directors**

Mr. Eav Yin (alias Duong Khai Nhon), aged 74, is the founder of the Company and a member of Chaozhou Committee of Guangdong Province of the Chinese People's Political Consultative Conference (廣東省潮州市政協委員) and was appointed as an Executive Director and the Chairman of the Company on 22nd November 2006. He is also the chairman of the nomination committee and a member of the remuneration committee of the Company. Mr. Eav Yin is a Cambodian Chinese and prior to his establishing of a Hong Kong company in 1968 as an importing agent for watch distribution business in Cambodia, had extensive experience of distributing watches in Cambodia and Vietnam. Mr. Eav Yin is the father of Mr. Eav Ming Keong, Kinson and Mr. Duong Ming Chi, Henry and the spouse of Mdm. Lam Kim Phung, a controlling shareholder of the Company. Mr. Eav Yin is a director and a controlling shareholder of Century Hero International Limited, which is a controlling shareholder of the Company.

Mr. Eav Ming Keong, Kinson, aged 39, holds a Bachelor of Arts degree in Interior Design and Technology and a Master of Arts degree in Art, Design and Visual Culture from the London Guildhall University. After graduation, Mr. Eav Ming Keong, Kinson has practiced in an architecture firm in London for 2 years. Mr. Eav Ming Keong, Kinson is a son of Mr. Eav Yin and a brother of Mr. Duong Ming Chi, Henry, both are Executive Directors of the Company. He was appointed as an Executive Director of the Company on 22nd November 2006.

Mr. Duong Ming Chi, Henry, aged 51, was educated at the University of Southern California. Mr. Duong has more than 30 years of experiences in the watch branding and retailing industries. He was appointed as an Executive Director of the Company on 7th July 2011. Before that, he was appointed as the Executive Director from the listing of the Company in 1989 and subsequently resigned on 31st August 1996 to pursue his personal career. Mr. Duong is a son of the Chairman, Executive Director and controlling shareholder of the Company, Mr. Eav Yin and is the elder brother of Mr. Eav Ming Keong, Kinson, who is an Executive Director of the Company.

Mr. André Francois Meier ("Mr. Meier"), aged 50, holds a degree in banking. Mr. Meier has more than 20 years experience in watch business. He spend his 12 years at Blancpain S.A. (10 years as vice president and international sales manager). Mr. Meier is the chief executive officer and director of Juvenia Montres S.A., a subsidiary of the Company. Mr. Meier was appointed as an Executive Director of the Company on 26th October 2011.

He is also the chairman of the audit committee and a member of the nomination committee and remuneration committee of the Company. Mr. Lai was elected as the Vice Chairman, General Practice Division of the Hong Kong Institute of Surveyors during the years from 2001 to 2003. Mr. Lai has been practicing as a professional surveyor since 1983 and has considerable experience in the property field. Mr. Lai holds a Master Degree of Business Administration from Chinese University of Hong Kong. Mr. Lai held directorship as independent non-executive director of The Sun's Group Limited during the years from 2002 to 2003.

Ms. Wong Wing Yue, Rosaline, aged 44, graduated with LLB (Hons) at King's College, London University, UK in 1992, and was admitted to both the UK Bar (Middle Temple, UK) and the Hong Kong Bar in 1993. Ms. Wong is a practicing barrister in Hong Kong. She was appointed as an independent non-executive Director of the Company on 16th December 2006. She is also a member of the nomination committee, the audit committee and the remuneration committee of the Company.

Mr. Lee Tat Cheung, Vincent, aged 44, has more than 20 years experience in accounting and auditing and is the sole proprietor of a firm of Certified Public Accountants practicing in Hong Kong. Mr. Lee is an associate member of The Institute of Chartered Accountants in England and Wales, a fellow member of The Hong Kong Institute of Certified Public Accountants and The Association of Chartered Certified Accountants. He holds a Master Degree in Corporate Finance from the Hong Kong Polytechnic University. He was appointed as an independent non-executive Director of the Company on 16th December 2006. He is the chairman of the remuneration committee and also a member of the audit committee and the nomination committee of the Company.



#### **Business Review**

The Group's turnover for the year was HK\$967 million which was 12% lower than HK\$1,099 million of last year. Gross profit margin declined from 25% to 22% due to intense market competition. Sales from mainland China were decreased by 35% to HK\$461 million while average same store sales in China were decreased by 16%. On the other hand, sales in Hong Kong were increased by 32% to HK\$503 million since the new shop opened on Canton Road generated more turnover as compared with the one which was closed during the year.

The Group had adopted a prudent approach to close down 15 stores (mainly non-profitable ones) but opened 3 stores in Beijing, Chengdu and Hong Kong respectively including our Rolex and Tudor flagship store on Canton Road which has been well received by the market.

The total number of stores is as below:

#### 業務回顧

本年度本集團之營業額為967,000,000港元,較去年同期的1,099,000,000港元下降12%。由於市場競爭激烈,毛利率從25%下降到22%。來自中國大陸的銷售額減少35%至461,000,000港元,而中國平均同店銷售則減少16%。另一方面,香港的銷售則增加32%至503,000,000港元;乃因自廣東道新店開業後,與年內關閉的店舖比較,帶來更多的營業額。

本集團已採取審慎態度,關閉十五間店舖(主要為無利可圖的),但分別在北京、成都及香港新開三間店舖,包括已深受市場歡迎的廣東道勞力士及帝舵表旗艦店。

#### **Financial Review**

#### Results review

The Group recorded a turnover of HK\$967 million for the year ended 31st March 2014, (2013: HK\$1,099 million) which was 12% lower than last year. Sales from the mainland China decreased by 35% to HK\$461 million as compared with HK\$714 million of last year was due to the slow down of the market and closure of non-profitable stores during the year. Sales in Hong Kong increased by 32% to HK\$503 million as compared with HK\$380 million of last year due to the fact that the new Rolex and Tudor flagship store on Canton Road brought more turnover as compared with the one which was closed during the year.

Distribution costs decreased by 14% to HK\$353 million as compared with HK\$411 million of last year was mainly due to the decrease in advertising, business promotion expenses, rental and staff cost due to the closure of shops and tightening control in expenses. Administrative expenses decreased by 28% to HK\$34 million as compared with HK\$47 million of last year which was mainly due to the decrease in equity-settled share based payment expenses in this year.

Valuation gains on investment properties increased by 77% to HK\$14 million as compared with HK\$8 million of last year as a result of the increase in the valuation of the properties located in Hong Kong.

Other net loss amounting to HK\$11 million this year was mainly consisted of the onerous contract provision for some loss making stores of HK\$7 million and write off of assets due to closure of stores of HK\$3 million.

Finance costs decreased by 37% to HK\$12 million as compared with HK\$20 million of last year was due to the decrease in bank loans during the year.

#### Liquidity, financial resources and capital structure

As at 31st March 2014, the Group's total cash balance amounted to HK\$40 million (2013: HK\$119 million). The decrease was mainly due to the repayment of bank loans and convertible notes during the year. The Group has secured banking facilities amounting to HK\$74 million which were secured by certain inventories, bank deposits, leasehold properties, prepaid lease payments, investment properties, rental assignment, assignment of dividends and shareholder's receivable as well as unlimited corporate guarantee provided by the Company. Gearing ratio of the Group, expressed as a ratio of total borrowing, over total equity, was 46% as at 31st March 2014 (2013: 50%).

#### Foreign exchange risks

The Group views its main currencies as Hong Kong dollars, Renminbi and Swiss Francs. The Group monitors its exposure to foreign exchange risks, and when it considers necessary and appropriate, will hedge its foreign exchange risks by using financial instruments.

#### 財務回顧

#### 業績回顧

截至二零一四年三月三十一日止年度本集團之營業額為967,000,000港元(二零一三年:1,099,000,000港元),低於去年同期12%。來自中國內地的銷售與去年的714,000,000港元比較,下降35%至461,000,000港元,概因年內市場放緩以及無利可圖的店舖結業所致。香港的銷售與去年的380,000,000港元比較,增加32%至503,000,000港元,乃因位於廣東道的新勞力士及帝舵表旗艦店與年內關閉的店舖比較,帶來更多的營業額。

分銷成本相較於去年的411,000,000港元減少14%至353,000,000港元,主要是由於店舖結業及收緊開支控制,因而減少廣告,業務推廣費用,租金及員工成本所致。行政費用較去年同期的47,000,000港元減少28%至34,000,000港元,主要因為今年以股份為基礎之付款開支減少。

投資物業估值收益較去年的8,000,000港元增加77%至 14,000,000港元,主要由於增加位於香港的物業估值 的結果。

本年度其他虧損淨額為11,000,000港元,主要包括為產生虧損7,000,000港元之一些店舗及由於結束店舖作出的3,000,000港元資產撇銷的有償合約撥備。

由於年內減少銀行貸款,財務費用較去年的20,000,000港元減少37%至12,000,000港元。

#### 流動資金、財務資源及資本結構

於二零一四年三月三十一日,本集團之現金結餘總額為40,000,000港元(二零一三年:119,000,000港元)。結餘減少主要是由於銀行貸款及可換股票據於年內償還。本集團銀行信貸總額為74,000,000港元,由若干存貨、銀行存款、租賃物業、預付租賃款項、投資物業、租金轉讓契約、股息分配及股東應收賬款,以及由本公司提供之無上限公司擔保作為擔保。本集團之借貸比率(以淨債項除以總權益表示),於二零一四年三月三十一日為46%(二零一三年:50%)。

### 外匯風險

本集團之主要貨幣為港元、人民幣及瑞士法郎。本集 團對外匯風險實行監控,會在必要及適當時運用金融 工具對沖其外匯風險。

# 管理層討論及分析

#### **Prospects**

The highly visible PRC government campaign encouraging frugality and focusing on corruption had a large impact on gifting, which had been one of the major growth engines of the luxury watches sector. This campaign especially constrained the growth of luxury watches making up over one fifth of the total domestic luxury market in China according to the Bain study will persist for a substantial period.

The Group has basically closed down all its non-core shops in China and cut corporate overhead. Baring unforeseen circumstances, the financial performance of China retailing unit will further improve.

From 30th May 2014 to 12th June 2014, the Group had made its debut of "FROM DAYTONA TO THE COSMOGRAPH DAYTONA. A PASSION FOR SPEED" exhibition in Hong Kong in its Rolex boutique on Canton Road.

The Group will close down its nonperforming shop in Causeway Bay, Hong Kong when its lease expires in October this year.

The Group is determined to rebuild its financial strength and confidence to turnaround its business.

On behalf of the Group, we sincerely thank for the kind and positive supportive of our shareholders, customers, suppliers and associates.

#### 展望

中國政府備受注目的鼓勵節儉、專注打擊腐敗運動對 送禮饋贈有極大影響,這一直是豪華名錶行業主要的 增長動力之一。根據Bain的研究報告指出,此一運動尤 其限制了佔中國奢侈品市場總額五分之一的豪華名錶 的增長,並將持續一段頗長時間。

本集團基本上已關閉了國內所有非核心店鋪以及削減 企業開支。撇除不可預期的情形下,中國零售業務的 財務狀況將可望進一步改善。

從二零一四年五月三十日至二零一四年六月十二日,本集團在廣東道的勞力士專賣店作出「FROM DAYTONA TO THE COSMOGRAPH DAYTONA. A PASSION FOR SPEED」的首次展覽。

當今年十月租賃合約到期時,本集團將關閉其位於香港銅鑼灣業務欠佳的店鋪。

本集團決定重建本身之財務實力,以及有信心令業務 轉虧為盈。

謹代表本集團,對各股東、客戶、供應商及聯屬人士給 予本集團的積極支持,致以由衷謝意。

# The principal activity of the Company is investment holding and the principal activities of its subsidiaries are set out in Note 18 on the financial statements.

#### **SHARE OPTION SCHEME**

On 20th September 2002, the shareholders of the Company approved the adoption of a new share option scheme (the "2002 Share Option Scheme"). The purpose of the 2002 Share Option Scheme is to encourage qualifying grantees to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole. Qualifying grantees of the 2002 Share Option Scheme mean (i) any employee or any business-related consultant, agent, representative or advisor of the Company or any subsidiary or any affiliate; or (ii) any supplier, agent or consultant who provide goods or services to the Company or any subsidiary or any affiliate; or (iii) any customer of the Company or any subsidiary or any affiliate; or (iv) any business ally or joint venture partner of the Company or any affiliate.

Refreshment of 2002 Share Option Scheme mandate limit (the "Refreshment") and amendment of rules of 2002 Share Option Scheme (the "Amendment") had been approved at the annual general meeting of the Company held on 26th August 2008. Details of the Refreshment and the Amendment were contained in the circular to shareholders dated 1st August 2008. The 2002 Share Option Scheme has been expired on 20th September 2012.

The Company has issued 146,800,000 and 34,170,000 share options to the qualifying grantees to subscribe for ordinary shares of HK\$0.02 each in the share capital of the Company under the 2002 Share Option Scheme on 31st March 2011 and 26th October 2011 of which the exercise prices were HK\$0.394 per share and HK\$0.263 per share respectively. Upon the completion of the share consolidation and rights issue in January 2013 and February 2013 respectively, both the exercise prices and the numbers of share options have been adjusted according to the 2002 Share Option Scheme. As of 31st March 2014, the outstanding amount of share options was 34,072,661.

The exercise price of any share option is the highest of (i) the nominal value of a share; (ii) the closing price of the share as stated in the daily quotation sheets of the Stock Exchange on the date of grant; and (iii) the average closing price of the share as stated in the daily quotation sheets of the Stock Exchange for the five business days immediately preceding the date of grant.

The validity period of share options shall be vested in the grantees over a time period of five years commencing from the date of grant above. For each of such five years, 20% of the share options granted to the grantees will vest. The vested share options shall be valid for a period of ten years from the date of grant and shall lapse at the expiry of the option period.

The total number of shares available for issue under the 2002 Share Option Scheme, the share award plan approved by the shareholders of the Company on 13th September 2010 and any other share option schemes, after adjustment made for the share subdivision in November 2010, the share consolidation in January 2013 and the rights issue in February 2013, was 58,782,332 shares which represented approximately 4.3% of the issued share capital of the Company at 31st March 2014. In respect of the maximum entitlement of each grantees under the 2002 Share Option Scheme, the number of shares issued and to be issued upon exercise of the share options granted to each grantees in any 12-month period is limited to 1% of the Company's ordinary shares in issue.

# DIRECTORS' REPORT

## 董事會報告

The share options granted to the Directors are registered under the names of the Directors who are also the beneficial owners. The closing prices of the Company's shares immediately before the date of grant of the share options on 31st March 2011 and 26th October 2011 were HK\$0.39 and HK\$0.26 respectively.

During the year, 8,799,000 share options were lapsed under the 2002 Share Option Scheme.

#### **DIRECTORS' RIGHTS TO ACQUIRE SHARES OR DEBENTURES**

Save as disclosed herein, at no time during the year, was the Company or any of its associated corporations a party to any arrangement to enable the Directors to acquire benefits by means of the acquisition of shares in, or debentures of, the Company or any other body corporate and none of the Directors or their spouses or children under 18 years of age was granted any right to subscribe for any shares in, or debentures of, the Company or any of its associated corporations.

#### **DIRECTORS' INTERESTS IN COMPETING BUSINESS**

During the year and up to the date of this report, no Director is considered to have interests in the businesses which compete or are likely to compete with the businesses of the Group pursuant to the Listing Rules.

#### CONVERTIBLE SECURITIES, OPTIONS, WARRANTS OR SIMILAR **RIGHTS**

In addition to the share options granted under the 2002 Share Option Scheme as disclosed herein, the Company entered into a placing agreement with the placing agent on 31st August 2010, pursuant to which the placing agent conditionally agreed, to procure placees to subscribe for convertible notes (the "Convertible Notes") issued by the Company in an aggregate principal amount of up to HK\$100,800,000 on a "best-efforts" basis. On 27th September 2010, the Company completed the placing of HK\$100,800,000 Convertible Notes to independent placees. The Convertible Notes carry interest at 3% per annum and the principal amounts of all Convertible Notes shall be due and repayable on the third anniversary of the date of issue. The Convertible Notes entitle their holders to convert their outstanding principal amounts into new conversion shares at the initial conversion price of HK\$0.84 per conversion share (subject to anti-dilutive adjustment). Pursuant to the terms and conditions of the Convertible Notes, the Conversion Price of the Convertible Notes was adjusted from HK\$0.84 per Conversion Share to HK\$0.168 per subdivided share as a result of the share subdivision approved by the shareholders of the Company on 12th November 2010. The above adjustment took effect from the close of business of 15th November 2010. Upon the completion of the share consolidation and the rights issue in January 2013 and February 2013, the conversion price of the Convertible Notes was further adjusted to HK\$1.68 and HK\$0.573 per share respectively. The final adjustment was effective on 16th January 2013. The General Mandate (2009), which has not been used before the placing agreement, was used for the allotment and issue of the conversion shares. On 27th September 2013, all outstanding Convertible Notes have been redeemed by the Company.

## 可換股證券、購股權、認股權證或類似權利

根據二零零二年購股權計劃附加於授予購股權所披 露,本公司與配售代理於二零一零年八月三十一日訂 立配售協議,根據協議配售代理有條件同意,按[竭盡 所能」基準,致力承配人認購累計本金金額最高達至 100,800,000港元之本公司發行之可換股票據(「可換股 票據」)。於二零一零年九月二十七日,本公司完成配 售100,800,000港元之可換股票據予獨立承配人。可換 股票據以3%之年利率計算,以及所有可換股票據之本 金金額將會到期及在發行日期第三週年悉數償還。可換 股票據賦予其持有人轉換其未行使之本金金額以每可 換股股份0.84港元至新可換股股份(視乎調整而定)。 根據可換股票據條款及條件,可換股票據之轉換價由 每一可轉換股份0.84元調整至每一已拆細股份0.168元 (由於二零一零年十一月十二日,本公司股東批准股份 拆細)。上述調整於二零一零年十一月十五日交易日收 市後生效。於二零一三年一月及二零一三年二月股份 合併及供股完成後,可換股票據之轉換價分別進一步 調整至每股1.68港元及0.573港元。最後調整已於二零 一三年一月十六日生效。一般授權(二零零九)在配售 協議前仍未使用,惟於可轉換股份發行及配置時使用。 於二零一三年九月二十七日,本公司已贖回所有尚未 行使的可換股票據。

On 13th September 2010, the shareholders of the Company approved the adoption of a share award plan (the "Share Award Plan 2010"). The Share Award Plan 2010 is a ten-year discretionary share award and ownership plan. It is primarily for encouraging or facilitating the holding of shares by those selected employees of the Group who, as determined by the Board, are eligible to participate in the plan and to whom new shares are or will be awarded. The Directors will make use of the plan to award new shares to those selected employees of the Group on suitable terms as incentives and rewards for their contribution to the Group.

  and their children.
- Convenhills Limited is owned equally by the estate beneficiary of late Mr. Leong Lou Teck, Mr. Leong Lum Thye, Miss Leong Yoke Kheng and Mr. Leong Siew Khuen.

All the interests disclosed above represent long positions in shares of the Company.

Save as disclosed above, as at 31st March 2014, there were no other person (other than the Directors or chief executive of the Company) who was recorded in the register of the Company as having an interest or short position in the shares or underlying shares of the Company which would fall to be disclosed to the Company under the provision of Divisions 2 and 3 of Part XV of the SFO, or, which were recorded in the register required to be kept by the Company under Section 336 of the SFO.

#### **PRE-EMPTIVE RIGHTS**

There is no provision for pre-emptive rights under the Company's Bye-Laws although there is no restriction against such right under Bermuda law.

#### **EMPLOYEES AND REMUNERATION POLICY**

There are 310 employees in the Group as at 31st March 2014. The Group offers competitive remuneration packages to employees in line with market trends. Incentives such as discretionary bonuses and shares under share award plan are offered to motivate employees.

The emolument policy of the employees of the Group is set up by the Remuneration Committee on the basis of their merit, qualifications and competence.

The emoluments of the Directors of the Company are decided by the Remuneration Committee, having regard to the Company's operating results, individual performance and comparable market statistics.

# 企業管治報告

#### **CORPORATE GOVERNANCE PRACTICES**

The Company is committed to maintain a high standard of corporate governance practices by emphasising a quality board of directors, sound internal control, transparency and accountability to all the shareholders of the Company.

The Company has complied with all the code provisions set out in the Corporate Governance Code (the "Code") contained in Appendix 14 of the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited throughout the year ended 31st March 2014 except for the deviation from the code provisions A.4.1 and D.1.4 and those discussed below:

The Company was incorporated in Bermuda and enacted by private act, the Asia Commercial Holdings Limited Company Act, 1989 of Bermuda (the "1989 Act"). Pursuant to section 3(e) of the 1989 Act, director holding office as executive chairman or managing director shall not be subject to retirement by rotation at each annual general meeting as provided in the Bye-Laws. As the Company is bound by the provision of the 1989 Act, at this time, the Bye-Laws cannot be amended to fully reflect the requirements of the Code. As such, a special resolution was passed at the special general meeting held on 28th March 2007 to amend the Bye-Laws of the Company so that, inter alia, (i) every director (save for a director holding office as Chairman or Managing Director) of the Company shall be subject to retirement by rotation at least once every three years; (ii) a director may be removed by an ordinary resolution in general meeting instead of a special resolution; and (iii) any director appointed by the Board to fill a casual vacancy or as an additional director shall hold office until the next following general meeting, instead of the next annual general meeting.

To enhance good corporate governance practices, Mr. Eav Yin, the Chairman of the Board has confirmed to the Board that he will voluntarily retire from his directorship at annual general meeting of the Company at least once every three years in order for the Company to comply with the Code, provided that being eligible for re-election, he may offer himself for re-election at the annual general meeting. The Chairman is Mr. Eav Yin while the function of the chief executive officer is divided between the remaining executive directors.

Code provision A.4.1 of the Code provides that non-executive director should be appointed for a specific term, subject to re-election.

During the year, the non-executive directors of the Company are not appointed for a specific term but are subject to retirement by rotation at least once every three years and re-election at the annual general meeting in accordance with the Company's Bye-Laws. As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are not less exacting than those in the Code.

Code provision D.1.4 stipulates that directors should clearly understand delegation arrangements in place. Company should have formal letters of appointment for directors setting out the key terms and conditions of their appointments.

#### 企業管治常規

本公司致力透過高質素的董事會、有效的內部監控、 對本公司全體股東之透明度及問責性維持高水平之企 業管治常規。

於截至二零一四年三月三十一日止年度,本公司已遵守聯交所證券上市規則(「上市規則」)附錄十四企業管治常規守則(「守則」)所載的所有條文,惟對守則條文A.4.1條及D.1.4條以下之偏離者除外:

為提升良好企業管治常規,董事會主席楊仁先生已向 董事會確認彼將自願最少每三年一次於本公司之股東 週年大會上按照守則之規定退任董事職務,惟倘符合 資格,彼可於股東週年大會上膺選連任。楊仁先生為 主席,而行政總裁之職能則由餘下之執行董事分擔。

守則條例A.4.1規定,非執行董事應有指定任期,並須 輪值退任。

年內,本公司之非執行董事並無指定任期,但須根據本公司之公司細則最少每三年輪值退任一次及須於股東 週年大會上重選。因此,本公司認為已採取充足措施以 確保本公司之企業管治常規並不比守則所定者寬鬆。

守則條文第D.1.4條規定,董事應清楚地認識到適當委託安排。公司應該有正式的董事委任函件載列其委任之主要條款及條件。

The Company has not entered into any written letters of appointment with its Directors. However, the Board recognises that (i) the Directors have already been subject to the laws and regulations applicable to directors of a company listed on The Stock Exchange of Hong Kong Limited, including the Listing Rules as well as the fiduciary duties to act in the best interests of the Company and its shareholders; (ii) all of them are well established in their professions; and (iii) the current arrangement has been adopted by the Company for several years and has proven to be effective. Therefore, the Board considers that the Directors are able to carry out their duties in a responsible and effective manner under the current arrangement.

A balanced composition of Executive and non-executive Directors also generates a strong independent element on the Board, which allows independent and objective decision making process for the best interests of the Company.

#### **BOARD DIVERSITY POLICY**

The Company has adopted a board diversity policy (the "Policy") which sets out the approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board. Pursuant to the Policy, the Company seeks to achieve Board diversity through the consideration of a number of factors, including but not limited to gender, age, culture and education background, ethnicity, professional experience, skills, knowledge and length of service.

The Board will review the Policy from time to time to ensure its continued effectiveness. At present, the Board has not set measurable objectives to implement the Policy.

#### **REMUNERATION COMMITTEE**

The Board set up the Remuneration Committee on 15th July 2005 with specific written terms of reference which clearly deal with its authority and duties. The terms of reference have been updated during the year in line with the revised Corporate Governance Code requirement effective from 1st April 2012. The Remuneration Committee's role is to make recommendation to the Board on the remuneration policy and structure for Directors and senior management and to ensure that they are fairly rewarded for their individual contribution to the Group's overall performance, having regard to the interests of shareholders. The principal duties of the Remuneration Committee include determining the specific remuneration packages of all Directors and senior management as well as reviewing and approving performance-based remuneration by reference to corporate goals and objectives resolved by the Board from time to time.

The Audit Committee held 2 meetings during the year to review, among other things, the interim and annual financial statements. #### **FINANCIAL REPORTING**

The Board acknowledges its responsibilities for preparing the financial statements where were prepared in accordance with statutory requirements and applicable accounting standards. A statement by the auditor about their reporting responsibilities is set out on pages 34 to 35 of this annual report. As far as the Board is aware, there are no material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

#### **INTERNAL CONTROL**

During the year, the Board, with the establishment of internal audit department, had reviewed the effectiveness of the system of internal control of the Group including material controls over financial, operational and compliance controls and risk management functions.

In addition, the Board has considered the adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function, and their training programmes and budget.

#### SHAREHOLDER COMMUNICATION

The objective of shareholder communication is to provide our shareholders with detailed information about the Company so that they can exercise their rights as shareholders in an informed manner.

These include general meetings, interim and annual reports, announcements and circulars. Procedure for voting by poll has been read out by the chairman at the general meetings.

At the annual general meeting held on 26th September 2013, all directors (except Mr. Eav Ming Keong, Kinson, Mr. André Francois Meier and Ms. Wong Wing Yue, Rosaline) were present to answer questions raised by shareholders and a separate resolution was proposed by the chairman in respect of each separate issue, including re-election of Directors, and voted by way of poll. The Company announced the results of the poll in the manner prescribed under the Listing Rules.

# Procedures for special general meetings requisitioned by the shareholders

Shareholders holding not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company ("Requisitionists") shall have the right to require a special general meeting to be called and propose any matter to be considered at the general meeting of the Company. The Requisitionists may deposit the written requisition for special general meeting (which shall specify the full name of the Requisitionists, the business and proposal to be considered at the general meeting of the Company, and shall be signed by the Requisitionists) to the principal place of business of the Company for the attention of the Board. If within twenty-one days of such deposit, the Board fails to proceed to convene such meeting in specified days as provided by the bye-laws of the Company and the Listing Rules, the Requisitionists themselves may do so in accordance with the provisions of Section 74(3) of the Companies Act 1981 of Bermuda.

#### Procedures for shareholders to propose a person for election as a director

Bye-law 103 of the Bye-laws of the Company provides that no person, other than a retiring Director, shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the Head Office or at the Registration Office at least seven days before the date of the general meeting. The period for lodgment of the notices required under this Bye-law will commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than 7 days prior to the date of such general meeting.

Accordingly, if a shareholder of the Company (the "Shareholder") wishes to propose a person other than a director of the Company for election as a director of the Company at the general meeting (the "Proposal"), he/she should lodge at the principal place of business in Hong Kong of the Company at 19th Floor, 9 Des Voeux Road West, Hong Kong (i) a written notice setting out the Proposal; and (ii) a written notice signed by the person to be proposed of his willingness to be elected.

In order for the Company to inform all Shareholders of the Proposal, the written notice must state the full name of the person proposed for election as a director of the Company, include the person's biographical details as required under rule 13.51(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and such other information (e.g. contact details, including residential address, telephone number, and HKID card/passport number, etc.), and be signed by the Shareholder concerned.

The period for lodgment of above written notices shall commence not earlier than the day after the dispatch of the notice of general meeting and end no later than seven (7) days prior to the date of the general meeting. The Company is required under rule 13.70 of the Listing Rules to provide the information about the Proposal in a supplementary circular or by way of an announcement not later than 10 business days before the general meeting. If the above written notices are received by the Company less than 21 days prior to the general meeting, the Company may need to consider the adjournment of the general meeting.

Provided that an annual general meeting is called for a date six weeks or less after the requisition has been deposited, the requisition though not deposited within the time required shall be deemed to have been properly deposited for the purposes thereof.

### 財務報表附註

#### 1. GENERAL

Asia Commercial Holdings Limited (the "Company") is an investment holding company. Its subsidiaries are principally engaged in trading and retailing of watches and property leasing.

The Company is a limited company incorporated in Bermuda and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and principal place of business of the Company are Canon's Court, 22 Victoria Street, Hamilton HM12, Bermuda and 19th Floor, 9 Des Voeux Road West, Hong Kong respectively.

These financial statements are presented in thousand of units of Hong Kong dollars (HK\$'000), unless otherwise stated. These financial statements have been approved for issue by the Board of Directors on 26th June 2014.

The consolidated financial statements are presented in Hong Kong dollars, which is also the functional currency of the Company.

#### 2. GOING CONCERN

The Group incurred a loss attributable to owners of the Company of HK\$153,278,000 (2013: HK\$208,746,000) and net cash inflow from operating activities of HK\$21,790,000 (2013: outflow of HK\$56,094,000) for the year ended 31st March 2014 and had decrease in net current assets of HK\$119,479,000 (2013: decrease in net current assets of HK\$22,609,000) and net debt of HK\$147,267,000 (2013: HK\$150,969,000) as stated in note 35(b) to the consolidated financial statements as at 31st March 2014. In preparing these consolidated financial statements, the directors of the Company have given careful consideration to the impact of the current and anticipated future liquidity of the Group and the Company and the ability of the Group and the Company to attain profit and positive cash flows from operations in the immediate and longer term.

On 29th February 2012, the Group was granted a longterm loan of HK\$130,000,000 by a bank which is repayable by quarterly installment by February 2016. As of 31st March 2014, the remaining outstanding balances of the bank loan was HK\$74,260,000. Pursuant to the loan facility agreement, an event of default would arise if the Group cannot meet the financial covenants as set out in the loan facility agreement. At the end of the reporting period, the Group was unable to comply with certain of these financial covenants. The directors have negotiated with the bank and obtained a waiver for the breach of the financial covenants. In this regard, the directors considered that the Group's inability to comply with such covenants will not result in any liquidity issue to the Group and the Group will have adequate working capital to finance its operations. Accordingly, these financial statements have been prepared on a going concern basis.

#### 1. 一般事項

冠亞商業集團有限公司(「本公司」)為一間投資控股公司。其附屬公司主要從事鐘錶貿易、零售以及物業租賃。

本公司為一間在百慕達註冊成立之股份有限公司,其股份於香港聯合交易所有限公司(「聯交所」)上市。本公司之註冊辦事處及主要營業地點分別為Canon's Court, 22 Victoria Street, Hamilton HM12, Bermuda及香港德輔道西9號19樓。

除非另外説明,否則本財務報表乃以千港元(「千港元」)呈列。本財務報表已於二零一四年六月二十六日由董事會批准發佈。

本綜合財務報表乃以港元呈列,港元亦是本公司 的功能貨幣。

#### 2. 持續經營

於截至二零一四年三月三十一日止年度,本集團產生本公司持有人應佔虧損153,278,000港元(二零一三年:208,746,000港元),及經營活動產生的現金淨流入21,790,000港元(二零一三年:56,094,000港元流出);及減少流動資產淨值19,479,000港元(二零一三年:減少流動資產淨值22,609,000港元),及債務淨額147,267,000港元(二零一三年:150,969,000港元)如於二零一四年三月三十一日綜合財務報表附註35(b)所述。在編制該等綜合財務報表時,本公司董事已審慎考慮當前和預期的未來流動性對本集團及本公司的影響,以及本集團及本公司在短期及長遠的業務中,實現盈利和正面現金流的能力。

於二零一二年二月二十九日,本集團公司獲一間銀行授予一筆於二零一六年二月到期須按季度分期償還之130,000,000港元長期貸款。於二零一四年三月三十一日,銀行貸款的餘下未償還結餘為74,260,000港元。根據貸款融資協議,倘若本集團無法符合貸款融資協議所載的財務契約,違結等會出現。於呈報期末,本集團未能符合結等財務契諾。董事會已與銀行磋商並獲得團未能符合該等契諾將不會導致本集團出現任何流動性問題,而本集團將具備充足營運資金應付營運將需。因此,該等財務報表乃按持續經營基準編製。

In order to strengthen the Group's capital base and liquidity in the foreseeable future, the Group has taken the following measures:

- In June 2013, the Group entered into a term loan facility agreement for HK\$150 million with Mr. Eav Yin, a director and controlling shareholder of the Company for a period from 27th June 2013 to 30th September 2014. The total amount utilized under the term loan facility agreement as at 31st March 2014 were HK\$52,000,000. The Group renewed the term loan facility agreement with Mr. Eav on 25th June 2014 for another year to 30th September 2015;
- the directors of the Company have been taking various cost control measures to tighten the costs of operations; and
- the directors of the Company have reviewed the performance of individual stores and plan to close non-profitable stores if appropriate.

Based on the cash flow projections of the Group and having taken into account the available financial resources of the Group and the above measures, the directors have concluded that the Group and the Company are able to continue as a going concern and to meet their financial liabilities as and when they fall due in the foreseeable future.

- 於二零一三年六月,本集團與楊仁先生(於 二零一三年六月二十七日至二零一四年九 月三十日期間,為本公司的董事及控股股 東) 訂立150,000,000港元之定期貸款融資協 議。於二零一四年三月三十一日,根據定期 貸款融資協議可動用的總金額為52,000,000 港元。本集團與楊先生於二零一四年六月 二十五日重續另一年至二零一五年九月三十 日的定期貸款融資協議:
- 本公司董事已採取多項成本控制措施以緊縮 經營成本;及
- 本公司董事已檢討個別店舖的表現,並計劃 結束無利可圖的店舖(如適用)。

基於本集團的現金流量預測及經考慮本集團可動 用財務資源及上述措施,公司董事會認為本集團 及本公司能夠繼續持續經營,以及在可預見的將 來其金融負債到期時能達到要求。

#### (a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the applicable disclosure requirements of the Hong Kong Companies Ordinance, which for this financial year and the comparative period continue to be those of the predecessor Companies Ordinance (Cap. 32), in accordance with transitional and saving arrangements for Part 9 of the new Hong Kong Companies Ordinance (Cap. 622), "Accounts and Audit", which are set out in sections 76 to 87 of Schedule 11 to that Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. A summary of the significant accounting policies adopted by the Group is set out below.

The HKICPA has issued certain new and revised HKFRSs which are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 4 provides information on initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these financial statements.

#### (b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31st March 2014 comprise the Company and its subsidiaries.

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the following assets and liabilities are stated at their fair value as explained in the accounting policies set out below:

- investment property (see note 3(f)); and
- financial instruments classified as available-for-sale or as trading securities (see note 3(e)).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 40.

#### (b) 編製財務報表基準

截至二零一四年三月三十一日止年度之綜合 財務報表包括本公司及其附屬公司。

在編制財務報表時所使用的計量基準為歷史 成本基準,以下按其公允值呈列之資產及負 債如下文所載之會計政策所解釋除外:

- 物業投資(參閱附註3(f));及
- 一 分類為可供出售或證券買賣之金融工 具(參閱附註3(e))。

編製符合香港財務報告準則之財務報表需要管理層作出影響政策應用及所呈報資產、負債、收入及費用之數額之判斷、估計及假設。估計及相關假設乃根據過往經驗及在該等情況下乃屬合理之各種其他因素而作出,其結果構成對無法從其他來源中容易得出之資產及負債之賬面值作出判斷之基準。實際結果可能與於該等估計有所不同。

管理層按持續經營基準檢討估計及相關假設。倘修訂會計估計僅影響修訂之期間,則該修訂於該期間內確認,或倘修訂影響本期間及未來期間,則修訂於本期間及未來期間內確認。

管理層於應用香港財務報告準則時所作出構成對財務報表重大影響的判斷及估計不明朗因素的主要來源於附註40內討論。

#### (c) Subsidiaries and non-controlling interests

Subsidiaries are entitles controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the owners of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the owners of the Company. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the noncontrolling interests even if this results in the non-controlling interests having a deficit balance. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position.

於附屬公司的投資由控制開始當日至控制終止當日綜合計入綜合財務報表。集團內公司間的交易結餘及交易以及現金流,與任何因集團內公司間交易而產生的未變現溢利均在編製綜合財務報表時全數對銷。集團內公司間交易所產生的未變現虧損以處理未變現收益的同樣方式對銷,惟僅會在無減值跡象的情況下進行。

非控股股東權益指並非由本公司直接或間接 佔有之附屬公司權益,及有關本集團並未同 意與該等權益持有人之任何附加條款,其將 導致本集團整體上就有關符合金融負債定義 之該等權益負上合約義務。

非控股股東權益呈列於綜合財務狀況表內之權益,與歸屬於本公司持有人之權益分開。 非控股股東權益於本集團業績中在綜合損益 表及綜合損益及其他全面收益表一欄內呈 列,及綜合全面收益表為本年內利潤或虧損 總額及全面收益總額在非控股股東權益及其 。附屬公司全面收益 總額歸屬於本公司持有人及歸屬於非控股股 東權益,即使該等結果在非控股股東權益及 其他合 同義務的貸款,對該等持有人於綜合財務狀 況表作為金融負債呈列。

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, the interest in subsidiaries is stated at cost less impairment losses (see Note 3(i)), unless the investment is classified as held for sale (or included in a disposed group that is classified as held for sale).

#### (d) Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair values, except that:

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at their fair value or, when applicable, on the basis specified in another HKFRS.

Where the consideration transferred by the Group in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured at subsequent reporting dates in accordance with HKAS 39 "Financial Instruments: Recognition and Measurement", or HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets", as appropriate, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control) and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period (see above), or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

The Group's and the Company's policies for investments in debt and equity securities, other than investments in subsidiaries, are as follows:

Investments in debt and equity securities are initially stated at fair value, which is their transaction price unless it is determined that the fair value at initial recognition differs from the transaction price and that fair value is evidenced by a quoted price in an active market for an identical asset or liability or based on a valuation technique that uses only data from observable markets. Cost includes attributable transaction costs, except where indicated otherwise below. These investments are subsequently accounted for as follows, depending on their classification:

Investments in securities held for trading are classified as current assets. Any attributable transaction costs are recognised in profit or loss as incurred. At the end of each reporting period the fair value is remeasured, with any resultant gain or loss being recognised in profit or loss. The net gain or loss recognised in profit or loss does not include any dividends or interest earned on these investments as these are recognised in accordance with the policies set out in Note 3(s).

Dated debt securities that the Group and/or the Company have the positive ability and intention to hold to maturity are classified as held-to-maturity securities. Held-to-maturity securities are stated at amortised cost less impairment losses (see note 3(i)).

Investments in securities which do not fall into any of the above categories are classified as available-for-sale securities. At the end of each reporting period the fair value is remeasured, with any resultant gain or loss being recognised in other comprehensive income and accumulated separately in equity in the fair value reserve. As an exception to this, investments in equity securities that do not have a quoted price in an active market for an identical instrument and whose fair value cannot otherwise by reliably measured are recognised in the statement of financial position at cost less impairment losses (see note 3(i)). Dividend income from equity securities and interest income from debt securities calculated using the effective interest method are recognised in profit or loss in accordance with the policy set out in note 3(s). Foreign exchange gains and losses resulting from changes in amortised cost of debt securities are also recognised in profit or loss.

When the investments are derecognised or impaired, the cumulative gain or loss recognised in equity is reclassified to profit or loss. Investments are recognised/derecognised on the date the Group commits to purchase/sell the investments or they expire.

債務及股本證券投資最初以公允值,即其交易價格列賬,除非判斷於初始確認時之公允值和交易價格有所不同,而該公允值是以相同資產或負債在活躍市場的報價作依據,或採用僅輸入可觀察市場數據的估值技術。成本包括應佔交易成本,惟並不包括以下所述情況。該等投資其後將根據其分類按下列方式列賬:

持有作買賣用途之證券投資,分類為流動資產。任何相關之交易成本於產生時在損益中確認。於每個報告期末,公允值須重新計量,任何產生之損益於損益中確認。於損益中確認的溢利或虧損淨額不包括任何由該等投資收取之股息或利息,該等投資之股息或利息收入根據附註3(s)所載之政策確認。

有期債務證券為本集團及/或本公司有足夠能力和意向持至到期日的債務證券,被歸類為持至到期證券。持至到期證券按攤銷成本扣減減值虧損呈列(見附註3(j))。

#### Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see Note 3(h)) to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment properties are stated at fair value, unless they are still in the course of construction or development at the end of the reporting period and their fair value cannot be reliably measured at that time. Any gain or loss arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss. Rental income from investment properties is accounted for as described in Note 3(s).

When the Group holds a property interest under an operating lease to earn rental income and/or for capital appreciation, the interest is classified and accounted for as an investment property on a property-by-property basis. Any such property interest which has been classified as an investment property is accounted for as if it were held under a finance lease (see Note 3(h)), and the same accounting policies are applied to that interest as are applied to other investment properties leased under finance leases. Lease payments are accounted for as described in Note 3(h).

#### (g) Property, plant and equipment

The following items of property, plant and equipment are stated in the statement of financial position at cost less accumulated depreciation and impairment losses (see Note 3(i)):

- buildings;
- other items of property, plant and equipment.

If an item of property becomes an investment property because its use has changed as evidenced by end of owneroccupation, any difference between the carrying amount and the fair value of that item at the date of transfer is recognised in other comprehensive income and accumulated in revaluation reserve. On the subsequent sale or retirement of the asset, the relevant revaluation reserve will be transferred directly to retained profits.

Historical cost includes expenditure that is directly attributable to the acquisition of the items. Cost may also include transfers from equity of any gains/losses on qualifying cash flow hedges of foreign currency purchases of property, plant and equipment.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are recognised in profit or loss during the financial period in which they are incurred.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Construction-in-progress represents leasehold improvements under construction and pending installation and is stated at cost less accumulated impairment losses, if any. Cost includes the costs of leasehold improvements and, for qualifying assets, borrowing costs capitalized in accordance with the Group's accounting policies. No provision for depreciation is made on construction-in-progress until such time as the relevant assets are completed and ready for intended use. When the assets concerned are brought to use, the costs are transferred to property, plant and equipment and depreciated in accordance with the policy as stated above.

#### (h) Leased assets

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

Depreciation is provided at rates which write off the cost of the assets over the term of the relevant lease or, where it is likely the Company or Group will obtain ownership of the asset, the life of the asset, as set out in Note 3(g). Impairment losses are accounted for in accordance with the accounting policy as set out in Note 3(i). Finance charges implicit in the lease payments are charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period.

Most leases provide for monthly fixed minimum rentals or contingent rentals based upon sales in excess of stated amounts and normally require the Group to pay insurance, common area maintenance costs and other occupancy costs. The Group recognizes rent expense for leases that include scheduled and specified escalations of the minimum rent on a straight-line basis over the base term of the lease. Any difference between the straight-line rent amount and the amount payable under the lease is included in other liabilities in the consolidated statement of financial position. Contingent rental payments are expensed as incurred.

The cost of acquiring land held under an operating lease and is presented as "prepaid lease payments" in the consolidated statement of financial position, is amortised on a straight-line basis over the period of the lease term except where the property is classified as an investment property (see note 3(f)).

Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

### - Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see Note 3(i)(i) and (ii)).

#### (j) Inventories

Inventories are carried at the lower of cost and net realisable value. Cost is calculated on a first-in, first-out basis and comprises all costs of purchase, cost of conversion and other cost incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

In such cases, the receivables are stated at cost less allowance for impairment of doubtful debts (see Note 3(i)).

#### (I) Interest-bearing borrowings

Interest-bearing borrowings are recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost with any difference between the amount initially recognised and redemption value being recognised in profit or loss over the period of the borrowings, together with any interest and fees payable, using the effective interest method.

#### (m) Trade and other payables

Trade and other payables are initially recognised at fair value. Except for financial guarantee liabilities measured in accordance with note 3(r)(i), trade and other payables are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### (n) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a components of cash and cash equivalents for the purpose of the consolidated statement of cash flows.

貿易及其他應收賬款初步按公允值確認,其後應用有效利率法按攤銷成本減呆壞賬減值虧損後列賬,惟倘應收賬款為向非關連人士作出且無固定還款期之免息貸款或貼現之影響不大情況則作別論。於該等情況下,應收賬款按成本減呆壞賬減值撥備列賬(見附註3(j))。

#### (I) 附息借款

附息借款按公允值減應佔交易成本初始確認。初始確認後,附息借款以攤銷成本列賬,而初始確認金額與贖回價值之任何差異,均以有效利率法於借款期內連同任何應付利息及費用在損益表中確認。

#### (m) 貿易及其他應付賬項

貿易及其他應付賬項初步按公允值確認。除財務擔保負債根據附註3(r)(i)外,貿易及其他應付賬項其後則按攤銷成本列賬,惟在貼現並無重大影響之情況下,則會按成本列賬。

#### (n) 現金及現金等值物

現金及現金等值物包括存於銀行及手頭之現金、銀行及其它財務機構之即期存款,及短期而高流動性之投資,即於購入時三個月內到期而在沒有涉及重大價值轉變之風險下可以隨時轉換為已預知金額現金之投資。按要求償還之銀行透支為本集團之現金管理不可或缺的一部份,亦包括於綜合現金流量表中現金及現金等值物之組合部份。

#### (o) Convertible notes

Convertible notes that can be converted to equity share capital at the option of the holder, where the number of shares that would be issued on conversion and the value of the consideration that would be received at that time do not vary, are accounted for as compound financial instruments which contain both a liability component and an equity component.

At initial recognition the liability component of the convertible notes is measured as the present value of the future interest and principal payments, discounted at the market rate of interest applicable at the time of initial recognition to similar liabilities that do not have a conversion option. Any excess of proceeds over the amount initially recognised as the liability component is recognized as the equity component. Transaction costs that relate to the issue of a compound financial instrument are allocated to the liability and equity components in proportion to the allocation of proceeds.

The liability component is subsequently carried at amortised cost. The interest expense recognised in profit or loss on the liability component is calculated using the effective interest method. The equity component is recognised in the convertible notes equity reserve until either the note is converted or redeemed.

If the note is converted, the convertible notes equity reserve, together with the carrying amount of the liability component at the time of conversion, is transferred to share capital and share premium as consideration for the shares issued. If the note is redeemed, the capital reserve is released directly to retained profits.

#### (p) Employee benefits

 Short term employee benefits and contributions to defined contribution retirement plans

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

於初步確認時,可換股票據之負債部份按未來利息和本金之現值計算,而未來利息和本金之現值計算,而未來利息和本金之現值是以無轉換權之同類負債於初步確認時適用之市場利率貼現計算。任何超過初步確認為負債部份之所得款項將確認為股本部分。與發行複合金融工具之相關交易成本將按所得款項之分配比例分配到負債及股本部分。

#### (ii) Share-based payments

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in share option reserve within equity. The fair value is measured at grant date using the binomial lattice model, taking into account the terms and conditions upon which the options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share options, the total estimated fair value of the share options is spread over the vesting period, taking into account the probability that the options will vest.

During the vesting period, the number of share options expected to vest is reviewed. Any resulting adjustment to the cumulative fair value recognised in prior years is charged/credited to the profit or loss for the year under review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the share option reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of share options that vest (with a corresponding adjustment to the share option reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognised in the share option reserve until either the option is exercised (when it is transferred to the share premium account) or the option expires (when it is released directly to retained profits).

#### (iii) Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

#### (q) Income tax

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit before tax" as reported in the profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

#### (ii) 以股份為基礎之付款

授予僱員之購股權公允值於股本中之 購股權儲備相應增加而確認為僱員成 本。公允值於授出日使用二項式點陣 法模式計算,並考慮授出購股權時之 條款及條件。如僱員於無條件獲授購 股權節須先符合歸屬條件,則計入購 股權歸屬之可能性後,估計之購股權 公允值總額按歸屬期計算。

#### (iii) 終止福利

終止福利須於本集團不得再撤銷提供 該等福利,及本集團確認涉及支付終止 福利之重組之成本時(以較早者為準) 確認。

#### (q) 所得税

所得税開支指當期應付税項及遞延所得税項 總和。

#### (q) Income tax (Continued)

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities. For the purposes of measuring deferred tax liabilities or deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment properties are depreciable and are held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Current and deferred tax is recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax are also recognised in other comprehensive income or directly in equity, respectively. Where amount tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for business combination.

### (q) 所得税(續)

遞延税項為就綜合財務報表資產及負債賬面 值及計算應課税溢利相應稅基暫時性差額而 須確認之稅項。遞延稅項負債通常會就所有 應課稅暫時性差額確認。一般確認為遞延所 得稅資產可抵扣暫時性差異乃按可能出現可 利用暫時性差額扣稅之應課稅溢利時確認。 於並不影響應課稅溢利或會計溢利之交易 中,倘暫時性差額由初步確認其他資產及負 債(業務合併除外)產生,則不會確認該等資 產及負債。

遞延税項負債就有關投資於附屬公司所產生之可課税暫時性差異而確認,惟倘本集團作為母公司可以控制暫時性差異之撥回,並暫時性差異在可預見未來不可能會撥回則除外。遞延稅項資產就該等投資及權益所產生之可抵扣暫時性差異而引起,只按可能將有足夠的應稅利潤可抵銷暫時性差異之利益的範圍內,並該等經營在可預見未來可扭轉而確認。

遞延税項資產及負債乃按於報告期末已頒佈 或已實質頒佈,預期於負債清償或資產變現 期間適用之税率(及税法)計量。遞延税項負 債及資產計量反映按該集團預計之方式,於 報告期末可取回或解決其資產和負債的賬面 金額所引致不確定之税項。對於以公允值模 式計量之投資物業,為計量其遞延税項負債 或遞延税項資產之目的,該等物業的賬面值 被假定為透過出售可完全收回,除非該假定 被推翻。當該投資物業為應折舊資產,而且 以隨著時間實質地消耗該投資物業所包含之 全部經濟利益,而不是通過出售之商業模式 持有,則該假設可被推翻。當期及遞延税項 於損益中確認,惟當其於其他全面收益或直 接於權益中確認之相關項目除外,在此情況 下,當期及遞延税項亦分別於其他全面收益 或直接於股本中確認。其中來自初次會計處 理的企業合併的當期税項或遞延税項,有關 税務影響包括在業務合併會計處理內。

# (r) Financial guarantees issued, provisions and contingent liabilities

#### (i) Financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of the debt instrument.

Where the Group issues a financial guarantee, the fair value of the guarantee (being the transaction price, unless the fair value can otherwise be reliably estimated) is initially recognised as deferred income within trade and other payables. The fair value of financial guarantees issued at the time of issuance is determined by reference to fees charged in an arm's length transaction for similar services, when such information is obtainable, or is otherwise estimated by reference to interest rate differentials, by comparing the actual rates charged by lenders when the guarantee is made available with the estimated rates that lenders would have charged. had the guarantees not been available, where reliable estimates of such information can be made. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

The amount of the guarantee initially recognised as deferred income is amortised in profit or loss over the term of the guarantee as income from financial guarantees issued. In addition, provisions are recognised in accordance with Note 3(r)(ii) if and when (i) it becomes probable that the holder of the guarantee will call upon the Group under the guarantee, and (ii) the amount of that claim on the Group is expected to exceed the amount currently carried in trade and other payables in respect of that guarantee i.e. the amount initially recognised, less accumulated amortisation.

#### (ii) Other provisions and contingent liabilities

Provisions are recognised for other liabilities of uncertain timing or amount when the Group or the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

#### (i) 所發出的財務擔保

財務擔保乃要求發行人(即擔保人)就 擔保受益人(「持有人」)因特定債務人 未能根據債務工具之條款於到期時付 款而蒙受之虧損,而向持有人支付特 定款項之合約。

當本集團發出財務擔保,該擔保之公允 值(即交易價格,除非該公允值能確實 估計)最初確認為應付貿易及其他賬項 內之遞延收入。已發出財務擔保的公允 價值於發出時乃參照類似服務於公平 磋商交易的過程中所收取的費用(如可 獲得該等資料)而釐定,或參照息差作 出估計,方法為以貸款人在獲提供擔保 之情況下實際收取之利率與在不獲提 供擔保之情況下貸款人將會收取之估 計利率作比較(如該等資料能可靠地估 計)。倘在發行該擔保時收取或可收取 代價,該代價則根據適用於該類資產之 本集團政策而予確認。倘並無有已收取 或應予收取之代價,則於最初確認任何 遞延收入時,即時於損益內確認開支。

最初確認為遞延收入之擔保款額按擔保年期於損益內攤銷為發出財務擔保收入。此外,倘(i)擔保持有人有可能根據擔保向集團追索:及(ii)向集團申索款額預期超過現時列於應付貿易及其他賬款內之擔保金額(即最初確認的金額減累計攤銷),則按附註3(r)(ii)確認有關撥備。

倘本集團或本公司須就已發生事件承 擔法律或推定責任,因而預期會導致 含有經濟效益之資源外流,於可作出 可靠估計時,本集團或本公司便會就 該時間或數額不定之其他負債計提準 備。倘貨幣時間值重大,則按預計所需 支出之現值計提撥備。

倘含有經濟效益的資源外流之可能性 較低,或無法對有關數額作出可靠估 計,便則將該責任披露為或有負債,但 資源外流可能性極低者則除外。倘本 集團之責任須視乎某宗或多宗未來事 件是否發生才能確定是否存在,亦能性 極低者則除外。

#### (iii) Onerous contracts

Present obligations arising under onerous contracts are recognised and measured as provisions. An onerous contract is considered to exist where the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract.

#### (s) Revenue recognition

Revenue is measured at fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follow:

Sales of goods are recognised when goods are delivered and the customer has accepted the goods and related risks and rewards of ownership. Revenue excludes value added tax or other sales taxes and after deducting of any trade discounts.

Revenue from provision of services is recognised when services are provided.

Interest income from a financial asset is recognised when it is probable that the economic benefits, will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

Dividend income from unlisted investments is recognised when the shareholders' rights to receive payment have been established. Dividend income from listed investments is recognised when the share price of the investment goes exdividend.

根據有償合約產生的現時責任確認和 計量為撥備。有償合約被視為存在當 本集團擁有一份合約,根據合約符合 責任之不可避免成本超過該合約預計 將收到的經濟效益。

#### (s) 收入確認

收入按已收及應收代價之公允值計量。只要 是經濟利益將有可能流入本集團,而收入和 成本(如適用下列)能夠可靠地計量,收入將 於損益內確認:

貨品之銷售收益在貨品付運予客戶,當客戶 已接納該貨品及有關風險和擁有權時確認。 收入不包括增值税或其他銷售税及扣除任何 貿易折扣後。

提供服務之收入乃於提供服務時確認。

金融資產利息收入之確認,當其經濟利益可能將流入本集團以及收入金額能夠可靠地計量。利息收入按時間基準確認,參考未償還本金及適用之實際利率計算,該利率為確實地將金融資產之預計可用年期內之估計未來現金收入初步確認折現至該資產之賬面淨值之折現率。

經營租賃之應收租金收入是根據租期所涵蓋的期間以等額於損益內確認,但如有其他基準對於來自使用該租賃資產所得利益之模式,能更具有代表性則例外。租賃優惠在損益內確認為一個應收租賃總額不可分割的一部分。或然租金於其賺取之會計期間內,確認為收入。

來自非上市投資之股息收入於股東收取付款 的權利確定時予以確認。上市投資之股息收 入在投資之股價除息時確認。

#### (t) Translation of foreign currencies

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates ruling at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In the case of a partial disposal of a subsidiary that includes a foreign operation that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are re-attributed to noncontrolling interests and are not recognised in profit or loss.

#### (t) 外幣換算

年內之外幣交易均按交易日之適用匯率換算。於報告期末,以外幣為單位之貨幣資產 及負債均按報告期末之適用匯率換算。匯兑 盈虧均於損益內確認。

按歷史成本計值之外幣非貨幣資產及負債乃 以交易日適用之匯率換算。按公允值計值之 外幣非貨幣資產及負債乃以公允值獲計量日 之適用匯率換算。

海外業務之業績乃按接近交易日外幣匯率的 兑換率換算為港元。財務狀況表項目,均以 報告期末之適用匯率收市價換算為港元。產 生之匯兑差額於其他全面收益及於滙兑儲備 之獨立累計股本中確認。

於出售海外業務(即出售本集團於海外業務的全部權益,或出售涉及失去對附屬公司的控制權(包括海外業務)),就有關歸屬於本公司持有人的業務累計於權益之所有匯兑差額重新分類至損益。

就部分出售一間附屬公司包括海外業務,並不會導致本集團失去控制權情況下,按比例 所佔的累計匯兑差額乃重新計入非控股權益 且不會在於損益表中確認。

#### (u) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

#### (v) Related parties

- (a) A person, or a close member of that person's family, is related to the Group if that person:
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Group or the Group's parent;
- (b) An entity is related to the Group if any of the following conditions applies:
  - The entity and the Group are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others);
  - (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member);
  - (iii) Both entities are joint ventures of the same third party;
  - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity;

In addition, the Group has chosen to use the new titles "consolidated statement of profit or loss" and "consolidated statement of profit or loss and other comprehensive income" as introduced by the amendments in these consolidated financial statements.

#### **HKFRS 10 Consolidated Financial Statements**

HKFRS 10 replaces the requirements in HKAS 27 Consolidated and Separate Financial Statements relating to the preparation of consolidated financial statements and HK-SIC 12 Consolidation – Special Purpose Entities. It introduces a single control model to determine whether an investee should be consolidated, by focusing on whether the entity has power over the investee, exposure or rights to variable returns from its involvement with the investee and the ability to use its power to affect the amount of those returns. As a result of the adoption of HKFRS 10, the Group has changed its accounting policy with respect to determining whether it has control over an investee. The adoption does not change any of the control conclusions reached by the Group in respect of its involvement with other entities as at 1st April 2013.

#### **HKFRS 12 Disclosure of Interests in Other Entities**

HKFRS 12 brings together into a single standard all the disclosure requirements relevant to an entity's interests in subsidiaries, joint arrangements, associates and unconsolidated structured entities. The disclosures required by HKFRS 12 are generally more extensive than those previously required by the respective standards.

#### **HKFRS 13 Fair Value Measurement**

HKFRS 13 replaces existing guidance in individual HKFRSs with a single source of fair value measurement guidance. HKFRS 13 also contains extensive disclosure requirements about fair value measurements for both financial instruments and non-financial instruments. The adoption of HKFRS 13 does not have any material impact on the fair value measurements of the Group's assets and liabilities.

#### (i) Store closure costs

The store closure costs for the year ended 31st March 2014 comprised of a loss on write off of leasehold improvements and equipment of HK\$3,053,000, other expenses for store closure of HK\$84,000 and write off of rental deposits totalling HK\$4,861,000 for early termination of operating leases.

The store closure costs for the year ended 31st March 2013 include loss on write off of leasehold improvements and equipment of HK\$1,592,000, write off of construction in progress of HK\$6,593,000 and write off of rental deposits and prepayments and compensation totalling HK\$8,221,000 for early termination of operating lease upon closure of stores.

### (ii) Impairment loss on other receivables

The impairment loss on other receivables mainly represented the carrying amount of the rental prepayment exceeds its recoverable amount.

### (iii) Gain on early move out of a store

During the year, a supplier of the Group took over the operation of a store in the PRC. In return for the early move out of the store by the Group, the supplier paid a compensation of HK\$4,728,000 to the Group upon handover of the store.

#### 8. SEGMENT REPORTING

The Group manages its business by divisions. In a manner consistent with the way in which information is reported internally to the board of directors of the Company, being the chief operating decision maker ("CODM") for the purposes of resource allocations and performance assessments. The Group has presented two reportable segments: (i) sale of watches and (ii) properties leasing. No operating segments have been aggregated to form these two reportable segments.

For the purposes of assessing segment performance and allocating resources between segments, the CODM monitors the results, assets and liabilities attributable to each reportable segment on the following bases:

The accounting policies of the reportable segments are the same as the Group's accounting policies described in note to the financial statements. Segment profit/(loss) represents the profit earned by/(loss) from each segment without allocation of central administration costs such as those finance costs and corporate costs which cannot be meaningfully allocated to individual segment. This is the measure reported to the CODM for the purposes of resource allocation and performance assessment.

Revenue and expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation and amortization of assets attributable to those segments.

The revenue from external parties reported to the CODM is measured in a manner consistent with that in the consolidated statement of profit or loss.

All assets are allocated to reportable segments other than available-for-sale investments and other corporate assets.

All liabilities are allocated to reportable segments other than current income tax payable, deferred tax liabilities and borrowings not attributable to individual segments and corporate liabilities.

As disclosed in note 2 to the financial statements, the Group failed to fulfill certain financial covenants under a term loan agreement, namely, the current ratio and tangible net worth of Asia Commercial Holdings Limited and its subsidiaries. Such breach entitles the bank to declare the outstanding principal amount, accrued interest and all other sums payable under the bank loan to become immediately due and payable. As such, the whole amount of the outstanding bank loan of HK\$74,260,000 was classified as bank loans due for repayment within one year.

The bank loans are carried at amortised cost.

The effective interest rates (which are also equal to contractual interest rates) on the Group's bank loans are ranged from 2.90% to 6.60% (2013: 2.90% to 7.21%) per annum.

As at 31st March 2014, the secured bank loans were secured by (i) pledged of assets as disclosed in note 37, (ii) corporate guarantees given by the Company (iii) assignment of dividends payable by 冠亞名表城(上海)貿易有限公司 and shareholder's loans of 冠亞名表城(上海)貿易有限公司 advanced or to be advanced by Time City (Hong Kong) Limited and (iv) assignment of rental income from certain investment properties.

As at 31st March 2013, the unsecured bank loans of HK\$18,676,000 is guaranteed by the bank deposit of HK\$3,900,000 owned by a director, Mr. Eav Yin and corporate guarantees from the Company and certain subsidiaries.

### (b) Deferred tax assets not recognised

The Group has allowable tax losses arising in Hong Kong of approximately HK\$500,738,000 (2013: HK\$452,594,000) which are mainly arisen prior to the capital restructuring in 1997, that are available for offsetting against future taxable profits of the companies in which the losses arose. Deferred tax assets have not been recognised in respect of these losses due to the unpredictability of future profit streams. The tax losses do not expire under the current tax legislation. Tax losses of approximately HK\$66,884,000 (2013: HK\$33,622,000) attributable to the continuing operations in the PRC are available for offsetting against future profits that may be carried forward for five years for the PRC Corporate Income Tax purpose.

A lower withholding tax rate may be applied if there is a tax treaty arrangement between the PRC and the jurisdiction of the foreign enterprise investors. On 22nd February 2008, Caishui (2008) No. 1 was promulgated by the PRC tax authorities to specify that dividends declared and remitted out of the PRC from the retained earnings as at 31st December 2007 determined based on the relevant PRC tax laws and regulations are exempted from the withholding tax. At 31st March 2014, temporary differences relating to the undistributed profits of subsidiaries amounted to HK\$28,013,000 (2013: HK\$91,417,000). Deferred tax liabilities in respect of these temporary differences have not been recognised, as the Company controls the dividend policy of the subsidiaries of the Group in the PRC and it has been determined that it is probable that the profits earned by the Group's subsidiaries in the PRC for the period from 1st January 2008 to 31st March 2014 will not be distributed in the foreseeable future.

The Group's activities expose it to a variety of financial risks: credit risk, liquidity risk and market risk (including foreign currency risk and interest rate risk). The Group is also exposed to equity price risk arising from its equity investments in other entities. These risks are limited by the Group's financial management policies and practices described below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

### (i) Credit risk

Credit risk is the risk of financial loss to the Group if a customer or counterparty to a financial instrument fails to meet its contractual obligations, and the Group's credit risk primarily arises from cash at banks and, trade and other receivables. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

Cash at banks and bank deposits are placed with licensed financial institutions with high credit ratings. The Group monitors the exposure to each single financial institution.

For trade and other receivables, credit checks are part of the normal operating process and stringent monitoring procedures are in place to deal with overdue debts. In addition, the Group reviews the recoverable amounts of trade and other receivables at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts.

The Group has no significant concentrations of credit risk with exposure spread over a number of counterparties and customers. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the statement of financial position after deducting any impairment allowance. Normally, the Group does not obtain collateral from customers.

Further quantitative disclosure in respect of the Group's exposure to credit risk arising from trade receivables and other receivables are set out in Note 21.

Except for the financial guarantees given by the Company as set out in note 41, the Group and the Company do not provide any other guarantees which would expose the Group or the Company to credit risk. The maximum exposure to credit risk in respect of these financial guarantees at the end of the reporting period is disclosed in note 41.

### (ii) Liquidity risk

Liquidity risk is the risk that the Group will not be able to meet its financial obligations as they fall due. The Group's policy is to regularly monitor its current and expected liquidity requirements and its compliance with lending covenants, to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

The management reviews the capital structure by considering the cost of capital and the risks associated with each class of capital. In view of this, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt as it sees fit and appropriate.

The Group monitors capital using gearing ratio, which is net debt divided by the total equity. Net debt is calculated as bank loans, loans from a director and convertible notes less pledged bank deposits and cash and cash equivalents as shown in the consolidated statement of financial position. Total equity comprises all components of equity. The Group aims to maintain the gearing ratio at a reasonable level. The gearing ratios as at the end of the reporting period were as follows:

In preparing these financial statements, management is required to exercise significant judgements in the selection and application of accounting principles, including making estimates and assumptions. The following is a review of the more significant accounting policies that are impacted by judgements and uncertainties and for which different amounts may be reported under a different set of conditions or using different assumptions.

# a) Critical judgements in applying the Group's accounting policies

In the process of applying the Group's accounting policies, management has made the following accounting judgements:

#### (i) Provision for store closure

The provision for store closure of the Group consists of provisions for store closure costs, compensation to landlords and other related costs.

The Group recognises and measures a provision for store closure costs as a provision for onerous contract. In accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets", an onerous contract is a contract in which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received under it. The unavoidable costs under a contract reflect the least net cost of exiting from the contract, which is the lower of the cost of fulfilling it and any compensation or penalties arising from failure to fulfill it.

The Group estimates the provision based on the amount of compensation payment agreed with the landlord as a result of early termination of leases, unfulfilled lease obligations, and economic benefits estimated to be received from fulfilling the lease contracts. Management also consults with retail agencies for certain locations in respect of the current market trends. The Group also estimates the provision based on past experience of payout ratio of the total compensation to the landlords. Estimates differ depending on the current rent, location, lease exit terms and management's assessment of when the lease term can be terminated early and expected benefits to be received from fulfilling the leases. Except for stores which termination contracts have already been agreed with the landlords, the settlement of these contracts may be different from the Group's estimation subject to the negotiation with the landlords and the economic benefits estimated to be received. The Group recognises a provision for compensation to employees when the Group has a detailed formal plan for store closure and has communicated the plan to the employees affected by it. The Group recognises a provision for other related costs when obligations for direct expenditures necessarily entailed by the plan for store closure and not associated with the ongoing activities of the Group arise.

### (ii) Fair value of investment properties

Investment properties are stated at fair value based on valuation performed by independent professional valuers. The determination of the fair value involves certain assumptions of market conditions. In relying on the valuation report, the directors of the Company have exercised their judgment and are satisfied that the method of valuation is reflective of the current market conditions.

### (i) 結束店舗撥備(續)

本集團確認店舗結束撥備乃根據零售 店舖符合所有租賃及其他責任下估計 的不可避免成本,扣除預計將可從店 舖收到的經濟利益(如有)。本集團估 計之撥備乃根據與業主因提早終止租 約、未履行租賃義務、及履行租賃合約 估計將獲得的經濟利益而議定的補償 金額。管理層亦就某些地點的當前市 場趨勢諮詢零售代理。本集團亦根據 過往經驗補償總額予業主的支付比率 估計撥備。估計的差異視乎於目前租 金、位置、租賃終止條款,以及管理層 評估租賃期限何時可提前終止及履行 租約將收到的預期利益。除已經同意與 業主終止合約的店舖外,解決此等合 約可能會和本集團的估計有所不同, 視乎與業主協商以及估計將可獲得的 經濟效益而定。當本集團在店舖結束 有了一份詳盡的正式計劃,並與受影 響的員工傳達該計劃後,本集團確認 員工賠償撥備。當店舖結束的計劃出 現必須的直接支出責任, 而並非是本 集團之持續業務所產生,本集團將確 認其他相關費用的撥備。

### (ii) 投資物業之公允值

投資物業以公允值列賬,以獨立專業 估值師為基礎。公允值之釐定包括若 干市場環境之假設。依據估值報告,本 公司董事行使其判斷及有信心該估值 方法反映在當時市場環境。

### b) Key sources of estimation uncertainty

Notes 17 and 33 contain information about the assumptions and their risk factors relating to valuation of investment property and fair value of share options granted. Other key sources of estimation uncertainty are as follows:

#### (i) Write-down of inventories

Inventories are written down to net realisable value based on an assessment of the realisability of inventories. Write downs on inventories are recorded where events or changes in circumstances indicate that the balances may not be realised. The identification of write downs requires the use of estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of inventories and write downs of inventories in the periods in which such estimate has been changed. As at 31st March 2014, the carrying amount of inventories is HK\$469,341,000 (2013: HK\$569,071,000).

### (ii) Impairment loss on trade and other receivables

The policy for impairment losses is based on an assessment of the recoverability of trade and other receivables. Impairments are applied to trade and other receivables where events or changes in circumstances indicate that the balances may be uncollectible. The identification of impairment loss requires the use of estimates. Where the expectation is different from original estimates, such difference will impact the carrying value of receivables and impairment loss expenses in the period in which such estimate has been changed. As at 31st March 2014, the carrying amount of trade and other receivables is HK\$29,933,000 (2013: HK\$32,485,000).

### b) 估計不明朗因素的主要來源

附註17及33包括有關投資物業估值及授予購股權的公允值,其有關之假設及其風險因素之資料。估計不明朗因素之其他主要來源如下:

### (i) 撇減存貨

存貨根據可變現性之評估撇減至可變現特值。一旦事件發生或情況改變顯示存貨結餘可能未能變現時將被設為存貨撇減。識別撇減需要作出估計。當預期與原定估計有差異時內則間內,影響存貨之賬面值及存貨之撇減。於二零一四年三月三十一日,存貨之賬面值為469,341,000港元(二零一三年:569,071,000港元)。

### (ii) 貿易及其他應收賬款減值虧損

減值虧損之政策乃基於對貿易及其他應收賬款以及於附屬公司之權益之評估之可收回性。一旦事件發生或情況改變顯示該餘額有可能不能收回時,則會就貿易及其他應收賬款作出減值。識別減值虧損需要作出估計。倘預期原定估計有差異時,則該差異將會於估計改變之期間內,分別影響應收賬款之賬面值及期間的減值虧損開支。於二零一四年三月三十一日,貿易及其他應收賬款之賬面金額為29,933,000港元(二零一三年:32,485,000港元)。

### (iii) Income tax and deferred taxation

The Group estimates its income tax provision in accordance with the prevailing tax rules and regulations, taking into account any special approvals obtained from relevant tax authorities and any preferential tax treatment to which it is entitled in each location or jurisdiction in which the Group operates. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax provisions in the period in which such determination is made.

The Group believes it has recorded adequate current tax provision based on the prevailing tax rules and regulations and its current best estimates and assumptions. In the event that future tax rules and regulations or related circumstances change, adjustments to current taxation may be necessary which would impact the Group's results or financial position. As at 31st March 2014, the carrying amount of current tax payable and deferred tax liabilities are HK\$3,548,000 (2013: HK\$3,137,000) and HK\$6,736,000 (2013: HK\$7,741,000) respectively.

### (iii) 所得税及遞延税項

本集團評估其所得稅撥備乃根據可適 用之稅務條例及規則,並考慮任何相關 稅務機構獲得之批准,以及本集團營運 之每一地點獲得授予之任何優先稅務 處理或裁判權。於日常業務運作中,有 許多交易及計算其最終之稅務審項決定事件 而評估將可能支付之額外稅務事確認為 和記錄之稅務金額不同,其差異在 該決定期間,將會對所得稅及遞延稅 撥備產生影響。

#### 41. FINANCIAL GUARANTEE CONTRACTS

As at 31st March 2014, the Company had given corporate guarantee to a bank in connection with banking facilities granted to the Group amounting to HK\$130,000,000 (2013: HK\$161,200,000). Facilities utilized by the Group as at 31st March 2014 were HK\$74,260,000 (2013: HK\$130,096,000). The directors of the Company considered that no recognition was required because the fair value of such guarantee was insignificant and that the directors of the Company did not consider it probable that a claim would be made against the Company under the guarantee.

#### 42. EVENTS AFTER THE REPORTING PERIOD

In April 2014, 冠亞名表城 (上海) 貿易有限公司, a wholly owned subsidiary, entered into a loan agreement (the "Agreement") with a bank in the PRC. Under the Agreement, the subsidiary was granted a loan of RMB16 million (equivalents to approximately HK\$20 million) for a period of six months. The bank loan is unsecured and has been used for purchase of inventories. 冠亞名表城 (上海) 貿易有限公司 repaid the outstanding bank loans of RMB20 million, RMB0.5 million and RMB0.5 million on 11th April 2014, 16th June 2014 and 17th June 2014 respectively.

於二零一四年四月,本公司全資擁有附屬公司 冠亞名表城(上海)貿易有限公司與中國內地銀 行簽訂貸款協議(「協議」)。根據該協議,該附 屬公司獲授予16,000,000元人民幣(相當於約 20,000,000港元)之六個月期貸款。銀行之貸款 為無抵押及用於購買存貨。冠亞名表城(上海)貿 易有限公司於二零一四年四月十一日、二零一四 年六月十六日及二零一四年六月十七日,已分別 償還20,000,000元人民幣、500,000元人民幣及 500,000元人民幣的未償還銀行貸款。
