**SOUND GLOBAL WON THE BID FOR THE SEWAGE TREATMENT BUNDLED CONSTRUCTION CONCESSION PROJECT IN XINGREN COUNTY, GUIZHOU PROVINCE**

Sound Global Ltd. (“Sound Global” or the “Company”) hereby announces that it has won the bid for a bundled sewage treatment construction concession project in Xingren County, Guizhou Province, the PRC in September 2014.

Located in Xingren County of Guizhou Province, the project, namely Xingren County Sewage Treatment Works Phase 3, Sewage Treatment Project in Xingren Industrial Park and two rural sewage treatment projects for Phase 1, respectively, will be invested and built by Sound Global. The BOT (Build, Operate and Transfer) model will be adopted for the investment, building, operation and transfer for these plants, while the BT (Build and Transfer) model will be used for the investment and building of the ancillary drainage network therein. The project has a daily sewage treatment capacity of 11,900 tonnes. The total investment in the treatment plants and the drainage network amounts to approximately RMB95 million for a concession period of 30 years. Upon completion, the project will not only significantly improve the ecology of Xingren County, but also greatly promote the friendly and harmonious development of the local economy and environment.

Mr. Wen Yibo, Chairman of Sound Global, commented that the bundled sewage treatment project in Xingren County of Guizhou is another typical example of comprehensive sewage treatment following the successful implementation of bundled sewage treatment projects in rural areas of Xishui County and Huangpin County of Guizhou. Leveraging its strengths in the technology, capital, operation management and integrated industry chain, and through centralized, modularized and clustered management, Sound Global is able to simplify its operational management to a large extent, save operating cost, and improve the stability, reliability and efficiency of the system, thereby formulating an economically viable solution for the environmental management in the towns and rural areas in the PRC, especially Guizhou Province. The commencement of the project will accelerate Sound Global’s pace in expanding its foothold in Guizhou and the entire Country.

None of the Directors or substantial shareholders of the Company has any direct or indirect interest (other than through their shareholdings in the Company) in the above-mentioned transaction.

The accounting treatment for this project will be the same as that of our previous BOT and BT projects. This transaction is not expected to have any material impact on the net earnings per share and the net tangible assets per share of the Company for the financial year ending 31 December 2014.
