In the case of joint holders of any share, any one of such joint holders may attend and vote at the Meeting either personally or by proxy in respect of such share but if more than one of such joint holders are present at the Meeting personally or by proxy, the vote(s) tendered by the senior holder, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s), and for this purpose, seniority will be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.

To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power or authority, must be deposited at the office of the Company's branch share registrar in Hong Kong, Tricor Secretaries Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 48 hours before the time appointed for the holding of the Meeting or the adjourned meeting (as the case may be).
- 8. The proxy need not be a member of the Company but must attend the Meeting in person to represent you.
- 9. Completion and deposit of this form of proxy will not preclude you from attending and voting at the Meeting or any adjourned meeting if you so wish, but this form of proxy will in which case be deemed to be revoked.
