Notes: 1 The acquisitions of 100% equity interest in Shenhua Baotou Coal Chemical Co., Ltd. and 100% equity interest in Shenhua Guohua Jiujiang Power Co., Ltd. held by Shenhua Group Co. and its subsidiary which were approved by the board of directors of China Shenhua Energy Company Limited (the “Company”) on 23 December 2013 have been completed. The aforesaid businesses, where already in operation, have been included in the Company’s operational data of 2014, and the operational data of 2013 have been restated accordingly.

2. The calculation of “seaborne coal” has ceased to include the seaborne coal for sale in domestic coal trading since January 2013. “Domestic coal trading” refers to the purchase and sale of coal nationwide, except for the self-produced coal of the Company in the PRC and the coal purchased from third parties in the surrounding areas of the self-owned mines and railways of the Company but shipped with the Company’s transportation capability.

The major operational data above were calculated based on the internal statistics of the Company. As a result, operational data may show major differences between months. The factors giving rise to such differences include, without limitation to, bad weather, equipment overhaul, seasonal factors, and safety checkup and so on. The major operational data may somewhat differ from the data disclosed in the relative periodic reports. Investors are hereby reminded of the risks which may result from inappropriate reliance upon or utilization of the information given above. In case of any differences between Chinese version and English version, the Chinese version shall prevail.
