- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;

- 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;

- 向本公司或香港證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機關或政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人 」或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

#### 4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料 所需的用途保留證券申請人及持有人的個人資 料。無需保留的個人資料將會根據條例銷毀或 處理。

#### 5. 查閱和更正個人資料
