**SOUND GLOBAL WON THE BID FOR INDUSTRIAL SEWAGE TREATMENT PLANT PROJECT
IN JINJIANG ECONOMIC DEVELOPMENT ZONE, FUJIAN**

Sound Global Ltd. (“Sound Global” or the “Company”) wishes to announce that Sound Global officially won the bid for the build, operate and transfer (“BOT”) project of the industrial sewage treatment plant in Jinjiang Economic Development Zone, Fujian (“Fujian Jinjiang Project”) in March 2015.

The Fujian Jinjiang Project is invested, constructed, operated and transferred by Sound Global. The total sewage treatment capacity of the project is 35,000 tonnes per day, of which 55% will be recycled as reclaimed water. The quality of sewage discharged is designed to Class IA standard as set out in the national standard for the Discharge Standards on Pollutants from Urban Sewage Treatment Plants (“城鎮污水處理廠污染物排放標準”) (GB18918-2002). The total investment of the project is approximately RMB183 million with a concession term of 25 years. The project, upon completion and commencement of operation, will represent a key demonstration driver of overall sewage environmental governance along Jinjiang and in Fujian Province or even the coastal provinces.

The Fujian Jinjiang Project, being another sewage treatment project of Sound Global in Fujian Province, will be a starting point and represent a benchmark in Fujian Province or even the coastal provinces, which will greatly improve the reduction of COD emission within the region and strongly promote the friendly and harmonious development of the sewage environment in the coastal region.

The award of the Fujian Jinjiang Project fully demonstrates Sound Global’s technological strengths in industrial wastewater treatment and sewage treatment in the economic development zone and capital funding, as well as the overall capabilities in full industry chain from project implementation, equipment procurement to operation. Capitalising on its own advantages in technology, management and full industry chain, Sound Global has greatly simplified the operational management procedures, reduced operating costs and enhanced the stability, reliability and effectiveness of the system utilising the coagulation sedimentation + SDN + MBR + RO processes through intensification, modular and centralised management, thus creating an economically viable solution for economic development zone environmental governance in the coastal region.

None of the Directors or substantial shareholders of the Company has any direct or indirect interests in the above transaction (other than those owned through their equity interests in the Company).

The above-mentioned transaction is not expected to have a material impact on the net earnings per share and the net tangible assets per share of the Company for the financial year ending 31 December 2015.
