VOLUNTARY ANNOUNCEMENT STRATEGIC COOPERATION AGREEMENT

The board of directors (the “Board”) of Launch Tech Company Limited (the “Company”) wishes to notify Shareholders that strategic cooperation framework agreement was entered into between the Company and China Innovationpay Group Limited (“Innovationpay”) today, pursuant to which, both parties will cooperate and issue golo membership card with pay functions, and strive to satisfy the application O2O in car and car peripheral market, and to develop together the relevant consumption market in car life and its subsequent service areas.

Both parties will consolidate each of their technologies, channels and operation resources in their respective industries, issue and operate golo membership card with pay function together, and to provide payment services which cover a variety of payment methods and provide more diversify membership services to golo members of the Company. Both parties expected that the payment services can bring more golo users for the Company, and at the same time, golo users will bring the payment business of Innovationpay to the field of Internet of Car. Management believes that the cooperation is beneficial to both parties.

Innovationpay

Innovationpay is a company listed on the Growth Enterprise Market (“GEM”) of The Stock Exchange of Hong Kong Limited (Stock Code: 8083), one of the main businesses of Innovationpay is the prepaid card business, i.e. provision of third party payment services and consultancy services; and marketing and sale of consumer goods in form of prepaid gift cards in the People's Republic of China (“the PRC”).

The diagnostic technique of Launch

Since its foundation, the Group has been devoting to the research, development and production of automotive diagnostic device and accumulated related techniques for over 20 years, supporting and working closely with maintenance technicians, and golo products are the flagship products of the Group in Internet of Car.
