ANNOUNCEMENT REGARDING ADJUSTMENTS TO ELECTRICITY TARIFFS

This announcement is made pursuant to Rule 13.09(2) and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Recently, the National Development and Reform Commission issued the Notice on Reduction in Ongrid Tariffs for Coal-fired Power Generation and Electricity Tariffs for Industrial and Commercial Use issued by (Fa Gai Jia Ge [2015] No. 748) (the "Notice"). In line with the spirit related to the reform of the electricity system and the relevant provisions of the linkage mechanism for coal prices and electricity tariffs, it was decided to reduce the on-grid tariffs for coal-fired power generation from 20 April 2015.

The major impacts of the Notice on China Shenhua Energy Company Limited (the "Company") are as follows:

(I) REDUCTION IN ON-GRID TARIFFS FOR COAL-FIRED POWER GENERATION

In accordance with the Notice, the regions in which the coal-fired generators of the Company are located and the adjustments are shown in the table below:

On the basis of 212.70 billion kWh, the 2015 business target of the Company for power output dispatch, and according to preliminary estimates, the adjustments to electricity tariffs will result in a reduction of approximately RMB2,650 million (unaudited) in the profit before income tax of the Company in 2015.

The on-grid electricity tariff in this announcement refers to the tariff specified in the electricity sale and purchase contract entered into between the power generation company and the grid company, which corresponds to the electricity volume.
