The request form may also be downloaded from the Bank’s website at www.hangseng.com or from www.hkexnews.hk.

If you would like to change your choice of means of receipt or language of the Bank’s Corporate Communications in the future, please give the Bank c/o the Bank’s Registrar reasonable notice in writing or send email to hangseng@computershare.com.hk. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications via the Bank’s website but for any reason you have difficulty in receiving or gaining access to the Current Corporate Communications via the Bank’s website, the Bank will promptly, upon your request, send the Current Corporate Communications to you in printed form free of charge.
