VOLUNTARY ANNOUNCEMENT YUNCHENG CITY WATER PROJECT

This is a voluntary announcement made by the Company.

The Company is pleased to announce that on 29 July 2015 the Company entered into the Cooperation Agreement with the Yuncheng Management Committee and Xiaxian Company relating to the water supply project in the Airport Area of Yuncheng City, Shanxi Province, PRC.

Pursuant to the Cooperation Agreement, the Project will involve the reorganization of the JV Company to the effect that its registered capital will be increased to RMB100,000,000, of which the Company's subsidiaries will contribute approximately RMB64.5 million and hold approximately 64.5% thereof, Xiaxian Company will contribute RMB30 million and hold 30% thereof and Yunchang Management Committee's designated entity will contribute approximately RMB5.5 million and hold approximately 5.5% thereof. The Company's subsidiaries will make the contribution in cash. Xiaxian Company will make the contribution by injecting water assets including the waterworks and water pipe network at Xiaxian, Shanxi Province. Yuncheng Management Committee's designated entity will make the contribution by injecting assets including water pipe network and equipment.

The Group is currently a water supply operator in Yuncheng City, which has a designed daily water supply capacity of 60,000 tonnes.

Xiaxian Company is the investor in the Xiaxian Wen Yu Water Induction Project which has been confirmed by the Government of the Shanxi Province to be a key project for new water resources. The Project will increase the Group's water resources in Yuncheng City, improve the quality of general water resources and expand the water pipe network and the waterworks water supply capacity through connecting the water pipes lending to the waterworks, thus creating synergy in operation. The waterworks of the JV Company has a designed daily water supply capacity of 55,000 tonnes. The Yuncheng Management Committee will grant a concession to the JV Company regarding the Project for 30 years.
