If the Company does not receive from you the properly completed and signed Reply Slip before Wednesday, 30 December 2015, you will be deemed to have agreed to receive the Company’s Corporate Communications by Website Version and a printed-form notification regarding the publication of each Corporate Communication on the Company’s website will be sent to you in the future.
