# 概述

本集團截至二零一五年十二月三十一日止年度錄得虧損,主要 來自股票之投資。

#### 財務關鍵表現指標

截至二零一五年十二月三十一日止年度本集團錄得本公司擁 有人應佔淨虧損金額為104,000,000港元(二零一四年:溢利 87,100,000港元),包括來自股票相關投資虧損96,000,000港元 (二零一四年:溢利105,600,000港元),部份可被債券投資貢 獻溢利18,000,000港元(二零一四年:27,700,000港元)抵銷。

於二零一五年十二月三十一日,本公司擁有人應佔本集團之 資產淨值減少10.7%至1,228,900,000港元。作為比較,於二 零一五年,恒生指數及恒生中國企業指數分別下跌7.2%及 19.4%。此為自二零零八年以來本集團第二次表現遜於恒生指 數。

### 投資回顧

於二零一五年十二月三十一日,本集團之主要投資項目如下:

#### **Overview**

The Group recorded a loss for the year ended 31st December, 2015 primarily arising from its investments in equities.

#### **Financial Key Performance Indicators**

The Group recorded a net loss attributable to the owners of the Company in the amount of HK\$104.0 million (2014: profit HK\$87.1 million) for the year ended 31st December, 2015, comprising losses of HK\$96.0 million from equity related investments (2014: profit of HK\$105.6 million) offset partly by profit contribution of HK\$18.0 million from bond investments (2014: HK\$27.7 million).

As at 31st December, 2015, the Group's net assets attributable to the owners of the Company decreased by 10.7% to HK\$1,228.9 million. In comparison, the Hang Seng Index and the Hang Seng China Enterprises Index dropped by 7.2% and 19.4% respectively during 2015. This is the second time since 2008 the Group underperforms the Hang Seng Index.

# 投資回顧(續)

本集團之投資組合包括於香港、台灣、馬來西亞、美國、日本、新加坡及中華人民共和國(「中國」)之證券。投資組合價值 於二零一五年有所減少。

我們於台灣投資之上市公司乃從事乾散貨航運及中國百貨公司 業務。前者由於行業持續放緩再經歷了艱苦的一年,後者則 受到網上購物的影響而失去市場份額。再者由於股票市場調 整令其錄得重大投資損失。本集團於台灣投資之市值下跌及 33,700,000港元減值撥備已於二零一五年確認。

年內,投資組合中盈利最豐厚的五大證券為國泰君安國際控股 有限公司(提供買賣及經紀、貸款及融資服務)、中國太平保險 控股有限公司(一家中國保險公司)、北控水務集團有限公司(污 水及自來水處理廠建築商、污水處理、自來水處理及供水商)、 國農控股有限公司(中國軟件開發商及提供融資租賃服務)及三 和建築集團有限公司(提供地基工程及附屬服務業務)。

年內,投資組合中五大虧損為中國平安保險(集團)股份有限公司(一家中國保險公司)、博雅互動國際有限公司(網絡棋牌類遊戲開發及營運商)、益航股份有限公司(中國百貨公司營運商及提供乾散貨航運服務)、馬鞍山鋼鐵股份有限公司(中國鋼鐵生產商)及中國廣核電力股份有限公司(核電站營運商)。

# 股息

本公司董事會提議保留現金用於投資,不建議派發截至二零 一五年十二月三十一日止年度任何股息(二零一四年:每股1港 仙)。

#### Investment Review (continued)

The Group's portfolio of investments comprises securities in Hong Kong, Taiwan, Malaysia, United States, Japan, Singapore and the People's Republic of China (the "PRC"). The value of our portfolio decreased in 2015.

The listed company we invest in Taiwan is engaged in the businesses of dry bulk shipping and department store in the PRC. The former experienced another difficult year due to the continuous slowdown in sector, and the latter suffered from loss of market share to online shopping. It also recorded significant investment losses due to corrections in the stock markets. The market value of the Group's investment in Taiwan declined and an impairment of HK\$33.7 million was recognised in 2015.

The five most profitable securities in our portfolio during the year are Guotai Junan International Holdings Limited (provision in dealing and broking, loans and financing), China Taiping Insurance Holdings Company Limited (an insurance company in the PRC), Beijing Enterprises Water Group Limited (sewage and water treatment plants contractor, sewage treatment, water treatment and distributor), National Agricultural Holdings Limited (software developer and provision of financial leasing business in the PRC) and Sam Woo Construction Group Limited (provision of foundation works and ancillary services).

The five biggest losses in our portfolio during the year are Ping An Insurance (Group) Company of China, Ltd. (an insurance company in the PRC), Boyaa Interactive International Limited (developer and operator of online card and board game), First Steamship Co., Ltd. (department stores operator in the PRC and provision of dry bulk carrier shipping), Maanshan Iron & Steel Company Limited (iron and steel manufacturer in the PRC) and CGN Power Co., Ltd. (nuclear power stations operator).

### Dividend

The board of Directors of the Company proposes to preserve cash for investment activities and does not recommend any dividend for the year ended 31st December, 2015 (2014: HK1 cent per share).

## 暫停辦理股份過戶登記

本公司應屆股東週年大會(「股東週年大會」)定於二零一六年五 月二十四日(星期二)舉行。本公司將於二零一六年五月二十三 日(星期一)及二零一六年五月二十四日(星期二)暫停辦理本公 司股份過戶登記,在此期間本公司股份之轉讓手續將不予辦 理。股東為符合資格出席股東週年大會並於會上投票,須於二 零一六年五月二十日(星期五)下午四時三十分前將所有過戶文 件連同有關股票送交本公司之股份過戶登記處卓佳秘書商務有 限公司(地址為香港皇后大道東183號合和中心22樓)辦理股份 過戶登記手續。

## 前景、投資基礎與策略

我們以研究為依據、以公司為基礎,但不會刻意專注於特定產 業或行業。一直以來,我們的方法是甄別估值偏低但可於中長 期內上漲之股份。本公司規模相對適中,可使我們利用優勢, 投資於交投較少的小型公司。債券組合旨在為應對本公司之股 票投資波動提供緩衝,但不時亦會成為重大的溢利貢獻因素。

於二零一五年,港股經歷近年來升跌最戲劇化的一年。恒生 指數跟隨中國A股市場令人振奮的表現,於第二季度強勢回升 後,卻在下半年嚴重受挫,將上半年取得的收益全部回吐,更 有甚者。恒生指數於二零一五年下跌達7.2%。

受到中國政府出手干預保證金融資飆升觸發市場出現預期之外 的逆轉,導致二零一五年七月A股市場暴跌。其後於二零一五 年八月中國人民銀行啟動人民幣突然貶值,更令情況加劇,對 投資者信心造成不利影響。

現時,我們對包括股票等風險資產抱持審慎態度。截至撰文時,恒生指數及恒生中國企業指數於今年分別下跌6.4%及 9.2%。儘管人民幣自二零一五年八月貶值後已相較穩定,惟美 國聯邦儲備局於二零一五年十二月決定加息,進一步影響人民 幣的前景。預期人民幣將會進一步貶值,此舉近期已引致資金 大量流出中國,外匯儲備下降程度已出現警號。我們的首要工 作將是保本,保持大量現金及小心進行風險資產投資,直到人 民幣匯率預期貶值的陰霾減退(透過強勢美元撥轉或人民幣一次 過貶值)。

#### **Closure of Register of Members**

The forthcoming annual general meeting of the Company is scheduled to be held on Tuesday, 24th May, 2016 (the "AGM"). The register of members of the Company will be closed on Monday, 23rd May, 2016 and Tuesday, 24th May, 2016, during which period no transfer of shares of the Company will be registered. To be eligible to attend and vote at the AGM, all transfer forms accompanied by the relevant share certificates must be lodged with the Company's share registrar, Tricor Secretaries Limited of Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong for registration not later than 4:30 p.m. on Friday, 20th May, 2016.

#### **Prospects, Investment Basis and Strategy**

We are research based, company focused and without sector preference. Our approach has been to identify securities that are undervalued, and offer prospects of improvement over the medium to long term. The relatively modest size of our company allows us to take advantage of investing in smaller companies with relatively lower turnover. The bond portfolio is designed to offer a buffer to counter the volatility of our equities investment, but had from time to time proved to be an important profit contributor.

In 2015, Hong Kong stock market experienced one of the most dramatic trajectories in recent years. After the strong rally in second quarter following China A-share market stellar performance, Hang Seng Index suffered a severe setback in second half, more than erasing all of the gain made in first half. Hang Seng Index was down 7.2% in 2015.

The rather unexpected reversal was triggered by the Chinese government's abrupt attempt to stall the rampant growth in margin financing, leading to the collapse of the A-share market in July 2015. This was aggravated by the sudden devaluation of Renminbi in August 2015 initiated by the People's Bank of China, adversely affecting investors' confidence.

At present, we are cautious about risk assets including equities. Hang Seng Index and Hang Seng China Enterprises Index have been down by 6.4% and 9.2% respectively this year up to the time of writing. While Renminbi has been relatively stable since the devaluation in August 2015, decision of the Federal Reserve of United States to raise interest rate in December 2015 further worsened the Renminbi outlook. Expectation of further depreciation of Renminbi remains, and has triggered strong capital outflow from China recently, depleting foreign exchange reserve at an alarming pace. Until expectation of Renminbi depreciation fades (either by reversal of strong US dollar or one-off devaluation of Renminbi), our priority would be capital preservation by holding a high level of cash, and to tread carefully in risk assets.

#### 財務資源、流動資金及資本與負債比率

於二零一五年十二月三十一日,本集團持有現金及現金等價物約313,900,000港元(二零一四年:約244,600,000港元)及交易保證金約6,300,000港元(二零一四年:約500,000港元),合共約320,200,000港元(二零一四年:約245,100,000港元),投資約889,700,000港元(二零一四年:約1,139,300,000港元)及於二零一五年及二零一四年十二月三十一日並無銀行貸款。本集團之流動性資金狀況使我們可以對更多預期可為股東帶來更佳回報之投資機會作出反應。本集團之資本與負債比率(乃根據於二零一五年十二月三十一日之貸款總額與本公司擁有人應佔權益總額之比率計算)為0%(二零一四年:0%)。

#### 外匯風險

於二零一五年十二月三十一日,本集團的大部份投資均以港元 或美元計值。外幣匯率風險來自本集團之海外投資及現金結 存,包括新台幣、人民幣、馬來西亞林吉特、泰銖、新加坡元 及日圓。本集團目前無任何合同對沖其外匯風險。如本集團認 為其外匯風險波動情況適宜進行對沖,本集團可能使用遠期或 對沖合同來降低風險。

## 擔保

本 公 司 就 其 全 資 附 屬 公 司 所 獲 財 務 機 構 提 供 不 超 逾 140,000,000港元(二零一四年:140,000,000港元)的銀行融資 額提供擔保。

#### 員工成本

本集團於截至二零一五年十二月三十一日止年度之員工成本 (包括董事酬金)總額合共約2,800,000港元(二零一四年:約 3,400,000港元)。

#### 資產抵押

於二零一五年十二月三十一日,本集團之僱員總人數(包括董 事)為6名(於二零一四年十二月三十一日:7名)。本集團之酬 金政策在於確保所有僱員(包括董事)為本集團貢獻之能力及時 間均獲得充份之酬勞,而所提供之酬金乃與其職責相符及與市 場水平相若。概無董事或其任何聯繫人士或行政人員參與決定 其本身酬金。

#### **Financial Resources, Liquidity and Gearing Ratio**

As at 31st December, 2015, the Group had cash and cash equivalents of approximately HK\$313.9 million (2014: approximately HK\$244.6 million) and security deposits of approximately HK\$6.3 million (2014: approximately HK\$0.5 million), totalling approximately HK\$320.2 million (2014: approximately HK\$245.1 million), investments of approximately HK\$889.7 million (2014: approximately HK\$1,139.3 million) and no bank borrowings as at 31st December, 2015 and 2014. The liquidity position of the Group enables us to respond to further investment opportunities that are expected to generate better returns for the Shareholders. The Group's gearing ratio, calculated by reference to the ratio of total borrowings to total equity attributable to the owners of the Company as at 31st December, 2015, was 0% (2014: 0%).

#### Foreign Exchange Exposure

As at 31st December, 2015, the majority of the Group's investments were either denominated in Hong Kong dollars or United States dollars. Exposure to foreign currency exchange rates arises out of the Group's overseas investments and cash balances, including New Taiwan dollars, Renminbi, Malaysian ringgit, Thai baht, Singapore dollars and Japanese yen. The Group at present does not have any contracts to hedge against its foreign exchange risks. Should the Group consider that its exposure to foreign currency risk justifies hedging, the Group may use forward or hedging contracts to reduce the risks.

#### Guarantee

The Company has given guarantees to financial institutions to secure banking facilities available to its wholly-owned subsidiaries in the amount not exceeding HK\$140.0 million (2014: HK\$140.0 million).

### **Staff Costs**

The Group's total staff costs (including Directors' emoluments) for the year ended 31st December, 2015 amounted to approximately HK\$2.8 million (2014: approximately HK\$3.4 million).

#### Pledge of Assets

Details regarding the pledge of assets are set out in Note 21 to the financial statements on page 100.

#### **Employees**

The total number of staff of the Group, including Directors, at 31st December, 2015 was 6 (at 31st December, 2014: 7). The remuneration policy of the Group is to ensure that all employees, including Directors, are sufficiently compensated for their efforts and time dedicated to the Group and remuneration offered is appropriate for their duties and in line with market practice. No Director, or any of his associates, or executive is involved in deciding his own remuneration.

#### 主要業務

本集團於年內之主要業務包括投資於上市及非上市之金融工具。

#### 業務回顧

本年報第3至6頁主席報告所列有關本集團業務、投資及財務活動的回顧,包括按照香港公司條例附表5規定運用財務表現關鍵指標對業務作出的公平審閱及本集團日後可能出現的業務發展。主席報告亦構成本董事會報告的一部分。

#### 本公司面對的主要風險及不確定性

#### 市場風險

本集團面對因所持投資的價格不利變動導致盈利或資本縮減的 風險。

為妥善管理市場風險,本集團多年前已制定投資政策及程序。 執行委員會(「執行委員會」)獲給予董事會的所有權力,負責制 定及修訂本集團的投資策略及政策。此外,投資經理負責就投 資事宜向執行委員會作出建議、就投資意念進行研究及落實執 行委員會批准的投資決定。投資政策及程序亦詳列投資過程及 各項限制。投資經理每日須向執行委員會提交報告,闡述市場 價格變動對投資的影響。

根據此項完善的管治架構,本集團可適時找到有關風險,並可 評估、監控及向上下人員匯報有關風險。

#### 流動資金風險

本集團面對即使清盤其並無充足財務資源,於責任到期時履行 其責任,或在付出大量成本後方能獲得該等資源的風險。

本集團旨在於任何時間維持正數的流動資產淨值。就此,呈列 自由現金結餘的報告每日會提交執行委員會,以供參考。另外 亦會與若干主要來往銀行維持融資額度,以確保需要時有充足 資金可用。 The board of Directors of the Company (the "Board") submit their report together with the audited financial statements of the Company and its subsidiaries (together referred to as the "Group") for the year ended 31st December, 2015.

#### **Principal Activities**

The principal activities of the Group during the year include the investments in listed and unlisted financial instruments.

#### **Business Review**

A review of the Group's business, investment and financial activities, including a fair review of the business using financial key performance indicators and an indication of likely future development in the Group's business, as required by Schedule 5 to the Hong Kong Companies Ordinance, is shown in the Chairman's Statement on pages 3 to 6 of this Annual Report. The Chairman's Statement also forms part of this report of the directors.

## Principal Risks and Uncertainties Facing the Company Market Risks

The Group faces the risk of a reduction in earnings or capital caused by the adverse price movements of its investments held.

To properly manage the market risks, the Group had established investment policies and procedures a few years ago. The Executive Committee ("Exco") has been given the full power of the Board and is responsible for setting and modifying investment strategies and policies of the Group. On the other hand, the investment manager is responsible for advising the Exco on investments, carrying out research on investment ideas and execution of investment decisions approved by the Exco. The investment policies and procedures also detail the investment processes and restrictions. Report showing the effects on the investments due to changes in market prices is submitted to the Exco daily by the investment manager.

Under this well-established governance structure, the relevant risks can be identified, assessed, controlled and reported throughout the Group on a timely basis.

#### Liquidity Risks

The Group faces the risks that it, although solvent, either does not have sufficient financial resources to meet its obligations as they fall due, or can secure such resources only at excessive cost.

The Group aims at maintaining positive net current assets at all times. In this regard, report showing free cash balances is sent to the Exco daily for reference. Facility lines are also maintained with certain principal bankers so as to ensure sufficient funds are available once needed.

本公司面對的主要風險及不確定性(續)

#### 經營風險

本集團面對人為因素、內部流程及系統不足或故障或外來事件 造成的直接或間接影響所導致的風險。

由於本集團的管理層已向投資經理作出授權,故管理經營風險 的主要責任由產生風險的相關部門的投資經理負責。投資經理 的各有關部門主管須識別風險、評估主要監控措施的成效、評 價是否已有效處理有關風險,並按特別匯報基準通知董事會。

#### 環保政策

本集團致力成為一家重視環保的機構,不斷減低其業務營運對 環境造成的影響。

目前,本集團實施以下節約用紙措施:

- 1. 鼓勵僱員雙面列印內部文件;
- 2. 備有設施及程序回收廢紙;
- 本集團一直致力建立無紙辦公室,在可行情況均以電子 方式儲存資料及進行通訊。

我們亦採取各種措施,節約用電以及鼓勵回收辦公室用品及其 他物料,務求盡量減少對環境造成的影響。

#### 遵守法例及法規

本集團的主要業務為投資於香港及其他地區的上市及非上市金融工具。本公司的投資須遵守其組織章程細則所述的限制。此外,本公司為香港的上市公司。本集團亦須遵守香港聯合交易所有限公司(「香港聯交所」)證券上市規則(「上市規則」)的規定。截至二零一五年十二月三十一日止年度及截至本報告日期,據董事所深知及確信,本集團就其投資事務已遵守香港及其他司法權區的相關法例及法規。

#### **Operational Risks**

The Group faces the risk of direct or indirect impacts resulting from human factors, inadequate or failed internal processes and systems or external events.

Since the management of the Group has been delegated to the investment manager, the prime responsibility for the management of operational risk rests with the relevant departmental units of the investment manager where the risk arises. Each relevant department head of the investment manager has to identify risks, evaluate the effectiveness of key controls in place, assess whether the risks are effectively managed and notify the Board on an exceptional reporting basis.

#### **Environmental Policies**

The Group is committed to building an eco-friendly corporation that tries to reduce the impacts of its operation on the environment.

Currently, the Group implements the following paper-saving measures:

- Employees are encouraged to use duplex printing for internal documents;
- 2. Facilities and procedures are in place for paper waste recycling; and
- 3. The Group had strived for long to establish a paperless office by using electronic storage and communication whenever possible.

We also took different measures to minimize environmental impact by saving electricity and encouraging recycle of office supplies and other materials.

#### Compliance with Laws and Regulations

The Group's principal activities are investments in listed or unlisted financial instruments in Hong Kong and elsewhere. The Company has to invest in accordance with the restrictions stated in its articles of association. Meanwhile, the Company is a company listed in Hong Kong. The Group also has to comply with the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange of Hong Kong"). During the year ended 31st December, 2015 and up to the date of this report and to the best of the Directors' knowledge and belief, the Group has complied with the relevant laws and regulations in Hong Kong and other jurisdictions as far as its investments are concerned.

Although the above-mentioned Directors have competing interests in other companies by virtue of their respective common directorship, they will fulfill their fiduciary duties in order to ensure that they will act in the best interest of the shareholders of the Company (the "Shareholders") and the Company as a whole at all times. Hence, the Group is capable of carrying on its businesses independently of, and at arm's length from, the businesses of such companies.

YMIM is entitled to a management fee equal to 1.5% per annum of the consolidated net asset value of the Group attributable to the owners of the Company, calculated and payable in arrears on a quarterly basis by reference to the arithmetical average of the published consolidated net asset value of the Group attributable to the owners of the Company on the last day of each calendar month during each guarter; and a performance fee equal to 20% of the amount by which the audited consolidated net asset value of the Group attributable to the owners of the Company of each year ending 31st December, exceeds the audited consolidated net asset value of the Group attributable to the owners of the Company as at the end of the latest financial year in which YMIM was entitled to a performance fee.

A new investment management agreement (the "New Investment Management Agreement") for three years effective from 1st January, 2016, with similar terms set out in the Investment Management Agreement but new annual caps, was approved by the independent Shareholders on 29th December, 2015. Details of the New Investment Management Agreement are set out in the related circular of the Company dated 11th December, 2015.

The chairman of the AGM had explained the procedures for conducting a poll during the meeting. All resolutions proposed at the AGM were voted separately by way of poll. All the votes cast at the said meeting were properly counted and recorded.

An EGM was held in December 2015 for approval of continuing connected transaction. Independent Non-Executive Director was available to answer questions at the EGM. #### **Procedures for Members Putting Forward Proposals**

Members may put forward proposals for consideration at a general meeting. Pursuant to Section 615 of the Hong Kong Companies Ordinance, the members of the Company may request the Company to give, to members of the Company entitled to receive notice of the AGM, notice of a resolution that may properly be moved and is intended to be moved at that meeting. The request may be sent to the Company in hard copy form or in electronic form and must identify the resolution of which notice is to be given, be authenticated by the person or persons making it and be received by the Company not later than 6 weeks before the AGM to which the requests relates; or if later, the time at which notice is given of that meeting.

The Company will give notice of a resolution if it has received the requests from (a) members representing at least 2.5% of the total voting rights of all the members who have a right to vote on the resolution to which the request relate; or (b) at least 50 members who have a relevant right to vote on the resolution to which the request relate.

The address of the principal place of business of the trustees of Lee and Lee Trust is 24th Floor, Allied Kajima Building, 138 Gloucester Road, Wanchai, Hong Kong.

The principal activities of the Company and its subsidiaries (together referred to as the "Group") during the year include the investments in listed and unlisted financial instruments.

#### HKFRS 9 – Financial Instruments

HKFRS 9 introduces new requirements for the classification and measurement of financial assets. Debt instruments that are held within a business model whose objective is to hold assets in order to collect contractual cash flows (the business model test) and that have contractual terms that give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding (the contractual cash flow characteristics test) are generally measured at amortised cost. Debt instruments that meet the contractual cash flow characteristics test are measured at fair value through other comprehensive income ("FVTOCI") if the objective of the entity's business model is both to hold and collect the contractual cash flows and to sell the financial assets. Entities may make an irrevocable election at initial recognition to measure equity instruments that are not held for trading at FVTOCI. All other debt and equity instruments are measured at fair value through profit or loss ("FVTPL").

HKFRS 9 includes a new expected loss impairment model for all financial assets not measured at FVTPL replacing the incurred loss model in HKAS 39 and new general hedge accounting requirements to allow entities to better reflect their risk management activities in financial statements.

HKFRS 9 carries forward the recognition, classification and measurement requirements for financial liabilities from HKAS 39, except for financial liabilities designated at FVTPL, where the amount of change in fair value attributable to change in credit risk of the liability is recognised in other comprehensive income unless that would create or enlarge an accounting mismatch. In addition, HKFRS 9 retains the requirements in HKAS 39 for derecognition of financial assets and financial liabilities.

The amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively.

#### Amendments to HKAS 1 – Disclosure Initiative

The amendments to HKAS 1 are designed to further encourage companies to apply professional judgement in determining what information to disclose in their financial statements. For example, the amendments make clear that materiality applies to the whole of financial statements and that the inclusion of immaterial information can inhibit the usefulness of financial disclosures. Furthermore, the amendments clarify that companies should use professional judgement in determining where and in what order information is presented in the financial disclosures.

### 3. Summary of Significant Accounting Policies

#### 3.1 Basis of preparation

### 3.1 Basis of preparation (continued)

The significant accounting policies that have been used in the preparation of these financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of the revised HKFRSs and the impact on the Group's financial statements, if any, are disclosed in Note 2.

The financial statements have been prepared on the historical cost basis except for:

- financial instruments classified as availablefor-sale and at fair value through profit or loss, and
- derivative financial instruments

It should be noted that accounting estimates and assumptions are used in preparation of the financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. 綜合財務報表載有本集團截至每年十二月 三十一日止之財務報表。

附屬公司自其控制權被轉讓予本集團之日起納 入綜合財務報表,並自控制權終止之日起不再 納入本集團綜合財務報表。於年內購入或售出 之附屬公司,其業績由收購生效日起計或計至 出售生效日止(如適用)列入綜合收益表內。

所有集團內公司間進行交易時之公司間交易、 結餘及未變現收益已於編製綜合財務報表時抵 銷。當集團內公司間資產銷售產生之未變現虧 損於綜合入賬時回撥,本集團亦會對有關資產 作減值測試。附屬公司財務報表所報金額作出 調整(倘需要),以確保與本集團採納之會計政 策相符一致。

#### 3.2 Basis of consolidation and business combination

The consolidated financial statements incorporate the financial statements of the Group made up to 31st December, each year.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are excluded from consolidation from the date that control ceases. The results of the subsidiaries acquired or disposed of during the year are included in the consolidated income statement from the effective date of acquisition or up to the effective date of the disposal, as appropriate.

All intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on intra-group asset sales are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

Acquisition of subsidiaries or businesses is accounted for using the acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interests that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other noncontrolling interests are measured at fair value, unless another measurement basis is required by HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Any contingent consideration to be transferred by the acquirer is recognised at acquisition-date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any noncontrolling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus such non-controlling interests' share of subsequent changes in equity. Total comprehensive income is attributed to such non-controlling interests even if this results in those non-controlling interests having a deficit balance.

#### 3.3 附屬公司

附屬公司為本集團可行使控制權的被投資方。 如以下三個因素全部滿足時,本集團控制被投 資方:對被投資方的權力,來自被投資方可變 回報的風險或權利及利用其權力影響該等可變 回報的能力。當有事實或情況顥示任何該等控 制因素可能出現變動時,控制權會被重新評估。

### 3.3 Subsidiaries

Subsidiaries are investees over which the Group is able to exercise control. The Group controls investees if all three of the following elements are present: power over the investees, exposure, or rights, to variable returns from the investees and the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are carried at cost less any impairment loss (Note 3.9) unless the subsidiary is held for sale or included in a disposal group. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or postacquisition profits are recognised in the Company's profit or loss.

#### 3.4 Associates

Associates are those entities over which the Group is able to exert significant influence, generally accompanying a shareholding of between 20% and 50% of voting rights but which are neither subsidiaries nor joint arrangements. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

在綜合財務報表中,於聯營公司的投資初步按 成本確認,其後採用權益法入賬。任何收購成 本超逾本集團於收購日期確認聯營公司之已識 別資產、負債及或然負債中分佔之公平值淨 額,均確認為商譽。商譽包括投資之賬面款 額,並就評估耗蝕,作為投資之一部分。收購 成本乃按本集團於交換日期給予之資產、產 或承擔之負債及發行之權益工具之公平值總額 計量,另加投資應佔之任何直接應佔成本。於 重估後,任何本集團分佔之已識別資產、負債 及或然負債之公平淨額超逾收購成本,均即時 確認損益,用作決定本集團於收購投資時分佔 聯營公司於期內之損益。

In consolidated financial statements, investments in associates are initially recognised at cost and subsequently accounted for using the equity method. Any excess of the cost of acquisition over the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities of the associates recognised at the date of acquisition is recognised as goodwill. The goodwill is included within the carrying amount of the investments and is assessed for impairment as part of the investments. The cost of acquisition is measured at the aggregate of the fair values, at the date of exchange, of assets given, liabilities incurred or assumed and equity instruments issued by the Group, plus any costs directly attributable to the investments. Any excess of the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities over the cost of acquisition, after reassessment, is recognised immediately in profit or loss in the determination of the Group's share of the associates' profit or loss in the period in which the investments are acquired.

Under the equity method, the Group's interests in the associates are carried at cost and adjusted for the post-acquisition changes in the Group's share of the associates' net assets less any identified impairment loss, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). The profit or loss for the period includes the Group's share of the post-acquisition, post-tax results of the associates for the year, including any impairment loss on the investments in associates recognised for the year.

Unrealised gains on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Where unrealised losses on assets sales between the Group and its associates are reversed on equity accounting, the underlying asset is also tested for impairment from the Group's perspective. Where the associates use accounting policies other than those of the Group for like transactions and events in similar circumstances, adjustments are made, where necessary, to conform the associates' accounting policies to those of the Group when the associates' financial statements are used by the Group in applying the equity method.

When the Group's share of losses in associates equals or exceeds its interests in the associates, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associates. For this purpose, the Group's interests in the associates are the carrying amount of the investments under the equity method together with the Group's long-term interests that in substance form part of the Group's net investments in the associates.

After the application of equity method, the Group determines whether it is necessary to recognise an additional impairment loss on the Group's investments in its associates. At each reporting date, the Group determines whether there is any objective evidence that the investments in associates are impaired. If such indications are identified, the Group calculates the amount of impairment as being the difference between the recoverable amount (higher of value in use and fair value less costs to sell) of the associates and their carrying amounts. In determining the value in use of the investment, the Group estimates its share of the present value of the estimated future cash flows expected to be generated by the associates, including cash flows arising from the operations of the associates and the proceeds on ultimate disposal of the investments.

3.5 合營公司

合營公司是一項安排,據此本集團或本公司與 其他方協定分享對此項安排的控制權,並享有 此項安排的資產淨值。

合營公司之業績和資產及負債乃以權益會計法 計入綜合財務報表。根據權益法,於合營公司 之投資乃按成本於綜合財務狀況表中列賬,並 就本集團於收購後應佔該合營公司之損益及其 他全面收益作出調整,以及減去任何已確定之 減值虧損。當本集團應佔一間合營公司之虧損 相等於或超出其於該合營公司之權益(包括實質 上構成本集團於該合營公司部份投資淨額之任 何長期權益),則本集團不再繼續確認其應佔之 進一步虧損。當本集團已產生法定或推定責任 或代表該合營公司作出付款時,才會以該等金 額為限,額外為應佔之虧損撥備及確認負債。

任何收購成本超出於收購日本集團應佔一間合 營公司已確認可識別資產、負債及或有負債公 允淨值之差額,均確認為商譽,而商譽計入投 資賬面值。

#### 3.5 Joint ventures

A joint venture is an arrangement whereby the Group or the Company and other parties contractually agree to share control of the arrangement, and have rights to the net assets of the arrangement.

The results and assets and liabilities of joint ventures are incorporated in the consolidated financial statements using the equity method of accounting. Under the equity method, investments in joint ventures are carried in the consolidated statement of financial position at cost as adjusted for postacquisition changes in the Group's share of the profit or loss and other comprehensive income of the joint ventures, less any identified impairment loss. When the Group's share of losses of a joint venture equals or exceeds its interest in that joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the joint ventures), the Group discontinues recognising its share of further losses. An additional share of losses is provided for and a liability is recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of that joint venture.

Any excess of the cost of acquisition over the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities of a joint venture recognised at the date of acquisition is recognised as goodwill, which is included within the carrying amount of the investment.

Any excess of the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities over the cost of acquisition, after reassessment, is recognised immediately in profit or loss.

財務報表以香港元(「港元」)呈列,港元亦為本 公司之功能貨幣。

於綜合企業之個別財務報表內,外幣交易按交 易當日之主要匯率換算為個別企業之功能貨 幣。於報告日,以外幣為單位之貨幣資產及負 債均按該日適用之匯率換算。因結算該等交易 及報告日重新換算貨幣資產及負債所產生外匯 收益及虧損,乃於損益內確認。

按公平值列賬並以外幣為單位之非貨幣項目乃 按釐定公平值日期之匯率重新換算,並報告為 公平值收益或虧損之一部份。以歷史成本並以 外幣為單位計量之非貨幣項目不會重新換算。

At each reporting date the Group determines whether there is any objective evidence that the investments in joint ventures are impaired. If such evidence is identified, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 "Impairment of Assets" as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs to sell) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When a group entity transacts with its joint venture, profits and losses resulting from the transactions with the joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the joint venture that are not related to the Group.

#### 3.6 Foreign currency translation

The financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

於綜合財務報表內,海外業務原先以有別於本 集團呈報貨幣之貨幣呈列之所有個別財務報 表,已折算為港元。資產及負債已按報告日之 收市匯率換算為港元。收入及支出已按交易日 期之適用匯率或於申報期間之平均匯率折算為 港元,惟匯率不得出現大幅波動。自此步驟產 生之任何差額已於其他全面收益確認並且於權 益內之貨幣換算儲備另行累計。

#### 3.7 收入確認

收入乃按已收或應收代價之公平值計量。

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into HK\$. Assets and liabilities have been translated into HK\$ at the closing rates at the reporting date. Income and expenses have been converted into HK\$ at the exchange rates ruling at the transaction dates, or at average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

#### 3.7 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable.

Provided it is probable that the economic benefits will flow to the Group and the revenue can be measured reliably, revenue is recognised as follows:

Interest income is recognised on a time-proportion basis using the effective interest method.

Dividend is recognised when the right to receive payment is established.

#### 3.8 Borrowing costs

Borrowing costs incurred for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other borrowing costs are expensed when incurred.

當資產開支產生時、貸款成本產生時及進行預 備資產作擬定用途或出售的活動時,貸款成本 被資本化為合資格資產的成本部份。在大致上 完成預備合資格資產作擬定用途或出售的所有 必須活動後,貸款成本不會再被資本化。

附屬公司、聯營公司及合營公司之權益須進行 耗蝕測試。

所有非財務資產則在出現未必能收回有關資產 賬面值之跡象時進行耗蝕測試。

耗蝕虧損按資產賬面值超過其可收回款額之差 額即時確認為支出。可收回款額為反映市況之 公平值減銷售成本與使用價值兩者之較高者。 於評估使用價值時,估計未來現金流量乃採用 税前貼現率貼現至其現值,以反映現時市場對 金錢時間值及有關資產特有風險之評估。

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

#### 3.9 Impairment of non-financial assets

Interests in subsidiaries, associates and joint ventures are subject to impairment testing.

All non-financial assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs to sell, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

Impairment losses recognised for cash-generating units are charged pro rata to the assets in the cash generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost to sell, or value in use, if determinable.

### 3.10 Financial assets

The Group's accounting policies for financial assets other than investments in subsidiaries, associates and joint ventures are set out below.

Financial assets are classified into the following categories:

- financial assets at fair value through profit or loss;
- loans and receivables; and
- available-for-sale financial assets.

Management determines the classification of its financial assets at initial recognition depending on the purpose for which the financial assets were acquired and where allowed and appropriate, reevaluates this designation at every reporting date.

All financial assets are recognised when, and only when, the Group becomes a party to the contractual provisions of the instrument. Regular way purchases or sales of financial assets are recognised and derecognised on trade date basis. When financial assets are recognised initially, they are measured at fair value, plus, in the case of investments not at fair value through profit or loss, directly attributable transaction costs.

Derecognition of financial assets occurs when the rights to receive cash flows from the investments expire or are transferred and substantially all of the risks and rewards of ownership have been transferred.

Financial assets are classified as held for trading if they are acquired for the purpose of selling in the near term, or it is part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent pattern of short-term profit-making. Derivatives, including separated embedded derivatives are also classified as held for trading unless they are designated as effective hedging instruments or financial guarantee contracts.

Where a contract contains one or more embedded derivatives, the entire hybrid contract may be designated as a financial asset at fair value through profit or loss, except where the embedded derivative does not significantly modify the cash flows or it is clear that separation of the embedded derivative is prohibited.

Financial assets may be designated at initial recognition as at fair value through profit or loss if the following criteria are met:

Loans and receivables (including trade and other receivables, amounts due from joint ventures, amount due from an associate, security deposits and cash and cash equivalents) are subsequently measured at amortised cost using the effective interest method, less any impairment losses. Amortised cost is calculated taking into account any discount or premium on acquisition and includes fees that are an integral part of the effective interest rate and transaction cost.

Gain or loss arising from a change in the fair value excluding any dividend and interest income is recognised in other comprehensive income and accumulated separately in the available-for-sale financial assets revaluation reserve in equity, except for impairment losses (see the policy below) and foreign exchange gains and losses on monetary assets, until the financial asset is derecognised, at which time the cumulative gain or loss is reclassified from equity to profit or loss. Interest calculated using the effective interest method is recognised in profit or loss.

The fair value of available-for-sale monetary assets denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the reporting date. The change in fair value attributable to translation differences that result from a change in amortised cost of the asset is recognised in profit or loss, and other changes are recognised in other comprehensive income.

For available-for-sale equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured and derivatives that are linked to and must be settled by delivery of such unquoted equity instruments, they are measured at cost less any identified impairment losses at each reporting date subsequent to initial recognition.

Where the recovery of trade receivables is considered doubtful but not remote. the impairment losses for doubtful receivables are recorded using an allowance account. When the Group is satisfied that recovery of trade receivables is remote, the amount considered irrecoverable is written off against trade receivables directly and any amounts held in the allowance account in respect of that receivable are reversed. Subsequent recoveries of amounts previously charged to the allowance account are reversed against the allowance account. #### 3.11 Derivative financial instruments

Derivative financial instruments, in individual contracts or separated from hybrid financial instruments, are initially recognised at fair value on the date the derivative contract is entered into and subsequently re-measured at fair value. Derivatives that are not designated as hedging instruments are accounted for as financial assets or financial liabilities at fair value through profit or loss. Gains or losses arising from changes in fair value are taken directly to profit or loss for the year.

#### 3.12 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, associates and joint ventures, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset is realised, provided they are enacted or substantively enacted at the reporting date.

#### **Retirement benefits**

Retirement benefits to employees are provided through a defined contribution plan.

The Group operates a defined contribution retirement benefits scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme"), for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligation under this plan is limited to the fixed percentage contributions payable.

#### Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

#### 3.16 Financial liabilities

The Group's financial liabilities include trade and other payables and accrued expenses, amounts due to a holding company and a fellow subsidiary and financial liabilities at fair value through profit or loss.

Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. All interest related charges are recognised in accordance with the Group's accounting policy for borrowing costs (see Note 3.8).

The Executive Directors assess segment profit or loss using a measure of operating profit. The measurement policies the Group uses for segment reporting under HKFRS 8 are the same as those used in its HKFRS financial statements.

On adoption of HKFRS 8, based on the regular internal financial information reported to the Group's Executive Directors for their decisions about resources allocation to the Group's business components and review of these components' performance, the Group has identified only one operating segment, financial instrument investments. Accordingly, segment disclosures are not presented.

#### Critical Accounting Estimates and Judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

### Fair value of financial assets and liabilities

The best evidence of fair value is the published price quotations in an active market. In the absence of such information, the fair value is determined by an independent professional valuer. Such valuation is subject to limitations of the valuation models adopted and the uncertainty in estimates used by management in the assumptions. Should the estimates including share prices, deposit rates, spot rates, risk-free rates, volatility and the relevant parameters of the valuation model be changed, there would be material changes in the fair value of certain financial instruments without quoted prices.

## Impairment of amounts due from subsidiaries, an associate and joint ventures

The Group's management determines the need to make allowance for impairment of amounts due from subsidiaries, an associate and joint ventures. This estimate is based on the subsidiaries', an associate's and joint ventures' net asset values and operating results. Management reassesses the allowance at the reporting date.

### Impairment of available-for-sale financial assets

For available-for-sale financial assets, a significant or prolonged decline in fair value below cost is considered to be objective evidence of impairment. Judgement is required when determining whether a decline in fair value has been significant or prolonged. In making this judgement, the historical data on market volatility as well as the price of the specific investment are taken into account. The Group also takes into account other factors, such as industry and sector performance and financial information regarding the issuer/ investee.

#### Impairment of interests in joint ventures and associates

The Group's management assesses impairment of interests in joint ventures and associates at each reporting date by evaluating conditions specific to the Group that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amounts of the assets are determined. Value in use calculations performed in assessing recoverable amounts incorporate a number of key estimates and assumptions about future events, which are subject to uncertainty and might materially differ from the actual results. In making these key estimates and judgements, the management takes into consideration assumptions that are mainly based on market condition existing at the reporting date, appropriate market and discount rates and what information it can obtain from the joint ventures and associates. These estimates are regularly compared to actual market data and actual transactions entered into by the Group.

#### Impairment of trade receivables

The Group's management determines impairment of trade receivables on a regular basis. This estimation is based on the credit history of debtors and current market conditions. Management reassesses the impairment of trade receivables at the reporting date.

The overall objectives in managing financial risks focus on securing the Group's short-to-medium-term cash flows by minimising its exposure to financial markets. Long-term financial investments are managed to generate lasting returns with acceptable risk levels.

The Group adopts conservative investment strategies. Usually investments are in liquid securities quoted on recognised stock exchanges, except where entered into for long-term strategic purposes. For investment in debt securities, basically only debt securities with credit ratings of C or above would be considered. Trading accounts are only opened with reputable security brokers. The Board monitors the Group's overall investment position and exposures based on the investment report.

The Group's management considers that all the above financial assets that are not impaired for each of the reporting dates under review are of good credit quality.

None of the Group's financial assets are secured by collateral or other credit enhancements.

#### 33.6 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or other financial assets. The Group is exposed to liquidity risk in respect of settlement of trade and other payables and its financing obligations, and also in respect of its cash flow management. The Group's objective is to maintain an appropriate level of liquid assets and committed lines of funding to meet its liquidity requirements in the short and long term.

The Group manages its liquidity needs by carefully monitoring scheduled debt servicing payments for long-term financial liabilities as well as cashoutflows due in day-to-day business. Liquidity needs are monitored on a day-to-day basis. Longterm liquidity needs for 360-day lookout period are identified monthly.

Unlisted equity securities are measured at fair value at the end of the reporting period. Based on the relevant agreements, the Group can require the relevant investment manager to redeem the units at net asset value by giving a written redemption notice. The fair value of the unlisted equity securities are provided by the relevant investment managers.

Fair value of listed and unlisted debt securities and equity forward contracts, have been determined by a firm of independent professional valuer, Greater China Appraisal Limited, using valuation techniques.

#### Listed and unlisted debt securities

Fair values of the listed and unlisted debt securities have been determined by valuation technique as described below:

The Group held hybrid instruments comprising perpetual bonds and guaranteed notes, which are separated into two components: the debt element and the option element. The Group has classified the debt element as available-for-sale financial assets and the option element as derivative financial instruments (Note 25).

The methods and assumptions applied for the valuation of the bonds are as follows:

(i) Valuation of debt element

The debt element is recognised at fair value at date of initial recognition and subsequent measurement with fair value change at each reporting date recognised directly in equity until the instrument is sold. As at 31st December, 2015, the fair value of the debt element is approximately HK\$66,583,000 (2014: approximately HK\$182,490,000) which was calculated based on the present value of contractually determined stream of future cash flows discounted at the required yield, which was determined with reference to instruments of similar terms. The effective interest rates of the debt element at 31st December, 2015 ranged from 4.64% to 9.56% (2014: ranged from 4.10% to 12.55%).

Under the terms of the contracts, the Group is obligated to acquire of the underlying shares of each contract at a forward price for a year long. The contracts require no initial cost. Predetermined number of shares is accumulated to be acquired of by the Group on a daily basis and they are settled on monthly basis. The key terms of these contracts incorporate knockout and gearing properties. A knockout price is set for each contract, once the daily share price of the underlying share triggers the knock-out price, the contract is closed out immediately. However, if the daily share price of the underlying share falls below the forward price, the Group has to acquire double of the predetermined daily number of shares.
