公司簡介

China Fortune Holdings Limited (“China Fortune” or the “Group”), formerly named Fortune Telecom Holdings Limited, mainly sells and distributes mobile phones and digital products in the People’s Republic of China (the “PRC”). The Group was established in Hong Kong in 1992. It was first listed on the GEM Board of the Stock Exchange of Hong Kong Limited (Stock code: 8040) on 16th February, 2000, and then successfully shifted to the Main Board (Stock code: 110) on 26th January, 2004. The Group has a strong shareholder background and well operational and professional management team.

The Group owns a retail chain in Zhuhai, the PRC for selling mobile phones and telecommunication equipments.

In 2009, the Group acquired a Strontium mining site in the PRC, as its first step in entering the natural resource industry.

The corporate culture of the Group rests on the integration of the West and the East, modern and traditional management philosophy, with an aim to build up a “Continuous Learning Enterprise”. The corporate spirit of China Fortune focuses on “Human Enterprise”. Under the leadership of its aspiring and energetic management, China Fortune’s staff will team up and move towards the Group’s goal of ranking as one of the largest and best wireless communication and data products and services providers in the region.

本集團於中國珠海擁有一間零售連鎖店，銷售移動電話及電訊設備。

二零零九年，本集團收購了中國一家鋇礦場，作為其涉足天然資源行業之第一步。

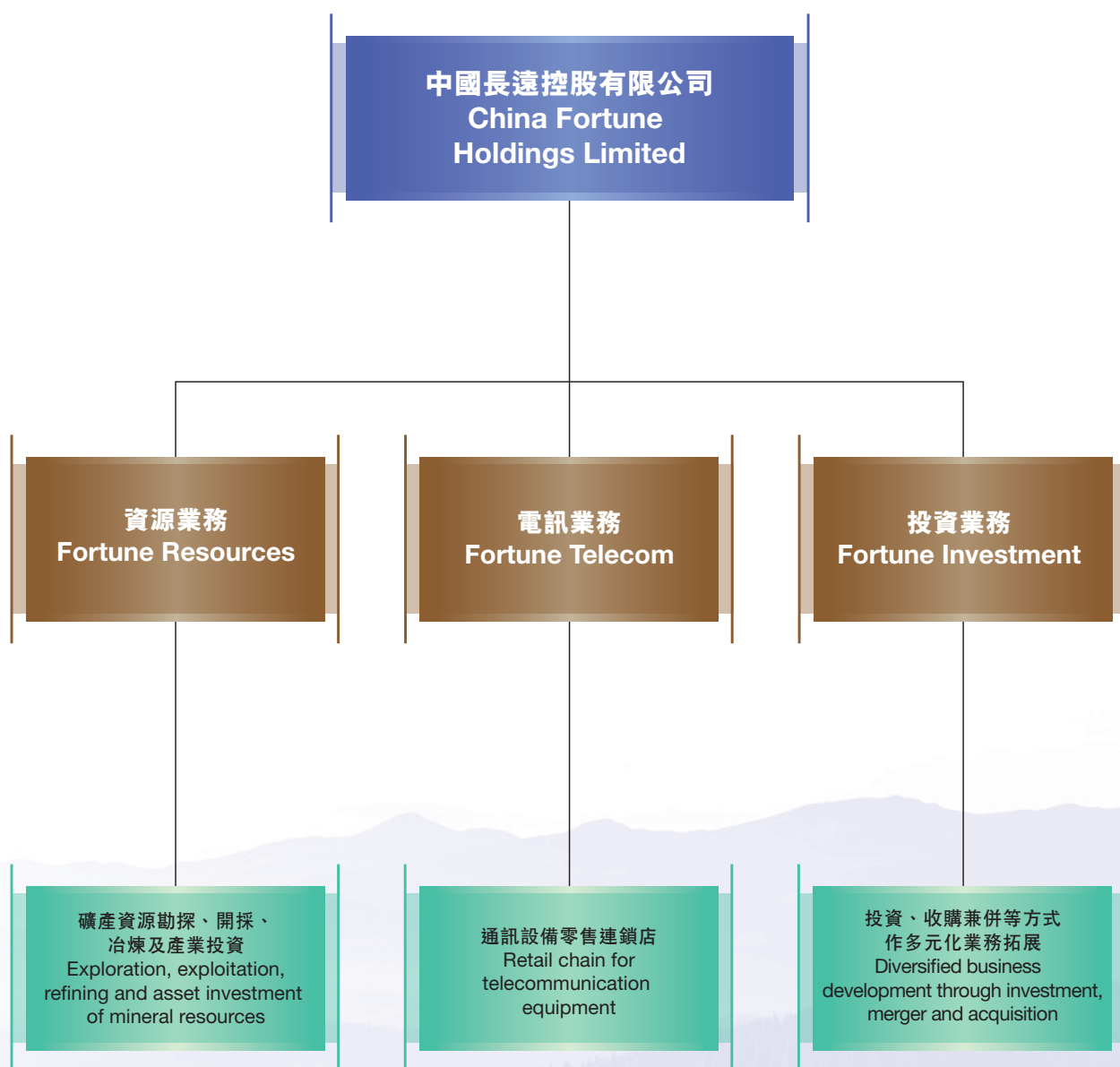

REVIEW

REVIEW AND OUTLOOK

Financial Review

Our turnover in mobile phone business increased in the year, leading to a reduced loss of HK\$8.1 million incurred in this business segment, as compared to a segment loss of HK\$9.5 million in last year. For our mining business which the exploitation on the first phase was completed in 2010 and development of a new mining site exploitation system in the next phase commenced since then, exploitation of minerals is now halted.

The Group recorded an increase in the consolidated revenue from HK\$57.6 million in last year to HK\$157.9 million in this year. The gross profit amounted to HK\$5.4 million, a decrease when compared to the last year of HK\$8.6 million. The gross margin percentage during the year was 3.4% which was lower than the last year of 14.9% due to the lower gross margin achieved in the mobile phone trading business in this year. The other income in this year included interest income amounted to HK\$1.0 million. The other gains and losses in the year consisted a one-off impairment loss recognised in respect of available-for-sale investments amounted to HK\$6.2million and an impairment loss recognised in respect of trade and other receivables amounted to HK\$2.8 million.

The selling and distribution costs amounted to HK\$6.6 million which decreased as compared to HK\$10.4 million of last year. It was mainly because the staff costs decreased during this year. The administrative expenses amounted to HK\$18.2 million, a decrease when compared to the last year of HK\$30.0 million mainly due to decrease in staff cost in the year.

回顧及前景

財務回顧

本集團移動電話業務之營業額於年內報升，導致此業務分部產生虧損減少至8,100,000港元，而去年則錄得分部虧損9,500,000港元。就本集團之採礦業務而言，第一階段的開採工作已於二零一零年完成，其後已開展下一階段，發展新礦地開採系統，而目前暫停礦物開採。

本集團之綜合收益由上年度之57,600,000港元，增加至本年度之157,900,000港元。毛利為5,400,000港元，較上年度之8,600,000港元減少。年內之毛利率由上年度之14.9%降至3.4%，此乃由於本年度移動電話貿易業務之毛利率下滑所致。年內其他收入包括利息收入1,000,000港元。年內之其他收益及虧損包括就6,200,000港元之可供出售投資確認之一次性減值虧損及就2,800,000港元之應收貿易賬款及其他應收賬款確認之減值虧損。

銷售及分銷成本為6,600,000港元，與上年度10,400,000港元有所下降。此乃主要由於本年度員工成本減少所致。行政費用為18,200,000港元，較上年度之30,000,000港元為少，主要由於員工成本下降所致。

Management Discussion and Analysis 管理層討論與分析

As far as the mobile phone retail chain and wholesale business in Zhuhai was concerned, the revenue achieved during the year amounted to HK\$21.7 million, decreased by 48.7% as compared with last year of HK\$42.3 million. Owing to the fierce competitive business environment this retail chain facing, the Group continued to share a loss from it during the year. As the performance of the associates was unpromising so far since these associates were invested by the Group, the Group shared net losses of HK\$2.0 million from the results of the associates during the year as compared to the net loss of HK\$1.4 million in last year.

The finance costs kept at same level at HK\$1.3 million this year when compared to last year.

The net asset value of the Group attributable to owners of the Company as at 31st December, 2015 amounted to HK\$165.4 million or HK\$0.2 per share when compared to HK\$195.9 million or HK\$0.24 per share as at 31st December, 2014. The basic loss per share was 2.78 Hong Kong cents as compared to the basic loss per share of 2.96 Hong Kong cents in last year.

As at 31st December, 2015, the Group's aggregate other borrowings amounted to HK\$14.8 million when compared to HK\$15.5 million as at 31st December, 2014, which was maintained at a similar level.

The gearing ratio of the Group, defined as the ratio of the total long term liabilities to the shareholder's equity, was 0.48 and 0.34 as at 31st December, 2015 and 2014 respectively.

有關珠海移動電話零售連鎖及批發業務方面，於年內錄得收益為21,700,000港元，較上年度之42,300,000港元下跌48.7%。鑑於此零售連鎖之營商環境面對激烈競爭，本集團年內因此繼續分佔虧損。由於本集團投資之聯營公司，該等聯營公司之表現至今仍未如理想，本集團年內分佔該等聯營公司業績之淨虧損為2,000,000港元，而上年度則為分佔淨虧損1,400,000港元。

本年度之融資成本與上年度相同，維持在1,300,000港元。

於二零一五年十二月三十一日，本公司擁有人應佔本集團資產淨值為165,400,000港元或每股0.2港元，而於二零一四年十二月三十一日則為195,900,000港元或每股0.24港元。每股基本虧損為2.78港仙，而上年度則為每股基本虧損2.96港仙。

於二零一五年十二月三十一日，本集團之其他借貸總額為14,800,000港元，而於二零一四年十二月三十一日則為15,500,000港元，水平相若。

於二零一五年及二零一四年十二月三十一日，本集團本年度負債資產比率（長期負債總額對股東權益之比率）分別為0.48及0.34。

Management Discussion and Analysis

The total cash and cash equivalents amounted to HK\$12.9 million as at 31st December, 2015 without any deposit pledged to banks. The Group is financed by a combination of its equity capital, cash flow generated from its operation and other borrowings. During the year, there was no material change in the funding and treasury policy of the Group. The Group considers there is no material potential currency exposure as the majority of its revenue and expenses are derived and incurred all in Renminbi in the PRC. It is the treasury policy of the Group to manage its foreign currency exposure whenever its financial impact is material to the Group.

The inventories of the Group as at 31st December, 2015 amounted to HK\$2.0 million, when compared to HK\$6.5 million as at 31st December, 2014, mainly since less inventories was kept as driven by stringent inventory control in the year. The inventory turnover period was 17 days in this year when compared to 46 days of last year. The Group will continue to apply strict policy in inventory control in the future.

The amount of trade and other receivables as at 31st December, 2015 was HK\$43.3 million, when compared to HK\$14.9 million as at 31st December, 2014. In order to minimise the credit risk for the trade receivables, the Group has implemented strict control on the determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts.

As at 31st December, 2015, the Group had in total 89 employees as compared to 140 employees as at 31st December, 2014. Employees were remunerated according to the nature of their job duties and market trend. The Group provided staff welfare and fund contribution to its employees in accordance with the prevailing regulations in the PRC and Hong Kong. There was no material change in the remuneration policy, bonus scheme and share option scheme during the year. The Group has a share option scheme under which the Company may grant share options to the participants, including directors and employees, to subscribe for shares of the Company.

於二零一五年十二月三十一日之現金及現金等價物總額為12,900,000港元，並無任何存款質押予銀行。本集團同時透過股本、經營業務所得現金流及其他借貸等方式籌集資金。年內，本集團融資及庫務政策並無重大轉變。本集團認為，由於本集團收益及支出大部分來自中國並均以人民幣作出，故此並無潛在重大貨幣風險。本集團之庫務政策為管理對本集團有重大財務影響之外幣風險。

本集團於二零一五年十二月三十一日之存貨金額為2,000,000港元，而於二零一四年十二月三十一日則為6,500,000港元，主要由於年內存貨量控制嚴謹，促使存貨減少。本年度之存貨周轉期為17天，而上年度則為46天。本集團日後將繼續實施嚴格存貨控制政策。

於二零一五年十二月三十一日，應收貿易賬款及其他應收賬款為43,300,000港元，而於二零一四年十二月三十一日則為14,900,000港元。為降低應收貿易賬款之信貸風險，本集團一直嚴格控制信貸限額之釐定及信貸額之批核，並設有其他監管程序，以確保能跟進追討過期債務。

於二零一五年十二月三十一日，本集團共聘用89名僱員，而於二零一四年十二月三十一日則有140名僱員。僱員薪酬按彼等之職責性質及市場趨勢而定。本集團根據中國及香港之現行規例向僱員提供員工福利及退休金供款。年內，薪酬政策、花紅計劃及購股權計劃並無重大變更。本集團已制訂購股權計劃，據此，本公司可向參與者（包括董事及僱員）授出可認購本公司股份之購股權。

OPERATIONAL REVIEW

Market Overview

According to the statistics released by the Ministry of Industry and Information Technology of the People's Republic of China ("MIIT"), there were more than 1.3 billion subscribers to mobile phone services in the PRC as at the end 2015. While there are continuing intense competitions among the major mobile phone manufacturers in the PRC, they are trying to cut the distribution layers by directly supplying to the provincial distributors and leading retailers with a view to increase their profitability. Because of this, leading vendors have developed multi-channel distribution models which include "national distribution", "provincial distribution", "direct to retail" and "direct to operator".

On the other hand, mobile carriers are key participants in the mobile phone industry chain. The restructuring of mobile carriers in 2009 and the issuance of 3G licenses have led to more intense competition among the mobile carriers. By cooperating with retailers, especially large mobile telecommunication chain stores, the mobile carriers can benefit from the retailers' in-depth understanding of customer behaviors and spending preferences. Through such cooperation, the customers will experience more professional, convenient and integrated customer services. Thus, large mobile telecommunications chain stores are expected to become the main sales channel for the mobile carriers for their bundled mobile phones.

Business Review

Mobile Phone Business

The Group was involved in the business of trading, wholesale and retail of mobile phones and telecom equipments in China. Although there was growth in the mobile phone market, the competition in the mobile phone retail market was very keen and the Group's performance in this area had been affected.

營運回顧

市場概覽

根據中華人民共和國工業和信息化部（「工業和信息化部」）發佈之統計數據，於二零一五年底，中國之移動電話服務用戶人數超過13億人。隨着競爭不斷加劇，中國各大移動電話製造商正試圖通過直接向省級分銷商及主要零售商供貨而減少分銷層數，以增強盈利能力。因此，大廠商已創出多渠道分銷模式，包括「全國分銷」、「省級分銷」、「直達零售」及「直達營運商」。

另一方面，移動運營商為移動電話行業鏈的主要參與者。移動運營商於二零零九年進行重組，並發行3G牌照，導致移動運營商之間的競爭更為激烈。移動運營商透過與零售商，特別是大型移動電訊連鎖店合作，可受惠於零售商對客戶習慣及消費喜好的深入了解。透過有關合作，客戶可體驗更專業、便捷及一體化的客戶服務。因此，預期大型移動電訊連鎖店會成為移動運營商銷售其捆綁式移動電話的主要渠道。

業務回顧

移動電話業務

本集團於中國參與移動電話及電訊設備之貿易批發及零售業務。雖然移動電話市場錄得增長，惟移動電話零售市場的競爭非常激烈，令本集團於此範疇的表現亦受影響。

Management Discussion and Analysis

管理層討論與分析

Customers focus is expected to gradually shift from the functionality of mobile phone to the shopping experience. Customers will normally require services such as function presentations, digital phone books synchronization and pre-installing software, etc, in purchasing a mobile phone. In the 3G & 4G era, the convergence of mobile telecommunications and the Internet also led to rapid development of value-added business which requires the retail channels to advance from a pure sales platform to an integrated service platform. In this regard, the large mobile telecommunication chain stores have advantages.

Mining

We commenced developing a new mining site exploitation system in our Strontium mining site since 2010. After the expiration of a 5-year mining exploitation permit on 25th September, 2012, Sifa Mining obtained a renewed mining operating permit for 2 years (the “2-year Permit 2012-2014”) from the Ministry of Land and Resources of the PRC (中華人民共和國國土資源部) (“MLR”), under which Sifa Mining was allowed to carry out exploration activities only, but not exploitation activities. The 2-year Permit 2012-2014 was expired on 25th September, 2014.

During the year 2014, the Group prepared documents as required and submitted the application to MLR to obtain a mining exploitation permit. In return, a renewed permit was granted by MLR on 27th April, 2015 for a term of 2 years from 25th September, 2014 to 25th September, 2016 (the “2-year Permit 2014-2016”). The terms and conditions of the 2-year Permit 2014-2016 are the same as the 2-year Permit 2012-2014, no exploitation activities were allowed but only exploration activities.

The Directors are of the opinion that the Group is still probable in obtaining the mining exploitation permit in the next renewal. Nevertheless, the Directors are also exploring all commercially viable opportunities to maximise the return from this investment, including finding potential buyers.

預計客戶之焦點將由移動電話的功能逐漸移向購物體驗。客戶購買移動電話時一般需要功能展示、數碼電話賬簿同步及預設軟件等服務。在3G及4G年代，移動電訊及互聯網覆蓋亦帶動增值業務發展加快，有關業務要求零售渠道由純粹銷售平台進化至綜合服務平台，就此而言，大型移動電訊連鎖公司享有優勢。

採礦

本集團自二零一零年開始於旗下鋇礦場建設新礦場開採系統。於五年期採礦許可證於二零一二年九月二十五日到期後，鋇發礦業獲中華人民共和國國土資源部（「國土資源部」）授予為期兩年的經重續採礦許可證（「二零一二年至二零一四年兩年期許可」），據此鋇發礦業只可在礦場進行勘探而不得進行開採活動。二零一二年至二零一四年兩年期許可已於二零一四年九月二十五日到期。

於二零一四年內，本集團編製有關規定文件並遞交予國土資源部，以取得採礦許可證，而國土資源部亦已於二零一五年四月二十七日授出重續許可，由二零一四年九月二十五日至二零一六年九月二十五日為期兩年（「二零一四年至二零一六年兩年期許可」）。然而，二零一四年至二零一六年兩年期許可的條款及條件與二零一二年至二零一四年兩年期許可相同，概不准進行開採活動，惟只可進行勘探活動。

董事認為本集團仍可在下一次重續時取得採礦許可證。然而董事亦將探討所有可行商機，將該投資之回報最大化，包括尋找潛在買家。

The Directors have carefully reviewed the recoverable amount of the cash-generating unit of the mining business (the “CGU”) to which the mining right is allocated. The Directors determined the recoverable amount of the CGU was not able to be measured by a fair value less cost of disposal using the market approach method as no sufficient and reliable market information can be obtained. In 2014, the recoverable amount of the CGU was determined by the value in use calculation. Since the management has changed their intentions by also considering the possible disposal of the CGU in current year, the recoverable amount of the CGU was then determined by a fair value less cost of disposal as at 31st December, 2015 using the income approach method. The recoverable amount of the CGU was classified as level 3 in the fair value hierarchy. The key assumptions adopted in the income approach method (2014: value in use calculation) relate to the renewal of a mining exploitation permit, estimated reserves, estimated productivity and the estimated prices of mineral resources. The calculation uses cash flow projections with certain key parameters as below:

Based on the above review, the recoverable amount of the cash-generating unit of the mining business approximates to its carrying value as at 31st December, 2015. The Directors considered that no impairment loss has to be recognised for the year.

董事已仔細審視採礦權所歸屬之採礦業務現金產生單位 (「現金產生單位」) 之可收回金額。董事判斷現金產生單位之可收回金額未能使用市場法，以公平值減出售成本計量，因為並無取得充足及可靠之市場資料。於二零一四年，現金產生單位之可收回金額以使用價值計算釐定。由於管理已改變其意向，於本年度亦考慮可能出售現金產生單位，故現金產生單位於二零一五年十二月三十一日之可收回金額乃採用收入法以公平值減出售成本計量。現金產生單位之可收回金額乃於公平值層級中分類為第三級。收入法 (二零一四年：使用價值計算) 採納之重要假設涉及採礦許可證的重續、估計儲量、估計生產力及礦產資源估計價格。計算使用現金流預測，若干重要參數如下：

Prospects and Outlook

The continued economic growth in the PRC is fuelled by a high internal consumption. As the world's biggest handset market, there were more than 1.3 billion handset subscribers in the PRC with an increase of around 19.6 million subscribers in 2015. There was over 29% of 4G users out of the total subscribers, and forecasted to increase much further in the near future. On the other hand, there were more than 700 million mobile Internet users which implies that there are huge business opportunities in both mobile application and mobile commerce. Since the Group has been in the related mobile phone industry for decades, mobile phone operating system and mobile internet would be surely the key business areas that the Group is interested in. The Group is actively looking for further opportunities which will further enhance the shareholders' value.

前景及展望

龐大內銷市場為中國經濟帶來持續增長動力。作為全球最大移動電話市場，中國移動電話用戶人數超過13億人，二零一五年增加大約19,600,000名用戶。用戶總數中逾29%為4G用戶，且預料將於不久將來進一步大幅增長。另一方面，移動電話互聯網用戶人數已超過700,000,000人，反映移動電話應用程式及移動商務市場商機龐大。由於本集團從事相關移動電話行業數十載，移動電話操作系統及移動互聯網勢將為本集團矢志發展之業務重點。本集團正積極物色將進一步提升股東價值之其他商機。

CORPORATE GOVERNANCE PRACTICES

The Board is committed to maintaining high standards of corporate governance with a view to assuring the integrity, transparency and quality of disclosure to protect the interests of all shareholders. The Company's corporate governance practices are based on the principles and code provisions ("Code Provisions") set out in the Code on Corporate Governance Practices (the "CG Code") as set out in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

BOARD OF DIRECTORS

Overall accountability

Members of the Board are individually and collectively accountable to the shareholders for the success and sustainable development of the Company. The Board provides direction and approval in relation to matters concerning the Company's business strategies, policies and plans whilst the day-to-day business operations are delegated to the executive management. The Board is accountable to the shareholders and in discharging its corporate accountability, every Director of the Company is required to pursue excellence in the interests of the shareholders and fulfill his fiduciary duties by applying the required level of skills, care and diligence to a standard in accordance with the statutory requirements.

Board composition

The Board currently comprises three Executive Directors and three Independent Non-executive Directors of whom all are independent as defined under the Listing Rules. Independent Non-executive Directors constitute more than one-third of the Board. The Company has received from each Independent Non-executive Director an annual confirmation of his independence pursuant to the independence guidelines set out in Rule 3.13 of the Listing Rules and considers that all Independent Non-executive Directors are independent. To the best knowledge of the Company, there is no financial, business, family or other material/relevant relationship among the members of the Board. Brief biographical particulars of the Directors are set out on pages 17 to 19.

Re-election of directors

All Non-executive Directors of the Company are not appointed for a specific term as stipulated under the provision A.4.1 of the CG Code but are subject to retirement by rotation in accordance with the Company's Bye-laws. In accordance with the relevant provisions in the Bye-laws of the Company, if the appointment of Directors is made by the Board, the Directors so appointed must stand for election by the shareholders at the first annual general meeting following their appointments and all Directors, except the Chairman, must stand for re-election by the shareholders by rotation. Separate resolutions are proposed for the election of each director.

本公司所有非執行董事之委任並無根據企業管治守則第A.4.1條之規定指定任期，惟彼等須根據本公司之公司細則輪流退任。根據本公司之公司細則相關條文，倘董事由董事會委任，則獲委任之董事必須於獲委任後首屆股東週年大會上由股東推選，而除主席外，所有董事必須輪流接受股東重選。推選每名董事均以獨立決議案提呈。

Nomination of directors

The Nomination Committee is authorised by the Board to determine the policy for the nomination of Directors, to set out the nomination procedures and the process and criteria adopted to select and recommend candidates for directorship.

Board responsibilities and delegation

The Board collectively determines the overall strategies of the Company, monitors performance and the related risks and controls in pursuit of the strategic objectives of the Company. Day-to-day management of the Company is delegated to the Executive Directors or the officer in charge of each division and function who is required to report back to the Board. Functions reserved to the Board and those delegated to management are reviewed periodically. All Board members have separate and independent access to the senior management, and are provided with full and timely information about the conduct of the business and development of the Company, including monthly reports and recommendations on significant matters. Should separate independent professional advice be considered necessary by the Directors or any Board Committee, independent professional services would be made available to the Directors or such Board Committee upon request. The Board has delegated some of its functions to the Board Committees, details of which are set out below. Matters specifically reserved for the Board include approval of financial statements, dividend policy, significant changes in accounting policies, material contracts, significant appointments such as Company Secretary and external auditor, terms of reference of Board Committees, as well as major corporate policies.

To implement the strategies and plans approved by the Board, Executive Directors and senior management meet on a regular basis to review the performance of the Group and make financial and operational decisions. The Company has arranged appropriate insurance cover on directors and officers liability for its directors and officers.

Provision A.4 of the CG Code states that all directors should be subject to re-election at regular intervals. However, Mr. Lau Siu Ying, being the Chairman of the Board, does not need to retire by rotation.

Mr. Lau Siu Ying has been in charge of the overall management of the Company since its incorporation. As a result, although he does not need to retire by rotation and assumes both roles of the Chairman and the Chief Executive Officer of the Company, the Board considers that such arrangement at the Group's current stage of development can facilitate the execution of the Group's business strategies and maximise the effectiveness of its operations. Nevertheless, through the supervision from the Board including the Independent Non-executive Directors, the interests of the shareholders should be adequately and fairly considered.

Directors' continuing professional development

Each newly appointed director is provided with necessary induction and information to ensure that he has a proper understanding of the Company's operations and businesses as well as his responsibilities under the relevant statutes, laws, rules and regulations.

Directors' training is an ongoing process. During the year, Directors are provided with monthly updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties. In addition, all Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The Company updates Directors on the latest development regarding the Listing Rules and other applicable regulatory requirements from time to time, to ensure compliance and enhance their awareness of good corporate governance practices.

The Board has established three committees to oversee particular aspects of the Company's affairs and to assist in the execution of the Board's responsibilities. Set out below is a summary of certain rights of the shareholders of the Company as required to be disclosed pursuant to the mandatory disclosure requirement under Paragraph O of the CG Code:

Convening of a special general meeting on requisition by shareholders

Pursuant to clause 58 of the Company's bye-laws, a special general meeting may be convened by the Board upon requisition by any shareholder holding not less than one-tenth of the issued share capital of the Company and the securities being held carrying the right of voting at any general meetings of the Company. The shareholder shall make a written requisition to the Board or the Company Secretary of the Company at the head office address of the Company, specifying the shareholding information of the shareholder, his/her contact details and the proposal regarding any specified transaction/business and its supporting documents.

The Board shall arrange to hold such general meeting within two (2) months after the receipt of such written requisition. Pursuant to clause 59 of the Company's bye-laws, the Company shall serve requisite notice of the general meeting, including the time, place of meeting and particulars of resolutions to be considered at the meeting and the general nature of the business.

If within twenty one (21) days of the receipt of such written requisition, the Board fails to proceed to convene such special general meeting, the shareholder shall do so pursuant to the provisions of Section 74(3) of the Companies Act 1981 of Bermuda (the "Act").

On 20th May, 2014, the Company entered into a placing agreement with Convoy Investment Services Limited (as placing agent) for the placing of up to 160,000,000 warrants of the Company at the issue price of HK\$0.01 per warrant. The subscription price attaching to each warrant is HK\$0.50 per subscription share (subject to adjustment). The closing price of the shares of the Company was HK\$0.44 per share as quoted on the Stock Exchange on the date of the placing agreement. The placing was completed on 15th July, 2014 and an aggregate of 160,000,000 warrants were issued to not less than six investors, who are individual investors, being third parties independent of the Company and its connected persons (as defined under the Listing Rules). The warrants confers its holders the right to subscribe for subscription shares during a period of two years commencing from 15th July, 2014. The subscription shares to be issued pursuant thereto shall be issued and allotted under the general mandate to issue shares granted to the Directors at the annual general meeting of the Company held on 21st May, 2013. The Company raised a net proceed of approximately HK\$1.3 million from the issue of the warrants and had been utilised as general working capital of the Group. The placing would enhance the capital and shareholders' base of the Company.

As at 31st December, 2015, an aggregate of 3,200,000 subscription shares have been issued upon exercise of the subscription rights attaching to the 3,200,000 warrants, whilst 156,800,000 warrants remain outstanding and unexercised. A net proceeds of approximately HK\$1.6 million arising from exercising such 3,200,000 warrants have been raised. The Company has utilised such net proceeds as general working capital of the Group.

Other details of the warrants of the Company are set out in note 30 to the consolidated financial statements.

Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the consolidated financial statements are free from material misstatement. Because of the matter described in the “Basis for disclaimer of opinion” paragraphs, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

BASIS FOR DISCLAIMER OF OPINION

As detailed in Note 17(i) of the consolidated financial statements, during the year, the Group's application for a mining exploitation permit turned out to be unsuccessful. Notwithstanding this fact, the directors are of the opinion that the Group is probable in obtaining the mining exploitation permit in the next application for renewal. Accordingly in the assessment of the recoverable amounts of the Group's mining right and the related plant and equipment of approximately HK\$266,342,000 and HK\$9,918,000 respectively and the carrying amount of the related deferred tax liabilities of approximately HK\$63,967,000 as at 31st December, 2015 (“the mining activities related assets and liability”) the directors assume that the Group will obtain the mining exploitation permit in the next application for renewal. As there is no sufficient appropriate audit evidence for us to assess the likelihood of the Group in obtaining the mining exploitation permit, we are not able to satisfy ourselves of the appropriateness of the assumptions used by the directors in assessing the recoverable amounts and carrying amount of the mining activities related assets and liability as at 31st December, 2015 and whether any impairment loss on the mining activities related assets should be recognised and whether any adjustment to the mining activities related liability should be made.

Any adjustments to the assets and liability as described above might have a significant consequential effect on the Group's financial position as at 31st December, 2015 and of its financial performance for the year then ended, and the related disclosures thereof in the consolidated financial statements.

倘對上述資產及負債作出任何調整，可能對貴集團於二零一五年十二月三十一日之財務狀況及其於截至該日止年度之財務表現，以及綜合財務報表內相關披露資料造成重大後續影響。

1. GENERAL

The Company is an exempted company with limited liability incorporated in Bermuda under the Companies Act 1981 of Bermuda (as amended). The shares of the Company are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). Its parent and ultimate holding company is Future 2000 Limited, a company incorporated in the British Virgin Islands. The addresses of the registered office and principal place of business of the Company are disclosed in the “Corporate Information” section to the annual report.

The functional currency of the Company is Renminbi (“RMB”). The consolidated financial statements are presented in Hong Kong dollars (“HK\$”) for the convenience of the shareholders, as the Company is listed in Hong Kong.

The Company is an investment holding company. The principal activities of the Group are distribution and trading of mobile phones and related accessories, development of marketing and after-sales service network and mining and processing of celestite, zinc and lead minerals. The activities of its principal subsidiaries and principal associates are set out in Notes 39 and 40, respectively.

1. 一般事項

Amendments to HKAS 1 – Disclosure Initiative

The amendments are designed to encourage entities to use judgment in the application of HKAS 1 when considering the layout and content of their financial statements.

An entity’s share of other comprehensive income from equity accounted interests in associates and joint ventures will be split between those items that will and will not be reclassified to profit or loss, and presented in aggregate as a single line item within those two groups.

Amendments to HKAS 16 and HKAS 38 – Clarification of Acceptable Methods of Depreciation and Amortisation

The amendments to HKAS 16 prohibit the use of a revenue-based depreciation method for items of property, plant and equipment. The amendments to HKAS 38 introduce a rebuttable presumption that amortisation based on revenue is not appropriate for intangible assets. Amendments to HKFRS 10 and HKAS 28 – Sale or Contribution of Assets between an Investor and its Associate or Joint Venture

The amendments clarify the extent of gains or losses to be recognised when an entity sells or contributes assets to its associate or joint venture. When the transaction involves a business the gain or loss is recognised in full, conversely when the transaction involves assets that do not constitute a business the gain or loss is recognised only to the extent of the unrelated investors’ interests in the joint venture or associate.

HKFRS 9 (2014) – Financial Instruments

HKFRS 9 introduces new requirements for the classification and measurement of financial assets. Debt instruments that are held within a business model whose objective is to hold assets in order to collect contractual cash flows (the business model test) and that have contractual terms that give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding (the contractual cash flow characteristics test) are generally measured at amortised cost. Debt instruments that meet the contractual cash flow characteristics test are measured at fair value through other comprehensive income (“FVTOCI”) if the objective of the entity’s business model is both to hold and collect the contractual cash flows and to sell the financial assets. Entities may make an irrevocable election at initial recognition to measure equity instruments that are not held for trading at FVTOCI. All other debt and equity instruments are measured at fair value through profit or loss (“FVTPL”).

HKFRS 9 (2014) – Financial Instruments (Continued)

HKFRS 9 includes a new expected loss impairment model for all financial assets not measured at FVTPL replacing the incurred loss model in HKAS 39 and new general hedge accounting requirements to allow entities to better reflect their risk management activities in financial statements.

HKFRS 9 carries forward the recognition, classification and measurement requirements for financial liabilities from HKAS 39, except for financial liabilities designated at FVTPL, where the amount of change in fair value attributable to change in credit risk of the liability is recognised in other comprehensive income unless that would create or enlarge an accounting mismatch. In addition, HKFRS 9 retains the requirements in HKAS 39 for derecognition of financial assets and financial liabilities.

HKFRS 15 – Revenue from Contracts with Customers

The new standard establishes a single revenue recognition framework. The core principle of the framework is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services. HKFRS 15 supersedes existing revenue recognition guidance including HKAS 18 Revenue, HKAS 11 Construction Contracts and related interpretations.

HKFRS 15 requires the application of a 5 steps approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer

- Step 4: Allocate the transaction price to each performance obligation
- Step 5: Recognise revenue when each performance obligation is satisfied

HKFRS 15 includes specific guidance on particular revenue related topics that may change the current approach taken under HKFRS. The standard also significantly enhances the qualitative and quantitative disclosures related to revenue.

The Group has already commenced an assessment of the impact of adopting the above Standards and amendments to existing Standards to the Group. The provisions of the new Hong Kong Companies Ordinance, Cap. 622, in relation to the preparation of financial statements apply to the Company in this financial year.

The directors consider that there is no impact on the Group’s financial position or performance, however the new Hong Kong Companies Ordinance, Cap. 622, impacts on the presentation and disclosures in the consolidated financial statements. For example, the statement of financial position of the Company is now presented in the notes to the consolidated financial statements rather than as a primary statement and related notes to the statement of financial position of the Company are generally no longer presented.

Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries (the “Group”). Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the effective dates of acquisition or up to the effective dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

有關編製財務報表之新香港公司條例（第622章）條文在本財政年度適用於本公司。

Acquisition of subsidiaries or businesses is accounted for using the acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interests that represent present ownership interests in the subsidiaries either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other non-controlling interests are measured at fair value unless another measurement basis is required by HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Any contingent consideration to be transferred by the acquirer is recognised at acquisition-date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interest are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interest is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus such non-controlling interest's share of subsequent changes in equity. Total comprehensive income is attributed to such non-controlling interests even if this results in those non-controlling interests having a deficit balance.

Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: power over the investee, exposure, or rights, to variable returns from the investee, and the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Associates

An associate is an entity over which the investor has significant influence and that is neither a subsidiary nor an interest in a joint venture. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate.

Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss. Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

聯營公司

聯營公司乃指投資者可行使重大影響力之實體，且該實體並非附屬公司亦非合營企業權益。重大影響力指參與被投資方之財務及經營決策但並非控制或共同控制該等政策之權力。

聯營公司採用權益法入賬，據此，聯營公司初步按成本確認，其後則為就本集團應佔聯營公司資產淨值之收購後變動對賬面值作出調整，惟超出本集團於聯營公司權益之虧損不予確認，惟有責任補償該等虧損則除外。

本集團與其聯營公司間進行交易所產生之溢利及虧損僅以無關連投資者於聯營公司之權益為限確認。投資者應佔聯營公司於該等交易所產生溢利及虧損，與聯營公司賬面值對銷。

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods sold and services provided in the normal course of business, net of discounts and sales related taxes.

Revenue from sales of goods is recognised when goods are delivered and title has passed.

Service income is recognised when services are provided.

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate.

Plant and equipment

Plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and accumulated impairment losses.

The cost of plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Depreciation is provided to write off the cost of items of plant and equipment over their estimated useful lives and after taking into account of their estimated residual values, using the straight-line method. The principal annual rates used for the current year are as follows:

Leasehold improvements	5%-20% or over the term of the relevant leases, whichever is shorter
Furniture, fixtures and equipment	20%-33%
Motor vehicles	20%-25%

An item of plant and equipment is written down immediately to its recoverable amount if its carrying amount is higher than the asset's estimated recoverable amount.

Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in the profit or loss in the period in which the item is recognised.

Construction in progress represents plant and equipment under construction or pending installation and is stated at cost less any impairment losses. No provision for depreciation is made on construction in progress until such time as the relevant assets are completed and ready for intended use. Construction in progress is classified to the appropriate category of plant and equipment when completed and ready for use.

Intangible asset

Club memberships

Club memberships with indefinite life are carried at cost less any subsequent accumulated impairment losses.

Mining right

Mining right is stated at cost less subsequent accumulated amortisation and accumulated impairment losses. Mining right is amortised using the units of production method based on the proven and probable mineral reserves.

In addition, intangible assets with indefinite useful lives are tested for impairment annually, and whenever there is an indication that they may be impaired. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

Provision for close down and restoration costs

Close down and restoration costs are provided in the accounting period when the obligation arising from the related disturbance occurs, whether this occurs during mine development or during the production phase, based on the net present value of estimated future costs. The cost is capitalised where it gives rise to future benefits, whether the rehabilitation activity is expected to occur over the life of the operation or at the time of close down. The capitalised cost is amortised over the life of the operation and the increase in the net present value of the provision is included in borrowing costs. Where there is a change in the expected decommissioning and restoration costs, an adjustment is recorded against the carrying value of the provision and related assets, and the effect is then recognised in the profit or loss on a prospective basis over the remaining life of the operation. Provision for close down and restoration costs do not include any additional obligations which are expected to arise from future disturbance. The cost estimates are reviewed and revised at the end of each reporting period to reflect changes in conditions.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost, which comprises all costs of purchase and, where applicable, cost of conversion and other costs that have been incurred in bringing the materials and supplies to their present location and condition, is calculated using the first-in, first-out method. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

Operating lease payments are recognised as an expense on a straight-line basis over the term of the relevant lease. Benefits received and receivable as an incentive to enter into an operating lease are recognised as a reduction of rental expense over the lease term on a straight-line basis.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing on the dates of the transactions. At the end of reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's entities are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the rate of exchange prevailing at the end of reporting period, and their income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity (the translation reserve).

Exchange differences arising are recognised in the translation reserve.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised profit or loss in the period in which they are incurred.

Government grants

Government grants are recognised when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as revenue in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

Retirement benefit costs

Payments to the Mandatory Provident Fund Scheme and other PRC state-managed retirement benefit schemes are charged as expenses when employees have rendered services entitling them to the contributions.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit as reported in the consolidated statement of comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be recognised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is recognised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of reporting period. The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of reporting period, to recover or settle the carrying amount of its assets and liabilities. Deferred tax is recognised in profit or loss, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity respectively.

Financial assets at fair value through profit or loss are initially measured at fair value and all other financial assets are initially measured at fair value plus transaction costs that are directly attributable to the acquisition of the financial assets. Regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. A regular way purchase or sale is a purchase or sale of a financial asset under a contract whose terms require delivery of the asset within the time frame established generally by regulation or convention in the marketplace concerned.

Financial assets at fair value through profit or loss

These assets represent held for trading financial assets. Financial assets are classified as held for trading if they are acquired for the purpose of sale in the near term.

Subsequent to initial recognition, financial assets at fair value through profit or loss are measured at fair value, with changes in fair value recognised in profit or loss in the period which they arise.

Loans and receivables

These assets are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers (trade debtors), and also incorporate other types of contractual monetary asset. Subsequent to initial recognition, they are carried at amortised cost using the effective interest method, less any identified impairment losses (see accounting policy on impairment loss on financial assets below).

In the application of the Group's accounting policies, which are described in Note 3, the directors of the Company are required to make estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Mining right

The mining right represents the right of Sifa Mining to conduct mining activities in Huangshi City, Hubei Province, the PRC. The mining right is amortised using the units of production method based on the proven and probable mineral reserves.

In 2014, the Group prepared documents as required and submitted the application to the Ministry of Land and Resources of the PRC (中華人民共和國國土資源部) ("MLR") for a mining exploitation permit. On 27th April, 2015, a permit was granted by MLR with a term of 2 years from 25th September, 2014 to 25th September, 2016, however, no exploitation activities were allowed but only exploration activities.

In the opinion of the directors, Sifa Mining is still probable in obtaining the mining exploration and exploitation permit until all the proven and probable minerals have been mined.

於二零一四年內，本集團編製有關規定文件並遞交予中華人民共和國國土資源部（「國土資源部」），以取得開採許可。國土資源部已於二零一五年四月二十七日授出許可，由二零一四年九月二十五日至二零一六年九月二十五日為期兩年。然而，概不准進行開採活動，惟只可進行勘探活動。

董事認為總發礦業仍很可能取得礦區開採及勘探許可，直至所有探明及推定礦產已獲開採。

Production capacity assumption

The mining operating permit under renewal limits the production capacity to 100,000 tons per year. In the opinion of the directors, the application for increasing the production capacity is procedural and Sifa Mining should be able to obtain a mining operating permit with higher production capacity without significant cost. In case the production capacity limit cannot be increased, the carrying amount of the mining right may be impaired.

Reserves estimates

Reserves are estimates of the amount of products that can be economically and legally extracted from the Group's properties. In order to calculate reserves, estimates and assumptions are required about a range of geological, technical and economic factors, including quantities, grades, production techniques, recovery rates, production costs, transport costs, commodity demand and commodity prices.

Estimating the quantity and/or grade of reserves requires the size, shape and depth of ore bodies or fields to be determined by analysing geological data such as drilling samples. This process may require complex and difficult geological judgments and calculations to interpret the data.

Because the economic assumptions used to estimate reserves change from period to period, and because additional geological data is generated during the course of operations, estimates of reserves may change from period to period. Changes in reported reserves may affect the Group's financial results and financial position in a number of ways, including the following:

- (i) Asset carrying values may be affected due to changes in estimated future cash flows.
- (ii) Depreciation, depletion and amortisation charged to profit or loss may change where such charges are determined by the units of production basis, or where the useful economic lives of assets change.
- (iii) Decommissioning, site restoration and environmental provisions may change where changes in estimated reserves affect expectations about the timing or cost of these activities.
- (iv) The carrying value of deferred tax may change as a result of changes in the asset carrying values as discussed above.

Provision for close down and restoration costs

The provision for close down and restoration costs is estimated by management based on the current regulatory requirements issued by the Hubei Provincial Peoples Government. Provision set up, if any, is reviewed regularly by management to ensure it properly reflects the obligation arising from mining and exploration activities.

Estimated impairment of trade and other receivables

When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31st December, 2015, the carrying amount of trade and other receivables was approximately HK\$43,282,000, net of allowance for doubtful debts of approximately HK\$24,045,000 (2014: 14,919,000 net of allowance for doubtful debts of approximately HK\$21,638,000).

5. CAPITAL RISK MANAGEMENT

The Group's objective of managing capital is to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce cost of capital.

The capital structure of the Group consists of debt, which includes other borrowings as disclosed in Note 27 and equity attributable to owners of the Company, comprising issued share capital and various reserves.

The directors of the Company review the capital structure periodically. As part of their review, the directors consider the cost of capital and the risks associate thereto. Based on recommendations of the directors, the Group will maintain its overall capital structure through the payment of dividends, new share issues as well as issue of new debt or the redemption of existing debt.

Credit risk

The Group's credit risk is primarily attributable to its trade and other receivables, amount due from a non-controlling shareholder of a subsidiary and bank balances. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

In respect of trade and other receivables, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customers as well as pertaining to the economic environment in which the customers operate. Ongoing credit evaluation is performed on the financial condition of trade customers. Normally, the Group does not obtain collateral from customers.

In addition to credit risk on trade and other receivables, the Group is also exposed to concentration of credit risk through advance to a non-controlling shareholder of a subsidiary of HK\$3,586,000 (2014: HK\$3,767,000). Because of its significance, management has regular liaison with the counterparty to understand their financial position and to identify any early sign of potential problems. Should any potential default risk arise, the Group's management will take prompt actions to safeguard the Group's assets.

In addition, the Group had concentration of credit risk on its liquid funds as 98% (2014: 99%) of bank balances were placed with five (2014: five) banks. However, the credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

Other price risk

The Group is exposed to equity price risk through its investments in listed equity securities. The management manages this exposure by maintaining a portfolio of investments with different risks. The Group's equity price risk is mainly concentrated on equity instruments quoted in the PRC stock exchange. Management monitors the price risks and will consider hedging the risk exposure should the need arises.

The management considered that the Group's exposure to the equity price risk on held-for-trading investments is not significant. Accordingly, no sensitivity analysis is presented.

Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the recognised of borrowings as well as the cash flows from operating activities.

The table has been drawn up based on the undiscounted cash flows of financial liabilities and the earliest date on which the Group can be required to pay. (i) Mining exploitation permit

After the expiration of a 5-year mining exploitation permit on 25th September, 2012, Sifa Mining obtained a renewed mining operating permit for 2 years (the "2-year Permit 2012-2014") from the Ministry of Land and Resources of the PRC (中華人民共和國國土資源部) ("MLR"), under which Sifa Mining was allowed to carry out exploration activities only, but not exploitation activities. The 2-year Permit 2012-2014 was expired on 25th September, 2014.

During the year 2014, the Group prepared documents as required and submitted the application to MLR to obtain a mining exploitation permit. In return, a renewed permit was granted by MLR on 27th April, 2015 for a term of 2 years from 25th September, 2014 to 25th September, 2016 (the "2-year Permit 2014-2016"). However, the terms and conditions of the 2-year Permit 2014-2016 are the same as the 2-year Permit 2012-2014, no exploitation activities were allowed but only exploration activities.

The directors are of the opinion that the Group is still probable in obtaining the mining exploitation permit in the next year renewal. Nevertheless, the directors are also exploring all commercially viable opportunities to maximise the return from this investment, including finding potential buyers.

In 2014, the recoverable amount of the CGU was determined by the value in use calculation. Since the management has changed their intentions by also considering the possible disposal of the CGU in current year, the recoverable amount of the CGU was then determined by a fair value less cost of disposal as at 31st December, 2015 using the income approach method. The recoverable amount of the CGU was classified as level 3 in the fair value hierarchy.
