4. 個人資料的保留

5. 查閱和更正個人資料

證券持有人有權確定本公司或香港證券登 記處是否持有其個人資料,並有權索取有 關該資料的副本並更正任何不準確資料。 本公司和香港證券登記處有權就處理任何 查閱資料的要求收取合理費用。
