# 獨立核數師報告

致恒生人民幣黃金ETF(「基金」)單位持有人的獨立核數師報告

#### 財務報表的報告

本核數師(以下簡稱「我們」)已審計第8至26頁基金的財務報表,此財務報表包括於二零一五年十二月三十一日的資產負債表,截至該日止年度的全面收入表、權益變動表和現金流量表以及主要會計政策概要及其他附註解釋資料。

基金經理及受託人就財務報表須承擔的責任

基金經理及受託人須負責根據香港會計師公會頒佈的《香港財務報告準則》編製財務報表,以令財務報表作出真實而公平的反映及落實其認為編製財務報表所必要的內部控制,以使財務報表不存在由於欺詐或錯誤而導致的重大錯誤陳述。

此外,基金經理及受託人須負責並確保財務報表符合經修訂的《信託契約》的相關披露規定及香港證券及期貨事務監察委員會頒布的《單位信託及互惠基金守則》(「該守則」)附錄E所列的相關披露要求。

#### 核數師的責任

Independent Auditor's Report to the Unitholders of Hang Seng RMB Gold ETF (the "Fund")

#### Report on the financial statements

We have audited the financial statements of the Fund set out on page 8 to 26, which comprise the statement of assets and liabilities as at 31 December 2015, the statement of comprehensive income, statement of changes in equity and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information.

Manager's and Trustee's responsibilities for the financial statements

The Manager and the Trustee are responsible for the preparation of financial statements that give a true and fair view in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants and for such internal control as the Manager and the Trustee determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In addition, the Manager and the Trustee also have a responsibility to ensure that the financial statements comply with the relevant disclosure provisions of the Trust Deed, as amended, and the relevant disclosure requirements set out in Appendix E to the Hong Kong Code on Unit Trusts and Mutual Funds issued by the Hong Kong Securities and Futures Commission ("the Code").

## 財務報表附註

#### 1. 背景

恒生人民幣黃金ETF(「基金」)由香港證券及期貨事務監察委員會(「證監會」)根據香港證券及期貨條例第104(1)條認可,並由香港《單位信託及互惠基金守則》(「該守則」)管轄。

基金是根據香港法例並按2012年1月27日訂立並經修訂的《信託契約》成立,並於2012年2月8日根據香港法例註冊為單位信託基金。

基金的投資目標是要提供(未計費用和開銷以及其他對沖成本前)與以美元計值的倫敦黃金定盤價的表現緊密相關的以人民幣計值的投資結果。

由2015年3月20日起,LBMA上午黃金價(根據基金的章程中的定義)取代倫敦黃金定盤價成為基金的基準。

# 2. 主要會計政策

#### (a) 遵例聲明

基金的財務報表是按照香港會計師公會頒佈的所有適用的《香港財務報告準則》(包含所有適用的個別《香港財務報告準則》、《香港會計準則》及詮譯)、香港公認會計原則、經修訂的《信託契約》的有關披露條款及證監會發出的該守則的相關披露規定編製。以下是基金採用的主要會計政策概要。

香港會計師公會頒布了若干新訂和經修訂的《香港財務報告準則》。這些準則在基金當前會計期間首次生效或可供提前採用。在與基金有關的範圍內初始應用這些新訂和經修訂的準則所引致當前和以往會計期間的會計政策變更,已於本財務報表內反映,有關資料載列於附註3。

#### (b) 財務報表的編製基準

本財務報表中所呈列的貨幣為人民幣(即基金的報價貨幣),而所有數項則以個位計算。

除商品及衍生工具(見下文所載的會計政策)外,本財務報表以歷史成本作為編製基準。

在按照《香港財務報告準則》編製財務報表時,基金經理及受託人就會計政策的採用及財務報表中所列之資產、負債、收入及開支數額的呈報需作判斷、估計及假設。該等估計與相關假設乃基於過往經驗和其它被認為合理之各種因素作出,從而作為計算某些難以確認的資產及負債之賬面價值的基準。實際結果或與該等估計不盡相同。

該等估計及相關假設經被不時檢討。因應該等估計需作出的修訂將在該等估計之修訂期間(若該等修訂僅影響該期間)或者修訂期間及未來期間(若該等修訂影響現時及未來期間)予以確認。

#### (c) 收入與費用

利息支出以實際利率法計算。所有其他的收入及支出均以權責發生制的形式入帳。

#### (d) 外幣換算

年度內的外幣交易按交易日的匯率換算至人民幣。以外幣為單位的貨幣資產及負債則按年終日的匯率換算至人民幣。匯兌盈虧均撥入收入或虧損確認。商品及衍生工具的投資而產生之匯兌差異已被包括於投資收益或虧損。

#### (e) 商品

商品包括黃金。黃金按年終日之黃金早熙定盤價呈列。金價變動所產生之差額於收入或虧損內處理。商品之已變現淨收益及虧損以平均成本法計算。

#### (f) 金融工具

#### (i) 分類

所有衍生工具的投資被歸類為持作交易用途的金融資產或金融負債。基金將其所有於衍生工具的投資歸類為按公平價值列入收入或虧損的金融資產或金融負債。被歸類為應收款項的金融資產包括其他應收款項。不被歸類為按公平價值列入收入或虧損的金融負債包括銀行透支、預提費用及其他應付款項。

所有衍生工具如錄得淨應收款項(即正公平價值),將被列為持作交易用途之金融資產,並被包括於資產負債表內的按公平價值列人收入或虧損的金融資產。所有衍生工具如錄得淨應付款項(即負公平價值),將被列為持作交易用途之金融負債,並被包括於資產負債表內的按公平價值列入收入或虧損的金融負債。

#### (ii) 確認

金融資產和金融負債在基金成為相關合約條文的人士時,將被予以確認。

在一般情况下購入或出售的按公平價值列入收入或虧損的金融資產或金融負債是根據交易日法予以確認。該等金融資產或金融負債之公平價值變動所產生的盈餘和虧損由該日起計算。

除非合約的其中一方已履行合約責任或該合約為不獲《香港會計準則》第39條豁免的衍生工具合約,否則金融負債將不被確認。

#### (iii) 計量

金融工具的首次計量是以公平價值(即交易價格)計算。按公平價值列人收入或虧損的金融資產及負債的交易成本列為費用撥入收入或虧損立即註銷。

首次確認後,所有按公平價值列入收入或虧損的工具以公平價值計量,其公平價值之變動則於收入或虧損予以確認。

分類為貸款或應收款項的金融資產採用實際利率法按攤銷成本扣除減值虧損(如有)後列賬。

非按公平價值列入收入或虧損的金融負債採用實際利率法按攤銷成本計量。

#### (iv) 公平價值計量的進則

「公平價值」是指市場參與者於計量日在主要市場(如果沒有主要市場則為最有利的市場)進行有序交易,出售資產時收取或轉移負債時支付的價格。負債的公平價值反映了其不履約風險。

非交易所買賣的衍生工具之公平價值是根據當時市況及交易對手之信貸狀況,按基金在年終日終止合約後可收取或須支付的金額估計。

遠期合約之投資將在資產負債表中以公平價值予以確認。未平倉的遠期合約之公平價值將以合約價格與合約相關資產的當時市場遠期價值的差額計算。

基金會在出現變動的該年期結束時確認公平價值級別之間的轉移。

投資於衍生工具的淨收益及虧損將列於收入或虧損內。投資於衍生工具的已變現收益及虧損及由公平價值變動所帶來的未變現的收益及虧損則載列於附註8。

#### (f) 金融工具(續)

#### (v) 減值

於每個年終日,以成本或攤銷成本計量的金融資產均會進行檢討以決定是否存在減值的客觀證據。若出現該等證據,減值虧損便以金融資產的賬面值與其預計未來現金流量按原訂實際利率折現的現值之間的差額在收入或虧損內確認。

若以攤銷成本列賬之金融資產的減值虧損於其後期間減少,而且客觀上該減少與減值後發生的事件有關,則在收入或虧損內回撥減值。

#### (vi) 取消確認

若可按金融資產合約收取現金的權利已過期或該金融資產連同大部份的風險及所有權的報酬被轉讓,該金融資產即被取消確認。

於基金出售持作交易用涂的資產當日,已出售之該等資產將被取消確認,來自經紀商的相關應收款項將於基金出售該等資產當日進行確認。

若合約所指定的責任被解除、取消或終止時,金融負債即被取消確認。

金融資產被取消確認時,資產之帳面金額及所得款項之差異在收入或支出被確認。

#### (vii) 抵銷

若基金具有將某項金融資產和金融負債的經確認數額互相抵銷之合法可執行權利,並有意根據其差額或同時進行結算交易(例如通過市場清算機制),該金融資產和金融負債會以互相抵銷後的淨額列入資產負債表內。

#### (g) 關聯方

- (a) 任何人士如果:
  - (i) 控制或與第三方共同控制本基金;
  - (ii) 對本基金具有重大的影響力;或
  - (iii) 是本基金或本基金母公司的關鍵管理人員,其本人或近親可視為本基金的關聯方。
- (b) 如屬下列任何一種情況,企業實體可視為本基金的關聯方:
  - (i) 該實體與本基金隸屬同一集團(意指彼此的母公司、附屬公司和同系附屬公司互有關聯)。
  - (ii) 一家實體是另一實體的聯營公司或合營企業(或是另一實體所屬集團旗下成員公司的聯營公司或合營企業)。
  - (iii) 兩家實體是同一第三方的合營企業。
  - (iv) 一家實體是第三方實體的合營企業,而另一實體是第三方實體的聯營公司。
  - (v) 該實體是作為本基金關聯方的任何實體的僱員福利而設的離職後福利計劃。
  - (vi) 該實體受到上述第(a)項內所認定人士控制或與第三方共同控制。
  - (vii) 上述第(a)(i)項內所認定人士對該實體具有重大的影響力或是該實體(或該實體母公司)的關鍵管理人員。
  - (viii) 該實體或與該實體所屬集團旗下任何成員提供關鍵管理人員服務予基金或基金母公司。

任何人士的近親是指預期會在與該實體的交易中影響該名人士或受其影響的家屬。

#### (h) 現金及現金等價物

現金及現金等價物包括銀行存款,於銀行及其他金融機構的活期存款和短期及流動性極高的投資項目。這些項目可以在沒有重大價值轉變的風險下容易地換算為 已知的現金數額,並在購入後三個月內到期。可隨時被要求還款的銀行透支組成基金現金管理一部分,並於現金流量表被列為現金及現金等價物的組成部分。

## (i) 已發行單位

基金根據發行的金融工具實質的合約條款,把其分類為金融負債或權益工具。

基金只發行一類可贖回單位。該類單位是基金的金融工具中居最末的類別及於所有重大層面擁有同等地位及有著相同的條款與章則。可贖回單位賦予投資者權利,可於每個贖回日及當基金清盤時,要求以現金形式贖回等值其於基金資產淨值中的持股比例。

發行人於有合約性責任以現金或其他金融資產回購或贖回的可贖回金融工具如符合下列所有條件時,應分類為權益工具:

- (i) 基金清盤時,持有人有權依其持有比例取回基金之資產淨值;
- (ii) 該金融工具所屬的類別於所有工具的類別中居最末位;
- (iii) 於所有工具的類別中居最末位的類別中的所有金融工具均有相同的特質;
- (w) 基金除了以現金或其他金融資產回購或贖回工具以履行合約性責任外,該工具本身並無任何其他符合負債定義的特質;及
- (v) 工具全期內之總預期現金流量的攤派是根據實質的損益計算:或根據已確認的資產淨值的變動計算;或根據基金已確認及未確認的資產淨值之公平價值的變動計算。

基金的可贖回單位符合以上所有的條件,並被分類為權益。

#### (j) 分部報告

分部經營是基金的組成部分且從事可賺取收入並衍生費用(包括與同一基金內的其他組成部分進行交易而衍生的相關收入和費用)的商業活動,其經營成果由主要經營決策者定期進行檢討,以決定分部的資源分配並評估其表現,及可取得其個別的財務資訊。匯報予主要經營決策者的分部表現包括可直接攤派至分部及可按合理的原則分配予分部的項目。基金的主要經營決策者為基金經理,即恒生投資管理有限公司。

#### 7. 金融風險管理

根據其投資管理策略,基金將購買及持有金條。為管理及對沖人民幣兌美元之間的匯率變動,基金將與掉期對手訂立一系列的掉期。

基金的投資活動為其帶來了不同種類的風險,此等風險與其投資的商品和衍生工具及市場有關。為了遵從《香港財務報告準則》第7號的要求,基金經理為基金持有 的商品及衍生工具確立了最重要的固有財務風險的種類。基金經理欲強調以下所載列的關聯風險只是其中一部份,並不為投資於基金的固有風險的全部。投資者請注 意與基金投資有關聯的風險的更多資訊已載列於基金的章程內

基金於年終日所持有的投資的性質及種類與其風險管理政策詳述如下。

#### (a) 市場風險

因市場價格變動而令到商品及金融工具的公平價值和未來現金流出現波動,會引致市場風險,包括滙率、利率及價格風險。

#### (i) 滙率風險

基金所投資之金條的報價貨幣為美元,而基金的報價貨幣則為人民幣。基金訂立一系列的掉期,以使人民幣計算的基金資產淨值將按美元計值的倫敦黃金定 盤價(2015年3月20日前)及LBMA上午黃金價(由2015年3月20日起)相若的升跌百分比上升及下跌。雖然不保證所有該等外匯風險都可以全部被抵銷,但基金須 承受的滙率風險已大大降低。

#### (ii) 利率風險

利率變動可能為帶息資產的價值帶來相反影響,或會引致基金獲得收益或虧損,從而或會產生利率風險。除銀行存款外,基金的商品、金融資產及金融負債 均為非帶息,因此基金並沒有重大的利率風險。

#### (iii) 價格風險

基金所持之金融工具的價值會受市場價格的轉變(由利率風險及匯率風險所引起的除外)的影響而波動(不論該市場價格的轉變是否由個別投資特有的因素 ,其發行人或所有會影響於市場交易的金融工具的因素所引起),從而產生價格風險

由於基金並非積極管理型基金,不論其投資是否有利,基金經理不會試圖挑選其他商品或貴金屬或在逆市中採取防禦措施。因此,LBMA上午黃金價下跌將會 導致基金的價格相應下跌。

基金所持之主要投資為金條。基金以整體基礎來估計黃金未來合理及有可能的價格變動,若LBMA上午黃金價於2015年12月31日合理及有可能增強20% (2014: 20%),則估計資產淨值會上升10,477,486人民幣 (2014:14,710,146人民幣);若LBMA上午黃金價於相反方向有同樣的變動,則估計資產淨值會下跌相同的金額。 這分析假設所有其他可變因素,尤其是利率保持不變。

#### 7. 金融風險管理(續)

#### (b) 信貸風險

#### (i) 信貸風險的管理策略及集中度之分析

於結算交易時,黃金交易商及參與經紀商可能未能交付或指示存入或分配金條及掉期對手可能無力償債或違約,因而產生信貸風險。然而所涉及的結算時間非常短暫及選用的黃金交易商、參與經紀商及掉期對手亦有一定的質素,因此由於未能結算而衍生出的信貸風險是非常低的。基金經理會透過監察黃金交易商、參與經紀商及掉期對手的信貸評級及其財政狀況以進一步減低此風險。

滙豐機構信託服務(亞洲)有限公司為基金的受託人。如受託人破產或清盤,或會令到基金資產的權益受到耽擱或限制。基金經理每年均會履行與受託人的 盡責審查以確保其信貸質素。

由2015年2月16日起,HSBC Bank plc取代HSBC Bank USA為基金的託管人。於截至2015年12月31日止年度內,基金的所有投資均存放於HSBC Bank plc (「託管人」)及HSBC Bank USA (2014:所有投資均存放於HSBC Bank USA)。如託管人破產或清盤,或會令到存於託管人的基金投資的權益受到耽擱或限制。基金經理會透過持續監察託管人的信貸質素以檢視其風險。

基金持有的所有現金均存於恒生銀行有限公司(「恒生銀行」)及香港上海滙豐銀行有限公司(「滙豐銀行」)(合稱「該等銀行」)。如該等銀行破產或清盤或會令到存於該等銀行的基金現金的權益受到耽擱或限制。基金經理會透過持續監察該等銀行的信貸質素以檢視其風險。

除以上所述外,於2015年12月31日及2014年12月31日,基金並沒有與其他對手有重大的集中的信貸風險。

#### (ii) 金融資產與金融負債的互相抵銷

資產負債表中沒有抵銷任何金融資產和金融負債。下表披露的項目包括需遵守可強制執行的總淨額結算安排的金融資產與金融負債。

可強制執行的總淨額結算安排未能符合資產負債表中的抵銷準則,因為這類安排賦予可抵銷已確認數額的權利,而這項權利本來只會在基金或其對手違約、無力償債或破產時才可強制執行。此外,基金及其對手均無意以淨值結算交易或同時變現資產和結算負債。

#### (c) 流通性風險

流通性風險是基金以現金或其他金融資產來履行由金融負債引起的責任時會遇到困難的風險,或該責任的解除方式會不利於基金。

基金及基金經理用以管理流通性的策略是備有足夠的現金以應付其負債包括預計的單位贖回,可於到期時支付而沒有帶來不能支付的損失或對基金的聲譽造成損害。

基金的章程賦予單位可每日發行及贖回,所以基金面對每日應付單位持有人贖回的流通性風險。所有其他金融負債是按需求而償付或其合約的期限少於三個月。

基金主要的投資是金條,是可輕易變現的投資。因此,基金能夠將其某部份的投資快速變現以應付其流動需要。部份的投資是可透過櫃台交易的衍生工具,未必能輕易變現,故此會承受某程度的流涌性風險。

基金的流通性風險由基金經理根據現有的政策及程序每日管理。基金的贖回政策允許投資者透過參與經紀商以實物黃金及以少量現金款額或全數以現金贖回最少 300.000個單位。

#### 13. 公平價值

基金的商品及衍生工具投資於年終日是以公平價值計量。而公平價值是於某一指定時間,因應市場因素及商品和金融工具的有關資料計算出來。公平價值的計算涉及不明因素及主觀判斷,然而公平價值仍可於合理估計範圍內確實地計算出來。而其他金融工具包括其他應收款項、現金及現金等價物、銀行透支及預提費用及其他應付款項,基於其性質屬中期或短期,故該等公平價值則以帳面金額計算。

#### 金融工具的估值

基金公平價值計量的會計政策詳見附註2(f)(iv)。

基金以下列公平價值級別計量公平價值,以反映在計量時所用輸入值的重要性。

- 第一級:所用輸入值為相同工具在活躍市場的報價 (未經調整)。
- 第二級:所用輸入值為第一級別的市場報價以外的數據,包括可直接(即價格)或間接(即源自價格)觀察的數據。這類別包括使用以下方法進行估值的工具:類似工具在活躍市場的報價;相同或類似工具在較不活躍市場的報價;或所有重大輸入值均可直接或間接從市場數據觀察的其他估值技術。
- 第三級:所用輸入值為不可觀察的數據。這類別包括所有工具,其所用估值技術並非基於可觀察的輸入值,而不可觀察的輸入值對工具的估值有重大影響。這類別亦包括工具是基於類似工具的報價進行估值,但需要重大不可觀察的輸入值作出調整或假設,以反映工具之間的差異。

基金利用估值技巧來決定衍生工具的公平價值。至於所有其他金融工具,由於它們中期或短期的性質,其帳面金額與公平價值接近。

基金持有被歸類為第二級的投資,基金利用得到廣泛認同的估值模型來釐訂公平價值,而這些估值模型所輸入的重要元素是可直接或間接於市場觀察得到的數據。這些常見及簡單的金融工具只採用可觀察的市場數據及需要極少的管理層的判斷及估計來釐訂公平價值。

估值方法包括淨現值及貼現現金流模型、與可於市場觀察價格的相近工具比較、Black-scholes及多項式期權定價模型及其他估值模型。用於估值方法的假設及輸入數據包括無風險及基準利率、信貸息差及其他用於估計貼現率的參數、債券及股票價格、匯率、股票及股票指數價格及預計的價格波幅及相互關係。

估值方法的目的是為了達到反映市場參與者於計量日進行有序交易時出售資產所收取或轉移負債所支付的價格的公平價值計量。

簡單的場外交易證券的可觀察價格及模型輸入元素通常可於市場獲取。可獲取的可觀察價格及模型輸入元素減少了管理層的判斷及估計的需要,亦減少了與釐訂公平 價值有關的不明朗因素。可獲取的可觀察價格及模型輸入元素會因應不同的產品及市場而有所迥異及會根據投資的特殊及一般情況有所轉變。

至於比較複雜的投資,基金會採用通常由廣為認同的估值模型演變出來的專有估值模型。這些模型部份或全部重要的輸入數據可能不可於市場觀察到,及由市場價格或利率或根據假設而衍生出售。涉及重要的不可觀察的輸入數據的工具包括如若干於場外交易的衍生工具。估值模型採用重要及不可觀察的輸入數據需要高度的管理層判斷及估計以釐訂公平價值。於選用合適的估值模型、釐訂受估值工具的預計現金流量、釐訂對手違約的機率及選用合適的貼現率方面通常均需要管理層判斷及估計。

## **Notes on the Financial Statements**

#### 1 Background

Hang Seng RMB Gold ETF ("the Fund") is authorised by the Securities and Futures Commission in Hong Kong ("SFC") under Section 104(1) of the Hong Kong Securities and Futures Ordinance, and is governed by the Hong Kong Code on Unit Trusts and Mutual Funds ("the Code").

The Fund was constituted by a Trust Deed dated 27 January 2012, as amended, under the laws of Hong Kong, and registered on 8 February 2012 as a unit trust under the laws of Hong Kong.

The investment objective of the Fund is to provide investment results denominated in Renminbi that, before fees and expenses and other hedging costs, closely correspond to the performance of the London Gold Fixing Price in United States dollars ("USD").

With effect from 20 March 2015, the London Gold Fixing Price was replaced by the LBMA Gold Price AM, as defined in the Fund's prospectus, as the benchmark of the Fund.

### 2 Significant accounting policies

#### (a) Statement of compliance

The financial statements of the Fund have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong, the relevant disclosure provisions of the Trust Deed, as amended, and the relevant disclosure requirements of the Code issued by the SFC. A summary of the significant accounting policies adopted by the Fund is set out below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Fund. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Fund for the current and prior accounting periods reflected in these financial statements.

#### (b) Basis of preparation of the financial statements

The financial statements are presented in Renminbi and all figures are rounded to the nearest integer.

The measurement basis used in the preparation of the financial statements is the historical cost basis except the measurement of commodity and derivatives explained in the accounting policies set out below.

The preparation of financial statements in conformity with HKFRSs requires the Manager and the Trustee to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### (c) Income and expenses

Interest expenses are recognised as they accrue using the effective interest method. All other income and expenses are accounted for on an accruals basis.

#### (d) Translation of foreign currency

Foreign currency transactions during the year are translated into Renminbi at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into Renminbi at the foreign exchange rates ruling at the date of statement of assets and liabilities. Exchange gains and losses are recognised in profit or loss. Exchange differences relating to investments in commodity and derivatives are included in gains/losses on investments.

#### (e) Commodity

Commodity comprises gold bullion. Gold bullion is stated at the morning fixing price of gold at the date of the statement of assets and liabilities. Differences arising from changes in gold prices are dealt with in profit or loss. Net realised gains and losses from commodity is calculated using the average cost method.

#### (f) Financial instruments

#### (i) Classification

All the investments in derivatives are classified as held-for-trading. The Fund classifies all the investments in derivatives into financial assets or financial liabilities at fair value through profit or loss category. Financial assets that are classified as receivables include other accounts receivable. Financial liabilities that are not at fair value through profit or loss include bank overdrafts and accrued expenses and other payables.

All derivatives in a net receivable position (positive fair value) are classified as financial assets held-for-trading and included in financial assets at fair value through profit or loss in the statement of assets and liabilities. All derivatives in a net payable position (negative fair value) are reported as financial liabilities held-for-trading and included in financial liabilities at fair value through profit or loss in the statement of assets and liabilities.

#### (ii) Recognition

The Fund recognises financial assets and financial liabilities on the date it becomes a party to the contractual provisions of the instruments.

A regular way purchase or sale of financial assets or financial liabilities at fair value through profit or loss is recognised on a trade date basis. From this date, any gains and losses arising from changes in fair value of the financial assets or financial liabilities at fair value through profit or loss are recorded.

Financial liabilities are not recognised unless one of the parties has performed their obligations under the contract or the contract is a derivative contract not exempted from the scope of HKAS 39.

#### (iii) Measurement

Financial instruments are measured initially at fair value (transaction price). Transaction costs on financial assets and liabilities at fair value through profit or loss are expensed immediately.

Subsequent to initial recognition, all instruments classified at fair value through profit or loss are measured at fair value with changes in their fair values recognised in profit or loss.

Financial assets classified as loans and receivables are carried at amortised cost using the effective interest rate method, less impairment losses, if any.

Financial liabilities, other than those at fair value through profit or loss, are measured at amortised cost using the effective interest rate method.

#### (iv) Fair value measurement principles

'Fair value' is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date in the principal or, in its absence, the most advantageous market to which the Fund has access at that date. The fair value of a liability reflects its non-performance risk.

The fair value of derivatives that are not exchange-traded is estimated at the amount that the Fund would receive or pay to terminate the contract at the date of statement of assets and liabilities based on the prevailing market conditions and the current creditworthiness of the counterparties.

Investments in forward contracts are recognised in the statement of assets and liabilities at fair value. The fair value of open positions in forward contracts is calculated as the difference between the contract price and the fair value of current market forward rate.

The Fund recognises transfers between levels of the fair value hierarchy as at the end of the reporting period during which the change has occurred.

Net gains and losses on investments in derivatives are included in profit or loss. Realised gains and losses on investments in derivatives and unrealised gains and losses on investments in derivatives arising from a change in fair value are provided in note 8.

#### (v) Impairment

Financial assets that are stated at cost or amortised cost are reviewed at each reporting date to determine whether there is objective evidence of impairment. If any such indication exists, an impairment loss is recognised in profit or loss as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

If in a subsequent period the amount of an impairment loss recognised on a financial asset carried at amortised cost decreases and the decrease can be linked objectively to an event occurring after the write-down, the write-down is reversed through profit or loss.

#### (vi) Derecognition

A financial asset is derecognised when the contractual rights to receive the cash flows from the financial asset expire, or where the financial asset together with substantially all the risks and rewards of ownership, have been transferred.

Assets held for trading that are sold are derecognised and corresponding receivables from brokers are recognised as of the date the Fund commits to sell the assets.

A financial liability is derecognised when the obligation specified in the contract is discharged, cancelled or expires.

On derecognition of a financial asset, the difference between the carrying value of the asset and the consideration received is recognised in profit or loss.

#### (vii) Offsetting

Financial assets and financial liabilities are offset and the net amount is reported in the statement of assets and liabilities when the Fund has a legally enforceable right to offset the recognised amounts and the transactions are intended to be settled on a net basis or simultaneously, e.g. through a market clearing mechanism.

#### (g) Related parties

- (a) A person, or a close member of that person's family, is related to the Fund if that person:
  - (i) has control or joint control over the Fund;
  - (ii) has significant influence over the Fund; or
  - (iii) is a member of the key management personnel of the Fund or the Fund's parent.
- (b) An entity is related to the Fund if any of the following conditions applies:
  - (i) The entity and the Fund are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
  - (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
  - (iii) Both entities are joint ventures of the same third party.
  - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
  - (v) The entity is a post-employment benefit plan for the benefit of employees of an entity related to the Fund.
  - (vi) The entity is controlled or jointly controlled by a person identified in (a).

- (vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).
- (viii) The entity, or any member of a group of which it is a part, provides key management personnel services to the Fund or to the Fund's Parent.

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

#### (h) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand form an integral part of the Fund's cash management and are included as a component of cash and cash equivalents for the purpose of the cash flow statement.

#### (i) Units in issue

The Fund classifies financial instruments issued as financial liabilities or equity instruments in accordance with the substance of the contractual terms of the instruments.

The Fund has one class of redeemable units in issue. This is the most subordinate class of financial instruments in the Fund and ranks *pari passu* in all material respects and has identical terms and conditions. The redeemable units provide investors with the right to require redemption for cash at a value proportionate to the investor's share in the Fund's net assets at each redemption date and also in the event of the Fund's liquidation.

A puttable financial instrument that includes a contractual obligation for the issuer to repurchase or redeem that instrument for cash or another financial asset is classified as equity instruments if it meets the following conditions:

- (i) it entitles the holder to a pro rata share of the entity's net assets in the event of the Fund's liquidation;
- (ii) it is in the class of instruments that is subordinate to all other classes of instruments;
- (iii) all financial instruments in the class of instruments that is subordinate to all other classes of instruments have identical features;
- (iv) apart from the contractual obligation for the Fund to repurchase or redeem the instrument for cash or another financial asset, the instrument does not include any other features that would require classification as a liability; and
- (v) the total expected cash flows attributable to the instrument over its life are based substantially on the profit or loss, the change in the recognised net assets or the change in the fair value of the recognised and unrecognised net assets of the Fund over the life of the instrument.

The Fund's redeemable units meet all of these conditions and are classified as equity.

#### (j) Segment reporting

An operating segment is a component of the Fund that engages in business activities from which they may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Fund's other components, whose operating results are reviewed regularly by the chief operating decision maker to make decisions about resources allocated to the segment and assess its performance, and for which discrete financial information is available. Segment results that are reported to the chief operating decision maker include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. The chief operating decision maker of the Fund is identified as the Manager, Hang Seng Investment Management Limited.

#### 3 Changes in accounting policies

The HKICPA has issued a number of amendments to HKFRSs that are first effective for the current accounting period of the Fund. Of these, the following developments are relevant to the Fund's financial statements.

- Annual Improvements to HKFRSs 2010-2012 Cycle
- Annual Improvements to HKFRSs 2011-2013 Cycle

None of these developments have had a material effect on how the Fund's results and financial position for the current or prior periods have been prepared or presented. The Fund has not applied any new standard or interpretation that is not yet effective for the current accounting period (see note 15).

#### 4 Taxation

No provision for Hong Kong Profits Tax has been made in the financial statements as the income of the Fund is exempt from taxation under Section 26A(1A) of the Hong Kong Inland Revenue Ordinance.

#### 5 Commodity

The value of commodity as of 31 December 2015 and 31 December 2014 is shown on page 14.

#### 6 Financial assets and financial liabilities at fair value through profit or loss

Financial assets and financial liabilities at fair value through profit or loss as of 31 December 2015 and 31 December 2014 are shown on page 14.

#### 7 Financial risk management

The Fund will acquire and hold gold bullion as dictated by its investment management strategy. To manage and hedge the foreign exchange rate movements between Renminbi and USD, the Fund will enter into a series of swaps with the swap counterparty.

The Fund's investing activities expose it to various types of risks that are associated with the commodity and derivatives and markets in which it invests. To comply with HKFRS 7, the Manager has set out below the most important types of financial risks inherent in the commodity and derivatives held by the Fund. The Manager would like to highlight that the following list of associated risks only sets out some of the risks but does not purport to constitute an exhaustive list of all the risks inherent in an investment in the Fund. Investors should note that additional information in respect of risks associated with the investment in the Fund can be found in the Fund's prospectus.

The nature and extent of the investments outstanding at the year end date and the risk management policies employed by the Fund are discussed below.

#### (a) Market risk

Market risk arises when the fair value and future cash flows of commodity and financial instruments will fluctuate because of changes in market prices and includes currency risk, interest rate risk and price risk.

#### (i) Currency risk

The gold bullion invested by the Fund is denominated in USD, while the Fund is denominated in Renminbi. The Fund enters into a series of swaps, so that the net asset value of the Fund in Renminbi will rise and fall by the same approximate percentages as the increases and decreases in the London Gold Fixing Price (before 20 March 2015) and the LBMA Gold Price AM (with effect from 20 March 2015) which is denominated in USD. There can be no guarantee that all such foreign exchange risk can be fully eliminated, however, the Fund's exposure to a foreign exchange risk is greatly reduced.

#### (ii) Interest rate risk

Interest rate risk arises from changes in interest rates which may inversely affect the value of interest bearing assets and therefore results in potential gain or loss to the Fund. Except for bank deposits, all the commodity, financial assets and financial liabilities of the Fund are non-interest bearing. As a result, the Fund has limited exposure to interest rate risk.

#### (iii) Price risk

Price risk is the risk that the value of a financial instrument will fluctuate as a result of changes in market prices (other than those arising from interest rate risk or currency risk), whether caused by factors specific to an individual investment, its issuer or all factors affecting all instruments traded in the market.

The Fund is not actively managed. Regardless of its investment merit, the Manager does not attempt to select other commodities or precious metals or to take defensive positions in declining markets. Hence, any fall in the LBMA Gold Price AM will result in a corresponding fall in the value of the Fund.

Major investments of the Fund are gold bullion. The Fund estimates the future reasonably possible market price fluctuations for gold on an overall basis. It is estimated that a reasonably possible strengthening in the LBMA Gold Price AM of 20% (2014: 20%) at 31 December 2015 would increase the net assets attributable to unitholders by RMB 10,477,486 (2014: RMB 14,710,146); an equal change in the LBMA Gold Price AM in the opposite direction would decrease the net assets attributable to unitholders by an equal but opposite amount. The analysis assumes that all other variables, in particular, interest rates remain constant.

#### (b) Credit risk

#### (i) Analysis of credit risk management policy and concentration of credit risk

Credit risk arises if a gold dealer or a participating dealer fails to deliver or instruct a credit or allocation of gold bullion and in the event of an insolvency or default by the swap counterparty upon settlement. Risk relating to unsettled transactions is considered small due to the short settlement period involved and the high quality of the gold dealer, participating dealer and swap counterparty. The Manager monitors the credit rating and financial positions of the gold dealer, participating dealer and the swap counterparty to further mitigate this risk.

HSBC Institutional Trust Services (Asia) Limited is the Trustee of the Fund. Bankruptcy or insolvency of the Trustee may cause the Fund's rights with respect to the assets to be delayed or limited. The Manager monitors the credit quality of the Trustee by performing due diligence annually.

HSBC Bank plc replaced HSBC Bank USA as the custodian of the Fund with effect from 16 February 2015. During the year ended 31 December 2015, all of the investments of the Fund are held by HSBC Bank plc (the "Custodian") and HSBC Bank USA (2014: all of the investments of the Fund were held by HSBC Bank USA). Bankruptcy or insolvency of the Custodian may cause the Fund's rights with respect to investments held by the Custodian to be delayed or limited. The Manager monitors the risk by monitoring the credit rating of the Custodian on an on-going basis.

All of the cash held by the Fund is deposited with Hang Seng Bank Limited ("HSB") and The Hongkong and Shanghai Banking Corporation Limited ("HSBC") (collectively the "Banks"). Bankruptcy or insolvency of the Banks may cause the Fund's rights with respect to the cash held by the Banks to be delayed or limited. The Manager monitors its risk by monitoring the credit rating of the Banks on an on-going basis.

Other than outlined above, there were no significant concentrations of credit risk to counterparties at 31 December 2015 and 31 December 2014.

#### (ii) Offsetting financial assets and financial liabilities

None of the financial assets and financial liabilities is offset in the statement of assets and liabilities. The disclosures set out in the table on page 15 include financial assets and financial liabilities that are subject to an enforceable master netting arrangement.

The enforceable master netting arrangements do not meet the criteria for offsetting in the statement of assets and liabilities. This is because they create a right of set-off of recognised amounts that is enforceable only following on event of default, insolvency or bankruptcy of the Fund or its counterparties. In addition, the Fund and its counterparties do not intend to settle on a net basis or to realise the assets and settle the liabilities simultaneously.

The gross amounts of recognised financial assets and financial liabilities and their net amounts presented in the statement of assets and liabilities disclosed in the table on page 15 have been measured in the statement of assets and liabilities at fair value.

#### (c) Liquidity risk

Liquidity risk is the risk that the Fund will encounter difficulty in meeting obligations arising from its financial liabilities that are settled by delivering cash or another financial asset, or that such obligations will have to be settled in a manner disadvantageous to the Fund.

The Fund's policy and the Manager's approach to manage liquidity is to have sufficient liquidity to meet its liability including estimated redemption of units, as and when due, without incurring undue losses or risking damage to the Fund's reputation.

The Fund's prospectus provides for the daily creation and redemption of units and it is therefore exposed to the liquidity of meeting unitholder redemptions daily. All other financial liabilities are repayable on demand or have contractual maturities less than three months.

The Fund's majority of investments are gold bullion which is considered to be readily realisable. As a result, the Fund is able to liquidate quickly some of its investments in order to meet its liquidity requirements. However, for other investments including derivatives which are traded over-the-counter and may not be able to liquidate quickly, they are exposed to certain degree of liquidity risks.

The Fund's liquidity risk is managed on a daily basis by the Manager in accordance with the policies and procedures in place. The Fund's redemption policy allows redemption to be made through participating dealers by any investor with gold and a minor cash component or wholly with cash at a minimum of 300,000 units.

The Manager has the right to declare suspension of unitholders' right to redeem units under certain conditions, such as when the London bullion market is closed; dealings on the London bullion market are restricted or suspended; or the LBMA Gold Price AM is not published or available, etc. in accordance with the Fund's prospectus.

#### (d) Derivatives

The table which states the Fund's holdings in derivatives as of the year end date translated into its reporting currency is shown on page 16.

#### (e) Capital management

The Fund's capital as at the year end date is represented by its redeemable units.

The Fund's objective in managing the capital is to ensure a stable and strong base to maximise returns to all investors, and to manage liquidity risk arising from the redemptions. The Manager manages the capital of the Fund in accordance with the Fund's investment objectives and policies stated in the Fund's prospectus.

There were no changes in the policies and procedures during the year with respect to the Fund's approach to its capital management.

The Fund is not subject to externally imposed capital requirements.

The amount and the movement of equity are stated in the statement of changes in equity. As the redeemable units are redeemed on demand at the unitholders' option, the actual level of redemption may differ significantly from the historic experience.

#### 8 Net (losses)/gains on commodity and net losses on derivatives

During the year, the Fund disposed of gold bullion and derivatives, and earned or incurred realised and unrealised gains and losses as shown on page 16.

#### 9 Transactions with related parties

The following is a summary of transactions with related parties during the year which were entered into in the ordinary course of business and under normal commercial terms. To the best of the knowledge of the Trustee and the Manager, the Fund did not have any other transactions with their related parties except for those disclosed below. The relevant receivables and payables are unsecured, interest-free and repayable on demand:

- (a) Hang Seng Investment Management Limited ("HSIM"), a wholly-owned subsidiary of HSB, which is a member of the HSBC Group, is the Manager of the Fund. HSIM earns management fees at a rate of 0.15% of net asset value per annum. Management fees are calculated as at each dealing day and payable monthly. Management fees payable to the Manager at the year end date is RMB 6,680 (2014: RMB 9,994).
- (b) HSBC Institutional Trust Services (Asia) Limited is the Trustee and the Registrar of the Fund and earns trustee fee and registrar fee at a rate of 0.12% of net asset value per annum, subject to a minimum monthly fee of RMB 30,000 per month for the first 18 months after the Fund launched and RMB 65,000 per month from the 19th month onwards. The trustee fee and registrar fee are calculated as at each dealing day and payable monthly. Trustee fee and registrar fee payable at the year end date is RMB 66,783 (2014: RMB 75.969).

The Trustee also earns a service fee of RMB 21,000 (2014: RMB 21,000) per annum. Service fees are calculated as at each dealing day and payable quarterly. Service fees payable at the year end date is RMB 9,200 (2014: RMB 1,898).

In addition, the Trustee earns processing fee of RMB100 (2014: RMB 100) for handling each purchase or sale of investments.

- (c) The Fund utilised the services of HSB in its purchase and sale of investments. Details of such transactions executed are shown on page 16. No commission was paid to HSB for these transactions during the year.
- (d) Effective from 16 February 2015, HSBC Bank plc replaced HSBC Bank USA as the Custodian of the Fund and earns custodian's fee at a rate of 0.06% and 0.1% of the outstanding credit balance on allocated gold account and unallocated gold account respectively per annum. The change in the Custodian resulted in no adjustment to the rate of custodian's fee. Custodian's fee is calculated as at each dealing day and payable monthly. Custodian's fee paid during the year is RMB 36,744 (2014: RMB 48,073. The Fund also paid bank charges of RMB 315 (2014: nil) to HSBC Bank USA during the year. Custodian's fee payable at the year end date is RMB 13,557 (2014: RMB 10,713).
- (e) All bank accounts are maintained with HSBC and HSB. The respective bank balances at the year end date are RMB 3,253 (2014: RMB 31,410) and RMB 76,122 (2014: RMB 196,387). There is no bank overdraft in Hong Kong Dollar bank account maintained at HSB at the year end date (2014: RMB 133). During the year, the Fund paid interest expenses to HSB amounted to RMB 1 (2014: nil) for such Hong Kong Dollar bank account.
- (f) HSB provided unsecured overdraft facility, risk weighted FX facility / interest rate swap facility and daily settlement facility to the Fund. The details of the facilities, the annual fee and interest expenses recognised in the profit or loss are shown on page 17.
- (g) The Fund entered into foreign currency forward contracts and asset swap contracts with HSB to hedge against the foreign exchange rate movements between Renminbi and USD. Financial assets arising from outstanding foreign currency forward contracts at the year end date are RMB 19,968 (2014: RMB 13.690) and financial liabilities arising from outstanding asset swap contracts at the year end date are RMB 253 (2014: RMB 265).

#### 10 Units in issue

For the movement of units in issue, please refer to page 17.

The Fund did not have units issued or redeemed during the year ended 31 December 2014.

#### 11 Bank overdrafts

Bank overdrafts were unsecured and repayable on demand.

#### 12 Soft dollar commission

As regards to the Fund, the Manager has not entered into any soft dollar commission arrangements with brokers.

#### 13 Fair value information

The Fund's commodity and derivatives investments are measured at fair value on the date of the statement of assets and liabilities. Fair value estimates are made at a specified point in time, based on market conditions and information about the commodity and derivatives investments. With the involvement of unobservable factors and judgement, fair value can be reliably determined within a reasonable range of estimates. For certain other financial instruments, including other accounts receivable, cash and cash equivalents, bank overdrafts and accrued expenses and other payables, the carrying amounts approximate fair value due to the intermediate or short-term nature of these financial instruments.

#### Valuation of financial instruments

The Fund's accounting policy on fair value measurements is detailed in accounting policy in note 2(f)(iv).

The Fund measures fair values using the following fair value hierarchy that reflects the significance of the inputs used in making the measurements.

- Level 1: Inputs that are quoted market prices (unadjusted) in active markets for identical instruments.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable either directly (i.e. as prices) or indirectly (i.e. derived from prices). The category includes instruments valued using: quoted market price in active markets for similar instruments; quoted prices for identical or similar instruments in markets that are considered less than active; or other valuation techniques in which all significant inputs are directly or indirectly observable from market data.
- Level 3: Inputs that are unobservable. This category includes all instruments for which the valuation technique includes inputs not based on observable data and the unobservable inputs have a significant effect on the instrument's valuation. This category includes instruments that are valued based on quoted prices for similar instruments but for which significant unobservable adjustments or assumptions are required to reflect differences between the instruments.

Fair values of derivatives are determined by valuation techniques. For all other financial instruments, their carrying amounts approximate fair value due to the intermediate or short-term nature of these financial instruments.

For investments held by the Fund that are grouped into Level 2, the Fund uses widely recognised valuation models where all significant inputs are directly or indirectly observable from market data in determining the fair value. The valuation of these common and simple financial instruments uses only observable market data and require little management judgement and estimation.

Valuation techniques include net present value and discounted cash flow models, comparison to similar instruments for which market observable prices exist, Black-Scholes and polynomial option pricing models and other valuation models. Assumptions and inputs used in valuation techniques include risk-free and benchmark interest rates, credit spreads and other premia used in estimating discount rates, bond and equity prices, foreign currency exchange rates, equity and equity index prices and expected price volatilities and correlations.

The objective of the valuation techniques is to arrive at a fair value measurement that reflects the price that would be received to sell the asset or paid to transfer the liability in an orderly transaction between market participants at the measurement date.

Observable prices and model inputs are usually available in the market for simple over-the-counter securities. Availability of observable market prices and model inputs reduces the need for management judgement and estimation and also reduces the uncertainty associated with determination of fair values. Availability of observable market prices and inputs varies depending on the products and markets and is prone to changes based on specific events and general conditions in the financial markets.

For more complex instruments, the Fund uses proprietary valuation models, which are usually developed from recognised valuation models. Some or all of the significant inputs into these models may not be observable in the market, and are derived from market prices or rates or are estimated based on assumptions. Examples of instruments involving significant unobservable inputs include certain over-the-counter derivatives. Valuation models that employ significant unobservable inputs require a higher degree of management judgement and estimation in the determination of fair value. Management judgement and estimation are usually required for selection of the appropriate valuation model to be used, determination of expected future cash flows on the financial instrument being valued, determination of probability of counterparty default and selection of appropriate discount rates.

The tables on page 18 present the carrying value of commodity and derivatives investments measured at fair value at the date of the statement of assets and liabilities across three levels of fair value hierarchy.

During the year, there is sufficient information available to measure the fair value of the asset swap contracts based on the valuation models where all significant inputs are directly or indirectly observable from market data in determining the fair value. Therefore, the asset swap contracts are grouped into Level 2.

Although the Fund believes that their estimates of fair value are appropriate, the use of different methodologies or assumptions could lead to different measurements of fair value.

There were no transfers of financial instruments between Level 1 and Level 2, or transfers into or out of Level 3 during the year.

#### 14 Segment information

The Manager makes strategic resource allocation on behalf of the Fund and determines operating segments based on internal reports reviewed which are used to make strategic decisions.

The Manager considers that the Fund has one single operating segment based on one single integrated investment strategy by investing in gold bullion and derivatives with the objective to match, before expenses, as closely as practicable, the performance of the LBMA Gold Price AM in USD as stipulated in the Fund's prospectus. There were no changes in the operating segment during the year.

Major revenues generated by the Fund are from gold bullion. The segment information provided to the Manager is the same as that disclosed in the statement of comprehensive income and statement of assets and liabilities.

The Fund is domiciled in Hong Kong. Majority of the Fund's investment income is from gold bullion traded in London bullion market.

#### 15 Possible impact of amendments and new standards issued but not yet effective for the year ended to 31 December 2015

Up to the date of issue of these financial statements, the HKICPA has issued a number of amendments and new standards which are not yet effective for the year ended 31 December 2015 and which have not been adopted in these financial statements.

Of these developments, the following relates to matters that may be relevant to the Fund's operations and financial statements:

Effective for accounting periods beginning on or after

1 January 2016

Amendments to HKAS1, Disclosure initiative HKFRS 9, Financial instruments

1 January 2018

The Fund is in the process of making an assessment of what the impact of these amendments and new standard is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the Fund's results of operations and financial position.


