At the annual general meeting of Yan Tat Group Holdings Limited (the “**Company**”) held on Wednesday, 25 May 2016 (“**AGM**”), a poll was demanded by the chairman of the board of directors of the Company for voting on all the resolutions as set out in the notice of AGM dated 22 April 2016.

As at the date of the AGM, the issued share capital of the Company was 240,000,000 shares, which was the total number of shares entitling the holders to attend and vote on the resolutions at the AGM. The total number of shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM only is nil. No shareholders are required to abstain from voting at the AGM. The total number of shares held by the shareholders or their proxy(ies) who have attended the AGM and are entitled to vote is 180,040,200 shares, representing approximately 75.02% of the total issued shares as at the date of this announcement.

The Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. All the ordinary resolutions were duly passed and details of the poll results are as follows:
