Before that, he was the chief financial officer of Coolsand Technologies Limited from 2009 to 2015; he was a consultant of Yeton Venture Limited from 2008 to 2009; he was the executive director and chief financial officer of Wanji Group Limited from 2001 to 2007; he worked as financial controller in Whirlpool Home Appliance Co. Ltd. from 1995 to 2001; he worked as regional controller in Amphenol East Asia Limited from 1986 to 1995; and he also

worked for Fairchild Semiconductor (HK) Ltd. from 1978 to 1986 first as accountant and subsequently as cost accounting manager. Mr. Lam obtained a diploma in accounting and business management from Hong Kong Baptist University in 1978.

Save as disclosed above, Mr. Lam has not previously held any position with the Company and its subsidiaries. He has not held directorships in the last three years preceding the date of this announcement in public companies the securities of which are listed on any securities market in Hong Kong or overseas, and does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company.
