- To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy thereof, must be deposited at the office of the Company's branch registrar in Hong Kong (Tricor Abacus Limited, Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong) as soon as possible and in any event not later than 48 hours before the time for holding the meeting or adjourned meeting or poll (as the case may be).
- The proxy need not be a member of the Company but must attend the meeting in person to represent you.
- Any alteration made to this form of proxy must be initialled by the person who signs it.
