Terms defined in the Relevant Announcements shall have the same meaning in this joint announcement, unless the context otherwise requires.

This joint announcement is made by CCT Land pursuant to Chapter 14 and Chapter 14A of the Listing Rules and Rule 25 of the Takeovers Code and by CCT Fortis pursuant to Chapter 14 of the Listing Rules.

For CCT Land

As additional time is required to, among others, update information to the latest practicable date and prepare and finalise the information for inclusion in the CCT Land Circular, the despatch date of the CCT Land Circular will be further postponed to a date falling on or before 27 September 2016.

For CCT Fortis

As stated in the Relevant Announcements, a circular of CCT Fortis containing, amongst other information, further details of the Agreement and the Transaction and other information required to be disclosed under the Listing Rules, will be despatched to the CCT Fortis Shareholders on or before 23 September 2016. As additional time is required to clarify the basis for CCT Fortis to enter into the Second Supplemental Manufacturing Agreement, update information to the latest practicable date and prepare and finalise the information for inclusion in the circular of CCT Fortis, CCT Fortis has applied to the Stock Exchange for a waiver from strict compliance with Rule 14.41(a) of the Listing Rules and the despatch date of the circular of CCT Fortis will be further postponed to a date falling on or before 27 September 2016.
