POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 29 SEPTEMBER 2016

The Board is pleased to announce that all the resolutions set out in the Notice of the AGM were duly passed by way of poll by the Shareholders at the AGM held on 29 September 2016.

Reference is made to the notice of the annual general meeting (“**AGM**”) dated 29 August 2016 (the “**Notice**”) of Ban Loong Holdings Limited (the “**Company**”), the circular dated 29 August 2016 issued by the Company (the “**Circular**”). Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE ANNUAL GENERAL MEETING

The Board is pleased to announce that all the resolutions set out in the Notice (the “**Resolutions**”) were duly passed by way of poll by the Shareholders at the AGM held on 29 September 2016.

As at the date of AGM, the total number of the issued shares of the Company was 2,670,663,200, which was the total number of Shares entitling the Shareholders to attend and vote for or against the Resolutions at the AGM. There were no restrictions on any Shareholders to cast votes on any of the Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. There were no Shareholders who are required under the Listing Rules to abstain from voting at the AGM.
