5. You must be outside the United States, not be a United States Person (as defined in Regulation S) and not be a legal or natural person of the PRC.

Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Thursday, 6 October 2016, and in any event, not later than Thursday, 6 October 2016. Applicants are required to pay the maximum Offer Price of HK\$0.70 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Joint Lead Managers (for themselves and on behalf of the Joint Bookrunners and the other Underwriters) and the Company by Thursday, 6 October 2016, the Share Offer will not proceed. Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
