**ANNOUNCEMENT  
POWER GENERATION FOR NOVEMBER 2016**

This announcement is made by Huaneng Renewables Corporation Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) regarding inside information to provide shareholders of the Company and the public with the business data of the Company.

Huaneng Renewables Corporation Limited (the “**Company**”) announces that, according to the Company’s preliminary statistics, the gross power generation of the Company for November 2016 amounted to 1,996,073.4 MWh, representing an increase of 32.6% as compared with November 2015. In particular, wind power generation amounted to 1,918,834.7 MWh, representing an increase of 32.4% as compared with November 2015, and solar power generation amounted to 77,238.7 MWh, representing an increase of 39.0% as compared with November 2015. The gross power generation of the Company for the eleven months ended 30 November 2016 amounted to 17,564,190.9 MWh, representing an increase of 32.4% as compared with the eleven months ended 30 November 2015. In particular, wind power generation amounted to 16,635,127.0 MWh, representing an increase of 32.9% as compared with the eleven months ended 30 November 2015, and solar power generation amounted to 929,063.9 MWh, representing an increase of 23.9% as compared with the eleven months ended 30 November 2015.
