主席報告

CHAIRMAN'S STATEMENT

本人謹代表迅捷環球控股有限公司(「本公司」)董事(「董事」)會(「董事會」)欣然提呈本公司及其附屬公司(統稱「本集團」或「迅捷環球」)截至二零一六年十二月三十一日止年度經審核綜合業績。

業務概覽

回顧年內，本集團收益減少至約1,088,200,000港元，較二零一五年下跌約11.1%；而權益持有人年內應佔溢利則增至約31,500,000港元，較二零一五年上升約27.0%。

服裝供應鏈服務業務

本集團依然以向多家全球知名品牌擁有人或代理提供廣泛的梭織衣服及剪裁針織產品的服裝供應鏈服務業務(「服裝供應鏈服務業務」)為核心業務。於二零一六年，服裝供應鏈服務業務的收益約為1,088,200,000港元(二零一五年：1,215,900,000港元)，而服裝供應鏈服務業務的應佔分部溢利(扣除其他收益／虧損一淨額、融資成本淨額及所得稅開支前)則較二零一五年減少24.6%至約48,100,000港元(二零一五年：63,800,000港元)。年內成衣業仍然面對重重困難。為配合我們專注於產品設計與開發、品質控制及生產管理優勢的策略，我們因應客戶不斷轉變的喜好，設計、開發及生產男女裝梭織衣服及剪裁針織產品。由於服裝零售市場衰退，故年內服裝供應鏈服務業務的收益減少。

On behalf of the board (the "Board") of the directors (the "Directors") of Speedy Global Holdings Limited (the "Company"), I am pleased to present the audited consolidated results of the Company and its subsidiaries (collectively referred to as the "Group" or "Speedy Global") for the year ended 31 December 2016.

BUSINESS OVERVIEW

For the year under review, the Group's revenue decreased to approximately HK\$1,088.2 million, representing a decrease of approximately 11.1% in comparison to that of the year 2015, while profit for the year attributable to equity holders increased to approximately HK\$31.5 million, representing an increase of approximately 27.0% as compared to that of the year 2015.

Apparel Supply Chain Servicing Business

The apparel supply chain servicing business which offers a wide range of woven wear and cut-and-sewn knitwear products to a number of owners or agents of global reputable brands (the "Apparel Supply Chain Servicing Business") continued to be the core business of the Group. For the year 2016, revenue under Apparel Supply Chain Servicing Business was approximately HK\$1,088.2 million (2015: HK\$1,215.9 million) and segment profit (before other gains/losses-net, net finance costs and income tax expense) attributable to Apparel Supply Chain Servicing Business decreased by 24.6% to approximately HK\$48.1 million (2015: HK\$63.8 million) when comparing to the year 2015. During the year, the garment industry remained challenging. Being in line with our strategy to focus on our strengths in product design and development, as well as quality control and production management, we design, develop and produce men's and women's woven wear and cut-and-sewn knitwear products to respond to constantly evolving consumer preferences. Due to the depression in the apparel retail market, revenue under the Apparel Supply Chain Servicing Business decreased during the year.

CHAIRMAN'S STATEMENT

服裝零售業務

本集團亦主要從事於中國以Unisex自營品牌及Promod品牌分銷權經營服裝零售業務(「服裝零售業務」)。由於Unisex及Promod品牌的銷售表現未如理想，故其業務已於二零一五年五月底終止。因此，年內並無自服裝零售業務產生任何收益或毛利(二零一五年：收益7,900,000港元及毛利2,100,000港元)，且年內僅產生有限的開支。二零一六年分部虧損(扣除其他收益／虧損一淨額、融資成本淨額及所得稅開支前)較二零一五年減少98.4%至約300,000港元(二零一五年：18,400,000港元)。

物業投資及發展業務

本集團亦從事物業投資及發展(「物業投資及發展業務」)。本集團過往一直致力開發中國河南省鄭州新密市人和路以東、勞動街以南、興業路以西及花園街以北兩幅地塊，以及中國河南省鄭州新密市興業路以東、勞動街以南、楊莊路以西及花園街以北一幅地塊，均為工業用途。本公司於二零一六年七月十五日宣布，本公司與買方已訂立協議，據此，本公司已有條件同意出售及買方已有條件同意購買Speedy Global Development Limited(「目標公司」，一間於英屬處女群島註冊成立的公司)已發行總股本的50%，代價為現金10港元。目標公司及其附屬公司(「目標集團」)主要於新密市從事上述地塊的物業開發及投資。董事會認為，出售目標集團令本集團避免與工業物業投資有關的風險及不明朗因素，包括但不限於人民幣呈貶值趨勢及中國國內生產總值與中國河南省產業附加值的增長趨勢減慢。於二零一六年九月初完成該出售後，本公司不再於目標集團持有任何權益。於二零一六年並無產生收益，僅產生開支。

Apparel Retail Business

The Group also principally engaged in the apparel retail business operating under the in-house brand of Unisex and under the distribution right of Promod brand in the PRC (the "Apparel Retail Business"). Due to the unsatisfactory sales performance of the Unisex and Promod brands, their operations ceased by the end of May 2015 accordingly. Therefore, there was neither revenue nor gross profit generated from our Apparel Retail Business during the year (2015: revenue of HK\$7.9 million and gross profit of HK\$2.1 million) and only limited expenses were incurred during the year. Segment loss (before other gains/losses-net, net finance costs and income tax expense) decreased by 98.4% in 2016 to approximately HK\$0.3 million (2015: HK\$18.4 million) when comparing to the year 2015.

Property Investment and Development Business

The Group also engaged in the property development and investment (the "Property Investment and Development Business"). The Group was progressing diligently with the development of two pieces of land in the east of Renhe Road, south of Laodong Street, west of Xingye Road and north of Fayuan Street, Xinmi City, Zhengzhou, Henan Province, PRC and one piece of land in the east of Xingye Road, south of Laodong Street, west of Yangzhan Road and north of Fayuan Street, Xinmi City, Zhengzhou, Henan Province, PRC, all of which are for industrial use. The Company announced on 15 July 2016 that the Company and the purchaser have entered into the agreement pursuant to which the Company had conditionally agreed to sell and the purchaser had conditionally agreed to purchase 50% of the total issued share capital of Speedy Global Development Limited (the "Target"), a company incorporated in the British Virgin Islands, at the consideration of HK\$10 in cash. The Target and its subsidiaries (the "Target Group") are principally engaged in the property development and investment for the land above-mentioned at Xinmi City. The Board considered that the disposal of the Target Group enables the Group to avoid the risks and uncertainties associated with the investments in industrial properties, including but not limited to the depreciation trend in Renminbi and decreasing trend in growth for both gross domestic production in the PRC and the industrial added value in Henan province, the PRC. After the completion of the disposal in early September 2016, the Company no longer held any interest in the Target Group. No revenue was generated and only expenses was incurred during the year 2016.

CHAIRMAN'S STATEMENT

前景展望

展望未來，我們預期，由於競爭激烈，二零一七年服裝供應鏈服務業務的營商環境仍充滿挑戰。為保持競爭優勢，本集團將繼續加強產品創新及提升創意，以緊貼時裝潮流及維持優良品質。生產管理方面，本集團將繼續透過簡化生產過程提高營運效率，從而縮短產品付運時間。此外，本集團將與客戶緊密合作，合併生產以取得更優惠價格大量採購物料，提升我們的成本競爭力。本集團向現有客戶提供具有競爭力的價格及較具彈性的安排，以爭取更多長期及承諾訂單，並積極物色新客戶，以爭取更多增長機會。

由於中國零售市道仍然疲弱，因此我們於拓展零售業務方面持審慎態度。我們將保留資金及尋找其他盈利能力更佳的零售業務機會。

於完成出售目標集團後，我們不再於目標集團持有任何權益，而目標集團亦不再為本公司的附屬公司。我們會繼續密切注視物業市場，並為本集團的物業投資及發展業務釐定合適的發展策略。倘我們相信可藉此擴大本集團股東回報，則我們將物色合適物業投資及發展項目。

FUTURE PROSPECTS

Looking forward, we expect the business environment of our Apparel Supply Chain Servicing Business keeps challenging in the year 2017 due to keen competition. In order to maintain our competitiveness, the Group will enhance product innovation and creativity to meet fashion trends and maintain premium quality. For production management, the Group will continue to enhance the operating efficiency by simplifying the production processes which results in a shorter product delivery time. In addition, the Group will work closely with our customers to consolidate the fabrication in order to obtain better material prices with mass volume which will enhance our cost competitiveness. The Group is offering a competitive price with higher flexibility arrangements to our existing customers in order to secure more long term and committed orders and is also actively looking for new customers for further growth opportunities.

As the retail sentiment in the PRC remains weak, we adopt a cautious approach in developing the retail business. We retain capital and are looking for other retail business opportunity with a better profitability.

After the completion of the disposal of the Target Group, we no longer held any interest in the Target Group which ceased to be a subsidiary of the Company. We are still closely monitoring the property market and determine the appropriate development strategy for the Group's Property Investment and Development Business. We will seek any appropriate property investment and development project if we believe that it can magnify the Group's shareholders' return.

Last but not least, I would like to take this opportunity to extend my sincere gratitude to all fellow directors, management and our staff for their unwavering dedication and contribution to our Group's development. I would also like to thank all of our shareholders, for their trust and continuous support over a challenging but rewarding year 2016.

MANAGEMENT DISCUSSION AND ANALYSIS

業務回顧

本集團專注於提供服裝供應鏈服務，包括產品設計及開發、確認時裝潮流及起辦、採購原材料、管理生產訂單及採購商品、品質監控、包裝、存貨管理及物流管理，向客戶提供一站式解決方案。於服裝供應鏈服務業務中，我們將勞工密集的生產工序外判予第三方製造商，以便集中向客戶提供一站式解決方案，以配合彼等的不同需要。

此外，本集團亦從事服裝零售業務，主要專注於採購、營銷及零售「Unisex品牌」及「Promod品牌」的男裝及配飾產品。由於「Unisex品牌」及「Promod品牌」的銷售表現未如理想，有關業務已於二零一五年五月底前停止運作。

本集團亦從事物業投資及發展業務以開拓相關市場，並積極發展三幅位於新密市的工業用地塊。本公司於二零一六年七月十五日公布，本公司與買方已訂立協議，據此，本公司已有條件同意出售及買方（由本公司主席、執行董事兼控股股東黃志深先生全資實益擁有）已有條件同意購買目標公司已發行總股本的50%，代價為現金10港元。目標集團主要於新密市從事上述地塊的物業開發及投資。董事會認為，出售目標集團令本集團避免與工業物業投資有關的風險及不明朗因素，包括但不限於人民幣呈貶值趨勢及中國國內生產總值與中國河南省產業附加值的增長趨勢減慢。於二零一六年九月初完成該出售後，本公司不再於目標集團持有任何權益。

Under our Apparel Supply Chain Servicing Business, we outsource the labor-intensive manufacturing function to third-party manufacturers and focus on providing one-stop solution to our customers to accommodate their different needs.

Furthermore, the Group also engaged in the Apparel Retail Business which mainly focused on procuring, marketing and retailing men's and women's apparel and accessory products under the Unisex and Promod brands. Due to the unsatisfactory sales performance of the Unisex and Promod brands, their operations ceased by the end of May 2015 accordingly.

The Group also engaged in the Property Investment and Development Business to develop the relevant market and was progressing diligently with the development of the three pieces of land in Xinmi City, all of which are for industrial use. The Company announced on 15 July 2016 that the Company and the purchaser, a wholly and beneficially owned by Mr. Huang Chih Shen, chairman, executive Director and controlling shareholder of the Company, have entered into the agreement pursuant to which the Company had conditionally agreed to sell and the purchaser had conditionally agreed to purchase 50% of the total issued share capital of the Target, at the consideration of HK\$10 in cash. The Target Group is principally engaged in the property development and investment for the land above-mentioned at Xinmi City. The Board considered that the disposal of the Target Group enables the Group to avoid the risks and uncertainties associated with the investments in industrial properties, including but not limited to the depreciation trend in Renminbi and decreasing trend in growth for both gross domestic production in the PRC and the industrial added value in Henan province, the PRC. 服裝供應鏈服務業務

為配合我們專注於產品設計與開發、品質監控及生產管理優勢的策略，我們因應客戶不斷轉變的喜好，設計、開發及生產男女梭織衣服及剪裁針織產品。年內，我們向客戶提供多項服裝產品設計，深受客戶歡迎。然而，由於服裝零售市場不景，二零一六年服裝供應鏈服務業務的收益減少10.5%至約1,088,200,000港元（二零一五年：1,215,900,000港元）。

二零一六年服裝供應鏈服務業務的毛利減少14.2%至約114,000,000港元（二零一五年：132,800,000港元），而毛利率降至10.5%，較去年下跌0.4個百分點（二零一五年：10.9%）。毛利率輕微下跌主要由於二零一六年作出存貨減值撥備約5,600,000港元。

於二零一六年，我們錄得扣除其他虧損 — 淨額、融資成本淨額及所得稅開支前分部溢利約48,100,000港元，較二零一五年約63,800,000港元減少約24.6%。分部溢利減少主要由於二零一六年收益減少。

Apparel Supply Chain Servicing Business

Being in line with our strategy to focus on our strengths in product design and development, as well as quality control and production management, we design, develop and produce men's and women's woven wear and cut-and-sewn knitwear products to respond to constantly evolving consumer preferences. During the year, we have provided many designs of apparel products to our customers and our designs are well appreciated by our customers. However, due to the depression in the apparel retail market, revenue under the Apparel Supply Chain Servicing Business decreased by 10.5% to approximately HK\$1,088.2 million during the year 2016 (2015: HK\$1,215.9 million).

Gross profit under our Apparel Supply Chain Servicing Business decreased by 14.2% to approximately HK\$114.0 million (2015: HK\$132.8 million) while gross profit margin decreased to 10.5% for the year 2016, representing a decrease of 0.4 percentage point when compared with the preceding year (2015: 10.9%). The slight decrease in gross profit margin was mainly due to the allowance for inventory impairment of approximately HK\$5.6 million provided during the year 2016.

During the year 2016, we recorded a segmental profit before other losses — net, net finance costs and income tax expense of approximately HK\$48.1 million, represented a decrease of approximately 24.6% compared to that of approximately HK\$63.8 million for 2015. The decrease in the segmental profit was mainly due to the decrease in revenue during the year 2016.

服裝零售業務

二零一六年服裝零售業務並無錄得任何收益或毛利(二零一五年：收益7,900,000港元及毛利2,100,000港元)，並僅產生有限開支，此乃由於二零一五年五月底前關閉「Unisex品牌」及「Promod品牌」旗下所有零售店，導致二零一六年扣除其他虧損—淨額、融資成本淨額及所得稅開支前分部虧損減少約98.4%(二零一六年：300,000港元；二零一五年：18,400,000港元)。

物業投資及發展業務

二零一六年物業投資及發展業務並無錄得任何收益或毛利，並僅產生開支。由於在二零一六年出售目標集團，已產生出售相標集團收益約5,400,000港元，而目標集團所產生開支(扣除出售目標集團收益)重新分類為綜合全面收益表項下已終止經營業務之年內虧損。

銷售開支

銷售開支主要指二零一六年產生的宣傳開支及運費。二零一六年銷售開支大幅減少86.7%至約2,300,000港元(二零一五年：17,300,000港元)，主要由於(i)自營零售門店租金；(ii)銷售人員的僱員福利開支；及(iii)提早終止零售店租賃協議的罰款減少。所有開支均由服裝零售業務於二零一五年產生。二零一六年並無產生有關開支。

行政開支

行政開支主要指管理、財務及行政人員的僱員福利開支、應酬開支、辦公室物業租金開支及出差開支。二零一六年行政開支減少10.9%至約65,100,000港元(二零一五年：73,100,000港元)，主要由於二零一六年成本控制得宜，以及並無作出呆賬撥備(二零一五年：4,000,000港元)。

Apparel Retail Business

There was neither revenue nor gross profit from our Apparel Retail Business (2015: revenue of HK\$7.9 million and gross profit of HK\$2.1 million) and only limited expenses were incurred during the year 2016 due to the closure of all the retail shops for the Unisex and Promod brands before the end of May 2015, which resulted in a decrease in the segmental loss before other losses — net, net finance costs and income tax expense of approximately 98.4% during the year 2016 (2016: HK\$0.3 million; 2015: HK\$18.4 million).

Property Investment and Development Business

There was neither revenue nor gross profit from our Property Investment and Development Business and only expenses were incurred during the year 2016. Due to the disposal of the Target Group during the year 2016, a gain on disposal of the Target Group of approximately HK\$5.4 million was generated and the expenses incurred by the Target Group net with the gain on disposal of the Target Group were reclassified as losses for the year from discontinued operations in the consolidated statement of comprehensive income.

SELLING EXPENSES

Selling expenses mainly represented promotion expenses and freight charges incurred during the year 2016. Selling expenses significantly decreased by 86.7% to approximately HK\$2.3 million during the year 2016 (2015: HK\$17.3 million) mainly due to decrease in (i) rent of the self-operated retail outlets, (ii) employee benefit expense for salespersons, and (iii) penalty fees for the early termination of the rental agreements for the retail shops, all incurred under the Apparel Retail Business during the year 2015. No such expenses was incurred during the year 2016.

ADMINISTRATIVE EXPENSES

Administrative expenses mainly represented employee benefit expenses for our management, finance and administrative personnel, entertainment expenses, rental expenses for our office premises and travelling expenses. Administrative expenses decreased by 10.9% to approximately HK\$65.1 million during the year 2016 (2015: HK\$73.1 million) mainly because better cost control was implemented and there was no allowance for doubtful debts provided during the year 2016 (2015: HK\$4.0 million).

其他(虧損)/收益—淨額

二零一六年的其他虧損—淨額約1,000,000港元(二零一五年：其他收益—淨額1,000,000港元)主要指出售物業、廠房及設備的虧損約17,000港元(二零一五年：收益32,000港元)及匯兌虧損淨額約1,000,000港元(二零一五年：300,000港元)。去年金額亦包括撇銷應付賬款收益約1,200,000港元(二零一六年：無)。

財務收入及融資成本

二零一六年的財務收入減少80.3%至約1,200,000港元(二零一五年：6,100,000港元)，主要由於在二零一六年存入較少人民幣存款。

融資成本減少50.3%至約7,500,000港元(二零一五年：15,100,000港元)，主要由於二零一六年撥資一般營運所需的平均銀行借貸減少及於二零一六年換算現金及現金等價物以及借款結餘時產生的匯兌虧損淨額減少(二零一六年：2,800,000港元；二零一五年：7,300,000港元)。

所得稅開支

所得稅開支主要指根據香港及中國相關法律及法規按適用稅率計算的已付或應付即期所得稅。所得稅開支減少15.4%至約8,800,000港元(二零一五年：10,400,000港元)，主要由於二零一六年本集團產生較少應課稅溢利。

存貨

存貨結餘由二零一五年十二月三十一日約91,600,000港元增至二零一六年十二月三十一日約120,000,000港元，此乃由於去年年結日前交付更多貨品，令存貨週轉日數增加(二零一六年十二月三十一日：40日；二零一五年十二月三十一日：36日)。

發展中物業

去年發展中物業結餘包括土地使用權、建築成本、資本化融資成本及相關開支。由於在二零一六年出售目標集團，故二零一六年十二月三十一日的結餘為零元。

應收賬款

應收賬款結餘總額並無重大變動(二零一六年十二月三十一日：197,800,000港元；二零一五年十二月三十一日：206,500,000港元)。

OTHER (LOSSES)/GAINS — NET

Other losses— net of approximately HK\$1.0 million during the year 2016 (2015: other gains — net of HK\$1.0 million) mainly represented loss on disposal of property, plant and equipment of approximately HK\$17,000 (2015: gain of HK\$32,000) and the net exchange losses of approximately HK\$1.0 million (2015: HK\$0.3 million). Last year's amounts also included gain on written off of trade payable of approximately HK\$1.2 million (2016: Nil).

FINANCE INCOME AND COSTS

Finance income decreased by 80.3% to approximately HK\$1.2 million for the year of 2016 (2015: HK\$6.1 million) primarily because less time deposits in Renminbi were made during the year 2016.

Finance costs decreased by 50.3% to approximately HK\$7.5 million (2015: HK\$15.1 million) primarily due to a decrease in average bank borrowings to finance the general operation and decrease in net exchange loss arising from translation of the balances of cash and cash equivalents and borrowings during the year 2016 (2016: HK\$2.8 million; 2015: HK\$7.3 million).

INCOME TAX EXPENSE

Income tax expense mainly represented amounts of current income tax paid or payable at the applicable tax rates in accordance with the relevant laws and regulations in Hong Kong and the PRC. Income tax expense decreased by 15.4% to approximately HK\$8.8 million (2015: HK\$10.4 million) primarily as less taxable profit was generated by the Group during the year 2016.

INVENTORY

Inventory balance increased from approximately HK\$91.6 million as at 31 December 2015 to approximately HK\$120.0 million as at 31 December 2016 because more goods were delivered before the last year ended which resulted in an increase in the inventory turnover days (31 December 2016: 40 days; 31 December 2015: 36 days).

PROPERTIES UNDER DEVELOPMENT

Last year's properties under development balance comprised land use rights, construction costs, capitalised finance costs and related expenses. The balance become nil as at 31 December 2016 due to the disposal of the Target Group during the year 2016.

TRADE RECEIVABLE

There was no material fluctuation in the gross trade receivable balance (31 December 2016: HK\$197.8 million; 31 December 2015: HK\$206.5 million).

我們一般向服裝供應鏈服務業務的客戶提供30至90日的信貸期，彼等一般須透過銀行轉賬或支票向我們清償貿易結餘。

於二零一六年十二月三十一日，應收賬款的週轉日數為68日(二零一五年十二月三十一日：55日)，大致上介乎我們向客戶授出的信貸期範圍內。

應付賬款

應付賬款結餘由二零一五年十二月三十一日約215,500,000港元減少至二零一六年十二月三十一日約199,600,000港元，主要由於年結日前進行較少採購。

我們一般享有最多90日的信貸期以償還款項。於二零一六年十二月三十一日，應付賬款的週轉日數為78日(二零一五年十二月三十一日：67日)，維持於我們獲供應商及第三方製造商給予的信貸期範圍內。

借貸

本集團於二零一六年十二月三十一日有銀行借貸約79,000,000港元。所有銀行借貸均由香港銀行提供，按浮動利率計息。於二零一六年十二月三十一日，全部銀行借貸均須於一年內償還或按要求隨時償還。此外，本集團於二零一六年十二月三十一日有融資租賃負債約800,000港元(二零一五年十二月三十一日：1,100,000港元)。銀行借貸的賬面值以港元計值。本集團並無使用任何財務工具作對沖用途，亦無任何以現有借貸及／或其他對沖工具對沖的外幣淨額投資。

流動資金及財務資源

於二零一六年，本集團維持健全的流動資金狀況，以內部資源及銀行借貸提供營運資金。於二零一六年十二月三十一日，現金及現金等價物約為244,800,000港元，其中約167,200,000港元以港元計值，66,200,000港元以人民幣計值，11,300,000港元以美元計值，另外100,000港元則以其他貨幣計值。於二零一六年十二月三十一日，本集團的流動比率為1.5(二零一五年十二月三十一日：1.8)。本集團於二零一六年十二月三十一日處於充裕的淨現金狀況。本集團擁有充足及隨時可用的財務資源滿足一般營運資金需要及可預見的資本開支。

We generally grant customers of our Apparel Supply Chain Servicing Business a credit period of 30 to 90 days and they are generally required to settle their trade balances with us by bank transfer or by cheque.

Our trade receivable turnover days as at 31 December 2016 was 68 days (31 December 2015: 55 days) which is in general within the credit period granted by us to the customers.

TRADE PAYABLE

Trade payable balance decreased from approximately HK\$215.5 million as at 31 December 2015 to approximately HK\$199.6 million as at 31 December 2016 primarily because less purchases were made before the year ended.

We generally enjoy a credit term of up to 90 days to settle payment. Our trade payable turnover days as at 31 December 2016 was 78 days (31 December 2015: 67 days) which is within the credit period granted by our suppliers and third-party manufacturers.

BORROWINGS

The Group had bank borrowings as at 31 December 2016 in the sum of approximately HK\$79.0 million. All bank borrowings were made from banks in Hong Kong at floating interest rates. As at 31 December 2016, all bank borrowings were repayable within one year or repayable on demand. Furthermore, the Group had finance lease liabilities of approximately HK\$0.8 million as at 31 December 2016 (31 December 2015: HK\$1.1 million). The carrying amounts of bank borrowings were denominated in HK\$. No financial instruments were used for hedging purposes, nor were there any foreign currency net investments hedged by current borrowings and/or other hedging instruments.

LIQUIDITY AND FINANCIAL RESOURCES

During the year 2016, the Group maintained a healthy liquidity position, with working capital financed by both internal resources and bank borrowings. As at 31 December 2016, cash and cash equivalents amounted to approximately HK\$244.8 million, of which approximately HK\$167.2 million denominated in HK\$, HK\$66.2 million in Renminbi, HK\$11.3 million in United States dollar and HK\$0.1 million in other currencies. As at 31 December 2016, the current ratio of the Group was 1.5 (31 December 2015: 1.8). The Group was in a strong net cash position as at 31 December 2016. The Group has sufficient and readily available finance resources for general working capital requirement and foreseeable capital expenditure.

庫務政策

本集團在執行庫務政策上採取審慎的財務管理策略，因而於整段回顧期間內維持健全的流動資金狀況。本集團不斷評估其客戶的信貸狀況及財務狀況，務求降低信貸風險。為控制流動資金風險，董事會密切監察本集團的流動資金狀況，確保本集團擁有充足財務資源以及時滿足其資金需要及承擔。

外匯風險

外匯風險源自日後商業交易、已確認資產及負債以及海外業務的投資淨額。

當日後商業交易或已確認資產或負債以實體功能性貨幣以外的貨幣計值時，外匯風險即產生。對於以人民幣作為功能貨幣的集團公司來說，其外匯風險主要來自港元；而對於以港元作為功能貨幣的集團公司來說，其外匯風險主要來自人民幣。本集團通過緊密關注匯率變動以控制外匯風險。

本集團在中國有投資，其資產淨值面對外幣換算風險。本集團在中國投資的資產淨值所產生外幣風險，可以通過在中國境外支付的股息管理。

於年內，本集團並無利用任何財務工具對沖外幣風險。

資本結構

於二零一六年，本公司的資本結構並無任何重大變動。本公司的資本包括普通股及其他儲備。

資本承擔

於二零一六年十二月三十一日，本集團並無任何重大資本承擔(二零一五年十二月三十一日：51,600,000港元)。

TREASURY POLICIES

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the period under review. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that sufficient financial resources are available in order to meet its funding requirements and commitment timely.

FOREIGN EXCHANGE EXPOSURE

Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations.

Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. For group companies with Renminbi as their functional currency, foreign exchange risk arises primarily with respect of HK\$. For group companies with HK\$ as their functional currency, foreign exchange risk arises primarily with respect to Renminbi. The Group manages its foreign exchange risk by closely monitoring the movement of the foreign currency rates.

The Group has investments in the PRC, whose net assets are exposed to foreign currency translation risk. Currency exposure arising from the net assets of the Group's investments in the PRC can be managed through dividends paid outside the PRC.

During the year, the Group did not commit to any financial instruments to hedge its exposure to foreign currency risk.

CAPITAL STRUCTURE

There has been no material change in the capital structure of the Company during the year 2016. The capital of the Company comprises ordinary shares and other reserves.

CAPITAL COMMITMENTS

As at 31 December 2016, the Group did not have any significant capital commitments (31 December 2015: HK\$51.6 million).

除基本薪金外，亦可視乎本集團的業績及個人表現獲發花紅。其他員工福利包括香港的強制性公積金計劃供款，以及提供退休金、醫療保險、失業保險及為根據中國規則及規例以及中國現行相關監管規定獲本集團聘用的僱員而設的其他相關保險。

本集團僱員的薪金及福利均處於具競爭力的水平，僱員的待遇均在本集團就薪酬及花紅設定的整體框架內按表現釐定，而該框架每年進行檢討。本集團亦設有一項由本公司於二零一二年十二月二十四日採納的購股權計劃（「購股權計劃」），據此，董事及本集團僱員可獲授予購股權以認購股份。

Remuneration is determined with reference to market norms as well as individual employees' performance, qualification and experience.

On top of basic salaries, bonuses may be paid by reference to the Group's performance as well as individual's performance. Other staff benefits include contributions to Mandatory Provident Fund retirement benefits scheme in Hong Kong and the provision of pension funds, medical insurance, unemployment insurance and other relevant insurance for employees who are employed by our Group pursuant to the PRC rules and regulations and the prevailing regulatory requirements of the PRC.

The salaries and benefits of the Group's employees are kept at a competitive level and employees are rewarded on a performance-related basis within the general framework of the Group's salary and bonus system, which is reviewed annually. The Group also operates a share option scheme adopted by the Company on 24 December 2012 ("Share Option Scheme") where options to subscribe for shares may be granted to the Directors and employees of the Group.

Details of the Share Option Scheme are disclosed in the section headed "Share Option Scheme" on pages 59 to 61 of this annual report.

No formal sale and purchase agreement for the possible sale has been entered into at the date of this annual report.

CORPORATE GOVERNANCE REPORT

企業管治常規

配合及遵循企業管治原則及常規之公認標準一向為本公司最高原則之一。董事會認為良好企業管治是帶領本公司邁向成功及平衡股東、客戶與僱員之間利益的其中一大關鍵，董事會致力持續提升該等原則及常規之效率及效益。

於二零一六年度，本公司一直遵守聯交所證券上市規則（「上市規則」）附錄14所載企業管治守則之守則條文（「守則條文」），惟下文所述偏離情況除外：

- (i) 守則條文A.2.1訂明主席與行政總裁的角色應予區分，不應由一人同時兼任。本公司的主席與行政總裁角色並無區分，並由黃志深先生同時兼任。由於董事定期會面以考慮影響本公司業務的重大事宜，故董事認為，此架構不會損害董事與本公司管理層之間權責平衡，並相信此架構有助本公司迅速及有效地作出及執行決策。本公司深明遵守守則條文A.2.1的重要性，並將繼續考慮委任獨立行政總裁的可行性。
- (ii) 根據守則條文A.6.7，獨立非執行董事應出席股東大會，對股東的意見有公正的了解。本公司獨立非執行董事陳振彬博士及彭婉珊女士因處理其他事務而未有出席本公司的二零一五年股東周年大會，而本公司獨立非執行董事張灼祥先生亦因處理其他事務而未有出席本公司的二零一六年股東特別大會。

CORPORATE GOVERNANCE PRACTICES

Adapting and adhering to recognised standards of corporate governance principles and practices has always been one of the top priorities of the Company. The Board believes that good corporate governance is one of the areas that lead to the success of the Company and in balancing the interests of shareholders, customers and employees, and the Board is devoted to ongoing enhancements of the efficiency and effectiveness of such principles and practices.

During the year 2016, the Company had complied with the code provisions (“Code Provisions”) set out in the Corporate Governance Code contained in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”), except for the following deviations:

- (i) Code Provision A.2.1 stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. The roles of the chairman and the chief executive officer of the Company are not separate and both are performed by Mr. Huang Chih Shen. Since the Directors meet regularly to consider major matters affecting the operations of the Company, the Directors consider that this structure will not impair the balance of power and authority between the Directors and the management of the Company and believe that this structure will enable the Company to make and implement decisions promptly and efficiently. The Company understands the importance to comply with the Code Provision A.2.1 and will continue to consider the feasibility of appointing a separate chief executive officer.
- (ii) Under Code Provision A.6.7, independent non-executive Directors should attend general meetings and develop a balanced understanding of the views of shareholders. The Board is also responsible for determining the Company's corporate governance policies which include: (i) development and review of the Company's policies and practices on corporate governance; (ii) review and monitoring of the training and continuous professional development of Directors and senior management; (iii) review and monitoring of the code of conduct and compliance manual (if any) applicable to employees and Directors; and (iv) review of the Company's disclosure in the Corporate Governance Report.

While at all times the Board retains full responsibility for guiding and monitoring the Company in discharging its duties, certain responsibilities are delegated to various Board committees which have been established by the Board to deal with different aspects of the Company's affairs. However, if the number of Directors is not a multiple of three, then the number nearest to but not less than one third shall be the retiring Directors. The Directors who shall retire in each year will be those who have been the longest in the office since their last re-election or appointment but as for persons who became or were last re-elected as Directors on the same day those to retire will (unless they otherwise agree among themselves) be determined by lot. Such retiring Directors may, being eligible, offer themselves for re-election at the annual general meeting. All Directors appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of shareholders after their appointment and be subject to re-election at such meeting and all Directors appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting and shall then be eligible for re-election.

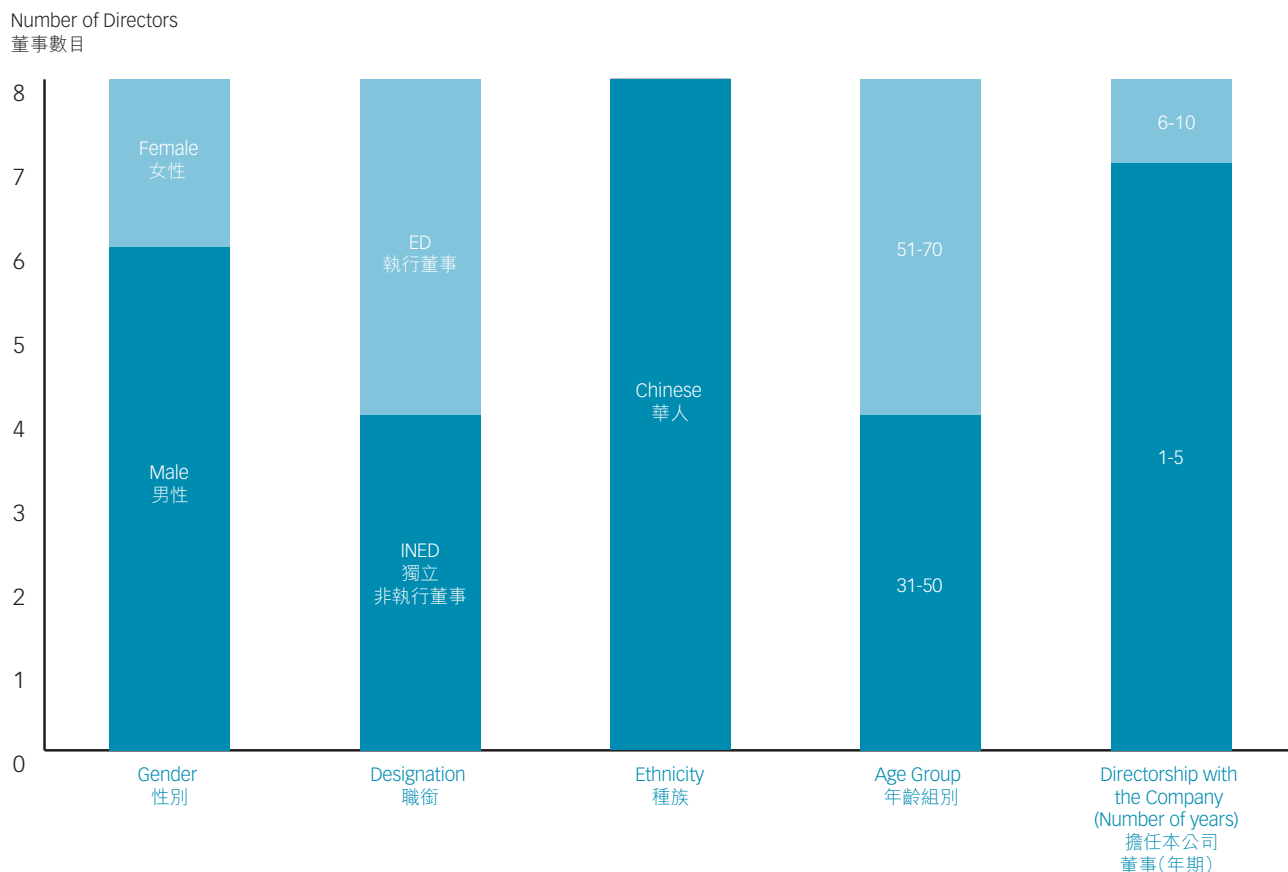

With the implementation of internal audit function, the effectiveness of the risk management and internal control systems is reviewed by conducting internal audit assignments. Recommendations for major observations of control weaknesses from the audits will be provided, so as to resolve material internal control defects.

2. 迅捷環球的环境方針

迅捷環球依據國際標準化組織ISO:14001:2004環境管理系統標準而制訂了本集團的環境管理政策。本集團的環境方針亦符合環球服裝生產社會責任組織(WRAP)的12項原則¹，確保本集團的營運、產品和服務均符合有關法律法規，並致力減少業務對環境的影響。此外，迅捷環球制訂了內部環境手冊，規範本集團各承包外發商從事與有關的活動中必須共同遵守。

本集團承諾：

- 遵守法律、法規要求，實現環境方針的承諾；
- 要求承包外發商貫徹實行本集團的環境管理。本集團及承包外發商將全面識別出生產過程、產品、及服務過程中的環境因素，設定環境目標、指標、及管理方案；
- 採取不同的措施，監管承包外發商對環境的排放並提升資源利用；
- 量化與監察本集團的用電，用水，及廢棄物產生量；及
- 致力通過不同的項目與計劃，提升員工及有關人士對環保和提升資源效益的意識。

¹ World Wide Responsible Apparel Production (WRAP) 標準是由環球服裝生產社會責任組織制訂的，是全球最大的獨立的認證項目，主要集中於服裝、鞋襪和縫紉紡織品領域。WRAP與生產企業通過合作方式完成社會責任的認證，確保企業持續符合WRAP 12項原則。

2. THE ENVIRONMENTAL POLICY OF SPEEDY GLOBAL

Speedy Global established the environmental management policies of the Group in accordance with ISO:14001:2004 Environmental Management System Standards of the International Organization for Standardization. The environmental policies of the Group also follow the 12 principles of the World Wide Responsible Apparel Production (“WRAP”)¹ to ensure the operation, products and services of the Group comply with the relevant laws and regulations. The Group strived to reduce impact of business on the environment. Furthermore, Speedy Global has prepared an internal environmental manual to regulate the relevant activities carried out by the outsourcing contractors and for their joint compliance.

The Group undertakes to:

- comply with requirement of laws and regulations to realise commitment to the environmental policies;
- require outsourcing contractors to implement environmental management thoroughly within the Group. The Group and its outsourcing contractors shall identify environmental factors in production process, products and process of services comprehensively and thereby set up environment objectives, indicators and management solutions respectively;
- adopt various measures to monitor emissions of outsourcing contractors to the environment and improve utilisation of resources;
- quantify and monitor consumption of electricity and water and volume of waste generated by the Group; and
- enhance environmental awareness and improve resource efficiency of staff and related parties through different projects and schemes.

¹ Standards of World Wide Responsible Apparel Production (“WRAP”) is the world’s largest certification project set up by WRAP. The project mainly focuses on apparels, shoes, socks, and sewing and weaving products. WRAP carries out its certification on social responsibilities through cooperation with production enterprises, ensuring the enterprises comply with WRAP 12 principles in an ongoing basis.

2.1 珍惜天然資源及排放物管理

2.1.1 溫室氣體排放

迅捷環球於營運過程中主要使用到電資源為主要能源，而使用電資源會間接排放包括二氧化碳在內的溫室氣體。本集團使用的電力使用範圍涵蓋辦公室區域，廠房大樓，員工食堂及宿舍等。本集團主要電力使用於廠房大樓裡的照明系統，針織設備，及蒸燙儀器等。為了管理用電量的使用，本集團制訂了相關監控流程，規範承包外發商有效地使用電力。

2.1.2 包裝材料及固體廢棄物管理

本集團鼓勵承包外發商對廢棄物分別標識上相應的廢棄物類別，以利於識別、存放及處理。

2.1.3 生活廢棄物及生活用水

迅捷環球對於員工宿舍及辦公室的生活廢棄物及生活用水設定管理措施，時刻提醒各員工及有關負責人妥善處理生活廢棄物，同時珍惜水資源，避免浪費。

2.2 資源使用

迅捷環球積極推動可持續發展和環境保護，於資源運用上制訂了一系列的措施，督導承包外發商的營運作出了明確管理，使本集團對環境造成的影響降至最低。

2.1 Cherishing natural resources and managing emissions

2.1.1 Emission of greenhouse gases (GHG)

The largest environmental footprint of Speedy Global's operation was in electricity consumption, which indirectly contributed to GHG (such as carbon dioxide) emissions. Areas of the Group that required electricity consumption covered the office area, factory building and staff canteen and dormitory. Electricity was principally used in lighting system, knitwear equipment and steaming and ironing equipment in factory building. To manage electricity consumption, the Group established relevant monitoring procedures to regulate outsourcing contractors to use electricity efficiently.

2.1.2 Management of packaging materials and solid waste

The Group encouraged outsourcing contractors to provide labels to facilitate separation, storage and process of different kinds of waste.

2.1.3 Domestic waste and water consumption

Speedy Global set management measures for domestic waste and water consumption in staff dormitory and offices, reminding staff and relevant persons in charge to process daily waste properly and to treasure water resources and avoid wasting.

2.2 Utilisation of resources

Speedy Global actively promoted sustainable development and environmental protection. The Group implemented a series of measures on utilisation of resources and managed the monitoring of operations of outsourcing contractors, in order to minimise environmental impact of the Group.

2.2 資源使用(續)

2.2.1 布料管理

迅捷環球於設計及開發過程中使用到不同的布料。為避免製造不必要的浪費及實行有效資源使用，本集團規管承包外發商於設計過程中善用布料資源，把裁剪後多餘的布料盡量循環再用，減少製造浪費。此外，於服裝設計研究與開發過程中，本集團善用剩餘的布碎物料，力求減少浪費資源。

2.2.2 善用資源

為了有效地使用資源，本集團監察及時刻提醒承包外發商善用資源，如教導員工在機器不需時關掉電源，避免浪費資源。

3. 迅捷環球企業社會責任

3.1 迅捷環球的僱傭政策

迅捷環球採用多元化及非歧視性政策建立專業團隊，並提供具競爭力的薪酬待遇、各類培訓項目及事業發展機會。本集團根據WRAP原則及有關法律法規要求，制訂了聘用程序，通過多種渠道實施招聘以利于人力資源的開發。本集團為員工提供平等機會，所有員工於聘請時必須遵守適用的僱傭及其他法例，絕不容忍任何歧視、騷擾或違法行為。

2.2 Utilisation of resources (Continued)

2.2.1 Management of fabrics

Speedy Global used various kind of fabrics in the course of design and development. To avoid unnecessary waste and implement efficient use of resources, the Group regulated outsourcing contractors to make good use of fabrics in the designing process and to recycle and reuse excess fabrics after cutting, in order to reduce waste. In addition, during the design, research and development process of apparel, the Group made good use of remained strips of fabrics in order to reduce waste.

2.2.2 Efficient use of resources

To make efficient use of resources, the Group kept monitoring and reminding outsourcing contractors to make good use of resources. For example, employees were instructed to switch off machines when not in use to avoid waste of resources.

3. CORPORATE SOCIAL RESPONSIBILITIES OF SPEEDY GLOBAL

3.1 Employment policy of Speedy Global

Speedy Global adopted diversification and anti-discrimination policies in establishing its professional team and provided competitive remuneration packages, various training programmes and career development opportunities for employees. In accordance with requirement of the WRAP principles and relevant laws and regulations, the Group established employment procedures to recruit through various channels, which facilitated the development of human resources. The Group provided equal opportunities to all staff. All staff must comply with applicable employment and other laws in their recruitment. The Group tolerated no discrimination, harassment or illegal acts.

3. 迅捷環球企業社會責任(續)

3.1 迅捷環球的僱傭政策(續)

3.1.1 工作時數與年假

本集團年假待遇及福利比照當地勞動法執行滿足不同員工需求。本集團亦遵守法律和 WRAP 社會責任管理條件的規定。利用員工身份證掃描系統紀錄及監察員工的工作時數，防止因工作時間過長而影響員工的安全與健康。

3.1.2 薪酬管理程序

根據員工各自的工作表現，本集團遵循一公平及透明的薪酬計劃去報酬員工。

於匯報期間，本集團行為符合有關薪酬及解僱、招聘及晉升、工作時數、假期、平等機會、多元化、反歧視以及其他待遇及福利的政策及相關法律法規。

3.2 運營安全 — 員工安全管理

迅捷環球致力遵守適用法例及 WRAP 管理原則的要求，通過制訂安全管理控制程序，為所有員工締造安全和健康的工作環境。

3.2.1 提供安全及健康工作環境

本集團一直秉承社會責任，努力為員工營造一個安全、健康及舒適的工作環境。本集團亦遵守 WRAP 的有關要求，如委任有關負責人溝通，部署和監察所有健康和安全的政策及措施。本集團亦每年進行內部安全審核。

3.1 Employment policy of Speedy Global (Continued)

3.1.1 Working hours and annual leaves

Staff annual leaves and benefits packages of the Group were enforced with reference to local labour laws to satisfy the needs of different staff. The Group also complied with requirement of laws and social responsibility management criteria of WRAP such as utilize ID card scanning system as time keeping mechanism to record and monitor employees working hours to prevent impact on safety and health of staff due to excessive working hour.

3.1.2 Remuneration management procedures

The Group adopts a fair and transparent remunerate scheme which awards employees based on their performance.

During the Reporting Period, the Group has complied with policies and relevant laws and regulations regarding remuneration and termination of employment, recruitment and promotion, working hours, vacation, equal opportunities, diversity, anti-discrimination and other packages and benefits.

3.2 Operation Safety — Staff safety management

Speedy Global is committed to comply with requirement of applicable laws and management principles of WRAP. Safe and healthy working environment was created for all employees by establishing monitoring procedures for safety management.

3.2.1 Providing safe and healthy working environment

The Group has upheld social responsibilities and strived to create a safe, healthy and comfortable working environment for employees. The Group has also complied with relevant requirement of WRAP such as designating responsible personnel to communicate, deploy and monitor all health and safety policies are implemented. The Group has also conducted safety audit once a year.

3.2.2 員工安全管理

3.2.2 Safety management for staff

Speedy Global kept improving its occupational safety by providing value-added safe production trainings for employees of the Group and outsourcing contractors. Employees would use production equipment and machines of various size in performing their jobs during the operation and processing. The focus of the training was to reduce and prevent industrial accidents and improve precaution measures in order to ensure safety of employees. The Group also provided all necessary protective resources for employees in the workshop.

During the Reporting Period, the Group has complied with policies and relevant laws and regulations regarding safe working environment and prevention of occupational hazard of employees.

3.3 Development and training

3.3.1 Nurturing talents

Speedy Global believes employees are valuable capital and key to the development of the Group's business. The Group believes continuous learning and training can effectively improve quality of employees and foster continuous improvement of the Group.

During the Reporting Period, the Group recommended outsourcing contractors to provide different kinds of training projects for frontline staff. Training projects of the Group mainly focused on safe operation of machinery equipment, learning new techniques and managerial enhancements.

The Group established management policy for forced labour and captive labour to prohibit any forced labour and regulate that employees of the Group must be employed voluntarily, undertaking that:

- no forced acts would be allowed;
- no deceptive means shall be applied in attracting workers to work in the Group;
- no threat or punishment to gain any benefit from employees or force employees to work.

During the Reporting Period, the Group has complied with policies and relevant laws and regulations regarding prevention of child labour or forced labour.

- all suppliers or individuals dealing business with the Company shall not offer commercial bribe or transfer other benefits by any means to employees or management of the Group.

3.5.2 Reporting system

The Group prohibited employees from perusing the seal without permission, signing beyond one's authority, and approving the signing of external contracts or terminating it, and varying performance of relevant contracts. The reporting system of the Group allowed employees to report any suspected misconduct or frauds to relevant department head through effective channels.

During the Reporting Period, the operation of Speedy Global has complied with policies and relevant laws and regulations regarding anti-bribery, extortion, fraud and money laundering.

The operation model of Speedy Global is to manage outsourcing contractors of different scales, to strive continuously to make products complied with integrated standards and to ensure products complied with all relevant requirements. In the coming year, the Group will conduct various assessments on each supplier regarding social and environmental, striving to further improve its sustainable development.

3.6.2 Anti-corruption

The Group set up strict guidelines to prevent any employee, outsourcing contractor or supplier from breaching the anti-corruption guideline requirements by implementing appropriate disciplinary punishment. The Group also stated in its anti-corruption policy that it will not work with suppliers who has violated the requirements.

3.6.3 Protecting human rights and labour rights in supply chain

The Group complied with the relevant local laws, regarding child labour and forced labour. Suppliers were also required to comply with the same

3.7.1 Quality Check

The Group set up specialised research and development centres with high standard interior design and sample rooms for customers. The Group ensured all products meet requirements and standards of customers through stringent quality control and management procedures. The Group engaged National Product Quality Supervision And Inspection Centre For Apparel And Garment Products Of Textile Industry (國家紡織業品服裝服飾產品質量監督檢驗中心) to conduct quality check for fabrics and garment upon demand of customers, with a view to provide quality products.

3.7.2 Protecting customer privacy

As an apparel supply chain servicing company, the Group respects intellectual property rights. The Group is committed to protecting trademarks of customers and restricts any person from using the trademarks on any other unauthorized events.

During the Reporting Period, the operation of Speedy global has complied with the relevant requirements on product liabilities, for example health and safety of customer, advertisement and promotion, labels and protecting privacy information.

During the year under review, the Group complied with the relevant laws and regulations in Hong Kong and the PRC in all material respects.

The Group offers competitive remuneration packages to attract, retain and motivate employees. Key personnel have been part of the management team since the inception of business. Another renewed tenancy agreement dated 30 December 2014 was entered into between Shing Fun International, as landlord, and Jointex Garment, as tenant, under which Shing Fun International agreed to lease to Jointex Garment, Workshops C and D on 13th Floor, Wing Chai Industrial Building, Nos. 222-224 Choi Hung Road, Nos. 27-29 Ng Fong Street, Kowloon, Hong Kong, for a term of three years commencing on 1 January 2015 and ended on 31 December 2017 for office use. Both tenancy agreements are collectively known as "Hong Kong Office Tenancy Agreements".

Pursuant to the Hong Kong Office Tenancy Agreements, Speedy Garment and Jointex Garment paid Shing Fun International monthly rentals of HK\$66,000 in total.

The annual caps for the rental payable by Speedy Garment and Jointex Garment to Shing Fun International under the Hong Kong Office Tenancy Agreements, for each of the three years ended 31 December 2015, 2016 and 2017, is HK\$792,000.

2. Tenancy agreement between Jinfeng Huizhou and Koyip Huizhou

Jinfeng Huizhou as landlord and Koyip Huizhou, a subsidiary of the Group, as tenant, entered into a renewed tenancy agreement dated 30 December 2014, pursuant to which Jinfeng Huizhou agreed to lease to Koyip Huizhou, Shenfeng Industrial Park, Julong Village, Yuanzhou Town, Boluo County, Huizhou, the PRC, with a gross floor area of approximately 6,000 square metres, for a term of three years commencing on 1 January 2015 and ended on 31 December 2017 for office and sample room use.

Pursuant to the tenancy agreement, Koyip Huizhou paid Jinfeng Huizhou annual rental of RMB396,000.

4. 東莞市長安鎮廈崗股份經濟聯合社（「聯合社」）與本集團附屬公司東莞迅捷（作為承租人）訂立日期為二零一一年十二月二十五日的租賃協議及日期為二零一二年十月二十四日的補充租賃協議。根據租賃協議、補充租賃協議及東莞知榮發出的授權確認函，東莞知榮授權聯合社將東莞知榮擁有的工廠廠房以月租人民幣233,312元租予東莞迅捷。

Pursuant to the said tenancy agreement, Koyip Huizhou paid Yicheng Huizhou annual rental of RMB132,000.

The annual caps for the rental payable by Koyip Huizhou to Yicheng Huizhou under the said tenancy agreement, for each of the three years ended 31 December 2015, 2016 and 2017, is RMB132,000.

4. Dongguan City Changan Town Xiagang Village Shareholding Economic Cooperation Unit (the "Cooperation Unit") and Speedy Dongguan, a subsidiary of the Group, as tenant, entered into a tenancy agreement dated 25 December 2011 and a supplementary tenancy agreement dated 24 October 2012. Pursuant to the tenancy agreement and the supplementary tenancy agreement and an authorization confirmation letter issued by Dongguan Zhirong, Dongguan Zhirong authorized the Cooperation Unit to lease the factory plant owned by Dongguan Zhirong to Speedy Dongguan with a monthly rental of RMB233,312.

Pursuant to tenancy agreements entered into between Dongguan Zhirong and Speedy Dongguan dated 28 October 2014 and 30 December 2014, the parties agreed that Speedy Dongguan shall pay the rent to Dongguan Zhirong directly for the period from 1 November 2014 to 31 December 2014 and for the period from 1 January 2015 to 31 December 2017, respectively. Therefore, the rental payment arrangement among the Cooperation Unit, Dongguan Zhirong and Speedy Dongguan has ceased since November 2014.

The annual caps for the rental payable by Speedy Dongguan to the Dongguan Zhirong under the said tenancy agreements, for each of the three years ended 31 December 2015, 2016 and 2017, is RMB2,799,744.

The Company's auditor was engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The auditor has issued an unqualified letter containing their findings and conclusions in respect of the continuing connected transactions disclosed by the Company in this annual report in accordance with Rule 14A.56 of the Listing Rules. A copy of the auditor's letter has been provided by the Company to the Stock Exchange.

Save as disclosed above, a summary of significant related party transactions, which do not constitute connected transactions, made during the year is disclosed in Note 32 to the Financial Statements. The Company confirmed that it has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules.

SHARE OPTION SCHEME

The Company's existing Share Option Scheme was approved for adoption pursuant to a written resolution of all of our shareholders passed on 24 December 2012 for the purpose to provide our Company with a flexible means of giving incentive to, rewarding, remunerating, compensating and/or providing benefits to eligible participants and for such other purposes as the Board approve from time to time.

Subject to the terms of the Share Option Scheme, the Board may, at their absolute discretion, grant or invite any person belonging to any of the following classes to take up options to subscribe for shares: (a) any employee, supplier/service provider, customer, partner or joint-venture partner of the Group (including any director, whether executive and whether independent or not, of the Group) who is in full-time or part-time employment with the Company or any subsidiaries, (b) any person who have contributed or may contribute to the Group.

The maximum number of shares which may be issued upon exercise of all outstanding options granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 30% of the total number of shares in issue from time to time.

The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 10% of the total number of shares in issue on the Listing Date unless the Company seeks the approval of the shareholders in general meeting for refreshing the 10% limit under the Share Option Scheme provided that options lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company will not be counted for the purpose of calculating 10% limit.

Details of the principal terms of the Share Option Scheme are set out in paragraph headed "Share Option Scheme" in section headed "Statutory and General Information" in Appendix IV to the Prospectus. The principal terms of the Share Option Scheme are summarised as follows:

The Share Option Scheme was adopted for a period of 10 years commencing from 24 December 2012 and remains in force until 23 December 2022. The Company may, by resolution in general meeting or, such date as the Board determined, terminate the Share Option Scheme at any time without prejudice to the exercise of options granted prior to such termination.

The exercise price per share of the Company for each option granted shall be determined by the Board in its absolute discretion but in any event shall be at least the higher of:

- (1) the closing price of the shares as stated in the daily quotations sheets issued by the Stock Exchange on the date of offer for the grant of option ("Date of Grant") which must be a trading day;
- (2) the average closing price of the shares as stated in the daily quotations sheets issued by the Stock Exchange for the five trading days immediately preceding the Date of Grant; and
- (3) the nominal value of the shares on the Date of Grant.

Upon acceptance of the options, the grantee shall pay HK\$1.00 to the Company as consideration for the grant. The acceptance of an offer of the grant of the option must be made within the date as specified in the offer letter issued by the Company. The exercise period of any option granted under the Share Option Scheme shall not be longer than 10 years commencing on the date of grant and expiring on the last day of such 10-year period subject to the provisions for early termination as contained in the Share Option Scheme.

The Group manufactures and sells a wide range of woven wear and knitwear products. The value of the products will drop significantly when they become outdated or there is a change in customers' demand. The slow-moving and obsolete inventories may be impaired. As at 31 December 2016, management made a provision of approximately HK\$9.3 million for such inventories.

1 一般資料

迅捷環球控股有限公司（「本公司」）於二零一一年九月二十八日根據開曼群島公司法（二零一零年修訂本）在開曼群島註冊成立為獲豁免有限公司。註冊辦事處地址為Vistra (Cayman) Limited, P.O. Box 31119 Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands。本集團的直屬及最終控股公司為皓天控股有限公司。

本公司及其附屬公司（統稱「本集團」）主要從事(i)向多家全球知名品牌擁有人或代理提供廣泛的梭織衣服及剪裁針織產品的服裝供應鏈服務業務（「服裝供應鏈服務業務」）、(ii)於中華人民共和國（「中國」）經營服裝零售業務（「服裝零售業務」）；及(iii)物業發展及投資（「物業投資及發展業務」）。

本公司於二零一三年一月十五日在聯交所上市。

除另有所指外，綜合財務報表乃以港元（「港元」）呈列。綜合財務報表已於二零一七年三月二十三日獲董事會批准刊發。綜合全面收益表的比較數字已重列，猶如因本公司於截至二零一六年十二月三十一日止年度出售其於經營物業投資及發展業務的附屬公司的全部權益而終止經營的業務於比較期間開始時已終止經營。

2 主要會計政策概要

編製該等綜合財務報表所採用主要會計政策於下文載列。除另有指明外，該等政策已於所有呈報年度貫徹應用。

1 GENERAL INFORMATION

Speedy Global Holdings Limited (the “Company”) was incorporated in the Cayman Islands on 28 September 2011 as an exempted Company with limited liability under the Companies Law (2010 Revision) of the Cayman Islands. The address of its registered office is at the office of Vistra (Cayman) Limited, P.O. Box 31119 Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands. The immediate and ultimate holding company of the Group is Sky Halo Holdings Limited.

The Company and its subsidiaries (together the “Group”) are principally engaged in: (i) the apparel supply chain servicing business which offers a wide range of woven wear and cut-and-sewn knitwear products to a number of owners or agents of global reputable brands (the “Apparel Supply Chain Servicing Business”); (ii) the apparel retail business operating in the People’s Republic of China (the “PRC”) (the “Apparel Retail Business”); and (iii) the property development and investment (“the Property Investment and Development Business”).

The Company has been listed on the Stock Exchange since 15 January 2013.

The consolidated financial statements are presented in Hong Kong dollar (“HK\$”), unless otherwise stated. These consolidated financial statements have been approved for issue by the Board of Directors on 23 March 2017. The comparative consolidated statement of comprehensive income has been re-presented as if the operation discontinued due to the Company’s disposal of its entire interests in the subsidiaries which operated the Property Investment and Development Business during the year ended 31 December 2016 had been discontinued at the beginning of the comparative period.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 4.

2.2 附屬公司

2.2.1 綜合

附屬公司指本集團擁有控制權的實體(包括結構性實體)。當本集團因參與該實體而承擔可變回報的風險或享有可變回報的權益，並有能力透過其對該實體的權力影響此等回報時，本集團即控制該實體。附屬公司在控制權轉移至本集團之日起綜合入賬。附屬公司在控制權終止之日起不再綜合入賬。

(a) 業務合併

本集團以收購會計法而非共同控制下的業務合併入賬。收購一家附屬公司所轉讓代價為所轉讓資產、收購對象前擁有人所產生負債及本集團所發行股本權益的公平值。所轉讓代價包括或然代價安排產生的任何資產或負債的公平值。在業務合併中所收購可識別資產以及所承擔負債及或然負債，均初步按其收購當日公平值計量。

本集團以逐項收購為基礎，確認於收購對象的任何非控股權益。收購對象的非控股權益為現時擁有權權益，並於清盤時賦予其持有人按比例分佔實體的資產淨值，有關權益可按公平值或按現時擁有權權益分佔收購對象可識別淨資產的已確認金額比例計量。非控股權益的所有其他組成部分按其收購日期的公平值計量，除非香港財務報告準則規定必須以其他計量基準計量則另當別論。

2.2 Subsidiaries

2.2.1 Consolidation

A subsidiary is an entity (including a structured entity) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

(a) Business combinations

The Group applies the acquisition method to account for business combinations not under common control. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

The Group recognises any non-controlling interest in the acquiree on an acquisition-by-acquisition basis. Non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation are measured at either fair value or the present ownership interests' proportionate share in the recognised amounts of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at their acquisition date fair value, unless another measurement basis is required by HKFRS.

Acquisition-related costs are expensed as incurred.

2.2.1 綜合(續)

(a) 業務合併(續)

倘業務合併分階段完成，收購方過往於收購對象持有的股本權益按收購日期的賬面值，於收購日期公平值重新計量，由此產生的任何收益或虧損於損益確認。

本集團將予轉讓的任何或然代價於收購日期按公平值確認。或然代價(被視為一項資產或負債)公平值的其後變動，根據香港會計準則第39號確認為損益或其他全面收入的變動。分類為權益的或然代價並無重新計量，其後於權益中結算。

所轉讓代價、收購對象的任何非控制性權益數額，及在收購對象先前的任何股本權益在收購日期的公平值，超出購入可識別資產淨值公平值的數額記錄為商譽。如屬議價購買，而所轉讓代價、已確認的非控制性權益及先前持有的權益總額，低於購入附屬公司資產淨值公平值，則將該差額直接在綜合全面收益表中確認。

(a) Business combinations (Continued)

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability is recognised in accordance with HKAS 39 either in profit or loss or as a change to other comprehensive income. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

The excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identifiable net assets acquired is recorded as goodwill. If the total of consideration transferred, non-controlling interest recognised and previously held interest measured is less than the fair value of the net assets of the subsidiary acquired in the case of a bargain purchase, the difference is recognised directly in the consolidated statement of comprehensive income.

- (a) 業務合併(續)
集團內公司間交易、結餘及未變現交易收益均會對銷。除非交易提供所轉讓資產減值的證據，否則未變現虧損亦會對銷。附屬公司呈報的金額已按需要作出調整，以確保與本集團會計政策一致。
- (b) 並無失去控制權的附屬公司的所有權權益變動不會導致失去控制權的非控股權益交易入賬列作權益交易——即以擁有人的身份與附屬公司權益持有人進行交易。已付代價的公平值與所購買附屬公司淨資產賬面值的相關部分兩者之間差額列作權益。向非控股權益出售的收益或虧損亦列作權益。
- (c) 出售附屬公司
本集團失去控制權時，於實體的任何保留權益按失去控制權當日的公平值重新計量，有關賬面值變動在損益中確認。就其後入賬列作聯營公司、合資企業或金融資產的保留權益，其公平值為初始賬面值。此外，先前於其他全面收益確認與該實體有關的任何金額按猶如本集團已直接出售有關資產或負債的方式入賬。此可能意味先前在其他全面收益確認的金額重新分類至損益或按適用香港財務報告準則所規定／准許而轉撥至其他權益類別。

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. When necessary, amounts reported by subsidiaries have been adjusted to conform with the Group's accounting policies.
- (b) Changes in ownership interests in subsidiaries without change of control
Transactions with non-controlling interests that do not result in a loss of control are accounted for as equity transactions — that is, as transactions with the equity holders of the subsidiary in their capacity as owners. The difference between fair value of any consideration paid and the relevant share acquired of the carrying amount of net assets of the subsidiary is recorded in equity. Gains or losses on disposals to non-controlling interests are also recorded in equity.
- (c) Disposal of subsidiaries
When the Group ceases to have control, any retained interest in the entity is re-measured to its fair value at the date when control is lost, with the change in carrying amount recognised in profit or loss. The fair value is the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. It means the amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs.

2.2.2 獨立財務報表

於附屬公司的投資按成本扣除減值列賬。成本亦包括直接應佔投資成本。附屬公司的業績乃由本公司按已收及應收股息基準入賬。

倘股息超出附屬公司宣派股息期間全面收入總額，或倘獨立財務報表中投資賬面值超出綜合財務報表所示投資對象資產淨值(包括商譽)的賬面值，則須於自該等投資收取股息時，對於附屬公司的投資進行減值測試。

2.3 分部報告

營運分部按照與向主要營運決策者提供的內部報告一致的方式報告。董事會主席已確認為主要營運決策者，負責分配資源及評估營運分部的表現。

2.4 外幣換算

(a) 功能與呈列貨幣

本集團各實體的財務報表內的項目，乃以該實體營運所在主要經濟環境的貨幣(「功能貨幣」)計量。綜合財務報表以港元列報，港元為本公司的功能貨幣及本集團的列報貨幣。

2.2.2 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost also includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

2.3 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chairman of the board, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the chief operating decision-maker.

2.4 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

(b) 交易與結餘

外幣交易按交易當日的匯率或重新計量項目的估值換算為功能貨幣。結算該等交易以及將外幣計值的貨幣資產和負債按年終匯率換算產生的匯兌收益及虧損，在綜合全面收益表確認。

有關借貸以及現金及現金等價物的匯兌收益及虧損計入綜合全面收益表「財務收入或融資成本」內。所有其他匯兌收益及虧損計入綜合全面收益表「其他(虧損)/收益 — 淨額」內。

(c) 集團公司

所有集團實體(各實體貨幣並非極高通脹經濟地區者)的功能貨幣倘與呈列貨幣不同，其業績及財務狀況均按以下方法換算為呈列貨幣：

- (a) 每份呈列的資產負債表的資產與負債均以該資產負債表日期的收市匯率換算；

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gain and loss resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated statement of comprehensive income.

Foreign exchange gain and loss that relate to borrowings and cash and cash equivalents are presented in the consolidated statement of comprehensive income within 'finance income or cost'. All other foreign exchange gain and loss are presented in the consolidated statement of comprehensive income within 'other (losses)/gains — net'.

(c) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (a) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (b) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (c) all resulting exchange differences are recognised in other comprehensive income.

(d) 出售海外業務及部分出售

於出售一項海外業務時(即出售本集團於一項海外業務中的全部權益),本公司權益持有人應佔與該業務所涉及於權益累計的所有匯兌差額,將重新分類至綜合全面收益表。

在部分出售而不會導致本集團失去對包括海外業務的附屬公司的控制權的情況下,累計匯兌差額的按比例部分將重新分派予非控股權益,且不會於綜合全面收益表中確認。

2.5 土地使用權

土地使用權指獲得土地使用權而預付的款項,按歷史成本計,並按租賃期以直線法在綜合全面收益表支銷。倘出現減值,減值將於綜合全面收益表中確認。

2.6 物業、廠房及設備

物業、廠房及設備按成本減累計折舊及累計減值虧損(如有)入賬。歷史成本包括因直接購買該等項目而產生的開支。

只有有關項目的未來經濟利益可能流入本集團,且該項目成本能可靠計算時,其後續成本方可計入資產賬面值或確認為個別資產(視適用情況而定)。已更換部分的賬面值會終止確認。所有其他維修及保養開支均於產生該等開支的財政期間自綜合全面收益表扣除。

(d) Disposal of foreign operation and partial disposal

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation), all of the currency translation differences accumulated in equity in respect of that operation attributable to the equity holders of the Company are reclassified to the consolidated statement of comprehensive income.

In the case of a partial disposal that does not result in the Group losing control over a subsidiary that includes a foreign operation, the proportionate share of accumulated currency translation differences are re-attributed to non-controlling interests and are not recognised in consolidated statement of comprehensive income.

2.5 Land use rights

Land use rights represent upfront prepayments made for the land use rights at historical cost, and are expensed in the consolidated statement of comprehensive income on a straight-line basis over the terms of the leases. Whenever there is impairment, the impairment is recognised in the consolidated statement of comprehensive income.

2.6 Property, plant and equipment

Property, plant and equipment is stated at cost less accumulated depreciation and accumulated impairment losses, if any. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the consolidated statement of comprehensive income during the financial period in which they are incurred.

物業、廠房及設備折舊乃按以下估計可使用年期以直線法計算，以將其成本分配至其餘值：

樓宇	20年
租賃裝修	2至10年
傢俬及固定裝置	5至10年
辦公室設備	3至5年
機器	7至10年
汽車	4至5年

餘值介乎零至10%。

資產的餘值及可使用年期於各報告期末審閱，並作適當調整。

倘資產賬面值高於估計可收回金額 (附註2.8)，則該資產的賬面值即時撇減至其可收回金額。

出售收益及虧損乃經比較所得款項與賬面值後釐定，並於綜合全面收益表「其他(虧損)/收益 — 淨額」項下確認。

在建工程指正在興建的廠房及樓宇，按成本減去減值虧損入賬。工程直接應佔歷史開支包括建築成本、開支以及於建築期內產生的適用借貸成本。於有關資產落成並可作擬定用途前，不會就在建工程作出折舊撥備。當有關資產投入使用时，成本將轉撥至物業、廠房及設備下樓宇一項，並根據上述政策予以折舊。

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their costs to their residual values over their estimated useful lives, as follows:

Buildings	20 years
Leasehold improvements	2–10 years
Furniture and fixtures	5–10 years
Office equipment	3–5 years
Machinery	7–10 years
Motor vehicles	4–5 years

Residual values range from nil to 10%.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.8).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within 'Other (losses)/gains — net' in the consolidated statement of comprehensive income.

Construction in progress represents plant and buildings under construction and is stated at cost less impairment losses. Historical expenditure that is directly attributable to the construction comprises construction costs, expenditure and applicable borrowing costs incurred during the construction period. No provision for depreciation is made on construction-in-progress until such time as the relevant assets are completed and ready for intended use. When the assets concerned are brought into use, the costs are transferred to buildings under property, plant and equipment categories and depreciated in accordance with the policy mentioned above.

2.7 無形資產

購入的電腦軟件特許權按購入及使該特定軟件可供使用時所產生成本作資本化處理。此等成本按其估計可使用年期3至5年攤銷。

2.8 非財務資產減值

無限使用年期的無形資產或尚未可供使用的無形資產均毋須進行攤銷，惟每年須進行減值測試。每當有事件或情況變動顯示賬面值或不可收回，則會就攤銷資產作出減值檢討。資產賬面值高於其可收回金額的數額會確認為減值虧損。可收回金額為資產公平值減銷售成本與使用價值兩者的較高者。就評估減值而言，資產按可分開識別現金流量(現金產生單位)的最低級別分組。倘非財務資產(商譽除外)出現減值，則會於各報告日檢討減值是否可予撥回。

2.9 已終止經營業務

已終止經營業務為本集團業務的組成部分，其業務及現金流量可與本集團其他業務清楚區分。已終止經營業務指一項獨立的主要業務。

倘業務被分類為已終止經營業務，則本集團會於綜合全面收益表呈列一項單一金額，該金額包括已終止經營業務的除稅後溢利或虧損及就計量構成已終止經營業務的資產或出售組別的公平值減銷售成本或就出售所確認的除稅後收益或虧損。

2.7 Intangible assets

Acquired computer software licences are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised over their estimated useful lives of 3 to 5 years.

2.8 Impairment of non-financial assets

Intangible assets that have an indefinite useful life or intangible assets not ready to use are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

2.9 Discontinued operations

A discontinued operation is a component of the Group's business, the operations and cash flows of which can be clearly distinguished from the rest of the Group and which represents a separate major line of business.

When an operation is classified as discontinued, a single amount is presented in the consolidated statement of comprehensive income, which comprises the post-tax profit or loss of the discontinued operation and the post-tax gain or loss recognised on the measurement to fair value less costs to sell, or on the disposal, of the assets or disposal group(s) constituting the discontinued operation.

2.10 財務資產

2.10.1 分類

本集團的財務資產分為貸款及應收款項。分類乃按購入財務資產之目的劃分。管理層於首次確認時釐定財務資產的分類。

貸款及應收款項為沒有在活躍市場報價且具備固定或可釐定付款的非衍生財務資產。此等款項計入流動資產，惟不包括現時或預期於報告期末後超過十二個月結算者。該等款項會列作非流動資產。本集團的貸款及應收款項由財務狀況表中「應收賬款及其他應收款項」、及「現金及現金等價物」(附註 2.15 及 2.16) 組成。

2.10.2 確認及計量

按一般方式買賣的財務資產於交易日(本集團承諾買賣資產的日期)確認。從該等投資收取現金流量的權利已到期或已轉讓，且本集團已轉移與擁有權相關的絕大部分風險及回報時，則會終止確認財務資產。貸款及應收款項乃其後使用實際利率法按攤銷成本列賬。

2.11 抵銷財務工具

當有法定可執行權力可抵銷已確認金額，並有意按淨額基準結算或同時變現資產及結算負債時，財務資產與負債可互相抵銷，並在資產負債表報告其淨額。法定可執行權力不得依賴未來事件而定，而必須在一般業務過程中以及倘公司或對手方一旦出現違約、無償債能力或破產時可強制執行。

2.10 Financial assets

2.10.1 Classification

The Group classifies its financial assets as loans and receivables. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for the amounts that are settled or expected to be settled more than 12 months after the end of the reporting period. These are classified as non-current assets. The Group's loans and receivables comprise 'trade and other receivables', and 'cash and cash equivalents' in the statement of financial position (Notes 2.15 and 2.16).

2.10.2 Recognition and measurement

Regular way purchases and sales of financial assets are recognised on the trade-date — the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership. Loans and receivables are subsequently carried at amortised cost using the effective interest method.

2.11 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

2.12 財務資產減值

就按攤銷成本列賬的財務資產而言，本集團於每個報告期末評估是否存在客觀證據證明某項財務資產或某組財務資產出現減值。只有當存在客觀證據證明於首次確認資產後發生一宗或多宗事件導致出現減值（「虧損事項」），而該宗（或該等）虧損事項對該項或該組財務資產的估計未來現金流量構成的影響可以合理估計，有關的財務資產或該組財務資產才會出現減值及產生減值虧損。

減值跡象可包括一名或一組債務人正面臨重大財務困難、違約或未能償還利息或本金、彼等有可能破產或進行其他財務重組，以及有可觀察得到的數據顯示估計未來現金流量出現可計量的減少，例如欠款數目或出現與違約相關的經濟狀況變動。

就貸款及應收款項類別而言，虧損金額乃按資產賬面值與按財務資產原實際利率貼現的估計未來現金流量（不包括尚未產生的未來信貸虧損）現值間差額計量。資產的賬面值予以削減，而虧損金額則於綜合全面收益表內確認。在實際應用中，本集團可利用觀察所得的市場價格，按工具的公平值計量減值。

倘在往後期間減值虧損的數額減少，而此減少可客觀地聯繫至減值確認後才發生的事件（例如債務人的信貸評級有所改善），則之前已確認的減值虧損可在綜合全面收益表撥回。

2.12 Impairment of financial assets

For financial assets carried at amortised cost, the Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or group of financial assets is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a 'loss event') and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

Evidence of impairment may include indications that the debtors or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation, and where observable data indicate that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

For loans and receivables category, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate. The carrying amount of the asset is reduced and the amount of the loss is recognised in the consolidated statement of comprehensive income. As a practical expedient, the Group may measure impairment on the basis of an instrument's fair value using an observable market price.

If, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised (such as an improvement in the debtor's credit rating), the reversal of the previously recognised impairment loss is recognised in the consolidated statement of comprehensive income.

存貨按成本與可變現淨值的較低者列賬。成本以加權平均法釐定。製成品及在製品的成本包括原材料、直接工資、其他直接成本及相關生產開支(根據正常營運產能)，惟不包括借貸成本。可變現淨值指日常業務過程中的估計售價，減適用可變銷售開支。

2.14 發展中物業

發展中物業按成本與可變現淨值兩者的較低者入賬。可變現淨值乃參考日常業務中出售物業的銷售所得款項減相關可變銷售開支及完成估計開支，或由管理層基於當時市況估計而定。

物業發展成本包括土地使用權成本、建築成本、資本化融資成本及發展期間產生的專業費用。竣工後，有關物業轉撥至持作出售已竣工物業。

發展中物業歸類為流動資產，除非有關物業開發項目的建築工程預期需要超過正常營運週期方可完成，則作別論。

2.15 應收賬款及其他應收款項

應收賬款為在日常業務中就所售出貨品應收客戶的款項。應收賬款及其他應收款項倘預期在一年或以內收回，將被分類為流動資產；否則分類為非流動資產。

應收賬款及其他應收款項初步按公平值確認，其後利用實際利率法按攤銷成本扣除減值撥備計量。有關本集團應收賬款會計處理的進一步資料，請參閱附註2.10.2，而有關本集團減值政策的說明，請參閱附註2.12。

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average method. The cost of finished goods and work in progress comprises raw materials, direct labor, other direct costs and related production overheads (based on normal operating capacity). It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.14 Properties under development

Properties under development are stated at the lower of cost and net realisable value. Net realisable value is determined by reference to the sale proceeds of properties in the ordinary course of business, less applicable variable selling expenses and the anticipated costs to completion, or by management estimates based on prevailing marketing conditions.

Development cost of property comprises costs of land use rights, construction costs, capitalised finance costs and professional fees incurred during the development period. On completion, the properties are transferred to completed properties held for sale.

Properties under development are classified as current assets unless the construction period of the relevant property development project is expected to complete beyond the normal operating cycle.

2.15 Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold in the ordinary course of business. If collection of trade and other receivables is expected in one year or less, they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. See Note 2.10.2 for further information about the Group's accounting for trade receivable and Note 2.12 for a description of the Group's impairment policies.

2.16 現金及現金等價物

於綜合現金流量表內，現金及現金等價物包括手頭現金及銀行活期存款。

2.17 股本

普通股分類為權益。直接歸屬於發行新股份或期權的新增成本，在權益中列為所得款項減少(扣除稅項)。

2.18 應付賬款及其他應付款項

應付賬款為於日常業務過程中向供應商購入貨品或服務產生的付款責任。倘應付賬款的支付日期在一年或以內，則有關應付賬款會分類為流動負債，否則分類為非流動負債。

應付賬款初步按公平值確認，其後利用實際利率法按攤銷成本計量。

2.19 借貸

借貸初步按公平值並扣除產生的交易成本確認。借貸其後按攤銷成本列賬；所得款項(扣除交易成本)與贖回價值的任何差額採用實際利率法，於借貸期間在綜合全面收益表確認。

除非本集團有無條件權利將負債的結算遞延至報告期末後最少12個月，否則借貸分類為流動負債。

2.16 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents includes cash in hand and deposits held at call with banks.

2.17 Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

2.18 Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Accounts payable is classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities.

Trade payable is recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.19 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of comprehensive income over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

2.20 借貸成本

直接歸屬於收購、建造或生產合資格資產(指需經一段較長時間籌備方能作預定用途或出售的資產)的一般及專用借貸成本，計入該等資產之成本內，直至該等資產大致作其預定用途或出售為止。

在專用借貸撥作合資格資產支出前之暫時投資所賺取投資收入，應自合資格撥充資本的借貸成本中扣除。

所有其他借貸成本於其產生期間於綜合全面收益表中確認。

2.21 即期及遞延所得稅

年內的稅項支出包括即期及遞延稅項。稅項於綜合全面收益表內確認，惟與直接於權益中確認的項目有關者則除外。在此情況下，稅項亦直接於權益中確認。

(a) 即期所得稅

即期所得稅支出，根據本公司的附屬公司營運及產生應課稅收入所在國家於結算日已生效或實質生效的稅務法例計算。管理層就適用稅務規例有待詮釋的情況定期評估稅務申報的狀況，並在適用情況下根據預期須向有關稅務機關支付的稅款設定撥備。

2.20 Borrowing costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in the consolidated statement of comprehensive income in the period in which they are incurred.

2.21 Current and deferred income tax

The tax expense for the year comprises current and deferred tax. Tax is recognised in the consolidated statement of comprehensive income, except to the extent that it relates to items recognised directly in equity. In this case the tax is also recognised directly in equity.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

2.21 即期及遞延所得稅 (續)

(b) 遞延所得稅

內在基準差異

遞延所得稅乃採用負債法，就資產和負債的稅基與其在綜合財務狀況表賬面值間暫時差額予以確認。遞延所得稅乃以於結算日前已生效或實際生效的稅率（及稅法）並以預期於變現相關遞延所得稅資產或償還遞延所得稅負債時適用稅率釐定。

確認遞延所得稅資產以預期日後可能出現應課稅溢利用作抵銷暫時差額為限。

外在基準差異

本集團就於附屬公司的投資所產生暫時差額作出遞延所得稅撥備，惟本集團可控制撥回暫時差額的時間且暫時差額不大可能於可預見將來撥回的遞延所得稅負債除外。

(c) 抵銷

當有法定可執行權利將流動稅項資產與流動稅項負債抵銷，且遞延所得稅資產與負債涉及由同一稅務機關對有意以淨額基準結算所得稅結餘的應課稅實體或不同應課稅實體徵收的所得稅時，則遞延所得稅資產與負債可互相抵銷。

2.21 Current and deferred income tax (Continued)

(b) Deferred income tax

Inside basis differences

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated statement of financial position. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Outside basis differences

Deferred income tax is provided on temporary differences arising on investments in subsidiaries, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

(c) Offsetting

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income tax assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

2.22 僱員福利 — 退休金責任

本集團為其所有香港僱員運作根據強制性公積金計劃條例設立的定額供款強制性公積金退休計劃(「退休金計劃」)。退休金計劃的供款按僱員基本薪金的特定百分比計算，並於根據退休金計劃規定應支付供款時，在綜合全面收益表扣除。退休金計劃的資產與本集團的資產分開持有，由獨立管理基金保管。本集團於支付供款後即無其他付款責任。

此外，根據中國的政府規例，本集團須按中國員工該年度的工資約7%至20%，就若干退休福利計劃供款，由地方市政府承擔本集團該等僱員的退休福利責任。就該等退休福利計劃作出的供款，於產生時在綜合全面收益表扣除。

2.23 撥備

當本集團因過往已發生的事件而產生現有法定或推定責任；很可能需要資源流出以償付責任，且金額已可靠估計時便會確認撥備。概不會就日後經營虧損確認撥備。

倘有多項類似責任，則釐定需要流出資源償付的可能性時，整體考慮責任的類別。即使就同一責任類別所包含任何一個項目流出資源的可能性極低，仍須確認撥備。

撥備按照預期須償付有關責任開支的現值，採用稅前利率計量，該利率反映當時市場對金錢時間值及有關責任固有風險的評估。隨著時間過去而增加的撥備確認為利息開支。

2.22 Employee benefits — pension obligation

The Group operates a defined contribution Mandatory Provident Fund retirement benefits scheme (the “Pension Scheme”) set up pursuant to the Mandatory Provident Fund Schemes Ordinance, for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees’ basic salaries and are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the Pension Scheme. The assets of the Pension Scheme are held separately from those of the Group in an independently administrated fund. The Group has no further payment obligations once the contributions have been paid.

In addition, pursuant to the government regulations in the PRC, the Group is required to contribute an amount to certain retirement benefit schemes based on approximately 7% to 20% of the wages for the year of those employees in the PRC. The local municipal government undertakes to assume the retirement benefits obligations of those employees of the Group. Contributions to these retirement benefits schemes are charged to the consolidated statement of comprehensive income as incurred.

2.23 Provisions

Provisions are recognised when: the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

2.24 收益確認

收益按已收或應收代價公平值計量，指所供應貨品的應收金額，扣除折扣、退貨及增值稅後列賬。本集團於收益金額能可靠計量；且日後經濟利益可能會流入實體；及下文所述本集團各項活動的特定準則獲達成時確認收益。本集團根據過往業績估計回報，並已計及客戶類別、交易類別及各項安排的細節。

(a) 貨品銷售 — 服裝供應鏈服務業務

本集團向多個全球知名品牌擁有人或代理提供廣泛的梭織及針織產品。於貨品的風險及回報轉讓予批發商後，即通常於本集團的實體將產品交付予批發商，而批發商接納該等產品且並無可影響批發商接納該等產品的未履行責任的日期，即確認貨品銷售的收益。

(b) 貨品銷售 — 服裝零售業務

本集團經營銷售梭織及針織產品的連鎖零售門店。貨品銷售於集團實體向自營零售門店客戶售出貨品時確認。本集團並無運作任何積分計劃。

(c) 諮詢服務收入

本集團提供諮詢服務。有關服務收入於提供服務及交易結果能可靠計量時確認。

(d) 租金收入

租金收入乃按直線法於各租期內確認。

2.24 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts, returns and value added taxes. The Group recognises revenue when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the entity; and when specific criteria have been met for each of the Group's activities, as described below. The Group bases its estimates of return on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

(a) Sales of goods — Apparel Supply Chain Servicing Business

The Group manufactures and sells a wide range of woven wear and knitwear products to a number of owners or agents of global reputable brands. Revenue from the sales of goods is recognised when the risks and rewards of the goods have been transferred to the wholesaler, which is usually at the date when an entity of the Group has delivered products to the wholesaler, the wholesaler has accepted the products, and there is no unfulfilled obligation that could affect the wholesaler's acceptance of the products.

(b) Sale of goods — Apparel Retail Business

The Group operate a chain of retail outlets for selling woven wear and knitwear products. Sales of goods were recognised when a Group entity sold a product to the customers of self-operated retail outlets. The Group did not operate any loyalty programmes.

(c) Consulting service income

The Group provides consulting service. The service income is recognised upon the rendering of services and when the outcome of the transaction can be estimated reliably.

(d) Rental income

Rental income is recognised on a straight-line basis over the terms of the respective leases.

(e) 利息收入

利息收入使用實際利率法確認。倘一項貸款及應收款項出現減值，本集團會將賬面值減至其可收回金額，即按該財務工具原實際利率貼現的估計日後現金流量，並持續轉回貼現為利息收入。已減值貸款及應收款項的利息收入，採用原實際利率確認。

(f) 股息收入

股息收入於收取付款的權利確立時確認。

2.25 租賃

凡擁有權的大部分風險及回報仍歸出租人所有的租賃，皆分類為經營租賃。根據經營租賃支付的款項(扣除出租人給予的任何優惠)，於租期內以直線法在綜合全面收益表確認。

本集團租賃若干物業、廠房及設備。凡本集團持有擁有權的絕大部分風險及回報的物業、廠房及設備租約，均分類為融資租賃。融資租賃在租約開始時按租賃物業的公平值及最低租賃付款現值兩者的較低者入賬。

每項租金均分攤為負債及融資費用。相應租賃責任在扣除融資開支後計入其他長期應付款項內。財務成本的利息部分於租期內於綜合全面收益表扣除，使融資成本與每個期間的負債餘額達致常數定期利率。根據融資租賃取得的物業、廠房及設備於資產可使用年期及租期兩者的較短者內折舊。

2.24 Revenue recognition (Continued)

(e) Interest income

Interest income is recognised using the effective interest method. When a loan and receivable is impaired, the Group reduces the carrying amount to its recoverable amount, being the estimated future cash flow discounted at the original effective interest rate of the instrument, and continues unwinding the discount as interest income. Interest income on impaired loans and receivables are recognised using the original effective interest rate.

(f) Dividend income

Dividend income is recognised when the right to receive payment is established.

2.25 Leases

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating leases. Payments made under operating leases (net of any incentives received from the lessor) are charged to the consolidated statement of comprehensive income on a straight-line basis over the period of the leases.

The Group leases certain property, plant and equipment. Leases of property, plant and equipment where the Group has substantially all the risks and rewards of ownership are classified as finance leases. Finance leases are capitalised at the lease's commencement at the lower of the fair value of the leased property and the present value of the minimum lease payments.

Each lease payment is allocated between the liability and finance charges. The corresponding rental obligations, net of finance charges, are included in other long-term payables. The interest element of the finance cost is charged to the consolidated statement of comprehensive income over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The property, plant and equipment acquired under finance leases is depreciated over the shorter of the useful life of the asset and the lease term.

2.26 股息分派

向本公司股東分派的股息，於股息獲本公司股東或董事批准（視適用情況而定）的期間內，於本集團及本公司的財務報表內確認為負債。

3 財務風險管理

(a) 財務風險因素

本集團經營活動面對各種財務風險：市場風險（包括貨幣風險、現金流量利率風險及公平值利率風險）、信貸風險及流動資金風險。本集團整體風險管理政策針對難以預測的金融市場，務求盡可能減低對本集團財務表現的潛在不利影響。

(1) 市場風險

(i) 外匯風險

如未來商業交易或已確認資產或負債並非以本集團實體的功能貨幣計值，即產生外匯風險。以人民幣（「人民幣」）作為其功能貨幣的集團公司所面臨外匯風險主要與港元有關。以港元作為其功能貨幣的集團公司所面臨外匯風險主要與人民幣有關。本集團透過密切監察外幣匯率變動以管理其外匯風險。

本集團於中國進行投資，該等投資的資產淨值面臨外幣換算風險。本集團投資資產淨值產生的貨幣風險主要透過中國境外派付股息管理。

2.26 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

3 FINANCIAL RISK MANAGEMENT

(a) Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including currency risk, cash flow interest rate risk and fair value interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(1) Market risk

(i) Foreign exchange risk

Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. For group companies with Renminbi ("RMB") as their functional currency, foreign exchange risk arises primarily with respect to HK\$. For group companies with HK\$ as their functional currency, foreign exchange risk arises primarily with respect to RMB. The Group manages its foreign exchange risk by closely monitoring the movement of the foreign currency rates.

The Group has investments in the PRC, whose net assets are exposed to foreign currency translation risk. Currency exposure arising from the net assets of the Group's investments in the PRC is managed primarily through dividends paid outside the PRC.

於二零一六年十二月三十一日，倘人民幣兌港元貶值／升值1%，而所有其他變數維持不變，則年內除稅後溢利應減少／增加166,000港元(二零一五年：541,000港元)，主要由並非以實體功能貨幣計值的現金及現金等價物、應收賬款及其他應收款項以及應付賬款及其他應付款項的匯兌收益／虧損所致。同樣，對其他儲備權益造成的影響為減少／增加1,050,000港元(二零一五年：3,904,000港元)，主要由於以外幣換算中國資產淨值所致。

(ii) 現金流量及公平值利率風險

本集團面對的利率風險主要源自現金及現金等價物以及借貸。固定利率現金及現金等價物以及借貸導致本集團面臨公平值利率風險。浮動利率現金及現金等價物以及借貸導致本集團面對現金流量利率風險。

於二零一六年及二零一五年十二月三十一日，本集團的現金及現金等價物以及借貸按浮動利率持有。

本集團的借貸的利率及到期日於附註17披露。

(i) Foreign exchange risk (Continued)

At 31 December 2016, if RMB had weakened/strengthened by 1% against HK\$ with all other variables held constant, post-tax profit for the year would have been HK\$166,000 (2015: HK\$541,000) lower/higher, mainly as a result of foreign exchange gains/losses on translation of cash and cash equivalents, trade and other receivables and trade and other payables that are not denominated in the entity's functional currency. Similarly, the impact on equity of other reserves would have been HK\$1,050,000 (2015: HK\$3,904,000) lower/higher, mainly as a result of foreign currency translation on net assets in the PRC.

(ii) Cash flow and fair value interest rate risk

The Group's exposure to interest rate risk arises mainly from cash and cash equivalents and borrowings. Cash and cash equivalents and borrowings at fixed rates expose the Group to fair value interest rate risk. Cash and cash equivalents and borrowings at variable rates expose the Group to cash flow interest rate risk.

As at 31 December 2016 and 2015, the Group's cash and cash equivalents and borrowings were held at variable rates.

The interest rates and maturities of the Group's borrowings are disclosed in Note 17.

管理層監察利率變動，以確保所承受利率風險處於可接受水平範圍內。

於二零一六年十二月三十一日，倘以港元計值借貸之利率上升／下降2.5個基點，而所有其他變數維持不變，則年內除稅後溢利會減少／增加167,000港元(二零一五年：226,000港元)，主要由於浮息借貸之較高／較低利息開支所致。

(2) 信貸風險

信貸風險來自現金及現金等價物以及應收賬款及其他應收款項。上述各類財務資產的賬面值或未貼現面值(視適用情況而定)代表本集團就相應類別財務資產所承受最高信貸風險。

為管理此風險，存款均存入信譽良好的財務機構或由政府控制的財務機構。就服裝零售業務而言，向自營零售門店客戶作出的銷售，一般以現金或信用卡結算。就服裝供應鏈服務業務而言，本集團已定下政策確保貨品均售予知名及在財政實力、信用記錄方面均值得信賴的客戶，並在收取適當百分比的訂金後開始發貨。本集團亦設有其他監察程序，確保採取跟進行動追收逾期欠款。此外，本集團定期檢討向個別客戶授出的信貸限額及個別應收賬款的可收回金額，確保就無法收回的款項作出充足減值虧損撥備。

Management monitors interest rate fluctuations to ensure that exposure to interest rate risk is within an acceptable level.

At 31 December 2016, if interest rates on Hong Kong dollar-denominated borrowings had been 2.5 basis points higher/lower with all other variables held constant, post-tax profit for the year would have been HK\$167,000 (2015: HK\$226,000) lower/higher, mainly as a result of higher/lower interest expense on floating rate borrowings.

(2) Credit risk

Credit risk arises from cash and cash equivalents, and trade and other receivables. The carrying amounts or the undiscounted nominal amounts, where applicable, of each class of these financial assets represent the Group's maximum exposure to credit risk in relation to the corresponding class of financial assets.

To manage this risk, deposits are mainly placed with reputable financial institutions or with financial institutions which are controlled by the government. For Apparel Retail Business, sales made to customers of self-operated retail outlets are usually settled by cash or credit cards. For Apparel Supply Chain Servicing Business, the Group has policies in place to ensure that sales are made to reputable and credit-worthy customers with an appropriate financial strength, credit history and after receiving an appropriate percentage of down payments. It also has other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews regularly the authorisation of credit limits to individual customers and recoverable amount of individual trade receivable to ensure that adequate impairment losses are made for non-recoverable amounts.

本集團存在信貸風險集中的情況。五大客戶所佔銷貨額約為1,044,700,000港元(二零一五年: 1,175,690,000港元)，佔本集團截至二零一六年十二月三十一日止年度的收益96.0%(二零一五年: 佔96.1%)，五大應收賬款結餘約為191,007,000港元(二零一五年: 190,993,000港元)，佔二零一六年十二月三十一日的應收賬款結餘總額96.6%(二零一五年: 佔92.5%)。本集團不斷密切監察尚欠應收款項結餘的收賬情況，盡量降低該信貸風險。

(3) 流動資金風險

審慎的流動資金風險管理意味著需要維持充足現金及現金等價物以及透過足夠的信貸融資額度獲得備用資金。本集團以經營業務所得資金及銀行借貸提供所需營運資金。

The Group has concentration of credit risk. Sales of goods to the top five customers constituted approximately HK\$1,044,700,000, representing 96.0% of the Group's revenue for the year ended 31 December 2016 (2015: HK\$1,175,690,000, representing 96.1%). The top five trade receivable balances accounted for approximately HK\$191,007,000, representing 96.6% of the gross trade receivable balances as at 31 December 2016 (2015: HK\$190,993,000, representing 92.5%). Collections of outstanding receivable balances are closely monitored on an ongoing basis to minimise such credit risk.

(3) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and cash equivalents and the availability of funding through an adequate amount of committed credit facilities. The Group finances its working capital requirements through a combination of funds generated from operations and bank borrowings.

The table below analyses the Group's non-derivative financial liabilities into relevant maturity groupings based on the remaining period from the consolidated statement of financial position date to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows.

(b) Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

Consistent with others in the industry, the Group monitors capital on the basis of the gearing ratio. This ratio is calculated at net debt divided by total equity. Net debt is calculated as total borrowings as shown in the consolidated statement of financial position, less cash and cash equivalents.

The gearing ratio is calculated as follows:

The fair value of financial liabilities for disclosure purpose is estimated by discounting the future contractual cash flows at the current market interest rate that is available to the Group for similar financial instruments.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Current and deferred income taxes

Significant judgment is required in determining the provision for income tax. There are many transactions and calculations for which the ultimate determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such difference will impact the income tax and deferred tax provision in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and tax losses are recognised when management considers to be probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. The outcome of their actual utilisation may be different.

(b) Net realisable value of inventories

Net realisable value of inventories is the estimated selling prices in the ordinary course of business less estimated selling expenses. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of changes in economic conditions in places where the Group operates and changes in customer taste and competitor actions in response to changes in market conditions. Management reassesses these estimates at each reporting date.

(c) Impairment of receivables

The Group makes allowance for impairment of receivables based on an assessment of the recoverability of the receivables. Provisions are applied to the receivables where events or changes in circumstances indicate that the balances may not be collectible. The identification of impairment requires the use of judgment and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of the receivables and provision for impaired receivables in the period in which such estimate has been changed.
