I. INTRODUCTION

The purpose of this circular is to give you information regarding the following resolutions to be proposed at the Annual General Meeting to enable the Shareholders to make an informed decision on whether to vote for or against the resolutions, notice of which is set out on pages 14 to 18 of this circular.

LETTER FROM THE BOARD

At the Annual General Meeting, the resolutions regarding: (i) the re-election of the Directors; and (ii) the granting to the Directors general mandates for the issue and repurchase of the Shares.

II. PROPOSED RE-ELECTION OF THE DIRECTORS

Pursuant to Bye-laws 99, at each annual general meeting one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest one-third, shall retire from office by rotation save any Director holding office as Chairman or Managing Director. The Directors to retire in every year shall be those who have been longest in office since their last election. The retiring Directors shall be eligible for re-election.

Messrs. Neil Bush should retire and re-elect at the forthcoming Annual General Meeting.

Pursuant to A.4.3 of the Corporate Governance Code, any further appointment of an Independent Non- Executive Director in excess of nine years should subject to a separate resolution to be approved by shareholders.

Messrs. Chen Wei-Ming Eric, Kwan Wang Wai Alan and Ng Chi Kin David have served as an Independent Non-executive Director for more than nine years. Therefore, Messrs. Chen Wei-Ming Eric, Kwan Wang Wai Alan and Ng Chi Kin David should retire and re-election at the forthcoming annual general meeting.

The Directors are of the opinion that they remain independent, notwithstanding their length of tenure. They continue to demonstrate the attributes of an Independent Non-Executive Director noted above and there is no evidence that their tenure has had any impact on his independence. The Board believes that their detailed knowledge and experience of the Group's business and their external experience continue to be of significant benefit to the Company, and that they maintain an independent view of its affairs.

Each of the Independent Non-Executive Directors has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all Independent Non-Executive Directors meet the independence guidelines set out in Rule 3.13 of the Listing Rules.

Details of the abovementioned Directors, Messrs. Neil Bush, Chen Wei-Ming Eric, Kwan Wang Wai Alan and Ng Chi Kin David who are proposed to be re-elected at the Annual General Meeting, are set out in Appendix I to this circular. At the Annual General Meeting, ordinary resolutions will be proposed to approve the re-election of Messrs. Neil Bush as Executive Director and Messrs. Chen Wei-Ming Eric, Kwan Wang Wai Alan and Ng Chi Kin David as Independent Non-Executive Directors of the Company.

III. PROPOSED GRANTING OF GENERAL MANDATE TO ISSUE SHARES

At the Annual General Meeting, an ordinary resolution will be proposed that the Directors be given a general and unconditional mandate to allot, issue and deal with additional Shares representing not more than 20% of the aggregate nominal amount of the issued share capital of the Company at the date the relevant resolution is passed at the Annual General Meeting (the “Issue Mandate”).

IV. PROPOSED GRANTING OF GENERAL MANDATE TO REPURCHASE SHARES

At the Annual General Meeting, an ordinary resolution will be proposed that the Directors be given a general and unconditional mandate to exercise all powers of the Company to repurchase on the Stock Exchange the Shares in the Company up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company at the date the relevant resolution is passed at the Annual General Meeting (the “Repurchase Mandate”).

In addition, an ordinary resolution will be proposed at the Annual General Meeting providing that any Shares repurchased under the Repurchase Mandate (up to maximum of 10% of the issued Shares as at the date of the grant of the Repurchase Mandate) will be added to the total number of Shares which may be allotted and issued under the Issue Mandate.

The Repurchase Mandate and the Issue Mandate would continue in force until the first occurrence of either the conclusion of the next annual general meeting of the Company following the passing of the relevant resolutions unless it is renewed at such meeting or the expiration of the period within which the next annual general meeting of the Company is required by the Company’s Bye-laws or any applicable law to be held or it is revoked or varied by an ordinary resolution of the Shareholders in general meeting.

An explanatory statement required by the Listing Rules to be sent to the Shareholders in connection with the proposed general mandate to repurchase Shares is set out in the Appendix II to this circular. The explanatory statement contains all information reasonably necessary to enable the Shareholders to make an informed decision as to whether to vote for or against the resolution at the Annual General Meeting.

V. CLOSURE OF REGISTER OF MEMBERS

The register of members of the Company will be closed from Thursday, 22 June 2017 to Wednesday, 28 June 2017 (both days inclusive), during which period no transfer of shares of the Company will be registered. To be eligible to attend and vote at the AGM, all share transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar and transfer office in Hong Kong, Tricor Standard Limited, at level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong for registration no later than 4:30 p.m. on Wednesday, 21 June 2017.

VI. NOTICE OF ANNUAL GENERAL MEETING

A notice convening the Annual General Meeting to be held at 11:00 a.m. on Wednesday, 28 June 2017 at Units 1910-12, 19th Floor, China Merchants Tower, Shun Tak Centre, 168-200 Connaught Road Central, Sheung Wan, Hong Kong is set out pages 14 to 18 of this circular for the purpose of considering and, if thought fit, passing: (i) an ordinary resolution to re-elect of the Directors; and (ii) an ordinary resolution to grant to the Directors general mandates for the issue of the Shares and the repurchase of its Shares.

VII. FORM OF PROXY

A form of proxy is enclosed for use by the Shareholders. Such form of proxy is also published on the website of the Stock Exchange (www.hkexnews.hk) and the website of the Company (www.hoifuenergy.com). Shareholders are requested to complete and return the form of proxy to the Company's branch share registrar and transfer office in Hong Kong, Tricor Standard Limited at level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible, but in any event not less than 48 hours before the scheduled time of the Annual General Meeting. The lodging of the form of proxy will not preclude the Shareholders from attending the Annual General Meeting and voting in person should he so wish. No Shareholder is required under the Listing Rules to abstain from voting at the Annual General Meeting.

VIII. VOTING BY WAY OF POLL

Pursuant to Rule 13.39(4) of the Listing Rules, all votes of the Shareholders at the AGM will be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Therefore, the chairman of the AGM will demand a poll for each and every resolution put forward at the AGM pursuant to bye-law 70 of the Bye-laws. The Company will appoint scrutineers to handle vote-taking procedures at the AGM. An announcement on the poll voting results will be published by the Company after the AGM in the manner prescribed under Rule 13.39(5) of the Listing Rules.

IX. RECOMMENDATION

The Board is of the opinion that (i) the re-election of the Directors; and (ii) the granting of the general mandates to the Directors to issue Shares and to repurchase Shares are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of the relevant resolutions to be proposed at the Annual General Meeting.

MR. CHEN WEI-MING ERIC

Mr. Chen Wei-Ming Eric, aged 53, was appointed as an independent non-executive Director on 8 September 2000, since the listing of the Company. Mr. Chen does not hold other position in the Group. Mr. Chen is a director of several general trading companies in Hong Kong. Mr. Chen holds a Bachelor of Science degree in Business Administration from the Boston University in Massachusetts, USA and is engaged in the food import business. Mr. Chen did not hold directorship in other listed public companies in Hong Kong in the last three years.

Mr. Chen is appointed for a specific term for three years and subject to retirement and re-election provisions in accordance with the Bye-laws. Mr. Chen's annual remuneration is HK\$50,000 which is based on mutual agreement between the Board and Mr. Chen and Mr. Chen's responsibilities and duties in the Company.

MR. KWAN WANG WAI ALAN

Mr. Kwan Wang Wai Alan, aged 54, was appointed as an independent non-executive Director on September 2004, Mr. Kwan does not hold other position in the Group. Mr Kwan holds a Bachelor of Arts degree in Engineering Science and a Master of Arts degree from the University of Oxford and has over 19 years of experience in the consumer electronics field. Mr. Kwan is also independent non-executive director of Asia Tele-Net and Technology Corporation Limited (Stock Code: 679), a publicly listed company in Hong Kong. Other than that, Mr. Kwan did not hold directorship in other listed public companies in Hong Kong in the last three years.

Mr. Kwan is appointed for a specific term for three years and subject to retirement and reelection provisions in accordance with the Bye-laws. Mr. Kwan's annual remuneration is HK\$50,000 which is based on mutual agreement between the Board and Mr. Kwan and Mr. Kwan's responsibilities and duties in the Company.

MR. NG CHI KIN DAVID

Mr. Ng Chi Kin David, aged 55, was appointed as an independent non-executive Director on 8 September 2000, since the listing of the Company. Mr. Ng is the independent non-executive Director with appropriate professional qualifications or accounting or related financial management expertise of the Company pursuant to Rule 3.10(2) of the Listing Rules. Mr. Ng does not hold other position in the Group. Mr. Ng is a professional accountant with over twenty-four years of professional experience and is a fellow member of the Hong Kong Institute of Certified Public Accounts, member of CPA Australia, Hong Kong Institute of Company Secretaries and Institute of Chartered Secretaries and Administrators in the United Kingdom. Mr. Ng is also an independent non-executive director of Asia Tele-Net and Technology Corporation Limited, (Stock Code: 679) a publicly listed company in Hong Kong. Other than this and the directorship in the Company, he did not hold directorship in other listed public companies in Hong Kong in the last three years.

Mr. Ng is appointed for a specific term for three years and subject to retirement and reelection provisions in accordance with the Bye-laws. Mr. Ng's annual remuneration is HK\$50,000 which is based on mutual agreement between the Board and Mr. Ng and Mr. Ng's responsibilities and duties in the Company.

MR. NEIL BUSH

Mr. Neil Bush, aged 62, was appointed the Deputy Chairman and an executive director on 15 November 2012 of the Company. He is responsible for the implementation of the overall strategic planning and development of the Group. Mr. Bush graduated from Tulane University with a bachelor's degree in International Economics and from the Tulane University Freeman School of Business with a master's degree in Business Administration. Mr. Bush had over 30 years of experience in domestic and international energy and real estate business development. He formed oil companies which explored oil resources in various states in the United States of America and overseas. Mr. Bush has engaged in various international business development activities with a focus on the PRC and Middle East. Since 1975, Mr. Bush has traveled to the PRC over 140 times and worked with numerous entities on a variety of projects including real estate development, energy, automobile parts, sheet rock manufacturing and paint production. From 7 December 2010 to 20 July 2012, Mr. Bush was a non-executive director of China Resources and Transportation Group Limited, a company of which the shares are listed on the Stock Exchange (stock code: 269). Since 22 April 2013, Mr. Neil Bush has been serving as the Non-Executive Chairman on the board of SGX-ST Mainboard-listed SingHaiyi Group Limited, a Singapore based real estate company. He is also the Chairman of the Points of Light, a national charitable organisation formed by President George H.W. Bush in 1989 that promotes citizen service through volunteerism in communities all across America and increasingly overseas. Mr. Bush serves as Chairman of the Barbara Bush Houston Literacy Foundation, and on the boards of the Houston Salvation Army and the Bush School of Government and Public Service..

Mr. Neil Bush is appointed for a specific term for three years and subject to retirement and reelection provisions in accordance with the Bye-laws. Mr. Neil Bush's annual remuneration is HK\$600,000 which is based on mutual agreement between the Board and Mr. Neil Bush and Mr. Neil Bush's responsibilities and duties in the Company.

This Appendix serves as an explanatory statement, as required by the Listing Rules to be sent to the Shareholders of the Company to enable the Shareholders to make informed decision whether to vote for or against the resolution at the Annual General Meeting in relation to the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 2,521,280,885 Shares.

Subject to the passing of the ordinary resolution granting the Proposed Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 252,128,088 Shares during the period in which the Repurchase Mandate remains in force.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and its Shareholders to seek the Repurchase Mandate which enables the Directors to repurchase the Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its Shareholders. The Directors have no present intention to repurchase any Shares.

3. DIRECTORS' DEALING AND CONNECTED PERSONS

None of the Directors, to the best of their knowledge having made all reasonable enquiries, or any of their associates (as defined in the Listing Rules) have any present intention, if the Repurchase Mandate is approved by the Shareholders at the Annual General Meeting, to sell all of their Shares to the Company or its subsidiaries. No connected persons or their respective associates (as defined in the Listing Rules) have notified the Company that they have a present intention to sell their Shares to the Company, or have undertaken not to do so in the event that the Company is authorised to make repurchase of the Shares.

4. FUNDING OF REPURCHASES

Repurchases must be funded entirely from the Company's available cash flow or working capital facilities, which will be funded by resources legally available for that purpose in accordance with the Company's Bye-Laws and the laws of Bermuda. The Company is empowered by its memorandum of association and Bye-laws to purchase its Shares. Bermuda law provides that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or the funds of the Company that would otherwise be available for dividend or distribution or the proceeds of a new issue of shares made for such purpose. The amount of premium payable on repurchase may only be paid out of either the funds of the Company that would otherwise be available for dividend or distribution or out of the share premium account of the Company.

If the Repurchase Mandate is exercised in full, there might be a material adverse effect on the working capital or gearing position of the Company (as compared with the position disclosed in the audited financial statements contained in the Annual Report). However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels of the Company.

6. DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange that they will exercise the Repurchase Mandate in accordance with the applicable Listing Rules and the laws of Bermuda.

7. HONG KONG CODE ON TAKEOVERS AND MERGERS

If on the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Dr. Hui Chi Ming, Mr. Huang Huafeng, Mr. Xu Zhenhui, Mr. Liu Hao and Taiming Petroleum Group Limited (“Taiming”) through Triumph Energy Group Limited (“Triumph”) were deemed to be interested in an aggregate of 891,821,143 Shares, representing approximately 35.37% of the issued share capital of the Company.

Triumph is beneficially and indirectly owned as to 84.25% by Dr. Hui Chi Ming, 7.09% by Mr. Xu Zhenhui, 7.33% by Mr. Huang Huafeng and 1.33% by Mr. Liu Hao, through Taiming, AMA Energy Group Limited and Simply Superb Holdings Ltd respectively.

Moreover, Dr. Hui Chi Ming through Taiming, Wisdom On Holdings Limited (“Wisdom On”) and Golden Nova Holdings Limited (“Golden Nova”) was deemed to be interested in an aggregate of 4,018,000 Shares, 21,984,000 Shares and 935,026,284 Shares respectively, representing approximately 0.16%, 0.87% and 37.09% of the issued share capital of the Company respectively. Both of Taiming and Golden Nova are beneficially owned as to 100% by Dr. Hui Chi Ming while Wisdom On is beneficially owned as to 100% by Hoifu Petroleum Group Investment Limited, which is wholly owned by Dr. Hui Chi Ming.

In the event that the Directors exercise in full the power to repurchase Shares pursuant to the Repurchase Mandate, the shareholdings of Triumph, Taiming, Wisdom On and Golden Nova in the Company will increase to approximately 39.30%, 0.18%, 0.97% and 41.21% of the total issued share capital of the Company respectively and such increase would give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. However, the Directors have no intention to exercise the Repurchase Mandate to such an extent that as would give rise to such obligation. Save as aforesaid, the Directors are not aware of any consequence which would arise under the Takeovers Code as a consequence of any repurchases pursuant to the Repurchase Mandate. The Directors have no intention to exercise the Repurchase Mandate to such an extent that will result in the number of Shares in hands of public falling below the prescribed minimum percentage of 25%.

8. SHARE REPURCHASES MADE BY THE COMPANY

The Company had not purchased any of its shares during the six months preceding the Latest Practicable Date.
