



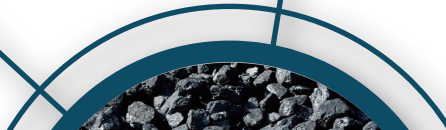

CHAIRMAN'S STATEMENT

主席報告書

Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (the “**Directors**”) of China Qinfra Group Limited (the “**Qinfra Group**” or the “**Company**”), I hereby present the annual result of the Company and its subsidiaries (the “**Group**”) for the year ended 31 December 2016.

CUTTING PRODUCTION CAPACITY AND CONTROLLING PRODUCTION VOLUME-KEY WORDS OF CHINA'S COAL INDUSTRY IN 2016

The coal industry has been in excess production capacity with decreasing coal price and the utilisation of the production capacity has been far lower than the normal level since 2011. The national goal is to cut production capacity by approximately 800 million tonnes in the future 3-5 years. As such, the four ministries including Ministry of Human Resources and Social Security and the Central Bank launched various ancillary policies to strictly control the credit investment in outdated capacity and establish proprietary incentive funds of RMB100 billion, which policies are the most useful to cut capacity. In 2016, the coal production capacity of Shanxi reduced 143 million tonnes as compared to last year, representing a decrease of 14.7%, and the total reduced capacity was 47.7% of the national reduced coal production volume of 300 million tonnes.

The coal price increased rapidly in the previous three quarters as a result of margin supply gap due to production curtailment. The 276 working days restriction policy in late March was allowed to extend to 330 working days by National Development and Reform Commission in early October for eligible coal mines to operate in the heating season of the fourth quarter, resulting in the coal price decreasing slightly from a top level. Although the moderate increased coal price and improved profits contribute to the results of the Group, the demands for coal continued decreasing as a result of the slowdown of the macro economic growth. Furthermore, the coal price has decreased for many years and the gearing ratio of coal enterprises are high, so such contribution can't change the weakness of many years and the industry remains in a difficult situation. Therefore, the Group should conduct its businesses with caution.

In 2016, against the backdrop of cutting industrial capacity, the Group's coal operation and trading volume continued to decrease as compared to 2015. Under the difficult operating environment, the Group has always been persisting in its position and taken more cautious response measures according to situations on a timely basis.

尊敬的各位股東：

本人僅代表中國秦發集團有限公司（「**秦發集團**」或「**本公司**」）董事（「**董事**」）會（「**董事會**」）提呈本公司及其附屬公司（「**本集團**」）截至二零一六年十二月三十一日止年度之全年業績。

去產能、控產量－2016年中國煤炭行業的關鍵字

自2011年以來，煤炭生產過剩，煤價持續下跌，產能利用率遠低於正常水準。國家目標未來3-5年退出產能約8億噸，為此，人社部、央行等四部委紛紛出台嚴控落後產能的信貸投放、設立1000億元專項獎補資金的配套政策，去產能的作用將最為顯著。2016年山西煤炭產量同比壓減1.43億噸、減幅14.7%，減產總量佔全國壓減煤炭產量3億噸的47.7%。

由於限產造成邊際供給缺口，煤價前三季度快速攀升，3月底的276天限產政策至10月初發改委表示允許合格煤礦在第四季度的用煤旺季擴產至330天，煤價從高點稍回落。儘管煤價稍有回升，盈利有所改善，為本集團帶來一點小陽春，但宏觀經濟增速放緩導致煤炭需求繼續下降，且煤價下跌數年，煤炭企業資產負債率高企，一點暖意並未能化解多年積寒，行業生存環境依舊十分嚴峻，本集團仍需步步為營。

二零一六年，在去產能的大環境下本集團煤炭經營及貿易量較二零一五年繼續下跌，在多方困難的經營環境下，本集團一直緊守位置卻不敢怠慢，時刻根據情況適時採取更謹慎的應對措施。

CHAIRMAN'S STATEMENT 主席報告書

PROPOSED DISPOSAL OF GROUP'S COAL BUSINESS AND SHIPPING BUSINESS IN THE PRC

As the coal business and shipping business in the PRC have uncertain prospects and their losses have affected the operation and financial activities of the Group, the Company, after cautious consideration and discuss and in the best interests of the stakeholders, intended to dispose of the Group's coal business and shipping business in the PRC, and retain international shipping business that can bring steady cash flows, so as to improve the financial position of the Group and more effectively use all kinds of resources.

SEIZING OPPORTUNITIES AND OPTIMISING PRODUCTION, TRANSPORTATION AND SALES TO ACHIEVE IMPROVED MECHANISM THROUGH COMPREHENSIVE COOPERATION IN ALL RESPECTS

The market changes rapidly. To seize the opportunities resulted from the changing demand for coal and increase in the coal price, the Group held communication meetings every week for main departments including production, transportation and sales departments. Each department mutually provided support and collaboration and timely adjusted the strategy of production, transportation and sales to seize market opportunities in advance, leading to realise goals as scheduled and even better than expect.

For the coal production, the production department reports production plan on a monthly basis, sets indicators of cost and profit, specifies appraisal, reward and punishment, effectively controls costs, and balance the relationship between production and costs to guarantee the production capacity upon the rebound of the coal price;

For the coal logistics, the Group actively strengthens the transportation and storage management, implements effective connecting system, reduces losses, and implements quality punishment system;

For sales of coal, the Group places great emphasis in the investigation of clients' creditworthiness, takes flexible marketing strategy and communicates in time, and also strengthens the management of receivables;

Strengthening the management and control of logistics, market and finance involved in the operation, optimising the group organisation structure and improving its internal control system, the Group believes that these relevant measures can optimise the organisation structure, enhance its production capacity, update its service and generate a novel operation situation.

擬出售集團的煤炭業務及中國航運業務

由於煤炭業務及中國航運業務前景不明朗，且虧損程度已影響到集團的經營及融資活動狀況，經過謹慎考慮及討論，以各方持份者最大利益為出發點，本公司擬出售集團的煤炭業務及中國航運業務，保留能帶來穩定現金流的國際航運業務，藉此改善集團的財務狀況及更有效地運用各項資源。

把握時機，優化生產運輸銷售，各方位全面配合，達致完善機制

市場變化迅速，為抓住煤炭需求變動趨勢、煤價上漲的時機，本集團每週組織產運銷等主要部門溝通會議，各部門互相究輔助，合作無間，及時調整產運銷策略，掌握市場先機，令目標如期實現，甚至超出理想。

於煤炭生產方面，生產部按月上報生產計劃，組織下達成本利潤指標，明確考核獎罰，有效控制成本，抓好生產及成本之間關係，在煤價回升之時保證產能數；

煤炭物流方面，則積極加強運輸及儲存管理，落實高效銜接系統，減少虧噸掉卡、實行品質扣罰制度；

煤炭銷售方面，本集團非常重視客戶信用調查、採取靈活行銷策略和及時溝通，同時加強應收賬款的管理；

加強營運中涉及的物流、市場、財務等管控，優化集團組織架構、完善內部控制制度，相信相關措施定能優化組織架構，推動企業生產能力，將服務升級，帶來一個嶄新的營運層面。

CHAIRMAN'S STATEMENT

主席報告書

As one of the key areas of supply-side structural reform, the coal industry's priority next year remains to cut excessive capacity. Under the changing operational environment, the Group is used to developing and seeking opportunities amidst difficult situations. We are brave enough to analyse the situations and seize opportunities, dare to find out problems and bear the responsibility, and are willing to conduct constant self-examination and encourage innovation.

DEEPENING REFORM, ACHIEVING BREAKTHROUGH OF TRANSFORMATION AND OVERPACING TO REALISE THE GROUP'S SPIRIT FOR OVERCOMING DIFFICULTIES

The Group believes that the market will remain changing in the coming year. The Group will constantly persist in its position, remain united, consolidate the foundation, make an improvement, and realise its goal for the coming year with caution:

- explore a comprehensive operating model covering internet, futures trading and logistics platform, complementary to the existing coal business, to improve the value of the platform;
- work hard toward the annual plan of the Group's coal business and shipping business in the PRC, no matter the disposal of such businesses will be completed or not, and conduct safe, effective and refined production;
- seize opportunities in the coal market and focus on exploring the profitability, striving to improve the result in 2017 through cautious layout and operation.

Finally, I would also like to take this opportunity to express my sincere thanks to the board of directors and all shareholders, management, employees and business partners who have supported the Group for years. With your great support, it is believed that the Group can successfully overcome this difficult period and create more value for the stakeholders.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論與分析

The Group is a leading non-State owned thermal coal supplier in China, and it operates an integrated coal supply chain, including coal mining, purchase and sales, filtering, storage, blending and shipping transportation business. During the year ended 31 December 2016, the Group continued to focus on these business activities and expanded its integrated coal supply chain through upward vertical integration.

BUSINESS REVIEW

Proposed disposal of the Group's coal business and shipping business in the PRC

As set out in the announcement of the Company dated 14 July 2016, the Group has entered into a sale and purchase agreement with Bo Hai Investment Limited for the proposed disposal. Save for the condition relating to the approval of the independent shareholders to the entry of the agreement and the transaction contemplated thereunder at an extraordinary general meeting that had been fulfilled, some conditions precedent as described in the circular of the Company dated 26 October 2016 have not been fulfilled. As additional time is required to fulfill some conditions precedent and negotiate with third party financial institutions in respect of the fulfillment of the outstanding conditions precedent, the parties to the agreement agreed to further extend the long stop date for satisfying the outstanding conditions precedent to 30 April 2017.

While we see a moderate recovery in coal prices and some signs that profit is improving, there are still uncertainties in market factors. The slowdown in the growth of macro economy has resulted in a declining coal demand. Our shipping business in the PRC is also challenging. Losses may affect the direction of business and capability of finance of the Group in the future. Upon prudent consideration and acting in the best interests of the shareholders, the Company intends to dispose both the Group's coal business and shipping business in the PRC, while retaining the international shipping business which can bring a stable cash flow, in the hope of improving the financial condition of the Group, reducing costs and bringing more flexibility in resource allocation.

本集團是中國領先的非國有動力煤供應商，經營一體化煤炭供應鏈，包括採煤、煤炭購銷、選煤、存儲、配煤及航運運輸業務。截至二零一六年十二月三十一日止年度，本集團繼續專注該等業務活動及透過上游垂直整合拓展其一體化煤炭供應鏈。

業務經營回顧

擬出售集團的煤炭業務及中國航運業務

本公司於二零一六年七月十四日之公佈中列明已就建議出售與渤海投資有限公司訂立買賣協定。除有關於股東特別大會上獲獨立股東批准訂立協議及其項下擬進行的交易之條件已達成外，本公司日期於二零一六年十月二十六日的通函中部分先決條件尚未達成，因部分先決條件及與第三方金融機構就達成尚未達成的先決條件進行磋商需要額外時間，協定的各訂約方同意於將達成尚未達成的先決條件的截至時間延長至二零一七年四月三十日。

雖則煤炭價格稍有回升，盈利有所改善，但市場因素仍存在變化，宏觀經濟增長放軟導致煤炭需求繼續下降，中國航運業務亦面臨挑戰，虧損可影響到集團將來的經營方向及融資能力。經過謹慎考慮，以股東最大利益為前題，出售集團的煤炭業務及中國航運業務，保留能帶來穩定現金流的國際航運業務，望能藉此改善集團的財務狀況，減低成本開支及靈活調配資源。

- (1) The Group engaged an independent mineral industry consultant to estimate the total coal reserves and resources as of 30 June 2016 in accordance with the JORC Code. For the period from 1 January 2016 to 30 June 2016, there was no material change in total coal reserves and resources. The total coal reserves and resources as of 31 December 2016 were derived from the estimated figures after deducting the raw coal production for the period from 1 July 2016 to 31 December 2016.
- (2) The production capacity for Xingtao coal mine of Huameiao Energy is 1.5 million tonnes per annum, with a total investment budget (excluding coal washing plant) of RMB380 million. The construction was commenced in October 2011. As of 31 December 2016, the accumulated actual investment was RMB380 million. The construction was commenced in September 2011. As of 31 December 2016, the accumulated actual investment was RMB392 million. The construction of the coal mine and coal washing plant was completed, delivering a capacity of 0.9 million tonnes per annum. It has commenced operation on 21 January 2014.
- (5) The Group completed the establishment of two companies, Xinglong Coal and Hongyuan Coal, both wholly-owned by Shenchi Shenda Energy Investment Co., Ltd. during the first half year of 2013.

The segment revenue for shipping transportation from external customers for the year ended 31 December 2016 was RMB107.7 million as compared with RMB156.7 million for the same period in 2015. The Group has recorded 31.3% decline in shipping transportation revenue principally because of disposal of two chartering vessels during the year.

The Group keeps expanding the network of suppliers to ensure a supply of coal with reliable and stable quantity and quality.

The Group has established stable cooperative relationships with its key PRC domestic coal suppliers and has developed business relationships with the majority of them over a period of not less than three years. This enables the Group to obtain a reliable supply of quality coal.

Gross Profit/Loss

The Group recorded gross profit from continuing operations in 2016 principally because of the rapid rising of coal selling price after several years of decline and effective implementation of cost-control measures.

The decrease in other income, gains and losses from continuing operations in 2016 was mainly due to the one-off loss arising from the net loss on disposal of property, plant and equipment, including two vessels, of RMB70.5 million in 2016.

Distribution Expenses

Distribution expenses from continuing operations decreased by 48.1% to RMB16.0 million for the year ended 31 December 2016, as compared with RMB30.8 million in 2015. The decrease in distribution expenses from continuing operations was in line with the decrease in coal handling and trading volume during the year.

Administrative Expenses

During the year ended 31 December 2016, the Group's administrative expenses from continuing operations amounted to RMB189.3 million, representing a decrease of 9.1%, as compared with RMB208.3 million in 2015. The slight decrease was mainly attributable to the Group has further launched a series of cost saving controls during the year to reduce the administrative costs.

Other Expenses

During the year ended 31 December 2016, the Group's other expenses from continuing operations amounted to RMB59.5 million, representing an increase of 28.2%, as compared with RMB46.4 million in 2015.

Net Finance Costs

Net finance costs from continuing operations of the Group in 2016 amounted to RMB447.0 million, representing an increase of RMB79.0 million or 21.5%, as compared with RMB368.0 million in 2015. The increase was principally due to the drop of interest capitalised into construction of coal mines in 2016. Construction of certain coal mines had suspended during the year.

Loss Attributable to Equity Shareholders

Loss attributable to equity shareholders of the Company during the year ended 31 December 2016 was RMB330.5 million, representing a decrease of approximately of RMB5,680.7 million as compared with RMB6,011.2 million in the same period in 2015. The decrease in loss attributable to equity shareholders of the Company was principally due to no further significant impairment on the assets and partial recovery of previous impairment amounting to RMB604.2 million.

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

The Group adopts stringent financial management policies and strives to maintain a healthy financial condition. The Group funds its business operations and general working capital by internally generated financial resources and bank borrowings.

As of 31 December 2016, the Group recorded net current liabilities of RMB9,463.9 million. The Group has taken initiative to enhance the financial flexibility by diversifying the funding bases and obtain medium term loans to replace short term loans. The Group is currently negotiate with financial institutions to renew and extend bank borrowings and consider ways to improve the Group's working capital.

On 25 December 2015, the Company entered into the subscription agreement with Link Beautiful Limited (“**Link Beautiful**”) pursuant to which Link Beautiful has agreed to subscribe 215,000,000 new shares in the capital of the Company to settle a payable of approximately RMB48,822,000 (equivalent to approximately HKD58,480,000) owed by the Company to Link Beautiful. The conditions of the subscription agreement have been fulfilled and completion of the subscription agreement took place on 6 January 2016. In this regard, the Company allotted 215,000,000 new shares to Link Beautiful as at 6 January 2016. The subscription arrangement converted the outstanding interest payable of the loan into equity capital of the Company, which reduced the amount of borrowings of the Group and improve its financial position in an efficient and effective manner. The Directors believe that it is in the interests of the Company to preserve as much liquidity as possible in order to strengthen the Group's financial position and secure a sustainable business growth.

As of 31 December 2016, the cash and cash equivalents of the Group amounted to RMB24.7 million (2015: RMB20.7 million), representing an increase of 19.3%.

截至二零一六年十二月三十一日，本集團錄得流動負債淨額人民幣9,463,900,000元。本集團已採取措施，透過多元化融資基礎提升財務靈活性，並獲得中期貸款以取代短期貸款。本集團正與金融機構進行磋商，以重續及延長銀行借貸，並考慮改善本集團營運資金之方式。

於二零一五年十二月二十五日，本公司與聯合嘉華有限公司（「**聯合嘉華**」）訂立認購協議，據此，聯合嘉華已同意認購本公司股本中215,000,000股的新股份，以償付本公司結欠聯合嘉華之應付款項約人民幣48,822,000元（相當於約58,480,000港元）。認購協議之條件經已達成及認購協議已於二零一六年一月六日完成。就此，本公司於二零一六年一月六日向聯合嘉華配發215,000,000股新股份。認購協議將該筆貸款的未償還應付利息轉為本公司股本，從而以有效率及具效益的方式減少本集團之借貸金額及改善其財務狀況。董事認為，盡可能保留流動資金，既可增強本集團之財務狀況，亦可達成可持續業務增長，符合本公司之利益。

於二零一六年十二月三十一日，本集團現金及現金等價物達人民幣24,700,000元（二零一五年：人民幣20,700,000元），增加19.3%。

As of 31 December 2016, the total bank and other borrowings of the Group were RMB6,043.3 million (2015: RMB5,905.3 million), which were classified as current liabilities. As a result of the non-payment of loan principal and interests of RMB959,229,000 and RMB361,965,000 respectively, bank loans amounting to RMB2,473,678,000 (2015: RMB2,602,325,000) due for repayment after one year which contain a cross default clause that demands immediate repayment when there is default in any bank loans repayment are classified as current liabilities. The bank and other borrowings carried interest at rates ranging from 4.35% to 13.50% (2015: 4.35% to 12.96%) per annum.

As of 31 December 2016, the Group had total banking facilities of RMB6,136.4 million (2015: RMB6,313.1 million), of which RMB6,006.2 million (2015: RMB5,887.1 million) were utilised.

As of 31 December 2016, the Group's cash and cash equivalents, except amount of RMB12.2 million in United States dollars ("USD") and amount of RMB0.7 million in HKD, were held in RMB. All the Group's bank and other borrowings were made in RMB.

The gearing ratio (calculated as bank and other borrowings netted off sum of cash and cash equivalents and pledged and restricted deposits divided by total assets) of the Group as at 31 December 2016 was 106.3% (2015: 109.9%). The decrease in gearing ratio was mainly due to increase of total assets as a result of reversal of impairment losses on property, plant and equipment, coal mining rights, trade receivables and prepayments and other receivables.

EXPOSURE TO FLUCTUATIONS IN EXCHANGE RATES

The Group's cash and cash equivalents are held predominately in RMB and USD. Operating outgoings incurred by the Group's subsidiaries in the PRC are mainly denominated in RMB while overseas purchases and chartered hire income are usually denominated in USD. The Group's subsidiaries usually receive revenue in RMB. Hence, the Directors do not consider that the Group faces significant exposure to foreign exchange fluctuation risk.

於二零一六年十二月三十一日，本集團之現金及現金等價物（人民幣12,200,000元以美元（「美元」）及人民幣700,000元以港元持有除外）均以人民幣持有。本集團之所有銀行及其他借貸均以人民幣作出。

本集團於二零一六年十二月三十一日的資產負債比率（按銀行及其他借貸抵銷現金及現金等價物及已抵押及受限制存款之總額後除以資產總值計算）為106.3%（二零一五年：109.9%）。資產負債比率下降的主要因為物業、廠房及設備、煤炭採礦權、應收貿易賬款以及預付賬款及其他應收賬款之減值虧損撥回導致資產總額增加。

匯率波動風險

本集團之現金及現金等價物主要以人民幣及美元持有。本集團中國附屬公司之營運支出主要以人民幣列值，而海外採購及貨船租賃收入則一般以美元列值。本集團附屬公司普遍以人民幣收取收入。因此，董事認為本集團並無面臨重大匯率波動風險。

Except for certain matters disclosed in the Note 41 to the consolidated financial statements, the Group did not have any material contingent liabilities as at 31 December 2016.

FINAL DIVIDEND FOR THE YEAR ENDED 31 DECEMBER 2016

The Board does not recommend the payment of a final dividend for the year ended 31 December 2016 (2015: Nil).

MATERIAL ACQUISITION AND DISPOSAL OF SUBSIDIARIES

Except for the disposal of the equity interest in Zhuhai Qinfra Port Co., Limited on 7 August 2015 as disclosed in the Note 10 to the consolidated financial statements, there was no material acquisition and disposal of subsidiaries during the year ended 31 December 2016 and 2015. Additional information is set forth in the notes to the consolidated financial statements of the Group.

RELATIONSHIPS WITH CUSTOMERS AND SUPPLIERS

The Group understands that it is important to maintain good relationships with customers, suppliers and other business partners to achieve its long-term goals. Accordingly, our senior management has kept good communication, promptly exchanged ideas and shared business updates with them when appropriate. Except for certain outstanding litigations as disclosed in note 41(a) to the consolidated financial statements, there was no material and significant dispute between the Group and its customers, suppliers and other business partners during the year.

CORPORATE GOVERNANCE

The Company has complied with the applicable code provisions in the Corporate Governance Code (the “Code”) as set out in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) during the financial year ended 31 December 2016.

EMPLOYEES AND REMUNERATION

As of 31 December 2016, the Group employed 1,203 employees. The Group has adopted a performance-based reward system to motivate its staff and such system is reviewed on a regular basis. In addition to the basic salaries, year-end bonuses may be offered to staff members with outstanding performance.

Members of the Group established in the PRC are also subject to social insurance contribution plans organised by the PRC government. In accordance with the relevant national and local labour and social welfare laws and regulations, members of the Group established in the PRC are required to pay on behalf of their employees a monthly social insurance premium covering pension insurance, medical insurance, unemployment insurance and other relevant insurance. Members of the Group incorporated in Hong Kong have participated in mandatory provident fund scheme, if applicable, in accordance with the applicable Hong Kong laws and regulations.

Moreover, as disclosed in the prospectus of the Company dated 19 June 2009, the Company adopted a pre-IPO share option scheme and a post-IPO share option scheme in June 2009 to incentivise and retain staff members who have made contribution to the success of the Group. The Directors believe that the compensation packages offered by the Group to its staff are competitive in comparison with market standards and practices.

此外，誠如本公司日期為二零零九年六月十九日之招股章程所披露，本公司已於二零零九年六月採納一項首次公開發售前購股權計劃及一項首次公開發售後購股權計劃，以激勵及留任為本集團成功作出貢獻的員工。董事相信，與市場準則及慣例相比較，本集團提供予員工的薪酬待遇具有競爭力。

BUSINESS OUTLOOK

The year 2016 witnessed the commencement of China's major work of cutting excessive industrial capacity. As one of the key areas of supply-side structural reform, the coal industry's priority next year remains to cut excessive capacity. During 2016, China reduced coal capacity by more than 290 million tonnes, exceeding the previous goal of 250 million tonnes. Li Keqiang, Premier of the State Council, specified China's overcapacity cutting scheme: to cut 800 million tonnes of coal capacity in 3 to 5 years, aiming to bring coal industry back to a more healthy condition.

Affected by the slowdown of global economy, against this backdrop, the Group must adjust its direction in response to market movements, policy trend and supply and demand changes to achieve various targets in the future:

- improve the Group's financial indicators and complete the disposal of the Group's coal business and shipping business in the PRC so as to reduce the gearing ratio and finance costs of the Group. If the disposal is completed after all the conditions precedent were satisfied, it is believed to greatly ease the Group's cost pressure and allow a more effective allocation and application of financial resources, which will improve the operational position and profitability of the Group while relieving operating pressures ahead;
- work hard toward the annual plan of the Group's coal business and shipping business, no matter the disposal of such businesses will be completed or not. The Group will conduct safe, effective and refined production, seek for opportunities among challenges, and try every means to achieve cost efficiency and revenue growth;
- explore a comprehensive operating model covering internet, futures trading and logistics platform, complementary to the existing coal business, to improve the value of the Group. In view of constantly changing internet information, trading platforms and operating models, the Group also insists on keeping up with the market to expand new development directions; and
- conduct research and development on supply chain finance by leveraging on its years of industry resources and experience to promote business diversification, broaden source of revenue and improve risk resistance of the Company.

展望未來

2016年為中國去產能作重點之開局之年，煤炭行業作為供給側結構性改革主抓領域之一，去產能仍是明年重點發展因素。2016年中國壓減了2.9億噸以上的煤炭產能，數量超過了早先制定的2.5億噸煤炭去產能目標。國務院總理李克強表明了中國的去產能路線圖：計畫在3至5年內煤炭產能壓減8億噸，望使煤炭業恢復更加健康的經營層面。

但受到全球經濟放緩影響，面對大市場客觀問題，本集團只有因應市場變化、政策推行、供需改動而不斷調整方向，完成未來多個目標：

- 改善集團財務指標，完成出售集團的煤炭業務及中國航運業務，從而降低集團的資產負債率及財務成本。若能達成所有先決條件完成交易，相信能大大減輕集團成本負擔，於財務資源分配及運用上更顯成效，改善經營狀況，提高盈利能力的同時，也可有效化解經營壓力。
- 無論出售的煤炭業務及中國航運業務是否能完成，本集團亦將繼續盡力經營煤炭及航運業務的年度計畫，安全生產、高效運作、精益求精。在挑戰中尋找機遇，以節省成本為目標，增加收入為遠望，拓寬一切可能；
- 充分探討互聯網、期貨交易、物流運輸平臺與煤炭行業相結合的經營方式，致力提升平臺價值。網絡世界、交易平臺、營運方式日新月異，時時刻刻在變化中。本集團亦主張跟上市場步伐，拓展更加新發展方向；及
- 利用多年積累的行業資源及經驗，研究開發供應鏈金融服務，促進公司業務多樣化，技能開拓創收管道，提升公司抗風險能力。

As disclosed in the announcement of the Company dated 27 December 2015, the Company entered into the debt to equity agreement dated 25 December 2015 (the “**Agreement**”) in relation to the capitalisation of RMB48,822,000 (the “**Payable**”) with Link Beautiful Limited (the “**Creditor**”) pursuant to which the Creditor requested the full and final settlement of the Payable by capitalising the Payable. On 25 December 2015, the Group consolidated certain payable due to China Minsheng Banking Corp., Ltd by its subsidiaries of RMB141,533,000 (the “**Minsheng Payable**”) and novated the Minsheng Payable from the subsidiaries of the Company to the Company as the principal debtor. China Minsheng Banking Corp., Ltd, on the same date, signed a deed to assign the Minsheng Payable, including the Payable, to the Creditor. Subsequently, the condition of the Agreement has been fulfilled and completion of the Agreement took place on 6 January 2016, whereby a total of 215,000,000 new Shares were allotted and issued to the Creditor at the subscription price of approximately HKD0.272 per share.

Proposed disposal of entire equity interest in Hong Kong Qinfa International Trading Limited

On 25 April 2016 and 11 July 2016, the Group entered into a share sale and purchase agreement and a supplemental agreement with Bo Hai Investment Limited (“**Bo Hai Investment**”), a related company wholly owned by Mr. Xu Jihua, a former Director and a close family member of Mr. Xu Da, an executive Director and chairman of the Company respectively in relation to the disposal of entire equity interest in Hong Kong Qinfa International Trading Limited, a wholly-owned subsidiary of the Company, and its subsidiaries (“**HK Qinfa International Group**”) at a consideration of RMB176,740,000. The principal activities of HK Qinfa International Group are coal mining, purchase and sales, filtering, storage, blending of coal and shipping transportation in the PRC. The proposed transaction is yet to complete and is subject to certain conditions precedent as stated in the share sale and purchase agreement. Subsequent to the year, the Group and Bo Hai Investment agreed to further extend the long stop date to 30 April 2017 for satisfying the outstanding conditions precedent. Further details are set out in the circular dated 26 October 2016 and the announcements of the Company dated 16 December 2016, 30 December 2016 and 28 February 2017.

On 12 June 2009, Zhuhai Qinfra Logistics Co., Ltd. (“**Qinfra Logistics**”), which is a wholly-owned subsidiary of the Company, each member of the China Qinfra Group (as defined in the Prospectus), and their respective equity interest holders (which include Mr. XU Jihua, Mr. XU Da, Mr. LIU Jingwei and Ms. ZHOU Lusha, all being controlling shareholders of the Company) entered into the Structure Contracts (as defined in the Prospectus) for a term of 10 years pursuant to which Qinfra Logistics agreed to pay an annual fee of RMB10,000 to each member of the China Qinfra Group for the exclusive management and operation of the coal operation business and the inland shipping transportation business of the China Qinfra Group, and all economic benefits and risks arising from the business of the China Qinfra Group are transferred to Qinfra Logistics. Further details of the Structure Contracts are set forth in the section headed “Reorganisation and the Structure Contracts” in the Prospectus.

The Stock Exchange has granted a perpetual waiver pursuant to the Rule 14A.105 of the Listing Rules to the Company for all transactions under the Structure Contracts from strict compliance with the applicable announcement and independent Shareholders’ approval requirements under Chapter 14A of the Listing Rules.

In accordance with Rule 14A.56 of the Listing Rules, the Board engaged the auditor of the Company to perform procedures on the above continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) “Assurance Engagements Other Than Audits or Reviews of Historical Financial Information” and with reference to Practice Note 740 “Auditor’s Letter on Continuing Connected Transactions under the Hong Kong Listing Rules” issued by the Hong Kong Institute of Certified Public Accountants.

The auditor has issued his unqualified letter containing his findings and conclusions in respect of the continuing connected transactions in accordance with Rule 14A.56. A copy of the auditor’s letter has been provided by the Company to the Stock Exchange.

The independent non-executive Directors have confirmed that the above-mentioned continuing connected transactions for the Company were entered into: (i) in the ordinary and usual course of the Group’s business; (ii) in accordance with the terms of the respective agreements governing such transactions on terms that were fair and reasonable and in the interests of the shareholders of the Company as a whole; and (iii) either on normal commercial terms or on terms no less favourable to the Group than those available to or from independent third parties.

聯交所已根據當時上市規則第14A.105條，就架構合約下的所有交易授予本公司永久豁免嚴格遵守上市規則第十四A章項下的適用公佈及獨立股東批准的規定。

根據上市規則第14A.56條，董事會委聘本公司核數師就上述持續關連交易根據香港會計師公會頒佈的香港核證委聘準則第3000號（經修訂）「審核或審閱過去財務資料以外之核證委聘」，並參照實務說明第740號「關於香港上市規則所述持續關連交易之核數師函件」執执行程序。

核數師已根據上市規則第14A.56條就本集團的持續關連交易發出無保留意見函件，當中載有其發現及結論。本公司已向聯交所送呈核數師函件副本。

獨立非執行董事認為上述本公司之持續關連交易乃(i)於本集團一般日常業務過程中訂立；(ii)根據該等交易有關協議規定訂立，而條款屬公平合理且符合本公司股東整體利益；及(iii)按正常商業條款訂立，或按不遜於獨立第三方向本集團開出或本集團向獨立第三方開出之條款訂立。

Besides, the independent non-executive Directors have conducted an annual review on the Structure Contracts and have confirmed that (i) the transactions carried out during 2016 have been entered into in the ordinary and usual course of the Group's business; (ii) the transactions carried out during 2016 have been entered into in accordance with the relevant provisions of the Structure Contracts and so that all revenue generated by China Qinfra Group has been retained by Qinfra Logistics; (iii) any new contracts or renewed contracts have been entered into on the same terms as the existing Structure Contracts and are fair and reasonable so far as the Group is concerned and in the interests of the shareholders as a whole; and (iv) no dividends or other distributions have been made by any member of China Qinfra Group to its equity interest holders.

The Group comprises China Qinfra Group (as defined in the Prospectus) and Hong Kong Qinfra Group (as defined in the Prospectus). Having considered the demand for coal imported from overseas into China and the expansion of the Group's overseas coal operation business, the Directors strategically planned to centralise the management and operation of the Group's coal business in China and overseas markets and determined that Hong Kong Qinfra Group should manage and operate the coal operation business in China through the establishment of Zhuhai Qinfra Logistics Co. Ltd. ("**Qinfra Logistics**"), a member of Hong Kong Qinfra Group and an indirect wholly-owned subsidiary of the Company in February 2008.

However, after verbal consultations with the relevant PRC governmental authorities at Zhuhai at which the Group operates its coal business, the Directors understand that the PRC governmental authorities currently do not grant Coal Operation Certificates to foreign equity controlled companies as a matter of practice. In addition, according to (i) Article 7 of (The Regulations on the Management of Waterway Transport of the PRC) promulgated by the State Council on 12 May 1987 and revised on 27 December 2008 and (ii) (the Guidance of Foreign Investment (Amended 2007)); and after the verbal consultations with the relevant PRC governmental authorities at Zhuhai, the Directors understand that the PRC laws and regulations currently prohibit the issue of Waterway Transportation Licences to foreign equity controlled companies. These views have been confirmed by the PRC legal advisers of the Company.

In order to allow Hong Kong Qinfra Group to manage and operate the coal operation business in China, the Engagement Agreements and the Pledge Agreements (as defined in the Prospectus) (collectively the “**Structure Contracts**”) were entered into under which all the business activities of China Qinfra Group are managed and operated by Qinfra Logistics and all economic benefits and risks arising from the business of China Qinfra Group are transferred to Qinfra Logistics. Pursuant to the equity transfer agreements dated 25 October 2010, 15 December 2010 and 17 December 2010, equity interests of Qinhuangdao Qinfra Trading Co., Ltd., Yangyuan Guotong Coal Trading and Transportation Co., Ltd. and Datong Xiejiazhuang Jinfu Trading and Transportation Co., Ltd have been transferred to the Group. As of 31 December 2016, Zhuhai Qinfra Trading Co., Ltd (“**Zhuhai Qinfra Trading**”) and Zhuhai Qinfra Shipping Co., Ltd. (“**Zhuhai Qinfra Shipping**”) remained controlled by the Group under the Structure Contracts.

Mr. Xu Jihua, Ms Wang Jianfei, Mr. Xu Da, Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping entered into the Engagement Agreements and the Pledge Agreements on 12 June 2009. Qinfra Logistics is entitled to all the revenue of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping after deducting all relevant costs and expenses (including taxes) and has the right to acquire any or all of the equity interests and/or assets of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping at the lowest possible amount and at such time as permitted by the relevant PRC laws and regulations. All equity holders of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping have granted to Qinfra Logistics a pledge over the equity interests in equity holders for the purpose of securing the performance of the contractual obligations under the Structure Contracts. Any amendment to the Structure Contracts shall be subject to the approvals of (i) the directors nominated by Qinfra Logistics to Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping, and (ii) for the purpose of promoting good corporate governance, the Shareholders in general meeting. No amendments to the Structure Contracts can be made unless required under the Listing Rules or approved by Qinfra Logistics in writing in advance. For details of the Structure Contracts, please refer to the section headed “Reorganisation and the Structure Contracts” in the Prospectus.

委託協議及質押合同(定義見招股章程)(統稱「**架構合約**」)是為使香港秦發集團管理及經營中國煤炭業務而訂立，據此，中國秦發集團的所有業務活動由秦發物流管理及經營，而中國秦發集團業務產生的全部經濟利益及風險則轉讓予秦發物流。根據日期為二零一零年十月二十五日、二零一零年十二月十五日及二零一零年十二月十七日的股權轉讓協議，秦皇島開發區秦發貿易有限公司、陽原國通煤炭運銷有限公司及大同解家莊晉發運銷有限公司的股權已轉讓予本集團。於二零一六年十二月三十一日，本集團仍根據架構合約控制珠海秦發貿易有限公司(「**珠海秦發貿易**」)及珠海秦發航運有限公司(「**珠海秦發航運**」)。

徐吉華先生、王劍飛女士、徐達先生、珠海秦發貿易及珠海秦發航運於二零零九年六月十二日訂立委託協議及質押合同。秦發物流有權收取珠海秦發貿易及珠海秦發航運的所有收入(經扣除所有有關成本及開支(包括稅項))，並有權於相關中國法律及法規許可的時間按相關中國法律及法規所許可最低可能金額收購珠海秦發貿易及珠海秦發航運的任何或全部股權及／或資產。為確保履行架構合約的合約責任，珠海秦發貿易及珠海秦發航運的所有權益持有人已授予秦發物流對權益持有人的股權所作抵押。對架構合約作出任何修訂均須獲(i)秦發物流任命至珠海秦發貿易及珠海秦發航運的董事批准，及(ii)為推廣良好的企業管治須於股東大會上獲股東批准。除非屬上市規則之規定或經秦發物流事先書面批准，否則不得對架構合約作出任何修訂。有關架構合約的詳情，請參閱招股章程「重組及架構合約」一節。

The Structure Contracts, taken as a whole, permit the financial results of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping and economic benefits of their business to flow onto Qinfra Logistics. In addition, all the directors in Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping are to be nominated by Qinfra Logistics. Through its control over the directors of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping, Qinfra Logistics is able to monitor, supervise and effectively control the business, operations and financial policies of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping so as to ensure due implementation of the Structure Contracts. The Structure Contracts also enable Qinfra Logistics to exercise control over and to acquire the equity interests and/or assets of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping at the lowest value and at such time as permitted by the relevant PRC laws and regulations with an undertaking from the Controlling Shareholders to provide to Qinfra Logistics all the consideration received pursuant to any such acquisition. Based on the Structure Contracts, the Directors consider that, notwithstanding the lack of equity ownership between members of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping and Hong Kong Qinfra Group, Qinfra Logistics is entitled to control the business of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping in substance. On this basis, the financial position and operating results of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping are included in the Group's Consolidated Financial Statements.

As a result of the Structure Contracts, Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping are accounted for as the Company's subsidiaries, and their financial position and operating results are consolidated in the Group's Consolidated Financial Statements. The revenue and total asset value subject to the arrangements under the Structure Contracts amounted to approximately RMB31,483,000 for the year ended 31 December 2016 and approximately RMB52,164,000 as of 31 December 2016, respectively.

The Structure Contracts are governed by the PRC laws and provide for the resolution of disputes through arbitration in accordance with the arbitration rules of China International Economic and Trade Arbitration Commission in force at that time (the "CIETAC Arbitration Rules") in China. Accordingly, the Structure Contracts would be interpreted in accordance with the PRC law and any disputes would be finally resolved by arbitration in accordance with the CIETAC Arbitration Rules.

架構合約整體上准許將珠海秦發貿易及珠海秦發航運的財務業績及其業務的經濟利益流入秦發物流。此外，珠海秦發貿易及珠海秦發航運的所有董事須由秦發物流提名。通過秦發物流對珠海秦發貿易及珠海秦發航運董事的控制權，秦發物流可監察、監督及有效控制珠海秦發貿易及珠海秦發航運的業務、營運及財務政策，從而確保適當履行架構合約。架構合約亦可使秦發物流對珠海秦發貿易及珠海秦發航運的股權及／或資產施加控制及可按有關中國法律及法規所准許的最低價值及有關時間收購該等股權及／或資產，而控股股東均承諾將向秦發物流提供全部根據任何該等收購已收取的代價。基於架構合約，董事認為，儘管珠海秦發貿易及珠海秦發航運與香港秦發集團各成員公司之間沒有股權所有權關係，但秦發物流實質上有權控制珠海秦發貿易及珠海秦發航運的業務。基於此，珠海秦發貿易及珠海秦發航運的財政狀況及經營業績均計入本集團綜合財務報表內。

基於架構合約，珠海秦發貿易及珠海秦發航運均入賬作為本公司的附屬公司，而其財政狀況及經營業績均在本集團的綜合財務報表內綜合入賬。截至二零一六年十二月三十一日止年度及於二零一六年十二月三十一日，受制於架構合約項下安排的收益及資產總值分別約為人民幣31,483,000元及約人民幣52,164,000元。

架構合約受中國法律規管，並透過於中國根據當時生效的中國國際經濟貿易仲裁委員會仲裁規則（「中國國際經濟貿易仲裁委員會仲裁規則」）進行仲裁解決爭議。因此，架構合約將按中國法律作出詮釋，而任何爭議最終將根據中國國際經濟貿易仲裁委員會仲裁規則進行仲裁予以解決。

There are risks involved with the operation of the Group under the Structure Contracts. To the best knowledge of the Directors, if the Structure Contracts are considered to be in breach of any existing or future PRC laws or regulations, the relevant regulatory authorities would have broad discretion in dealing with such breach, including:

- imposing economic penalties;
- discontinuing or restricting the operations of Hong Kong Qinfra Group or Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping;
- imposing conditions or requirements in respect of the Structure Contracts with which Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping may not be able to comply;
- requiring the Group to restructure the relevant ownership structure or operations;
- taking other regulatory or enforcement actions that could adversely affect the business of the Group; and
- revoking the business licences and/or the licences or certificates of Zhuhai Qinfra Trading and Zhuhai Qinfra Shipping and/or voiding the Structure Contracts.

The Group takes the following measures to mitigate the risk and to ensure proper implementation of the Structure Contracts:

- (a) as part of the internal control measures, major issues arising from implementation and performance of the Structured Contracts are reviewed by the board of directors of Qinfra Logistics on a regular basis which is no less frequent than on a quarterly basis;
- (b) matters relating to compliance and regulatory enquiries from governmental authorities (if any) are discussed at such regular meetings which is no less frequent than on a quarterly basis; and
- (c) the relevant business units and operation divisions of the Hong Kong Qinfra Group report regularly, which is no less frequent than on a monthly basis, to the senior management of Qinfra Logistics on the compliance and performance conditions under the Structured Contracts and other related matters.

本集團在架構合約項下的業務涉及各種風險。據董事所深知，倘架構合約被視為違反任何現有或日後的中國法律或法規，則有關監管機關在處理有關違反情況時將有高度酌情權，包括：

- 實施經濟處分；
- 終止或限制香港秦發集團或珠海秦發貿易及珠海秦發航運的業務；
- 就架構合約實施珠海秦發貿易及珠海秦發航運未必有能力遵行的條件或規定；
- 要求本集團重組有關所有權架構或業務；
- 採取其他可能對本集團業務產生不利影響的監管或強制執行行動；及
- 撤銷珠海秦發貿易及珠海秦發航運的營業執照及／或牌照或許可證及／或作廢架構合約。

本集團採取以下措施以減低風險及確保妥為落實架構合約：

- (a) 作為內部監控措施的一部分，秦發物流董事會定期檢討因落實及履行架構合約所產生的主要事項，頻率不少於每季一次；
- (b) 有關合規及政府機關的監管查詢事宜（如有）會在相關例行會議上討論，頻率不少於每季一次；及
- (c) 香港秦發集團的相關業務單位及營運部門會定期向秦發物流的高級管理層報告架構合約的合規及履行情況以及其他相關事宜，頻率不少於每月一次。

The Board confirmed that there is no material change in the contractual arrangements under the Structure Contracts and/or the circumstances under which they were adopted, and their impact on the Group. The Board also confirmed that there is no removal of restrictions that led to the adoption of the Structured Contracts.

In January 2015, the Ministry of Commerce of the PRC (the “MOFCOM”) published the draft Foreign Investment Law (the “Draft FIL”) under which a foreign investor may be permitted to invest directly or indirectly in restricted industries (i.e. without the need to use contractual arrangements), so long as the foreign investor’s ultimate control person(s) is/are PRC investors, subject to competent authorities’ approval and certain limitations. The explanatory memorandum accompanying the Draft FIL proposed three options for dealing with existing VIE structures. According to these three options, a foreign investor would only be able to retain its business under contractual arrangements after the Draft FIL becomes effective if it is in fact controlled by PRC investors, subject to reporting or verification, or otherwise with MOFCOM’s prior approval.

Based on the fact that Mr. Xu Jihua holds 42.12% of the issued share capital of the Company (excluding the conversion effect of PSCS), and is hence capable of exerting decisive impact on the management and decisions of China Qinfra Group through the Structure Contracts, the PRC legal advisers of the Company advise that Mr. Xu Jihua is likely to be deemed as “ultimate control person” under the Draft FIL and that the contractual arrangements under the Structure Contracts are likely to be permitted to continue under the Draft FIL.

Since a number of legislative stages have to be undergone before the promulgation and implementation of the new Foreign Investment Law, the Directors are given no reasonably sufficient evidence to believe that the new Foreign Investment Law will be adopted immediately and/or the new Foreign Investment Law will be the same content or form with the Draft FIL and the accompanying notes. The Company will keep a close eye on the development of legislation and retain external legal advisers who will advise on the effect and the possible solutions to ensure that timely reaction and necessary adjustment is made in accordance with the new Foreign Investment Law, and the relevant rules and regulation taking effect in the future.

二零一五年一月，中國商務部（「商務部」）公布《外國投資法（草案徵求意見稿）》（「外資法草案」），據此，只要外國投資者的最終控制人為中國投資者，該外國投資者便可直接或間接投資於受限制行業（即毋須使用合約安排），惟須經主管機關批准及遵守若干限制。外資法草案隨附的說明提出了三個處理現有協議控制架構的方案。根據該三個方案，在外資法草案生效後，外國投資者必須由中國投資者實際控制，方可保留其於合約安排下的業務，惟須進行申報或經過認定，或取得商務部事先批准。

鑑於徐吉華先生持有本公司已發行股本的42.12%（不包括兌換永久次級可換股證券影響），因此能夠通過架構合約對中國秦發集團的管理及決策產生決定性的影響，據本公司的中國法律顧問告知，根據外資法草案，徐吉華先生可能會被視為「最終控制人」，而架構合約項下的合約安排根據外資法草案或可獲准延續。

由於新《外國投資法》必須經過多個立法階段後方會頒布及施行，因此董事並無合理充分證據相信新《外國投資法》將會即時獲採納及／或新《外國投資法》的內容或形式將會與外資法草案及隨附說明相同。本公司將會密切注意有關立法的事態發展，並會聘請外部法律顧問就有關影響及可能方案提供意見，以確保能夠及時按照日後生效的新《外國投資法》、相關規則及法規作出反應及必要的調整。

Details of the related party transactions of the Group for the year ended 31 December 2016 are set out in note 37 to the Consolidated Financial Statements. The related party transactions as disclosed in note 37(b) to the Consolidated Financial Statements constituted exempt continuing connected transaction and exempt connected transaction, respectively, under Chapter 14A of the Listing Rules and accordingly, are exempted from the disclosure requirements in Chapter 14A of the Listing Rules. The related party transactions as disclosed in note 37(a), (c) and (d) to the Consolidated Financial Statements are not regarded as connected transactions under chapter 14A of the Listing Rules.

The PSCS was approved by the independent shareholders on 31 December 2012 and the Company paid interest of HKD5,841,000 for the year ended 31 December 2016 pursuant to the terms of the PSCS.

The Directors confirm that the Company has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules.

SHARE OPTION SCHEMES

The Company has adopted a Pre-IPO Share Option Scheme and a Share Option Scheme on 12 June 2009. The principal terms of the two schemes are as follows:

Pre-IPO Share Option Scheme

Pursuant to the sole shareholder's written resolutions passed on 12 June 2009, the Company adopted the Pre-IPO Share Option Scheme whereby 26 employees of the Group were granted the rights to subscribe for Shares.

The purpose of the Pre-IPO Share Option Scheme is to recognise the contribution by certain employees towards the growth of the Group and/or the listing of the Shares on the Stock Exchange. The principal terms of the Pre-IPO Share Option Scheme are substantially the same as the terms of the Share Option Scheme, except that:

- (i) the exercise price per share; and
- (ii) the total number of Shares which may be issued pursuant to options granted under the Pre-IPO Share Option Scheme.

董事確認，本公司已遵守根據上市規則第十四A章之披露規定。

- Each option granted under the Pre-IPO Share Option Scheme has a vesting period of one to three years commencing from 3 July 2009, being the listing date of the Shares on the Stock Exchange. The Company has no legal or constructive obligation to repurchase or settle the option in cash.
- Each of the grantees to whom options have been granted under the Pre-IPO Share Option Scheme will be entitled to exercise:
 - 30% of the total number of the options from the expiry of the first anniversary of the Listing Date;
 - 30% of the total number of the options from the expiry of the second anniversary of the Listing Date; and
 - 40% of the total number of the options can be exercised from the expiry of the third anniversary of the Listing Date.

The fair value of options granted under Pre-IPO Share Option Scheme was determined using the "Binomial Option Pricing Model".

The significant inputs into the model were:

- risk-free rate of return – 3.029% per annum;
- forecast fluctuations in share price – 56%; and
- forecast dividend yield – 1.50% per annum.

Based on the inputs above to the "Binomial Option Pricing Model", the total fair value of the outstanding options as at the grant date (i.e. 12 June 2009) was HKD7,650,000.

The "Binomial Option Pricing Model" is designed to assess the fair value of options and is a common choice among various option pricing models for assessing the fair value of options. The value of the options depends on the valuation arrived at based on certain subjective assumptions on variables. Any changes in the variables used may cause a substantial effect on the assessment of the fair value of the options.

The Company adopted the Share Option Scheme which shall be valid and effective for a period of ten years commencing from 12 June 2009.

The purpose of the Share Option Scheme is to provide incentive or reward to eligible persons (including full time or part time employees, executive, non-executive directors and independent non-executive directors of our Group) for their contribution to, and continuing efforts to promote the interests of, the Company and to enable the Company and its subsidiaries to recruit and retain high-caliber employees.

The subscription price shall be a price determined by the Directors, but shall not be less than the highest of (i) the nominal value of the share; (ii) the closing price of the shares on the date of the offer; and (iii) the average closing price of the shares for the five trading days immediately preceding the date of the offer.

The total number of Shares issued and which may be issued upon exercise of the options granted under the Share Option Scheme to an employee in any 12-month period shall not exceed 1% of the Shares in issue. Any further grant of options in excess of this limit shall be subject to the approval of shareholders in a general meeting.

An option may be exercised at any time during a period to be determined by the Board, which shall not in any event exceed ten years from the date of grant. The Share Option Scheme does not specify any minimum holding period. The acceptance of an offer must be made within 30 days from the date of offer with a non-refundable payment of HKD1.00.

The total number of shares available for issue under the Share Option Scheme is 96,702,255 Shares, representing approximately 3.88% of the issued share capital of the Company as at 31 March 2017.

On 17 January 2012, the Company has granted share options (the "Options") to subscribe for a total of 20,751,196 new ordinary shares of the Company under the Share Option Scheme to 15 eligible participants of the Share Option Scheme at the exercise price HKD1.50 per share (which represents the highest of (i) the closing price of HKD1.50 per Share as stated in the Stock Exchange's daily quotation sheet on the date of grant; (ii) the average closing price of HKD1.392 per Share as stated in the Stock Exchange's daily quotation sheets for the 5 trading days immediately preceding the date of grant; and (iii) the nominal value of HKD0.10 per Share). The Options are valid for a period of 10 years from 17 January 2012 to 16 January 2022. None of the Grantees is a director, chief executive or substantial shareholder of the Company or an associate (as defined in the Listing Rules) of any of them.

None of the Directors is or was interested in any business apart from the Group's business, that competes or is likely to compete (either directly or indirectly) with the Group's business at any time during the year ended 31 December 2016 and up to the date of this report, save for Mr. XU Jihua's legal ownership in the equity interest in members of the China Qinfra Group (as defined in the Prospectus).

As disclosed in the Prospectus, the Controlling Shareholders (as defined in the Prospectus) and the executive Directors (collectively, the "Covenantors") have entered into a deed of non-competition dated 12 June 2009 in favour of the Company. The Covenantors have provided the Group with written confirmations that they and their associates (other than members of the Group) have fully complied with the deed of non-competition throughout the year ended 31 December 2016.

The independent non-executive Directors have conducted an annual review on the Covenantors' compliance with the deed of non-competition, the options, pre-emptive rights or first rights of refusals provided by the Controlling Shareholders (as defined in the Prospectus) on their existing or future competing businesses.

On 25 April 2016 and 11 July 2016, the Group entered into a share sale and purchase agreement and a supplemental agreement with Bo Hai Investment in relation to the disposal of entire equity interest in HK Qinfra International Group at a consideration of RMB176,740,000 as disclosed in this report. This proposed transaction is yet to complete and is subject to certain conditions precedent as stated in the share sale and purchase agreement. Subsequent to the year, the Group and Bo Hai Investment agreed to further extend the long stop date to 30 April 2017 for satisfying the outstanding conditions precedent. Further details are set out in the circular dated 26 October 2016 and the announcements of the Company dated 16 December 2016, 30 December 2016 and 28 February 2017.

TAXATION OF HOLDERS OF SHARES

Hong Kong

The purchase, sale and transfer of shares registered in the Company's Hong Kong branch register of members will be subject to Hong Kong stamp duty. The current rate charged on each of the purchaser and seller (or transferee and transferor) is 0.1% of the consideration or, if greater, the fair value of the shares being bought/sold or transferred (rounded up to the nearest HKD'000). In addition, a fixed duty of HKD5.00 is currently payable on an instrument of transfer of shares.

Profits from dealings in the share arising in or derived from Hong Kong may also be subject to Hong Kong profits tax.

Cayman Islands

Under the present Cayman Islands laws, transfers and other dispositions of shares in the Company are exempt from Cayman Islands stamp duty.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Mr. XU Jihua (resigned on 8 December 2016) and Mr. XU Da (appointed as the chairman of the Board on 8 December 2016) are the chairman of the Board and an executive Director, responsible for providing advice for the overall management and strategic development and overseeing the operation of the Board. Mr. BAI Tao, an executive Director, is the Chief Executive Officer, who is responsible for the Group's overall management, corporate development, strategic planning and the supervision of day-to-day operation. The segregation of duties and responsibilities between the chairman and the chief executive officer ensures a balance of power and authority.

REMUNERATION COMMITTEE

The Board established a remuneration committee on 12 June 2009 with specific written terms of reference. The remuneration committee consists of an executive Director, Ms. WANG Jianfei (resigned on 21 July 2016) and Mr. BAI Tao (appointed on 21 July 2016), and two independent non-executive Directors, namely Mr. HUANG Guosheng and Mr. XING Zhiying. APPOINTMENTS, RE-ELECTION AND REMOVAL OF DIRECTORS

Each of the executive Directors has entered into a service contract with the Company for an initial term of three years. Such term is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Articles.

BOARD DIVERSITY POLICY

The Company formulated the board diversity policy, which set out the requirements for diversity in Board members and the principles for the selection of Directors.

(1) Policy summary

To achieve sustainable and balanced development, the Company sees increased diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In planning the Board's composition, board diversity needs to be considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

(2) Quantifiable measurers and the progress of the Board Diversity Policy

Selection of candidates of the Company will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

MODEL CODE FOR DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code as its code of conduct regarding directors' securities transactions. Directors are reminded of their obligations under the Model Code on a regular basis. Following specific enquiry by the Company, all Directors have confirmed that they have complied with the required standard set out in the Model Code throughout the year ended 31 December 2016 and up to the date of this report.

AUDIT COMMITTEE

The Board established an audit committee on 12 June 2009 with specific written terms of reference. The audit committee consists of three independent non-executive Directors, namely Mr. HUANG Guosheng, Mr. LAU Sik Yuen and Mr. XING Zhiying. Mr. LAU Sik Yuen is the chairperson of the audit committee of the Board.

The primary duties of the audit committee are to review and approve the Group's financial reporting process and internal control system. The audit committee had reviewed the audited consolidated financial statements for the year ended 31 December 2016 and had also discussed auditing, internal control and financial reporting matters including accounting practices and principles adopted by the Group.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board has overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, maintaining sound systems of risk management and internal controls and reviewing their effectiveness to safeguard interests of the Group as a whole.

The internal audit function monitors the adequacy and effectiveness of the risk management and internal control systems established within the Company and its subsidiaries for proper accounting records, and for ensuring the reliability of financial information. The work of the internal audit function is generally focused on identifying, monitoring and reporting on major risks faced by the Group, including those related to business operations, compliance with laws and regulations and financial reporting. The review of risk management and internal control systems is conducted on an ongoing basis by the internal audit function. The Group has also adopted internal control policies to manage and minimise financial and other risks, ensuring timely and accurate preparation and reporting of financial information, and monitoring compliance with laws by the senior management of the Group in the performance of their duties.

The management of the Group is responsible for designing, maintaining, implementing and monitoring of the risk management and internal control system and ensuring that the Group established and maintained appropriate and effective systems. Management also assists the Board in the implementation of the Group's policies, procedures and controls by identifying and assessing the risks faced, and in the design, operation and monitoring of suitable internal controls to mitigate and control these risks.

The Group has established an audit committee under the Board, which has the functions of monitoring compliance with laws by the Group's senior management and in its daily operations, and of carrying out investigations for suspected breaches of law. The Company convened meetings with the audit committee periodically to discuss financial, operational and compliance controls and risk management functions. Moreover, the Audit Committee assists the Board in leading the management and overseeing their design, implementing and monitoring of the risk management and internal control systems.

The Board reviewed the effectiveness of risk management process and risk management report including key risks and mitigation measure submitted by the Management and the Audit Committee, in which it oversaw the development and implementation of the Group's risk management system.

COMMUNICATION WITH SHAREHOLDERS AND INVESTORS RELATIONS

The Company strictly complies with and implements the Listing Rules to disclose discloseable information on a true, accurate, complete and timely basis and all other information that might have significant impact on the decisions of shareholders and other concerned parties in an active and timely manner. Also, the Company takes effort in ensuring all shareholders have equal access to information.

The management believes that effective communication with the investment community is essential. The executive Directors and the chief financial officer of the Company hold regular briefings and results presentation, attend investor forums and respond to investors' call-in enquiries, participate in interviews with institutional investors and financial analysts in the PRC, Hong Kong and overseas countries to keep them abreast of the Company's business and development as well as operating strategies and prospects. In delivering information to investors, the Company also listens to their advice and collects the feedback from them, in the interests of developing an interactive and mutually beneficial relationship with the Company's investors.

SHAREHOLDERS' RIGHTS

To safeguard shareholders' interests and rights, a separate resolution is proposed for each substantially separate issue at shareholder meetings, including the election of individual directors.

All resolutions put forward at shareholder meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each shareholder meeting.

Shareholder(s) holding not less than one-tenth of the paid up capital of the Company can make a written requisition to the Board or the Company secretary to convene an extraordinary general meeting pursuant to article 58 of the Company's articles of association. The written requisition must state the objects of the meeting, and must be signed by the relevant shareholder(s) and deposited at the registered office of the Company, which is presently situated at Room 1303, 13th Floor, China Evergrande Centre, No. 38 Gloucester Road, Wanchai, Hong Kong. The same procedure also applies to any proposal to be tabled at shareholder meetings.

The Company welcomes enquires from shareholders. The Board will review shareholders' enquires on a regular basis. Specific enquiries and suggestions by shareholders can be sent in writing to the Board or the Company Secretary. Shareholders may also make enquiries with the Board at the general meetings of the Company.

The Group is a long-time, continuous supporter of corporate social responsibility, dedicated to contributing to society through nature preservation and helping the underprivileged. To maintain its sustainable development momentum and become a leading international coal operator, the Group treats its employees, customers, the society and the natural environment ethically.

ENVIRONMENTAL PROTECTION

The Group has been working tirelessly to build green communities. Besides promoting a green lifestyle, the Group strives to minimise damage to the environment while increasing production efficiency, creating win-win outcomes for the Group and the society.

Land reclamation

Consistent with the “those who destroys shall reclaim” guidance issued by the State Council, five coal mines of the Group (namely Fengxi Coal Mine, Chongsheng Coal Mine, Xingtao Coal Mine, Xinglong Coal Mine and Hongyuan Coal Mine) carried out reclamation activities for all parcels of land compromised during the course of mine construction and production. The reclamation project focuses on agricultural production and forest restoration according to the principle of “using for agriculture, forestry or animal husbandry as appropriate”. The Group will spend approximately RMB354 million on reclamation projects for the five coal mines over periods of 22, 31, 25, 30 and 30 years respectively. Throughout the process, the Group will provide streamlined management and land protection services, thereby allowing the land to maximise its economic, social and ecological benefits.

Office 4R

The Group actively encourages its employees to apply “4R” (reduce, reuse, recycle and replace) rules in the office. Under the 4R policy, the Group’s employees replace direct paper printing with electronic scanning and use email to transmit documents in order to reduce the use of paper, and avoid the use of disposable products. From time to time, the Group reminds its employees to reuse single-side printed waste paper for printing internal documents. The Group’s office drinking fountains also use recyclable plastic bottles. In the future, the Group will continue to pursue the 4R policy and maintain a green working environment.

土地復墾

本集團旗下的五個煤礦（分別是馮西煤礦、崇升煤礦、興陶煤礦、興隆煤礦和宏遠煤礦）亦遵從國務院「誰損毀，誰復墾」的規定，為在礦井生產建設過程中造成損毀的全部土地進行土地復墾工程。復墾工程偏重農業生產，按照「宜農則農、宜林則林、宜牧則牧」的原則將土地還原為林地。本集團對五個煤礦的復墾工程將會總共投放約人民幣三億五千四百萬元，分別為期22、31、25、30和30年。過程中本集團亦會提供精细化管理及土地的保護工作，讓土地能在最大限度發揮經濟、社會和生態三方面的效益。

辦公室4R

本集團積極鼓勵員工奉行辦公室「4R」原則，分別為減少使用(reduce)、再用(reuse)、循環再造(recycle)以及替代(replace)。本集團員工在4R原則影響下，使用掃描功能替代直接列印紙張，並轉用電郵傳遞文件，減少使用紙張，亦避免使用一次性產品。本集團更不時提醒員工將單面列印的廢紙重覆再用，用於內部文件列印。另外，本集團辦公室中的飲水機採用可回收膠樽，可被循環再造。日後，本集團將會持續遵行4R原則，保持綠化的工作環境。

Communication channels

The Group believes that work performance and learning attitudes are affected by internal factors such as the working environment, attitudes of co-workers and company policies. The Group therefore adopts an open approach which encourages employees to report their opinions to the management and provide the Group with ways to improve our operations.

Employee benefits

The Group's employees are an important part of its assets. This is why employees are covered by insurance policies taken out by the Group and receive medical benefits in addition to wages and bonuses. The Group also holds an annual year-end party to express its gratitude for the efforts made by the employees throughout the year and grants outstanding performance awards to employees with especially excellent performance.

Employee training

The Group's ability to maintain continuous development amid severe competition depends on each employee performing their role well. Towards this end, the Group regularly invites professionals to organise training seminars on management, law, accounting, finance and other corporate fields for its employees, allowing employees to keep abreast of the latest information and making sure they have the knowledge and skills they need to handle the demands of their jobs.

As a coal operator, the Group attaches great importance to the safety of coal miners at work. Workers are therefore required to comply with the Group's strict safety code and wear appropriate safety equipment before entering coal mines. The Group is particularly proud that the Xingtao coal mine operated by Huameiao Energy was designated a Grade 1 Safety Demonstration Mine by the China National Coal Association.

MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to Note 1.2(c) to the consolidated financial statements, which indicates that the Group incurred a consolidated net loss of RMB316,727,000 during the year ended 31 December 2016 and, as of that date, the Group had net current liabilities of RMB9,463,913,000 and capital deficiency of RMB4,921,307,000. As at 31 December 2016, the borrowings and accrued interest amounting to an aggregate amount of RMB959,229,000 and RMB361,965,000 respectively were not renewed or rolled over upon maturity, of which, up to the date of this report, the banks had renewed or had agreed to renew conditionally borrowings in an aggregate amount of RMB77,500,000. Subsequent to 31 December 2016, the Group had settled the principal and interest of such borrowings of RMB4,356,000 and RMB904,000 respectively. The non-payment of loan principal and interests in accordance with the scheduled repayment dates caused the banks having the rights to call for immediate repayment of all borrowings and their respective interest. As at 31 December 2016, the current borrowings included certain borrowings with scheduled repayment terms over one year amounting to RMB2,473,678,000. In addition, as at 31 December 2016, there were several unsettled litigations against the Group mainly requesting the Group to repay certain payables with interest immediately or within one year with an aggregate amount of RMB678,136,000.

These conditions, along with other matters as set forth in Note 1.2(c) to the consolidated financial statements, indicate the existence of material uncertainties which may cast significant doubt over the Group's ability to continue as a going concern. Our opinion is not modified in respect of these matters.

有關持續經營的重大不明朗因素

我們注意到綜合財務報表附註1.2(c)所載，其披露 貴集團於截至二零一六年十二月三十一日止年度產生綜合虧損淨額人民幣316,727,000元，及於當日， 貴集團擁有流動負債淨額人民幣9,463,913,000元及資金短缺人民幣4,921,307,000元。於二零一六年十二月三十一日，總額分別為人民幣959,229,000元及人民幣361,965,000元的借貸及應計利息尚未於到期時重續或滾存，直至本報告日期，銀行已重續或已同意有條件地重續借貸合共人民幣77,500,000元。二零一六年十二月三十一日後， 貴集團已分別償付該等借貸的本金及利息人民幣4,356,000元及人民幣904,000元。倘未能依照計劃還款日期償付貸款本金及利息，銀行有權要求立即償還所有借貸及其相應利息。於二零一六年十二月三十一日，即期借貸包括計劃還款日期為一年以上的若干借貸，為數人民幣2,473,678,000元。此外，於二零一六年十二月三十一日，有若干項針對 貴集團的未決訴訟，主要要求 貴集團立即或於一年內償還若干應付款項及利息，合共人民幣678,136,000元。

該等情況連同綜合財務報表附註1.2(c)所載的其他事宜，表明存在可能對 貴集團繼續持續經營的能力產生嚴重懷疑的重大不明朗因素。我們的意見並無就此作出修訂。

As at 31 December 2016, the Group had property, plant and equipment of RMB2,614,793,000 and coal mining rights of RMB2,292,588,000. Reversal of impairment of RMB211,597,000 and RMB371,199,000 in relation to property, plant and equipment and coal mining rights respectively were recognised during the year.

於二零一六年十二月三十一日，貴集團擁有物業、廠房及設備人民幣2,614,793,000元及煤炭採礦權人民幣2,292,588,000元。年內分別確認物業、廠房及設備以及煤炭採礦權之減值撥回人民幣211,597,000元及人民幣371,199,000元。

For the purpose of management's impairment assessment, the recoverable amounts of the individual assets or the cash generating units ("CGUs"), to which the assets belonged were determined by management based on their values in use using cash flow projections. In carrying out the impairment assessments, significant management judgement was used to determine the key assumptions, including sales quantity, unit selling price, unit cost and discount rates, underlying the value-in-use calculations.

1.1 General information

China Qinfra Group Limited (the “**Company**”) was incorporated in the Cayman Islands on 4 March 2008 as an exempted company with limited liability under the Companies Law (2007 Revision) of the Cayman Islands. The Company’s shares were listed on the Main Board of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 3 July 2009 (the “**Listing Date**”). The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands and the principal place of business of the Company is 22nd Floor, South Tower, Poly International Plaza, No. 1 Pazhou East Road, Haizhu District, Guangzhou, Guangdong, the People’s Republic of China (the “**PRC**”).

The principal activities of the Company and its subsidiaries (together, the “**Group**”) are coal mining, purchase and sales, filtering, storage, blending of coal in the PRC and shipping transportation. The Group was also engaged in the provision of port services, which the Group has discontinued during the year ended 31 December 2015 as a result of the disposal of a subsidiary, as disclosed in Note 10.

1.2 Basis of preparation

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable International Financial Reporting Standards (“**IFRSs**”), which collective term includes all applicable individual International Financial Reporting Standards, International Accounting Standards (“**IAS**”) and related Interpretations, promulgated by the International Accounting Standards Board (“**IASB**”) and the applicable disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”). A summary of the significant accounting policies adopted by the Group is set out below:

本公司及其附屬公司（統稱為「**本集團**」）的主要業務活動為於中國從事採煤、煤炭購銷、選煤、儲煤、配煤及航運運輸。本集團亦曾提供港口服務，本集團因出售一間附屬公司（誠如附註10所披露）而於截至二零一五年十二月三十一日止年度終止該項業務。

1.2 編製基準

(a) 合規聲明

本綜合財務報表是按照國際會計準則委員會（「**國際會計準則委員會**」）頒佈的所有適用國際財務報告準則（「**國際財務報告準則**」），包括所有適用的個別國際財務報告準則、國際會計準則（「**國際會計準則**」）及相關詮釋，以及香港公司條例的適用披露規定編製。本綜合財務報表亦符合聯交所證券上市規則（「**上市規則**」）的適用披露規定。本集團所採用的重大會計政策概要載於下文。

(a) Statement of compliance (continued)

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

(b) Basis of measurement

These consolidated financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousands, except when otherwise indicated.

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis.

(c) Going concern

During the year ended 31 December 2016, the Group continued to be affected by the unsatisfactory performance of the Chinese coal market. In preparing the consolidated financial statements of the Group, the directors of the Company have given consideration to the future liquidity of the Group in light of the fact that the Group incurred a consolidated net loss of RMB316,727,000 during the year ended 31 December 2016 and, as of that date, the Group's current liabilities exceed its current assets by approximately RMB9,463,913,000 and capital deficiency of RMB4,921,307,000. As at 31 December 2016, the borrowings and accrued interest amounting to an aggregate amount of RMB959,229,000 and RMB361,965,000 respectively were not renewed or rolled over upon maturity of which, up to the date of this report, the banks had renewed or had agreed to renew conditionally borrowings in an aggregate amount of RMB77,500,000. Subsequent to 31 December 2016, the Group had settled the principal and interest of such borrowings of RMB4,356,000 and RMB904,000 respectively. The non-payment of loan principal and interests in accordance with the scheduled repayment dates caused the banks having the rights to call for immediate repayment of all borrowings and their respective interest. In this connection, certain borrowings with scheduled repayment terms over one year totaling RMB2,473,678,000 have been classified as current liabilities.

國際會計準則委員會頒佈了若干新訂及經修訂的國際財務報告準則，該等準則於本集團及本公司的本會計期間首次生效或可以提早採用。附註3列示於當期及過往會計期間因首次採用與本集團有關的該等變動而反映於本綜合財務報表內的會計政策變動。

(b) 計量基準

除非另有指明，本綜合財務報表以人民幣（「人民幣」）為單位列示，所有金額均四捨五入至最接近的千位數計算。

編製本綜合財務報表所用之計量基準為歷史成本法。

(c) 持續經營

截至二零一六年十二月三十一日止年度，本集團繼續受中國煤炭市場的不良表現所影響。於編製本集團綜合財務報表時，本公司董事已考慮本集團的未來流動資金，因為本集團於截至二零一六年十二月三十一日止年度產生綜合虧損淨額人民幣316,727,000元，及於當日，本集團的流動負債超出其流動資產約人民幣9,463,913,000元及資金短缺人民幣4,921,307,000元。於二零一六年十二月三十一日，總額分別為人民幣959,229,000元及人民幣361,965,000元的借貸及應計利息於到期時並未重續或滾存，直至本報告日期，銀行已重續或已同意有條件地重續借貸合共人民幣77,500,000元。二零一六年十二月三十一日後，本集團已分別償付該等借貸的本金及利息人民幣4,356,000元及人民幣904,000元。倘未能依照計劃還款日期償付貸款本金及利息，銀行有權要求立即償還所有借貸及其相應利息。就此而言，計劃還款日期為一年以上，合計金額為人民幣2,473,678,000元的若干借貸已分類為流動負債。

As at the date of this report, the Group has not obtained waivers from the relevant banks on these cross default clauses, but these banks have not taken any action against the Group to demand immediate repayment except for as disclosed in Note 41(a)(v).

In addition, as at 31 December 2016, there were several pending litigations mainly requesting repayment of long outstanding payables with interest against the Group, as set out in Note 41(a).

These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern.

The consolidated financial statements have been prepared on the assumptions that the Group will continue to operate as a going concern notwithstanding the conditions prevailing as at 31 December 2016 and subsequently thereto up to the date of this report. In order to improve the Group's financial position, immediate liquidity and cash flows, and otherwise to sustain the Group as a going concern, the directors of the Company have adopted several measures together with other measures in progress at the date of this report which include, but not limited to, the followings:

- (i) The Group applies cost control measures in cost of sales, administrative expenses and capital expenditures;
- (ii) The Group is maximising its sales effort including seeking long term orders from power plants in the PRC with a view to improving operating cash flows. Considering the recovery of coal market and increasing coal prices, the Group is expected to generate operating cash inflows in 2017 from its existing production facilities;

截至本報告日期，本集團尚未獲有關銀行豁免該等交叉違約條款，但並無銀行對本集團採取行動要求即時還款，惟於附註41(a)(v)所披露除外。

此外，如附註41(a)所載，於二零一六年十二月三十一日，尚有若干項針對本集團的未決訴訟，主要要求償還長期未償還應付賬款及利息。

該等情況表明存在一項重大不明朗因素，令本集團持續經營的能力存在重大疑問。

儘管於二零一六年十二月三十一日及其後至本報告日期出現上述情況，綜合財務報表仍假設本集團將繼續以持續經營基準而編製。為改善本集團之財務狀況、可即時動用之流動資金及現金流量，以及讓本集團繼續以持續經營基準經營，本公司董事已採納若干措施及於本報告日期正在實行之其他措施，包括（但不限於）以下各項：

- (iii) The Group has been actively negotiating with certain banks to renew its borrowings. During the year ended 31 December 2016, the Group has successfully extended the repayment and renewed the terms of certain existing bank loans that had original maturity in 2016, totaling RMB1,986,392,000, which RMB1,915,092,000 and RMB71,300,000 will be falling due before and after the end of 2017 respectively.
- (iv) Subsequent to 31 December 2016, the banks had renewed or had agreed to renew conditionally the borrowings in an aggregate amount of RMB77,500,000. The renewed borrowings would be repayable after 31 December 2017;

(vii) The Group is actively negotiating with the plaintiffs for settlement of the court cases. Subsequent to year end and up to the date of this report, the Group has successfully reached an agreement with certain plaintiffs at a PRC court on a settlement plan over 40 cases with an aggregated amount of RMB72,062,000 that will be repaid by monthly installment. In addition, the Group has reached an agreement with certain plaintiff in settling the amount of RMB1,686,000 by installment. The aggregated amount to be settled before 31 December 2017 amounted to RMB25,686,000. The directors of the Company are of the view that the Group will be able to resolve these matters without significant impact on the Group's cash flow in the next twelve months.

On the basis of the successful implementation of the measures described above in the foreseeable future and after assessing the Group's current and forecasted cash positions, the directors of the Company are satisfied that the Group will be able to meet in full the Group's financial obligations as they fall due for the twelve months from 31 December 2016. Accordingly, the consolidated financial statements of the Group have been prepared on the going concern basis.

Should the Group be unable to continue in business as a going concern, adjustments would have to be made to write down the value of assets to their estimated recoverable amounts, to provide further liabilities that might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities respectively. The effects of these adjustments have not been reflected in the consolidated financial statements.

(vii) 本集團積極與原告就訴訟案件的和解進行磋商。於年結日後及截至本報告日期，本集團已成功於中國法院與若干原告就逾40宗案件、總額為人民幣72,062,000元的和解方案達成一致意見，該等款項須按每月分期償還。此外，本集團就分期支付人民幣1,686,000元的款項與若干原告達成一致意見。於二零一七年十二月三十一日前將予支付的總額為人民幣25,686,000元。本公司董事認為，本集團有能力解決該等事宜，並不會對本集團未來十二個月的現金流量造成重大影響。

(d) Use of judgements and estimates

The preparation of consolidated financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other resources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the consolidated financial statements and major sources of estimation uncertainty are described as follows:

(i) Impairment losses for trade and bill receivables

Impairment losses for trade and bill receivables are assessed and provided based on management's regular review of ageing analysis and evaluation of collectability. A considerable level of judgement is exercised by the management when assessing the credit worthiness and past collection history of each individual customer. Any increase or decrease in the impairment losses for bad and doubtful debts would affect the profit or loss in future years. At 31 December 2016, the carrying amount of the Group's trade and bill receivables was RMB392,342,000 (2015: RMB582,284,000). Further details are disclosed in Note 22.

Other than the mining structures, property, plant and equipment are depreciated on a straight-line basis over the estimated useful lives, after taking into account the estimated residual values. The management periodically reviews changes in technology and industry conditions, asset retirement activity and residual values to determine adjustments to estimated remaining useful lives and depreciation rates. Actual economic lives may differ from estimated useful lives. Periodic reviews could result in a change in depreciable lives and therefore depreciation expenses in future periods. At 31 December 2016, the carrying amount of the Group's property, plant and equipment, other than the mining structures and assets under construction, was RMB1,135,629,000 (2015: RMB1,351,366,000). Further details are disclosed in Note 15.

(iii) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market condition and the historical experience of distributing and selling products of similar nature. It could change significantly as a result of competitor's actions in response to industry cycles or other changes in market condition. Management assesses the estimations at each reporting date. At 31 December 2016, the carrying amount of the Group's inventories was RMB49,652,000 (2015: RMB88,073,000). Further details are disclosed in Note 21.

(iv) Coal reserves

Engineering estimates of the Group's coal reserves are inherently imprecise and represent only approximate amounts because of the subjective judgements involved in developing such information. There are authoritative guidelines regarding the engineering criteria that have to be met before estimated coal reserves can be designated as "proved" and "probable". Proved and probable coal reserve estimates are updated on a regular basis and have taken into account recent production and technical information about each mine. In addition, as prices and cost levels change from year to year, the estimate of proved and probable coal reserves also changes. This change is considered a change in estimate for accounting purposes and is reflected on a prospective basis in related depreciation and amortisation rates.

Despite the inherent imprecision in these engineering estimates, these estimates are used in determining depreciation and amortisation expenses and impairment loss. Depreciation and amortisation rates are determined based on estimated proved and probable coal reserve quantity (the denominator) and capitalised costs of mining structures and coal mining rights (the numerator). The capitalised cost of mining structures are depreciated and coal mining rights are amortised based on the units of coal produced. At 31 December 2016, the carrying amounts of the Group's mining structures recognised in property, plant and equipment and the Group's coal mining rights were RMB737,652,000 (2015: RMB661,379,000) and RMB2,292,588,000 (2015: RMB1,942,708,000) respectively. (iv) 煤炭儲量

The estimation of the liabilities for final reclamation and mine closure involves the estimates of the amount and timing for the future cash spending as well as the discount rate used for reflecting current market assessments of the time value of money and the risks specific to the liability. The Group considers various factors, including future production volume and development plan, the geological structure of the mining regions and reserve volume, to determine the scope, amount and timing of reclamation and mine closure works to be performed. Determination of the effect of these factors involves judgements from the Group and the estimated liabilities may turn out to be different from the actual expenditure incurred. The discount rate used by the Group may also be altered to reflect the changes in the market assessments of the time value of money and the risks specific to the liability, such as changes of the borrowing rate and inflation rate in the market. As changes in estimates occur (such as mine plan revisions, changes in estimated costs, or changes in timing of the performance of reclamation activities), revisions to the obligations will be recognised. At 31 December 2016, the carrying amount of the Group's accrued reclamation obligations was RMB96,458,000 (2015: RMB79,047,000). Further details are disclosed in Note 29.

(vi) Impairment of non-financial assets

The Group assesses at each reporting date whether there is any indication that non-financial assets with definite lives may be impaired. If any such indication exists, the Group estimates the recoverable amount of the assets in accordance with the accounting policy stated in Note 2(k)(ii). In assessing whether there is any indication that non-financial assets may be impaired, the Group considers indications from both internal and external sources of information such as evidence of obsolescence or decline in economic performance of the assets, changes in market conditions and economic environment. These assessments are subjective and require management's judgements and estimations.

(a) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at their proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company.

於附屬公司之投資會自控制開始日期起併入賬綜合財務報表內，直至控制結束日期為止。集團內公司間之結餘、交易及現金流量和集團內公司間之交易所產生之任何未變現盈餘於編製綜合財務報表時悉數抵銷。倘並無出現耗損跡象，集團內公司間之交易所產生之未變現虧損則按照未變現收益之相同方式抵銷。

非控股權益是指並非由本公司直接或間接擁有附屬公司的權益，而本集團並沒有同意與這些權益的持有人訂立任何可導致本集團整體就這些權益而承擔符合金融負債定義的合同義務的額外條款。就每項業務合併，本集團可選擇以公允值或附屬公司的可予識別資產淨值的份額以計量非控股權益。

非控股權益與本公司股東應佔權益在綜合財務狀況表的權益項目中分別列示。本集團業績劃分為非控股權益應佔溢利或虧損及全面收入與本公司股東應佔溢利或虧損及全面收入，於綜合全面收入表中分別列示。

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (Note 2(e)) or, when appropriate, the cost on initial recognition of an investment in an associate (Note 2(b)) or joint venture.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses.

(b) Associates

An associate is an entity in which the Group or the Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (Note 2(k)(ii)). Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in other comprehensive income.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (Note 2(e)).

(c) Goodwill

Goodwill represents the excess of

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

(c) Goodwill (continued)

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit (“CGU”), or groups of CGU, that is expected to benefit from the synergies of the combination and is tested annually for impairment (Note 2(k)).

On disposal of a CGU during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

(d) Foreign currency

(i) Functional and presentation currency

Items included in the financial statements of each entity in the Group are measured using the currency that best reflects the economic substance of the underlying events and circumstances relevant to the entity (the “functional currency”). The consolidated financial statements are presented in RMB (the “presentation currency”), while the functional currency of the Company is Hong Kong dollars (“HKD”).

(ii) Foreign currency transactions

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the financial year. Exchange gains and losses are recognised in profit or loss, except those arising from foreign currency borrowings used to hedge a net investment in a foreign operation which are recognised in other comprehensive income.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

年內出售現金產生單位時，購入商譽的任何應佔金額包括於計算出售的損益內。

(d) 外幣

(i) 功能和呈列貨幣

本集團每間實體的財務報表所載列的項目是最能反映有關該實體的相關事件及情況的經濟實質的貨幣（「功能貨幣」）計量。綜合財務報表是以人民幣（「呈列貨幣」）呈列，而本公司之功能貨幣為港元（「港元」）。

(ii) 外幣交易

年內的外幣交易乃按各交易日期的匯率進行換算。以外幣計值的貨幣資產及負債乃按財政年度末的匯率進行換算。匯率收益及虧損於損益內確認，而用於對沖海外業務投資淨額的外幣借款所導致的外幣收益或虧損則於其他全面收益內確認。

以外幣歷史成本計量的非貨幣資產及負債乃按交易日期的匯率進行換算。以外幣（按公允值列值）計值的非貨幣資產及負債乃按公允值計量之日的匯率進行換算。

(iii) Foreign operations

The assets and liabilities of foreign operations, including fair value adjustments arising on acquisition, are translated to RMB at exchange rates at the reporting date. The income and expenses of foreign operations are translated to RMB at exchange rates at the dates of the transactions.

Foreign currency differences are recognised in other comprehensive income and accumulated in the translation reserve, except to the extent that the translation difference is allocated to non-controlling interests.

If the settlement of a monetary item receivable from or payable to a foreign operation is neither planned nor likely to occur in the foreseeable future, then foreign currency differences arising from such item form part of the net investment in the foreign operation. Accordingly, such differences are recognised in other comprehensive income and accumulated in the translation reserve.

(e) Financial instruments

(i) Non-derivative financial assets

The Group initially recognises loans and receivables on the date that they are originated. All other financial assets are recognised initially on the trade date, which is the date that the Group becomes a party to the contractual provisions of the instrument.

The Group derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or it transfers the rights to receive the contractual cash flows in a transaction in which substantially all the risks and rewards of ownership of the financial asset are transferred, or it neither transfers nor retains substantially all of the risks and rewards of ownership and does not retain control over the transferred assets. Any interest in such transferred financial assets that is created or retained by the Group is recognised as a separate asset or liability.

(iii) 海外業務

海外業務的資產及負債(包括因收購產生的公允值調整)按報告日的外幣匯率換算為人民幣。海外業務的收入及開支按交易日匯率換算為人民幣。

Financial assets and liabilities are offset and the net amount presented in the consolidated statement of financial position when, and only when, the Group has a legal right to offset the amounts and intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

Loans and receivables

Loans and receivables are financial assets with fixed or determinable payments that are not quoted in an active market. Such assets are recognised initially at fair value plus any directly attributable transaction costs. Subsequent to initial recognition, loans and receivables are measured at amortised cost using the effective interest method, less any impairment losses (Note 2(k)).

Loans and receivables comprise pledged and restricted deposits, cash and cash equivalents, trade and bill receivables, and other receivables.

Cash and cash equivalents comprise cash at banks and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition.

(ii) Non-derivative financial liabilities

The Group initially recognises financial liabilities on the trade date at which the Group becomes a party to the contractual provisions of the instrument.

The Group derecognises a financial liability when its contractual obligations are discharged, cancelled or expire.

Financial liabilities at amortised cost comprise trade and bill payables, other payables and borrowings.

(iii) Share capital

Ordinary shares

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of ordinary shares, net of any tax effects, are recognised as a deduction from equity.

Perpetual subordinated convertible securities

Perpetual subordinated convertible securities issued by the Group gives the right to the holder to convert these securities into a fixed number of the Company's shares at any time at a fixed exercise price per share. Perpetual subordinated convertible securities with no contracted obligation to repay its principal nor to pay any distribution are classified as equity. Respective distributions if and when declared are treated as equity dividends.

(i) Recognition and measurement

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses (Note 2(k)(ii)).

Cost includes expenditure that is directly attributable to the acquisition of the asset. The cost of self-constructed assets includes the cost of materials and direct labour, any other costs directly attributable to bringing the asset to a working condition for its intended use, the costs of dismantling and removing the items and restoring the site on which they are located and capitalised borrowing costs (Note 2(s)) and changes in the measurement of existing liabilities recognised for these costs resulting from changes in the timing or outflow of resources required to settle the obligation or from changes in the discount rate. Purchased software that is integral to the functionality of the related equipment is capitalised as part of that equipment.

When proved and probable coal reserves have been determined, costs incurred to develop coal mines are capitalised as part of the cost of the mining structures. All other expenditures, including the costs of removing waste materials, the cost of repairs and maintenance and major overhaul, are expensed as they are incurred.

If significant parts of an item of property, plant and equipment have different estimated useful lives, then they are accounted for as separate items (major components) of property, plant and equipment.

Any gain or loss on disposal of an item of property, plant and equipment (calculated as the difference between the net proceeds from disposal and the carrying amount of the item) is recognised in profit or loss.

(f) 物業、廠房及設備

(i) 確認及計量

物業、廠房及設備的項目按成本減累計折舊及減值虧損計量(附註2(k)(ii))。

成本包括收購資產直接應佔的支出。自建資產的成本包括物料成本和直接勞工成本、令資產符合工作條件作其擬定用途的應佔任何其他直接成本，以及拆卸和搬遷項目及恢復項目所在地原貌的成本及資本化借貸成本(附註2(s))，以及就清償債務所需的時間或資源流出的變化或折現率的變化所引致之該等成本而確認的現有負債的計量變動。購買對相關設備的功能所必需的軟件，會作為該設備的一部分予以資本化。

(ii) Subsequent costs

The cost of replacing a component of an item of property, plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Group and its cost can be measured reliably. The carrying amount of the replaced component is derecognised. The costs of the day-to-day servicing of property, plant and equipment are recognised in profit or loss as incurred.

(iii) Depreciation

Depreciation is based on the cost of an asset less its residual value. Significant components of individual assets are assessed and if a component has an estimated useful life that is different from the remainder of the asset, that component is depreciated separately.

Depreciation is recognised in profit or loss on a straight-line basis over the estimated useful lives of each component of an item of property, plant and equipment, other than mining structures.

The estimated useful lives for the current and comparative years of significant items of property, plant and equipment are as follows:

Electronic and other equipment	3-10 years

Mining structures are depreciated using the units-of-production method, utilising proved and probable coal reserves in the depletion base.

No depreciation is provided for assets under construction until such time as the relevant assets are completed and available for intended use. Assets under construction are transferred to the relevant categories of property, plant and equipment upon the completion of their respective construction.

Depreciation methods, estimated useful lives and residual values are reviewed at each reporting date and adjusted if appropriate.

(iii) 折舊

(g) Coal mining rights

Coal mining rights represent coal mining rights acquired from the government or through a business combination. Coal mining rights are stated at cost less accumulated amortisation and impairment losses (Note 2(k)(ii)), if any.

Coal mining rights are amortised using the units-of-production method, utilising proved and probable coal reserves in the depletion base.

(h) Lease prepayments

Lease prepayments represent the cost of land use rights paid to the PRC government authorities. Lease prepayments are carried at cost less accumulated amortisation and impairment losses (Note 2(k)(ii)), if any.

Amortisation is charged to profit or loss on a straight-line basis over the respective periods of the rights except that the amortisation is included as part of assets under construction when the amortisation can be directly attributable to the cost of relevant assets during the construction period.

(i) Inventories

Inventories are carried at the lower of cost and net realisable value.

The cost of inventories is calculated using the weighted average cost formula and comprises expenditure incurred in acquiring the inventories, production or conversion costs and other costs incurred in bringing them to their existing location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

(g) 煤炭採礦權

煤炭採礦權指透過業務合併收購的煤礦開採權。煤炭採礦權按成本減累計攤銷及減值虧損(附註2(k)(ii))(如有)列賬。

煤炭採礦權使用探明及估計煤炭儲量，以耗蝕基準利用單位生產法予以攤銷。

(h) 租賃預付賬款

租賃預付賬款乃指支付中國政府機關的土地使用權成本。租賃預付賬款按成本減去累計攤銷及減值虧損列賬(附註2(k)(ii))(如有)。

攤銷在相關使用年期內以直線法於損益中扣除，除非攤銷可直接分類為建設期內的相關資產成本，則其可計入在建資產的一部分。

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(j) Obligations for reclamation

The Group's obligations for reclamation consist of spending estimates at both surface and underground mines in accordance with the PRC rules and regulations. The Group estimates its liabilities for final reclamation and mine closure based upon detailed calculations of the amount and timing of the future cash spending to perform the required work. Spending estimates are escalated for inflation, then discounted at a discount rate that reflects current market assessments of the time value of money and the risks specific to the liability such that the amount of provision reflects the present value of the expenditures expected to be required to settle the obligation. The Group records a corresponding asset associated with the liability for final reclamation and mine closure. The obligation and corresponding asset are recognised in the period in which the liability is incurred. The asset is depreciated on the units-of-production method over its expected life and the liability is accreted to the projected spending date. As changes in estimates occur (such as mine plan revisions, changes in estimated costs, or changes in timing of the performance of reclamation activities), the revisions to the obligation and the corresponding asset are recognised at the appropriate discount rate.

出售存貨時，該等存貨之賬面值於相關收益確認期間確認為支出。存貨撇減至可變現淨值及存貨的所有虧損，均在出現撇減或虧損的期間內確認為支出。存貨的任何撇減撥回的數額，均在出現撥回的期間內確認為已列作支出的存貨數額之扣除。

(j) 復墾承擔

本集團的復墾承擔包括根據中國法規及法例規定對露天礦及地下礦的估計開支。本集團根據為從事必要工程投放未來現金而詳細計算的金額及時間估計其就最後復墾及礦井關閉作出的承擔。估計開支因應通脹而調高，其後按反映現時市場對貨幣時間價值的評估以及負債特定風險的折現率折現，致使撥備金額反映為償付承擔預期所須開支的現值。本集團錄得一項與最後復墾及礦井關閉的負債有關聯的相應資產。該承擔及相應資產於負債產生期間確認。資產於其預計年內按生產單位法予以折舊，負債則累計至預定開支日期。由於出現估計變動（如礦場計劃修訂、估計成本變動或進行復墾活動的時間變動），該承擔及相應資產的修訂按適當折現率予以確認。

(k) Impairment of assets

(i) Non-derivative financial assets

Financial assets not classified as at fair value through profit or loss are assessed at each reporting date to determine whether there is objective evidence of impairment. A financial asset is impaired if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset, and that the loss event(s) had an impact on the estimated future cash flows of that asset that can be estimated reliably.

Objective evidence that financial assets are impaired includes default or delinquency by a debtor, restructuring of an amount due to the Group on terms that the Group would not consider otherwise, indications that a debtor or issuer will enter bankruptcy, adverse changes in the payment status of borrowers or issuers, the disappearance of an active market for a security, or observable data indicating that there is measurable decrease in expected cash flows from a group of financial assets. In addition, for an investment in an equity security, objective evidence of impairment includes a significant or prolonged decline in its fair value below its cost.

The Group considers evidence of impairment for financial assets measured at amortised cost (loans and receivables) at both an individual asset and a collective level. All individually significant assets are individually assessed for impairment. Those found not to be impaired are then collectively assessed for any impairment that has been incurred but not yet individually identified. Assets that are not individually significant are collectively assessed for impairment. Collective assessment is carried out by grouping together assets with similar risk characteristics.

In assessing collective impairment, the Group uses historical information on the timing of recoveries and the amount of loss incurred, and makes an adjustment if current economic and credit conditions are such that the actual losses are likely to be greater or less than suggested by historical trends.

(k) 資產減值

(i) 非衍生金融資產

並無分類為按公允值計入損益的金融資產於報告日進行評估，以釐定是否有客觀證據顯示出現減值。倘因資產首次確認後發生一項或多項事件而出現減值之客觀證據且該虧損事件對能夠可靠計量之該項資產的估計未來現金流造成影響，則該項金融資產將予以減值。

金融資產出現減值的客觀證據可包括：債務人違約或拖欠債務、根據本集團原本不會考慮的條款進行的應付本集團款項重組、有跡象顯示債務人或發行人將面臨破產、借款人或發行人支付情況的不利變動、證券失去交易活躍的市場或有顯著數據表明來自金融資產組合的預測現金流量有可量化的減少。此外，就投資於股本證券而言，減值的客觀證據包括其公允值大幅低於其成本值或長期下跌。

本集團按個別資產及綜合水平考慮按攤銷成本計量之金融資產（貸款及應收賬款）減值證據。所有個別重大資產單獨進行減值評估。並未發現減值之資產會就已發生但未個別識別之任何減值進行綜合評估。綜合評估通過將風險特徵相近之資產組合在一起進行。

評估綜合減值時，本集團運用可收回時間及產生虧損之金額方面的歷史資料，並於目前經濟及信貸狀況會導致實際虧損可能高於或低於歷史趨勢所提出結果時進行調整。

An impairment loss in respect of a financial asset measured at amortised cost is calculated as the difference between its carrying amount and the present value of the estimated future cash flows discounted at the asset's original effective interest rate. Losses are recognised in profit or loss and reflected in an allowance account against loans and receivables. When the Group considers that there are no realistic prospects of recovery of the asset, the relevant amounts are written off. If the amount of impairment loss subsequently decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, then the previously recognised impairment loss is reversed through profit or loss.

(ii) Non-financial assets

The carrying amounts of the Group's non-financial assets, other than inventories and deferred tax assets, are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated. Goodwill that have indefinite useful lives or coal mining rights that are not yet available for use, are tested annually for impairment. An impairment loss is recognised if the carrying amount of an asset or CGU exceeds its estimated recoverable amount.

The recoverable amount of an asset or CGU is the greater of its value in use and its fair value less costs of disposal. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or CGU. For impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or CGUs. Subject to an operating segment ceiling test, CGUs to which goodwill has been allocated are aggregated so that the level at which impairment testing is performed reflects the lowest level at which goodwill is monitored for internal reporting purposes. Goodwill acquired in a business combination is allocated to groups of CGUs that are expected to benefit from the synergies of the combination.

(i) 非衍生金融資產 (續)

有關按已攤銷成本計量金融資產的減值虧損乃按金融資產的賬面值與按資產最初實際利率折讓的估計未來現金流量的現值間的差額計算。虧損於損益內確認且貸款及應收賬款的撥備賬中反映。倘本集團認為資產並無可收回之實際前景，則撇銷相關金額。倘減值虧損金額後續減少，且該減少與確認減值後發生的事件客觀相關，則此前確認的減值虧損撥回至損益。

(ii) 非金融資產

除存貨及遞延稅項資產外，本集團非金融資產的賬面值，會於各申報日期獲審閱，以決定是否有任何減值跡象。倘出現任何有關跡象，則會估計該資產的可收回金額。無限定使用年期的商譽或尚未可供使用的煤炭採礦權於每年進行減值測試。倘一項資產或現金產生單位的賬面值超過其估計可收回金額，則會確認減值虧損。

資產或現金產生單位的可收回金額是其使用價值及其公允值減銷售成本兩者中的較高者。在評估使用價值時，估計未來現金流量會按可以反映當時市場對貨幣時間值及資產或現金產生單位特定風險的評估的稅前貼現率，貼現至其現值。就減值測試而言，資產集合為資產之最小組別，由持續使用中產生現金流量，當中大部分獨立於其他資產或現金產生單位之現金流量。經作出經營分部上限測試之後，為使進行減值測試的級別反映為內部報告目的對商譽進行監察的最低級別，已獲分配商譽的現金產生單位會予以整合。於業務合併中獲得的商譽會分配至預期可從合併的協同效應獲益的現金產生單位組別。

The Group's corporate assets do not generate separate cash inflows and are utilised by more than one CGU. Corporate assets are allocated to CGUs on a reasonable and consistent basis and tested for impairment as part of the testing of the CGU to which the corporate asset is allocated.

Impairment losses are recognised in profit or loss. Impairment losses recognised in respect of CGUs are allocated first to reduce the carrying amount of any goodwill allocated to the CGU (group of CGUs), and then to reduce the carrying amounts of the other assets in the CGU (group of CGUs) on a pro rata basis.

An impairment loss in respect of goodwill is not reversed. For other assets, an impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

(l) Employee benefits**(i) Short-term employee benefits**

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Defined benefit retirement plan obligations

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees' basic salaries and are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund.

本集團的企業資產並無產生個別現金流量並由多於一個現金產生單位使用。企業資產以合理和一致的基礎分配至現金產生單位，並進行減值測試以作為測試企業資產獲分配的現金產生單位的一部分。

減值虧損於損益中確認。就現金產生單位確認的減值虧損會予以分配，首先減去分配予現金產生單位（現金產生單位組別）的任何商譽的賬面值，其後按比例減去該現金產生單位（現金產生單位組別）中其他資產的賬面值。

有關商譽的減值虧損不會撥回。就其他資產而言，撥回減值虧損僅以資產的賬面金額不超過倘無確認減值虧損時所釐定的賬面金額（經扣除折舊或攤銷）為限。

(l) 僱員福利**(i) 短期僱員福利**

薪酬、每年花紅、有薪年假及非貨幣福利成本，於僱員提供有關服務之年度內累計。倘延遲付款會帶來重大影響，該等數額須按現值列賬。

(ii) 定額福利退休計劃責任

本集團根據強制性公積金計劃條例，為其所有香港僱員提供定額供款強制性公積金退休福利計劃（「強積金計劃」）。供款乃根據僱員基本薪金之百分比計算，並於有關款項根據強積金計劃之規則須予支付時計入綜合全面收入表。強積金計劃之資產乃獨立於本集團之資產，並由獨立管理之基金持有。

The employees of the subsidiaries within the Group which operate in the PRC are required to participate in the central pension scheme operated by the local municipal government. These PRC subsidiaries are required to contribute a percentage of their payroll costs to the central pension scheme as specified by the local municipal government. The contributions are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the central pension scheme.

There were no forfeited contributions utilised by the Group to reduce existing level of contributions for each of the years.

(iii) Share-based payments

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in a capital reserve within equity. The fair value is measured at grant date using the Binomial Model and Binomial Lattice Model, taking into account the terms and conditions upon which the options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the options, the total estimated fair value of the options is spread over the vesting period, taking into account the probability that the options will vest.

During the vesting period, the number of share options that is expected to vest is reviewed. Any resulting adjustment to the cumulative fair value recognised in prior years is charged/credited to the profit or loss for the year of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the capital reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of options that vest (with a corresponding adjustment to the share-based compensation reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognised in the share-based compensation reserve until either the option is exercised (when it is transferred to share capital and share premium accounts) or the option expires (when it is released directly to retained earnings or accumulated losses).

本集團於中國經營之附屬公司之僱員須參加由當地市政府所運作的中央退休金計劃。該等中國附屬公司須按其薪金成本的若干百分比向該中央退休金計劃供款。有關供款於根據該中央退休金計劃之規則須支付時計入綜合全面收入表。

本集團於各年度概無使用任何沒收供款減少現有供款額。

(iii) 以股份為基礎之付款

授予僱員購股權的公允值會確認為僱員成本，並相應在權益內增加資本儲備。公允值於授予日期按二項式模型及二項式點陣模型計量，當中考慮到授予購股權的條款及條件。倘若僱員須符合歸屬條件才無條件擁有購股權，則購股權的估計公允值總額會於考慮到購股權歸屬的可能性後在歸屬期內分攤。

於歸屬期內會檢討預期歸屬的認股權數目。對以前年度已確認的累積公允值所作出的調整，會在檢討年度扣自／計入損益表，除非原有僱員開支符合資格確認為資產，則作別論，並在資本儲備內作出相應調整。在歸屬日期，確認為開支的金額會作出調整，以反映實際歸屬的認股權數目（並在以股份為基礎補償儲備內作出相應調整），惟倘若僅因未能滿足本公司股份市場價格的歸屬條件而沒收則除外。權益金額於以股份為基礎補償儲備內確認，直至購股權獲行使（於轉撥至股本及股份溢價賬時）或購股權到期（於直接撥回至保留盈利或累計虧損時）。

(m) Provisions and contingent liabilities

Provisions are recognised when the Group or the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(n) Revenue

Revenue is measured at the fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follows:

(i) Sales of goods

Revenue from the sales of goods in the course of ordinary activities is measured at the fair value of the consideration received or receivable, net of returns, trade discounts and value added tax. Revenue is recognised when persuasive evidence exists, usually in the form of an executed sales agreement, that the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is probable, the associated costs and possible return of goods can be estimated reliably, there is no continuing management involvement with the goods, and the amount of revenue can be measured reliably. If it is probable that discounts will be granted and the amount can be measured reliably, then the discount is recognised as a reduction of revenue as the sales are recognised.

如因過往事件導致本集團或本公司負上法律或推定責任且有可能須流出經濟利益以結算該責任及作出可靠估計，則會確認撥備。倘金錢時間價值屬重大，撥備按支出現值列賬以結算該責任。

如不大可能須流出經濟利益，或金額不能可靠估計，則該責任披露為或然負債，除非經濟利益流出的可能性極微則作別論。可能責任（其存在將僅透一項或多項未來事件發生或不發生而確認）亦披露為或然負債，除非經濟利益流出的可能性極微則作別論。

(n) 收益

收益按已收或應收代價的公允值計量。收益是在經濟利益可能流入本集團，以及能夠可靠地計算收益和成本（如適用）時，根據下列方法在損益賬內確認：

(i) 商品銷售

商品銷售商品銷售收益於一般活動過程中按已收或應收代價扣除退款、貿易折扣及增值稅後的公允值列賬。倘存在具說服力證據，通常在簽訂銷售協議形式情況下，商品的所有權附帶的重大風險及回報轉移至買家，並應可收回代價，而有關成本及退貨的可能可以可靠地估計，且並無參與持續管理商品，且收益金額可可靠計量時，便會確認收益。倘折讓可能將獲授出及金額可可靠計量時，因該出售已確認，則該折讓確認為收益減損。

(ii) Charter hire income

Income from time charter, which is of operating lease in nature, is recognised on a straight-line basis over the period of each charter.

Income from voyage charter is recognised on a percentage-of-completion basis, which is determined on the time proportion method of each individual voyage.

(iii) Government subsidies

Government subsidies are recognised when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Subsidies that compensate the Group for expenses incurred are recognised as other income in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Subsidies that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the estimated useful life of the asset by way of reduced depreciation expense.

(o) Operating lease payments

Payments made under operating leases are recognised in profit or loss on a straight-line basis over the term of the lease. Lease incentives received are recognised as an integral part of the total lease expense, over the term of the lease.

(p) Finance income and costs

Finance income comprise interest income. Interest income is recognised as it accrues in profit or loss, using the effective interest method.

Finance costs comprise interest expense on borrowings and bank charges. Borrowing costs that are not directly attributable to the acquisition, construction or production of a qualifying asset are recognised in profit or loss using the effective interest method.

期租合約收入 (性質為經營租約) 於各租期以直線法確認。

程租合約收入按完成百分比為基準，就各個別航程以時間比例確認。

(iii) 政府補助金

倘合理保證將收取政府補助金，而本集團將遵守其附帶條件，則政府補助金將予以確認。補償本集團所產生的開支的補助金，會於產生開支的同一期間內作為其他收入有系統地於損益確認。補償本集團資產成本的補助金從資產賬面值中扣除，其後經由已扣除的折舊開支於資產估計可使用年期內在損益中實際確認。

(o) 經營租賃付款

經營租賃項下的付款會於租賃年期以直線法為基準在損益賬確認。所收取的租賃獎勵於租賃年期確認為租賃開支總額的組成部分。

(p) 財務收入及成本

財務收入包括利息收入。利息收入於其產生時以實際利率法於損益內確認。

財務成本包括借貸的利息開支及銀行收費。並非直接由收購、建設或生產合資格資產而產生的借貸成本均以實際利率法於損益賬確認。

Income tax expense for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the reporting date, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purpose and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax assets can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

所得稅開支於年內所得稅開支包括即期稅項及遞延稅項資產及負債之變動。即期稅項以及遞延稅項資產及負債變動於損益表中確認，惟與其他全面收入或直接於權益中確認的相關稅項金額則分別於其他全面收入或直接於權益內確認除外。

即期稅項是年內就應課稅收入而預期應付的稅項，乃按於報告日制定或實質制定的稅率，以及過往年度應付稅項的任何調整而計算。

遞延稅項資產及負債乃分別來自可扣稅或應課稅暫時性差異，即因資產及負債分別就財務報告及稅基而言之賬面值之間的差異而產生。遞延稅項資產亦會因未動用稅項虧損及未動用稅項抵免而產生。

除若干有限情況外，所有遞延稅項負債及遞延稅項資產當其甚有可能用於抵銷未來應課稅溢利時均會予以確認。支持確認由可抵扣暫時差異所產生遞延稅項資產的未來應課稅溢利，包括因轉回目前存在的應課稅暫時差異而產生的數額；但這些轉回的差異必須與同一稅務機關及同一應課稅實體有關，並預期在可抵扣暫時差異預計轉回的同一年間或遞延所得稅資產所產生可抵扣虧損可轉回或結轉的期間內轉回。在決定目前存在的應課稅暫時差異是否足以支持確認由未可抵扣虧損和未利用稅款抵減所產生的遞延所得稅資產時，亦會採用同一準則，即差異是否與同一稅務機關及同一應課稅實體有關，並是否預期在能使用可抵扣虧損和未利用稅項抵減撥回的同一年間內轉回。

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the reporting date. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each reporting date and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same tax authority on either:
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

遞延稅項確認額乃按資產及負債之賬面值之預期變現或支付形式，使用於報告日已頒佈或實質頒佈之稅率計算。遞延稅項資產及負債不予折現計算。

於各報告日，遞延稅項資產之賬面值均進行複核，對預期不再有足夠之應課稅溢利以供使用有關遞延稅項則予扣減。倘若有可能獲得足夠之應課稅溢利，則任何有關扣減均會被撥回。

支付相關股息之負債確認時，則分派股息產生之額外所得稅確認。

即期稅項結餘及遞延稅項結餘以及有關變動，均會個別呈列及不作抵銷。如本集團可依法行使權利將即期稅項資產抵銷即期稅項負債，並在符合下列其他條件之情況下，即期稅項資產方會與即期稅項負債抵銷，以及遞延稅項資產會與遞延稅項負債抵銷：

- 如屬即期稅項資產及負債，本集團擬以淨額基準清償或同時變現資產並清償負債；或
- 如屬遞延稅項資產及負債，被同一稅務機關對以下實體徵收所得稅而產生：
 - 同一個應課稅實體；或
 - 不同的應課稅實體，在未來每一個預期將清償或收回重大數額之遞延稅項負債或資產的期間，該等實體擬以淨額變現即期稅項資產及清償稅項負債或兩者同時進行。

(r) Dividends payable

Dividends are recognised as a liability in the period in which they are declared.

(s) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

(t) Financial guarantee contracts

Financial guarantee contracts are contracts that require the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payments when due, in accordance with the terms of a debt instrument. Such financial guarantees are given to banks and financial institutions on behalf of subsidiaries to secure interest-bearing bank borrowings and other banking facilities.

Financial guarantees are initially recognised in the consolidated financial statements at fair value on the date the guarantee was given. Subsequent to initial recognition, the Company's liabilities under such guarantees are measured at the higher of the initial amount, less amortisation of fees recognised in accordance with IAS 18, and the best estimate of the amount required to settle the guarantee. These estimates are determined based on experience of similar transactions and history of past losses, supplemented by management's judgement. The fee income earned is recognised on a straight-line basis over the life of the guarantee.

股息於宣派的期間確認為負債。

(s) 借貸成本

需長時間收購、建造或生產才可以投入擬定用途或出售的資產直接相關的借貸成本予以資本化並構成該資產之部分成本。其他借貸成本於產生期間列支。

屬於合資格資產成本一部分的借貸成本在資產產生開支、借貸成本產生及使資產投入擬定用途或銷售所必須的準備工作進行期間開始資本化。在使合資格資產投入擬定用途或銷售所必須的絕大部分準備工作中斷或完成時，借貸成本便會暫停或停止資本化。

(t) 財務擔保合約

財務擔保合約為須發行人作出特定付款以償付持有人因特定債務人未能根據債務工具的條款於到期時還款而產生的虧損的合約。有關財務擔保由若干附屬公司代表同系附屬公司向銀行提供，以取得貸款、透支及其他銀行融資。

財務擔保初步按作出擔保當日的公允值於綜合財務報表確認。初步確認後，本集團於該等擔保下的責任以初步金額扣除按照國際會計準則第18號確認的費用攤銷與對結算擔保所需金額的最佳估計的較高者計量。該等估計依照類似交易的經驗及過往虧損記錄連同管理層的判斷釐定。所賺取的費用收入於擔保年內按直線法確認。

Where guarantees in relation to interest-bearing bank borrowings of subsidiaries or associates are provided for no compensation, the fair values are accounted for as contributions and recognised as part of the cost of the investment in the financial statements of the Company.

(u) Earnings per share

The Group presents basic and diluted earnings per share (“EPS”) data for its ordinary shares. Basic EPS is calculated by dividing the profit or loss attributable to ordinary shareholders of the Company by the weighted average number of ordinary shares outstanding during the period. Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares.

(v) Segment reporting

Operating segments, and the amounts of each segment item reported in the consolidated financial statements, are identified from the financial information provided regularly to the Group’s most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group’s various lines of business and geographical locations.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

(a) Segment results, assets and liabilities

The Group has three reportable segments – coal business, shipping transportation and port business – which are the Group's strategic business units. These strategic business units offer different products and services, and are managed separately because they require different technology and marketing strategies. During the year ended 31 December 2015, the port business segment was disposed of and was presented as discontinued operation which details were set out in Note 10. For each of the strategic business units, the Chief Executive Officer (the "CEO") reviews internal management reports on a monthly basis.

For the purposes of assessing segment performance and allocating resources between segments, the CEO monitors the results, assets and liabilities attributable to each reportable segment on the following basis:

The measure used for reporting segment profit/(loss) is adjusted loss before net finance costs and income tax expense. Items not specifically attributable to individual segments, such as unallocated head office and corporate administration costs are further adjusted.

Segment assets include all tangible assets, coal mining rights, lease prepayments, interest in an associate and current assets with the exception of other corporate assets. Segment liabilities include trade and bill payables, other payables attributable to activities of the individual segments, accrued reclamation obligations and borrowings managed directly by the segments.

Revenue and expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those segments.

On 26 June 2015, Hong Kong Qinfra Trading Limited, a wholly owned subsidiary of the Company, entered into a conditional disposal agreement with Zhuhai Port Logistics Centre Co., Limited, a wholly owned subsidiary of Zhuhai Port Holdings Group Co., Limited to dispose of its 60% of the equity interest in Zhuhai Qinfra Port Co., Limited ("Zhuhai Port") for a cash consideration of RMB350,000,000 (the "Disposal"). Zhuhai Port Holdings Group Co., Limited is the non-controlling shareholder of Zhuhai Port who owned 40% of the equity interest in Zhuhai Port immediately before the Disposal.

Zhuhai Port was incorporated in the PRC and is principally engaged in provision of port services. The Disposal was completed on 7 August 2015. The Disposal constitutes a discontinued operation as Zhuhai Port represents the port business of the Group, a separate major line of business.

These calculations use cash flow projections based on financial budgets approved by management covering the useful life of the vessels. A pre-tax discount rate of 12.5% was applied and the discount rate reflects the specific risks relating to the shipping transportation segment.

Tongmei Qinfra sells coal in the PRC and is a strategic partnership for the Group for its coal business.

During the year ended 31 December 2015, Tongmei Qinfra suffered losses and management re-assessed the recoverable amount of the Group's interest in Tongmei Qinfra. The recoverable amount of equity interest in Tongmei Qinfra has been determined to be minimum based on its value in use with a pre-tax discount rate of 15.16%. The directors of the Company determined that the likelihood of recovering the interests in Tongmei Qinfra was remote. Accordingly, a full provision for impairment loss of RMB46,567,000 was made. During the year ended 31 December 2016, Tongmei Qinfra continued to suffer losses and no reversal of impairment has been made.

During the year ended 31 December 2016, the Group has discontinued recognition of its share of losses of Tongmei Qinfra. The amounts of unrecognised shares of the associate, extracted from the relevant management accounts of the associate, both for year and cumulatively, are as follows:

In addition to the disposal of Zhuhai Port as disclosed in Note 10, the Group disposed of two subsidiaries, together with two associates, during the year ended 31 December 2015.

On 10 April 2015, the Group agreed to sell its entire equity interest in Gerrards Agents (Macao Commercial Offshore) Limited (“**Gerrards Agents**”), an indirectly owned subsidiary of the Company, at an aggregate consideration of HKD1,995,000 (approximately equivalent to RMB1,662,000) to an independent third party. The completion date of the disposal was on 22 July 2015. Gerrards Agents was dormant.

On 30 December 2015, the Group has agreed to sell its entire equity interest in Bright Rock, an indirectly owned subsidiary of the Company, together with two associates, Tiaro Coal and Paragon Coal, at an aggregate consideration of AUD20,000 (approximately equivalent to RMB95,000) to another independent third party. The completion date of the disposal was on 30 December 2015. The principal activity of Bright Rock was investment holding of these two associates.

33. FINANCIAL GUARANTEE CONTRACTS

As at 31 December 2016, the Company has executed corporate guarantee to certain financial institution with respect to general banking facilities granted to certain subsidiaries of the Company of approximately RMB4,206,554,000 (2015: RMB5,934,404,000). In addition, as at 31 December 2016, the Company and certain subsidiaries of the Company have executed corporate guarantee to certain banks with respect to general banking facilities granted to an associate of approximately RMB640,600,000 (2015: RMB635,690,000) as disclosed in Note 37(c).

The Company has not recognised any financial liability (2015: Nil) in respect of the guarantees granted for general banking facilities of the associate as the Directors considered that it was not probable that the repayments of the borrowings from the associate would be in default and the estimated fair value is insignificant.

34. FINANCIAL RISK MANAGEMENT AND FAIR VALUES

Exposure to credit risk, liquidity risk, interest risk and currency risk arises in the normal course of the Group's businesses. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

The Group's credit risk is primarily attributable to trade and bill receivables. Management has a credit policy in place and the exposure to credit risk is monitored on an ongoing basis. Credit evaluations are performed on all customers requiring credit over a certain amount.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customer operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the reporting date, 64.4% (2015: 87.7%) of the net trade and bill receivables was due from the five largest customers within the coal business segment. In view of the history of business dealings with the customers and the sound collection history of the receivables due from them, management believes that there is no material credit risk inherent in the Group's outstanding receivable balance due from these customers. Management makes periodic assessment on the recoverability of the trade and other receivables based on historical payment records, the length of the overdue period, the financial strength of the debtors and whether there is any dispute with the debtors. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the consolidated statement of financial position. (b) Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, but the borrowings are subject to approval by the parent company's management. The Group's policy is to regularly monitor its liquidity requirements and its compliance with any lending covenants, to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

The exchange rate adopted for the foreign exchange transactions are the rates of exchange quoted by the People's Bank of China that are determined largely by supply and demand. The Group is exposed to foreign currency risk primarily through purchases giving rise to cash balances that are denominated in USD, while all the other operations of the Group are mainly transacted in RMB. Changes in exchange rate affect the RMB value of purchase costs of commodities that are denominated in foreign currencies.

IFRS 9 Financial Instruments

In July 2015, the IASB issued the final version of IFRS 9, bringing together all phases of the financial instruments project to replace IAS 39 and all previous versions of IFRS 9. The standard introduces new requirements for classification and measurement, impairment and hedge accounting. The Group expects to adopt IFRS 9 from 1 January 2018. The Group expects that the adoption of IFRS 9 will have an impact on the classification and measurement of the Group's financial assets. Further information about the impact will be available nearer the implementation date of the standard.

IFRS 15 Revenue from Contracts with Customers

IFRS 15 establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. IFRS 15 will supersede the current revenue recognition guidance including IAS 18 Revenue, IAS 11 Construction Contracts and the related Interpretations when it becomes effective.

The core principle of IFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, IFRS 15 introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under IFRS 15, an entity recognises revenue when a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer.

Far more prescriptive guidance has been added in IFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by IFRS 15.

The Group is still in the process of assessing the impact of IFRS 15. The directors of the Company believe that it is impractical to disclose the impact in these consolidated financial statements until the Group has completed the assessment.

IFRS 16 Leases

Under IFRS 16 a lessee recognises a right-of-use asset and a lease liability. The right-of-use asset is treated similarly to other non-financial assets and depreciated accordingly and the liability accrues interest. This will typically produce a front-loaded expense profile (whereas operating leases under IAS 17 would typically have had straight-line expenses) as an assumed linear depreciation of the right-of-use asset and the decreasing interest on the liability will lead to an overall decrease of expense over the reporting period.

The lease liability is initially measured at the present value of the lease payments payable over the lease term, discounted at the rate implicit in the lease if that can be readily determined. If that rate cannot be readily determined, the lessee shall use their incremental borrowing rate.

As with IFRS 16's predecessor, IAS 17, lessors classify leases as operating or finance in nature. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of an underlying asset. Otherwise a lease is classified as an operating lease.

For finance leases a lessor recognises finance income over the lease term, based on a pattern reflecting a constant periodic rate of return on the net investment. A lessor recognises operating lease payments as income on a straight-line basis or, if more representative of the pattern in which benefit from use of the underlying asset is diminished, another systematic basis.

- (i) Litigation claims relating to the performance of the contract execution between Liaoning Zhonghuitong Asset Management Limited (“Zhonghuitong”) and Xinglong Coal and Huameiao Energy

On 29 November 2012, Xinglong Coal acquired certain coal mining machineries at a consideration of RMB94,708,000. On 27 June 2013, Xinglong Coal settled the purchase of machineries by way of bill payables of RMB94,708,000 which was guaranteed by Zhonghuitong. Xinglong Coal eventually repaid the bill payables of RMB59,021,000 and failed to honor its remaining obligation of RMB35,687,000. As a guarantor, Zhonghuitong settled the principal and interest of the bill payables of RMB35,687,000 on behalf of Xinglong Coal. During the year ended 31 December 2015, Zhonghuitong applied to the Liaoning Shenyang Municipal Intermediate People’s Court to order Xinglong Coal and Huameiao Energy to repay RMB35,687,000, late penalty charges of RMB3,788,000 and interest payment of RMB6,888,000, totalling RMB46,363,000, in addition to the court litigation costs. The interest payment was calculated on the basis of 0.05% per day from 28 June 2014 until the settlement.

The principal and interest of RMB35,687,000 had already been recognised as payables to Zhonghuitong included in other payables in the consolidated statement of financial position as at 31 December 2015. As a result of the foregoing, the Group further recognised the late penalty charges of RMB3,788,000 and interest charges of RMB6,888,000 in the consolidated financial statements for the year ended 31 December 2015.

During the year ended 31 December 2016, pursuant to the judgements, the Group was ordered to make immediate repayment of payables to the plaintiffs, with additional corresponding legal costs of RMB279,000, which have been recognised in the consolidated financial statements for the year ended 31 December 2016.

Pursuant to the judgements, several bank accounts of the Group were frozen for one year from the date of the judgements and the coal mining rights of the Group and two properties of the Group's related companies were frozen for three years from the date of judgement. In addition, the Group was ordered to make immediate repayment of the aforesaid balances.

Up to the date of this report, the Group is still in the process of negotiating with these two banks to renew its loans outstanding.

(vi) Litigation claims relating to the performance of the contract execution Heilongjiang HengJiu Construction Limited ("HengJiu") and Chongsheng Coal and Fengxi Coal

During the year ended 31 December 2016, there was a litigation claim initiated by HengJiu against the Group to demand immediate repayment of overdue payable in relation to down-hole construction with an aggregate amount of RMB30,000,000 and the late penalty charges of RMB9,000,000. An aggregate amount of RMB30,000,000 had already been recognised as payables to these suppliers included in other payables in the consolidated statement of financial position as at 31 December 2016. As a result of the foregoing, the Group further recognised the late penalty charges of RMB9,000,000 in the consolidated financial statements for the year ended 31 December 2016. Up to the date of this report, the case has yet been concluded.

- (vii) Litigation claims relating to the performance of the contract execution Yu Lin Zhong Kuang Wan Tong Construction Limited Company (“Yu Lin Zhong Kuang”) and Xinglong Coal and Hongyuan Coal

During the year ended 31 December 2016, there was a litigation claim initiated by Yu Lin Zhong Kuang against the Group to demand immediate repayment of overdue payable in relation to construction of coal mining infrastructure with an aggregate amount of RMB101,323,000. It had already been recognised included in other payables in the consolidated statement of financial position as at 31 December 2016. The case was concluded on 9 January 2017 in the Shanxi Provincial Xinzhou City Intermediate People’s Court. As a result of the foregoing, the Group further recognised the late penalty charges of RMB16,345,000 and interest of RMB13,101,000 in the consolidated financial statements for the year ended 31 December 2016. The Group appealed to Shanxi Provincial High People’s Court on 22 February 2017. Up to the date of this report, the appeal has yet been concluded.

As at 31 December 2016, the directors of the Company are of the opinion that the provision for the above litigation is sufficient in the consolidated statement of financial position as at 31 December 2016.

Other than the disclosure of above, as at 31 December 2016, the Group was not involved in any other material litigation or arbitration. As far as the Group was aware, the Group had no other material litigation or claim which was pending or threatened against the Group. As at 31 December 2016, the Group was the defendant of certain non-material litigations, and also a party to certain litigations arising from the ordinary course of business. The likely outcome of these contingent liabilities, litigations or other legal proceedings cannot be ascertained at present, but the management of the Group believes that any possible legal liability which may be incurred from the aforesaid cases will not have any material impact on the financial position of the Group.

As at the end of the reporting period, the Group has issued the guarantees to certain banks in respect of borrowings made by Tongmei Qinfra, an associate of the Group. Under the guarantee, the Group that is a party to the guarantee are jointly and severally liable for any of the borrowings of Tongmei Qinfra from those banks.

As at 31 December 2016, the directors of the Company do not consider it probable that a claim will be made against the Group under any of the guarantees. The maximum liability of the Group at 31 December 2016 under the guarantees issued is a portion of the outstanding amount of the borrowings of Tongmei Qinfra amounting to RMB640,600,000 (2015: RMB635,690,000).

42. EVENTS AFTER THE REPORTING PERIOD

On 25 April 2016 and 11 July 2016, the Group entered into a share sale and purchase agreement and a supplemental agreement with Bo Hai Investment, a related company wholly owned by Mr. Xu, a previous director and a close family member of a director of the Company respectively in relation to the disposal of entire equity interest in Hong Kong Qinfra International Trading Limited, a wholly-owned subsidiary of the Company, and its subsidiaries (“**HK Qinfra international group**”) at a consideration of RMB176,740,000. The principal activities of HK Qinfra International Group are coal mining, purchase and sales, filtering, storage, blending of coal and shipping transportation in the PRC. The proposed transaction is yet to complete and is subject to certain conditions precedent as stated in the share sale and purchase agreement. Subsequent to the year, the Group and Bo Hai Investment agreed to further extend the long stop date to 30 April 2017 for satisfying the outstanding conditions precedent. Details of which are set out in the circular dated 26 October 2016 and the announcements of the Company dated 16 December 2016, 30 December 2016 and 28 February 2017.

於二零一六年四月二十五日及二零一六年七月十一日，本集團與渤海投資（本公司前董事及一名董事的直系親屬徐先生全資擁有的關連公司）訂立股份買賣協議及補充協議，內容有關出售本公司之全資附屬公司香港秦發國際貿易有限公司及其附屬公司（「**香港秦發國際集團**」）全部股權，代價為人民幣176,740,000元。香港秦發國際集團的主要業務為於中國從事採煤、煤炭購銷、選煤、存儲、配煤及航運運輸。建議交易尚未完成，須待達成股份買賣協議所載若干先決條件，方告作實。於年結日後，為滿足尚未達成的先決條件，本集團及渤海投資同意將最後截止日期延長至二零一七年四月三十日。有關詳情載於本公司日期為二零一六年十月二十六日的通函以及日期為二零一六年十二月十六日、二零一六年十二月三十日及二零一七年二月二十八日的公佈。

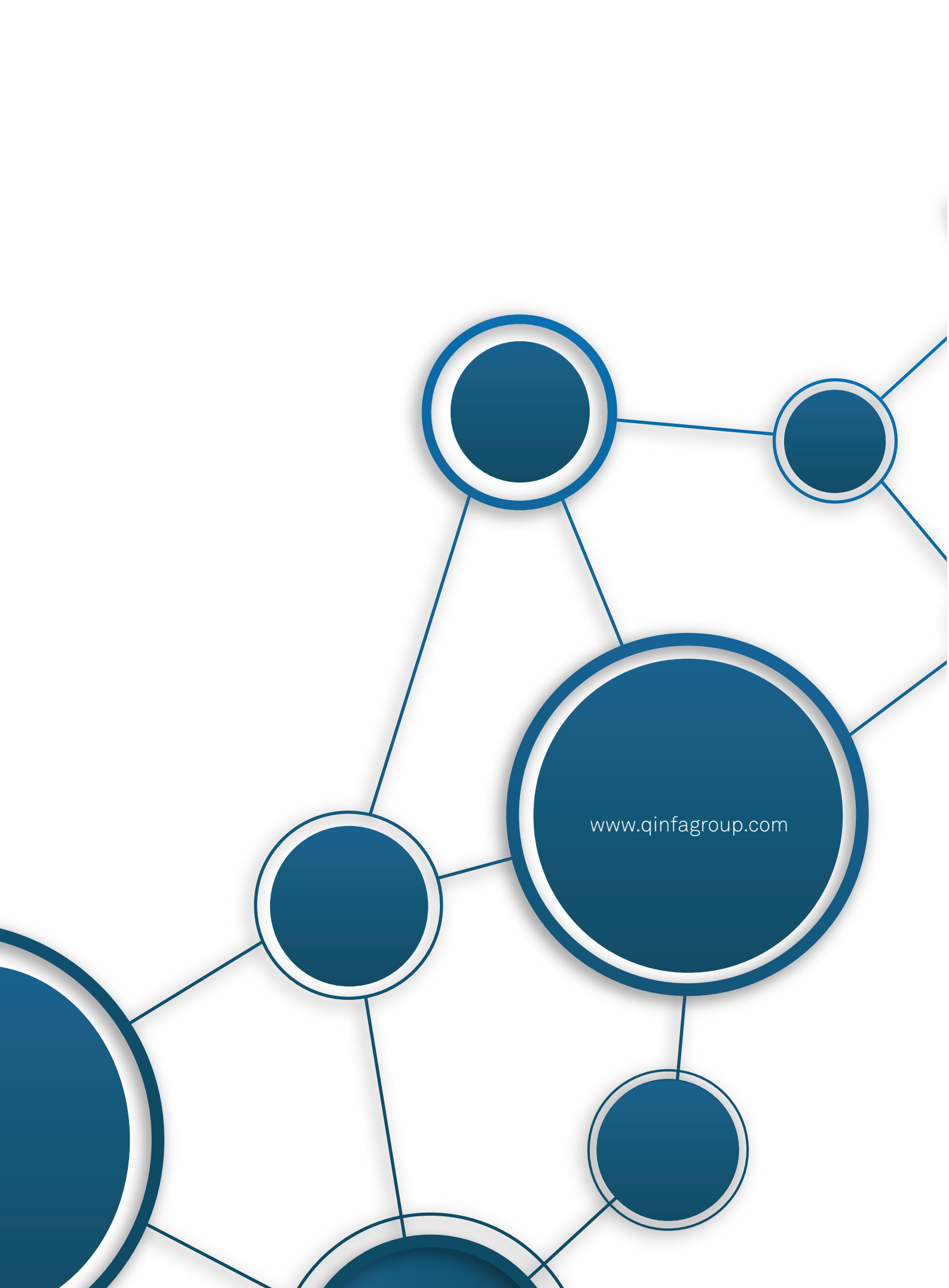
