## Chairman's Statement 主席報告

By abiding the corporate spirit of "seizing early opportunities, pursuing excellence, progressing proactively and forging ahead innovatively", all over the years, we have all along been adhering to the industry intrinsic value as the core of our investment philosophy. We believe all investment values are built on the growth and success of business operation. We applied the perfect investment evaluation and management system to select and invest in those enterprises that have high growth potential and solid business in their own industry sector. Meanwhile, we also worked closely with the management teams of prominent enterprises, seeking mutual development to maximize our own investment value through the joint growth with the investees.

秉承「把握先機、追求卓越、鋭意進取、勇於創新」 的企業精神,多年來,我們一直堅持以產業內在價 值為核心的投資理念,我們相信,一切投資價值都 是建立在產業經營的成長與成功之上。我們運用 完善的投資評價管理體系,選擇那些具有高成長 性,按照產業發展規律扎扎實實經營的企業進行 投資。與此同時,我們還和這些優秀企業的經營管 理團隊緊密合作,共謀發展,真正通過與被投資企 業共同成長來實現自身投資價值的最大化。

Like in the past, we continued to move forward dependably in achieving to "leap into the world with our foothold in China and become a professional investment institute with international competitiveness focusing on scalable industry investment". Apart from our existing securities trading, loan financing, financial leasing business and food and beverages businesses, during the year, the Group also entered into subscription agreements regarding the issuance of convertible bonds in the aggregate principal amount of HK\$850 million and convertible bonds in the amount of HK\$59.5 million respectively. The net proceeds of the issuance of convertible bonds were intended to be used to fund the Group's business development, in particular, the setting up of the Group's medical management company, utilising advanced medical technologies and equipment to focus on the field of oncology treatment and operation management, short-term loan financing business and to replenish the working capital of the Group. During the year, the Company issued convertible bonds in the aggregate principal amount of HK\$279.5 million in total, and all of the remaining aggregate principal amount were also issued before the date of this annual report.

在實現「立足中國、面向世界,成為一家專注於規模化產業投資、擁有國際競爭力的專業投資機構」的征途上,我們一如既往的踏實前進著。除現有證券買賣、貸款融資、融資租賃業務及餐飲業務之外,亦於本年度就發行本金總額為港幣8.5億元之可換股債券及金額為港幣5,950萬元之可換股債券 訂立認購協議。發行可換股債券所得款項淨額擬用作為本集團業務發展提供資金,特別是組建本集團之醫療管理公司,利用先進醫療技術及設備,專業济上於腫瘤治療領域和運營管理,短期貸款融資業務,以及補充本集團之營運資金。於年內,共有為本金總額港幣2億7,950萬元之可換股債券發行,而其餘的本金總額亦於本年報日期前全部發行。

During the past year, the Company devote much time to continued to explore different investment opportunities proactively. In addition, the management team visited different regions in China, North America and Southeast Asia to explore and study other investment opportunities in resources, especially new energy, other mining industry, medical new technology and financial projects, as well as investments in loan and financial leasing business, etc. The Company is confident about the prospect of such investment projects. We will notify our shareholders important information whenever is available.

過去一年,本公司除了投入不少時間積極探討不同的投資機會,管理團隊更多次前往國內、北美及東南亞等地,考察和研究資源特別是新能源、其他礦業、醫療新科技及金融項目之投資機遇,以及貸款、融資租賃業務等投資。本公司對這方面的投資項目的前景有信心,若有重要消息,當儘快通知股東。

#### Chairman's Statement 主席報告

The loss of the Company during the year was mainly attributable to the convertible bonds in amount of HK\$850 million that entered into, the fair value loss of derivative financial liabilities on the partial issued convertible bonds and share-based payment expenses of over 500 million share options granted during the year calculated according to the accounting standard, as well as the loss arising from the changes in fair value of securities investment calculated according to the accounting standard. However, these accounting losses did not have any effect on the cash flow of the Group. The Group's annual revenue was mainly contributed by loan financing, securities dividends and disposal, which represented a significant increase as compared to last year.

對於本年度內本公司的虧損,主要是由本年度簽訂的港幣8.5億元可換股債券、已經發行部份的可換股債券及5億多股的購股權,按會計準則計算出來的衍生金融負債之公允值虧損及以股份為基礎之付款開支;及證券投資按會計準則公允值變動產生之虧損;唯此等會計虧損對本集團並無任何現金流出影響。本年度集團主要貢獻來自貸款融資及證券股息及出售的收入,此等收入較去年有明顯增長。

Subsequent to the balance sheet date, the Company entered into the joint venture agreements with China CNNE Investment Limited\* (中核新能投資有限公司) and formed two joint ventures respectively. The first joint venture is for investment advisory services, wholesale and retails of pharmaceutical, the development, transfer, advices and services on the field on pharmaceutical technologies. The second joint venture is for the investment in hospitals and medical projects especially in proton medical center projects; medical technology research and development including proton accelerator and supporting scientific laboratory equipment. During this reporting period, the Company also completed all its contributions for the parts it invested.

本公司於年結日後和中核新能投資有限公司訂立 合營協議,分別成立兩間合營公司。第一間合營公 司進行投資諮詢服務、藥品批發及零售、藥品科技 領域內的技術開發、轉讓、諮詢及服務:第二間合 營公司對醫院及醫療項目的投資,特別在質子醫 療中心項目;醫療技術研發(包括質子加速器及配 套科學實驗設備)等。在本報告期內,本公司也完 成所有出資的部份。

Subsequent to the balance sheet date, the Company also entered into an acquisition agreement with myself, the Company has conditionally agreed to acquire Xintai Investment Company Limited\* (湛江鑫泰投資有限公司) ("Xintai"), a company indirectly held by me. Xintai is principally engaged in the development, operation and investment of property in Chikan District, Zhanjiang, Guangdong Province, the PRC. Xintai also holds One Parkview\* (公園一號), which comprises the unsold residential buildings together with a number of retail shops, car parks and facilities and developable vacant lands. The Company is very optimistic about the revenue and profit to be brought by the property development industry in which it will engage in the PRC in future.

本公司亦於年結日後和本人簽訂收購協議,有條件同意收購本人間接持有的湛江鑫泰投資有限公司(「鑫泰」)。鑫泰在中國廣東省湛江赤坎區主要從事物業開發、營運及投資,鑫泰亦持有公園一號包括未售賣的住宅樓宇連同多個零售舖位、停車位、設施組成及可發展的空地。公司對於未來在國內將會從事的物業開發行業,所帶來的收入及盈利感到非常樂觀。

I am also pleased to learn about that the Company would be included by Morgan Stanley Capital International ("MSCI") as a constituent of the MSCI Hong Kong Small Cap Index with effect from the market closing of 31 May 2017.

#### **BUSINESS REVIEW**

The Group's revenue from its continuing operations during the year under review amounted to approximately HK\$54 million or HK\$13 million more than that during the previous year. There was a loss for the year attributable to the Company's owners of approximately HK\$470 million (2016: HK\$511 million) which included a fair value loss on derivative financial liabilities amounted to approximately HK\$279 million (2016: HK\$213 million), loss arising from changes in fair value of held for trading investments amounted to approximately HK\$40 million (2016: HK\$171 million) and the share-based payment expenses of approximately HK\$163 million (2016: HK\$111 million).

The basic and diluted loss per share was HK9.06 cents, as compared with loss per share of HK11.54 cents last year.

#### SECURITIES TRADING

During the year, the Group has actively involved in the securities and futures contracts trading business. The majority of the Group's held for trading investments are those shares under Hang Seng Index or China Enterprises Index or H shares. Most of these shares are of China large corporations ("Entities") with high trading volumes and large market capitalization. The Group had achieved realised gain on the disposal of these shares held for trading investments amounting to approximately HK\$26 million (2016: HK\$37 million) during the year under review. The loss of approximately HK\$40 million (2016: HK\$171 million) arising from changes in the fair value of the shares still held for trading investments was greatly reduced as compared with that of last year. As a result, the Group reported a segment gain of approximately HK\$6 million (2016: segment loss of approximately HK\$131 million) during the year under review. Given the realised gain and segment gain during the year, the Group had shown a good performance in the trading investments. The Group considers that the prospects in respect of the shares still held for trading investments are healthy. The unrealised loss as recorded at the year end was due to market fluctuation rather than any problem with the Entities' fundamentals. The Board understands that the performance of the investments may be affected by the degree of volatility in the Hong Kong stock market and subject to other external factors that may affect their values. Accordingly, the Group will continue to maintain a diversified portfolio of investment of different seaments of markets to minimize the possible financial risks. Also, the Board will monitor the performance progress of the investment portfolio closely from time to time.

#### 業務回顧

本集團於回顧年度之持續經營業務收入為約港幣 5,400萬元,較去年增加港幣1,300萬元。本公司之擁有人應佔年度虧損為約港幣4.70億元(二零一六年:港幣5.11億元),包括衍生金融負債之公允值虧損約港幣2.79億元(二零一六年:港幣2.13億元)、持作買賣投資之公允值變動產生之虧損約港幣4,000萬元(二零一六年:1.71億元)及以股份為基礎支付開支約港幣1.63億元(二零一六年:港幣1.11億元)。

每股基本及攤薄虧損為港幣9.06仙,而去年每股虧損則為港幣11.54仙。

## 證券買賣

年內,本集團積極開展證券及期貨合約買賣業務。 本集團大部份持作買賣投資為恒生指數或中國企 業指數或H股項下股份。該等股份大多數為具備 較高成交量及較大市值之中國大型企業(「該等實 體」)之股份。於回顧年度,本集團就出售持作買賣 投資之該等股份獲得已變現收益約港幣2,600萬元 (二零一六年:港幣3,700萬元)。自仍持作買賣投 資之股份公允值變動產生之虧損約港幣4,000萬元 (二零一六年:港幣1.71億元)較去年大幅減少。因 此,於回顧年度,本集團呈報分類收益約港幣600 萬元(二零一六年:分類虧損約港幣1.31億元)。 鑑於年內之已變現收益及分類收益,本集團於買 賣投資方面具有良好表現。本集團認為仍持作買 賣投資之股份之前景穩健。於年末錄得未變現虧 損乃由於市場波動而非該等實體之基本因素存在 任何問題所致。董事會知悉,投資之表現可能受香 港股票市場波動之程度影響並受限於可能影響其 價值之其他外部因素。因此,本集團將繼續維持不 同市場分類之多元化投資組合,以盡量降低可能 之財務風險。此外,董事會將不時密切監察投資組 合之表現進展。

Notes:

- (a) The company and its subsidiaries are mainly engaged in property and casualty reinsurance, life and health reinsurance, primary property and casualty insurance, asset management and other businesses. As disclosed in the annual report of the company for the year ended 31 December 2016, it recorded an audited net profit attributable to equity shareholders of the parent of RMB5.2 billion for the year ended 31 December 2016. With regards to the future prospects of the company, the Directors noted that the company and its subsidiaries will speed up its development and expand its scale on the basis of strict risk control and stable business profitability and will adhere to the "One-Three-Five" strategy, accelerate optimization of business layout, actively nurture new growth opportunities, continue to expand the scopes of serving economic and social development and social securities.
- (b) The principal activities of the company and its subsidiaries are investment holding, hog production, livestock slaughtering, poultry husbandry, sales of fresh and frozen meats, manufacture and sales of meat products, and import of meat products. As disclosed in the annual report of the company for the year ended 31 December 2016, it recorded an audited net profit attributable to its owners from continuing and discontinued operations of RMB952 million for the year ended 31 December 2016. With regards to the future prospects of the company, the Directors noted that the board of directors of the company is confident to continue to create impressive performance, establish a national renowned brand and become a role model in China's meat industry.
- (c) The company and its subsidiaries were involved in securities and futures brokerage; securities investment fund distribution and introducing brokerage business for futures companies; agency sale of financial products; securities underwriting and sponsorship; investment advisory and consultancy services; proprietary securities activities; asset management and fund management; margin financing and securities lending; and stock option market-making. As disclosed in the annual report of the company for the year ended 31 December 2016, it recorded an audited net profit attributable to its owners of the parent of RMB10.4 billion for the year ended 31 December 2016. With regards to the future prospects of the company, the Directors noted that the company will strengthen the development of its communist party committee, enlarge its client market, reinforce and enhance its market position, enhance its trading and investment capabilities, raise capabilities in integrated services, further promote domestic and foreign integration and interaction as well as firmly improve management.

- The company and its subsidiaries are principally engaged in the operation of civil aviation, including the provision of passenger, cargo, mail delivery and other extended transportation services. As disclosed in the annual report of the company for the year ended 31 December 2016, it recorded an audited net profit attributable to its equity shareholders of RMB5,044 million for the year ended 31 December 2016. With regards to the business plan of the company, the Directors noted that the company will focus on (i) continuously improve the level of safety management; (ii) continuously optimize the fleet structure based on the market environment; (iii) create a first-class international service brand with sincere service; (iv) accelerate adaptation to new changes and further raise the capability in operation assurance; (v) vigorously strengthen the hub construction and continuously expand the effectiveness of transition; (vi) expedite the construction of the "China Southern e-Travel" and consolidate the competitive advantages; and (vii) fully utilize the important functions of financial management, and focus on cost control.

#### LOAN FINANCING

During the year, the Group recorded a revenue of HK\$28 million (2016: HK\$25 million) and the segment profit was HK\$27 million (2016: HK\$24 million). The Group will further develop in this segment in order to earn a higher interest income.

#### FINANCIAL LEASING

During the year, the Group has recorded HK\$2 million (2016: HK\$4 million) of interest income and HK\$2 million (2016: HK\$4 million) of segment profit from financial leasing business.

#### **FOOD AND BEVERAGES**

The food and beverages segment generated a revenue of HK\$4 million during the year under review (2016: HK\$8 million). The segment reported a loss of HK\$1 million (2016: HK\$1 million) for the current year due to the decrease in turnover and the increase in gross margin. The profit and loss were contributed by the restaurant in Beijing, PRC which was acquired on 1 January 2014.

#### TRADING OF WINE

The Group has kept certain quantities of fine wines. The stocks will be offered to sell when the market prices are favorable such that the Group can obtain a good return on the trading. At present, the stocks are kept in the wine cellar situated in Hong Kong.

#### INVESTMENT IN SHARES IN KORE

Kore Potash Limited ("Kore") (formerly known as "Elemental Minerals Limited") is a mineral exploration and development company listed on the Australian Stock Exchange. It is currently developing the Sintoukola potash project located in the Republic of Congo.

As at the date of this annual report, the Group holds an aggregate of 75,141,924 shares of Kore, representing approximately 9.78% of the entire issued share capital of Kore.

## 貸款融資

本集團已保存一定數量之優質酒。該等存貨將於 市價高時賣出,以令本集團可獲得理想之貿易回 報。現時,該等存貨存置於香港之酒窖。

#### 投資KORE之股份

Kore Potash Limited (「**Kore**」) (前稱「Elemental Minerals Limited」)是一間於澳大利亞證券交易所上市之礦物勘探及發展公司。其現正於剛果共和國發展Sintoukola鉀鹽項目。

於本年報日期,本集團持有合共75,141,924股Kore 股份,相當於Kore全部已發行股本之約9.78%。

## MAJOR TRANSACTION – PARTICIPATION IN COOPERATION AGREEMENT

On 25 September 2015, 鼎億金匯 (深圳)投資諮詢有限公司 ("Dingyi Jinhui"), an indirect wholly-owned subsidiary of the Company, entered into a cooperation agreement (the "Cooperation Agreement") committing to provide 38% funding for the acquisition (the "Xibu Yungu's Acquisition") by a joint venture company, 深圳市西部 雲谷投資有限責任公司 ("Xibu Yungu"), and the acquisition (the "Xumao Ventures' Further Acquisition") by Xumao Ventures Limited ("Xumao Ventures"), as a nominee of Xibu Yungu. Xibu Yungu then entered into an acquisition agreement (the "Acquisition Agreement") to acquire 80% equity interest in 金時代投資顧問(深圳)有限公 司 ("Jinshidai") and related shareholders' loans (the "Acquisition") from the vendors of Jinshidai (the "Jinshidai Vendors"), whereas Xumao Ventures entered into a sale and purchase agreement (the "Sales and Purchase Agreement") to acquire 100% equity interest in Think Right Developments Limited. The Cooperation Agreement was entered into to provide cash funding for the total acquisition consideration of RMB1,060,800,000 for Xibu Yungu's Acquisition and Xumao Ventures' Further Acquisition. The Group will provide its portion (i.e. Dingyi Jinhui's 38%) of the funding by its internal resources and/ or through other financing methods. The Cooperation Agreement has provided that the maximum commitment by Dingyi Jinhui towards the acquisitions is capped at RMB403,104,000.

The Company has been informed by Xibu Yungu that, despite of repeated reminders by Xibu Yungu to the Jinshidai Vendors, the Jinshidai Vendors have not performed in accordance with the terms of the Acquisition Agreement. On 29 January 2016, Xibu Yungu submitted an application for arbitration to the Shenzhen Arbitration Commission (深圳仲裁委員會) (the "Commission") seeking specific performance of the Acquisition Agreement and damages against the Jinshidai Vendors. The application has been accepted by the Commission on the same date.

The Company had been informed by Xibu Yungu that on 11 April 2016, Jinshidai Vendors, Parkwill Group Limited, Xibu Yungu and Xumao Ventures entered into a settlement agreement (the "Settlement Agreement") to settle the arbitration claim by Xibu Yungu to the commission seeking specific performance of the Acquisition Agreement and damages against the Jinshidai Vendors (the "Arbitration").

## 主要交易一參與合作協議

於二零一五年九月二十五日,鼎億金匯(深圳)投 資諮詢有限公司(「鼎億金匯」,本公司之間接全資 附屬公司)訂立合作協議(「合作協議」),承諾為 一間合營公司深圳市西部雲谷投資有限責任公司 (「西部雲谷」) 進行之收購事項(「西部雲谷之收購 事項」)及旭貿創投有限公司(「旭貿」)(作為西部 雲谷之代名人) 進行之收購事項(「旭貿之進一步收 購事項」)提供38%資金。西部雲谷則訂立收購協議 (「收購協議」)以自金時代投資顧問(深圳)有限 公司(「金時代」)之賣方(「金時代賣方」)收購金 時代之80%股權及相關股東貸款(「收購事項」), 而旭貿訂立買賣協議(「買賣協議」)以收購Think Right Developments Limited之100%股權。訂立合 作協議乃旨在為西部雲谷之收購事項及旭貿之進 一步收購事項之總收購代價人民幣1,060,800,000 元提供現金資金。本集團將以其內部資源及/或 透過其他融資方法提供其部份資金(即鼎億金匯 之38%)。合作協議已規定,鼎億金匯就收購事項 作出之最高承擔為人民幣403,104,000元。

本公司已獲西部雲谷通知,儘管西部雲谷多次提醒金時代賣方,惟金時代賣方並無根據收購協議之條款行事。於二零一六年一月二十九日,西部雲谷向深圳仲裁委員會(「委員會」)提交仲裁申請,以尋求強制金時代賣方履行收購協議及作出賠償。委員會已於同日受理申請。

本公司已獲西部雲谷通知,於二零一六年四月十一日,金時代賣方、Parkwill Group Limited、西部雲谷及旭貿訂立和解協議(「和解協議」),以和解西部雲谷向委員會尋求強制金時代賣方履行收購協議及作出賠償之仲裁索償(「仲裁」)。

Under the Settlement Agreement, the Jinshidai Vendors agreed to make a payment of RMB38,000,000 to settle the Arbitration and related proceedings. Xibu Yungu had received the payment during the year.

The Group had only provided the funding of RMB38,000,000 to Xibu Yungu as capital injection and such funding has been refunded to the Group in view of the cessation of the Acquisition.

After deducting the costs and expenses in relation to the Acquisition Agreement, the Sale and Purchase Agreement and the Settlement Agreement from the settlement of RMB38,000,000 by the Jinshidai Vendors, the Group received a share of 38% of the remaining balance, approximately HK\$9 million, as other income.

Details of the transaction were disclosed in the announcements of the Company dated 25 September 2015, 29 September 2015, 2 October 2015, 9 October 2015, 30 November 2015, 9 December 2015, 29 January 2016, 12 April 2016 and 27 April 2016.

## LETTER OF INTENT FOR ESTABLISHMENT OF JOINT VENTURE COMPANY

On 17 June 2016, the Company entered into a non-legally binding letter of intent with D&R Asset Management Group Co., Ltd. ("D&R") to establish a joint venture company. The total commitment of capital contribution to be made to the joint venture company is estimated to be RMB200 million, of which RMB98 million is proposed to be contributed by the Company and RMB102 million is proposed to be contributed by D&R. As at the date of this annual report, the parties to the letter of intent are still negotiating for the possible cooperation. Further announcement in relation to the letter of intent will be made by the Company as and when appropriate. Details of the transaction were disclosed in the announcement of the Company dated 17 June 2016.

#### **GRANT OF SHARE OPTIONS**

The share option scheme was adopted by the Company on 21 September 2012 (the "Share Option Scheme").

On 21 June 2017 (after trading hours), the Company as the purchaser and Mr. Li Kwong Yuk, being a controlling shareholder, an Executive Director and the Chairman of the Company, as the vendor ("Mr. Li" or the "Vendor") entered into the acquisition agreement (the "Acquisition Agreement") pursuant to which the Company has conditionally agreed to acquire for and the Vendor has conditionally agreed to dispose of the entire equity interest in United Faith Investments Limited (the "Target Company"), which is wholly-owned by the Vendor, for the consideration of HK\$1,000 million. Pursuant to the Acquisition Agreement, the consideration of HK\$1,000 million shall be satisfied by the issuance of the convertible bonds ("Mr. Li Convertible Bonds") in the aggregate principal amount of HK\$1,000 million to be issued by the Company to the Vendor under the specific mandate to be sought from the independent shareholders (the "Independent Shareholders") (other than Mr. Li, Mr. Su Xiaonong, an Executive Director and the Chief Executive Officer of the Company, and their respective associates who are required to abstain from voting at the special general meeting) at the special general meeting of the Company to be convened to allot and issue the new Shares which may fall to be allotted and issued upon exercise of the conversion rights attaching to Mr. Li Convertible Bonds. Apart from the existing businesses of securities trading, food and beverages, wine trading, loan financing, metal trading and finance leasing, the Group will continue to explore other potential investment opportunities with reasonable returns that meet the Company's criteria. This will not only strengthen our core business but also increase the shareholders' values. The Group has been exploring some investment opportunities in mining projects, resources projects, properties development projects, infrastructure development projects, investment and asset management. In particular, the Group will setup medical management company utilising advanced medical technologies and equipment to focus on the field of proton medical treatment in the PRC.

#### **REVENUE**

The Group's revenue increased from HK\$41 million in 2016 to HK\$54 million in 2017, mainly due to the increase in the interest income from provision of loan financing and dividend income.

#### **GROSS PROFIT**

Gross profit margin of the Group maintained at 98% (2016: 90%) this vear.

#### OTHER INCOME

Other income increased to HK\$14 million (2016: HK\$1 million) this year.

# SELLING AND DISTRIBUTION COSTS AND ADMINISTRATIVE EXPENSES

Selling and distribution costs was decreased to HK\$3 million this year as compared to HK\$4 million in last year due to the decrease in turnover of the Beijing Restaurant. The administrative expenses increased to HK\$209 million (2016: HK\$169 million) which was mainly due to the share-based payment expenses of HK\$163 million (2016: HK\$111 million).

#### PLANT AND EQUIPMENT

Plant and equipment maintained at HK\$6 million in this year (2016: HK\$6 million). The slightly decrease was mainly due to the depreciation charge for the year.

#### HELD FOR TRADING INVESTMENTS

Held for trading investments was significantly decreased from HK\$630 million to HK\$353 million this year because of the decrease in the portfolio of the listed investments in the securities trading business.

#### CASH AND BANK BALANCES

Cash and bank balances increased from HK\$18 million in last year to HK\$77 million this year mainly due to the proceeds received from issuance of convertible bonds during the year.

#### 收入

## 毛利

本集團之毛利率於本年度維持於98%(二零一六年:90%)。

## 其他收入

本年度之其他收入增加至港幣1,400萬元(二零 一六年:港幣100萬元)。

## 銷售及分銷成本及行政費用

由於北京餐廳之營業額減少,本年度之銷售及分銷成本由去年之港幣400萬元減少至港幣300萬元。 行政費用增加至港幣2.09億元(二零一六年:港幣1.69億元),乃主要由於以股份為基礎付款開支港幣1.63億元(二零一六年:港幣1.11億元)所致。

#### 廠房及設備

廠房及設備於本年度維持於港幣600萬元(二零一六年:港幣600萬元)。略微下降主要是由於年內 折舊開支所致。

### 持作買賣投資

持作買賣投資自港幣6.30億元大幅減少至本年度 之港幣3.53億元,乃由於證券買賣業務之上市投資 組合減少所致。

## 現金及銀行結餘

現金及銀行結餘由去年之港幣1,800萬元增加至本年度港幣7,700萬元,主要由於本年度內發行可換股債券收取之所得款項所致。

#### Financial Review 財務回顧

#### SHAREHOLDERS' FUNDS AND FINANCIAL RATIOS

As at 31 March 2017, the Group's net assets attributable to the owners of the Company amounted to HK\$389 million (2016: HK\$517 million), a decrease of HK\$128 million when compared with that of 2016. Such net decrease was mainly due to the loss for the year set off with the issue of convertible bonds during the year.

As at 31 March 2017, total debt to equity ratio was 0.58 (2016: 0.23) and net debt to equity ratio was 0.38 (2016: 0.19), which were expressed as a ratio of total convertible bonds and finance lease obligations and net convertible bonds and finance lease obligations respectively, over the total equity of HK\$389 million (2016: HK\$517 million).

#### **BORROWINGS**

As at 31 March 2017, the Group's finance lease obligations amounted to nil (2016: HK\$1 million). The finance lease obligations in previous year were denominated in Hong Kong dollars and subject to fixed interest rate.

#### **CHARGE ON ASSETS**

As at 31 March 2017, the Group had pledged its assets with net book value of nil (2016: HK\$3 million) to secure finance lease obligations.

#### FOREIGN EXCHANGE EXPOSURE

Most of the Group's assets are denominated in Hong Kong dollars ("HKD"), Renminbi ("RMB"), United States dollars ("USD") and Australian dollars ("AUD"). Considering the exchange rates between these currencies are relatively stable, the Group believed that the corresponding exposure to RMB, USD and AUD exchange rates fluctuation were relatively limited. The Group does not undertake any derivative financial instruments or hedging instruments. The Group will constantly review the economic situation and its foreign currency risk profile, and continues to actively monitor foreign exchange exposure to minimize the impact of any adverse currency movement.

#### 股東資金及財務比率

於二零一七年三月三十一日,本公司擁有人應佔之本集團資產淨值為港幣3.89億元(二零一六年:港幣5.17億元),較二零一六年減少港幣1.28億元。有關減少淨額主要由於年度虧損與年內發行可換股債券抵銷所致。

於二零一七年三月三十一日,總債務與權益比率 為0.58(二零一六年:0.23),而淨債務與權益比率 為0.38(二零一六年:0.19),此乃分別將可換股債 券及融資租賃承擔之總額及可換股債券及融資租 賃承擔之淨額除以總權益港幣3.89億元(二零一六年:港幣5.17億元)而得出之比率。

#### 借款

於二零一七年三月三十一日,本集團之融資租賃 承擔為零(二零一六年:港幣100萬元)。去年融資 租賃承擔乃以港幣計值並須按固定息率計息。

#### 資產抵押

於二零一七年三月三十一日,本集團已抵押其賬面淨值為零(二零一六年:港幣300萬元)之資產以擔保融資租賃承擔。

#### 外匯風險

本集團的大部份資產以港幣(「港幣」)、人民幣(「人民幣」)、美元(「美元」)及澳元(「澳元」)計值。考慮到該等貨幣之間的匯率相對穩定,本集團認為人民幣、美元及澳元匯率波動的相應風險相對有限。本集團並無涉及任何衍生金融工具或對沖工具。本集團將持續檢討經濟狀況及其外幣風險情況,並繼續積極監察外匯風險以盡量減少任何不利貨幣變動的影響。

#### TREASURY POLICIES

The Group adopts conservative treasury policies in cash and financial management. To achieve better risk control and minimize the cost of funds, the Group's treasury activities are centralized. Cash is generally placed in short-term deposits mostly denominated in HKD, USD, RMB or AUD. The Group's liquidity and financing requirements are frequently reviewed. In anticipating new investments, the Group will consider new financing channels while maintaining an appropriate level of gearing.

#### CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining a high standard of corporate governance and has introduced corporate governance practices appropriate to the conduct and growth of its business.

The Company's corporate governance practices are based on the principles and the code provisions as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules").

In the opinion of the Directors, the Company has complied with all code provisions of the CG Code during the year ended 31 March 2017 except for the deviation disclosed below:

Under code provision A.1.3 of the CG Code, notice of at least 14 days should be given of a regular board meeting to all Directors to give all Directors an opportunity to attend. During the year ended 31 March 2017, certain regular Board meetings were convened with less than 14 days' notice to facilitate the Directors' timely reaction and expeditious decision making process in respect of internal affairs of the Group. All Board meetings, nevertheless, were duly convened and held in the way prescribed by the Bye-laws of the Company. The Board will use reasonable endeavour to meet the requirement of code provision A.1.3 of the CG Code in future. Adequate and appropriate information are circulated normally three days in advance of Board meetings to the Directors.

#### 企業管治常規

The Company has made specific enquiries to all the Directors and they have confirmed that they have complied with the required standard set out in the Model Code throughout the year ended 31 March 2017.

#### THE BOARD OF DIRECTORS

The overall management of the business of the Company is vested in the Board, which assumes the responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. All Directors should make decisions objectively in the interests of the Company and the Shareholders as a whole. The Board has delegated the power to oversee the daily operational matters of the Group to the management of the Company under the supervision of the Board.

The functions of the Board are carried out either directly or through the Board committees. To ensure the Board is in a position to exercise its power in an informed manner, all members of the Board have full and timely access to all relevant information and may take independent professional advice if necessary.

The Board has full support from the Chief Executive Officer and the management of the Company to discharge its responsibilities.

Appropriate insurance cover for the Directors' liabilities in respect of legal actions against the Directors and senior management of the Group arising out of corporate activities of the Group has been arranged.

The Board is responsible for performing the corporate governance duties set out in the code provision D.3.1 of the CG Code.

The signed minutes of the said meetings are kept by the Company Secretary and are open for inspection by any Directors. If a substantial Shareholder or a Director has a conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matters will be dealt with by a Board meeting rather than written resolutions and the Board will ensure that an adequate number of Independent Nonexecutive Directors are involved in the consideration of the relevant matters. Independent Non-executive Directors are encouraged to take an active role in the Board meetings.

#### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Every Director shall retire from office no later than the third AGM since the last re-election or appointment of such Director.

During the year ended 31 March 2017, the Audit Committee comprises three Independent Non-executive Directors, namely Mr. Chow Shiu Ki (chairman of the Audit Committee), Mr. Cao Kuangyu and Mr. Ip Chi Wai. The chairman of the Audit Committee, Mr. Chow Shiu Ki, possesses appropriate professional qualifications in finance and accounting and meets the requirements of Rule 3.21 of the Listing Rules. The Directors acknowledged their responsibility for the preparation of the financial statements in accordance with the statutory requirements and applicable accounting standards. The Directors are not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Company's ability to continue as a going concern.

#### **AUDITOR'S STATEMENT**

The statement by the Auditor about their reporting responsibilities on the financial statements for the year ended 31 March 2017 is set out in the "Independent Auditor's Report" of this annual report.

#### **RISK MANAGEMENT AND INTERNAL CONTROL**

During the year, the Group has complied with Principle C.2 of the CG Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis. Main features of the risk management and internal control systems are described in the sections below:

#### **Risk Management System**

The Group adopts a risk management system which manages the risk associated with its business and operations. The system comprises the following phases:

- *Identification:* Identify ownership of risks, business objectives and risks that could affect the achievement of objectives.
- Evaluation: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly.
- Management: Consider the risk responses, ensure effective communication to the Board and on-going monitor the residual risks.

Based on the risk assessments conducted in 2017, no significant risk was identified.

#### 風險管理系統

#### **Internal Control System**

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission ("COSO") 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components of the framework are shown as follow:

- Control Environment: A set of standards, processes and structures that provide the basis for carrying out internal control across the Group.
- Risk Assessment: A dynamic and iterative process for identifying and analyzing risks to achieve the Group's objectives, forming a basis for determining how risks should be managed.
- Control Activities: Action established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.
- Information and Communication: Internal and external communication to provide the Group with the information needed to carry out day-to-day controls.
- Monitoring: Ongoing and separate evaluations to ascertain whether each components of internal control is present and functioning.

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

 The access of information is restricted to a limited number of employees on a need-to-know basis. Employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality.

#### 內部監控系統

- 風險評估:一個不斷轉變而反覆的過程,以 識別及分析達成本集團目標的風險,形成釐 定如何管理風險的依據。
- 監控活動:根據政策及程序確立的行動,以確保執行管理層為減低風險以達成目標所作出的指示。
- *資訊及溝通*:內部及外部溝通以向本集團提供進行日常監控所需的資料。
- *監察*:持續及個別評估以查明內部監控的各元素是否存在並運作正常。

- Confidentiality agreements are in place when the Group enters into significant negotiations.
- The Executive Directors are designated persons who speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.
- Refer to inside information policy and procedures for more procedures.

Based on the internal control reviews conducted in 2017, no significant control deficiency was identified.

#### **Internal Auditors**

The Group has an Internal Audit ("IA") function, which is consisted of professional staff with relevant expertise (such as Certified Public Accountant). The IA function is independent of the Group's daily operation and carries out appraisal of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness.

An IA plan has been approved by the Board. According to the established plan, review of the risk management and internal control systems is conducted annually and the results are reported to the Board via Audit Committee afterwards.

# **Effectiveness of the Risk Management and Internal Control Systems**

The Board is responsible for the risk management and internal control systems of the Group and ensuring review of the effectiveness of these systems has been conducted annually. Several areas have been considered during the Board's reviews, which include but not limited to (i) the changes in the nature and extent of significant risks since the last annual review, and the Group's ability to respond to changes in its business and the external environment; and (ii) the scope and quality of management's ongoing monitoring of risks and of the internal control systems.

The Board, through its reviews and the reviews made by IA function and Audit Committee, concluded that the risk management and internal control systems were effective and adequate. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. It is also considered that the resources, staff qualifications and experience of relevant staff were adequate and the training programs and budget provided were sufficient.

# RIGHTS TO CONVENE A SPECIAL GENERAL MEETING

Shareholders may convene special general meeting of the Company (the "SGM") according to the Bye-Laws and the provisions as set out in Section 74 of the Companies Act 1981 of Bermuda (the "Bermuda Act"). The Board shall, on the requisition of Shareholders holding at the date of the deposit of the requisition not less than one-tenth of the paid-up capital of the Company as at the date of the deposit carries the right of voting at general meetings of the Company, forthwith proceed duly, to convene the SGM. The requisition must state the purposes of the SGM, and must be signed by the requisitionists and deposited at the principal place of business in Hong Kong of the Company at Unit 2708, 27/F., Convention Plaza-Office Tower, 1 Harbour Road, Wanchai, Hong Kong, and may consist of several documents in like form each signed by one or more requisitionists.

(i) Pursuant to Sections 79 and 80 of the Bermuda Act, either any number of the Shareholders representing not less than one-twentieth of the total voting rights of all the Shareholders having at the date of the requisition a right to vote at the meeting to which the requisition relates or not less than 100 Shareholders, can request the Company in writing to (a) give to the Shareholders entitled to receive notice of the next AGM of any resolution which may properly be moved and is intended to be moved at that meeting; and (b) circulate to the Shareholders entitled to have notice of any general meeting sent to them any statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at that meeting.

Notice of any such intended resolution shall be deposited to the above-stated principle place of business of the Company in Hong Kong not less than six weeks before the meeting (in the case of a requisition requiring notice of a resolution); and not less than one week before the meeting (in the case of any other requisition) together with a sum reasonably sufficient to meet the relevant expenses of the Company.

Upon receiving the requisition, the Company would take appropriate actions and make necessary arrangements in accordance with the requirements under the provisions as stated in Sections 79 and 80 of the Bermuda Act.

本公司及其附屬公司(統稱「本集團」或「我們」) 發表的環境、社會及管治報告(「**ESG報告**」)闡述 本集團所秉持的可持續發展理念,及履行的企業 公民責任。ESG報告詳述本集團在二零一六年四 月一日至二零一七年三月三十一日(「本年度」)內 支持可持續發展原則的各項工作。

#### 報告範圍

ESG報告的內容闡述本集團的香港核心業務於本年度在環境及社會層面的表現。有關企業管治的內容,請參閱於本年報第38至54頁的《企業管治報告》。

#### 報告準則

ESG報告依照香港聯合交易所有限公司證券上市規則附錄二十七《環境、社會及管治報告指引》所編寫。

#### 利益相關者參與

撰寫ESG報告的過程有賴各部門同事的參與,使 我們更清晰地了解目前在環境和社會層面的發展 水平。我們收集的資料,既總結了本集團於本年度 內開展的環境和社會相關工作,也為我們制訂可 持續發展策略奠下基礎。

#### **ENVIRONMENTAL PROTECTION**

#### **ENERGY MANAGEMENT**

As an environmentally-friendly corporation, we bear the responsibility of protecting the nature. In order to reduce the power consumption of the lighting system, apart from using reflector in focusing the light on those areas where lighting is needed, we also adopt a highly energy-efficient lighting system, clean lighting facility constantly, and employ sectional lighting system. We clean air conditioners filters regularly and check the air conditioning facility to minimize the possibility of refrigerant leakage, and thereby improve the resources efficiency of the air conditioning systems. We set the temperature of air conditioning system at 25.5 degrees Celsius or above, and adopt low-emissivity glass to block ultraviolet, which in turn reduces the power consumption of air conditioning system. We encourage employees to switch off unnecessary lights and other electronic equipment, and conduct monthly electricity statistics to monitor power consumption.

#### **GREEN OPERATION**

The Group strictly complies with the laws and regulations related to emission. As a service-based company, our business operation mainly takes place in offices. The main wastewater generated from the Group is domestic sewage. The domestic sewage will be discharged into the municipal drainage system. The Group adopts a range of measures to conserve water and reduce wastage, including reducing water pressure to a feasible minimum level, installing water-saving faucets and urinals, displaying water-conservation slogans in toilets, and inspecting water pipes regularly to prevent water leakage. Since the Group's business does not involve any industrial production activity, vehicle exhaust is the main source of our gas emission. We constantly check and maintain the vehicles of the Group, and require the drivers of the Group to switch off idling engine, so as to reduce air pollution from vehicles.

In view of the potential threats of climate change on community, the Group has reduced carbon emission in our operations gradually. With regard to transportation, apart from encouraging employees to take public transport, we also hold video conferences to avoid unnecessary overseas business travel. We use packaging materials to the minimum extent possible and proactively reduce carbon emission generated in the course of organizing the activities. Furthermore, we promote and introduce measures on lowering carbon emission to our employees through different channels, including emails or posters, so as to strengthen their environmental protection awareness.

#### 保護環境

#### 能源管理

作為環境友好型企業,我們肩負保護自然的責任。 為減少照明系統的電力消耗,除了使用反射鏡讓 光線集中到需要照明的區域之外,我們亦採用高 能源效益的照明系統,定期清潔照明設施,並使用 分區獨立照明系統。為提高空調系統的能源效率, 我們定期清洗過濾網,並檢查空調設備以降低製 冷劑洩漏的可能性。我們將空調溫度設定在攝氏 25.5度或以上,以及採用低放射性玻璃以阻隔紫外 線及空調產生的熱能,從而減少空調系統的電力 消耗。我們鼓勵員工關閉不必要的照明及其他電 子設備,並每月進行電量統計以掌握用電情況。

#### 綠色營運

本集團嚴格遵守與排放物相關的法例法規。我們是以服務為主的企業,因此主要營運都於辦公室內進行。我們的主要廢水為生活污水。生活污水會排放至市政排水系統。本集團通過採取一系列的措施,例如:降低水壓至可行的最低程度、安裝具有節水效益的水龍頭和小便器、於洗手間內張貼節水標語和定期檢查水管有否漏水,以節約用水、減少浪費。由於本集團業務不涉及工業生產活動,車輛廢氣為我們主要氣體排放來源。我們定期檢查及保養本集團的車輛,並要求本集團的司機停車熄匙,以減低車輛造成的空氣污染。

考慮到氣候變化對社區的潛在威脅,本集團已逐步減少業務中的碳排放。就運輸而言,除鼓勵員工乘搭公共交通工具外,我們亦採用視頻會議,以取代非必要的海外公幹。籌辦活動時,儘量少用包裝,積極減低由舉辦活動間接產生的碳排放。除此之外,我們透過不同渠道,如電郵、海報等,向員工宣傳及介紹減少碳排放的措施,加強員工的環保意識。

#### **WASTE MANAGEMENT**

The solid waste is mainly generated from daily office operation. Our waste management strategy underpinned by the "3Rs" principle. For consumption and waste reduction, we encourage employees to double-sided printing and the use of electronic means for information dissemination whenever possible. Apart from using e-cards, we also send facsimile via internet to reduce paper consumption. Paper consumption is closely monitored and appropriate improvement measures are carried out. For waste recycling, the Group not only encourages employees to reduce the use of one-off office supplies and use environmental friendly stationeries instead, but also makes the best use of paper products, and utilises recycled papers. For recycling, we set up paper recycling bins, and arrange recycling company to handle non-classified office waste papers. For hazardous waste, all used cartridges are collected and returned to suppliers for recycling.

#### CARE FOR EMPLOYEES

#### **EMPLOYEE RIGHTS AND INTERESTS**

Employees are the cornerstone and core competitiveness of the Group's success. We emphasize talent operation, and care for our employees. The Group strictly complies with the laws and regulations related to the rights and interests of employees, such as the Employment Ordinance. During the recruitment process, the Group offers all applicants with equal employment opportunities, and will not tolerate any form of discrimination on grounds of gender, race, family status, etc. The Group verifies the age of applicants by checking their identification documents to avoid employment of child labour. Before commencement of employment, employees are provided with detailed job descriptions of the duties and responsibilities of the position concerned, and the employment is in accordance with labour contract to prevent any forced labour. When working overtime is needed, it must be on a voluntary basis to prevent forced overtime. We also arrange overtime payment in accordance with the relevant laws and regulations.

#### 廢物管理

固體廢物主要產生於日常辦公營運。本集團的廢物管理策略基於「3Rs」原則。在減耗減廢方面,我們鼓勵員工儘可能雙面使用紙張及善用電子途徑傳播信息。除使用電子賀卡外,我們亦使用網絡張入縣消耗。我們亦定期監察紙張用量,並作出適當改善措施。於廢物再用方面,本集團除鼓勵員工使用環保文具及可重複使用的物資,並對一次性辦公室物資,亦把紙製品物盡其用,並使用再造紙。循環再用方面,我們設置廢紙回收箱,並安排回收公司處理非機密辦公室廢紙。就有害廢物而言,我們收集使用過的墨盒,並交由供應商回收再用。

#### 關愛員工

#### 員工權益

員工是本集團賴以成功的基石和核心競爭力。我們著重人才經營,關愛員工。本集團嚴格遵守與員工權益相關的法律法規,如《僱傭條例》。在招聘員工時,本集團給予所有應徵者同等受聘機會,不會因性別、種族、家庭崗位等而區別對待。通過检查身份證明文件,我們核實申請者的年齡以避免僱用童工。在員工正式加入本集團之前,我們會向其提供詳細的工作說明,闡述該職位的義務及有任,並按勞動合約委聘員工,以避免強制勞工。倘員工需要逾時工作,員工的加班屬自願性質,以防止強制加班。我們亦按相關法例法規支付加班費用。

#### **EMPLOYEE BENEFITS AND DEVELOPMENT**

The Group adjusts employees' remuneration annually based on factors such as market conditions, employees work performance and index of living, striving to offer employees with competitive remuneration. Apart from basic salary, we also provide discretionary bonus according to employees' individual performance and the results of the Group. We strictly comply with the laws and regulations relating to working hours and holidays, and offer employees with different types of holidays, including annual leave, marriage leave, maternity leave, compassionate leave etc. In order to improve the operation of the Group, we arrange exit interview upon receipt of resignation notice to understand his/her reason of leaving and the balance of salary will be paid on time.

We continuously monitor employees' performance with a vision towards establishing a premier team for the rapid development and efficient operation of the Group. The promotion mechanism operates on a fair and open basis and will not tolerate with any form of discrimination. The employees are encouraged to participate in external lectures and seminars to enrich their professional knowledge.

#### **EMPLOYEE HEALTH AND SAFETY**

Work safety is the key to the sustainable development of the Group. We strictly comply with the laws and regulations related to occupational health and safety, such as the Occupational Safety and Health Ordinance, in our endeavour to create a safe and healthy environment for employees. Rescue, fire and evacuation drills are conducted regularly to increase employees' awareness and involvement in accident prevention. The Group also creates a pleasant and comfortable workplace by carrying out various measures including provision of adjustable seats and regular repair and maintenance of office equipment.

#### 員工福利及發展

本集團每年根據市況、員工工作表現及生活指數 等因素調整員工薪酬,務求為員工提供具市場競爭力的薪酬。除基本薪金外,我們亦視乎員工的個人表現以及本集團業績提供酌情花紅。我們嚴格遵守與工作時數及假期相關的法例法規,給予員工不同類型假期,如年假、婚假、產假、恩恤假等。為改善本集團的運作,我們為離職員工安排面談以瞭解其離開的原因,亦會依時發放餘下的工資。

為建立優秀團隊應對本集團的快速發展及高效營運,我們持續監察員工表現。我們秉持公平公開原則訂立晉升機制,絕不容忍任何形式的歧視。我們鼓勵員工參與外部講座及研討會,從而豐富有關專業知識。

#### 員工健康及安全

工作安全是本集團可持續發展的關鍵。我們嚴格遵守有關職業健康及安全的法例法規,如《職業安全及健康條例》,致力為員工創造安全健康的環境。我們定期進行救援、消防及疏散演習,提升員工的事故防範意識及參與程度。本集團亦實施多項措施,締造舒適的工作環境,如提供可調校高度的座椅以及定期維修保養辦公室設備等。

#### RESPECT CUSTOMERS AND SUPPLIERS

#### **SUPPLY CHAIN MANAGEMENT**

Notwithstanding the absence of bulk procurement due to our business nature, much attention is accorded to the purchase of office supplies for daily operation. Procurement policy is formulated to select reliable suppliers and service providers to support our business operation. Apart from taking into account the factors such as reputation, quality and price-performance ratio of suppliers, we give priority to suppliers who perform well in social responsibility or satisfy the requirement set out in our environmental protection policy, to encourage suppliers to forge sustainable development society together with the Group. For example, we give priority to purchase products with higher recycling value, less packing materials and better energy efficiency. Under our consistent principles of green procurement, we also assess the use of materials constantly to avoid overstocking and waste of resources. If a breach of the Group policy occurs, we will terminate the cooperation relationships with the suppliers concerned immediately.

#### **EMPHASIS ON CUSTOMERS**

As a financial service provider, protecting customers' privacy and safeguarding market fairness have core roles to play in the establishment of a long-term and mutually trusted relationship with customers. The Group is in compliance with the laws and regulations including the Personal Data (Privacy) Ordinance to handle and protect all personal data of customers. With greatest care and caution the importance of protecting the confidentiality of customer' personal data is also clearly stipulated in our Employee Handbook to new employees fully understand our confidentiality policy and manage such information properly.

We are committed to providing customers with clear and accurate information. Customers are advised of the details and terms of products (such as management fee and interest rate), as well as any associated risks to enable customers to make an informed decision. Furthermore, the Group has formulated guideline regarding sales materials, which requires all information of sales materials are true and free from errors, and forbids any false, misleading or inaccurate statement in any form of our communications. The Group respects and protects intellectual property, and strictly complies with the relevant laws and regulations, to eliminate any alleged infringement.

#### 尊重客戶及供應商

#### 供應鏈管理

鑑於本集團的業務性質,我們的營運不涉及大批量採購,但我們仍然非常重視辦公室日常營運的物資採購。本集團制定採購政策以挑選可靠的供應商及服務供應商支援業務營運。除了考慮供應商的聲譽、質量及性價比等因素之外,我們優先考慮社會責任表現良好或符合我們環保政策的供應商,鼓勵供應商跟本集團攜手創造可持續發展的社會。例如:我們優先考慮採購有較高回收價值、附有較少包裝材料及能源效益較佳的產品。為實徵我們的綠色採購原則,我們亦不斷評估材料的使用,以避免積壓及浪費資源。倘發現供應商的行為不符合本集團的政策,我們將立即終止合作關係。

#### 重視客戶

作為金融服務商,保障客戶私隱、維護市場公平, 是本集團與客戶建立長遠互信關係的關鍵。本集團 遵從《個人資料(私隱)條例》等相關法例法規, 嚴謹處理及保護客戶的所有個人資料。本集團在 《僱員手冊》清楚列明保護客戶資料機密的重要 性,確保新入職員工充分了解本集團的保密政策, 妥善管理資料。

我們亦致力確保資訊清晰無誤,向客戶清楚交代產品詳情及條款(如管理費、利率等),以及任何相關風險,助客戶作出知情決定。此外,本集團已就銷售材料制定指引,規定所有銷售材料所載資料真確無誤,並禁止在任何形式的通訊中作出虛假、誤導或失實陳述。本集團尊重及保護知識產權,嚴格遵守相關法例法規,杜絕任何侵權行為。

#### **ANTI-CORRUPTION**

It is the unwavering principle of the Group to combat corruption and advocate integrity and self-discipline. The Group strictly complies with the laws and regulations relating to bribery prevention, extortion, fraud and money laundering, such as the Prevention of Bribery Ordinance. A mechanism for declaration of interest is in place to prohibit employees engagement in any investment activities that collide with the interest of the Group, and require employees to report any situations that may involve conflict of interest with the Group, either directly or indirectly. There is also a whistle-blowing policy to provide a channel for employees to report suspected misconduct.

#### CONTRIBUTION TO SOCIETY

The past few years have witnessed our persistent engagement in public welfare and relentless effort in charitable activities with a view of paying back to the community. The Group also encourages employees to actively participate in various volunteer activities. Looking ahead, the Group will continue to uphold the principle of being responsible for its customers, employees, business partners, shareholders and the society, and will seek further opportunities to develop a harmonious relationship with its stakeholders.

#### 反貪污

#### MAJOR CUSTOMERS AND SUPPLIERS

The five largest suppliers accounted for 93% of the Group's purchases for the year whereas the five largest customers accounted for 43% of the Group's revenue for the year. The largest supplier accounted for 51% of the Group's purchases and the largest customer accounted for 11% of the Group's revenue. None of the Directors, their associates nor any Shareholder (whom to the knowledge of the Directors owns more than 5% of the Company's issued share capital) has any interest in the Group's five largest suppliers or five largest customers.

#### EMPLOYEES AND REMUNERATION POLICIES

The Group employed 31 (2016: 35) full-time staff under its subsidiaries globally as at 31 March 2017. Total staff costs amounted to HK\$30 million (2016: HK\$15 million) for the year ended 31 March 2017. The remuneration policies of the Group are reviewed periodically on the basis of job nature, market trend, company performance and individual performance. Other staff benefits include bonuses awarded on a discretionary basis, retirement schemes and the Share Option Scheme.

#### PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Bye-Laws although there are no restrictions against such rights under the laws in Bermuda where the Company is incorporated.

於二零一七年三月三十一日,本集團旗下附屬公司於全球僱用31名(二零一六年:35名)全職員工。截至二零一七年三月三十一日止年度,員工總成本為港幣3,000萬元(二零一六年:港幣1,500萬元)。本集團之薪酬政策乃根據僱員之工作性質、市場趨勢、公司業績及個別員工之表現而定期作出檢討。其他員工福利包括酌情發放花紅獎賞、退休計劃及購股權計劃。

#### 優先購買權

公司細則並無優先購買權之規定,雖然根據本公司之註冊地百慕達之法例,對此權利並無作出任何限制。

On 30 March 2016, Trillion Winner Investment Ltd ("Trillion") as the owner entered into an aircraft charter agreement (the "Aircraft Charter Agreement") with Dingyi Resources Limited ("Dingyi Resources"), an indirect wholly-owned subsidiary of the Company, as the charteree, pursuant to which Trillion agreed to provide and Dingyi Resources agreed to hire the aircraft commencing on 1 April 2016 to 31 March 2019 for the charter price of US\$2,000 per flight hour ("Charter Price") (excluding all other costs and expenses shall be for the account of Dingyi Resources in relation to hire an aircraft). The transaction pursuant to the Aircraft Charter Agreement constituted continuing connected transaction under the Listing Rules as Trillion is beneficially wholly-owned by Mr. Li Kwong Yuk, the controlling shareholder, a chairman and an Executive Director of the Company.

Details of the Aircraft Charter Agreement are set out in the Company's announcement dated 30 March 2016.

During the year ended 31 March 2017, Dingyi Resources paid the aggregate of the charter price of approximately HK\$834,000 (2016: HK\$1,587,000) to Trillion pursuant to the Aircraft Charter Agreement.

#### **OPINION**

We have audited the consolidated financial statements of Dingyi Group Investment Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 89 to 216, which comprise the consolidated statement of financial position as at 31 March 2017, and the consolidated statement of profit or loss, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2017, and of its consolidated financial performance and consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

We have tested the calculations carried out to split the convertible bonds into equity and debt element. We have assessed the accuracy of historical financial information, examined the mathematical accuracy of calculations, evaluated the valuation technique applied and approach used and evaluated the assumptions used to calculate discount rate.

Changes in fair value of financial liabilities attributable to changes in the financial liabilities' credit risk are not subsequently reclassified to profit or loss. Under HKAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss was presented in profit or loss.
- In the aspect of impairment assessments, the impairment requirements relating to the accounting for an entity's expected credit losses on its financial assets and commitments to extend credit were added. HKFRS 15 also introduces extensive qualitative and quantitative disclosure requirements which aim to enable users of the financial statements to understand the nature, amount, timing and uncertainty of revenue and cash flows arising from contracts with customers.

HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 Revenue, HKAS 11 Construction Contracts and the related interpretations when it becomes effective.

本公司董事預期,日後應用香港財務報告準則第15號或會導致確立獨立履約責任,此舉可能影響確認收益的時間。履行合約所產生的若干成本(於現時支銷)或須於香港財務報告準則第15號項下確認為資產。同時亦須就收益作出更多披露。然而,在完成詳細審閱前,未能切實可行地合理估計香港財務報告準則第15號的影響。

### 香港財務報告準則第16號租賃

香港財務報告準則第16號為租賃安排之識別以及其於出租人及承租人財務報表之處理方式提供一個綜合模式。

就承租人會計處理而言,該準則引入單一承租人會計模式,規定承租人須確認所有租賃 之資產及負債,租期均多於12個月,惟相關資產價值較低則除外。

At the commencement date of the lease, the lessee is required to recognise a right-of-use asset at cost, which consists of the amount of the initial measurement of the lease liability, plus any lease payments made to the lessor at or before the commencement date less any lease incentives received, the initial estimate of restoration costs and any initial direct costs incurred by the lessee. A lease liability is initially recognised at the present value of the lease payments that are not paid at that date.

Subsequently, the right-of-use asset is measured at cost less any accumulated depreciation and any accumulated impairment losses, and adjusted for any remeasurement of the lease liability. Lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability, reducing the carrying amount to reflect the lease payment made, and remeasuring the carrying amount to reflect any reassessment or lease modifications or to reflect revised in-substance fixed lease payments. Depreciation and impairment expenses, if any, on the right-of-use asset will be charged to profit or loss following the requirements of HKAS 16 Property, Plant and Equipment, while interest accrual on lease liability will be charged to profit or loss.

In respect of the lessor accounting, HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently.

HKFRS 16 will supersede the current lease standards including HKAS 17 Leases and the related Interpretations when it becomes effective.

就出租人會計處理而言,香港財務報告準則 第16號大致轉承了香港會計準則第17號之出 租人會計處理規定。因此,出租人繼續將其 租賃分類為經營租賃或融資租賃,並且對兩 類租賃進行不同之會計處理。

香港財務報告準則第16號生效後,將取代現有租賃準則,包括香港會計準則第17號租賃及相關詮釋。

HKFRS 16 will be effective for annual periods beginning on or after 1 January 2019 with early application permitted provided that the entity has applied HKFRS 15 Revenue from Contracts with Customers at or before the date of initial application of HKFRS 16. As at 31 March 2017, the Group has non-cancellable operating lease commitments of approximately HK\$17,354,000 as disclosed in note 31. A preliminary assessment indicates that these arrangements will meet the definition of a lease under HKFRS 16, and hence the Group will recognise a rightof-use asset and a corresponding liability in respect of all these lease unless they qualify for low value or short-term leases upon the application of HKFRS 16. In addition, the application of new requirements may result changes in the measurement, presentation and disclosure as indicated above. However, it is not practicable to provide a reasonable estimate of the effect until the Group performs a detailed review.

### AMENDMENTS TO HKAS 7 DISCLOSURE INITIATIVE

The amendments require entities to provide disclosures that enable users of financial statements to evaluate changes in liabilities arising from financing activities, including both changes arising from cash flows and non-cash changes. The amendments do not prescribe a specific method to fulfil the new disclosure requirements. However, the amendments indicate that one way is to provide a reconciliation between the opening and closing balances for liabilities arising from financing activities.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants in the principal (or most advantageous) market at the measurement date under current market conditions (i.e. an exit price) regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for sharebased payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

#### **BASIS OF CONSOLIDATION**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries.

Control is achieved where the Group has:

- power over the investee;
- exposure, or rights, to variable returns from its involvement with the investee; and
- the ability to use its power over the investee to effect the amount of the Group's returns.

The Group reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of these elements of control stated above.

Consolidation of a subsidiary begins when the Group obtains control of the subsidiary and cease when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

# CHANGES IN THE GROUP'S OWNERSHIP INTERESTS IN EXISTING SUBSIDIARIES

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

#### **REVENUE RECOGNITION**

Revenue is measured at the fair value of the consideration received or receivable for good and services renders in the normal course of business. Revenue is reduced for estimated customer returns, rebates and other similar allowances.

Revenue from the sale of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Finance lease income is recognised using the effective interest rate implicit in the lease over the term of the lease.

Gain or loss on the disposal of held for trading investments is recognised on a trade date basis when the relevant transactions are executed.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income from a financial asset is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Dividend income from investments is recognised when the shareholder's right to receive payment have been established (provided that it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably).

#### PLANT AND EQUIPMENT

Plant and equipment held for use in the production or supply of goods or services, or for administrative purposes are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to allocate the cost of plant and equipment less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and their useful lives.

An item of plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### **LEASING**

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lease. All other leases are classified as operating leases.

#### The Group as lessor

Amounts due from lessees under finance leases are recognised as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

#### The Group as lessee

Assets held under finance leases are recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as a finance lease obligation.

#### The Group as lessee (Continued)

Lease payments are apportioned between finance expenses and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in profit or loss, unless they are directly attributable to qualifying assets, in which case they are capitalised in accordance with the Group's general policy on borrowing costs (see the accounting policy below).

Operating leases payments are recognised as an expense on a straight-line basis over the lease term. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

#### **FOREIGN CURRENCIES**

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange fluctuation reserve.

#### **EMPLOYEE BENEFITS**

#### **Pension obligation**

Group entities operate various pension schemes. The schemes are generally funded through payments to insurance companies or trustee-administered funds, determined by periodic actuarial calculation. The Group has defined contribution plans.

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

The Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid.

Payments to state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme (the "MPF Scheme") are recognised as an expense when employees have rendered service entitling them to the contributions.

#### **TAXATION**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'loss before tax' as reported in the consolidated statement of profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Current and deferred tax are recognised in profit or loss.

#### **INVENTORIES**

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are calculated using the first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Cash and cash equivalents in the consolidated statement of financial position comprise cash at banks and on hand and short-term deposits with a maturity of three months or less. For the purpose of the consolidated statement of cash flows, cash and cash equivalents consist of cash and short-term deposits as defined above.

#### **FINANCIAL INSTRUMENTS**

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

The Group's financial assets are classified into financial assets at fair value through profit or loss ("FVTPL"), loans and receivables and available-for-sale financial assets. #### **Derivative financial instruments**

Derivatives are initially recognised at fair value at the date when a derivative contract is entered into and are subsequently remeasured at their fair values at the end of the reporting period. Changes in the fair value of these derivative instruments are recognised immediately in the consolidated statement of profit or loss.

#### **Derecognition**

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to accumulated losses.

#### **Share options granted to consultants**

Share options issued in exchange for goods or services are measured at the fair values of the goods or services received, unless that fair value cannot be reliably measured, in which case the goods or services received are measured by reference to the fair value of the share options granted. The fair values of the goods or services received are recognised as expenses, with a corresponding increase in equity (share option reserve), when the Group obtains the goods or when the counterparties render services, unless the goods or services qualify for recognition as assets.

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

# CRITICAL JUDGEMENTS IN APPLYING ACCOUNTING POLICIES

The following are the critical judgements, apart from those involving estimations (see below), that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised and disclosure made in the consolidated financial statements.

#### **Income taxes**

The Group is subject to income taxes in numerous jurisdictions. Significant judgement is required in determining the worldwide provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group estimates and recognises liabilities based on the submitted tax returns and expected the final tax assessment to be received will have no additional tax become due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

#### **KEY SOURCES OF ESTIMATION UNCERTAINTY**

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Depreciation of plant and equipment

Plant and equipment are depreciated on a straight-line basis over their estimated useful lives after taking into account their estimated residual values. The determination of the useful lives and residual values involve management's estimation. The Group assesses annually the residual values and the useful lives of the plant and equipment and if the expectation differs from the original estimates, such a difference may impact the depreciation charges in the year in which the estimates change.

#### **Estimated fair value of financial instruments**

As described in note 30(c), the directors of the Company use their judgement in selecting an appropriate valuation technique for financial instruments not quoted in an active market. Valuation techniques commonly used by market practitioners are applied. For derivative financial instruments, assumptions are made based on quoted market rates adjusted for specific features of the instrument. Other financial instruments are valued using a discounted cash flow analysis based on assumptions supported, where possible, by observable market prices or rates. The estimation of fair value of unlisted equity instruments includes some assumptions not supported by observable market prices or rates. Details of the assumptions used are disclosed in note 30(c). The directors of the Company believe that the chosen valuation techniques and assumptions are appropriate in determining the fair value of financial instruments.

#### Valuation of share options

As mentioned in note 32, the Group has granted share options to directors, employees and consultants. The directors of the Company have used an option-pricing model – Binomial model (the "Binomial Model") to determine the total fair value of the options granted. The option pricing models require the input of subjective assumptions, such as risk free rate, dividend yield, expected volatility and expected terms, to be made by the directors of the Company in applying the Binomial Model (note 32). The fair value of options granted for the year ended 31 March 2017 determined using the Binomial Model was approximately HK\$162,750,000 (2016: HK\$110,762,000).

#### Impairment of available-for-sale financial assets

For available-for-sale financial assets, a significant or prolonged decline in fair value below cost is considered to be objective evidence of impairment. Judgement is required when determining whether a decline in fair value has been significant or prolonged. In making this judgement, the historical data on market volatility as well as the price of the specific investment are taken into account. The Group also takes into account other factors, such as industry and sector performance changes in technology and operational and financing cash flow of the investee. As at 31 March 2017, the carrying amount of available-for-sale financial assets was approximately HK\$66,861,000 (2016: HK\$75,466,000) net of accumulated impairment loss of approximately HK\$59,698,000 (2016: HK\$51,537,000).

# Impairment of loan and interest receivables and finance lease receivable

The policy for impairment of loan and interest receivables and finance lease receivable is based on assessments of the recoverability of each debtor, including the current creditworthiness and the past collection history. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgment and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the receivables and doubtful debt expenses in the year in which such estimate has been changed.

As at 31 March 2017, the carrying amount of loan and interest receivables was approximately HK\$479,304,000 (2016: HK\$229,056,000) net of accumulated impairment loss of nil (2016: nil). No impairment loss is provided for the year (2016: nil).

As at 31 March 2017, the carrying amount of finance lease receivable was approximately HK\$94,470,000 (2016: HK\$101,302,000). No impairment loss is provided for the year.

Note: On 25 September 2015, the Group entered into a cooperation agreement with a nominee, Xumao Ventures Limited ("Xumao Ventures"), a company incorporated in the British Virgin Islands, to acquire the equity interest in Jinshidai Investment Consultancy (Shenzhen) Co., Ltd. ("Jinshidai"), an independent third party with property interests located in the PRC.

Due to the non-performance of the vendors, the Group has submitted an application for arbitration to the Shenzhen Arbitration Commission (深圳仲裁委員會) (the "Commission") seeking specific performance of the Acquisition Agreement and damages against the vendors. The application has been accepted by the Commission on the same date of 29 January 2016.

On 11 April 2016, the nominee and the vendors entered into a settlement agreement (the "Settlement Agreement") to settle the arbitration. Under the Settlement Agreement, the vendors agreed to make a payment of RMB38,000,000 to settle the arbitration and related proceedings. The consideration for the acquisition was settled by an advance from a director, Mr. Li Kwong Yuk and the settlement was repaid to the director during the years ended 31 March 2016 and 2017, respectively. The Group was entitled to a share of 38% of the remaining balance of approximately HK\$9,207,000 as net settlement and was recognised to offset to the amounts due to the related companies. The settlement was received subsequent to the end of the reporting period. Details of the transaction were disclosed in the announcements of the Company dated 25 September 2015, 29 September 2015, 2 October 2015, 9 October 2015, 30 November 2015, 9 December 2015, 29 January 2016, 12 April 2016 and 27 April 2016.

At the end of the reporting period, the Group has unused tax losses of approximately HK\$379,929,000 (2016: HK\$352,625,000) available for offset against future profits. A deferred tax asset has been recognised in respect of approximately HK\$4,800,000 (2016: HK\$3,582,000) of such losses.

No deferred tax asset has been recognised in respect of the remaining unused tax losses of approximately HK\$375,129,000 (2016: HK\$349,043,000) due to the unpredictability of future profit streams. Included in unrecognised tax losses are losses of approximately HK\$5,032,000 (2016: HK\$3,273,000) that will expire in the next five years. Other losses may be carried forward indefinitely.

The Group manages its capital structure to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of net debt, which includes the margin loans payable disclosed in note 23 and obligation under a finance lease disclosed in note 25, net of cash and cash equivalents and equity attributable to owners of the Company comprising share capital and reserves.

The directors of the Company review the capital structure periodically. As part of this review, the directors of the Company consider the cost of capital and the risk associated with each class of capital. Based on the recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as issue of new debt or the redemption of existing debt.

The Group is exposed to equity price risk through its investments in listed equity securities and these investments are classified on the consolidated statement of financial position either as available-forsale financial assets or held for trading investments. The management manages this exposure by maintaining a portfolio of investments with different risks. In addition, the management has appointed a special team to monitor the price risk and will consider hedging the risk exposure should the need arise.

In respect of loan and interest receivables and finance lease receivable, representing financing advances to customers under the Group's loan financing and financial leasing business, individual credit evaluations are performed on all customers. These evaluations focus on the customer's financial background and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The default risk of the industry in which customers operate also has an influence on credit risk but to a lesser extent.

In respect of the loan and interest receivables arising from the Group's loan financing business, 47% (2016: 22%) of the total gross loan and interest receivables as at 31 March 2017 was due from the Group's largest customer and 82% (2016: 78%) of the total gross loan and interest receivables as at 31 March 2017 was due from the Group's five largest customers for the Group's loan financing business.

In respect of the finance lease receivables arising from the Group's financial leasing business, 93% (2016: 93%) of the total gross finance lease receivable as at 31 March 2017 was due from the Group's largest customer and 100% (2016: 100%) of the total gross finance lease receivable as at 31 March 2017 was due from the Group's five largest customers for the Group's financial leasing business.

The Group's concentration of credit risk by geographical locations for loan and interest receivables is mainly in the PRC, which accounted for 75% (2016: 97% mainly in Hong Kong) of loan and interest receivables as at 31 March 2017 and 2016.

The directors of the Company consider the credit risk is under control since the management exercises due care in granting credit and checking the financial background of these customers on a regular basis.

The credit risk on liquid fund is limited because they are deposited with financial institutions or investment counterparties with high credit quality and the Group does not expect any significant counterparty risk.

#### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of margin loan from a financial institution and ensures compliance with loan covenants.

The Group's liquidity position is monitored closely by the management of the Company. The directors of the Company believe that the Group will be able to meet its financial obligations as they fall due in the foreseeable future.

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. The above loss arising from changes in fair value for the year ended 31 March 2017 recognised in profit or loss of approximately HK\$8,250,000 (2016: HK\$3,031,000) and approximately HK\$4,811,000 (2016: approximately HK\$213,321,000) are included in "Loss arising from changes in fair value of held for trading investments" and "Gain (loss) arising from changes in fair value of derivative financial liabilities" respectively in the consolidated statement of profit or loss.

The directors of the Company consider that the carrying amounts of other current financial assets and liabilities recorded at amortised cost in the consolidated financial statements approximate to their corresponding fair value due to short-term maturities. The directors of the Company consider that fair value of other non-current financial assets and liabilities approximate to their carrying amounts as the impact of discounting of non-current assets is not significant and the non-current liabilities are amortised at market interest rates.

The total number of shares in respect of which options might be granted under the Scheme and any other schemes is not permitted to exceed 10% of the shares of the Company in issue at the date of shareholders' approval of the Scheme (the "Scheme Mandate Limit") or, if such 10% limit was renewed, at the date of shareholders' approval of the renewal of the Scheme Mandate Limit. The maximum aggregate number of shares which might be issued upon the exercise of all outstanding options granted and yet to be exercised under the Scheme and any other share option schemes, must not exceed 30% of the total number of shares of the Company in issue from time to time.

The number of shares in respect of which options might be granted to any individual in any one year was not permitted to exceed 1% of the shares of the Company then in issue, without prior approval from the shareholders in general meeting.

Each grant of options to any director, chief executive or substantial shareholder must be approved by independent non-executive directors of the Company. Where any grant of options to a substantial shareholder or an independent non-executive director or any of their respective associates would result in the shares of the Company issued and to be issued upon exercise of options already granted and to be granted in excess of 0.1% of the Company's issued share capital and with a value in excess of HK\$5,000,000 in the 12-month period up to the date of such grant must be approved in advance by the Company's shareholders.

#### **HONG KONG**

The Group operates the MPF Scheme under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees in Hong Kong. The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, each of the Group companies (the "employer") in Hong Kong and its employees are required to make contributions to the scheme at 5% of the employees' earnings as defined under the Mandatory Provident Fund Legislation. The contributions from each of the employer and employees are subject to a cap of HK\$1,250 per month before 1 June 2014 and HK\$1,500 per month, since 1 June 2014 onwards. During the year ended 31 March 2017, the total amount contributed by the Group to this scheme and charged to the consolidated statement of profit or loss was approximately HK\$176,000 (2016: HK\$171,000).

#### THE PRC

As stipulated by rules and regulations in the PRC, subsidiaries in the PRC are required to contribute to a state-managed retirement plan for all its employees at a certain percentage of the basic salaries of its employees. The state-managed retirement plan is defined contribution retirement plan and responsible for the entire pension obligations payable to all retired employees. Under the state-managed retirement plan, the Group has no further obligations for the actual pension payments or post-retirement benefits beyond the annual contributions. During the year ended 31 March 2017, the total amount contributed by the Group to this scheme and charged to the consolidated statement of profit or loss was approximately HK\$65,000 (2016: HK\$97,000).

# VERY SUBSTANTIAL ACQUISITION AND CONNECTED TRANSACTION

On 21 June 2017, the Company (as the purchaser) and the vendor, Mr. Li Kwong Yuk (the "Vendor"), being a controlling shareholder, the executive director and the chairman of the Company, entered into the agreement, pursuant to which the Company has conditionally agreed to acquire for and the Vendor has conditionally agreed to dispose of the entire equity interest of the Target Company, United Faith Investments Limited (the "Target Company"), a company incorporated in the BVI with limited liability and is wholly owned by the Vendor, for the consideration of HK\$1,000 million. Pursuant to the agreement, the consideration of HK\$1,000 million shall be satisfied by the issuance of the convertible bonds in the aggregate principal amount of HK\$1,000 million by the Company to the Vendor upon completion of the transaction. The transaction has not yet been completed up to the date of this report.

Details of the transaction were disclosed in the announcement of the Company dated 21 June 2017.

# PARTIAL COMPLETION OF ISSUE OF CONVERTIBLE BONDS

Subsequent to the end of the reporting period, all conditions precedent under the certain subscription agreements of convertible bonds in note 21(iii) have been fulfilled. Convertible bonds of principal amounts of HK\$88,500,000, HK\$141,500,000 and HK\$230,000,000 were issued respectively.
