REPORT OF THE MANAGER TO THE UNITHOLDERS

Market Review

In the first half of Year 2017, the CSI300 Index was volatile in an upward trend. During the first three months, the index went generally stable in a mild zone around 3,400 point level. However, marching into April, the market significantly dropped down and total turnover also turned weak. The index bounced back from the bottom in early May with increasing fund inflows into large-cap stocks. After 3-year rejections of inclusion in MSCI Emerging Market Index, 222 large-cap stocks in China were finally decided to be added to the gauge, driving the expectation that initial cash inflow of US\$17-18 billion into the A-share market. Against this backdrop, China's A-share market experienced a booming June. The market rallied on the announcement of inclusion in MSCI's emerging markets index, loose monetary policy by regulators and brighter prospects for China's economy.

The CSI 300 index ended the first half of Year 2017 with a positive note by gaining 10.78% to 3,666.80, and the valuation was14.31x PE and 1.60x PB (based on expected earnings of 2017).

Portfolio Review

In the first half of 2017, Fund's NAV per unit increased 10.48%. The rolling 1-year tracking error (TE) of the fund was 1.28%, and the rolling 1-year tracking difference (TD) between Haitong CSI300 Index ETF and its underlying benchmark was -0.34%.

Market Outlook

Looking forward, supply side structural reforms will be the most important challenge of Chinese economy. In addition, cultivating new economic structure, strengthening the new momentum of development, promoting the national economy sustainable and healthy development will be the important work targets to continue to push forward.

Moreover, the announcement by index complier MSCI that from Year 2018 it will begin to include China's onshore stock markets in its benchmark indices is of great symbolic significance. Though inclusion in MSCI's emerging markets index may not trigger massive fund inflows in the near term, it will improve the market liquidity and the integration with global markets for the mainland stock market in the medium to long term. In general, we hold a bullish view on the A-share market in the second half of Year 2017.
