OVERSEAS REGULATORY ANNOUNCEMENT

Power Generation and On-grid Tariff

for the First Three Quarters of 2017

This announcement is made pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

As at 30 September 2017, the total amount of power generated by Huadian Power International Corporation Limited* (the "**Company**") and its subsidiaries (hereinafter referred to as the "**Group**") calculated on the basis of the consolidated financial statement of the Group according to the China Accounting Standards for Business Enterprises for the first three quarters of 2017 was 142.65 million MWh, representing an increase of approximately 2.43% compared with the same period of 2016; and the total amount of on-grid electricity sold was 133.40 million MWh, representing an increase of approximately 2.40% compared with the same period of 2016. The increase in power generation and on-grid electricity sold was mainly attributable to the power contribution from the operation of the newly-added generating units of the Group. The average tariff of on-grid electricity sold by the Group for the first three quarters of 2017 was RMB396.98 per MWh.
