BNP PARIBAS ISSUANCE B.V. (the "**Issuer**") gives notice that under the terms and conditions of the CBBCs (the "**Conditions**"), following the occurrence of the Mandatory Call Event ("**MCE**") of the CBBCs at 15:09:54 on 19 October 2017, the Residual Value has been determined to be HK\$0.0 per Board Lot (such Board Lot being **10,000** CBBCs).

The Residual Value is determined by the Issuer by reference to the following formula:

$$\text{Residual Value per Board Lot} = \frac{\text{Entitlement} \times (\text{Minimum Trade Price} - \text{Strike Price}) \times \text{one Board Lot}}{\text{Number of CBBC(s) per Entitlement}}$$

Where:

- (a) "**Strike Price**" is HK\$348.00;
- (b) "**Minimum Trade Price**" means the lowest Spot Price of the Shares during the MCE Valuation Period, being HK\$345.60;
- (c) "**Entitlement**" means 1 share(s); and
- (d) "**Number of CBBC(s) per Entitlement**" means 100 CBBCs;
