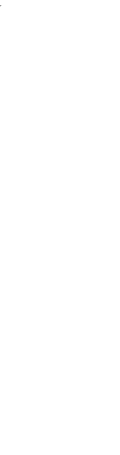

主席報告書

高瞻遠築

本人代表董事會(「董事會」或「董事」)欣然向股東提呈達力集團有限公司(「本公司」)及其附屬公司(「本集團」)截至二零一七年六月三十日止財政年度之年報。

業績

截至二零一七年六月三十日止之財政年度，本集團錄得收入港幣101,762,000元(二零一六年：港幣103,870,000元)，而毛利為港幣79,700,000元(二零一六年：港幣83,971,000元)。此業績主要源自本集團以人民幣(「人民幣」)結算之投資物業所帶來之穩定租金收入，連同毛利率達78%(二零一六年：81%)。

與此同時，本集團呈報其他收益為港幣16,038,000元(二零一六年：港幣6,266,000元)，主要源於假計利息收入。其他收益之大幅增加是由於年內從波動中的人民幣換算港幣(「港幣」)之貶值所產生之兌換淨虧損減少至港幣2,422,000元(二零一六年：港幣12,785,000元)，而且，本集團已確認其投資物業公平值之增加合計為港幣92,896,000元(二零一六年：港幣83,076,000元)。

經計入以人民幣為功能貨幣換算至港幣為呈列貨幣的影響，在年內人民幣兌換港幣之貶值為2%(二零一六年：8%)，本公司擁有人於本年度應佔溢利為港幣115,591,000元(二零一六年：港幣95,085,000元)，相比去年，上升22%。而每股基本盈利為港幣0.514元(二零一六年：港幣0.427元)。

經考慮於綜合財務賬內計入由人民幣換算至港幣為呈列貨幣之匯兌差額之其他全面支出，本年度本公司擁有人應佔總全面收入總額為港幣87,378,000元(二零一六年：總全面支出港幣66,749,000元)。

On behalf of the board of directors (the “Board” or “Directors”), I am pleased to present to the shareholders the annual report of Dynamic Holdings Limited (the “Company”) and its subsidiaries (the “Group”) for the financial year ended 30 June 2017.

RESULTS

For the financial year ended 30 June 2017, the Group recorded a total revenue of HK\$101,762,000 (2016: HK\$103,870,000) and gross profit of HK\$79,700,000 (2016: HK\$83,971,000). These results were mainly attributable to the stable rental income of investment properties of the Group all denominated in renminbi (“RMB”), together with gross profit margin of 78% (2016: 81%).

In addition, the Group reported other gain of HK\$16,038,000 (2016: HK\$6,266,000) that arose mainly from imputed interest income. It increased significantly due to the reduced net exchange loss and the net exchange loss was HK\$2,422,000 for the year (2016: HK\$12,785,000) arisen from the fluctuation of RMB devalued against Hong Kong dollar (“HK\$”). In addition, the Group recognised an aggregate increase in fair value of its investment properties in the sum of HK\$92,896,000 (2016: HK\$83,076,000).

After accounted for the effect of currency translation from functional currency in RMB to presentation currency in HK\$ that RMB devalued against HK\$ at about 2% (2016: 8%) in the year, the profit for the year attributable to owners of the Company amounted to HK\$115,591,000 (2016: HK\$95,085,000), which rose by 22% from that of the previous year, with basic earnings per share of HK\$0.514 (2016: HK\$0.427).

Taken into account of other comprehensive expense of exchange difference on translation of RMB to presentation currency of HK\$ in the consolidated financial statements, the total comprehensive income attributable to owners of the Company amounted to HK\$87,378,000 (2016: total comprehensive expense of HK\$66,749,000) for the year.

股息

董事會議決建議派發末期股息每股港幣3仙(二零一六年:港幣3仙)予於二零一七年十二月二十二日名列本公司股東名冊之所有股東,連同於本年度內已派發予本公司股東之中期股息每股港幣2.5仙,本年度之股息總額將為每股港幣5.5仙。股息單預期將約於二零一八年一月九日寄予各股東,但須待股東在即將於二零一七年十二月八日(星期五)舉行之本公司股東週年大會上通過。

業務回顧

於回顧年度,本集團之經營分類包含中國大陸之物業租賃及物業銷售。租賃分類乃位處於北京及上海之投資物業,並為本集團主要分類資產,均以人民幣結算而且租金表現平穩,並持續為本集團收入及業績帶來關鍵及穩固來源。

本集團核心租賃業務之投資物業(為位處於上海浦東之優質辦公樓及北京朝陽區的完善購物商場連同停車場)之資產總值合計為人民幣1,727,800,000元(二零一六年:人民幣1,646,300,000元),於本年度表現穩步良好,帶來物業租賃總收入合共為人民幣89,279,000元(二零一六年:人民幣86,270,000元),相比去年,顯示微升4%。此租賃收入於財務賬項內總金額為港幣101,762,000元(二零一六年:港幣103,870,000元),佔本集團全部(二零一六年:全部)營業額。此外,該等投資物業之公平值上升總值為人民幣81,500,000元(二零一六年:人民幣69,000,000元),換算為港幣92,896,000元(二零一六年:港幣83,076,000元)。據此,物業租賃分類業績錄得溢利為人民幣150,118,000元(二零一六年:人民幣138,623,000元),相比去年,穩健增長8%,而呈列為港幣171,108,000元(二零一六年:港幣166,902,000元)。

DIVIDENDS

The Board has resolved to recommend the payment of a final dividend of 3 Hong Kong cents (2016: 3 Hong Kong cents) per share to the shareholders of the Company whose names appear on the register of members of the Company on 22 December 2017. Together with the interim dividend of 2.5 Hong Kong cents per share which were paid to the shareholders of the Company during the year, the total dividend for the year will amount to a total of 5.5 Hong Kong cents per share. Subject to approval by the shareholders at the forthcoming annual general meeting of the Company to be held on Friday, 8 December 2017, the warrants for the final dividend are expected to be despatched to those entitled on or about 9 January 2018.

BUSINESS REVIEW

In the year under review, the operating segments of the Group consisted of property rental and property sales in the mainland China. The rental segment of investment properties in Beijing and Shanghai, which was the major segment assets of the Group with modest rental performance denominated in RMB, remained as the key and solid contributor of revenue and results of the Group.

The core rental business of investment properties of the Group, which were quality offices in Pudong in Shanghai and well-established mall together with car parks in Chaoyang District in Beijing with asset value in an aggregate of RMB1,727,800,000 (2016: RMB1,646,300,000), performed steadily in the year with total revenue of property rental of RMB89,279,000 (2016: RMB86,270,000), showing a mild increase of 4% as compared with that of last year. Such rental income presented in the financial statements in the sum of HK\$101,762,000 (2016: HK\$103,870,000) and contributed to all (2016: all) of the total turnover of the Group. Meanwhile, the fair value of these investment properties increased in the total of RMB81,500,000 (2016: RMB69,000,000), translating into HK\$92,896,000 (2016: HK\$83,076,000). As such, the segment results of property rental reported a profit of RMB150,118,000 (2016: RMB138,623,000) with a moderate increment of 8% from that of the last year and depicted in HK\$171,108,000 (2016: HK\$166,902,000).

業務回顧 (續)

在北京，儘管在面對網上零售商及新興商場湧現的強烈競爭下，本集團成熟完備之社區購物中心（名為「尚街購物中心」）之中檔零售商戶於年內仍維持高佔用率。商場租賃收入合計為人民幣29,426,000元（二零一六年：人民幣30,124,000元），相比去年微跌2%，並換算為港幣33,541,000元（二零一六年：港幣36,269,000元），佔本集團總收入33%（二零一六年：35%）。於年內，本集團投資物業公平值升值呈列為港幣2,850,000元（二零一六年：港幣4,816,000元），顯示升值共為人民幣2,500,000元（二零一六年：人民幣4,000,000元）。據此，分類業績（包括物業升值增長之影響）錄得溢利為人民幣20,968,000元（二零一六年：人民幣25,960,000元），相比去年顯示下調19%，而換算為港幣23,900,000元（二零一六年：港幣31,255,000元）。

由於本集團僅餘有限住宅單位可供銷售，故「朝陽園」之住宅單位並無（二零一六年：無）銷售收益，從而導致在分類業績產生行政費虧損為港幣173,000元（二零一六年：港幣140,000元）。

在上海，基於國內金融及專業企業於年內對浦東核心商務區的辦公樓市場需求，故辦公樓市場仍維持強勁。於年內，本集團名為「裕景國際商務廣場」的優質辦公樓（位處於小陸家咀的優越金融區）在穩健租金增長下已大致全部佔用。而租金收入總額為人民幣59,853,000元（二零一六年：人民幣56,146,000元），相比去年顯示溫和升幅7%，該收入換算為港幣68,221,000元（二零一六年：港幣67,601,000元），並佔本集團總營業額67%（二零一六年：65%）。該辦公樓物業公平值已確認升值為人民幣79,000,000元（二零一六年：人民幣65,000,000元），並呈列為港幣90,046,000元（二零一六年：港幣78,260,000元）。按此，分類業績（包括物業升值影響）帶來溢利人民幣129,150,000元（二零一六年：人民幣112,663,000元），相比去年穩健升幅為15%，並換算為港幣147,208,000元（二零一六年：港幣135,647,000元）。

BUSINESS REVIEW (Continued)

In Beijing, the well-established community mall of the Group known as “Uptown Mall” with mid-range retailers sustained high occupancy in the year, notwithstanding in the face of strong competition from on-line retailers and emerging malls. The mall rental amounted to RMB29,426,000 (2016: RMB30,124,000), representing a slight drop of 2% as compared with that of the last year. This rental translated into HK\$33,541,000 (2016: HK\$36,269,000) and contributed 33% (2016: 35%) of the total revenue of the Group. The increase in fair value of these investment properties depicted in HK\$2,850,000 (2016: HK\$4,816,000), showing an increase in the sum of RMB2,500,000 (2016: RMB4,000,000) in the year. Consequently, the segment results (including the effect of fair-value appreciation of properties) reported a profit of RMB20,968,000 (2016: RMB25,960,000), showing a drop of 19% from that of the last year and translated into HK\$23,900,000 (2016: HK\$31,255,000).

With limited residential units available for sale by the Group in Beijing, the proceeds from sale of residential units held by the Group at “Chaoyang Garden” were nil (2016: nil), thereby incurring an administrative loss of HK\$173,000 (2016: HK\$140,000) in the segment results.

In Shanghai, office market in core business district in Pudong remained robust due to demand from local financial and professional companies in the year. The quality offices of the Group known as “Eton Place” primely located at prominent financial area of Little Lujiazui were almost taken up in full at moderate rental growth in the year. And the rental revenue amounted to RMB59,853,000 (2016: RMB56,146,000), denoting a moderate increase of 7% from that of the last year. It presented into HK\$68,221,000 (2016: HK\$67,601,000), making up 67% (2016: 65%) of the total turnover of the Group. The fair value of these office properties appreciated in the sum of RMB79,000,000 (2016: RMB65,000,000), depicting in HK\$90,046,000 (2016: HK\$78,260,000). Thereby, the segment results (including the effect of fair-value appreciation of properties) was making a profit of RMB129,150,000 (2016: RMB112,663,000), representing a moderate increment of 15% from the one of the last year and presented into HK\$147,208,000 (2016: HK\$135,647,000).

業務回顧 (續)

於年內，深圳圳華港灣企業有限公司（「**圳華**」，本公司持有49%之中外合資經營企業）持有一幅位處於深圳南山區東角頭的土地（「**土地**」，自其經營期屆滿後，已於二零一六年七月進入強制清算。強制清算是經由中華人民共和國（「**中國**」）法院委任之清算委員會（「**清算委員會**」）執行及由中國法院監管。

於年內，本集團已在法律顧問的協助下密切監管強制清算程序，並已就圳華對本集團之欠款向清算委員會提出申索（「**申索**」）。此等申索已經清算委員會審查。與此同時，就有關清算事宜及就土地的重重新分區、拆遷賠償、土地置換及增加可發展面積的提議，本集團仍積極地與清算委員會、相關政府機構及中國合營夥伴共同工作。

依照本集團接獲的中國法律意見，該土地將會根據中國法律最終經公開拍賣或以其他適合方式處置，而任何盈餘（經償付所有相關負債後）將按照合營夥伴雙方權益比例分派。

由於強制清算圳華所涉及事宜（包括上述事宜）的複雜性，中國法院已接受清算委員會提呈，再進一步延長圳華強制清算六個月之期限至二零一八年一月。

與此同時，根據本集團中國法律顧問最近提供之法律意見及為了進一步爭取本集團的最佳利益，本集團已於二零一七年六月向華南國際經濟貿易仲裁委員會（「**仲裁委員會**」）提出國際仲裁呈請。此請求乃根據一九九六年十二月二十日就有關圳華而訂立之股東協議以清晰釐定本集團就來自土地之租金、收入及利潤的權利。此仲裁呈請已於二零一七年八月獲仲裁委員會接受，而有關仲裁進展及／或仲裁結果亦將會於適合的時間進一步公佈。然而，不管本集團與中國合營夥伴的仲裁程序結果，圳華將繼續會適時按程序清算。

BUSINESS REVIEW (Continued)

During the year, Shenzhen Zhen Wah Harbour Enterprises Ltd. (“**Zhen Wah**”, a sino-foreign equity joint venture in which the Company indirectly holds 49%), which holds a piece of land located in Tung Kok Tau, Nanshan District, Shenzhen (“**Land**”), entered into compulsory liquidation in July 2016 after the expiry of its operation period. The compulsory liquidation is conducted by a liquidation committee (“**Liquidation Committee**”) appointed by the court of the People’s Republic of China (the “**PRC**”) and under the supervision of the PRC court.

In the year, the Group has been closely monitoring the liquidation proceedings with the assistance of its legal advisers and has filed with the Liquidation Committee claims for debts owed by Zhen Wah to the Group (“**Claims**”). The Claims have been under review by the Liquidation Committee. Meanwhile, the Group continued to work actively with the Liquidation Committee, relevant official authorities and Chinese joint venture partner regarding the liquidation and a proposal for re-zoning, compensation for demolition, relocation and increase of gross developable area of the Land.

Based on PRC legal advice received by the Group, the Land will eventually be sold by way of public auction or disposed of by other applicable means in accordance with PRC laws, and any surplus (after settlement of all relevant liabilities) will be distributed to the joint venture partners in accordance with their equity contributions.

Due to complexity of issues involved in the liquidation of Zhen Wah including the aforesaid matters, the PRC court has accepted the application lodged by the Liquidation Committee to further extend the period of compulsory liquidation of Zhen Wah for six months up to January 2018.

In addition, based on recent PRC legal advice and to further strive for the best interests of the Group, the Group lodged an application for international arbitration with South China International Economic and Trade Arbitration Commission (“**Arbitration Commission**”) in June 2017 to determine the precise entitlement of the Group regarding rent, income and profit generated from the Land, pursuant to a shareholders’ agreement entered into between the Group and the Chinese joint venture partner on 20 December 1996 in relation to Zhen Wah. The arbitral application has been accepted by Arbitration Commission in August 2017, and further announcement on the progress and/or result of the arbitration will be made as and when appropriate. Irrespective of the result of the arbitral proceedings between the Group and the Chinese joint venture partner, Zhen Wah will still be wound up in the liquidation process in due course.

財務回顧

資本架構

本集團之財務狀況維持良好及資金流動充裕。於回顧年度內，本集團融資及財務政策均以企業層面且審慎態度管理及控制，以有效地利用集團資金及管理財務風險。於二零一七年六月三十日，本公司擁有人應佔權益合共為港幣1,978,078,000元(二零一六年：港幣1,902,346,000元)，而每股資產淨值為港幣8.79元(二零一六年：港幣8.48元)，本集團有抵押及無抵押之銀行借貸總額合共為約港幣143,290,000元(二零一六年：港幣149,593,000元)，均為港幣及以浮動利率基準計算而須於三年內償還。於二零一七年六月三十日，本集團負債比率約為7%(二零一六年：8%)，該比率乃按本集團負債總值相對本公司擁有人應佔權益計算。在本年度內，人民幣兌換港幣的匯率波動風險對本集團之影響產生淨兌換虧損港幣2,422,000元(二零一六年：港幣12,785,000元)，且於本年度內概未為對沖目的而採用金融工具。與此同時，人民幣之波動可能影響本集團財務表現及狀況，而本集團將會繼續評估及減低其負面影響。

財政資源及資金流動性

於回顧年度內，上海及北京投資物業租金收入已為本集團帶來充裕現金流量。於二零一七年六月三十日，本集團銀行定期存款和銀行結餘及現金主要為人民幣，總額為港幣258,278,000元(二零一六年：港幣244,719,000元)。本集團有充裕現金流量，而於二零一七年六月三十日維持尚未動用信貸額合共港幣15,000,000元(二零一六年：港幣11,000,000元)，作為流動資金，並以浮動利率計算。

資產抵押及或然負債

於二零一七年六月三十日，本集團為獲得財務機構的一般性銀行融資，已抵押賬面價值合共為港幣882,569,000元(二零一六年：港幣835,410,000元)的物業，轉讓予銀行該物業所得租金收入及出售款項且抵押本公司一間全資附屬公司的股份，並已將若干銀行存款港幣4,610,000元(二零一六年：港幣14,249,000元)向銀行作出抵押，作為銀行融資及本集團房地產項目的住房買家獲授予住房貸款提供擔保。於呈報期末，本集團已為北京住宅項目的住房買家提供銀行住房貸款擔保。於二零一七年六月三十日，本集團提供該等擔保住房貸款為港幣2,959,000元(二零一六年：港幣8,800,000元)。本公司董事認為由於該等財務擔保合同之借貸比率為低，故有關財務擔保合同之首次確認及於呈報期末之公平值並不重大。

FINANCIAL REVIEW

Capital Structure

The financial position of the Group remains sound and liquid. During the year under review, the financing and treasury policies of the Group were managed and controlled at the corporate level and prudent manner, to utilise the group funding and to manage the financial risks effectively. At 30 June 2017, the equity attributable to its owners amounted to HK\$1,978,078,000 (2016: HK\$1,902,346,000) with net asset value per share of HK\$8.79 (2016: HK\$8.48). Total unsecured and secured bank borrowings of the Group amounted to about HK\$143,290,000 (2016: HK\$149,593,000), which were in Hong Kong dollars and repayable within three years on floating rate basis. As at 30 June 2017, the gearing ratio of the Group was 7% (2016: 8%) based on the total debt of the Group to its equity attributable to owners of the Company. The exposure to foreign currency fluctuations of RMB against HK\$ affected the Group in the year resulting in net exchange loss of HK\$2,422,000 (2016: HK\$12,785,000) and no financial instruments were used for hedging purpose in the year. Meanwhile, the fluctuation of RMB may affect the financial performance and position of the Group, which the Group will continue to assess and minimise the adverse impact.

Financial Resources and Liquidity

In the year under review, there was sufficient cashflow as generated by rental revenue of investment properties in Shanghai and Beijing. As at 30 June 2017, the Group's fixed bank deposits and bank balance and cash stood at HK\$258,278,000 (2016: HK\$244,719,000), denominated primarily in RMB. With sufficient cashflow, the Group maintained an un-utilised credit facilities of HK\$15,000,000 (2016: HK\$11,000,000) as working capital at floating interest rate as at 30 June 2017.

Pledge of Assets and Contingent Liabilities

As at 30 June 2017, the Group pledged its properties with a total carrying value of HK\$882,569,000 (2016: HK\$835,410,000), an assignment of rental and sale proceeds from such properties and a charge over shares in respect of a wholly-owned subsidiary of the Company to financial institution as security against general banking facilities granted to the Group, and also pledged certain of its bank deposits in the sum of HK\$4,610,000 (2016: HK\$14,249,000) to banks to secure banking facilities and home loans granted to the home buyers of property project of the Group. As at the end of the reporting period, the Group provided guarantees in respect of settlement of home loans provided by banks to the home buyers of a property project in Beijing. As at 30 June 2017, the Group provided guarantees in respect of such home loans of HK\$2,959,000 (2016: HK\$8,800,000). The Directors of the Company consider that the fair values of these financial guarantee contracts at their initial recognition and at the end of the reporting period are insignificant on the basis of the low loan ratio.

展望

預期在採取官方貨幣政策以穩定人民幣匯率及國內投資下，中國國內經濟將會繼續以平穩步伐增長，而官方國家發展的高端服務業及重點關注國內消費，亦將持續支援辦公樓及零售業的租賃需求。

在北京，網上零售商的強烈競爭及零售空間供應的增加，將對於零售物業的租賃市場造成壓力。然而預期隨着中產階級的迅促發展所帶來的人均收入及支出的增長，將會支撐中檔及大眾市場之零售商。本集團將會致力積極優化租賃及市場策略，聚焦於以體驗為重點的品牌組合及特賣商店以應對不斷變化的消費趨勢，從而維持高佔用率及為本集團帶來穩定性收入。

在上海，預期金融業及專業行業將持續穩定承接以浦東作為金融樞紐的辦公樓市場。然而隨着優質辦公樓供應的湧入及辦公樓次市場的分散，將會限制租金增長。本集團將會採取具競爭性租賃策略，以維持高佔用率及固定經常性收入。

鑒於土地基建的不斷優化及周邊地帶的整體提升，本集團將持續積極維護本集團在圳華（作為本集團一項重要投資項目）的最佳利益。本集團將會持續採取最佳可實行之措施及權宜行動，包括但不限於上述仲裁，務求維護本集團在圳華的利益。然而，由於圳華清算所涉及事宜紛繁複雜，不僅牽涉中國法院；而且也涉及多個官方機構及其他有關聯方。就此，概不能保證清算不會遭受到重大延遲、反對、阻礙以及就圳華及／或其資產有進一步爭議及訴訟。

PROSPECTS

It is anticipated that the local economy of China will continue to grow in steady pace and that the official monetary policy will stabilise exchange rate of RMB and local investments, whereas the official national development of high-end service industry and focus on domestic consumption will sustain leasing demand of office and retail sectors.

In Beijing, strong competition from online retailers and increasing supply of retail space will put pressure on retail rental. However, it is expected that the burgeoning middle-class with growing disposable income and expenditure per capita will sustain mid-range and mass-market retailers. In order to maintain high occupancy rate and constant revenue to the Group, the Group will endeavor to proactively enhance leasing and marketing strategies, emphasising an experience-focused brand mix and outlet stores in response to the shifting consumption trends.

In Shanghai, it is expected that take-up of office market will remain stable in Pudong as financial hub and bolstered by demand from financial and professional sectors. But the rental growth will be constrained due to influx of premier office supply and decentralisation of office submarkets. To sustain high occupancy rate and steady recurring revenue, the Group will continue to adopt competitive rental strategies.

The Group will continue to act proactively for safeguarding the best interests of the Group in Zhen Wah as an important investment of the Group in view of the improving infrastructure and upgrading surrounding area of the Land. It will continue to adopt the best available measures and take expedient actions, including but not limited to the abovementioned arbitration, with a view to protecting the Group's interests in Zhen Wah. However, the issues involved in liquidation of Zhen Wah are complex and sophisticated, involving not only the PRC court but also various governmental authorities and other related parties. There is no assurance that the liquidation may not be subject to significant delay, oppositions, obstructions and further dispute or litigation with respect to the matters of Zhen Wah and/or its assets.

CORPORATE GOVERNANCE PRACTICES

The Board of Directors (the “**Board**”) and management of Dynamic Holdings Limited (the “**Company**”) strive to establish and uphold good practices and procedures on corporate governance. The corporate governance principles of the Company emphasize an effective Board, prudent risk management and internal control systems, transparency and accountability to its stakeholders including shareholders, customers, suppliers, employees and the public.

During the year ended 30 June 2017, being the financial year under review, the Board and the management of the Company have been continually reviewing and enhancing the corporate governance practices of the Company with reference to local and international best practices from time to time. The Board believes that its continued efforts in enhancing the Company’s corporate governance practices have contributed to sustain the business growth of the Company and its subsidiaries (the “**Group**”) in the past years.

For the year ended 30 June 2017, the Company has applied the principles and adhered to the code provisions as set out in the Corporate Governance Code (the “**CG Code**”) in Appendix 14 to the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) as amended from time to time and where appropriate, met the recommended best practices in the CG Code with an aim to safeguard the interests of the Company and its shareholders.

The Company has also established an internal corporate governance code (compliance guide) (the “**Internal CG Code**”), the contents of which are in line with the CG Code as revised from time to time according to the relevant amendments to the Listing Rules. The Internal CG Code aims to facilitate compliance with the CG Code and to give guidance to Directors of the Company (the “**Directors**”) and the senior management of the Company in this respect. The Board will continue to monitor and review the corporate governance practices and procedures of the Company to ensure compliance with the CG Code and to enhance its practices and procedures.

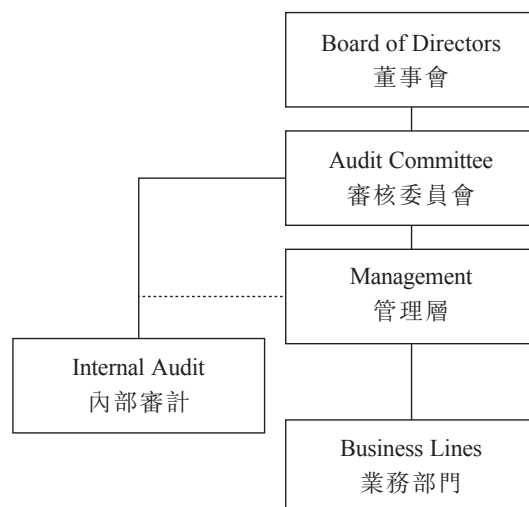
風險管理及內部監控

Risk Management and Internal Control

Risk is inherent in the Group's business and the markets in which it operates. To manage and monitor the various risk factors which the Company may be exposed, the Board is responsible for establishing and overseeing the Group's risk management and internal control systems on an ongoing basis, and ensuring the review of the effectiveness of the risk management and internal control systems has been properly conducted. The main features of these systems, which continue to operate, were described in this "Corporate Governance Report".

In view of the implementation of the consultation conclusions on risk management and internal control, relating to the Appendix 14 of the Listing Rules, issued by the Stock Exchange in December 2014, the Group has already reviewed its risk management framework and processes and has implemented relevant measures resulting from this exercise that aim to enhance its framework and processes. In particular, the Company has developed, approved and implemented a risk management system, which is defined and supported by its endorsed risk management policy. The terms of reference of the Audit Committee has included its responsibility for an effective system of risk management and internal control.

Risk Governance Structure

The governance structure of the Company for its risk management system is shown below. Each party has well defined and detailed roles and responsibilities.

風險評估方法

本公司的風險評估方法包括五個核心階段 (即風險識別、風險評估及優先排序、風險反應、風險監控及風險匯報)。該等流程每年最少進行一次，以就本集團業務環境的變化作出處理。

其主要涉及：

1. 風險識別

部門主管 (統稱為「**業務部門**」) 在日常業務中，識別其流程的潛在風險及其認為與本集團整體有關的風險。所有經識別的風險納入風險庫內。

2. 風險評估及優先排序

業務部門使用預先定義的風險評估標準對風險進行評估。使用定性和定量標準來衡量不同方面的風險。執行風險評分及優先排序流程。

3. 風險反應

所有風險庫提交內部審計和管理層審查。為每個選取的風險分配給風險責任人。風險責任人並就識別為重大的風險及與其責任有關的範疇，制定風險緩解計劃。

在確定適當風險緩解計劃時，一般可以採用四種類型的風險反應：接受、降低、分擔及迴避。

4. 風險監控

負責風險緩解計劃的風險責任人負責監控計劃的實施及有效性。風險責任人就風險管理流程的有效性和進展情況，以及風險緩解計劃的監控，向管理層提供定期更新。

5. 風險匯報

管理層應每年向審核委員會及董事會提交最終風險報告。

Risk Assessment Methodology

The methodology of the Company for its risk assessment comprises of five core stages (i.e. risk identification, risk assessment and prioritisation, risk responses, risk monitoring and risk reporting). These processes are performed at least once a year to address changes in the Group's business environment.

It mainly involves:

1. Risk Identification

Department heads (collectively referred as “**Business Lines**”) identify potential risks of their processes through daily operations as well as risks they believe are relevant to the Group as a whole. All the identified risks are consolidated into a risk inventory.

2. Risk Assessment and Prioritisation

Risks are evaluated by Business Lines using predefined risk assessment criteria. Both qualitative and quantitative criteria should be used to measure different aspects of the risks. Risk scoring and prioritisation process are performed.

3. Risk Response

All of the risk inventory are submitted to internal audit and management for review. Risk owners are assigned for each selected risk. Risk owners also formulate risk mitigation plans for the significant risks identified and relating to their areas of responsibility.

When determining appropriate risk mitigation plans, four types of risk response can generally be adopted: acceptance; reduction; sharing; and avoidance.

4. Risk Monitoring

Risk owners are responsible for monitoring the implementation and effectiveness of the risk mitigation plans which they are responsible for. Risk owners provide periodic updates on the effectiveness and progresses of the risk management processes and controls over risk mitigation plan to the management.

5. Risk Reporting

The management shall present the final risk report to the Audit Committee and the Board each year.

風險管理及內部監控系統可提供用以防止重大錯誤陳述或損失的合理而不絕對的保證，旨在管理而不是除去在達到業務目標過程中失誤的風險。根據年度檢討結果，董事會對本公司目前實施的風險管理及內部監控系統的有效性及其充分性，感到滿意及有信心。

Review on the Effectiveness of Risk Management and Internal Control Systems

For the year ended 30 June 2017, the Board and the Audit Committee have conducted and completed a review in respect of the effectiveness of the risk management and internal control systems of the Group. Such review conducts annually and covers all material controls including financial, operational and compliance controls, and risk management functions.

The Group has appointed Deloitte Advisory (Hong Kong) Limited to conduct independent review on the risk management and internal control systems of the Group for the year. The Group also has internal audit function and no material control failure or significant areas of concern or fraud which might affect the interests of the shareholders of the Company were identified during the reviews.

The risk management and internal control systems can provide reasonable and not absolute assurance against material misstatement or loss, and are designed to manage rather than eliminate the risk of failure in the process of attaining business objectives. Based on the results of the annual review, the Board is satisfied and confident with the effectiveness and adequacy of risk management and internal control systems currently put in place for the Company.

ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

環境、社會及管治報告書

達力集團有限公司及其附屬公司（「達力」、「本集團」、「我們」或「我們的」）謹此根據香港聯合交易所有限公司證券上市規則附錄二十七所載環境、社會及管治報告指引（「聯交所環境、社會及管治報告指引」），提呈二零一六年七月一日至二零一七年六月三十日期間（「呈報期」）之環境、社會及管治（「環境、社會及管治」）報告，旨在向持份者全面概述我們之環境、社會及管治政策、方案及績效。

董事會負責我們之環境、社會及管治策略及報告，而我們管理層負責監測及管理環境、社會及管治管理系統中有關環境、社會及管治之風險及成效。我們已通過審閱業務及舉行內部討論，落實我們之業務職能，以指出相關之環境、社會及管治問題，並評估其對我們業務及持份者之重要性。本環境、社會及管治報告已根據環境、社會及管治指引之一般披露要求，列出與重大環境、社會及管治問題相關之資料。

A. 環境

A1 排放物

本集團自成立以來一直致力於保護環境。本集團深知，物業項目開發過程中無可避免會出現氣體排放及其他排放，因此力求嚴格指導及監督承包商之環保措施。

此外，本集團已要求物業管理服務提供者於其工作計劃中考慮環境保護。每年評估供應商時，均會考慮環保措施、物業管理人員之環保工作、向租戶／客戶推廣之綠色生活方式等。

憑藉上述方案，加上本集團內部採購及管理流程顧及環保，本集團營運產生之污染及能源消耗將可大幅減少。

於呈報期內，並無注意到有關環保法律及規例之重大不合規情況。

In accordance with the Environmental, Social and Governance Reporting Guide (the “HKEx ESG Guide”) as set out in Appendix 27 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, Dynamic Holdings Limited and its subsidiaries (“Dynamic”, the “Group”, “we” or “our”) hereby presents our Environmental, Social, and Governance (“ESG”) Report for the period from 1 July 2016 to 30 June 2017 (the “Reporting Period”) with aims to provide stakeholders a comprehensive overview on our ESG policies, initiatives as well as performance.

The Board is responsible for our ESG strategy and reporting while our management is responsible for monitoring and managing ESG-related risks and the effectiveness of our ESG management systems. We have engaged our business functions to identify relevant ESG issues and to assess their materiality to our business as well as our stakeholders, through reviewing our operations and holding internal discussions. Disclosures relating to the material ESG issues identified have been included in this ESG Report pursuant to the General Disclosure requirements of the ESG Guide.

A. ENVIRONMENTAL

A1 Emissions

The Group has committed to environmental protection since its establishment. Knowing the fact that air emissions as well as other discharges are inevitable during property projects development, the Group strive to strictly guide and monitor contractor’s environmental protection measures.

In addition, the Group has required its property management service providers to take environmental protection into account in their work plan. Environmental protection measures, property management personnel’s environmental protection practices, promotion of green living style to tenants/customers, etc. will be considered during the annual vendor evaluation.

With the abovementioned initiatives, plus the environmental protection considerations in the Group’s internal procurement and administration processes, a significant reduction in pollutions and energy consumption from the Group’s operations can be achieved.

There were no material non-compliance cases noted in relation to environmental laws and regulations during the Reporting Period.

A1 排放物 (續)

排放及廢棄物管理

由於呈報期內，本集團並無任何物業發展項目，故於本年度並無產生任何氣體排放或有害廢棄物。

我們業務活動所產生之重大無害廢棄物主要是用於行政之辦公廢棄物，包括紙張、墨盒、墨粉、膠樽及即棄餐具。

溫室氣體則主要來自我們於辦公室及物業中之能源使用。我們已制定及實施內部政策，以減少能源消耗，從而減少碳足跡。請參閱以下「A2資源使用」一節。

本集團已減少使用及增加回收日常營運所產生之廢棄物，以保護天然資源。我們在營運中心及辦公室公共區域善用分類回收箱，以方便回收。此外，我們已減少打印，並且雙面打印內部文件。我們亦鼓勵以電話會議通訊取代商務差旅。

A2 資源使用

本集團致力於執行一套環保措施，以維持可持續發展，實現綠色商業運作。本集團確保所有業務活動及營運均符合節能原則，並且遵守所有環保相關政策及程序。

至於物業發展，本集團已將承包商採用之施工方法及設備納入招標過程中之承包商評估標準，並且首選採用綠色施工方法之承包商。甄選原材料供應商時亦沿用同樣理念，以優先選擇採用綠色材料之供應商。

A1 Emissions (Continued)

Emissions and waste management

Since the Group did not have any property development projects during the Reporting Period, we had neither generated any air emission nor produced any hazardous wastes during the year.

The major non-hazardous wastes produced from our business activities are mainly office wastes for administrative purposes, including paper, ink cartridge, toner, plastic bottle and disposal utensils.

For greenhouse gases, the major source is from the use of energy at our offices and properties. Internal policies have been developed and implemented to reduce energy usage for achieving a smaller carbon footprint. Please refer to the section of “A2 Use of Resources” below.

The Group has reduced the usage and increased the recycling of wastes generated from daily operations to protect natural resources. We have deployed recycling bins with classification at our operation centres and offices’ public area to facilitate recycling. Moreover, we have reduced printing and making use of duplex printing for internal documents. We also encouraged teleconference communication to replace business trips travelling.

A2 Use of Resources

The Group is dedicated to executing a set of environmentally friendly measures in order to maintain sustainability and achieve green commercial practices. The Group ensures all of its business activities and operations are in line with the principle of energy conservation, complying with all environmental protection related policies and procedures.

Regarding property development, the Group has incorporated construction methods and equipment adopted by the contractors into the contractor assessment criteria of the tendering process. Contractors adopt green construction practices are more preferable. The same concept will also be applied to raw materials supplier selection such that suppliers with green materials are more preferred.

此外，本集團之房地產項目已將環保要素納入建築設計，因此已採用環保建築設備以降低水電用量。

另一方面，本集團已在內部實施綠色管理體系，務求提升能源及資源效益，增進員工在節約能源及資源方面之意識。本集團已建立能源及資源運用報告機制，以監測資源使用情況、評估環保措施之成效及指出需要改善之處。

能源消耗

電力是我們於北京購物中心、上海辦事處單位及香港辦事處日常業務中主要消耗資源。為減少耗電，我們積極推動採購高能源效益設備，並要求同事實行綠色辦公。於呈報期內，我們已實施下列措施以減少能源消耗：

- 逐漸於辦公室以LED照明代替老化光管；
- 於午飯時間及離開辦公室前關掉空調及電器設備；
- 專職人員定期檢查及監督；
- 通過視頻會議及多方電話會議與客戶及附屬公司進行溝通；及
- 嚴格按照國家要求設定空調溫度，並進行定期檢查。

A2 Use of Resources (Continued)

Furthermore, the Group's real estate projects have embedded environmental protection elements into the building design such that environmentally friendly building equipment have been adopted to reduce electricity and water consumption.

On the other hand, the Group has implemented green management systems internally to improve energy and resources efficiency, and raise staff's awareness in energy and resources conservation. The Group has established energy and resources usage reporting mechanism to monitor the use of resources, and evaluate the effectiveness of environmental protection practices and identify improvement area.

Energy consumption

Electricity is the primary resource we consume in our daily operations in Beijing shopping mall, Shanghai office units and Hong Kong office. In order to reduce such consumption, we actively promote the procurement of energy efficient equipment and have required our colleagues to adopt green office practices. During the Reporting Period, we have implemented the following initiatives to reduce energy consumption:

- Gradually replacing aging light tubes with LED lighting at offices;
- Switching off air-conditioning and electric devices during lunch breaks and before leaving the offices;
- Conducting regular inspections and monitoring by dedicated staff;
- Communicating with clients and subsidiaries through video conferencing and multi-party teleconferencing; and
- Setting air conditioning temperature strictly in line with the national requirements and performing regular inspections.

A. 環境 (續)

A2 資源使用 (續)

耗水量

我們之耗水量主要包括僱員日常用水。為減少耗水量，於呈報期內，本集團已在洗手盆旁邊貼上標誌及通告，提高節水意識，並在水龍頭安裝感應器，以控制耗水量。

雖然在營運過程中並無使用實質包裝材料，但我們於客戶櫃檯展示環保海報，鼓勵客戶自備文件夾及袋子等。

A3 環境及天然資源

環境影響管理

本集團業務覆蓋北京、上海及深圳等中國各大主要城市，並重視企業社會責任，已於環保方案投入大量資源，以減少本集團業務對環境及天然資源造成之負面影響。本集團已嚴格遵守與環境相關之法規及國際標準。我們已將環保概念融入管理。本集團已實施環境監測系統，在日常營運中不斷評估及監測環境風險。

本集團會於房地產項目建設工程動工前，因應需要外聘專業顧問進行環境評估，並將有關結果交予承包商，由彼等作出相應回應。

此外，本集團已採用可持續綠色建築，以減少建築物在營運中對環境造成之影響。綠色方案例子包括具能源效益之設計（例如在牆上大開口，以改善通風及增加採光）以及綠化及美化特徵，該等設計及特徵可提高建築物用戶或設施使用者之生活質素。

A2 Use of Resources (Continued)

Water consumption

Our water consumption mainly comprised daily water usage of employees. To reduce water consumption, the Group has posted signs and notices by the washbasins to raise awareness towards water conservation and installed sensors at the water taps to control water consumption during the Reporting Period.

Although no substantial packaging materials are used during our operations, we have displayed environment protection poster at customer counters to encourage customer bringing their own folder, bags, etc.

A3 The Environment and Natural Resources

Environmental impact management

As the Group's businesses cover major cities in China such as Beijing, Shanghai and Shenzhen, the Group emphasises corporate social responsibility and has input massive resources in environmental protection initiatives so as to reduce the negative impacts on the environment and natural resources caused by the Group's business activities. The Group has strictly complied with all environment-related regulations and international standards. Concept of environmental protection has been assimilated into management. The Group has implemented an environment monitoring system to assess and monitor environmental risks continuously in daily operation.

The Group would engage external professional consultant in performing environmental assessments before the construction work of the real estate projects commences on a needed basis. The environmental assessment results were provided to the contractors for formulating corresponding responses.

Furthermore, the Group has adopted sustainable green architecture to reduce the buildings' impact on the environment during the operation. Examples of green initiatives include energy efficiency design (e.g. large openings on walls for better ventilation and use of daylight) and greening and landscaping features which can benefit the quality of life of the building occupants or users of the facilities.

B1 僱傭

本集團已制定符合中華人民共和國(「中國」)及香港僱傭法例之僱傭政策及指引。

招聘及晉升

本集團聘用及擢升認同本集團價值及職業道德之員工。本集團珍視主動、盡責及誠實之僱員，並以功績作為聘用及晉升標準。

薪酬

於二零一七年六月三十日，本集團於香港及中國大陸聘用約50名僱員(包括董事)，薪酬與現行市場水平相若，並包括僱員醫療保險、公積金計劃及認股權計劃等福利。

本集團之僱員薪酬政策由本集團薪酬委員會建議，基準為各自功績、責任及職務、表現、資歷及能力，並考慮到市場可比較水平、本集團經營業績、董事會企業目標及宗旨，以及相關法律規定、條文、指引及監管團體之推薦建議。

本集團各董事薪酬由本集團薪酬委員會參考本集團經營業績、企業目標及宗旨、個別工作表現及職責以及市場可比較統計後建議。本集團已採納認股權計劃以鼓勵董事及合資格僱員。

本集團員工之薪酬及其他福利待遇參照地方行業平均水平釐定。經驗及資格亦在考慮之列。釐定僱員薪金待遇時亦採用關鍵績效指標(視員工職位而定)衡量員工表現以作鼓勵。

解僱

解僱乃基於本集團行為守則作出。所有解僱依照中國勞工法及香港僱傭條例執行。

B. SOCIAL

B1 Employment

The Group has established employment policies and guidelines that are compliant with the People's Republic of China (the "PRC") and Hong Kong Employment Laws.

Recruitment and promotion

The Group hires and promotes staff who share the Group's values and work ethics. The Group treasures those who demonstrate initiative, responsibility and integrity. Hiring and promotion are based on merit.

Emolument

At 30 June 2017, the Group had about 50 employees (including directors) in Hong Kong and the mainland China at prevailing market remuneration with employee benefits such as medical insurance, provident fund schemes and share option schemes.

The emolument policy of the employees of the Group is recommended by the remuneration committee of the Group on the basis of the respective merits, responsibilities and duties, performance, qualifications and competence taking into account of comparable market level, operating results of the Group, corporate goals and objectives of the Board of Directors and relevant legal requirements, provisions, guidelines and recommendations of regularly bodies.

The emoluments of the respective Directors of the Group are recommended by the remuneration committee of the Group, having regard to the operating results of the Group, corporate goals and objectives, individual performance and responsibility and comparable market statistics. The Group has adopted share option schemes as incentive to Directors and eligible employees.

The Group's staff remuneration and other fringe benefits are referenced against local industrial averages. Experience and qualifications are also taken into account. Key Performance Indicators, depending on staff position, are adopted to measure staff performance in determining staff packages to incentivise.

Dismissal

Dismissals are based on the Group's code of conducts. All dismissals are carried out in accordance with the PRC Labour Law and Hong Kong Employment Ordinance.

B1 僱傭 (續)

平等機會、多元化發展及反歧視

本集團著重人力資本多元化，並反對任何類型歧視。本集團確保所有人力資源政策及程序均體現平等機會，而不論性別、懷孕、婚姻狀況、殘疾、家庭狀況及種族。

工作時數、假期以及其他待遇及福利

工作時數、假期以及其他待遇及福利參照地方行業平均水平釐定。經驗、資格及資歷亦在考慮之列。本集團確保此等常規依照本地適用之人力資源(「人力資源」)相關法規。

於呈報期內，並無注意到任何有關本集團勞工常規之重大不合規問題。

B2 健康與安全

工作場所健康與安全

本集團承諾為其員工提供安全、健康、舒適及有效率的工作環境。為確保工作環境健康安全，多項工作場所安全海報、培訓課程及指引等行政措施已落實。所有受傷個案不論嚴重程度，均須向總部匯報，以根據內部政策及程序作進一步評估，從而確保妥善處理有關個案及執行防範措施。

作為盡責僱主，全體員工均享有各種福利，包括本集團之醫療及人壽保險，以及其他具競爭力之福利待遇。

B1 Employment (Continued)

Equal opportunity, diversity, anti-discrimination

The Group emphasises human capital diversity, and is against any kind of discrimination. The Group ensures equal opportunities in all of its human resources policies and procedures, regardless of gender, pregnancy, marital status, disability, family status, and race.

Working hours, rest periods, and other benefits and welfare

Working hours, rest periods and other benefits and welfare are determined with reference to local industrial averages. Experience, qualification and seniority are taken into account as well. The Group ensures all these practices are in compliance with the applicable local Human Resources (“HR”) related regulations.

There were no material non-compliance issues noted regarding our labour practices during the Reporting Period.

B2 Health and Safety

Workplace health and safety

The Group is committed to providing a safe, healthy, pleasant and effective work environment for its staff. In order to ensure the working environment is healthy and safe, various administrative measures such as workplace safety posters, training courses and guidelines have been implemented. Regardless of seriousness, all cases of injury are required to be reported to the head office for further assessment under the internal policies and procedures so as to ensure proper handling of the cases and execution of preventive measures.

As a responsible employer, all staff are entitled to benefits including Group medical and life insurance as well as other competitive fringe benefits.

工作場所健康與安全 (續)

由於本集團承包商之工作環境(即建築地盤)屬高危性質,故此本集團要求所有承包商為其員工提供充分培訓,並持續監察健康及安全事宜。本集團亦已對承包商之健康與安全常規進行定期調查。

於呈報期內,並無注意到任何有關健康及安全法律法規之重大不合規情況。

B3 發展及培訓

僱員發展及培訓

本集團已制訂全面之培訓政策及系統支援僱員之在職培訓及教育,從而增進僱員之知識及技能。本集團之培訓包括新入職培訓、在職培訓及外部培訓。新入職培訓包括行為守則、職業道德、組織架構、工作場所之健康與安全、質素期望等範疇。在職培訓包括職責理論及常規。外部培訓包括所有特定職位必須修讀之專業課程。僱員為履行職責所需而支付之一切外部培訓課程費用均由本集團承擔。

本集團為擁有不同事業抱負之僱員提供不同事業發展計劃。本集團按照工作性質,規劃最適合之仕途及相關培訓,以培育有潛質之員工。此外,本集團為員工提供不同職能及職位之輪調機會,以拓展彼等視野及能力。我們亦為需要參加外部培訓課程之僱員提供特殊假期及財政補貼(如適用)。

Workplace health and safety (Continued)

As for the Group's contractors, in light of the high risk nature of their work environment (i.e. construction sites), the Group requires all contractors to provide adequate and sufficient training to their staff and monitor health and safety issues on an on-going basis. The Group has also performed regular inspections on contractors' health and safety practices.

There were no material non-compliance cases noted in relation to health and safety laws and regulations during the Reporting Period.

B3 Development and Training

Employee development and training

The Group has comprehensive training policy and system to support employees' on-the-job training and education so as to improve employees' knowledge and skills. The Group's training includes new hire orientation, on-the-job training and external training. New hire orientation includes code of conducts, work ethics, organisational structure, workplace health and safety, quality expectation, etc. On-the-job training includes job duties theories and practices. External training includes all professional courses necessary for particular job positions. The costs of all external training courses necessary for the employees in carrying out their job duties are borne by the Group.

The Group offers various career development plan for employees with different career aspirations. Based on the job nature, the Group formulates the most suitable career path and relevant training to cultivate potential staff. In addition, the Group provides rotation opportunities to staff for different functions and positions so as to enrich their horizons and capabilities. We also provide special leave and financial subsidies for employees to attend external training courses, where appropriate.

B4 勞工準則

反童工及強制勞工

本集團所有附屬公司及辦事處均嚴格遵守當地監管規定，並明確禁止童工及強制勞工。人力資源部門須核實每名求職者之身份證明文件，以確保申請人符合資格。雙方會簽訂僱傭合約以確保相互同意僱傭條款。

此外，本集團與承包商訂立之合約協議條款已規定，承包商人力資源政策及程序須遵守地方人力資源相關法規（例如中國勞工法及香港僱傭條例）。

本集團已對其附屬公司、地方辦事處及承包商進行定期調查，確保概無不符合相關法規之情況。

於呈報期內，並無注意到任何有關法律及法規規定之勞工準則之重大不合規問題。

B5 供應鏈管理

責任採購

供應鏈管理一直以來是本集團質素監控之關鍵步驟。本集團在甄選供應商時實施嚴格甄選標準。供應商須持有所有由相關政府機構發出之所需牌照。本集團在與供應商訂立協議前已對供應商進行產品質素測試及實地勘察。此外，總採購協議已包含有關環境及社會責任之條款及條件。

本集團已為承包商制定一個全面之招標制度，當中設有一套用作評估承包商之評核準則，包括背景、規模、建築素質、環境保護、人力資源常規、社區參與等。此制度確保只有符合我們環境保護及社區貢獻準則之承包商可獲選。

B4 Labour Standards

Anti-child and forced labour

All of the Group's subsidiaries and offices strictly comply with the local regulatory requirements, explicitly prohibit child and forced labour. HR departments are required to verify every job applicant's identification document to ensure eligibility. Employment contracts are signed by both parties to ensure mutual agreement on the terms of employment.

Furthermore, the Group has included terms in the contracting agreements requiring that contractors' human resources policies and procedures have to comply with the local HR related regulations (e.g. PRC Labour Law and Hong Kong Employment Ordinance).

The Group has performed regular inspections on its subsidiaries, local offices and contractors to ensure there was no non-compliance in the relevant regulations.

There were no material non-compliance issues noted regarding labour standards as required by related laws and regulations during the Reporting Period.

B5 Supply Chain Management

Responsible procurement

Supply chain management has long been the Group's key step in quality control. The Group implements strict selection criteria in supplier selection. Suppliers have to possess all necessary licenses issued by relevant government authorities. The Group has performed product quality test and on-site inspection on the suppliers before entering into agreement with suppliers. Moreover, terms and conditions regarding environment and social responsibilities are included in the master procurement agreements.

As for contractors, the Group has established a comprehensive tendering system. The system includes a set of assessment criteria for evaluating contractors, including background, size, construction quality, environmental protection, human resources practices, community involvement, etc. This system ensures only contractors meeting our requirements on environmental protection and community contribution can be selected.

B6 產品責任

產品及服務質素

本集團致力提供優質之房地產物業滿足客戶需要。本集團持續適當地披露有關建築、採購、銷售及服務程序之產品及服務資料，並採取適當保安措施確保資料保密。銷售與推廣文件及本集團產生之資料均遵守相關法規(即香港商品說明條例及中國廣告法)。本集團絕不容忍誇大或失實說明，並且已實施完善客戶反饋機制，確保能收集客戶對我們物業及服務之建議及意見以作跟進。

與此同時，本集團已不斷監控質素及定期評估承包商及供應商。如承包商／供應商資格有明顯變化或出現嚴重質素問題，本集團可停止與相關承包商／供應商進行之交易以確保本集團項目質素。

本集團著重保障私隱及個人資料保密之重要性，其在收集、處理及使用個人資料時，致力保護客戶、最終承包商擁有人及僱員。根據個人資料(私隱)條例，我們禁止其他各方在並無明確及默許之同意下，使用我們之客戶、最終承包商擁有人及僱員之個人資料。

於呈報期內，並無注意到任何有關產品與服務質素及資料私隱之重大不合規問題。

B. SOCIAL (Continued)

B6 Product Responsibility

Product and service quality

The Group exerts itself in providing high quality real estate properties to satisfy customers' needs. The Group maintains proper disclosures for product and service information regarding the construction, procurement, sales and servicing processes; and proper security measures to ensure confidentiality of information. The sales and promotion documents and data produced by the Group are in compliance with relevant regulations (i.e. Hong Kong Trade Descriptions Ordinance and Advertisements Law of PRC). No exaggeration or untrue descriptions are tolerated. The Group has also established comprehensive customer feedback mechanism. Such mechanism ensures customers' advices and opinions on our properties and services can be collected for follow-up accordingly.

Meanwhile, the Group has conducted on-going quality monitoring as well as regular assessments on its contractors and suppliers. If there is substantial change in contractors/suppliers' eligibility or significant quality issues, the Group can halt the transactions with the relevant contractors/suppliers so as to ensure the quality of the Group's projects.

The Group emphasises the importance of protecting the privacy and confidentiality of personal data. It strives to protect the privacy of its customers, ultimate owners of contractors and employees in the collection, processing and use of their personal data. Pursuant to Personal Data (Privacy) Ordinance, we have prohibited the use of any personal information of our customers, ultimate owners of contractors and employees by other parties without explicit and implicit consent.

During the Reporting Period, there were no material non-compliance issues noted regarding product and service quality, and data privacy.

B7 反貪污

Other than the internal anti-bribery and corruption guidelines as stipulated in the Group's code of conducts, the Group has also established whistle blowing mechanism to guide stakeholders in reporting any irregularities or misbehaviour.

The Group has performed regular internal audit to identify internal control deficiencies and remedy accordingly.

During the Reporting Period, there were no material non-compliance issues noted regarding corruption and money laundering.

Community programmes and donation

The Group is committed to enhancing the community's well-being and social services. The Group strives to utilise its resources in contributing to the society.

In addition, several Directors and senior management personnel of the Group have engaged in public offices to contribute their efforts. The Group's management also takes initiative in motivating staff to join community activities, which are held in support of its commitment to sustainable development. The Group hopes to raise staff's awareness on the community issues, instil the concept of serving the community in both their work and personal life.

The Directors have pleasure in presenting their report and the audited consolidated financial statements for the year ended 30 June 2017.

主要業務

本公司乃一間投資控股公司，其主要附屬公司之業務為物業投資及物業發展。

主要附屬公司之主要業務載於綜合財務賬項附註第32項內。

業務回顧

本集團的收入主要來自於中國大陸進行的商業租賃業務。本集團於本年度以經營分類作表現分析載於綜合財務賬項附註第5項內。

本集團的中肯業務回顧載於本年報的「主席報告書」內，其中包括運用財務主要表現指標對本集團表現進行的分析、本集團面臨的主要風險及不確定因素、自財政年終後發生影響本集團的重大事項（如有）以及預期日後發展。資本風險管理及財務風險管理詳情分別載於綜合財務賬項附註第29及30項內。

本集團致力於支持環境的可持續發展，及努力遵守有關環保的法律及法規並採取措施以達致資源有效利用、節能及減排。本集團的環境政策及表現的探討載於「環境、社會及管治報告書」內。

於本年度內，本集團已遵守對本集團經營有重大影響的相關法律及法規。

本集團致力於與僱員、客戶和供應商建立密切關係，並加強與業務夥伴的合作。詳情載於「環境、社會及管治報告書」內。

PRINCIPAL ACTIVITIES

The Company acts as an investment holding company. The activities of its principal subsidiaries are property investment and development.

The principal activities of the principal subsidiaries are set out in note 32 to the consolidated financial statements.

BUSINESS REVIEW

The Group's revenue is derived primarily from rental business activities conducted in the mainland China. An analysis of the Group's performance for the year by operating segment is set out in note 5 to the consolidated financial statements.

A fair review of the Group's business, including an analysis of the Group's performance using financial key performance indicators, principal risks and uncertainties facing the Group, the important events (if any) affecting the Group that have occurred since the end of the financial year and the likely future developments, is set out in the "Chairman's Statement" of this Annual Report. Details of capital risk management and financial risk management are set out in notes 29 and 30 to the consolidated financial statements respectively.

The Group is committed to support sustainability of the environment and endeavours to comply with laws and regulations regarding environmental protection and to adopt measurement to achieve efficient use of resources, energy saving and waste reduction. A discussion of the Group's environmental policies and performance is set out in the "Environmental, Social and Government Report".

During the year, the Group has complied with the relevant laws and regulations that have significant impact on the operations of the Group.

The Group is committed to establishing a close and caring relationship with our employees, customers and suppliers and enhancing collaboration with our business partners. Details are set out in the "Environmental, Social and Governance Report".

RESULTS AND APPROPRIATIONS

The results of the Group for the year ended 30 June 2017 are set out in the consolidated statement of profit or loss and other comprehensive income on page 57.

On 9 January 2017, a final dividend of 3 Hong Kong cents per share was paid to the Company's shareholders as a final dividend for the year ended 30 June 2016.

An interim dividend of 2.5 Hong Kong cents per share amounting to HK\$5,627,000 was paid to the shareholders of the Company during the year. The Directors now recommend the payment of a final dividend of 3 Hong Kong cents per share amounting to HK\$6,752,000 payable to the shareholders of the Company whose names appear on the register of members of the Company on 22 December 2017 which, in aggregate, will give a total of dividends for the year ended 30 June 2017 of 5.5 Hong Kong cents per share.

PROPERTY, PLANT AND EQUIPMENT AND INVESTMENT PROPERTIES

The increase in the fair value of the investment properties which has been credited to the consolidated statement of profit or loss and other comprehensive income amounted to HK\$92,896,000.

Details of these and other movements in the property, plant and equipment and investment properties of the Group are set out in notes 13 and 14 to the consolidated financial statements, respectively.

SHARE CAPITAL

Details of movement in the share capital of the Company during the year are set out in note 21 to the consolidated financial statements.

During the year, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the Company's listed securities.

Subject to the applicable laws, every Director of the Company shall be entitled to be indemnified by the Company against all actions, costs, charges, losses, damages and liabilities incurred by him or her in the course of his or her duties or in relation thereto pursuant to its by-laws of the Company. Such provisions were in force during the course of the year and remained in force as at the date of this report. The Company has arranged for appropriate insurance cover for Directors' and officers' liabilities in respect of legal action against its Directors and senior management arising out of corporate activities.

We have audited the consolidated financial statements of Dynamic Holdings Limited (the “Company”) and its subsidiaries (collectively referred to as the “Group”) set out on pages 57 to 133, which comprise the consolidated statement of financial position as at 30 June 2017, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 30 June 2017, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (“the HKICPA”) and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing (“HKSA”) issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA’s Code of Ethics for Professional Accountants (the “Code”), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We identified the valuation of investment properties as a key audit matter due to the significance of the balance to the consolidated financial statements as a whole, combined with significant judgements associated with determining the fair value.

我們認為投資物業估值為關鍵審核事項，乃由於投資物業在整體綜合財務賬項中所佔之金額重大，加上釐定公平值時涉及重大判斷。

The investment properties of the Group represented commercial and car parking portion and office units located in the People's Republic of China (the "PRC"). As at 30 June 2017, the Group's investment properties amounted to HK\$1,990,736,000, representing approximately 76% of the Group's total assets. During the year, an increase in fair value of investment properties of HK\$92,896,000 was recognised in profit or loss.

貴集團的投資物業乃位於中華人民共和國（「中國」）的商業及停車場部分以及辦公樓。於二零一七年六月三十日，本集團投資物業總額為港幣1,990,736,000元，佔本集團資產總值約76%。於年度內，投資物業公平值增加港幣92,896,000元已於損益內確認。

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

1. 概述

達力集團有限公司(「本公司」)乃在百慕達註冊成立之受豁免有限公司，其股份在香港聯合交易所有限公司(「聯交所」)主板上市。本公司註冊辦事處及主要營業地點已載列於年報內標題為「公司及投資者資料」一節。

本公司為一間投資控股公司，其附屬公司之主要業務詳情載於附註第32項內。

本公司之功能貨幣為人民幣(「人民幣」)。本公司董事考慮本公司上市地點而認為港幣(「港幣」)為最適合之呈列貨幣，故綜合財務賬項以港幣呈列。

Dynamic Holdings Limited (the “Company”) was incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The address of the registered office and principal place of business of the Company are disclosed in the section headed “Corporate and Investors Information” in the annual report.

The Company acts as an investment holding company. Details of the principal activities of its subsidiaries are set out in note 32.

The Company’s functional currency is Renminbi (“RMB”). The consolidated financial statements are presented in Hong Kong dollars (“HK\$”) as the Directors of the Company consider that Hong Kong dollar is the most appropriate presentation currency in view of the Company’s place of listing.

香港財務報告準則第9號「金融工具」

香港財務報告準則第9號引入有關金融資產、金融負債、一般對沖會計方法之分類及計量之新規定，以及金融資產之減值規定。

香港財務報告準則第9號之主要規定概述如下：

- 於香港財務報告準則第9號範圍內已確認之金融資產，其後按攤銷成本或公平值計量。具體而言，旨在為以收取合約現金流量之業務模式下持有之債務投資；及該合約現金流量主要用作支付本金及未付本金之利息之債務投資，一般於其後之會計報告日按攤銷成本計量。旨在為同時收回合約現金流及出售金融資產之業務模式內持有之債務工具，以及其合同條款以致於指定日期產生之現金流量僅為支付尚未償還本金額之本金和利息之債務工具，乃按公平值於其他全面收入(「其他全面收入之公平值」)計量。所有其他債務投資及股本權益投資於其後報告日按公平值計量。此外，根據香港財務報告準則第9號，實體可作出不可撤回之選擇，於其他全面收入中呈列股本權益投資(非持作買賣)其後公平值之變動，惟僅股息收入一般確認於損益中。
- 就指定為按公平值列賬計入損益之金融負債而言，香港財務報告準則第9號規定，該金融負債因信貸風險變動引致其公平值變動之數額，除非於其他全面收入中確認該負債之信貸風險變動之影響會導致或擴大於損益中之會計錯配，否則須於其他全面收入中呈列。金融負債之信貸風險而引致公平值變動其後不會重新分類至損益中。根據香港會計準則第39號，指定按公平值列賬計入損益之金融負債之公平值變動，均全數呈列於損益中。

HKFRS 9 “Financial Instruments”

HKFRS 9 introduces new requirements for the classification and measurement of financial assets, financial liabilities, general hedge accounting and impairment requirements for financial assets.

Key requirements of HKFRS 9:

- all recognised financial assets that are within the scope of HKFRS 9 are required to be subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent accounting periods. Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms that give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are generally measured at fair value through other comprehensive income (“FVTOCI”). All other debt investments and equity investments are measured at their fair value at the end of subsequent accounting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- with regard to the measurement of financial liabilities designated as at fair value through profit or loss, HKFRS 9 requires that the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is presented in other comprehensive income, unless the recognition of the effects of changes in the liability’s credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value attributable to a financial liability’s credit risk are not subsequently reclassified to profit or loss. Under HKAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss is presented in profit or loss.

- 就金融資產減值而言，與根據香港會計準則第39號按已產生信貸虧損模式計量相反，香港財務報告準則第9號規定按預期信貸虧損模式計量。預期信貸虧損模式規定實體於各報告日將預期信貸虧損及該等預期信貸虧損之變動入賬，以反映信貸風險自首次確認以來之變動。換言之，毋須待發生信貸事件即可確認信貸虧損。
- 新訂之一般對沖會計方法規定保留目前香港會計準則第39號之三類對沖會計處理手法。根據香港財務報告準則第9號，對可作對沖會計方法之各類交易引入更大靈活性，特別地擴闊合資格作為對沖工具之工具類別及可作對沖會計之非金融項目之風險成份類別。此外，對沖成效追溯評估已被移除。有關實體風險管理活動之優化披露規定亦已引入。

根據本集團於二零一七年六月三十日金融工具及風險管理政策，將來應用香港財務報告準則第9號可能對本集團金融資產之分類及計量產生重大影響。本集團之可供出售之投資，包括現在按成本扣減值列賬之可供出售之投資，會以公平值列賬並計入損益，或在符合指定要求下指定為按其他全面收入之公平值計量。此外，預期信貸虧損模式可能導致集團按攤銷成本計量之金融資產於尚未產生信貸虧損前作出提早撥備。

HKFRS 9 “Financial Instruments” (Continued)

- in relation to the impairment of financial assets, HKFRS 9 requires an expected credit loss model, as opposed to an incurred credit loss model under HKAS 39. The expected credit loss model requires an entity to account for expected credit losses and changes in those expected credit losses at each reporting date to reflect changes in credit risk since initial recognition. In other words, it is no longer necessary for a credit event to have occurred before credit losses are recognised.
- the new general hedge accounting requirements retain the three types of hedge accounting mechanisms currently available in HKAS 39. Under HKFRS 9, greater flexibility has been introduced to the types of transactions eligible for hedge accounting, specifically broadening the types of instruments that qualify for hedging instruments and the types of risk components of non-financial items that are eligible for hedge accounting. In addition, the retrospective quantitative effectiveness test has been removed. Enhanced disclosure requirements about an entity’s risk management activities have also been introduced.

Based on the Group’s financial instruments and risk management policies as at 30 June 2017, application of HKFRS 9 in the future may have a material impact on the classification and measurement of the Group’s financial assets. The Group’s available-for-sale investments, including those currently stated at cost less impairment, will either be measured as fair value through profit or loss or be designated as FVTOCI (subject to fulfillment of the designation criteria). In addition, the expected credit loss model may result in early provision of credit losses which are not yet incurred in relation to the Group’s financial assets measured at amortised cost.

香港財務報告準則第15號「客戶合約之收入」

香港財務報告準則第15號已經頒佈，其制定一項單一全面模式供實體用作將自客戶合約所產生之收入入賬。於香港財務報告準則第15號開始生效時，其將取代現時之收入確認指引，包括香港會計準則第18號「收入」、香港會計準則第11號「建築合約」及相關詮釋。

香港財務報告準則第15號之核心原則，為實體所確認向客戶轉讓承諾貨品或服務之收入金額，應為能反映該實體預期就交換該等貨品或服務有權獲得之代價。具體而言，該準則引入五個確認收入之步驟：

- 第一步：識別與客戶之合約
- 第二步：識別合約中之履約責任
- 第三步：釐定交易價格
- 第四步：分攤交易價格至合約中之履約責任
- 第五步：於實體完成履約責任時(或就此)確認收入

根據香港財務報告準則第15號，實體於完成履約責任時(或就此)確認收入，即於特定履約責任相關之貨品或服務之「控制權」轉讓予客戶時。香港財務報告準則第15號已就特別情況之處理方法加入更明確指引。此外，香港財務報告準則第15號規定作出更廣泛披露。

於二零一六年，香港會計師公會頒佈香港財務報告準則第15號之澄清，其有關履約義務之辨認、主理人與代理人之考量及授權之應用指引。

本公司董事預期，日後應用香港財務報告準則第15號可能導致更多披露，然而，本公司董事並未預期應用香港財務報告準則第15號將會對在相關呈報期內確認收入的時間和金額構成重大影響。

HKFRS 15 “Revenue from Contracts with Customers”

HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 “Revenue”, HKAS 11 “Construction Contracts” and the related interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for goods and services. Specifically, the standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, that is when “control” of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

In 2016, the HKICPA issued Clarifications to HKFRS 15 in relation to the identification of performance obligations, principal versus agent considerations as well as licensing application guidance.

The Directors of the Company anticipate that the application of HKFRS 15 in the future may result in more disclosures, however, the Directors of the Company do not anticipate that the application of HKFRS 15 will have a material impact on the timing and amounts of revenue recognised in the respective reporting periods.

香港財務報告準則第16號「租賃」

香港財務報告準則第16號就辨認出租人及承租人之租賃安排及會計處理引入一個全面模式。倘香港財務報告準則第16號生效時，其將取代香港會計準則第17號「租賃」及其相關詮釋。

香港財務報告準則第16號根據可識別之資產是否由客戶控制來區分租賃及服務合約。經營租賃及融資租賃之差異自承租人會計處理中移除，並由承租人須就所有租賃確認使用權資產及其相應負債之模式替代，惟短期租賃及低價值資產租賃除外。

使用權資產初步按成本計量，其後以成本(惟若干例外情況除外)減累計折舊及減值虧損計量，並就租賃負債之任何重新計量而作出調整。租賃負債初步按當日尚未支付之租賃款項之現值計量。其後，因應利息及租賃款項以及租賃修訂之影響等而對租賃負債作出調整。就現金流量分類而言，本集團目前將有關自用之租賃土地和該等分類為投資物業之租賃土地之前期預付土地租賃款項呈列為投資現金流量，其他經營租賃款項則呈列為經營現金流量。根據香港財務報告準則第16號，有關租賃負債之租賃款項將分配至本金及利息部分，並以融資現金流量呈列。

根據香港會計準則第17號，本集團已確認融資租賃安排之一項資產，以及租賃土地之預付租賃款項(本集團為承租人)。應用香港財務報告準則第16號可能導致該等資產在分類上的潛在變動，取決於本集團個別或一併呈列使用權資產，即在擁有對應相關資產情況下所獲呈列者。

2. APPLICATION OF NEW AND AMENDMENTS TO HONG KONG FINANCIAL REPORTING STANDARDS (“HKFRSs”) (Continued)

HKFRS 16 “Leases”

HKFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. HKFRS 16 will supersede HKAS 17 “Leases” and the related interpretations when it becomes effective.

HKFRS 16 distinguishes lease and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the Group currently presents upfront prepaid lease payments as investing cash flows in relation to leasehold lands for owned use and those classified as investment properties while other operating lease payments are presented as operating cash flows. Under HKFRS 16, lease payments in relation to lease liability will be allocated into a principal and an interest portion which will be presented as financing cash flows.

Under HKAS 17, the Group has already recognised an asset for finance lease arrangement and prepaid lease payments for leasehold lands where the Group is a lessee. The application of HKFRS 16 may result in potential changes in classification of these assets depending on whether the Group presents right-of-use assets separately or within the same line item at which the corresponding underlying assets would be presented if they were owned.

2. 應用新訂及經修訂香港財務報告準則 (「香港財務報告準則」)
(續)

香港財務報告準則第16號「租賃」(續)

相對於承租人會計處理，香港財務報告準則第16號大致轉承了香港會計準則第17號之出租人會計處理規定，並繼續要求出租人將其租賃分類為經營租賃或融資租賃。

此外，香港財務報告準則第16號規定更全面之披露。

於二零一七年六月三十日，本集團作為承租人就不可撤銷經營租賃之承擔為港幣1,402,000元。初步評估顯示該等安排將符合香港財務報告準則第16號項下租賃界定，因此，本集團將確認使用權資產及其有關該等租賃之相應負債，除非其於應用香港財務報告準則第16號時符合低價值或短期租賃。此外，應用新規定可能導致如上文所示計量、呈列及披露變動。然而，除非本集團已進行詳盡審閱，否則提供財務影響之合理估計並不可行。

香港會計準則第7號(修訂本)「披露動議」

該修訂本要求實體作出披露，使財務報表的使用者可評估融資活動所引致的負債變動，包括現金流量引致的變動及非現金變動。尤其是，該修訂本規定披露下列因融資活動所引致的負債變動：(i)融資現金流量的變動；(ii)獲得或失去對附屬公司或其他業務的控制所引致的變動；(iii)外匯匯率變動的影響；(iv)公平值的變動；及(v)其他變動。

該修訂本於二零一七年一月一日或之後開始之未來的年度期間應用，惟允許提早應用。該修訂本的應用將會導致需對本集團的融資活動作出額外的披露，特別是於應用時將須於綜合財務狀況表中提供就融資活動所產生的期初及期末負債結餘的對賬。

除此之外，董事預期應用其他新訂及經修訂香港財務報告準則將不會對財務表現及狀況及／或本集團綜合財務賬項之披露構成重大影響。

HKFRS 16 “Leases” (Continued)

In contrast to lessee accounting, HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by HKFRS 16.

As at 30 June 2017, the Group has non-cancellable operating lease commitments of HK\$1,402,000. A preliminary assessment indicates that these arrangements will meet the definition of a lease under HKFRS 16, and hence the Group will recognise a right-of-use asset and a corresponding liability in respect of all these leases unless they qualify for low value or short-term leases upon the application of HKFRS 16. In addition, the application of new requirements may result changes in measurement, presentation and disclosure as indicated above. However, it is not practicable to provide a reasonable estimate of the financial effect until the Group performs a detailed review.

Amendments to HKAS 7 “Disclosure Initiative”

The amendments require an entity to provide disclosures that enable users of financial statements to evaluate changes in liabilities arising from financing activities including both changes arising from cash flows and non-cash changes. Specially, the amendments require the following changes in liabilities arising from financing activities to be disclosed: (i) changes from financing cash flows; (ii) changes arising from obtaining or losing control of subsidiaries or other businesses; (iii) the effect of changes in foreign exchange rates; (iv) changes in fair values; and (v) other changes.

The amendments apply prospectively for annual periods beginning on or after 1 January 2017 with earlier application permitted. The application of the amendments will result in additional disclosures on the Group’s financing activities, specifically reconciliation between the opening and closing balances in the consolidated statement of financial position for liabilities arising from financing activities will be provided on application.

Other than that, the Directors anticipate that the application of other new and amendments to HKFRSs will have no material impact on the financial performance and position and/or the disclosures of the Group’s consolidated financial statements.

本綜合財務賬項乃根據香港會計師公會所頒佈之香港財務報告準則編製。此外，綜合財務賬項已包括聯交所證券上市規則及香港公司條例所規定的適用披露。

本綜合財務賬項乃根據歷史成本法編製，惟以公平值計量之投資物業則除外，其會計政策闡述如下。

歷史成本一般乃根據貨物或服務交易代價的公平值。

公平值為於計量日期在市場參與者之間進行的完整交易所出售資產可收取或轉讓負債須支付的價格，不論該價格是否直接觀察或使用另一估值技術估計所得。在釐定一項資產或負債的公平值時，本集團會考慮該等市場參與者於計量日期對資產或負債定價時所考慮的資產或負債的特點。於綜合財務賬項中作計量及／或披露用途的公平值乃按此基準釐定，惟屬於香港財務報告準則第2號「以股份為基礎之付款」範疇的以股份為基礎付款交易、屬於香港會計準則第17號「租賃」範疇的租賃交易以及其計量與公平值存在一些相似之處但並非公平值（例如香港會計準則第2號「存貨」的可變現淨值或香港會計準則第36號「資產減值」的使用價值）除外。

非金融資產的公平值計量計入市場參與者透過使用其資產的最高及最佳用途或透過將資產出售予將使用其最高及最佳用途的另一名市場參與者，而能夠產生經濟利益的能力。

此外，就財務申報目的而言，公平值計量根據公平值計量輸入數據的可觀察程度及輸入數據對公平值計量的整體重要性劃分為第一、第二或第三級，描述如下：

- 第一級輸入數據為實體可於計量日期獲取的相同資產或負債於活躍市場的報價（未經調整）；
- 第二級輸入數據為資產或負債的可直接或間接觀察所得輸入數據（第一級包括的報價除外）；及
- 第三級輸入數據為資產或負債的不可觀察所得輸入數據。

主要會計政策載列如下。

3. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for investment properties that are measured at fair values, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods or services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 “Share-based Payment”, leasing transactions that are within the scope of HKAS 17 “Leases”, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 “Inventories” or value in use in HKAS 36 “Impairment of Assets”.

A fair value measurement of a non-financial asset takes into account a market participant’s ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

綜合基準

綜合財務賬項包括本公司及受本公司及其附屬公司控制之個體之財務賬項。倘本公司符合以下條件時，即可取得控制權：

- 可對被投資方行使權力；
- 自參與被投資方營運所得的可變回報須承擔風險或擁有權利；及
- 能夠運用其權力以影響其回報金額。

倘有事實及情況顯示上述三項控制元素有一項或以上出現變動，則本公司再評估其是否控制被投資方。

倘本集團於投資對象之投票權少於大多數，而投票權足以賦予本集團實際能力可單方面指示投資對象之相關業務時，本集團即對投資對象擁有權力。在評估本集團於投資對象之投票權是否足以賦予其權力時，本集團考慮所有相關事實及情況，其中包括：

- 本集團持有投票權之規模相對於其他選票持有人持有投票權之規模及分散性；
- 本集團、其他選票持有人或其他人士持有的潛在投票權；
- 其他合約安排所產生之權利；及
- 於需要作出決定(包括先前股東大會上之投票模式)時表明本集團當時擁有或並無擁有能力指示相關活動之任何額外事實及情況。

當本集團取得附屬公司之控制權時，開始將附屬公司綜合入賬，且會在其失去附屬公司的控制權時，終止綜合入賬。具體而言，年內所收購或出售的附屬公司的收入及開支會由本集團取得控制權當日起計入綜合損益及其他全面收益表，直至本集團不再控制附屬公司為止。

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved where the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Company reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

損益及其他全面收益各項目歸屬於本公司擁有人及非控股權益。附屬公司之全面收入總額歸屬於本公司擁有人及非控股權益，即使這導致非控股權益出現赤字差額。

於有需要時，附屬公司之財務賬項會作出調整，以使其會計政策與本集團其他成員公司所採納一致。

所有集團內公司間之資產及負債、權益、收入、開支以及有關本集團成員間交易之現金流量均於綜合賬目時悉數撤銷。

附屬公司的非控股權益與本集團的權益分開呈列。

合營企業權益

合營企業指一種合營安排，對安排擁有共同控制權之各訂約方據此對合營安排之淨資產擁有權利。共同控制是一項安排所共有之控制，共同控制僅在當相關活動要求享有控制權之各訂約方作出一致同意之決定時存在。

合營企業之業績及資產及負債按權益會計法在綜合財務賬項綜合入賬。根據權益法，於合營企業之投資按成本值在綜合財務狀況表首次確認，並就本集團於隨後攤佔該合營企業之損益內及其他全面收入所作出調整及入賬。倘本集團攤佔合營企業之虧損相等於或超出其於該合營企業之權益，則本集團終止確認其攤佔之額外虧損。惟僅以本集團已產生法定或推定責任或已代表該合營企業作出付款為限，本集團會就額外虧損作出確認。

Basis of consolidation (Continued)

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein.

Interest in a joint venture

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of a joint venture are incorporated in the consolidated financial statements using the equity method of accounting. Under the equity method, an investment in a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the joint venture. When the Group's share of losses of a joint venture equals or exceeds its interest in that joint venture, the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of that joint venture.

合營企業權益 (續)

於投資方成為合營企業當日，對合營企業之投資採用權益法入賬。於收購合營企業之投資時，投資成本超出本集團分佔被投資方之可識別資產及負債之公平值淨額之任何差額均確認為商譽，並計入投資之賬面值。本集團應佔可識別資產及負債之公平淨值超出投資成本之任何差額（經重估後），則會於收購投資之期間即時於損益內確認。

香港會計準則第39號「金融工具：確認及計量」之規定應用於釐定是否需要就本集團於合營企業之投資確認任何減值虧損。於需要時，該項投資之全部賬面值（包括商譽）會根據香港會計準則第36號「資產減值」作為單一資產透過比較其可收回金額（使用價值與公平價值減出售成本之較高者）與賬面值作減值測試。任何已確認之減值虧損組成該項投資之賬面值一部分。根據香港會計準則第36號任何該減值虧損之撥回於投資之可收回金額其後增加時確認。

於投資不再為合營企業當日起或投資（或其中一部分）被分類為持作出售時，本集團終止採用權益法。

當集團實體與本集團之合營企業進行交易時，與合營企業之交易所產生的損益乃按本集團無關的合營企業所佔之權益為準而在本集團綜合財務賬內確認。

Interest in a joint venture (Continued)

An investment in a joint venture is accounted for using the equity method from the date on which the investee becomes a joint venture. On acquisition of the investment in a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 “*Financial Instruments: Recognition and Measurement*” are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in a joint venture. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 “*Impairment of Assets*” as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs to sell) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment ceases to be a joint venture, or when the investment (or a portion thereof) is classified as held for sale.

When a group entity transacts with a joint venture of the Group, profits or losses resulting from the transactions with the joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the joint venture that are not related to the Group.

投資物業為持作賺取租金收入及／或作資本增值的物業。

投資物業首次按成本(包括任何直接應佔支出)計量。於首次確認後，投資物業乃採用公平值模式計量其公平值。投資物業因公平值變動所產生之損益列入所產生期間之溢利或虧損。

當投資物業出售時，或當永不再使用該投資物業且預期在出售時將不會產生任何未來經濟利益時，則終止確認入賬。因終止確認資產時產生之任何收益或虧損(按其出售時所得款項之淨金額和資產賬面值之差額計算)，於該項目終止確認之期間內計入損益中。

租賃

當租賃條款將絕大部分擁有權之風險及回報轉移予承租者，該租賃均被分類為融資租賃。所有其他租賃均分類為經營租賃。

本集團為出租者

經營租賃之租金收入乃於相關租賃年內按直線基準於損益內確認。來自經營租賃的或然租金於賺取期間確認為收入。

倘訂立經營租賃可以獲得租賃優惠，該等優惠被確認為資產。優惠成本總額以直線法確認為租金收入減少，除非有另一系統化基準更能反映租賃資產減少經濟利益之時間模式。

本集團為承租者

經營租賃付款乃在租賃年內按直線基準確認為開支。

(Continued)

Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at their fair values using the fair value model. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the item is derecognised.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Contingent rentals arising under operating leases are recognised as income in the period in which they are earned.

In the event that lease incentives are granted to enter into operating leases, such incentives are recognised as assets. The aggregate cost of incentives is recognised as a reduction of rental income on a straight-line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are diminished.

The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term.

租賃土地及樓宇

倘租賃包括土地及樓宇部分，則本集團根據對擁有權所附帶之絕大部分風險及回報是否已轉讓予本集團之評估，獨立將各部分分類評估為財務或經營租賃，除非兩部分明顯為經營租賃，在該情況下，則整項租賃被歸類為經營租賃。具體而言，最低租賃款項(包括任何一次過預付款項)乃按租賃土地部分及樓宇部分於租賃開始時之租賃權益相對公平值比例於土地及樓宇部分之間分配。

倘能可靠分配租賃款項，作為營運租賃入賬之租賃土地權益於綜合財務狀況表內呈列為「預付租賃款項」並按直線法於租賃期內攤銷，被歸類為並作為投資物業及以公平值模式列賬則除外。當租賃款項未能於土地及樓宇部分之間可靠分配時，整份租賃一般分類為融資租賃並作為物業、機器及設備入賬。

借貸成本

與收購、建造或生產合資格資產(合資格資產指需要一段較長期間方能作擬定用途或銷售的資產)直接有關之借貸成本計入該等資產之成本，直至該等資產已大致可作擬定用途或銷售為止。於特定借貸暫時投資賺取之投資收益視乎該借貸用作合資格資產開支而定，會從合資格資本化之借貸成本中扣除。

所有其他借貸成本均於產生期間的損益內確認。

Leasehold land and building

When a lease includes both land and building elements, the Group assesses the classification of each element as a finance or an operating lease separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire lease is classified as an operating lease. Specifically, the minimum lease payments (including any lump-sum upfront payments) are allocated between the land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element of the lease at the inception of the lease.

To the extent the allocation of the lease payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as “prepaid lease payments” in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis except for those that are classified and accounted for as investment properties under the fair value model. When the lease payments cannot be allocated reliably between the land and building elements, the entire lease is generally classified as a finance lease and accounted for as property, plant and equipment.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit and loss in the period in which they are incurred.

3. 主要會計政策 (續)**待售物業**

待售物業按成本及可變現淨值兩者中之較低額入賬。成本包括於租賃土地之物業權益和發展成本，後者包括應佔資本化借貸成本。

可變現淨值指估計售價扣減所有估計完成成本及達到銷售所需成本。

收入確認

收入乃按於一般業務過程中所提供的貨物及服務的已收或應收代價的公平值計量及代表應收款項(扣除折扣及相關銷售稅項)。

當收入金額能夠可靠地計量、而未來經濟利益乃很可能流入本集團，且符合以下本集團各業務的特定準則時，本集團便會確認收入。

物業銷售

在日常業務進行下的銷售物業所得收入會於下列所有條件達成時確認：

- 本集團已將物業擁有權之重大風險及回報轉移予買方，指當相關物業的建築工程已完成而物業已交付予買方，並可合理確定收取有關應收款項的可能性時；
- 本集團並無保留一般與擁有權有關之銷售物業持續管理權或實際控制權；
- 收入金額能可靠地計量；
- 與交易相關之經濟利益將很可能流入本集團；及
- 交易已產生或將產生之成本能可靠地計量。

Properties held for sale are stated at the lower of cost and net realisable value. Cost comprises the property interest in leasehold land and development costs including attributable borrowing costs capitalised.

Net realisable value represents the estimated selling price less all estimated costs of completion and costs necessary to make the sale.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods sold and services provided in the normal course of business, net of discounts and sales related taxes.

Revenue is recognised when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the Group and when specific criteria have been met for each of the Group's activities, as described below.

Sales of properties

Revenue arising from the sale of properties in the ordinary course of business is recognised when the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the properties, which is when the construction of relevant properties has been completed, upon delivery, and collectability of related receivables is reasonably assured;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the properties are sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

收入確認 (續)

物業銷售 (續)

在符合上述所有收入確認條件前自買方收取的定金及供款已於綜合財務狀況表之流動負債內入賬。

其他

營運租賃的租金收入乃根據直線法於相關租賃年期內於損益內確認。或然租金於賺取期間內確認為收入。

服務收入於服務提供時確認。

當可能獲得的經濟效益將會流入本集團及該收入金額能可靠地衡量時，金融資產利息才會被確認。金融資產利息收入乃根據尚存本金及適用的實際利率按時間基準累計。而實際利率為透過金融資產於首次確認的眼面淨值的預計年期實際貼現預期未來現金收入的比率。

稅項

所得稅支出指現時應付稅項及遞延稅項總額。

現時應付稅項乃按本年度應課稅溢利計算。應課稅溢利與綜合損益及其他全面收益表中所呈報之「除稅前溢利」不同，乃由於應課稅溢利不包括於其他年度應課稅之收入或抵扣之開支，亦不包括永不須課稅或獲抵扣之項目。本集團的現時應付稅項負債乃按於呈報期末已頒佈或大體上已頒佈之稅率計算。

Sales of properties (Continued)

Deposits and instalments received from purchasers prior to meeting all the above criteria for revenue recognition are included in the consolidated statement of financial position under current liabilities.

Others

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Contingent rentals are recognised as income in the period in which they are earned.

Service income is recognised when services are provided.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income from a financial asset is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from the "profit before taxation" as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

遞延稅項乃按綜合財務賬項內資產及負債賬面值與計算應課稅溢利所採用相應稅基之暫時差額確認。遞延稅項負債一般就所有應課稅暫時差額確認，而遞延稅項資產一般則於可動用扣減暫時差額可能對銷可使用應課稅溢利時所有可扣減暫時性差額予以確認。於一項交易中，因其他資產及負債之商譽或初步確認（惟業務合併除外）引致既不影響應課稅溢利或會計溢利之暫時差額，則該等資產及負債不予確認。

遞延稅項負債乃按於附屬公司及合營企業權益相關之應課稅暫時差額而確認，惟若本集團可控制該暫時差額之撥回，且該暫時差額可能不會於可見將來逆轉則除外。與該等投資及權益有關之可扣減時差產生的遞延稅項資產只於可能有充足應課稅溢利動用時差的利益及預期在可見將來撥回時確認。

遞延稅項資產之賬面值乃於呈報期末進行檢討，並予以相應扣減，直至並無足夠應課稅溢利可供全部或部分資產可予收回為止。

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and interest in a joint venture, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on the tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

即期及遞延稅項在損益內確認，惟與其他全面收入或直接自權益確認之項目相關者除外，於該情況下，即期及遞延稅項亦會分別於其他全面收入或直接於權益中確認。

外幣

於編製各個別集團實體之財務賬項時，以該實體功能貨幣以外之貨幣（外幣）進行之交易乃按其功能貨幣（即該實體經營所在主要經濟環境之貨幣）於交易當日之匯率換算入賬。於呈報期末，以外幣計值之貨幣項目按呈報期末之匯率重新換算。以外幣計值按公平值列賬之非貨幣項目按釐定公平值當日之匯率重新換算，而以外幣之歷史成本計值之非貨幣項目不予重新換算。

因結算貨幣項目及重新換算貨幣項目所產生之匯兌差額於產生期間在損益內確認。重新換算按公平值列賬之非貨幣項目產生之匯兌差額計入該期內之損益中。

For the purposes of measuring deferred tax liabilities or deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. If the presumption is rebutted, deferred tax liabilities and deferred tax assets for such investment properties are measured in accordance with the above general principles set out in HKAS 12 (i.e. based on the expected manner as to how the properties will be recovered).

Current and deferred tax are recognised in profit or loss, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in its functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period.

金融工具

金融資產及金融負債於本集團成為工具訂約條文之一方時於綜合財務狀況表內確認。

金融資產及金融負債初步以公平值計量。購置或發行金融資產或金融負債時直接產生之交易成本於初步確認時從該金融資產或金融負債（視情況而定）之公平值加進或扣減。

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the group entity with functional currency of Renminbi are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the rate of exchange prevailing at the end of the reporting period, and their income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributed to non-controlling interests as appropriate).

Retirement benefits costs

Payments to defined contribution retirement benefits plans in Hong Kong and the People's Republic of China (the "PRC") and the Mandatory Provident Fund Scheme (the "MPF Scheme") in Hong Kong are charged as expenses when employees have rendered service entitling them to the contributions.

Financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets or financial liabilities are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

實際利息法

實際利息法乃計算金融資產攤銷成本及將利息收入按有關期間予以分配之方法。實際利率為於金融資產之預計可使用年期或於首次確認之賬面淨值的較短期間(如適用)內，將估計未來現金收入(包括所支付或收取構成實際利率的所有費用及基點、交易成本及其他溢價或折扣)準確貼現的利率。

利息收入按實際利率基準確認。

貸款及應收賬款

貸款及應收賬款為於活躍市場並無報價且附帶固定或可釐定付款之非衍生金融資產。於初步確認後，貸款及應收賬款(包括合營企業欠款、貸款應收賬款、貿易及其他應收賬款、非控股股東欠款、銀行存款及銀行結餘)乃採用實際利率法按攤銷成本減任何減值列賬(見下文有關金融資產之減值虧損之會計政策)。

利息收入乃採用實際利率確認，惟確認利息並不重大之短期應收款項除外。

The Group's financial assets are loans and receivables. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition. All regular way purchases or sales of financial assets are recognised and derecognised on a settlement date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees paid and points or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Interest income is recognised on an effective interest basis.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Subsequent to initial recognition, loans and receivables (including amount due from a joint venture, loan receivables, trade and other receivables, amount due from a non-controlling shareholder, bank deposits and bank balances) are measured at amortised cost using the effective interest method, less any impairment (see accounting policy on impairment loss on financial assets below).

Interest income is recognised by applying the effective interest rate, except for short-term receivables where the recognition of interest would be immaterial.

金融資產減值

Impairment of financial assets

Financial assets are assessed for indicators of impairment at the end of the reporting period. Financial assets are impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been affected.

Objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as default or delinquency in interest and principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation.

An impairment loss is recognised in profit or loss when there is objective evidence that the asset is impaired, and is measured as the difference between the financial asset's carrying amount and the present value of the estimated future cash flows discounted at the financial asset's original effective interest rate.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets with the exception of loan receivables and trade and other receivables, where the carrying amounts are reduced through the use of allowance accounts. Changes in the carrying amounts of the allowance accounts are recognised in profit or loss. When loan receivables and trade and other receivables are considered uncollectible, they are written off against the allowance accounts. Subsequent recoveries of amounts previously written off are credited to profit or loss.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment loss was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

股本權益工具乃任何合約可證明本集團於扣減所有負債後在資產中擁有剩餘權益。由本公司發行之股本權益工具乃按已收所得款項(扣除直接發行成本)入賬。

財務擔保合約

財務擔保合約乃規定發行者須支付特定款項以補償持有者因特定債務者未能按照債務票據原定或經修訂條款於到期時支付款項所蒙受損失之合約。

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest expense is recognised on an effective interest basis.

Financial liabilities

Financial liabilities (including trade and other payables and bank loans) are subsequently measured at amortised cost, using the effective interest method.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument.

終止確認

本集團僅於自財務資產獲取現金流之合約權利到期時終止確認財務資產。

於終止確認金融資產時，資產賬面值與已收及應收代價金額之差額於損益內確認。

當或只有本集團之責任獲解除、取消或到期時，本集團之金融負債方終止確認。已終止確認之金融負債賬面值與已付或應付代價之差額於損益內確認。

物業、機器及設備

物業、機器及設備乃按成本減去其後累積折舊及累積減值虧損(如有)於綜合財務狀況表內入賬。

物業、機器及設備項目成本之撇銷在考慮到其估計剩餘值後，乃以直線基準在估計可使用期內確認為折舊。估計可使用年期及折舊方法會在各呈報期末檢討，任何估計變動之影響按預計基準列賬。

物業、機器及設備項目會在出售或預期持續使用該資產不會帶來未來經濟利益時終止確認。出售或棄置該物業、機器及設備項目時所產生的任何損益以出售所得款項與該資產之賬面值之差額計算，並於損益內確認。

A financial guarantee contract issued by the Group and not designated as at fair value through profit or loss is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount of obligation under the contract, as determined in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets"; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised.

Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire.

On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or expire. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

Property, plant and equipment

Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment over their estimated useful lives and after taking into account of their estimated residual value using the straight-line method. The estimated useful lives and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

本集團於呈報期末檢討其有形資產賬面值，以確定該等資產是否已存在減損之跡象。倘出現此情況，將估計資產之可收回金額，以釐定減值虧損數額(如有)。倘無法估計個別資產之可收回金額，本集團將估計該資產所屬現金產生單位可收回金額。如能確定一個合理及一致之分配基準，公司資產亦分配至個別現金產生單位，否則將分配至如能確定一個合理及一致之分配基準的情況下之最小現金產生單位。

可收回金額乃公平價扣除銷售成本與使用價值之較高者。在評估使用價值時，估計未來現金流量將使用稅前貼現率貼現至其現值，以反映目前資金時間值之市場估量及有關未來現金流估計之資產之未調整風險。

倘估計資產或現金產生單位之可收回金額低於其賬面值，則將該資產或現金產生單位賬面值撇減至其可收回金額。減值虧損隨即確認為支出。

於回撥減值虧損時，資產(或現金產生單位)之賬面值可調高至重新釐定之估計可收回金額，惟不可高於該資產(或現金產生單位)於過往年度未計減值虧損前之賬面值。撥回之減值虧損可即時被確認為收入。

或然資產乃不獲確認，直至收入變現為實質確定，則有關資產並非或然資產及其確認為適當的。

Impairment on tangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. Where a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised as income immediately.

Contingent asset

A contingent asset is not recognised until the realisation of income is virtually certain, then the related asset is not contingent asset and its recognition is appropriate.

授予僱員及提供類似服務的顧問之認股權

參考認股權公平值而釐定的所獲服務公平值在認股權在授出日期授出及享有即時以股份為基礎之付款支銷，並在認股權儲備作出相應增加。

當認股權獲行使時，過往於認股權儲備內確認之金額將會轉撥至股份溢價。當認股權於歸屬日期後遭沒收或於屆滿日期仍未行使，則過往於認股權儲備內確認之金額將轉撥至保留溢利。

4. 重大會計判斷及估計不確定因素之主要來源

於應用附註第3項內所述本集團之會計政策時，本公司董事須就並不容易從其他來源顯示之資產及負債之賬面值作出判斷、估計及假設。估計及相關假設乃根據過往經驗及其他被認為相關之因素作出。實際結果可能與該等估計不同。

本集團就估計及相關假設持續予以檢討。倘會計估計之修訂僅對估計修訂之期間構成影響，則有關修訂於此期間確認，或倘有關修訂對本期間及未來期間均構成影響，則修訂乃於檢討及未來期間確認。

Share-based payment arrangements

Share options granted to employees and consultants providing similar services

The fair value of services received determined by reference to the fair value of share options granted and vested at the grant date is expensed as share-based payment expenses immediately on the date of grant, with a corresponding increase in share option reserve.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits.

4. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the Directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying the Group's accounting policies

The following are the critical judgements, apart from those involving estimations (see below), that the Directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

應用本集團會計政策之重大判斷 (續)

投資物業遞延稅項

就計算以公平值模式計量的投資物業產生的遞延稅項負債或遞延稅項資產之計量而言，董事已審閱本集團之投資物業組合，並總結本集團持有位於中國之投資物業之業務模式的目的並非隨時間耗用該投資物業所包含之大部分經濟利益。因此，在計算本集團投資物業之遞延稅項時，董事判定透過銷售全數收回採用公平值模式計量之投資物業之賬面值之假設不被推翻。由於本集團須就出售其投資物業繳付土地增值稅(「土地增值稅」)及企業所得稅(「企業所得稅」)，故本集團已就投資物業之公平值變動確認遞延稅項。

未售物業分類為待售物業

於年度內，本公司管理層在日常業務進行中，積極推銷可供出售的所有未出售待售物業。於二零一七年六月三十日，賬面值為港幣13,019,000元(二零一六年：港幣11,562,000元)的若干待售物業單元已暫時出租。本公司董事有意持有該等待售物業，因此，該等單元於綜合財務賬項中仍分類為待售物業。

估計不確定性之主要來源

於呈報期末，就有關日後及其他估計不明朗因素主要來源，具有存在重大風險，而導致下一財政年度內資產和負債賬面值出現重大調整的主要假設概述如下。

Critical judgements in applying the Group's accounting policies (Continued)

Deferred taxation on investment properties

For the purposes of measuring deferred tax liabilities or deferred tax assets arising from investment properties that are measured using the fair value model, the Directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties located in the PRC are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time. Therefore, in measuring the Group's deferred taxation on investment properties, the Directors have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. As a result, the Group has recognised the deferred taxes on changes in fair value of investment properties as the Group is subject to Land Appreciation Tax ("LAT") and Enterprise Income Tax ("EIT") on disposal of its investment properties.

Classification of unsold properties as properties held for sale

During the year, the management of the Company has actively marketed its unsold properties for all properties held for sale which are available for sale in the ordinary course of business. As at 30 June 2017, certain units of properties held for sale with carrying amount HK\$13,019,000 (2016: HK\$11,562,000) have been rented out temporarily. The Directors of the Company have intention to hold these properties for sale, and accordingly, these units are still classified as properties held for sale in the consolidated financial statements.

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

投資物業公平值

於呈報期末，本集團投資物業公平值合共港幣1,990,736,000元(二零一六年：港幣1,926,240,000元)乃按照獨立合資格專業估值師及本公司董事進行的估值。投資物業的估值(不包括以直接比較法估值的停車場)乃根據近期類似物業交易價格的市場證據和/或根據使用現時市場租金和收益作為輸入元素，估計未來租金收入的貼現現金流量預測而得出。依據估值，管理層行使其判斷並對估值方法反映現時市場情況表示滿意。此假設之有利或不利之改變會導致本集團之投資物業公平值改變及相應調整之收益或虧損會於損益內確認。

呆賬撥備

本集團根據對貸款應收賬款及貿易及其他應收賬款可收回程度的評估確認呆賬撥備。

倘出現事件或情況變動顯示結餘可能無法收回，則會就貸款應收賬款及貿易及其他應收賬款作出撥備。呆賬的確定須使用判斷及估計。當貸款應收賬款、貿易及其他應收賬款實際可收回現金流量與先前估計不符時，有關差異將影響貸款應收賬款、貿易及其他應收賬款的賬面值及呆賬支出。於二零一七年六月三十日，貿易及其他應收賬款的賬面值為港幣36,820,000元(減去呆賬撥備港幣3,726,000元)(二零一六年：港幣17,589,000元(減去呆賬撥備港幣3,739,000元))。而貸款應收賬款賬面值為港幣零元(減去呆賬撥備港幣1,537,000元)(二零一六年：港幣零元(減去呆賬撥備港幣1,560,000元))。

Fair value of investment properties

At the end of the reporting period, the Group's investment properties are carried at a total fair value of HK\$1,990,736,000 (2016: HK\$1,926,240,000) based on the valuations performed by independent qualified professional valuers and the Directors of the Company. The valuations of investment properties (excluding carparks being valued under the direct comparison approach) were arrived at by reference to market evidence of recent transaction prices for similar properties and/or on the basis of discounted cash flow projections based on estimates of future rental income from properties using current market rentals and yields as inputs. In relying on the valuation, management has exercised its judgment and is satisfied that the method of valuation is reflective of the current market conditions. Favourable or unfavourable changes to these assumptions would result in changes in the fair value of the Group's investment properties and corresponding adjustments to the amount of gain or loss recognised in profit or loss.

Allowance for doubtful debts

The Group recognises allowance for doubtful debts based on an assessment of the recoverability of loan receivables and trade and other receivables.

Allowances are applied to loan receivables and trade and other receivables where events or changes in circumstances indicate that the balances may not be collectible. The identification of doubtful debts requires the use of judgement and estimates. Where the actual cash flows relating to loan receivables and trade and other receivables are different from the previous estimate, such difference will impact the carrying value of loan receivables, trade and other receivables and the doubtful debts expense. As at 30 June 2017, the carrying amounts of trade and other receivables and loan receivables are HK\$36,820,000 (net of allowance for doubtful debts of HK\$3,726,000) (2016: HK\$17,589,000 (net of allowance for doubtful debts of HK\$3,739,000)) and nil (net of allowance for doubtful debts of HK\$1,537,000) (2016: nil (net of allowance for doubtful debts of HK\$1,560,000)) respectively.

No provision for Hong Kong Profits Tax has been made in the consolidated financial statements as the Group has no assessable profit for both years.

Under the Law of the People's Republic of China on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the Group's PRC entity is 25%.

Certain subsidiaries of the Company incorporated in Hong Kong and the British Virgin Islands are subject to withholding tax ranging from 10% to 25% on their taxable rental income, management fee income and interest income in the PRC.

Details of the deferred tax liabilities are set out in note 22.

The EIT Law also requires withholding tax upon distribution of profits earned by the PRC entities since 1 January 2008 at 5%. At the end of the reporting period, deferred taxation of HK\$2,493,000 (2016: HK\$2,602,000) has been provided for in the consolidated financial statements in respect of the temporary differences attributable to such profits.

於二零一七年及二零一六年六月三十日，本集團投資物業之公平值乃根據與本集團並無關連之獨立合資格專業估值師公司(第一太平戴維斯估值及專業顧問有限公司)，於該等日期進行之估值得出，其具有合適資格及於有關地區類似物業進行估值之經驗。估值乃採納直接比較法參考市場之可供比較銷售交易而作出，而當適用時採納投資法將現有物業租賃收取之租金收入資本化，並對物業之潛在復歸收入作出適當撥備。重估引致公平值增加而帶來之收益淨額港幣92,896,000元(二零一六年：港幣83,076,000元)已於損益內確認。所有投資物業均位於中國。

The fair value of the Group's investment properties as at 30 June 2017 and 2016 has been arrived at on the basis of valuations carried out by Savills Valuation and Professional Services Limited, an independent firm of qualified professional valuers not connected with the Group with appropriate qualification and recent experience in the valuation of similar properties in the relevant locations. The valuation was arrived at with adoption of the direct comparison approach by making reference to comparable sales transactions as available in the market and where appropriate, adopted the investment method by capitalising the rental incomes of the properties derived from the existing tenancies with due allowance for the reversionary income potential of the properties. The revaluation gave rise to a net gain arising from increase in fair value of HK\$92,896,000 (2016: HK\$83,076,000) which has been recognised in profit or loss. All the investment properties are situated in the PRC.

The investment properties of the Group held under operating leases to earn rentals or for capital appreciation purposes are measured using the fair value model for both years.

在直接比較法估值下，用於評估位於中國北京停車場部分的主要不可觀察元素，為經調整過其他因素如時間及地點的市場單元銷售額比率，相等於港幣167,988,000元(二零一六年：港幣165,327,000元)。使用停車場市場單元銷售額，是重大的不可觀察輸入元素，乃得自於範圍由每單元人民幣130,000元至人民幣200,000元(二零一六年：人民幣130,000元至人民幣190,000元)的可比較市場單元銷售額。增加使用市場單元銷售額會導致公平值增加，反之亦然。

過往年度採用的估值方法概無變動。於估計物業公平值時，物業的最高及最佳用途為其現時用途。

An increase in the capitalisation rate used would result in a decrease in fair value and vice versa. Market unit rent of individual unit used, derived from the market rentals from comparable properties with a range of RMB91/sq.m. to RMB205/sq.m. (2016: RMB87/sq.m. to RMB188/sq.m.) per month represents another significant unobservable input. An increase in the market unit rent would result in an increase in fair value and vice versa.

Key unobservable input used in valuing the carparks portions in Beijing, the PRC amounting to HK\$167,988,000 (2016: HK\$165,327,000) under direct comparison approach was the market unit sales rate with adjustment on other factors, such as time and location. Market unit sales of carparks used, derived from the markets unit sales comparables with a range of RMB130,000 to RMB200,000 (2016: RMB130,000 to RMB190,000) per unit, represents the significant unobservable input. An increase in the market unit sales used would result in an increase in fair value and vice versa.

There has been no change from the valuation technique used in prior year. In estimating the fair value of the properties, the highest and best use of the properties is their current use.

The valuation of the Group's investment properties is classified as Level 3 of the fair value hierarchy. There were no transfers into or out of Level 3 during both years.

於過往年度，本集團與中方合營夥伴就圳華的股權權益爭議提出國際仲裁呈請。兩項仲裁已進行聆訊，而中國國際經濟貿易仲裁委員會已於二零零八年及二零一零年作出仲裁裁決。

在裁決前，本集團向圳華注入人民幣42,840,000元作為投資成本，佔圳華股權權益的80%。根據二零零八年仲裁裁決，圳華之註冊資本確認為人民幣21,000,000元，其中本集團及中方合營夥伴分別出資人民幣10,290,000元及人民幣10,710,000元，而本集團及中方合營夥伴分別持有圳華之股權權益49%及51%。本集團在提供增加資本人民幣32,550,000元時已考慮作為本集團向圳華作出的墊款。

此外，二零一零年仲裁裁決內支持本集團按股東協議條款分配來自圳華持有位於中國深圳東角頭的一幅土地重新發展前有關收入之80%利潤。

自二零零九年六月三十日止年度，本集團按其持有圳華股權權益49%以權益法計入於圳華淨資產及業績之分攤，圳華已被視為合營企業，而圳華之資產與負債已被解除綜合入賬。

從有關收入所產生的利潤分配是按權益法計算(本集團佔49%圳華權益)。由於本公司董事認為裁決結果乃取決於中方合營夥伴的一致同意，故直至二零一七年六月三十日，其中額外分佔31%合共港幣10,368,000元(二零一六年：港幣10,368,000元)並未予以確認。

Shenzhen Zhen Wah Harbour Enterprises Ltd. ("Zhen Wah") was a sino-foreign equity joint venture company and indirectly held by the Company. The Group was able to exercise 50% voting power in the joint venture, which was determined by the proportion of the Group's representatives in the board of directors of Zhen Wah.

The Group had lodged petitions for international arbitrations in respect of the dispute with the Chinese joint venture partner as to the percentages of equity interest held in Zhen Wah in prior years. Two arbitral proceedings were heard and two arbitral awards were made by China International Economic and Trade Arbitration Commission in 2008 and 2010.

Before the arbitrations, the Group injected RMB42,840,000 as investment cost to Zhen Wah, representing 80% of equity interests in Zhen Wah. Pursuant to the arbitral award made in 2008, the registered capital of Zhen Wah was confirmed to be RMB21,000,000, of which RMB10,290,000 and RMB10,710,000 were contributed by the Group and the Chinese joint venture partner, respectively, and that the equity interests of Zhen Wah were held by the Group and the Chinese joint venture partner as to 49% and 51%, respectively. The additional capital contribution of RMB32,550,000 by the Group was considered as advances to Zhen Wah by the Group.

Also, the arbitral award made in 2010 supported the distribution of profit arising from relevant income generated from a piece of land held by Zhen Wah located in Tung Kok Tau, Shenzhen, the PRC before re-development entitled by the Group should be 80%.

The assets and liabilities of Zhen Wah were deconsolidated and the Group's share of net assets and results in Zhen Wah had been accounted for as a joint venture under the equity method based on the Group's 49% equity interest in Zhen Wah since the year ended 30 June 2009.

The distribution of profit arising from relevant income was accounted for under the equity method based on the Group's 49% equity interest in Zhen Wah. The additional share of 31% up to 30 June 2017 which has not been recognised by the Group amounted to HK\$10,368,000 (2016: HK\$10,368,000), as the Directors of the Company consider the result of the arbitration is subject to the agreement of the Chinese joint venture partner.

圳華的經營期已於二零一四年一月十六日屆滿。圳華合營夥伴雙方已決定不延續其經營期，並於過往年度提呈清算圳華之申請。中國法院於本年度接納清算圳華之申請及於中國委任一間律師事務所作為圳華的清算委員會。

根據中國法律和法規，以及本集團聘用之外部中國法律顧問提供的相關釋義，在經營期屆滿後及甚至在清算過程中，圳華的法人實體仍然存在，其淨資產將會於清算完成後按照合營夥伴雙方的權益分配予合營夥伴雙方。本公司董事預計清算過程預期將不會於一年內完成。據此，本公司董事繼續以權益法計算該等綜合財務賬項，圳華被視為本集團的合營企業。

The operation period of Zhen Wah expired on 16 January 2014. Both joint venture partners of Zhen Wah determined not to extend its operation period and an application was lodged to liquidate Zhen Wah in prior year. The PRC court accepted the application for liquidation of Zhen Wah and appointed a law firm in the PRC as the liquidation committee of Zhen Wah in the current year.

Based on the PRC laws and regulations and the related interpretations by an external PRC legal counsel engaged by the Group, after the expiry of the operation period and even during the liquidation process, the legal identity of Zhen Wah still exists and the net assets of Zhen Wah will be distributed to the joint venture partners based on their equity contributions after the completion of the liquidation. The Directors of the Company expect that the liquidation process is not expected to complete within one year. Accordingly, the Directors of the Company continue to account for Zhen Wah as a joint venture of the Group using the equity method of accounting in these consolidated financial statements.

The amount due from a joint venture is unsecured and to be repayable after the next twelve months from the end of the reporting period. The amount is carried at amortised cost at an effective interest rate of 6% (2016: 6%) per annum.

The Directors of the Company have assessed the recoverability of interest in a joint venture and amount due from a joint venture amounting to HK\$86,974,000 and HK\$218,549,000, respectively as at 30 June 2017. Based on the latest financial information and fair value of net assets of Zhen Wah, the Directors of the Company have concluded that the amounts will be fully recoverable.

Under both the 2001 Scheme and 2011 Scheme, the Board of Directors of the Company may grant share options (“**Options**”) to Directors, employees of the Company and its subsidiaries and such eligible participants at the discretion of the Board of Directors of the Company pursuant to the terms thereof, to subscribe for shares of the Company (“**Shares**”), at a price per Share not less than the highest of (i) the closing price of a Share as stated in the Stock Exchange’s daily quotation sheets on the date of grant of the relevant Option, which must be a trading day; (ii) the average of the closing price of a Share as stated in the Stock Exchange’s daily quotation sheets for the five trading days immediately preceding the date of grant of the relevant Option; and (iii) the nominal value of a Share.

The maximum number of Shares which may be issued upon exercise of all options to be granted under the share option schemes shall not in aggregate exceed 10% of the issued share capital of the Company at the date of the adoption of the relevant share option scheme. Under the 2011 Scheme, such 10% represents 21,910,368 shares, which continue to represent about 10% of the issued share capital of the Company as at the date of this annual report. No Director, employee or eligible participant may exercise option(s) granted to him or her under the share option scheme if such exercise would result in him or her subscribing for more than 1% of the issued share capital of the Company as at the date of such new grant in any 12-month period. The option period for which the options granted are exercisable, shall be such period as notified by the Board of Directors of the Company, save that it shall not be more than ten years from the date of grant. A nominal consideration of HK\$1 is payable by the grantee on acceptance of each grant. The offer of a grant of share options may be accepted within 28 days from the date of the offer.

Where there are Directors and employees who leave the Defined Contribution Scheme prior to vesting fully in the contributions, the amount of the forfeited contributions will be used to reduce future contributions payable by the Group.

Effective from 1 December 2000, the Group has set up a MPF Scheme. Members of the Defined Contribution Scheme were given one-time option to choose to transfer to the MPF Scheme or remain in the existing scheme. The MPF Scheme is registered with the Mandatory Provident Fund Schemes Authority under the Mandatory Provident Fund Schemes Ordinance. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of an independent trustee. Under the rules of the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at rates specified in the rules. No forfeited contributions are available to reduce the contribution payable in the future years by the employer.

The retirement benefit scheme contributions arising from the Defined Contribution Scheme and the MPF Scheme recognised in profit or loss represent contributions payable to the funds by the Group at rates specified in the rules of the schemes.

There are no forfeited contributions in both years which arose upon employees leaving the Defined Contribution Scheme and which are available to reduce the contributions payable by the Group under Defined Contribution Scheme in the future years.

(b) According to the relevant laws and regulations in the PRC, the PRC subsidiary and joint venture are required to contribute 20% and 9% of the stipulated salary set by the Beijing and Shenzhen local governments, respectively, to the retirement benefits schemes to fund the retirement benefits of their employees.

During the year, the retirement benefits scheme contributions recognised in profit or loss are HK\$621,000 (2016: HK\$557,000).

At 30 June 2017, the Group had pledged its investment properties situated in Shanghai, the PRC, with a carrying amount of HK\$882,569,000 (2016: HK\$835,410,000), certain bank balances and bank deposits of HK\$1,734,000 (2016: HK\$10,553,000), an assignment of rental and sale proceeds from the investment properties and a charge over share in respect of the Group's 100% equity interest in Move On International Limited, an indirect wholly-owned subsidiary of the Company, to the bank to secure general banking facilities granted to the Group. The pledged bank balances and deposits carry interest rate of 1.17% (2016: 1.07%) per annum.

若其他變數維持不變，而利率有100基點(二零一六年：100基點)增加或25基點(二零一六年：25基點)降低，則本集團截至二零一七年六月三十日止年度的溢利會減少港幣1,433,000元(二零一六年：港幣1,496,000元)或增加港幣358,000元(二零一六年：港幣374,000元)。這主要由於本集團就其浮動利率銀行貸款之利率風險所致。

The Group's activities expose it primarily to the financial risks of changes in interest rates and changes in foreign exchange rate.

Interest rate risk analysis

The Group's cash flow interest rate risk relates primarily to its variable-rate bank loans and bank deposits and bank balances amounting to HK\$143,290,000 (2016: HK\$149,593,000) and HK\$262,815,000 (2016: HK\$258,887,000), respectively. The interest rate risk of bank deposits and bank balances are considered insignificant as the bank deposits are substantially short-term deposits and fluctuation in interest rate of bank balances is limited. The variable-rate bank loans with original maturity instalments range from one year to three years. An increase in interest rates would increase interest expenses. The Group currently does not have interest rate hedging policy, however, management monitors interest rate exposure on dynamic basis and will consider hedging significant interest rate exposure should the need arise.

The sensitivity analyses below have been determined based on the exposure to interest rates for non-derivative instruments, excluding bank deposits and balances, at the end of the reporting period. For variable-rate bank loans, the analysis is prepared assuming the amount of liability outstanding at the end of the reporting period was outstanding for the whole year. A 100 basis points (2016: 100 basis points) increase or a 25 basis points (2016: 25 basis points) decrease is used as it represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 100 basis points (2016: 100 basis points) higher or 25 basis points (2016: 25 basis points) lower and all other variables were held constant, the Group's profit for the year ended 30 June 2017 would decrease by HK\$1,433,000 (2016: HK\$1,496,000) or increase by HK\$358,000 (2016: HK\$374,000). This is mainly attributable to the Group's net exposure to interest rates on its variable-rate bank borrowings.

With respect to the amounts due from a joint venture and a non-controlling shareholder, having considered their financial standings, the Directors of the Company are of the view that the credit risk is limited.

The Group's concentration of credit risk by geographical location is in the PRC. Other than concentration of credit risk on liquid funds and by geographical location, the Group does not have any other significant concentration of credit risk. Trade receivables consist of a large number of customers, spreading across diverse counterparties.

The Group has provided guarantees to banks in connection with the customers' borrowing of mortgage loans to finance their purchase of the properties for an amount up to 70% of the purchase price of the individual property. If a purchaser defaults on the payment of its mortgage loan during the period of guarantee, the bank holding the mortgage may demand the Group to repay the outstanding loan and any interest accrued thereon. Under such circumstances, the Group is able to resell the repossessed properties. Therefore, management considers it would recover any loss incurred arising from the guarantee to the customers.

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

The following tables detail the Group's remaining contractual maturity for its non-derivative financial liabilities. The tables have been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest period on which the Group can be required to pay.

The table includes both interest and principal cash flows. To the extent that interest flows are floating rate, the undiscounted amount is derived from the weighted average interest rate by reference to the HIBOR of the Group's variable-rate financial liabilities at the end of the reporting period.

As at 30 June 2016 and 2017, the Group does not have term loan with repayment on demand clause. The maturity dates for bank borrowings and other non-derivative financial liabilities is prepared based on the scheduled repayment dates.
