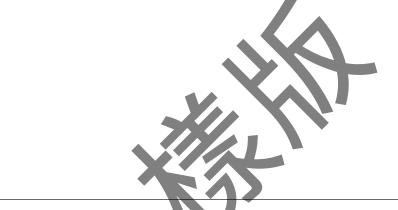

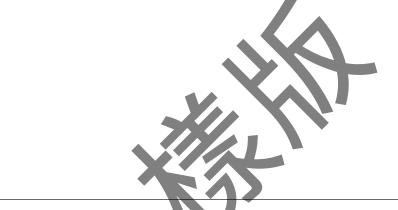
4. 個人資料的保留
