Such proposal is subject to the passing of a special resolution by the Shareholders and the Registrar of Companies in the Cayman Islands granting approval for the Proposed Change of Company Name.

A circular containing, among other things, details regarding the Proposed Change of Company Name and a notice convening the extraordinary general meeting to seek the Shareholders' approval will be despatched to the Shareholders as soon as practicable.

#### **BACKGROUND**

References are made to the announcements made by Times Property Holdings Limited (the "Company") on 12 September and 9 October 2017, the circular issued by the Company on 15 September 2017, the extraordinary general meeting of the Company held on 10 October 2017 (the "October EGM") and the poll results announcement made by the Company on 10 October 2017 in relation to the adjournment of the October EGM.

At the October EGM, the chairman explained that the board of directors (the "Board") of the Company was considering to propose another English name and dual foreign name of the Company for the shareholders of the Company (the "Shareholders") to consider and as such, a resolution was put forward at the October EGM to adjourn the October EGM sine die (without a date, i.e. indefinitely) (the "Adjournment Resolution"). The Adjournment Resolution was duly passed by way of poll at the October EGM.

The Board has decided on the new English name and dual foreign name of the Company for the Shareholders' consideration.

#### PROPOSED CHANGE OF COMPANY NAME

The Board proposes (i) to change the English name of the Company from "Times Property Holdings Limited" to "Times China Holdings Limited"; and (ii) to adopt the Chinese name of "時代中國控股有限公司" as the dual foreign name of the Company in place of its existing Chinese name "時代地產控股有限公司" (the "**Proposed Change of Company Name**").
