### 2. Explanation of the operating results and financial position

- 1. In 2017, the new energy vehicle industry maintained a positive development momentum, the new energy vehicle business of the Group continued to maintain its leading position in the industry and once again ranked as number one in terms of sales volume in the global new energy vehicle industry. During the year, the Group recorded a decline in the sales volume and revenue of its traditional automobile business which brought certain pressure on the Group's earnings growth, however, the launch of the new model Song MAX, received strong market response with increasing demands, leading the Group's traditional automobile business to reemerge. In respect of its handset components and assembly business, the metal parts business continues to record relatively fast growth, contributing favourably to the Group's profits. For its solar business, market competition remains fierce, which brought relatively undesirable impacts to the Group's earnings. Furthermore, the Skyrail business contributed to the Group's revenue beginning from the second half of 2017.
- 2. Primary profitability data changed compared to the same period last year, the main reasons are analyzed above.

#### 3. Explanation of the difference with the previous results forecast

The forecast operating results for the Year 2017 of the Company in the third quarterly report for 2017 was: Net profit attributable to shareholders of the Listed Company decreased by 15.09% to 20.03% as compared to the same period of the previous year.

There is no difference between the operating results disclosed in this announcement of the Company and the previous results forecast.
