Chairman's Statement

I am pleased to present to you the annual report of Gemdale Properties and Investment Corporation Limited (the “**Company**”) and its subsidiaries (collectively, the “**Group**”) for the year ended 31 December 2017.

MARKET OVERVIEW

In 2017, a steady growth in the overall property market in the PRC was recorded, though the real estate control policies were further tightened. Various city-specific measures aimed at restraining unreasonable housing demand were adopted in popular cities. Property prices in first and second tier cities were flat during the year due to the tightening policies. On the contrary, the property market in third- and fourth-tier cities recorded a robust growth due to government’s supportive policies. The supply of various types of land, especially the residential land, began to increase after years of shrinking supply. It bolstered the land transactions volume and effectively relieved the pressure of land shortage.

BUSINESS OVERVIEW AND OUTLOOK

Riding on the boost in PRC property market, the Group managed to record historical high contracted sales of RMB45.2 billion, representing an increase of approximately 120% over last year. The profits attributable to shareholders also recorded historical high of approximately RMB1,644 million, representing a year-on-year growth rate of 20%. And we expect this growth in terms of contracted sales and net profits would continue in the forthcoming years.

In 2017, the gross profit margin of the Group was 36.6%, a number that out beat most of the peer groups in PRC real estate business.

市場概覽

2017年，儘管房地產管控政策持續緊縮，中國整體物業市場仍錄得穩定增長。熱門城市已採納多項專為個別城市制定的措施，旨在限制不合理的住房需求。年內，一線及二線城市的物業價格因緊縮政策相對持平。反之，三線及四線城市物業市場因政府支持性政策錄得穩健增長。在多年供應縮減後，各種土地類型的供應量（特別是住宅用地）開始提升，有助於刺激土地交易量並有效舒緩土地短缺問題。

業績回顧及展望

鑒於中國房地產市場強勁增長，本集團的合約銷售額創歷史新高，金額達人民幣452億元，較去年增加約120%。股東應佔溢利亦創歷史新高達人民幣16.44億元，同比增幅為20%。同時，我們預計未來幾年的合約銷售額及淨利潤將會持續增長。

於2017年，本集團的毛利率達36.6%，遠高於大多數中國房地產同行。

Chairman's Statement

主席報告

In appreciation of the support of our shareholders, the Board resolved to declare the payment of a final dividend of RMB2.5 cents per ordinary share for the year ended 31 December 2017 to shareholders, which is subject to the approval by the shareholders in the forthcoming annual general meeting of the Company.

During the year, the Group has expanded aggressively in the investment and development of business parks. Leveraged on the success of the rental and management of Vision Shenzhen Business Park Phases 1 and 2 which attracts world-class tenants such as Alibaba, DJI, Amazon and Intel, the Group managed to acquire more than 500,000 square meters of land in Shanghai for development of business parks. The business park development business would expand exponentially following the accumulation of management expertise and brand-establishment.

In 2017, China's real estate market was a robust year and the Group has adopted investment strategies with primary focus on first and popular second-tier cities. During the year, the Group has acquired 25 pieces of new lands for development in Beijing, Kunming, Kunshan, Jinan, Nanjing, Qingdao, Shanghai, Suzhou, Wuhan, Xi'an and Xuzhou, with an aggregate GFA of approximately 4.06 million square meters, among which 14% or 572,000 square meters were located in Beijing and Shanghai. Such projects are expected to bring considerable profits and cashflow to the Group. We believe the Group will continue to record mild growth in contracted sales and net profits, which further strengthen our market position in the real estate industry.

OUTLOOK

Looking forward to 2018, the Group would remain focus in expanding scale in terms of contracted sales and landbank accumulation in the first-tier and certain second-tier cities with fast economic growth and large population inflow. The Group would also seek potential equity merger and acquisition and cooperation opportunities at the same time. While for commercial properties, the Group would aggressively expand our business in the development of high-end business parks and construction management commercial projects which are light-asset and could enhance investment returns.

CONCLUSION

On behalf of the Board, I would like to express my sincere appreciation to our shareholders, business partners and customers for their care and support over the past year. I would also like to take this opportunity to express my gratitude to our directors, management and staffs for their valuable contributions. We will continue to forge ahead and accelerate our growth and development, enhance our competitive edge and profitability and devote our best efforts to become one of the most successful property developers in China.

為感謝股東的支持，董事會決議，待本公司股東於即將舉行之股東週年大會上批准後，派付截至2017年12月31日止年度之末期股息每股普通股人民幣2.5仙。

於本年度，本集團亦積極拓展投資及開發商業園。鑒於深圳威新科技園一期及二期的成功租賃及管理吸引了多家世界級租戶（如阿里巴巴、大疆創新科技、亞馬遜及英特爾）進駐，本集團計劃在上海收購超逾50萬平方米的土地以發展商業園。隨著管理經驗的累積及品牌的成功構建，我們的商業園開發業務將呈現幾何級擴大。

2017年是中國房地產市場熱火朝天的一年，本集團實行著重投資一線及二線熱門城市的投資戰略。於本年度，本集團已在北京、昆明、崑山、濟南、南京、青島、上海、蘇州、武漢、西安及徐州收購25塊新開發用地，總樓面面積總計約406萬平方米，其中位於北京及上海的項目建築面積約57.2萬平方米，佔比14%，該等項目相信能為本集團帶來可觀利潤及現金流。我們相信本集團將持續錄得合約銷售額及淨利潤溫和增長，進而擴大本集團於房地產行業的市場地位。

展望

展望2018年，本集團仍將專注於擴大合約銷售額及土地儲備的規模，並以經濟增長快及人口流入大的一線及部份二線城市為落腳點。同時，本集團亦將尋求潛在的股權併購及合作機會。就商業房地產而言，本集團將竭力擴大發展高端商業園業務及建設管理輕資產商業項目，以提高投資回報。

結語

本人謹代表董事會感謝各位股東、合作夥伴及客戶於過去一年對本集團的關心及支持，並藉此機會感謝各位董事、管理人員及員工所作出的寶貴貢獻。我們將繼續向前邁進，推動我們增長及發展，提升競爭優勢及盈利能力，並積極致力成為中國最成功的房地產開發商之一。

FINANCIAL REVIEW

The accounting policies and methods of computation used in the preparation of the financial statements for the year ended 31 December 2017 were consistent with those used in the last financial year ended 31 December 2016, except that the Group has applied, for the first time, the revised Hong Kong Financial Reporting Standards (“HKFRSs”, which included all HKFRSs, Hong Kong Accounting Standards and Interpretations) issued by Hong Kong Institute Certified Public Accountants which are effective for the Group’s financial year beginning on or after 1 January 2017.

RESULTS FOR THE YEAR ENDED 31 DECEMBER 2017

The revenue of the Group for the year ended 31 December 2017 decreased to RMB4,381.1 million from RMB8,706.7 million for the year ended 31 December 2016. The decrease was primarily due to lower revenue recognised from sales of properties.

Other income and gains increased to RMB755.9 million for the year ended 31 December 2017 from RMB531.1 million for the year ended 31 December 2016. The increase was mainly due to higher interest income of RMB155.0 million from loans receivable and RMB17.7 million from available-for-sale financial investments during the year. In addition, the Group disposed of certain subsidiaries during the current year with a gain of RMB53.5 million.

The fair value gains of investment properties of RMB545.8 million was reported for the year ended in 31 December 2017, against RMB259.8 million for the year ended 31 December 2016.

The Group’s direct operating expenses for the year ended 31 December 2017 increased to RMB948.1 million from RMB634.5 million for the year ended 31 December 2016. During the second half of 2016 and the current year, more PRC property development projects launched the pre-sales, and a number of property development and property management subsidiaries were set up/acquired leading to higher operating expenses incurred.

The Group’s administrative expenses for the year ended 31 December 2017 decreased to RMB82.4 million from RMB90.6 million for the year ended 31 December 2016, mainly due to the decrease in share-based compensation expenses.

財務回顧

編製截至2017年12月31日止年度之財務報表所採用之會計政策及計算方法，與截至2016年12月31日止上一財政年度所採用者一致，惟本集團自2017年1月1日或之後開始本集團財政年度生效之經修訂香港財務報告準則（「香港財務報告準則」）（包括所有香港財務報告準則、香港會計準則及詮釋）除外。

截至2017年12月31日止年度業績

本集團截至2017年12月31日止年度之收入由截至2016年12月31日止年度之人民幣8,706,700,000元減少至人民幣4,381,100,000元。本年度收入減少主要由於物業銷售之確認收入下降所致。

截至2017年12月31日止年度之其他收入及收益由截至2016年12月31日止年度之人民幣531,100,000元增加至人民幣755,900,000元。主要上升原因乃本年度來自應收貸款及可供出售金融投資利息收入分別上升人民幣155,000,000元及人民幣17,700,000元。此外，本集團於本年度出售若干附屬公司取得收益人民幣53,500,000元。

截至2017年12月31日止年度內之投資物業公允值收益為人民幣545,800,000元，而截至2016年12月31日止年度則為人民幣259,800,000元。

本集團截至2017年12月31日止年度錄得之直接經營開支，由截至2016年12月31日止年度之人民幣634,500,000元增加至人民幣948,100,000元。由於2016年下半年及於本年度有多項國內物業發展項目開展銷售，以及成立／收購多家從事物業發展及物業管理之附屬公司，引致直接經營開支上升。

本集團截至2017年12月31日止年度錄得之行政開支，由截至2016年12月31日止年度之人民幣90,600,000元下降至人民幣82,400,000元，主要由於股份酬金開支減少。

Financial Review

財務回顧

The finance costs went up to RMB316.3 million for the current year from 267.9 million for the year ended 31 December 2016, an increase of RMB48.4 million, including interest on bank and other borrowings increased by RMB22.6 million due to several borrowings arranged for property acquisition and general working capital of the Group during the current year, and higher interest expenses (net of capitalised interest) of RMB15.6 million paid to the group companies.

Share of results of joint ventures and associates of the Group reported an aggregate profit of RMB1,192.8 million for the year ended 31 December 2017, against RMB184.7 million for the last year. The increase was mainly due to increase in revenue recognition from sales of properties of joint ventures in Beijing and Shenzhen, the PRC.

Overall, the Group's profit attributable to owners of the Company increased from RMB1,366.5 million for the year ended 31 December 2016 to RMB1,643.5 million for the year ended 31 December 2017. It was mainly due to the increase in share of profits of joint ventures during the current year. The increase in the profits from joint ventures was partially offset by the increase in direct operating expenses and finance costs.

The Group recorded basic earnings per share of RMB0.1039 for the year ended 31 December 2017, against basic earnings per share of RMB0.0865 for the year ended 31 December 2016, representing an increase of 20%. The diluted earnings per share for the current year and the prior year were RMB0.1029 and RMB0.0864 respectively.

PROPOSED FINAL DIVIDEND

The Board has recommended the payment of a final dividend of RMB0.025 per share (2016: RMB0.02 per share) for the year ended 31 December 2017, subject to shareholders' approval at the forthcoming annual general meeting of the Company. The proposed final dividend, if approved, will be paid on or about 15 June 2018 to shareholders whose names appear on the register of members of the Company on 1 June 2018. The proposed final dividend shall be declared in RMB and paid in Hong Kong dollars ("HK\$"). The final dividend payable in HK\$ will be converted from RMB at the average middle rate of RMB to HK\$ as announced by the People's Bank of China for the period from 10 May 2018 to 16 May 2018.

本年度之財務費用由截至2016年12月31日止年度人民幣267,900,000元上升至人民幣316,300,000元，增加人民幣48,400,000元，其中包括由於本年度本集團就收購物業及日常營運資金所需安排了數項貸款，致使銀行及其他貸款利息上升人民幣22,600,000元，以及支付集團公司利息（已扣除資本化利息）增加人民幣15,600,000元。

本集團截至2017年12月31日錄得應佔合營公司及聯營公司溢利總額人民幣1,192,800,000元，而去年則為總額人民幣184,700,000元。上升原因乃來自中國北京及深圳合營公司之物業銷售收入確認上升所致。

整體而言，本集團截至2017年12月31日止年度錄得之本公司持有人應佔溢利由截至2016年12月31日止年度人民幣1,366,500,000元增加至人民幣1,643,500,000元。溢利增加主要原因乃本年度本集團錄得應佔合營公司溢利上升所致。直接經營開支及財務費用之增加抵銷了部份上升之合營公司溢利。

本集團錄得截至2017年12月31日止年度每股基本盈利為人民幣0.1039元，截至2016年12月31日止年度則為人民幣0.0865元，增加20%。本年度及上年度之每股攤薄盈利分別為人民幣0.1029及人民幣0.0864元。

建議末期股息

董事會建議，待本公司股東於即將舉行之股東週年大會上批准後，派付截至2017年12月31日止年度之末期股息每股人民幣0.025元（2016年：每股人民幣0.02元）。該建議末期股息（如獲批准）將約於2018年6月15日派付予於2018年6月1日名列本公司股東名冊之股東。建議末期股息將以人民幣宣派並以港幣（「港幣」）支付。應付末期股息將按中國人民銀行於2018年5月10日至2018年5月16日期間所公佈人民幣兌港幣中間匯率平均價轉為港幣。

BUSINESS SEGMENTS

Property development

For the year ended 31 December 2017, the revenue of property development segment substantially decreased to RMB3,995.9 million, representing 91% of the total revenue, compared with RMB8,447.4 million, representing 97% of the total revenue for the year ended 31 December 2016. Revenue for the current year was mainly come from the sales of properties of Shanghai Shanshui Four Seasons, Hangzhou Jindu North Road, Shenyang Yijing and Shenyang Yuefang. The decrease in revenue mainly due to reduction in sales recognition of Shanghai Four Seasons. The profit in the property development segment during the current year decreased to RMB2,270.7 million, against RMB3,815.2 million for the previous year. The decrease in segment results was mainly due to profit reduced from Shanghai Shanshui Four Seasons project which partially offset by higher profit shared from joint ventures in the current year.

Property investment and management

The revenue earned by the property investment and management segment for the year ended 31 December 2017 increased from RMB259.3 million, representing 3% of the total revenue for the year ended 31 December 2016, to RMB385.2 million representing 9% of the total revenue. The increase in the revenue for the current year was mainly contributed by higher property management fee income of RMB70.7 million from the new acquired property management subsidiaries. During the year under review, the property investment and management segment recorded a profit of RMB806.5 million, including fair value gains of investment properties of RMB545.8 million and share of profits from joint ventures of RMB193.6 million which mainly resulted from fair value gains of investment properties, compared with the segment profit of RMB325.5 million for the corresponding period, including fair value gains of investment properties of RMB259.8 million.

業務分部

物業發展

截至2017年12月31日止年度，物業發展分部之收入大幅下降至人民幣3,995,900,000元，佔總收入之91%，相對截至2016年12月31日止年度之收入則為人民幣8,447,400,000元，佔總收入之97%。本年度收入主要來自上海山水四季城、杭州金渡北路、瀋陽藝境及瀋陽悅峰之物業銷售收入。收入下降主要由於上海山水四季城銷售確認減少。本年度物業發展分部之溢利由上年度人民幣3,815,200,000元減少至人民幣2,270,700,000元。分部業績下降之主要原因乃山水四季城項目利潤減少所致，而應佔合營公司之溢利增加抵銷了部份物業發展分部溢利之減少。

物業投資及管理

物業投資及管理分部獲得之收入由截至2016年12月31日止年度之人民幣259,300,000元，佔總收入3%，增加至截至2017年12月31日止年度之人民幣385,200,000元，佔總收入之9%。上升之收入主要來自新收購之物業管理附屬公司之物業管理費收入上升人民幣70,700,000元。本年度內之物業投資及管理分部錄得溢利人民幣806,500,000元，包括投資物業公允值收益人民幣545,800,000元及應佔合營公司溢利人民幣193,600,000元，其主要為投資物業公允值溢利，相對上年度錄得分部溢利人民幣325,500,000元，包括投資物業公允值收益人民幣259,800,000元。

Financial Review

財務回顧

SHAREHOLDERS' FUNDS

The Group's total shareholders' funds increased from RMB9,651.6 million as at 31 December 2016 to RMB10,914.8 million as at 31 December 2017. The increase was contributed by profit attributable to owners of the Company for the current year of RMB1,643.5 million which was partially offset by the final dividend declared for the year ended 31 December 2016 of RMB315.9 million. On a per-share basis, the consolidated net asset value attributable to owners of the Company as at 31 December 2017 increased by RMB0.077 or 13% to RMB0.688, against RMB0.611 as at 31 December 2016. The total shareholders' funds constituted approximately 25% of the total assets of RMB43,668.8 million as at 31 December 2017, against 30% of the total assets of RMB32,167.3 million as at 31 December 2016.

FINANCIAL RESOURCES, LIQUIDITY AND CAPITAL STRUCTURE

Liquidity and capital resources

The Group's deposits, bank and cash balances increased by 87% to RMB5,395.8 million as at 31 December 2017 from RMB2,893.0 million as at 31 December 2016. The increase was mainly from the proceeds from properties sales and new bank borrowings, netting off with cash applied to land acquisitions, payment of development costs of PRC property projects, repayments of loans from the ultimate holding company, payment of final dividend as well as acquisition/set up of joint ventures and associates.

Borrowings

As at 31 December 2017, total bank and other borrowings of the Group was RMB1,556.8 million with interest rates ranging from 3.1% to 4.3% per annum. The Group arranged two short-term bank loan facilities, one long-term bank loan facility and one long-term other borrowing totally amounting to RMB1,015.6 million during the current year for property acquisition and general working purpose. Meanwhile, the Group fully repaid two 1-year term loan facilities, totally approximately RMB140.7 million.

股東資金

本集團之股東資金總額由2016年12月31日人民幣9,651,600,000元增至2017年12月31日人民幣10,914,800,000元。有關增加乃來自本年度本公司持有人應佔溢利人民幣1,643,500,000元，部份溢利因宣派截至2016年12月31日止年度末期股息人民幣315,900,000元而被抵銷。按每股基準計算，本公司持有人應佔綜合資產淨值由2016年12月31日之人民幣0.611元上升至2017年12月31日之人民幣0.688元，增加人民幣0.077元或13%。於2017年12月31日，股東資金總額約佔資產總額人民幣43,668,800,000元之25%，而2016年12月31日則佔資產總額人民幣32,167,300,000元之30%。

財務資源、流動資金及資本架構

流動資金及資本資源

本集團之存款、銀行及現金結餘由2016年12月31日人民幣2,893,000,000元增加87%至2017年12月31日人民幣5,395,800,000元。增加之原因主要乃收取來自物業銷售所得款以及新增銀行及貸款，扣除用於購買土地、支付國內物業發展項目之開發成本、償還最終控股公司貸款、支付末期股息，以及收購／成立合營公司及聯營公司。

貸款

於2017年12月31日，本集團之銀行及其他貸款總額為人民幣1,556,800,000元，年利率介乎3.1%至4.3%。本集團於本年度內安排了兩項短期銀行貸款融資，一項長期銀行貸款融資以及一項長期其他貸款，合共人民幣1,015,600,000元，用以收購物業及日常營運資金所需。同時，本集團全數償還兩項一年定期貸款融資，合計約人民幣140,700,000元。

The net debt (measured by total borrowings minus cash and bank deposits excluding restricted cash) decreased by RM3,182.3 million to RMB4,148.8 million as at 31 December 2017 from RMB7,331.1 million as at 31 December 2016. The decrease in net debt was mainly due to more cash received from sale of properties during the year. The Group's net debt ratio (defined as net debt over total equity, including non-controlling interests) decreased to 32% as at 31 December 2017, from 63% as at 31 December 2016.

債務淨額(以貸款總額減現金及銀行存款(不包括受限制現金)計算)於2017年12月31日為人民幣4,148,800,000元,較2016年12月31日人民幣7,331,100,000元,減少人民幣3,182,300,000元。債務淨額減少主要因本年度收取大量銷售物業款項。本集團之債務淨額比率(定義為債務淨額除以權益總額,包括非控股股東權益)由2016年12月31日之63%下降至2017年12月31日之32%。

FINANCIAL MANAGEMENT

Foreign currency risk

As at 31 December 2017, borrowings were denominated in United States dollars ("US\$"), RMB and HK\$. The Group mainly operates in the Mainland China and most of the transactions, assets and liabilities are denominated in RMB. The Group is exposed to foreign currency risk due to the exchange rate fluctuation of RMB against HK\$ and US\$. Moderate depreciation of RMB against HK\$ and US\$ was expected, the Group considered the foreign currency risk exposure is acceptable. The Group will review and monitor its currency exposure from time to time and when appropriate hedge its currency risk.

Interest rate risk

As at 31 December 2017, 72% of borrowings of the Group were on a floating rate basis (2016: 67%). However, the interest rate risk exposure was considered acceptable and no hedging was considered necessary. The Group will continue to monitor the suitability and cost efficiency of hedging instrument (including interest rates swaps) and consider a mix of fixed and floating rate borrowings in order to manage interest rate risk.

財務管理

外匯風險

於2017年12月31日，貨款按美元、人民幣及港幣記賬。本集團主要於中國大陸內經營業務，大部份交易、資產及負債按人民幣記賬。本集團就人民幣兌港幣及美元之匯率波動承受外匯風險。預期人民幣兌港幣及美元之匯率有適量之貶值，但本集團認為有關外匯風險仍可接受。本集團將不時檢討及監察貨幣風險，並於適當時候對沖其貨幣風險。

本集團於2017年12月31日及2016年12月31日尚未償還之貸款按記賬貨幣分類概述如下：

利率風險

於2017年12月31日，本集團72%（2016年：67%）貸款按浮動利率計息。然而，利率風險被視為可接受，故毋須考慮對沖。本集團將繼續監控對沖工具（包括利率掉期）之適當性及成本效益，以及考慮固定及浮動利率組合貸款之需要，以便管理其利率風險。

PLEDGE OF ASSETS

At 31 December 2017, an investment property and a property held for sale of the Group with a carrying value of RMB196,745,000 (2016: RMB183,969,000) and RMB303,918,000 (2016: Nil) respectively were pledged to secure other borrowings granted to the Group.

CONTINGENT LIABILITIES

(a) As at 31 December 2017, the Group provided guarantees to certain banks in respect of mortgage granted by banks relating to the mortgage loans arranged for purchasers of the Group's properties. Pursuant to the terms of the guarantees, upon default in mortgage payments by these purchasers, the Group is responsible for repaying the outstanding mortgage principals together with the accrued interest and penalty owed by the defaulting purchasers to the banks and the Group is entitled but not limited to take over the legal titles and possession of the related properties. The Group's guarantee period starts from the dates of grant of the relevant mortgage loans and ends upon issuance of the real estate ownership certificates. As at 31 December 2017, the Group's outstanding guarantees amounted to RMB3,148,594,000 (2016: RMB639,580,000).

The Directors consider that the fair value of the guarantees is not significant and in case of defaulting payments, the net realisable value of the related properties will be sufficient to cover the outstanding mortgage principals, the accrued interest and penalty. Therefore, no provision has been made in the financial statements for the year ended 31 December 2017 (2016: Nil) for these guarantees.

(b) At the end of the reporting period, a maximum guarantee of US\$70,950,000 (equivalent to RMB463,601,000) (31 December 2016: US\$70,950,000 (equivalent to RMB492,180,000)) was borne by the Group to a group of financial institutions for a facility granted to a joint venture of the Group in the United States of America. As at 31 December 2017, the facility of RMB463,601,000 (31 December 2016: RMB414,641,000) guaranteed by the Group to a joint venture was utilised.

資產抵押

於2017年12月31日，本集團投資物業及待出售物業賬面值分別為人民幣196,745,000元（2016年：人民幣183,969,000元）及人民幣303,918,000元（2016年：無）已予抵押，以獲取向本集團授出之其他貸款。

或然負債

(a) 於2017年12月31日，就銀行提供按揭貸款予本集團物業之買家，本集團向若干該等銀行提供擔保。根據擔保條款，若該等買家拖欠按揭款項，本集團有責任向銀行償還該等買家拖欠之未償還按揭本金連同應付利息及罰款，而本集團有權但不限於接管有關物業之法定所有權及其擁有權。本集團之擔保期限由提供相關按揭貸款當日開始至出具物業房產證為止。於2017年12月31日，本集團尚未結清之擔保為人民幣3,148,594,000元（2016年：人民幣639,580,000元）。

董事考慮擔保之公允值並不重大，並且倘出現買家拖欠款項時，有關物業之可變現淨值將足以彌補未償還按揭本金、應付利息及罰款，因此，截至2017年12月31日止年度並無就該等擔保於財務報表內計提撥備（2016年：無）。

(b) 於本報告期末，就一組金融機構授出融資予本集團一家美國合營公司，本集團向該組金融機構承擔最高擔保額美元70,950,000（相等於人民幣463,601,000元）（2016年12月31日：美元70,950,000（相等於人民幣492,180,000元））。於2017年12月31日，由本集團擔保而提供予合營公司之融資已動用人民幣463,601,000元（2016年12月31日：人民幣414,641,000元）。

LAND BANK

The management of the Group believes that owning a sizable and quality land bank is one of the most important factors for a property developer to be successful. Timing for acquisition of land bank at competitive pricing is the core successful factor of the Group.

The Group has significantly increased its land bank with a projected gross floor area (“GFA”) of approximately 13.71 million square meters, under which approximately 21% were located in first tier cities – Beijing, Guangzhou, Shanghai and Shenzhen, and approximately 71% were located in second tier cities which includes Changsha, Hangzhou, Kunming, Kunshan, Nanjing, Qingdao, Tianjin, Wuhan etc, as well as 8% being located in third tier cities including Huaian, Taicang and Taiyuan.

The Group’s land bank distribution in the PRC are summarised below:

土地儲備

本集團管理層相信，擁有具規模及優質的土地儲備對物業發展商來說是最重要的成功因素之一，而適時以具競爭力的價格收購土地儲備更是本集團的成功關鍵。

本集團的土地儲備大幅增加至約1,371萬平方米的預計總樓面面積（「總樓面面積」），其中約21%位於北京、廣州、上海及深圳一線城市，約71%位於包括長沙、杭州、昆明、崑山、南京、青島、天津、武漢等二線城市，8%則位於包括淮安、太倉、太原等三線城市。

Land acquisition in 2017

In 2017, the Group acquired interests in a total of 25 new projects in the PRC, with total planned GFA of approximately 4,061,000 square meters, out of which 1,878,000 square meters were attributable to the Group's equity interests. Total consideration for the land acquisition in 2017 amounted to approximately RMB30,993 million, out of which RMB12,411 million were payable by the Group according to its equity interests in relevant projects. Based on the Group's attributable GFA acquired and its attributable acquisition considerations, the Group's average land acquisition cost in 2017 was approximately RMB6,600 per square meter.

Properties sales and development

With more available properties for sale and the Group's high quality residential/commercial projects continued to attract medium to high income level end-users as well as various property projects of the Group located in developed cities, such as Beijing, Ningbo, Shanghai and Tianjin, achieved outstanding sales performance, the sales performance was remarkable in 2017. For the year ended 31 December 2017, the aggregated contracted sales of the Group reached RMB45.28 billion with an aggregated contracted sales area of approximately 2,478,000 square meters, representing a remarkable growth of about 120% in both contracted sales amount and sales area. The average selling price during the year was approximately RMB18,300 per square meter.

Property leasing

As at 31 December 2017, Vision Shenzhen Business Park Phases 1 and 2, located in Nanshan District, Shenzhen and provides rental area of about 127,000 square meters, was 100% occupied and their rental yield and management quality were a representative project in the core area of Nanshan District. Besides, both of the Beijing Sohu.com Internet Plaza (a project 60% owned by the Group), located at Tsinghua Science Park in Zhongguancun, Haidian District, Beijing and the Bridge 8 project in Shanghai (a project 85% owned by the Group) were also 100% occupied. In addition, the Hangzhou commercial project commenced operations in the second half of the year. As at 31 December 2017, this project was also nearly 100% occupied.

During the year, benefiting from the significant increase in the number of the commercial property commencing operation, the Group achieved a growth of rental/management fees revenue of more than 50% to RMB356 million for the year ended 31 December 2017.

Currently, the commercial projects under development includes Suzhou, Nanjing and Huai'an commercial complex projects, the Shanghai commercial project, Vision Shenzhen Business Park Phase 3 in Shenzhen Nanshan district as well as the five new business parks in Shanghai. Upon completion, our commercial property portfolio would generate more than RMB1 billion annual rental income/management fees to the Group.

物業銷售及發展

由於本集團可供出售物業持續增加，而本集團的優質住宅／商業項目繼續獲得中高收入水平最終用戶的青睞，加上本集團在北京、寧波、上海、天津等發達城市的各物業項目均取得優異的銷售業績，推動本集團於2017年錄得卓越銷售表現。截至2017年12月31日止年度，本集團累計合約銷售總額達人民幣452.8億元，累計合約銷售面積約247.8萬平方米，兩者均較上年度躍升逾1.2倍，年內銷售均價為每平方米約人民幣18,300元。

物業租賃

於2017年12月31日，位於深圳南山區的深圳威新科技園第一、二期，提供出租面積約127,000平方米，出租率達100%，無論是租金收益還是管理品質都是南山核心區域具代表性的項目。此外，本集團持有60%權益位於北京海澱區中關村清華科技園的搜狐網路大廈及持有85%權益的上海8號橋項目的出租率亦達100%。此外，杭州商管項目於下半年投入營運。於2017年12月31日，該項目出租率亦近乎100%。

年內，受惠於開始營運的商業物業數量大幅增加，截至2017年12月31日止年度，本集團錄得租金／管理費收入增長超過50%至人民幣3.56億元。

目前正開發的商業項目包括位於蘇州、南京和淮安的商業綜合體項目、上海商業項目、深圳南山區深圳威新軟件科技園第三期以及上海5個新商業園。竣工後，本集團的商業地產業務將每年為本集團帶來超過人民幣10億元的租金／管理費收入。

The Company has taken steps to adopt the principles and comply with the code provisions of the Corporate Governance Code (the “CG Code”) set out in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). The Board has reviewed periodically the compliance of the CG Code and is of the view that throughout the year ended 31 December 2017 (“FY2017”), the Company has complied with the applicable code provisions of the CG Code, except for the following deviations:

1. Under CG Code A.6.7, independent non-executive directors and other non-executive directors should attend general meetings and develop a balanced understanding of the view of shareholders. Due to other pre-arranged business commitments which must be attended by the Directors, Mr. Loh Lian Huat, Ms. Zhang Feiyun and Mr. Hu Chunyuan were not able to attend the general meeting of the Company held on 29 May 2017.
2. Under CG Code E.1.2, the chairman of the board should attend the annual general meeting of the company. Due to other pre-arranged business commitments which must be attended by Mr. Huang Juncan, he was not able to attend the annual general meeting of the Company held on 29 May 2017.
3. Under CG Code A.1.1, board meeting should be held at least four times a year at approximately quarterly intervals. During the year, only two regular board meetings were held to review and approve the annual and interim results of the Company. The Company does not announce its quarterly results and hence does not consider the holding of quarterly meetings as necessary. Management supplied adequate and timely information to the board and the Directors can make further enquiries to the senior management from time to time to ensure that they are provided with sufficient information to fulfil their directors' duties.

企業管治

本公司（連同其附屬公司，「本集團」）致力維持高水平之企業管治常規，強調高質素之董事會、有效之內部監控、良好之原則和慣例，且具高透明度及對本公司全體股東（「股東」）負責，保障股東的利益及提高本集團的表現。

本公司依據香港聯合交易所有限公司證券上市規則（「上市規則」）附錄十四所載之企業管治守則（「企管守則」）採納該等原則之步驟，並遵照守則條文。董事會已定期審閱企管守則，並認為在截至2017年12月31日止年度（「2017年度」）內，除以下提述之偏離外，本公司已遵照企管守則之適用守則條文：

1. 根據企管守則A.6.7，獨立非執行董事及其他非執行董事應出席股東大會，並對股東之意見有公正之了解。鑒於部份董事必須出席其他已事先安排之業務承諾，故此Loh Lian Huat先生、張斐雲女士及胡春元先生未能出席本公司於2017年5月29日舉行之股東大會。
2. 根據企管守則E.1.2，董事會主席應出席公司的股東周年大會。鑒於黃俊燦先生必須出席其他已事先安排之業務承諾，故此未能出席本公司於2017年5月29日舉行之股東周年大會。
3. 根據企管守則A.1.1，每年應最少舉行四次董事會會議，大約每季舉行一次。年內，僅舉行兩次董事會常規會議以審閱及批准本公司年度及中期業績。本公司並無公佈其季度業績，故此認為毋須每季舉行會議。管理層不時向董事會提供充足的適時資料，董事亦可不時向高級管理人員作進一步查詢，以確保他們獲提供足夠信息履行其董事職責。

The three INEDs represent one-third of the Board. The Board possesses a mix and balance of skills and experience which are appropriate for the requirements of the business of the Company. The opinions raised by the INEDs in Board meetings facilitate the maintenance of good corporate governance practices. One of the INEDs has the appropriate professional qualification and accounting and audit experience and expertise as required by Rules 3.10(2) of the Listing Rules. A balanced composition of executive Directors, NEDs and INEDs also generates a strong independent element on the Board, which allows for an independent and objective decision making process for the best interests of the Company and its shareholders. The Company will review the composition of the Board from time to time to ensure that the Board possesses the appropriate and necessary expertise, skills, diversity of perspective and experience to meet the needs of the Group's business and to enhance the shareholders' value.

All NEDs (including INEDs) are appointed with specific term of not more than three years and all Directors are appointed with letters of appointment and subject to retirement by rotation and, being eligible, offer themselves for re-election at the annual general meetings in accordance with the Bye-laws of the Company. Bye-law 109(A) and 189(vii) of the Company's Bye-laws provides that at each annual general meeting, one-third of the Directors for the time being (or if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. Also, pursuant to Bye-law 100 of the Company's Bye-laws, any Director appointed to fill a casual vacancy or as an addition to the Board is subject to re-election at the next following general meeting.

The Company has received from each INED an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules and the Company considers that all the three INEDs are independent.

Directors and officers' policy

The Company has arranged appropriate Directors and officers liability insurance to indemnify its Directors and officers against liabilities arising out of legal action on corporate activities. Such insurance coverage is reviewed and renewed on an annual basis.

The Directors attend meetings in persons or through other means of electronic communication in accordance with the Bye-laws of the Company.

Relationships and associations among the Directors

Each of the executive Directors is also a director and/or top management of Gemdale Corporation (金地(集團)股份有限公司), which is the holding company of Glassy An Limited. Glassy An Limited is the controlling shareholder of the Company.

Save as disclosed above, there was no relationship between members of the Board (including financial, business, family or other material/relevant relationship(s)).

Chairman and Chief Executive Officer

The Chairman of the Board is Mr. Huang Juncan and the Chief Executive Officer is Mr. Xu Jiajun. The positions of the Chairman and the Chief Executive Officer are held by separate individuals with a view to maintaining an effective segregation of duties between the management of the Board and the day-to-day management of the Group's business and operations.

One of the important roles of the Chairman is to provide leadership for the Board to ensure that the Board always acts in the best interest of the Group. The Chairman shall ensure that the Board works effectively and fully discharges its responsibilities, and provides leadership for the Board in setting objectives and strategies, and ensure good corporate governance practices are enforced as well as all key issues are discussed by the Board in a timely manner. The Chairman has taken into account, where appropriate, any matters proposed by the Directors for inclusion in the agenda. The Chairman has delegated the responsibility of drawing up the agenda for each board meeting to the Chief Executive Officer and the Company Secretary. With the support of the Chief Executive Officer and the Company Secretary, the Chairman seeks to ensure that all Directors are properly briefed on issues arising at Board meetings and have received adequate and reliable information in a timely manner. The Chief Executive Officer is responsible for leading the management of the Company in conducting its business affairs in accordance with the Company's objectives, and implementing the Group's strategies and policies.

On appointment to the Board, each newly appointed Director receives a comprehensive induction package covering business operations, policy and procedures of the Company as well as the general, statutory and regulatory obligations of being a Director to ensure that he/she is sufficiently aware of his/her responsibilities under the Listing Rules and other relevant regulatory requirements.

The Directors are regularly briefed on the amendments to or updates on the relevant laws, rules and regulations. In addition, the Company has been encouraging the Directors and senior executives to enroll in a wide range of professional development courses and seminars relating to the Listing Rules, companies ordinance/act and corporate governance practices organized by professional bodies, independent auditors and/or chambers in Hong Kong so that they can continuously update and further improve their knowledge and skills.

From time to time, Directors are provided with written materials to develop and refresh their professional skills. The Company Secretary also organises and arranges seminars on the latest development of applicable laws, rules and regulations for the Directors to assist them in discharging their duties. During the year, all Directors, namely, Mr. Ling Ke, Mr. Huang Juncan, Mr. Xu Jiajun, Mr. Wei Chuanjun, Mr. Loh Lian Huat, Ms. Zhang Feiyun, Mr. Hui Chiu Chung, Mr. Chiang Sheung Yee, Anthony and Mr. Hu Chunyuan have received the requisite directors' training/materials in compliance with the requirement of the CG Code on continuous professional development.

In addition, all Directors are provided with monthly updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties.

RESPONSIBILITY OF DIRECTORS AND MANAGEMENT

The Board is responsible for ensuring continuity of leadership, development of sound business strategies, availability of adequate capital and managerial resources to implement the business strategies adopted, adequacy of systems of financial and internal control and conduct of business in conformity with applicable laws and regulations. All Directors have made full and active contribution to the affairs of the Board and the Board has always acted in the best interest of the Group.

The executive Directors and senior management are delegated with respective levels of authorities with regard to key corporate strategy and policy and contractual commitments. Management is responsible for the day-to-day operations of the Group with divisional heads responsible for different aspects of the business.

The Board considers that in preparing the financial statements, the Group has applied the appropriate accounting policies that are consistently adopted and made judgements/estimates that are reasonable and prudent in accordance with the applicable Hong Kong Financial Reporting Standards, as issued by the Hong Kong Institute of Certified Public Accountants. The publication of the financial statements of the Group is also in a timely manner.

The Board, having made appropriate enquiries, is of the view that the Group has adequate resources to continue in operational existence for the foreseeable future and that, for this reason, it is appropriate for the Group to adopt the going concern basis in the preparation of the financial statements.

董事會及管理層之責任

董事會須負責確保領導之延續性、發展健全之業務策略、具備充裕資金及管理資源，以落實採納之業務策略、財務及內部監控系統之完備性，且業務運作符合適用法律法規。全體董事已對董事會事務作出完全及積極貢獻，而董事會亦經常以本集團之最佳利益行事。

The Board has established three board committees, namely, the audit committee, remuneration committee and nomination committee, each of which has the specific written terms of reference that will be reviewed and updated periodically where necessary. Copies of minutes of all meetings and resolutions of the board committees are kept by the Company Secretary and are open for inspection at reasonable time on reasonable notice by any Director. Each board committee is required to report to the Board on its decisions and recommendations, where appropriate. Each board committee is also provided with sufficient resources to discharge its duties and has access to independent professional advice at the Company's expense according to the Company's policy, if necessary.

Audit Committee

The audit committee of the Board (the "Audit Committee") has been established with specific written terms of reference stipulating its authorities and duties in compliance with Rule 3.21 of the Listing Rules, which are available on the websites of the Company (www.gemdalepi.com) and HKExnews (www.hkexnews.hk). The Audit Committee currently comprises Mr. Hu Chunyuan (Chairman of the committee), Mr. Hui Chiu Chung and Mr. Chiang Sheung Yee, Anthony. All Audit Committee members are INEDs.

The functions of the Audit Committee are, among other things, responsible for assisting the Board to ensure objectivity and credibility of financial reporting, including interim and final results, and that the Directors have exercised the care, diligence and skills prescribed by law when presenting the Group's results to the shareholders. The Audit Committee is also responsible for assisting the Board to ensure effective risk management and internal control systems of the Group are in place and good corporate governance standards and practices are maintained within the Group and to monitor the internal and external audit functions and to make relevant recommendations to the Board to ensure effective and efficient operations and reliable reporting. The functions of the Audit Committee will be reviewed regularly by the Board and amended from time to time, as and when appropriate, in order to ensure compliance with the applicable code provisions of the CG Code (as amended from time to time). The Company has internal control procedures to ensure that the continuing connected transactions will be conducted in compliance with the Listing Rules.

ACCOUNTABILITY AND AUDIT

The Directors acknowledge their responsibility for preparing the financial statements which give a true and fair view and are in compliance with Hong Kong Financial Reporting Standards, statutory requirements and other regulatory requirements. As at 31 December 2017, the Board was not aware of any material misstatement or uncertainties that might put doubt on the Group's financial position or continue as a going concern. The Board endeavours to ensure a balanced, clear and understandable assessment of the Group's performance, position and prospects in financial reporting.

A statement by the external auditors of the Company relating to its reporting responsibilities on the financial statements of the Company is set out on pages 103 to 109 of this annual report. There are no material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board is responsible for overseeing the Group's risk management and internal control systems to safeguard the Company's assets and shareholders' interests, and reviewing their effectiveness annually through the Audit Committee. The Audit Committee assists the Board in fulfilling its oversight and corporate governance roles in the Group's financial, operational, compliance, risk management and internal control, and the resourcing of the finance and internal audit functions. The internal audit department of the holding company of the Company together with the legal department of the Group ("**Internal Audit Departments**") assist the Board and/or the Audit Committee in the review of the effectiveness of the Group's risk management and internal control systems on an ongoing basis. The Directors through the Internal Audit Departments are kept regularly apprised of significant risks that may impact on the Group's performance. The internal audit function is independent of the operating businesses of the Group.

The Internal Audit Departments would review the effectiveness and adequacy of the risk management and internal control procedures, and the findings will be provided to the Audit Committee to assist them in performing their annual reviews. The Audit Committee can make enquiries with the management from time to time to ensure that they are provided sufficient information to review the internal control procedures.

The Group has in place an organisational structure with defined lines of responsibility and delegation of authority. There are established policies and procedures for financial planning and budgeting; for information and reporting systems; for assessment of risk; and for monitoring the Group's operations and performance. The information systems in place are designed to ensure that the financial information reported is up to date and reliable. In addition, the Company will engage independent consultants to conduct review of the risk management and internal control system of the Group as and when necessary. The Board is responsible for approving and overall reviewing internal control policy while the responsibility of day-to-day management of operational risks lies with the management.

The systems and internal control are designed to manage, rather than eliminate the risk of failure to achieve business objectives so as to help safeguard the Group's assets against fraud and other irregularities and can only provide reasonable and not absolute assurance against material misstatement or loss. In addition, it should provide a basis for the maintenance of proper and fair accounting records and assist in the compliance with relevant rules and regulations.

During the year, the Board conducted an annual review on all material measures on risk management and internal control, including financial, operational and compliance control and risk management function. It also reviewed with Audit Committee and the information from the Internal Audit Departments in respect of the effectiveness and adequacy of the Group's risk management and internal control system, adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function and satisfied that they were effective and adequate as well as in compliance with our policies.

The Group considered that internal control should be adapted to the size, scope of business, competitive and risk level of the Group and adjusted in a timely manner followed by circumstances change. The Group will continue to improve the risk management and internal control system, standardise its implementation, strengthen internal supervision and inspection so as to promote the sustainable development of the Group.

Procedures for Shareholders to convene a special general meeting (“SGM”)

Pursuant to the Company’s Bye-laws and the Companies Act 1981 of Bermuda (“**Companies Act**”), registered Shareholders holding not less than one-tenth (10%) of the paid-up capital of the Company carrying the right of voting at general meetings of the Company (“**SGM Requisitionists**”) can deposit a written request to convene a SGM at the registered office of the Company (“**Registered Office**”), which is presently situated at Canon’s Court, 22 Victoria Street, Hamilton HM12, Bermuda. The SGM Requisitionists must state in their request(s) the objects of the SGM and such request(s) must be signed by all the SGM Requisitionists and may consist of several documents in like form, each signed by one or more of the SGM Requisitionists.

The share registrars of the Company (the “**Share Registrars**”) will verify the SGM Requisitionists’ particulars in the SGM Requisitionists’ request. Promptly after confirmation from the Share Registrars that the SGM Requisitionists’ request is in order, the Company Secretary will arrange with the Board to convene a SGM by serving sufficient notice to all the registered Shareholders in accordance with all the relevant statutory and regulatory requirements. On the contrary, if the SGM Requisitionists’ request is verified not in order, the SGM Requisitionists will be advised of the outcome and accordingly, a SGM will not be convened as requested.

The SGM Requisitionists, or any of them representing more than one-half of the total voting rights of all of them, may themselves convene a SGM if within 21 days of the deposit of the SGM Requisitionists’ request, the Board does not proceed duly to convene a SGM provided that any SGM so convened is held within three (3) months from the date of the original SGM Requisitionists’ request. A SGM so convened by the SGM Requisitionists shall be convened in the same manner, as nearly as possible, as that in which meetings are to be convened by the Company.

Procedures for Shareholders to put forward proposals at a general meeting

Pursuant to the Companies Act, either any number of the registered Shareholders holding not less than one-twentieth (5%) of the paid-up capital of the Company carrying the right of voting at general meetings of the Company (“**Requisitionists**”), or not less than 100 of such registered Shareholders, can request the Company in writing to (a) give to Shareholders entitled to receive notice of the next general meeting notice of any resolution which may properly be moved and is intended to be moved at that meeting; and (b) circulate to Shareholders entitled to have notice of any general meeting any statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at that meeting.

The requisition signed by all the Requisitionists may consist of several documents in like form, each signed by one or more of the Requisitionists; and it must be deposited at the Registered Office with a sum reasonably sufficient to meet the Company's relevant expenses, not less than six weeks before the meeting in case of a requisition requiring notice of a resolution or not less than one week before the meeting in the case of any other requisition, provided that if an annual general meeting is called for a date six weeks or less after the requisition has been deposited, the requisition though not deposited within the time required shall be deemed to have been properly deposited for the purposes thereof.

This Environmental, Social and Governance (ESG) Report has been prepared in compliance with the ESG Reporting Guide set out in Appendix 27 of the Main Board Listing Rules on The Hong Kong Exchanges and Clearing Limited. Major stakeholders within the Group, including the management and relevant employees, have jointly participated in preparing this ESG Report, which evaluates the importance of relevant ESG issues on the reporting principle of importance, equilibrium and consistency.

This ESG Report (the “**Report**”) covers ESG issues related to property development, property investment and management business of Gemdale Properties and Investment Corporation Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) from 1 January 2017 to 31 December 2017 (the “**Reporting Period**” or “**FY2017**”). Unless otherwise specified, the information disclosed in this Report includes five major real estate subsidiaries, namely Shanghai Zhong Jun Real Estate Development Co., Ltd.* (上海仲駿房地產開發有限公司), Vision (Shenzhen) Software Technology Co., Ltd.* (深圳威新軟件科技有限公司), Hangzhou Vision Real Estate Development Co., Ltd.* (杭州威新房地產開發有限公司), Shenyang Gemdale Huacheng Property Co., Ltd.* (瀋陽金地華城置業有限公司) and Shenyang Gemdale Yuefeng Real Estate Development Co., Ltd.* (瀋陽金地悅峰房地產開發有限公司). These projects are the core of the Group’s business, contributing to over 70% of the Group’s revenue in total in 2017.

The Group determines the following ESG reporting scope according to the importance of the environmental, social and governance subject areas to the Group’s business:

A. ENVIRONMENTAL

A1. Emissions

The Group is a real estate company specialised in property development, property investment and management. The Group understands that the Group's business development will exert certain impact on the surrounding environment, therefore the Group has always regarded environmental protection as a significant commercial consideration, and thus to provide customers of our projects and other stakeholders with a natural and unspoiled environment.

Environmental assessment on property development projects

All property development projects of the Group are outsourced to professional third-party contractors, so the Group does not directly produce any major emissions (such as exhaust fumes, sewage) as a result of its project developments. Nevertheless, the Group still bears the responsibility for supervising outsourced contractors. During the field construction process of the projects, the Group entrusts third-party engineering consulting companies to conduct on-site inspections on the environmental protection situation, working environment and safety conditions periodically, ensuring environmental protection measures for the projects are continuously monitored and all non-compliance with standards are improved in time. In addition, the Group has integrated the green design concepts into its projects, and put in our best efforts to adhere to the one-star design standards of China's Assessment Standards for Green Building. The Group has even obtained one-star certifications for green building designs for several of our projects.

A. 環境

A1. 排放物

本集團為一家專注於物業發展、物業投資及物業管理的房地產公司。本集團明白本集團的業務發展會為周邊範圍帶來一定的影響，因此本集團一直視環境保護為重要的商業考量，務求各項目的客戶以及其他持份者能夠享有自然、不受破壞的環境。

房地產開發項目環境評估

本集團所有的房地產開發項目均外判予專業的第三方承建商負責，故本集團於項目開發過程中並沒有大量的直接廢氣及污水等排放。儘管如此，本集團亦負起監管承建商的責任，在各項目現場施工的過程當中，本集團委託第三方工程顧問公司定期對現場環保狀況、工作環境和安全狀況進行檢查，確保工程的環保措施受到持續監控，所有不合標準的地方亦能得到及時改善。此外，本集團把綠色理念融入項目設計當中，盡可能按照中國《綠色建築評價標準》一星標準配置，部份項目地塊更因而取得綠色建築設計一星認證證書。

Environmental protection measures for property management

In terms of property management, the Group has implemented many environmental protection policies and encouraged outsourced property management personnel, renters and owners to carry out energy conservation and emission reduction measures. The Group entrusts Shenzhen Gemdale Property Management Co., Ltd. ("**Gemdale PM**") to take responsibility for property management of property development and commercial projects. Gemdale PM has passed the certifications of ISO9001/ISO14001/OHSAS18001, while its environmental protection work has been certified by international standards. Besides, Gemdale PM has cooperated for many years with Dongjiang Environmental Company Limited, which is recognised by Shenzhen Government. Dongjiang Environmental Company Limited is responsible for disposing of wastes produced from repair and maintenance of equipment and facilities during the property management process, and ensures the wastes from property management are disposed of properly. Property wastes warehouses are required to be established by each project's property management personnel, where waste oil, waste liquid, waste lighting and other wastes are to be collected and disposed of properly by a qualified environmental property company on a regular basis.

Waste disposal for renters and owners

In terms of waste disposal for offices, shopping malls and other projects, the Group requires the waste collector to first sort general wastes, collect recyclable and reclaimable wastes for recycling and clear-up other wastes for disposal. For certain wastes that require special treatment, such as food residues, the Group has also arranged separate spaces for special collection and temporary storage, and has set up various equipment to reduce the impact on the surrounding environment. The Group also requires the property management companies to engage qualified garbage disposal companies to clear-up and dispose of the wastes they produce.

物業管理環保措施

本集團於物業管理方面實施了多項環保政策，鼓勵外判物業管理人員和各租客、業戶推行節能減排措施。本集團委託深圳市金地物業管理有限公司（「**金地物業**」）負責開發物業和商業項目的物業管理工作。金地物業已取得ISO9001/ISO14001/OHSAS18001認證，於環保方面的工作得到國際標準認證。此外，金地物業多年來與受深圳政府認可的東江環保股份公司合作，並由東江環保股份公司負責處理在物業管理過程中，進行設備設施維修、保養等所產生的廢物，確保物業管理廢物得到合理處置。各項目的物業管理人員需設置物業廢棄物倉庫，集中收集廢油、廢液、廢舊燈管及其他有害廢棄物，定期交由合資格的環保公司處理。

租客及業戶廢物處理

對於辦公室、購物中心及其他項目的垃圾處理方面，本集團要求垃圾收集商首先對普通垃圾進行分類，對可以循環再用、回收再造的廢棄物進行回收處理，其他垃圾則進行清運處理。而對於某些需特別處理的垃圾，例如餐飲垃圾，本集團亦安排了獨立空間進行特別收集及暫存，並安裝一系列裝置減低此類垃圾對附近的影響。本集團亦要求物業管理公司委託合資格的垃圾處理公司對其產生的廢物進行清理和處理。

In terms of waste reduction, the Group requires property management companies to set up a used battery collection box at the waste collection site of the projects, where used batteries from employees and customers will be collected to reduce land pollution. The Group also requires wastes sorting and has put up posters in conspicuous places of the projects to encourage merchants, employees and customers to sort wastes and facilitate recycling.

On the other hand, the Group has also established corresponding control measures for oil fume emission and sewage treatment for catering renters in shopping malls. Whenever any renter applies for renovation, the Group will require the renter to install a two-stage oil fume filter system and three-stage oil and residue separator inside their store for oil fume and sewage treatment. The Group further requires the renters to clean up their kitchen exhaust hoods and oil separator every day as well as the smoke vents and kitchen ventilators regularly during their routine operation. Besides, the Group requires property management companies of the projects to engage an eligible environmental protection company to clean up and drain the public oil separation tank to ensure effective operation of these equipment.

Waste reduction measures within the Group

The Group also requires property management companies to use electronic records for their routine inspection work, and reduce the use of paper-based record forms. When it is necessary to use paper-based record forms, the quantity used must be checked carefully and printed in bulk to reduce the use of paper.

減少廢物產生方面，本集團要求物業管理公司於各項目的垃圾收集處設置廢舊電池收集盒，以收集僱員和客戶的廢舊電池，減低廢棄電池對土地的污染。本集團亦要求為垃圾桶分類，在各項目明顯位置貼出海報鼓勵商戶、僱員及客戶對廢物進行分類，方便回收。

另一方面，在針對購物中心的餐飲商戶油煙排放、污水處理方面，本集團亦訂立了相應的控制措施。在商戶提出裝修申請時，本集團即要求商戶在鋪內安裝兩級油煙淨化設備、三級隔油隔渣池等處理油煙及污水。而在日常經營中，本集團亦要求商戶每日清洗廚房排煙罩、清撈隔油池、定期清洗排煙煙道、抽油煙風機等。此外，本集團要求各項目的物業管理公司委託合資格的環保公司為公共隔油池進行清理和清撈處理，以確保這些裝置能夠有效地運作。

本集團內部減廢措施

另一方面，本集團也要求物業管理日常巡查工作採用電子方式記錄，減少使用紙張紀錄表。對必須使用的紙張記錄表格，需認真核對用量，批量印刷，減少紙張的使用。

In addition, the offices of the Group have implemented eco-office measures, including set up single-sided paper/waste paper recycling bin by the printer to strengthen the centralised collection and disposal of waste papers, old newspapers and magazines. Employees are also encouraged to communicate with each other via email and reduce the use of paper as much as possible. Paperless office are implemented by handling paperwork electronically, and reducing paper waste from to administrative work. The Group also raises individual environmental protection awareness for employees by posting labels such as “Save Disposable Tableware” and “Do Not Waste Paper” in the office’s pantries and restrooms to constantly remind employees of energy conservation and emission reduction.

The majority of waste¹ generated by the Group during the Reporting Period are one-time use paper products, such as used paper from administrative work and paper cups for guest reception which amounted up to 12 tonnes. The Group does not directly generate any hazardous waste.

The Group has compiled a range of environmental protection measures related to the property management process as well as environmental protection regulations related to the work of employees, enabling the Group’s employees and property management companies to comply with and promote such environmental protection measures among clients and customers, enhancing their awareness of environmental protection and encouraging its implementation.

The above measures have been duly implemented during the year and have led to successful results.

此外，本集團辦公室實行了環保辦公的措施，包括於印表機處設置單面紙／廢紙回收箱，加強廢紙、舊報紙雜誌的統一收集和處理；在對外聯繫中建立電郵通訊的習慣，盡可能減少紙張的使用；在辦公室實行無紙化，盡量把文書工作電腦化，減少行政工作所廢棄的紙張。本集團亦要求僱員提高個人環保意識，在辦公室茶水間及衛生間等張貼「節約即棄餐具」、「節約用紙」等標示，時刻提醒僱員節能減排。

本集團於報告期間內產生的主要廢棄物¹為行政辦公的紙張、接待用的紙杯等一次性紙製品，共計12噸。本集團並無直接產生有害廢棄物。

本集團編製了一系列與物業管理過程相關的環保方案以及與僱員工作相關的環保規範，讓本集團和物業管理公司的僱員依隨實行，並向各商戶、顧客等宣揚環保理念及鼓勵推行環保措施。

而報告期間上述各項措施均有切實執行，且成效顯著。

Carbon emissions

Greenhouse gas emissions of the Group mainly comes from the use of energy in daily office work and property management. During the Reporting Period, CO₂e generated by the Group was 1,224 tonnes in total (intensity: 5 tonnes of CO₂e per employee)². The Group implemented various energy conservation plans to reduce carbon footprint of the Group. Please refer to the below section headed "A2. Use of Resources".

During the Reporting Period, the Group is not aware of any violation of the Environmental Protection Law of the People's Republic of China or other applicable laws and regulations related to pollution.

A2. Use of Resources

The Group is committed to implementing an environment-friendly resources utilisation system, which targets at sustainable development and aims to realise green business. In order to protect the natural environment and prevent waste of resources, the Group has formulated different energy-saving and water utilisation reduction policies covering the subject areas of business operation and property management. The Group did not use any packaging materials during the Reporting Period.

本集團的溫室氣體排放主要來自於日常辦公及物業管理工作之能源使用。在本報告期間，本集團營運所產生的二氧化碳當量(CO₂e)共計1,224噸(密度：每位僱員5噸二氧化碳當量)²。本集團實行了不同的節能計畫以減低本集團的碳足跡，請參考下面的「層面A2. 資源使用」部份。

本報告期間內，本集團並無發現任何違反《中華人民共和國環境保護法》及其他環境相關的適用法例法規的情況。

A2. 資源使用

本集團致力執行環保的資源使用制度，以可持續發展為目標，實現綠色商業。為保護自然環境及避免浪費資源，本集團訂立了不同的節能及減少用水政策，覆蓋商業營運及物業管理各範疇。本集團於報告期間並無使用包裝材料。

Energy utilisation

Main forms of energy utilised by the Group are urban electricity and petroleum³. Electricity utilised by the Group during the Reporting Period amounted to a total of 1,473,952 kWh (intensity: 5,919 kWh per employee); petroleum utilised amounted to a total of 82,126 litres (intensity: 330 litres per employee). The Group understands that reducing energy consumption not only cuts greenhouse gas emissions but also reduces unnecessary expense for the Group. Therefore, the Group has implemented a number of energy conservation plans in order to enhance energy efficiency during the Reporting Period.

First, the Group has formulated the energy utilisation plan for property projects. Based on an intact system, this plan covers the aspects from equipment design to user awareness, and aims to improve the energy utilisation efficiency comprehensively. This plan requires working out the central air conditioner operating scheme and public utilities energy-saving solution for each operational project, which shall be adopted strictly upon approval by the Headquarters. The employees shall utilise electricity according to the energy-saving solution, so as to enhance the efficiency. The Headquarters will check regularly to ensure effective implementation of the energy-saving solution.

能源使用

本集團使用之能源主要為市電及汽油³。於本報告期間，本集團所使用的電力總共為1,473,952千瓦時（密度：每位僱員5,919千瓦時）；而所使用的汽油總量則為82,126升（密度：每位僱員330升）。本集團明白減少能源消耗不但能降低溫室氣體的排放，更能夠為本集團省去非必要開支。因此，本集團於報告期間實行了多項節能計畫以增加能源效益。

首先，本集團為各房地產項目制定能源使用計畫。該計畫涵蓋從設備設計至使用者意識建設等各個層面，以完善的體系全方位提高能源使用效益，包括要求各營運項目編製中央空調運作方案、公共設備節能方案等，經總部審批後落實並嚴格執行，讓僱員按節能方案用電，提高能效。總部亦會定期進行檢查確保節能方案有效地執行。

The Group requires keeping the public energy consumption records for each operational project and conducting statistics, analysis and improvement on public energy consumption every month. Such records will be submitted to the Headquarters for review, thus ensuring the management's regular supervision and inspection of energy consumption of each project. The Headquarters will establish energy consumption indices according to industry standards, compare with actual consumption of the projects, then improve and strengthen management of non-compliance projects. Furthermore, the Group will carry out maintenance and even energy-saving transformation on high energy-consuming equipment, such as air conditioner and lighting system on a regular basis according to energy consumption records, so as to enhance the efficiency of routine high energy-consuming equipment. The Group also has the air conditioning equipment in public areas of certain projects changed from dispersed control to concentrated control in order to reduce operation time and power consumption. The Group also prefers repairs over purchasing new equipment to reduce the amount of waste and save cost.

LED lighting and identification systems are installed in the underground parking lots of operational projects of the Group. Intelligent lighting systems are applied for public stairs of the projects with an aim to provide sufficient lighting with minimum power consumption. Air-conditioning systems of the projects use the building automated energy saving control systems, while water pumps of the air-conditioning system and water supply system use frequency conversion energy saving control systems to reduce any unnecessary energy consumption. After the aforesaid energy-saving measures had been adopted for the projects, approximately 11% public energy consumption has been saved, which has greatly reduced the impact on environment.

Green management is implemented within the Group, including controlling the use of energy-consuming office equipment, improving energy utilisation and operation efficiency and promoting energy-saving concepts among employees. These measures allow the Group to utilise energy and other resources efficiently, thus enhancing energy saving and emission reduction awareness of employees.

本集團要求各營運項目編製公共耗能紀錄，每月對公共耗能進行統計、分析及改善，並交由總部覆核，確保各項目的能源消耗得到管理層的定期監管。總部會按照行業標準建立能源消耗指標，並與各項目的實質消耗對比，對不達標項目進行改善和加強管理。另外，本集團會定期根據耗能紀錄對高耗能的設備，例如空調、照明等進行保養甚至節能改造，加強日常高耗能設備的效率。本集團亦將部份項目公共區域的空調設備由分散控制改為集中控制以減少執行時間及電能損耗，並以維修代替採購新設備以減少廢物數量和節約成本。

本集團的營運項目於地下停車場安裝節能的LED照明和標識系統，而項目的公共樓梯照明採用智慧照明系統，務求使用最少的電量提供足夠的照明。項目的空調系統使用樓宇自控節能控制，而空調系統水泵、供水系統水泵亦使用變頻節能控制，以減低不必要的能耗。項目實行上述措施後，節省公共能耗約百分之十一，大大減低對環境造成的負荷。

本集團內部亦推行綠色管理，包括減少辦公室設備閒置耗電的情況，改善能源使用及運作效率，向僱員宣揚推廣節省能源的概念等。此舉有助於本集團有效地使用能源及各種其他資源，並提高僱員的節能減排意識。

Apart from the energy-saving plan implemented during daily operations, the Group also focuses on reducing energy consumption from the source. The Group requires the outsourced contractors to adopt green construction solutions in order to reduce energy and raw materials consumption. In terms of raw materials, the Group endeavours to select renewable materials so as to reduce consumption of natural resources. In terms of project design, the Group also takes energy saving into consideration, for example, increasing the use of natural lighting, improving building ventilation to reduce the use of air-conditioning system.

Water resources utilisation

In terms of water resources, during the Reporting Period, the total water consumption of the Group was 39,295 cubic metres⁴ (intensity: 158 cubic metres per employee), which primarily consisted of water used for property management and daily living of employees.

The Group fully understands how valuable water resources is and therefore implements water saving plans to reduce water consumption through promoting water saving awareness among employees. The Group posts labels of "Please Save Water" in offices, work places, pantries and restrooms to advocate resources saving and promoting an eco-friendly working environment. Considering the substantial amount of water consumption for property management (including cleaning and landscaping), the Group has also taken relevant measures to supervise the water consumption of outsourced contractors. Referring to the actual work and previous records, the Group has established the water consumption index for outsourced contractors to follow and report monthly. Through this water consumption index, the Group can analyse the water consumption for property management work in order to timely supervise the outsourced contractors. The Group has also changed the landscape watering systems of certain projects into automatic sprinkling, reducing a significant amount on water consumption.

除了從日常營運方面執行節能計畫外，本集團亦著重從源頭降低能源消耗。本集團要求承建商使用綠色施工方案，減低能源及原材料的消耗。本集團盡量選用再生物料作為原材料，減少消耗自然資源。而項目設計方面，本集團亦加入節能考慮，例如增加自然光的採用以減少照明設備的使用，改善樓層通風以減少空調裝置的使用等。

水資源使用

在水資源方面，於本報告期間，本集團的總用水量為39,295立方米⁴（密度：每位僱員158立方米），主要為物業管理及員工生活用水。

本集團深明水資源的寶貴，故落實節水計畫以降低用水量，透過宣傳方式提高僱員節約用水的意識。本集團於辦公室及工作場所、茶水間、衛生間等地方張貼「節約用水」宣傳標示，宣導節約資源和綠色辦公。針對用水量較大之外判商如物業管理（包括清潔、綠化工作），本集團亦實行了相關監管措施。本集團參考外判商實際工作及過往紀錄訂立了用水指標，要求他們遵守並進行每月彙報。透過此用水指標管理，本集團得以分析物業管理工作的用水量，並對外判商進行及時管理。本集團亦將部份項目園區的綠化澆水改為自動噴灌，大大節省用水量。

A3. Environmental and Natural Resources

The Group has a strong sense of social responsibility and corporate knowledge. During the project development period, the Group strictly abides by applicable environmental laws and regulations and national standards, and tries to minimise the impact on the environment and natural resources.

Noise and dust from project construction

Before the construction of the projects, the Group employs qualified third-party environmental impact assessment experts to conduct a detailed assessment of the environmental impacts arising from the project development, establishes a written environmental impact assessment report and formulates a compensation plan. During the project implementation period, the Group allocates special funds and implements all measures to control the impact of the construction process on the surrounding environment, including dust and noise. After the commencement of the project business, the Group also makes great efforts to control the environmental risk of property operation, for example, it will introduce the advanced equipment such as imported fume extractors, professional rainwater-sewage separators and grease traps for high-emission businesses, which will provide powerful support for subsequent overall environmental protection of the projects.

In order to control the impact of project construction on the environmental and natural resources, the Group requires the project contractors to reduce the environmental impact of the project sites by using the outer frame, tower crane and road spraying equipment. In addition, the construction contractor shall be equipped with professional environmental tester for real-time monitoring of the site noise, PM2.5 and other data, so as to timely control and handle any abnormal conditions.

A3. 環境及天然資源

本集團積極履行社會責任及宣揚企業公民意識。在項目開發中，本集團嚴格遵守環保相關的適用法例法規及國家標準，盡可能將對環境及天然資源的影響降至最低。

項目施工噪音及塵土

項目施工前，本集團聘請合資格的第三方環境影響評估專家對項目開發所引起的環境影響進行詳細評估，建立書面的環境影響評估報告並制定應對方案。在項目實施階段，本集團調撥專項資金，全力落實措施控制施工過程為周遭環境帶來的影響，包括塵土、噪音等。於項目開業後，本集團亦極力控制物業營運中的環境風險，包括針對高排放商戶引進進口油煙淨化器、專業排污及隔油裝置等先進設備，為項目後續的整體環保工作提供有力支援。

為控制項目施工對環境及天然資源帶來的影響，本集團要求項目施工單位以外架、塔吊、道路噴淋設備方式，著力降低項目現場各項環境問題。另外，施工單位需配備專業環境檢測儀，即時監控施工現場的噪音、PM2.5等各項資料，確保在超標情況發生時能夠及時作出控制及改善。

Project renovation works

In order to mitigate the impact caused by the decoration construction conducted by renters and owners or other property users and the environment, regulations related to property renovation have been put into place for certain projects, which require customers to apply to property management first before carrying out any type of construction. Customers must submit supporting documents to the property management for construction and management to prove that aspects such as construction quality, construction operation, environmental protection and safety are all in compliance with standards of the project and relevant regulatory authorities of the government. Additionally, renovation materials used by the Group and its operations are all in compliance with relevant national green environmental protection regulatory requirements, such as the regulations stipulated in the Code for Indoor Environmental Pollution Control of Civil Building Engineering (GB-50325-2001D) and other relevant international regulations, and must satisfy inspection standards.

Indoor air quality of projects

As for the operation of the projects, the office buildings and shopping malls of the Group require a total ban on smoking. Air purifiers or air conditioning are also installed by property management to ensure the quality of indoor air. For catering merchants, the decomposition of kitchen waste will produce peculiar smell, so the Group has arranged a separate garbage room for collection of food waste. The Group has also installed the ventilating, venting and refrigeration equipment for food garbage room to eliminate odour in the daily operation. In addition, the renovation materials and furniture used in the projects are also in compliance with formaldehyde safety emission standards.

The Group is committed to environmental protection, thereby realising the sustainable development of the Group and contributing to the environmental protection of the society.

項目裝修工程

為減輕租客、業戶進行之裝修工程對其他物業使用者及環境的影響，部份項目建立了物業裝修相關的規範，要求客戶進行所有工程前必須先向物業管理申請。客戶需為施工、管理等向物業管理提交支援文件，證明工程品質、施工操作、環保、安全等各方面皆符合項目及相關政府監管部門的標準。另外，本集團所使用的裝修物料和操作均符合國家綠色環保相關規範要求，例如《民用建築工程室內環境污染控制規範》GB-50325-2001D的規定及其他相關國標規定，並必須達到檢測標準。

項目室內空氣品質

項目營運方面，本集團的辦公樓、購物中心等明文規定全面禁煙，物業管理會於項目辦公室及購物中心室內安裝空氣淨化器或空調鮮風系統，以保證室內空氣的品質。針對餐飲商戶，由於餐飲廚餘分解時會產生大量異味，本集團安排了獨立垃圾房以收集餐飲廢物。本集團亦為餐飲垃圾房安裝了通風、排氣和製冷設備，保證日常運作中餐飲垃圾房無異味傳出。此外，項目所使用的裝修物料及傢俱亦符合甲醛安全排放標準。

本集團持續地致力於環境保護工作，並堅持以此為基礎，來實現本集團發展的可持續化，為社會的環境保護工作做出應有的貢獻。

B. SOCIAL

B1. Employment

Human resources are important assets of the Group. The Group attaches importance to improving the quality of our employees, increasing productivity and quality of service, and attracting and retaining talents through our human resources policies.

Compensation and dismissal, recruitment and promotion, working hours and rest periods

The remuneration of employees of the Group is determined by reference to market levels and industry practice. Employee promotion and performance awards are based on the Group's financial performance and objective performance appraisal of individual employees. The Group's employee benefit plans cover mandatory provident fund, insurance and medical cover, subsidised educational and training programmes as well as share option schemes. The Group's recruitment, dismissal, working hours, rest periods and other policies comply with the Labour Law of the People's Republic of China and other applicable relevant laws and regulations to ensure that each process is legal and reasonable.

The Group also provides a wide range of activities for employees of each project in order to encourage exchange between colleagues, enhance team cohesion and cultivate a good working atmosphere in the office, such activities include annual gatherings, festival celebrations and activities, company trips, sports events and competitions, staff birthday parties, group companies festival walking events, company food festivals, etc.

Equal opportunity, diversity and anti-discrimination

As an equal opportunity employer, the Group is committed to providing a working environment free from discrimination. This includes all arrangements relating to the employment of the Group, such as recruitment, transfer, resignation, training, promotion, remuneration and welfare, which are all conducted in accordance to an established procedure of fairness and objective standards to ensure equal opportunities and fair treatment for all employees and job applicants. The Group is firmly opposed to all forms of discrimination.

B. 社會

B1. 僱傭

人力資源乃本集團的重要資產。本集團重視提高僱員質素，提升生產力及服務品質，並透過有效的人力資源政策吸引和保留人才。

薪酬及解僱、招聘及晉升、工作時數、假期

本集團僱員之薪酬乃參考市場水準及行業慣例而釐定。僱員的晉升及業績獎勵乃基於本集團之業績及個別員工之客觀表現評核。本集團僱員福利計畫包括強積金、保險及醫療保險、教育及培訓津貼計畫，以及購股權計畫。而本集團的招聘、解僱、工作時數、假期等都遵從《中華人民共和國勞動法》及其他適用的相關法例法規執行，確保每個程序都合法合理。

本集團亦為各項目的員工提供多元化活動以增加同事之間的交流，增強團隊凝聚力以及在公司培養良好工作氣氛，如年會、節慶日活動、員工旅行、運動會及比賽、員工生日會、集團公司慶典步行活動和公司美食節等。

平等機會、多元化、反歧視

作為平等機會僱主，本集團致力提供一個不存在歧視的工作環境。此乃包括本集團所有有關僱員的安排，如聘用、調職、離職、培訓、晉升、薪酬福利等，均以既定之公平程序和客觀標準進行，以確保所有僱員及職位申請者都獲得公平待遇。本集團堅決反對一切歧視行為。

During the Reporting Period, the Group is not aware of any violation of the Labour Law of the People's Republic of China, the Law of the People's Republic of China on the Protection of Women's Rights and Interests, the Trade Union Law of the People's Republic of China, or other applicable laws and regulations on human resources.

Human resources policy for outsourced contractors

Some of the Group's daily operations which require substantial human resources are outsourced to third parties, including construction of project developments and property management. As a result, the Group is committed to monitoring the human resources policy of outsourcing contractors. The Group includes investigations on human resources management and past violation records of the outsourced contractors into the contractor evaluation criteria as direct considerations for contractor selection.

B2. Health and Safety

Occupational health and safety

The Group provides employees with an ideal and safe working environment and takes all appropriate measures to safeguard the health and safety of employees.

During the operation of commercial projects, the project company regularly organises training on fire safety knowledge, provides fire prevention knowledge for business employees, carries out safety inspections on fire safety, electricity and water use every month and organises fire drills every year. The project company also reviews the staff training plan (involving fire safety, staff safety, occupational health and safety) prepared by the property company at the beginning of each year and supervises the implementation of the training plan in the daily process to ensure that the property personnel are equipped to meet the requirements of safety knowledge. Furthermore, in order to improve physical and mental health of our employees, the Group has arranged health and fitness activities for our employees during the Reporting Period, including walking events, fun water sports activities, in order to allow our employees to achieve a work-life balance.

本報告期間內，本集團並無發現任何違反《中華人民共和國勞動法》、《中華人民共和國婦女權益保障法》、《中華人民共和國工會法》或其他人力資源相關的適用法例法規的情況。

外判商人力資源政策

本集團日常營運中有部份工作需外判予第三方，當中包括項目開發的建築工程以及物業管理等。這些工作均需大量人力資源，因此，本集團亦致力監管外判商的人力資源政策，透過考察瞭解外判商的人力資源管理及過往的違規紀錄，並將此納入外判商評核準則，作為外判商篩選的直接考慮。

B2. 健康與安全

職業健康與安全

本集團為僱員提供理想及安全的工作環境，及採取所有適當措施保障僱員的健康及安全。

商業項目運營期間，項目公司定期組織消防安全知識培訓，為商戶僱員提供消防知識，並於每月對商戶進行消防、用電用水等安全檢查及於每年組織消防演習。項目公司亦於每年年初審核物業公司編製的僱員培訓計畫（涉及消防安全、僱員安全、職業健康安全等），並在日常過程中監督培訓計畫的實施，以確保物業人員具有符合工作要求的的安全知識。此外，為增強僱員體質、促進僱員身心健康，本集團於報告期間為僱員提供了健身活動等福利，也組織了徒步大會、趣味水上運動會等活動，幫助僱員勞逸結合，達到工作和生活間的平衡。

In addition, the Group attaches great importance to the work safety and health management of outsourced contractors. In the bidding documents for outsourcing property management, the Group explicitly requires outsourced contractors to purchase social insurance for employees according to government requirements, regularly carry out occupational safety and health training, and purchase commercial insurance for projects with major dangers and hazards. For dangerous outsourced operations, the project company will review the commercial insurance documents purchased and organise the safety training and technical handover before the construction/service of contractors is commenced. During hot summer weathers, the project company will require the outsourced contractors to protect the staff from heatstroke, exchange outdoor staff shifts to ensure their health in the hot environment.

During the Reporting Period, the Group is not aware of any violation of applicable laws and regulations on employee health and safety.

B3. Development and Training

Employee development and training

The Group has complete training regulations and training system to support on-the-job education and training of employees in order to improve their knowledge and skills. Our training mainly includes orientation training, on-the-job training and external training. Orientation training covers personnel rules and regulations, professional quality and corporate management system; on-the-job training covers job qualification (job theory and practice) and annual training plan; external training covers the training for special jobs. All the training expenses are borne by the Group. The Group also arranges different career development plans and programmes according to different business characteristics and personal aspirations, competencies and development needs of employees.

此外，本集團對外判商的工作安全及健康管理十分重視。在物業管理類外判招標文件中，本集團明確要求外判商按政府要求為僱員購買社保、定期進行職業安全與健康培訓、並就重大危險項目另外購買商業保險等。對於具有危險性的外判業務，在外判商施工／服務前，項目公司將審核其購買的商業保險單據，並組織施工／服務前的安全培訓、技術交接工作等。在夏季高溫天氣下，項目公司會知會各外判商，要求做好僱員的高溫防暑工作，調換室外工作人員，保證外判僱員在酷熱工作環境下的健康。

本報告期間內，本集團並無發現任何違反僱員健康與安全相關的適用法例法規的情況。

B3. 發展及培訓

僱員發展及培訓

本集團有完整的培訓制度和培訓體系來支持僱員的在職教育和培訓，以便提升僱員的知識和技能。本集團的培訓主要包括入職培訓、在職培訓和外界培訓。入職培訓課程包括人事規章制度、職業素養和公司管理體系等相關內容；在職培訓課程包括崗位資格認證（崗位理論與實踐）和年度培訓計畫等相關內容；外界培訓課程包括特殊崗位的崗位培訓等相關內容。所有培訓費用均由本集團承擔。本集團更針對不同的業務特性和僱員的個人志向、能力和發展需求，安排不同的職業發展計畫與規劃。

B4. Labour Standards

Prevention of child labour or forced labour

In strict accordance with the requirements of the applicable laws and regulations on human resources, the Group recruits persons who have attained the age of 18 or above with valid identification, and inspects the identification of the applicants upon their entry. The companies under the Group recruit employees on a fair, open and voluntary principle and signs legal employment contracts with each employee and does not use any forced labour.

On the other hand, contracts between the Group and outsourced contractors include provisions regarding human resources. Such provisions require the outsourced contractor to ensure that all personnel are employed in accordance with the Labour Law of the People's Republic of China and all applicable relevant laws and regulations, and all child labour and forced labour are strictly forbidden.

The Group conducts random checks for subsidiaries and contractors on a regular basis to ensure that there is no violation of the relevant laws and regulations. During the Reporting Period, the Group is not aware of any violation of applicable laws and regulations relating to the prevention of child labour or forced labour.

B5. Supply Chain Management

Supply chain quality and environmental management

The Group has very high standards for project quality. Therefore, the Group incorporated a comprehensive selection process in the selection of suppliers to effectively control the quality of raw materials and services. The Group has established a system of procedure documents covering supplier investigation, selection, bidding, subsequent supervision and evaluation to ensure that each selection process is conducted under appropriate conditions and consistent standards to exclude unqualified suppliers. In addition to quality, the Group also considers environmental protection measures of the suppliers and their use of raw materials to promote a green procurement process.

B4. 勞工準則

防止童工或強制勞動

本集團嚴格按人力資源相關的適用法例法規要求，招聘錄用年滿18歲或以上持有有效居民身份證的人員，並於入職時檢查應聘者的身份證。本集團之成員公司本著公平、公開、自願的原則招聘錄用僱員，並與僱員簽訂合法僱傭合同，並無強制使用勞動力行為。

另一方面，本集團與外判商所簽訂的合同中均包含人力資源的相關條款。條款要求外判商確保所有人員的聘用都符合《中華人民共和國勞動法》或相關的適用法例法規，嚴禁一切童工和強制勞動力的聘用。

本集團定期為子公司及外判商進行抽查，確保沒有違反相關的適用法例法規的情況。本報告期間內，本集團並無發現任何違反防止童工或強制勞動相關的適用法例法規的情況。

B5. 供應鏈管理

供應鏈品質及環境管理

本集團對項目品質有著極高要求，因此本集團於選擇供應商的過程中加入完善的挑選程式以有效地控制原材料、服務等的質素。本集團建立了供應商的入圍考察、選擇、招投標、後期監督考評等一系列制度文件，確保每一個挑選過程都以合適的條件、統一的標準去過濾不達標的供應商。除了品質方面，選擇供應商時本集團亦會考慮供應商的環保措施及原材料的使用情況，推行綠色採購。

In the event that the contractor fails to meet the requirements of the bidding documents or the contract is unable to guarantee the interests of the employees, the contract will be terminated in advance as required under contract provisions and the contractor will not be engaged by the Group for a certain period of time.

In addition, the Group will do its best to engage local suppliers for all of its projects in order to reduce carbon emissions resulting from the transportation of products and services. In FY2017, the Group cooperated with a total of 228 suppliers, all of which are based in the PRC.

B6. Product Responsibility

Real estate advertising and labelling

The Group is dedicated to providing high-quality projects to satisfy customers' needs and ensure transparency and accuracy of the information relating to its projects and services in the course of engineering, procurements, sales and services, in order to prevent misleading customers or prejudicing their interests. The Group makes certain that all sales and promotional documents and information are prepared in compliance with relevant advertising laws and regulations and does not contain any exaggerated or false marketing information.

Health and safety quality of property projects

The Group has also been conducting inspections on the quality of its contractors and suppliers on a regular basis. If significant changes occurred in the quality and the performance of a contractor or a supplier, the Group may suspend the projects or the deliveries of such contractor or supplier at any time and remove them from the list of qualified suppliers in order to ensure the reliability of our projects. When selecting building materials, the Group also takes their effects on human health into consideration and comply with relevant national environmental regulations and requirements (including the requirements of GB-50325-2001D, Code for Indoor Environmental Pollution Control of Civil Building Engineering), ensuring that the materials do not have any negative effect on residents' health.

對於中標後提供服務的外判商在履約過程中達不到招標文件、合同的要求，以及出現不能保證僱員利益等情況的，將按合同條款規定提前解約，並在一定時間內不再予以聘用。

此外，本集團所有項目都會盡量選用本地供應商，以減少產品及服務運輸過程中產生的碳排放。在2017財政年度，本集團共有228間有合作紀錄的供應商，全部來自中國內地。

B6. 產品責任

房地產項目廣告和標籤

本集團強調提供優質項目以滿足客戶要求，在工程、採購、銷售及服務流程中均確保項目及服務資訊之透明性及準確性，防止誤導或損害客戶權益。本集團確保所有的銷售、推廣文件及資料符合相關廣告法例法規的要求，不存在誇張失實之市場行銷手法。

房地產項目健康與安全品質

本集團亦對房地產項目進行長期品質監管及定期對其承建商和供應商進行檢查。倘若承建商或供應商資歷出現重大改變或發生嚴重品質問題，本集團可隨時暫停有問題之承建商的工程或供應商之付運，及取消其作為合格供應商的資格，以確保本公司項目之可靠品質。項目於物料選用上本集團亦會考慮到物料對健康的影響，物料選擇均符合國家綠色環保相關規範要求（包括《民用建築工程室內環境污染控制規範》GB-50325-2001D的規定），不會對用戶健康造成負面影響。

The Group requires property management companies to provide suitable types of training for property management staff to ensure that they have sufficient knowledge and skills to serve all customers. Property management companies will provide employees with external training on fire control, elevator management, electricians and other special jobs, so that they comply with relevant government regulations.

Customer service

The Group is focused on establishing good and long-term relationships with its customers and increasing customer loyalty. Therefore, the Group has established comprehensive after-sales service and customer feedback channels to regularly collect all comments and complaints on services and product quality. Specific personnel is responsible for follow-ups and improvements to ensure that all customer comments and complaints are handled satisfactorily. Inspections are conducted on the facilities and equipment in public areas of the community and the hygiene of the environment in the area before the ownership of a property is delivered. Inspection rules for property projects are also established and the inspection work of the projects will be organised by the property engineers so as to ensure quality and meet customers' needs.

In order to understand the needs of our customers and to collect their feedback, the Group conducts satisfaction surveys for projects and on contracted clients of projects for sale as well as property owners by way of telephone or in person to continuously improve the Group's products and services. After the investigation is completed, detailed analyses are carried out on the investigation results and an action plan would be formulated to improve its performance for the next year.

本集團要求物業管理公司為物業管理僱員提供恰當的各類培訓，確保僱員有足夠的知識及技巧服務所有客戶。物業管理公司會為僱員提供消防上崗證件、電梯管理上崗證件、電工及其他特種行業上崗證件的外委培訓，使之符合政府相關法規的要求。

客戶服務

本集團著眼於與客戶建立良好及長遠的關係，增加客戶忠誠度，因此本集團設立完善的售後服務及客戶意見反映渠道，定期收集所有關於服務、產品品質等的意見和投訴，並由專責人員負責進行跟進及改善，確保所有客戶意見及投訴都得到滿意處理。在物業交付時，本集團會對社區內公共區域設施設備是否完好、園區是否清潔衛生進行驗收。另外，項目亦會建立物業驗收規範，由物業工程人員組織項目承接查驗工作，以確保項目品質滿足客戶要求。

The Group has established customer service guideline and established appropriate standards on “the time required to confirm a complaint is received,” “the time required to handle and address complaints” and “complaint response rate” in accordance with the characteristics of the projects (such as their nature, scale and customer base). Customer service also conducts random checks on the handlings to ensure that the customer complaints are properly resolved.

Customer privacy

The Group has the responsibility to protect the privacy of its customers or consumers. In addition to the public documents prescribed by laws and regulations, the Group strictly complies with relevant privacy regulations and will not allow any disclosure of information without the permission of the owner of the information. In addition, the Group will only collect personal information necessary for its operations, which will only be used for the purposes specified when collecting such information.

During the Reporting Period, the Group is not aware of any violation of applicable laws and regulations on privacy, product and service quality.

The Group is committed to providing high quality property projects together with top-level services to meet the living, entertainment and business needs of our customers. The Group is widely recognised for its efforts and contributions to the property industry, and has achieved various honour and certifications awarded by different institutions in 2017, including “2017 China’s Excellent Industrial Park Operator”, “2017 China Property’s Annual Influencing Listed Enterprises”, “2017 Ranking of China’s 100 Best Real Estate Enterprises” and “2017 Ranking of China’s TOP100 Commercial Property Enterprises”. Furthermore, the Group was designated by the China Industrial Park Association as its “2017 Vice-Directing Unit of China Industrial Park Association”.

Close attention will be paid to all aspects and methods of the investigation progress in order to prevent disclosure of the whistle-blower's information.

In respect of illegal fundraising activities commonly seen during the year, the Group also held events regarding the prevention and whistleblowing of illegal fundraising together with local police stations to prevent illegal behaviour from invading the community and to keep its members from bearing unnecessary loss.

As the Group's flagship business park project in the PRC, Vision Shenzhen Business Park is committed to building top class energy-saving, low-consumption and green ecological business spaces through technology and design, nurturing a lifestyle of arts, vitality and technology experiences. The project's contribution to the community has gained industry-wide recognition and was awarded with "Guangdong Province's Property Management Project of Excellence" and "China's Unique Industrial Park honours" during the Reporting Period.

The directors of the Company (the “**Directors**”) present their report of the Company and the audited consolidated financial statements of the Company and its subsidiaries (the “**Group**”) for the year ended 31 December 2017.

PRINCIPAL ACTIVITIES

The principal activity of the Company continues to be investment holding while the principal activities of the Group are property investment, development and management of residential, commercial and business park projects. There have been no significant changes in the nature of the Group's principal activities during the year.

RESULTS AND DIVIDENDS

The audited consolidated results of the Group for the year ended 31 December 2017 and the financial position of the Group at that date are set out on pages 110 to 265 of this annual report.

The Board has resolved to recommend the payment of a final dividend of RMB0.025 per share (2016: RMB0.02) for the year ended 31 December 2017, subject to shareholders' approval at the forthcoming annual general meeting of the Company. The proposed final dividend, if approved, will be paid on or about 15 June 2018 to shareholders whose names appear on the register of members of the Company on 1 June 2018. The proposed final dividend shall be declared in RMB and paid in Hong Kong dollars. The final dividend payable in Hong Kong dollars will be converted from RMB at the average middle rate of RMB to Hong Kong dollars as announced by the People's Bank of China for the period from 10 May 2018 to 16 May 2018.

No interim dividend was paid during the year.

BUSINESS REVIEW

Major Possible Risks and Uncertainties Facing the Group

The Group's financial conditions, results of operations, businesses and prospects may be affected by a number of risks and uncertainties. The following are the key risks and uncertainties identified by the Group. There may be other risks and uncertainties which are not known to the Group or which may not be material now but could turn out to be material in the future.

Business Risk

A substantial portion of the operating assets of the Group are located in the PRC and the Group expects that a material portion of the revenue will continue to be derived from the operations in the PRC. The results of operations and prospects are subject, to a significant degree, to economic, political and legal developments in the PRC. The economy of the PRC differs from the economies of most developed countries in many respects, including the extent of government involvement, the level of development, the growth rate, and government control of foreign exchange. The Group cannot predict whether changes in the PRC's political, economic and social conditions, laws, regulations and policies will have any material adverse effect on the current or future business, results of operation or financial condition of the Group.

業務回顧

業務風險

本集團大多數營運資產乃位於中國，本集團預期絕大部份收入將繼續來自中國業務。經營業績及前景很大程度取決於中國之經濟、政治及法律發展。中國經濟在多方面有別於大部份已發展國家之經濟，包括政府干預程度、發展水平、增長率及政府外匯管制。本集團無法預測中國政治、經濟及社會狀況、法律、法規及政策之變動會否對本集團現時或未來業務、經營業績或財務狀況造成任何重大不利影響。

Financial Risk

The financial risk management objectives and policies of the Group are set out in the Management Discussion and Analysis on pages 6 to 24 of this annual report and note 43 to the financial statements.

Management will hold meetings from time to time to discuss the various industrial and tax policies implemented in the country/cities/regions and will analyse the impact on the Group's business. Therefore, management can assess the possible changes in policies in an early stage so that management can develop appropriate strategies to reduce the risk of policy changes. Besides, management are provided various analysis regularly which covering business operations and financial information so that management can have a clear and timely understanding of the Group's operating conditions, project progress and capital requirements timely so as to identify the potential risks.

Relationship with Key Stakeholders

The Group fully understand that employees, customers, suppliers, partners and shareholders are the key to our sustainable and stable development. The Group committed to establishing a close relationship with our employees, providing high-quality products and services to our customers, enhancing cooperation with our suppliers and partners so as to ensure our sustainable development of the Group for the benefit of the shareholders of the Company.

Our staff is regarded as the most important resource of the Group. Hence, the Group has been endeavouring to provide our staff with a fair and harmonious workplace where individuals with diverse cultural backgrounds are treated equally. The Group offers a competitive remuneration package and great opportunities for career advancement based on employees' performance. The Group also provides our staff with regular trainings, including internal trainings and refresher courses offered by professional organisations, so as to keep them abreast of the latest development in the market, industry and various businesses.

The Group effectively implements the vendor assessment process by conducting sampling check, site visit, evaluation on the performance of contract, third-party certification and other measures, to ensure the performance of our vendors.

One of the corporate goals of the Group is to enhance corporate value to its shareholders. The Group is poised to foster business developments for achieving the sustainability of earnings growth and rewarding shareholders by stable dividend payouts taking into account the capital adequacy levels, liquidity positions and future business expansion needs of the Group.

The Group is also subject to various corporate and administrative requirements under other laws and regulations such as the Companies Ordinance (Cap. 622), the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") and the Employment Ordinance. Through various internal control and approval procedures that are in place, the Company seeks to ensure the compliance with these requirements.

During the year, as far as the Company is aware, there was no material breach of or non-compliance with applicable laws and regulations by the Group that has a significant impact on the business and operations of the Group.

CONNECTED TRANSACTIONS

The Group has entered into the following connected transactions during the year:

(a) Continuing Connected Transactions

1. On 29 March 2017, a property development and technical services agreement was entered into between the Company and Gemdale Corporation (the "**Services Agreement**"), pursuant to which Gemdale Corporation agreed to provide property development and technical services to the Company (or its subsidiary(ies)) in relation to certain property projects of the Company (or its subsidiary(ies)) as set out therein for the year ending 31 December 2017 at a service fee calculated based on 0.6% of the contracted sales of the Group's properties receiving such services catered by Gemdale Corporation.

Gemdale Corporation is the ultimate controlling shareholder of the Company and is therefore a connected person of the Company under the Listing Rules. The Services Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the aggregate amount of services fee payable pursuant to the Services Agreement at RMB65,000,000 for the year ending 31 December 2017.

During the year, the aggregate amount of services fee of approximately RMB64,869,000 was paid to Gemdale Corporation under the Services Agreement.

2. On 29 March 2017, an entrusted operation agreement was entered into between the Company, 北京港旅房地產開發有限公司(Beijing Ganglu Real Estate Development Co., Ltd.) ("**Beijing Ganglu**", a subsidiary of the Company, as trustee), 北京金地鴻運房地產開發有限公司(Beijing Gemdale Hongyun Real Estate Development Co., Ltd.) ("**Beijing Gemdale**") and Beijing Gemdale, Chaoyang Branch (together with Beijing Gemdale, as principal) (the "**Entrusted Operation Agreement**"), pursuant to which the Principal agreed to engage Beijing Ganglu to manage the operations of 北京金地廣場(Beijing Gemdale Plaza) located in Beijing, the PRC for and on its behalf for the year ending 31 December 2017 at an entrusted management fee calculated based on a margin of 20% to the existing cost operating the Beijing Gemdale Plaza.

關連交易

本集團於年內曾訂立下列關連交易：

(a) 持續關連交易

1. 於2017年3月29日，本公司與金地集團訂立物業開發及技術服務協議（「**服務協議**」），據此，金地集團同意於截至2017年12月31日止年度就本公司（或其附屬公司）之若干物業項目向本公司（或其附屬公司）提供物業開發及技術服務，服務費按本集團使用金地集團提供相關服務之物業之合約銷售額之0.6%計算。

金地集團為本公司之最終控股股東，因此根據上市規則為本公司之關連人士，訂立服務協議構成本公司之持續關連交易。因此，本公司根據服務協議設定截至2017年12月31日止年度應付服務費總額之年度上限為人民幣65,000,000元。

年內，本公司於服務協議下已向金地集團支付服務費總額約人民幣64,869,000元。

2. 於2017年3月29日，本公司、北京港旅房地產開發有限公司（「**北京港旅**」，本公司之附屬公司，作為受託人）、北京金地鴻運房地產開發有限公司（「**北京金地**」）及北京金地朝陽分公司（連同北京金地，作為委託人）訂立項目運營委託協議（「**項目運營委託協議**」），據此，北京金地同意委任北京港旅於截至2017年12月31日止年度代其管理位於中國北京之北京金地廣場之營運，運營託管費按營運北京金地廣場之現有成本上浮20%計算。

Beijing Gemdale is a subsidiary of Gemdale Corporation and is therefore a connected person of the Company under the Listing Rules. The Entrusted Operation Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the entrusted management fee receivable pursuant to the Entrusted Operation Agreement at RMB26,400,000 for the year ending 31 December 2017.

During the year, an entrusted management fee of approximately RMB26,400,000 was received from Beijing Gemdale under the Entrusted Operation Agreement.

- On 29 March 2017, a property management service agreement was entered into between Vision (Shenzhen) Software Technology Co., Ltd. (“**Shenzhen Vision**”, a subsidiary of the Company) and 深圳市金地物業管理有限公司 (Shenzhen Gemdale Property Management Co., Ltd.) (“**Gemdale Property**”) (the “**Property Management Service Agreement**”), pursuant to which Gemdale Property agreed to provide property management services to Shenzhen Vision for Phase 1 and Phase 2 of Vision Shenzhen Business Park located in Shenzhen, the PRC for the year ending 31 December 2017.

Gemdale Property is a subsidiary of Gemdale Corporation and is therefore a connected person of the Company under the Listing Rules. The Property Management Service Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the property management fee payable pursuant to the Property Management Service Agreement at RMB13,000,000 for the year ending 31 December 2017.

During the year, a property management fee of approximately RMB12,022,000 was paid to Shenzhen Gemdale under the Property Management Service Agreement.

北京金地為金地集團之附屬公司，因此根據上市規則為本公司之關連人士，項目運營委託協議構成本公司之持續關連交易。因此，本公司根據項目運營委託協議設定截至2017年12月31日止年度應收運營託管費之年度上限為人民幣26,400,000元。

年內，本公司於項目運營委託協議下已向北京金地收取運營託管費約人民幣26,400,000元。

- 於2017年3月29日，深圳威新軟件科技有限公司（「**深圳威新**」，本公司之附屬公司）與深圳市金地物業管理有限公司（「**金地物業**」）訂立物業管理服務協議（「**物業管理服務協議**」），據此，金地物業同意於截至2017年12月31日止年度就位於中國深圳之深圳威新軟件科技園第一及第二期向深圳威新提供物業管理服務。

金地物業為金地集團之附屬公司，因此根據上市規則為本公司之關連人士，物業管理服務協議構成本公司之持續關連交易。因此，本公司根據物業管理服務協議設定截至2017年12月31日止年度應付物業管理費之年度上限為人民幣13,000,000元。

年內，本公司於物業管理服務協議下已向金地物業支付物業管理費約人民幣12,022,000元。

On 29 March 2017, a framework agreement was entered into between the Company and Gemdale Property (the “**Property Management Framework Agreement**”), pursuant to which Gemdale Property and/or its subsidiaries and/or its designated affiliated companies under the same control agreed to provide property management services during the development stage of the property projects of the Group as set out therein for the year ending 31 December 2017 at a management services fee calculated based on 10% margin on the costs of provision of the relevant services incurred plus tax.

Accordingly, the Company set the annual cap for the aggregate amount of management services fee payable pursuant to the Property Management Framework Agreement at RMB50,000,000 for the year ending 31 December 2017.

During the year, the aggregate amount of management services fee of approximately RMB43,441,000 was paid to Shenzhen Gemdale or its subsidiaries/designated affiliated companies under the same control under the subsidiary agreements to the Property Management Framework Agreement.

5. On 29 March 2017, a framework system installation agreement was entered into between the Company and 深圳市金地樓宇工程有限公司 (Shenzhen Gemdale Building Project Co., Ltd.) (“**Gemdale Building**”) (the “**Framework System Installation Agreement**”), pursuant to which Gemdale Building agreed to provide certain intelligent system project services for the various property projects of the Group for the year ending 31 December 2017 at a project fee calculated based on 1.25% margin on the actual cost of providing relevant services plus tax.

5. 於2017年3月29日，本公司與深圳市金地樓宇工程有限公司（「**金地樓宇**」）訂立系統裝設工程框架協議（「**系統裝設工程框架協議**」），據此，金地樓宇同意於截至2017年12月31日止年度就本集團多個物業項目提供若干智能化系統工程，工程費按提出相關服務之裝設有關係成本上浮1.25%及另加稅費計算。

Gemdale Building is a subsidiary of Gemdale Corporation and is therefore a connected person of the Company under the Listing Rules. The Framework System Installation Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the aggregate amount of project fees payable pursuant to the Framework System Installation Agreement at RMB30,000,000 for the year ending 31 December 2017.

During the year, the aggregate amount of project fees of approximately RMB13,078,000 was paid to Gemdale Building under the Framework System Installation Agreement.

6. On 29 March 2017, an entrusted project management agreement was entered into between 深圳市新威投資有限公司 (Shenzhen Xinwei Investment Company Limited) (“**Shenzhen Xinwei Investment**”, a subsidiary of the Company) and 武漢市地安君泰房地產開發有限公司 (Wuhan Dian Juntai Property Development Company Limited) (“**Wuhan Dian Juntai**”) (the “**Entrusted Project Management Agreement**”), pursuant to which Wuhan Dian Juntai agreed to engage Shenzhen Xinwei Investment to manage the marketing, design and liaison work with subcontractors in relation to the pre-launch stage of the project located at Wuhan, the PRC for the year ending 31 December 2017 at an entrusted project management fee calculated based on 15-20% margin on the projected costs for operating and managing the project.

Wuhan Dian Juntai is a subsidiary of Gemdale Corporation and is therefore a connected person of the Company under the Listing Rules. The Entrusted Project Management Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the aggregate amount of entrusted project management fee receivable pursuant to the Entrusted Project Management Agreement at RMB17,850,000 for the year ending 31 December 2017.

During the year, the aggregated amount of entrusted project management fee of approximately RMB595,000 was received from Wuhan Dian Juntai under the Entrusted Project Management Agreement.

金地樓宇為金地集團之附屬公司，因此根據上市規則為本公司之關連人士，系統裝設工程框架協議構成本公司之持續關連交易。因此，本公司根據系統裝設工程框架協議設定截至2017年12月31日止年度應付工程費總額之年度上限為人民幣30,000,000元。

年內，本公司於系統裝設工程框架協議下已向金地樓宇支付工程費總額約人民幣13,078,000元。

6. 於2017年3月29日，深圳市新威投資有限公司（「**深圳新威投資**」，本公司之附屬公司）與武漢市地安君泰房地產開發有限公司（「**武漢地安君泰**」）訂立項目管理委託協議（「**項目管理委託協議**」），據此，武漢地安君泰同意聘請深圳新威投資於截至2017年12月31日止年度管理位於中國武漢的項目推出前階段相關營銷、設計及與分包商之聯絡工作，項目管理委託費按該項目營運及管理成本上浮15-20%計算。

武漢地安君泰為金地集團之附屬公司，因此根據上市規則為本公司之關連人士，項目管理委託協議構成本公司之持續關連交易。因此，本公司根據項目管理委託協議設定截至2017年12月31日止年度應收項目管理委託費總額之年度上限為人民幣17,850,000元。

年內，本公司於項目管理委託協議下已向武漢地安君泰收取項目管理委託費總額約人民幣595,000元。

7. On 17 July 2017, a framework agreement was entered into between 深圳新家生活科技服務有限公司 (Shenzhen Xinjia Living Technology Service Co., Ltd.) (“**Shenzhen Xinjia**”, a subsidiary of the Company) and Gemdale Corporation (the “**Decoration Services Framework Agreement**”), pursuant to which Gemdale Corporation agreed to engage Shenzhen Xinjia to provide decoration services for certain property projects developed by Gemdale Corporation and its subsidiaries through tendering, invited tendering or direct engagement for the year ended 31 December 2017 at a decoration fee calculated based on 7-15% margin on the actual costs expected to arise with respect to the provision of services to such projects.

The Decoration Services Framework Agreement constituted a continuing connected transaction of the Company. Accordingly, the Company set the annual cap for the aggregate amount of decoration fees receivable pursuant to the Decoration Services Framework Agreement at RMB70,000,000 for the year ending 31 December 2017.

During the year, the aggregate amount of decoration fees of approximately RMB7,190,000 was received from Gemdale Corporation under the Decoration Services Framework Agreement.

8. On 15 March 2016, a tenancy agreement was entered into between Beijing Gemdale (as landlord) and 深圳火花時代投資管理有限公司 (Shenzhen Firework Time Investment Management Co., Ltd.) (“**Shenzhen Firework**”, a subsidiary of the Company) (as tenant) in respect of leasing a premises in Beijing, the PRC for a term of 36 months commencing from 1 January 2016 to 31 December 2018 (both days inclusive). The annual rent and property management fee payable by the tenant to the landlord for each of the three years ending 31 December 2018 were approximately RMB6,726,000 (the “**Beijing Tenancy Agreement**”).

Accordingly, the Company set the annual caps for the aggregate amount of rent and property management fee payable pursuant to the Beijing Tenancy Agreement at RMB7,000,000 for each of the three years ending 31 December 2018.

7. 於2017年7月17日，深圳新家生活科技服務有限公司（「深圳新家」，本公司之附屬公司）與金地集團訂立框架協議（「**批量精裝服務框架協議**」），據此，金地集團同意委託深圳新家於截至2017年12月31日止年度就金地集團及其附屬公司發展的若干地產項目向彼等提供批量精裝服務，裝修工程費按向相關項目提供服務之有關工程預計所產生之實際成本上浮約7-15%計算。

批量精裝服務框架協議構成本公司之持續關連交易。因此，本公司根據批量精裝服務框架協議設定截至2017年12月31日止年度應收裝修工程費總額之年度上限為人民幣70,000,000元。

年內，本公司於批量精裝服務框架協議下已向金地集團收取裝修工程費總額約人民幣7,190,000元。

8. 於2016年3月15日，北京金地（作為出租人）與深圳火花時代投資管理有限公司（「深圳火花」，本公司之附屬公司）（作為承租人）就租賃位於中國北京一物業訂立為期由2016年1月1日起至2018年12月31日止（包括首尾兩天）36個月之租賃協議。截至2018年12月31日止3年承租人向出租人應付之年度租金及物業管理費總額每年為人民幣6,726,000元（「**北京租賃協議**」）。

因此，本公司根據北京租賃協議設定於截至2018年12月31日止3年應付租金及物業管理費總額之年度上限每年為人民幣7,000,000元。

During the year, the aggregate amount of rent and property management fee of approximately RMB6,220,000 was paid to Beijing Gemdale under the Beijing Tenancy Agreement.

9. On 15 March 2016, a tenancy agreement was entered into between Shenzhen Vision (as landlord) and 深圳市金地投資管理有限公司 (Shenzhen Gemdale Investment Management Co., Ltd.) ("**Gemdale Investment**", as tenant) in respect of leasing a premises in Vision Shenzhen Business Park, the PRC for a term of 36 months commencing from 1 December 2015 to 30 November 2018 (both days inclusive). The annual rent and property management fee payable by the tenant to the landlord for each of the three years ending 31 December 2018 were RMB1,214,000, RMB1,304,000 and RMB1,196,000, respectively. On 26 June 2015, a tenancy agreement was entered into between Shenzhen Vision (as landlord) and Gemdale Property (as tenant) in respect of leasing a premises in Vision Shenzhen Business Park, the PRC for a term of 34 months commencing from 1 July 2015 to 30 April 2018 (both days inclusive). The annual rent and property management fee payable by the tenant to the landlord for each of the three years ending 31 December 2018 were RMB7,346,000, RMB7,346,000 and RMB2,449,000, respectively (collectively, the "**Shenzhen Tenancy Agreements**").

Each of Gemdale Investment and Gemdale Property is a subsidiary of Gemdale Corporation and is therefore a connected person of the Company under the Listing Rules. The Shenzhen Tenancy Agreements constituted continuing connected transactions of the Company. Accordingly, the Company set the annual caps for the aggregate amount of rent and property management fee receivable pursuant to the Shenzhen Tenancy Agreements (aggregated under Rules 14A.81 of the Listing Rules) at RMB9,000,000, RMB9,000,000 and RMB4,000,000 for each of the three years ending 31 December 2018, respectively.

During the year, the aggregate amount of rent and property management fee of approximately RMB8,577,000 was received from Shenzhen Investment and Gemdale Property under the Shenzhen Tenancy Agreements.

9. 於2016年3月15日，深圳威新（作為出租人）與深圳市金地投資管理有限公司（「**金地投資**」，作為承租人）就租賃位於中國深圳威新軟件科技園一物業訂立為期由2015年12月1日起至2018年11月30日止（包括首尾兩天）36個月之租賃協議。截至2018年12月31日止3年承租人向出租人應付之年度租金及物業管理費總額每年分別為人民幣1,214,000元、人民幣1,304,000元及人民幣1,196,000元。於2015年6月26日，深圳威新（作為出租人）與金地物業（作為承租人）就租賃位於中國深圳威新軟件科技園一物業訂立為期由2015年7月1日起至2018年4月30日止（包括首尾兩天）34個月之租賃協議。截至2018年12月31日止3年承租人向出租人應付之年度租金及物業管理費總額每年分別為人民幣7,346,000元、人民幣7,346,000元及人民幣2,449,000元（統稱「**深圳租賃協議**」）。

金地投資及金地物業均為金地集團之附屬公司，因此根據上市規則為本公司之關連人士，深圳租賃協議構成本公司之持續關連交易。因此，本公司根據深圳租賃協議設定截至2018年12月31日止3年之應收租金及物業管理費之年度上限總額（根據上市規則第14A.81條合併計算）每年分別為人民幣9,000,000元、人民幣9,000,000元及人民幣4,000,000元。

年內，本公司於深圳租賃協議下已向金地投資及金地物業收取之租金及物業管理費總額約人民幣8,577,000元。

10. On 13 December 2016, a framework agreement was entered into between 廣州廣電房地產開發集團股份有限公司 (Guangzhou Guangdian Real Estate Development Group Co., Ltd.) (“**Guangzhou Guangdian**”), which is owned as to 74% by the Company, and Gemdale Corporation (the “**Financial Consulting Framework Agreement**”), pursuant to which Gemdale Corporation agreed to provide financial advisory and consultation services to Guangzhou Guangdian and/or its subsidiaries, joint ventures and associated companies for their property projects for three years at a maximum rate of 1% per annum over the facility amount obtained by Guangzhou Guangdian and/or its subsidiaries, joint ventures and associated companies.

Accordingly, the Company set the annual caps for the aggregate amount of financial consultancy fee payable pursuant to the Financial Consulting Framework Agreement at RMB8.5 million, RMB100 million, RMB100 million and RMB92 million for each of the four years ending 31 December 2019, respectively.

During the year, the aggregate amount of financial consultancy fee of approximately RMB52,095,000 was paid to Gemdale Corporation under the Financial Consulting Framework Agreement.

(b) Connected Transactions

On 2 August 2017, an entrusted loan agreement was entered into between (i) Shanghai Zhongjun Real Estate Development Co., Ltd. (“**Shanghai Zhongjun**”, a subsidiary of the Company) (as lender), (ii) Chengdu Sino-Singapore South West Logistics Co., Ltd., (“**Chengdu Logistics**”, a subsidiary of a company which is a substantial shareholder of Shanghai Zhongjun) (as borrower) and (iii) a bank (as lending agent) (the “**Entrusted Loan Agreement**”), pursuant to which the lender agreed, through the bank, to grant an entrusted loan of RMB400 million to Chengdu Logistics.

10. 於2016年12月13日，廣州廣電房地產開發集團股份有限公司（「廣州廣電」）（本公司擁有其74%股權）與金地集團訂立框架協議（「財務顧問框架協議」），據此，金地集團同意就廣州廣電及／或其附屬公司、合營公司及聯營公司的地產項目分別向彼等提供財務顧問及諮詢服務，為期3年，財務顧問費年費率按廣州廣電及／或其附屬公司、合營公司及聯營公司各自已獲取之融資款不高於1%計算。

因此，本公司根據財務顧問框架協議設定截至2019年12月31日止4年之應付財務顧問費之年度上限總額每年分別為人民幣8,500,000元、人民幣100,000,000元、人民幣100,000,000元及人民幣92,000,000元。

年內，本公司財務顧問框架協議下已向金地集團支付財務顧問費總額約人民幣52,095,000元。

(b) 關連交易

於2017年8月2日，(i)上海仲駿房地產開發有限公司（「上海仲駿」，本公司之附屬公司）（作為貸款方）與(ii)成都中新西南物流有限公司（「成都物流」，上海仲駿之主要股東之附屬公司）（作為借款方）及(iii)一間銀行（作為貸款代理人）訂立一份委託貸款協議（「委託貸款協議」），據此，貸款方同意透過銀行向成都物流提供人民幣4億元之委託貸款。

According to the terms of the Entrusted Loan Agreement, the repayment of loan was required to be made at the earlier of (a) 12 months from the date of drawdown; or (b) 1 month from the date of demand of repayment from the lender and the interest payable was calculated based on the floating rate in accordance with the benchmark lending rate in the People's Bank of China, the then interest rate was 4.35% per annum.

Chengdu Logistics is a subsidiary of a company which is a substantial shareholder of Shanghai Zhongjun and is therefore a connected person of the Company at the subsidiary level under the Listing Rules. The Entrusted Loan Agreement constituted a connected transaction of the Company. Such transaction was subject to reporting and announcement but was exempt from circular and independent shareholders' approval requirements under Rule 14A.101 of the Listing Rules.

(c) Annual review of the continuing connected transactions

In accordance with Rule 14A.37 of the Listing Rules, the INEDs had reviewed the continuing connected transactions as contemplated under the (i) Services Agreement, (ii) Entrusted Operation Agreement, (iii) Property Management Service Agreement, (iv) Property Management Framework Agreement, (v) Framework System Installation Agreement, (vi) Entrusted Project Management Agreement, (vii) Decoration Services Framework Agreement, (viii) Beijing Tenancy Agreement, (ix) Shenzhen Tenancy Agreements and (x) Financial Consulting Framework Agreement (collectively, the "2017 Continuing Connected Transactions") which were subsisting during the year and confirmed that the 2017 Continuing Connected Transactions had been entered into:

- (i) in the ordinary and usual course of business of the Group;
- (ii) on normal commercial terms; and
- (iii) in accordance with the relevant agreements governing the 2017 Continuing Connected Transactions on terms that are fair and reasonable and in the interests of the Company's shareholders as a whole.

根據委託貸款協議之條款，貸款須於(a)於貸款借出之日起計12個月；或(b)貸款方要求償還後一個月內(以較早者為準)償還，且應付利息須按人民銀行基準貸款年利率之浮動利率計算，當時為4.35%。

成都物流為上海仲駿之主要股東之附屬公司，因此根據上市規則為本公司(在附屬公司層面)之關連人士，委託貸款協議構成本公司之關連交易。該項交易根據上市規則第14A.101條須遵守報告及公告之規定，但獲豁免遵守有關通函及獨立股東批准之規定。

(c) 持續關連交易的年度審閱

根據上市規則第14A.37條，獨立非執行董事已審閱年內於(i)服務協議、(ii)項目運營委託協議、(iii)物業管理服務協議、(iv)物業管理框架協議、(v)系統裝設工程框架協議、(vi)項目管理委託協議、(vii)批量精裝服務框架協議、(viii)北京租賃協議、(ix)深圳租賃協議及(x)服務顧問框架協議項下所進行之持續關連交易(統稱「2017年持續關連交易」)，並確認2017年持續關連交易乃：

- (ii) 按一般商業條款訂立；及
- (iii) 根據監管2017年持續關連交易之相關協議，協議按公平合理及符合本公司股東整體利益之條款訂立。

The Company's auditors were engaged to report on the Group's 2017 Continuing Connected Transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. During the year and up to the date of this annual report, Mr. Ling Ke, Mr. Huang Juncan, Mr. Xu Jiajun and Mr. Wei Chuanjun, all being executive Directors, held shareholding or other interests and/or directorships in companies/entities within the group of Gemdale Corporation. Gemdale Corporation mainly focuses on residential property development and participates in large-scale urban complex/commercial projects in the top 50 cities (by population/economic scale) in the PRC.

The Board also includes two NEDs and three INEDs whose views carry significant weight in the Board's decisions. Therefore the Board is independent from the board of directors/governing committees of Gemdale Corporation and none of the above-mentioned Directors can personally manage the Board. The audit committee of the Company, which consists of three INEDs, meets regularly to assist the Board in reviewing the financial performance, risk management and internal control, and compliance systems of the Group.

On 6 February 2017, 28 July 2017 and 24 August 2017, the Group acquired 100% equity interests of Shanghai Zhitao Motor Components Company Limited ("Zhitao"), Yuxin Shanghai Electronic Company Limited ("Yuxin") and Shanghai Lier Modern Material Company Limited ("Lier"), respectively, from independent third parties at a total consideration of RMB194 million, RMB81.9 million and RMB86.6 million. Zhitao, Yuxin and Lier hold land use rights in Shanghai.

貴集團於2017年2月6日、2017年7月28日及2017年8月24日分別從獨立第三方收購上海志韜汽車零部件有限公司（「志韜」）、裕新（上海）電子有限公司（「裕新」）及上海利爾新材料有限公司（「利爾」）的100%股權，總代價分別為人民幣1.94億元、人民幣0.819億元及人民幣0.866億元。志韜、裕新及利爾於上海持有土地的使用權。

Management concluded that the above acquisition constituted an acquisition of assets instead of a business combination because the acquired entities and assets did not constitute the carrying on of a business (i.e., there are no processes applied to the inputs that have the ability to create outputs). Zhitao, Yuxin and Lier had no operation team and no construction work was carried out before the acquisition. Such conclusion depends on significant judgement made by management.

1. CORPORATE AND GROUP INFORMATION

Gemdale Properties and Investment Corporation Limited (the “Company”) is a limited liability company incorporated in Bermuda. The registered office of the Company is located at Canon’s Court, 22 Victoria Street, Hamilton HM12, Bermuda.

During the year, the principal activity of the Company was investment holding while the Group was involved in property development, investment and management of residential, commercial and business park projects.

The immediate holding company of the Company is Glassy An Limited, a company incorporated in the British Virgin Islands with limited liability. In the opinion of the Directors, the ultimate holding company of the Company is 金地(集團)股份有限公司 (“Gemdale Corporation”), which is established in the PRC with limited liability and whose shares are listed on the Shanghai Stock Exchange.

Particulars of the Company’s principal subsidiaries are disclosed in note 45.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties and certain available-for-sale financial investments which have been measured at fair value. These financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated.

本公司之直接控股公司乃一家於英屬處女群島註冊成立之有限公司－潤安有限公司。董事認為本公司之最終控股公司乃一家於中國成立之有限公司－金地(集團)股份有限公司(「金地集團」)，其股份在上海證券交易所上市。

本公司主要附屬公司詳情已於附註45中披露。

Basis of consolidation

Subsidiaries

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2017. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date of acquisition, being the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Business combination involving entities under common control

The consolidated financial statements incorporate the financial statements of the combining entities or businesses as if they had been combined from the date when the combining entities or businesses first came under the control of the controlling parties.

The net assets of the combining entities or businesses are recognised at the carrying values prior to the common control combination.

Further information about those HKFRSs that are expected to be applicable to the Group is described below. Of those standards, HKFRS 9 and HKFRS 15 will be applicable for the Group's financial year ending 31 December 2018 and are expected to have impacts on the Group's financial statements upon adoption. Whilst management has performed a detailed assessment of the estimated impacts of these standards, that assessment is based on the information currently available to the Group, including expectations of the application of transitional provision options and policy choices. The actual impacts upon adoption could be different to those below, depending on additional reasonable and supportable information being made available to the Group at the time of applying the standards and the transitional provisions and policy options finally adopted.

Amendments to HKFRS 2

The HKICPA issued amendments to HKFRS 2 in August 2016 that address three main areas: the effects of vesting conditions on the measurement of a cash-settled share-based payment transaction; the classification of a share-based payment transaction with net settlement features for withholding a certain amount in order to meet an employee's tax obligation associated with the share-based payment; and accounting where a modification to the terms and conditions of a share-based payment transaction changes its classification from cash-settled to equity-settled. The amendments clarify that the approach used to account for vesting conditions when measuring equity-settled share-based payments also applies to cash-settled share-based payments. The amendments introduce an exception so that a share-based payment transaction with net share settlement features for withholding a certain amount in order to meet the employee's tax obligation is classified in its entirety as an equity-settled share-based payment transaction when certain conditions are met. Furthermore, the amendments clarify that if the terms and conditions of a cash-settled share-based payment transaction are modified, with the result that it becomes an equity-settled share-based payment transaction, the transaction is accounted for as an equity-settled transaction from the date of the modification. On adoption, entities are required to apply the amendments without restating prior periods, but retrospective application is permitted if they elect to adopt for all three amendments and other criteria are met. The Group will adopt the amendments from 1 January 2018. The amendments are not expected to have any significant impact on the Group's financial statements.

HKFRS 9

In September 2014, the HKICPA issued the final version of HKFRS 9, bringing together all phases of the financial instruments project to replace HKAS 39 and all previous versions of HKFRS 9. The standard introduces new requirements for classification and measurement, impairment and hedge accounting. The Group will adopt HKFRS 9 from 1 January 2018. The Group will not restate comparative information and will recognise any transition adjustments against the opening balance of equity at 1 January 2018. During 2017, the Group has performed an assessment of the impact of the adoption of HKFRS 9. The expected impacts relate to the classification and measurement and the impairment requirements and are summarised as follows:

(a) Classification and measurement

The Group does not expect that the adoption of HKFRS 9 will have a significant impact on the classification and measurement of its financial assets. It expects to continue measuring at fair value all financial assets currently held at fair value. Equity investments currently held as available for sale will be measured at fair value through other comprehensive income as the investments are intended to be held for the foreseeable future and the Group expects to apply the option to present fair value changes in other comprehensive income. Gains and losses recorded in other comprehensive income for the equity investments cannot be recycled to profit or loss when the investments are derecognised.

(b) Impairment

HKFRS 9 requires an impairment on debt instruments recorded at amortised cost or at fair value through other comprehensive income, lease receivables, loan commitments and financial guarantee contracts that are not accounted for at fair value through profit or loss under HKFRS 9, to be recorded based on an expected credit loss model either on a twelve-month basis or a lifetime basis. The Group will apply the simplified approach and record lifetime expected losses that are estimated based on the present values of all cash shortfalls over the remaining life of all of its trade receivables. Furthermore, the Group will apply the general approach and record twelve-month expected credit losses that are estimated based on the possible default events on its other receivables within the next twelve months. The amendments are not appeared to have significant impact on the Group's provision for impairment.

Amendments to HKFRS 10 and HKAS 28 (2011)

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

香港財務報告準則第10號及香港會計準則第28號 (2011年) 之修訂解決香港財務報告準則第10號及香港會計準則第28號 (2011年) 對於處理投資方與其聯營公司或其合營公司之間有關資產出售或注資之不一致規定。該等修訂規定當投資方與其聯營公司或其合營公司之間有關資產出售或注資構成業務時，需全面確認盈虧。若涉及資產之交易不構成業務，則投資方於損益確認交易產生之盈虧只限於不屬於投資方於其聯營公司或其合營公司權益之部份。該等修訂乃採用未來適用法。香港財務報告準則第10號及香港會計準則第28號 (2011年) 早前訂定之強制性生效日期已於2016年1月被香港會計師公會刪除，而新強制性生效日期將待對聯營公司及合營公司之會計處理完成廣泛審閱後訂定。儘管如此，此項修訂現已可作採納。

HKFRS 15

HKFRS 15, issued in July 2014, establishes a new five-step model to account for revenue arising from contracts with customers. Under HKFRS 15, revenue is recognised at an amount that reflects the consideration to which an entity expects to be entitled in exchange for transferring goods or services to a customer. The principles in HKFRS 15 provide a more structured approach for measuring and recognising revenue. The standard also introduces extensive qualitative and quantitative disclosure requirements, including disaggregation of total revenue, information about performance obligations, changes in contract asset and liability account balances between periods and key judgements and estimates. The standard will supersede all current revenue recognition requirements under HKFRSs. Either a full retrospective application or a modified retrospective adoption is required on the initial application of the standard. In June 2016, the HKICPA issued amendments to HKFRS 15 to address the implementation issues on identifying performance obligations, application guidance on principal versus agent and licences of intellectual property, and transition. The amendments are also intended to help ensure a more consistent application when entities adopt HKFRS 15 and decrease the cost and complexity of applying the standard. The Group plans to adopt the transitional provisions in HKFRS 15 to recognise the cumulative effect of initial adoption as an adjustment to the opening balance of retained earnings at 1 January 2018. In addition, the Group plans to apply the new requirements only to contracts that are not completed before 1 January 2018. The Group expects transitional adjustment to be made on 1 January 2018 upon initial adoption of HKFRS 15. However, the expected changes in accounting policies, as further explained below, will have a material impact on the Group's financial statements from 2018 onwards. During 2017, the Group has performed an assessment on the impact of adoption of HKFRS 15.

(a) Sale of properties held for sale

The timing of revenue recognition for the sale of properties held for sale is currently based on whether significant risks and rewards of ownership of properties are transferred, in accordance with the policies set out for "Revenue recognition" below. Upon adoption of HKFRS 15, revenue from the sale of properties held for sale will be recognised at a point when control of the properties is transferred to the property buyers.

於2014年7月頒佈之香港財務報告準則第15號確立了一項全新之五步模型，用以處理來自與客戶合約之收入。根據香港財務報告準則第15號，收入確認之金額為反映實體預期可將商品或服務轉讓予客戶而換取之代價金額。香港財務報告準則第15號之原則提供更為條理之方法進行計量及確認收入。該準則也引入廣泛定性及定量之披露要求，其中包括分拆總收入、關於履行之責任、各期間合約資產及負債賬目結餘之變動，以及主要判斷及估計之訊息。該準則將取代目前所有根據香港財務報告準則確認收入之規定。初始應用該準則需採用全面追溯或修訂追溯法。於2016年6月，香港會計師公會頒佈香港財務報告準則第15號之修訂，解釋採納該準則的不同實施問題，包括識別履約責任，主事人與代理人及知識產權許可有關之應用指引，以及準則採納之過渡。該等修訂亦擬協助確保實體於採納香港財務報告準則第15號時能更加一致地應用，及降低應用有關準則之成本及複雜性。本集團計劃採納香港財務報告準則第15號之過渡性條文，以確認初始採納之累計影響，並於保留溢利2018年1月1日之期初數作出調整。此外，本集團計劃僅將新規定應用於2018年1月1日前仍未完成之合約。本集團預期就初始採納香港財務報告準則第15號於2018年1月1日作出過渡性調整。然而，誠如下文進一步之解釋，會計政策預期之變化將對本集團自2018年起之財務報表產生重大影響。於2017年，本集團對採納香港財務報告準則第15號之影響已進行評估。

(a) 待出售物業之銷售

目前待出售物業之收入乃按下文「收入確認」所載之政策，根據物業擁有權之重大風險及回報是否已轉移作出確認。採納香港財務報告準則第15號後，待出售物業之收入將根據物業之控制權移交給物業買家時確認。

(a) Sale of properties held for sale (continued)

The Group expects those sales of properties held for sale with control of the properties that are not transferred to customers before 1 January 2018 and the corresponding cost of sales effect will be adjusted to the opening balance of retained earnings at 1 January 2018. The Group is currently computing the opening retained earnings impact of the above.

(b) Sales commission

The Group pays commission to the sales agent when the sale and purchase agreement is signed and the sales proceed is received from the property buyer. Following the adoption of HKFRS 15, incremental costs of obtaining a contract, including sales commission, if recoverable, are capitalised as an asset and shall be amortised on a systematic basis that is consistent with the transfer of the related property to the customer. Accordingly, the Group expects the recognition of an asset would result in an increase of opening retained profits as at 1 January 2018.

(c) Presentation and disclosure

The presentation and disclosure requirements in HKFRS 15 are more detailed than those under the current HKAS 18. The presentation requirements represent a significant change from current practice and will significantly increase the volume of disclosures required in the Group's financial statements. Many of the disclosure requirements in HKFRS 15 are new and the Group has assessed that the impact of some of these disclosure requirements will be significant. In particular, the Group expects that the notes to the financial statements will be expanded because of the disclosure of significant judgements made on determining the transaction prices of those contracts that include variable consideration, how the transaction prices have been allocated to the performance obligations, and the assumptions made to estimate the stand-alone selling price of each performance obligation. In addition, as required by HKFRS 15, the Group will disaggregate revenue recognised from contracts with customers into categories that depict how the nature, amount, timing and uncertainty of revenue and cash flows are affected by economic factors. It will also disclose information about the relationship between the disclosure of disaggregated revenue and revenue information disclosed for each reportable segment.

(b) 銷售佣金

本集團與物業買方簽訂買賣協議及收取售樓款項後向銷售代理支付佣金。隨著採納香港財務報告準則第15號，對取得合同所增加之成本(包括銷售佣金)如可收回，將資本化為資產，並按系統化基準予以攤銷，有關基準與向客戶轉讓相關物業一致。因此，本集團預期確認資產將會調增二零一八年一月一日之期初保留溢利。

(c) 呈列及披露

香港財務報告準則第15號之呈列及披露規定較現行香港會計準則第18號更為詳細。呈列規定與目前常規有重大之改動，並將大幅增加本集團財務報表所需披露量。大部份香港財務報告準則第15號之披露規定乃新訂定，而本集團已評估其中部份披露規定將有顯著之影響。特別是，由於披露有關釐定該等合約交易價格之重大判斷，包括可變代價、交易價格如何按履約責任分配，以及為估計每項履約責任之獨立售價而作出之假設，本集團預期將擴大財務報表附註。此外，根據香港財務報告準則第15號之規定，本集團與客戶合約確認之收入將分拆為描述收入及現金流量之性質、金額、時間及不確定性如何受經濟因素影響之分類。另外，還需就有關分拆收入披露與每項可呈報分部收入所披露資訊之間之關係作出披露資訊。

HKFRS 16

HKFRS 16, issued in May 2016, replaces HKAS 17 Leases, HK(IFRIC) – Int 4 *Determining whether an Arrangement contains a Lease*, HK(SIC) – Int 15 *Operating Leases – Incentives* and HK(SIC) – Int 27 *Evaluating the Substance of Transactions Involving the Legal Form of a Lease*. The standard sets out the principles for the recognition, measurement, presentation and disclosure of leases and requires lessees to recognise assets and liabilities for most leases. The standard includes two recognition exemptions for lessees – leases of low-value assets and short-term leases. At the commencement date of a lease, a lessee will recognise a liability to make lease payments (i.e., the lease liability) and an asset representing the right to use the underlying asset during the lease term (i.e., the right-of-use asset). The right-of-use asset is subsequently measured at cost less accumulated depreciation and any impairment losses unless the right-of-use asset meets the definition of investment property in HKAS 40, or relates to a class of property, plant and equipment to which the revaluation model is applied. The lease liability is subsequently increased to reflect the interest on the lease liability and reduced for the lease payments. Lessees will be required to separately recognise the interest expense on the lease liability and the depreciation expense on the right-of-use asset. Lessees will also be required to remeasure the lease liability upon the occurrence of certain events, such as change in the lease term and change in future lease payments resulting from a change in an index or rate used to determine those payments. Lessees will generally recognise the amount of the remeasurement of the lease liability as an adjustment to the right-of-use asset. Lessor accounting under HKFRS 16 is substantially unchanged from the accounting under HKAS 17. Lessors will continue to classify all leases using the same classification principle as in HKAS 17 and distinguish between operating leases and finance leases.

HKFRS 16 requires lessees and lessors to make more extensive disclosures than under HKAS 17. Lessees can choose to apply the standard using either a full retrospective or a modified retrospective approach. The Group expects to adopt HKFRS 16 from 1 January 2019. The Group is currently assessing the impact of HKFRS 16 upon adoption and is considering whether it will choose to take advantage of the practical expedients available and which transition approach and reliefs will be adopted. As disclosed in note 39(b) to the financial statements, at 31 December 2017, the Group had future minimum lease payments under non-cancellable operating leases in aggregate of approximately RMB364,961,000. Upon adoption of HKAS 16, certain amounts included therein may need to be recognised as new right-of-use assets and lease liabilities. Further analysis, however, will be needed to determine the amount of new rights of use assets and lease liabilities to be recognised, including, but not limited to, any amounts relating to leases of low-value assets and short term leases, other practical expedients and reliefs chosen, and new leases entered into before the date of adoption.

香港財務報告準則第16號

於2016年5月頒佈之香港財務報告準則第16號替代香港會計準則第17號租賃、香港(國際財務報告詮釋委員會)–詮釋第4號釐定安排是否包括租賃、香港(準則詮釋委員會)–詮釋第15號經營租賃–優惠及香港(準則詮釋委員會)–詮釋第27號評估涉及租賃法律形式交易的內容。該準則載列確認、計量、呈列及披露租賃之原則，並要求承租人就大多數租賃確認資產及負債。該準則包括給予承租人兩項租賃確認豁免–低價值資產租賃及短期租賃。於租賃開始日期，承租人將確認於租賃期作出租賃付款為負債(即租賃負債)及代表可使用相關資產之權利為資產(即有使用權資產)。除非有使用權資產符合香港會計準則第40號投資物業之定義，或有使用權資產屬於應用重估模型之物業、廠房及設備類別，否則有使用權資產其後按成本減累計折舊及任何減值虧損計量。租賃負債其後會就反映租賃負債利息而增加及因租賃付款而減少。承租人將須分別確認租賃負債之利息開支及有使用權資產之折舊開支。承租人將亦須於若干事件發生時重新計量租賃負債，例如由於租賃期變更或用於釐定該等付款之一項指數或比率變更而引致未來租賃付款變更。承租人一般將確認之重新計量租賃負債數額作為有使用權資產之調整。香港財務報告準則第16號大致沿用香港會計準則第17號內出租人之會計處理方式。出租人將繼續使用與香港會計準則第17號相同之分類原則，對所有租賃進行分類，並將之分為經營租賃及融資租賃。

香港財務報告準則第16號要求承租人及出租人作出較香港會計準則第17號更廣泛之披露。承租人可選擇採用全面追溯或修訂追溯方法應用該準則。本集團預期自2019年1月1日起採納香港財務報告準則第16號。本集團正評估採納香港財務報告準則第16號之影響，並正考慮會否選用提供之可行簡化方案及採納何種過渡方式與寬免措施。誠如財務報表附註39(b)披露，於2017年12月31日，本集團根據不可撤銷經營租約而須於未來支付之最低租金付款總數約為人民幣364,961,000元。採納香港會計準則第16號後，其中若干款項或需確認為新使用權資產及租賃負債。然而，需要進行進一步分析以確定新使用權資產和租賃負債之金額，包括但不限於與低價值資產之租賃及短期租賃相關之任何數額、其他可行簡化方案與寬免措施之選用，以及於採納前訂立之新租約。

Amendments to HKAS 40

Amendments to HKAS 40, issued in April 2017, clarify when an entity should transfer property, including property under construction or development, into or out of investment property. The amendments state that a change in use occurs when the property meets, or ceases to meet, the definition of investment property and there is evidence of the change in use. A mere change in management's intentions for the use of a property does not provide evidence of a change in use. The amendments should be applied prospectively to the changes in use that occur on or after the beginning of the annual reporting period in which the entity first applies the amendments. An entity should reassess the classification of property held at the date that it first applies the amendments and, if applicable, reclassify property to reflect the conditions that exist at that date. Retrospective application is only permitted if it is possible without the use of hindsight. The Group expects to adopt the amendments prospectively from 1 January 2018. The amendments are not expected to have any significant impact on the Group's financial statements.

HK(IFRIC) – Int 22

HK(IFRIC) – Int 22, issued in June 2017, provides guidance on how to determine the date of the transaction when applying HKAS 21 to the situation where an entity receives or pays advance consideration in a foreign currency and recognises a non-monetary asset or liability. The interpretation clarifies that the date of the transaction for the purpose of determining the exchange rate to use on initial recognition of the related asset, expense or income (or part of it) is the date on which an entity initially recognises the non-monetary asset (such as a prepayment) or non-monetary liability (such as deferred income) arising from the payment or receipt of the advance consideration. If there are multiple payments or receipts in advance of recognising the related item, the entity must determine the transaction date for each payment or receipt of the advance consideration. Entities may apply the interpretation on a full retrospective basis or on a prospective basis, either from the beginning of the reporting period in which the entity first applies the interpretation or the beginning of the prior reporting period presented as comparative information in the financial statements of the reporting period in which the entity first applies the interpretation. The Group expects to adopt the interpretation prospectively from 1 January 2018. The amendments are not expected to have any significant impact on the Group's financial statements.

香港（國際財務報告詮釋委員會）－詮釋第22號

香港（國際財務報告詮釋委員會）－詮釋第22號於2017年6月頒佈，就應用香港會計準則第21號對實體預收或預付外幣款項及確認非貨幣性資產或負債時如何釐定交易日期提供指引。該詮釋澄清釐定用於初始確認相關資產、費用或收入（或其部份）時使用之匯率之交易日期為實體初步確認因預先支付或收取代價而產生之非貨幣性資產（如預付款項）或非貨幣性負債（如遞延收入）之日期。若確認之相關項目有多筆預付款或預收款，則實體必須確定每筆預付或預收款項之交易日期。實體可按全面追溯基準或按未來適用基準應用該詮釋，於實體首次採納該詮釋之報告期間，或於實體首次應用該詮釋之報告期之前一報告期間（作為比較資訊呈列）開始時起應用。本集團預期將於2018年1月1日起按未來適用法採納該詮釋。該等修訂預期不會對本集團之財務報表構成重大影響。

HK(IFRIC) – Int 23

HK(IFRIC) – Int 23, issued in July 2017, addresses the accounting for income taxes (current and deferred) when tax treatments involve uncertainty that affects the application of HKAS 12 (often referred to as “uncertain tax positions”). The interpretation does not apply to taxes or levies outside the scope of HKAS 12, nor does it specifically include requirements relating to interest and penalties associated with uncertain tax treatments. The interpretation specifically addresses (i) whether an entity considers uncertain tax treatments separately; (ii) the assumptions an entity makes about the examination of tax treatments by taxation authorities; (iii) how an entity determines taxable profits or tax losses, tax bases, unused tax losses, unused tax credits and tax rates; and (iv) how an entity considers changes in facts and circumstances. The interpretation is to be applied retrospectively, either fully retrospectively without the use of hindsight or retrospectively with the cumulative effect of application as an adjustment to the opening equity at the date of initial application, without the restatement of comparative information. The Group expects to adopt the interpretation from 1 January 2019. The amendments are not expected to have any significant impact on the Group's financial statements.

2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investments in associates and joint ventures

As associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decision of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

香港 (國際財務報告詮釋委員會) – 詮釋第 23 號

香港 (國際財務報告詮釋委員會) – 詮釋第 23 號於 2017 年 7 月頒佈，針對稅務處理涉及影響香港會計準則第 12 號應用之不確定性 (通常稱為「不確定稅務狀況」) 時之所得稅 (即期及遞延) 之處理。該詮釋不適用於香港會計準則第 12 號範圍以外之稅項或徵費，亦無具體包括與不確定稅務處理相關利息及罰款之規定。該詮釋特別針對 (i) 實體有否分開考慮不確定稅務處理；(ii) 實體就稅務機關審查稅務處理作出之假設；(iii) 實體如何確定應課稅利潤或稅損、稅基、未使用稅損、未使用稅收抵免及稅率；以及 (iv) 實體如何考慮事實與情況之變化。該詮釋將追溯應用，可按全面追溯或將應用之累計影響調整首次應用當日之期初權益而沒有重列比較資訊之追溯。本集團預計自 2019 年 1 月 1 日起採納該詮釋。該等修訂預期不會對本集團之財務報表構成重大影響。

2.4 重要會計政策概要

於聯營公司及合營公司之投資

聯營公司指本集團持有其通常不少於 20% 股本表決權之長期權益，並可對其發揮重大影響力之實體。重大影響力為可參與投資對象之財務及營運政策決定，而非控制或共同控制該等政策。

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the asset transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

本集團之聯營公司及合營公司投資根據權益會計法按本集團應佔淨資產減任何減值損失於綜合財務狀況表列賬。

倘若會計政策存在任何不一致，則會作出相應調整。

本集團於綜合損益表及綜合其他全面收益分別計入其應佔聯營公司及合營公司收購後業績及其他全面收益。此外，當直接確認聯營公司或合營公司之權益有變動時，則本集團在適當的情況下於綜合權益變動表確認應佔之變動。本集團與其聯營公司或合營公司之交易產生之未變現盈虧會對銷，對銷金額以本集團對聯營公司或合營公司之投資為限，除非未變現虧損能證明被轉移資產出現減值。收購聯營公司或合營公司產生之商譽被納入為本集團於聯營公司或合營公司投資之一部份。

倘於聯營公司之投資變為合營公司之投資或出現相反情況，則不會重新計算保留權益。反之，該投資繼續根據權益法入賬。在所有其他情況下，倘本集團失去對聯營公司之重大影響或合營公司之共同控制，則以其公平值計量任何保留投資。失去重大影響力或共同控制之聯營或合營公司，其賬面值與保留投資之公平值及出售所得款項之差異於損益內確認。

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

業務合併乃以收購法入賬。轉讓之代價乃以收購日期之公允值計算，即就換取被收購方控制權，本集團向被收購方前擁有人所轉讓資產、本集團所承擔負債，及本集團發行股本權益於收購日期之公允值總和。就各項業務合併而言，本集團選擇是否按公允值或被收購方可識別資產淨值之應佔比例，計算被收購方之非控股股東權益，有關權益乃被收購方賦予其擁有人權利在清盤時按比例分佔其淨資產之現有擁有人權益。所有非控股股東權益其他組成部份按公允值計量。收購相關成本乃於產生時支銷。

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative values of the operation disposed of and the portion of the cash-generating unit retained.

商譽初步按成本值計量，即所轉讓總代價、已確認非控股股東權益之金額及本集團先前持有被收購方股權之公允值之總和，超出所收購可識別資產及所承擔負債淨額之差額。倘此代價及其他項目之總和低於資產淨值之公允值，於評估後，其差額將於損益內確認為議價收購收益。

於初始確認後，商譽按成本值減任何累計減值虧損計量。商譽須每年作減值檢測，倘有事件發生或情況改變顯示賬面值有可能減值時，則會更頻密地進行檢測。本集團每年對截至12月31日之商譽進行減值檢測。就減值檢測而言，於業務合併所收購商譽，乃自收購日期起分配至預期於合併所產生之協同效益中受惠之本集團各現金產生單位或各現金產生單位組，而不論本集團其他資產或負債有否轉撥至該等單位或單位組。

減值按與商譽有關之現金產生單位（現金產生單位組）可收回金額評估釐定。倘現金產生單位（現金產生單位組）之可收回金額低於賬面值，則確認減值虧損。就商譽確認之減值虧損不會於往後期間撥回。

倘商譽分配至現金產生單位（或現金產生單位組）組成部份，該單位部份業務出售時，與售出業務有關之商譽將計入業務賬面值，以釐定出售盈虧。於該等情況售出之商譽，按售出業務及保留現金產生單位部份相對價值基準計算。

Fair value measurement

The Group measures its investment properties and certain available-for-sale financial investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

公允值計量

本集團於各報告期末按公允值計量其投資物業及若干可供出售金融投資。公允值乃在市場參與者於計量日期進行之有序交易中出售資產所收取或轉移負債所支付之價格。公允值計量乃基於假設出售資產或轉移負債之交易於資產或負債的主要市場或於未有主要市場之情況下，則於資產或負債之最有利市場進行。主要或最有利市場須為本集團能進入之市場。資產或負債之公允值乃基於市場參與者為資產或負債定價所用之假設計量（假設市場參與者依照彼等之最佳經濟利益行事）。

非金融資產之公允值計量參考市場參與者可從使用該資產得到之最高及最佳效用，或將該資產售予另一可從使用該資產得到最高及最佳效用之市場參與者，從而產生經濟效益之能力。

本集團使用適用於不同情況之估值方法，而其有足夠資料計量公允值，以盡量利用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

於財務報表計量或披露公允值之所有資產及負債，根據對於公允值計量整體屬重要之最低輸入值水準按如下所述在公允值架構中分類：

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than properties held for sale, properties under development, deferred tax assets, financial assets and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in the prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

對於在財務報表以持續基準確認之資產及負債，本集團按對於公允值計量整體有重大影響之最低輸入值於各報告期末重新評估分類，以確定架構各級之間是否出現轉移。

非金融資產減值

倘有跡象顯示存在減值，或須就資產（待出售物業、發展中物業、遞延稅項資產、金融資產及投資物業除外）進行年度減值檢測，則會估計該資產之可收回金額。資產之可收回金額為該資產或現金產生單位之使用價值與其公允值減銷售成本之較高金額，並就個別資產釐定，除非有關資產並無產生在很大程度上獨立於其他資產或資產組別之現金流入，在此情況下，可收回金額就資產所屬現金產生單位釐定。

減值虧損僅於資產之賬面值超逾其可收回金額時確認。於評估使用價值時，估計未來現金流量按可反映現時市場對貨幣時間價值及資產特定風險之評估之稅前貼現率貼現至現值。減值虧損於產生期間內在損益表中與已減值資產功能一致之支出類別內扣除。

於各報告期末須評估是否有跡象顯示過往確認減值虧損不再存在或已減少。如存在該跡象，則會估計可收回金額。過往確認之資產（商譽除外）減值虧損，僅會於用以釐定該資產可收回金額之估計改變時撥回，惟撥回後之金額不得高於假設過往年度並無就資產確認減值虧損而應已釐定之賬面值（扣除任何折舊／攤銷）。減值虧損撥回於產生期間計入損益表。

Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life as follows:

Leasehold improvements	The lease terms or 5 years, whichever is shorter
Office equipment, furniture and fixtures	3-5 years
Motor vehicles	4-5 years

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

物業、廠房及設備與折舊

物業、廠房及設備按成本值減累積折舊及任何減值虧損入賬。物業、廠房及設備成本包括其購入價及將該項資產達致現行運作狀況及地點以供擬定用途之直接成本。

物業、廠房及設備項目投入運作後之支出，如維修及保養費用，一般於產生期間自損益表扣除。在符合確認標準之情況下，用於重大檢測之開支將作為重置該資產，並撥作資本性費用列入該資產之賬面值中。倘物業、廠房及設備之重要部份需不時更換，本集團會將該等部份確認為具特定可使用年期之個別資產及相應作出折舊處理。

物業、廠房及設備項目乃按直線法，就其估計可使用年期，撇銷成本至其剩餘價值計算折舊如下：

租賃物業裝修	按租約年期或五年，取兩者較短期限
辦公室設備、傢俬及裝置	三年至五年
汽車	四年至五年

當物業、廠房及設備項目之部份各有不同可使用年期，該項目之成本按合理基準在各部份中分配，而各部份個別折舊。剩餘價值、可使用年期及折舊方法在適當情況下至少於每個財政年度結束時進行檢討並調整。

物業、廠房及設備項目包括初始確認之任何重大部份於出售，或預期使用或出售不再帶來未來經濟效益時，終止確認。在終止確認資產年度內於損益表所確認之出售或報銷盈虧，指有關資產之銷售所得款項淨額與賬面值之差額。

Investment properties

Investment properties are interests in land and buildings (including the leasehold interest under an operating lease for a property which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Properties under construction or development for further use as investment properties are classified as investment properties under construction. If the fair value cannot be reliably determined, the investment properties under construction will be measured at cost until such time as fair value can be determined or construction is completed. The Group has concluded that the fair value of its investment properties under construction can be measured reliably, and therefore, the Group's investment properties under construction are measured at fair value.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise. Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

投資物業

投資物業乃持作賺取租金收入及／或作資本增值之土地及樓宇權益（包括可能符合投資物業定義之物業經營租約下之租賃權益），而非用於生產或供應貨品或服務；或非用作行政用途；或非作日常業務中之銷售。該等物業初始按成本值計量（包括交易成本）。於初始確認後，投資物業以反映於報告期末市況之公允值入賬。

供進一步用作投資物業之在建或發展中物業分類為在建投資物業。倘公允值無法可靠釐定，在建投資物業將按成本值計量，直至可釐定公允值或工程竣工為止。本集團認為其 在建投資物業之公允值能夠可靠計量，故本集團之在建投資物業按公允值計量。

因投資物業之公允值變動而產生之收益或虧損，於產生之年度計入損益表。因報銷或出售投資物業而產生之盈虧在報銷或出售年度於損益表中確認入賬。

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Property management contracts

Property management contracts are stated at cost less any impairment losses and are amortised on the straight-line basis over their estimated useful lives of 6 to 12 years.

Operating leases

Leases where substantially all the rewards and risks of ownership of assets remain with the lessor are accounted for as operating leases. Where the Group is the lessor, assets leased by the Group under operating leases are included in non-current assets, and rentals receivable under the operating leases are credited to the statement of profit or loss on the straight-line basis over the lease terms. Where the Group is the lessee, rentals payable under operating leases net of any incentives received from the lessor are charged to the statement of profit or loss on the straight-line basis over the lease terms.

Prepaid land lease payments under operating leases are initially stated at cost and subsequently recognised on the straight-line basis over the lease terms.

無形資產 (商譽除外)

獨立收購之無形資產乃於初步確認時按成本計量。於業務合併中收購之無形資產成本為於收購日期之公平值。無形資產之可使用年期可評估為有限或無限。年期有限的無形資產乃其後於可使用經濟年期內攤銷，並於該無形資產出現減值跡象時進行減值評估。可使用年期有限之無形資產的攤銷期及攤銷方法須至少於每個財務結算日檢討。

物業管理合約

物業管理合約按成本減去任何減值虧損後列賬。並且以直線法按其估計可使用年期6至12年進行攤銷。

經營租約

經營租約項下預付土地租賃付款初步按成本值列賬，其後就租期以直線法確認。

Properties under development

Properties under development are stated at cost less any impairment losses. Cost of properties under development comprises cost of acquisition, land cost, construction costs, development costs, capitalised borrowing costs and other direct costs attributable to the development. The land cost is recognised on the straight-line basis over the lease term. Impairment is assessed by the directors based on prevailing market prices, on an individual property basis.

Properties held for sale

Properties held for sale are stated at the lower of cost and net realisable value. Cost is determined by apportionment of total development cost, including capitalised borrowing cost, attributable to the unsold units. Net realisable value is determined on the basis of anticipated sales proceeds, or estimated by management based on the prevailing market conditions, less all estimated costs to be incurred to completion and selling expenses, on an individual property basis.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as financial assets at fair value through profit or loss, loans and receivables, held-to-maturity investments and available-for-sale financial investments, as appropriate. When financial assets are recognised initially, they are measured at fair value plus transaction costs that are attributable to the acquisition of the financial assets, except in the case of financial assets recorded at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

發展中物業

發展中物業乃按成本值減任何減值虧損後列賬。發展中物業成本包括收購成本、土地成本、建設成本、開發成本、撥作資本性借貸成本及其他發展應佔之直接成本。土地成本乃按租期以直線法確認。減值乃由董事根據個別物業當時之市場價格為基準而估計。

待出售物業

待出售物業乃以成本值及可變現淨值兩者中之較低者列賬。成本乃藉分配未出售單位應佔之總發展成本（包括已撥作資本性借貸成本）而釐定。可變現淨值乃根據個別物業基準計算，按預計銷售所得款項，或按管理層就當時市況而作出之估計，減去直至竣工時預計將會產生之所有成本及銷售費用。

投資及其他金融資產

初始確認及計量出售物業

金融資產於初始時適當地分類為公允值計入損益之金融資產、貸款及應收款項、持至到期之投資及可供出售金融投資。當初始確認金融資產時，以公允值加上就購入該金融資產而產生之交易成本計量，惟按公允值計入損益之金融資產除外。

所有循正常途徑買賣之金融資產於交易日（即本集團承諾購買或出售該資產當日）確認。循正常途徑買賣指規定須於市場所規定或按慣例一般既定之期間內付運資產之金融資產買賣。

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial measurement, such assets are subsequently measured at amortised cost using the effective interest rate method less any allowance for impairment. Amortised cost is calculated by taking into account any discount or premium on acquisition and includes fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in other income and gains in the statement of profit or loss. The loss arising from impairment is recognised in the statement of profit or loss in finance costs for loans and in direct operating expenses for receivables.

Available-for-sale financial investments

Available-for-sale financial investments are non-derivative financial assets in listed and unlisted equity investments. Equity investments classified as available for sale are those which are neither classified as held for trading nor designated as at fair value through profit or loss. Debt securities in this category are those which are intended to be held for an indefinite period of time and which may be sold in response to needs for liquidity or in response to changes in market conditions.

After initial recognition, available-for-sale financial investments are subsequently measured at fair value, with unrealised gains or losses recognised as other comprehensive income in the available-for-sale investment revaluation reserve until the investment is derecognised, at which time the cumulative gain or loss is recognised in the statement of profit or loss in other income and gains, or until the investment is determined to be impaired, when the cumulative gain or loss is reclassified from the available-for-sale investment revaluation reserve to the statement of profit or loss in other gains or losses. Interest and dividends earned whilst holding the available-for-sale financial investments are reported as interest income and dividend income, respectively and are recognised in the statement of profit or loss as other income and gains.

金融工具之隨後計量取決於其分類如下：

貸款及應收款項

貸款及應收款項為具有固定或可確定付款，但並無在活躍市場中報價之非衍生金融資產。初步計量後，該等資產其後以實際利率法，以攤銷成本減去任何減值撥備列賬。攤銷成本乃計及收購之任何折讓或溢價後計算，並包括屬於實際利率組成部份之費用或成本。實際利率之攤銷計入損益表之其他收入及收益。減值所產生之虧損於損益表確認為財務費用（若為貸款）及為直接經營開支（若為應收款項）。

可供出售金融投資

可供出售金融投資指上市及非上市股權投資之非衍生金融資產。分類為可供出售之股權投資指並無分類為持作買賣，亦非指定為以公允值計入損益之投資。列入此項分類之債務證券並無特定持有期限，並可能按流動資金需求或市場條件改變而出售。

於初始確認後，可供出售金融投資以公允值進行後續計量，其未變現收益或虧損作為可供出售投資重估儲備在其他全面收益中確認，直至終止確認投資為止，屆時，累積收益或虧損於損益表確認為其他收入及收益，或直至投資被釐定為出現減值為止，屆時累積收益或虧損由可供出售投資重估儲備重新分類至損益表中其他收益或虧損。持有可供出售金融投資所賺取之利息及股息分別呈報為利息收入及股息收入，並於損益表內確認為其他收入及收益。

When the fair value of unlisted equity investments cannot be reliably measured because (a) the variability in the range of reasonable fair value estimates is significant for that investment or (b) the probabilities of the various estimates within the range cannot be reasonably assessed and used in estimating fair value, such investments are stated at cost less any impairment losses.

The Group evaluates whether the ability and intention to sell its available-for-sale financial assets in the near term are still appropriate. When, in rare circumstances, the Group is unable to trade these financial assets due to inactive markets, the Group may elect to reclassify these financial assets if management has the ability and intention to hold the assets for the foreseeable future or until maturity.

For a financial asset reclassified from the available-for-sale category, the fair value carrying amount at the date of reclassification becomes its new amortised cost and any previous gain or loss on that asset that has been recognised in equity is amortised to profit or loss over the remaining life of the investment using the effective interest rate. Any difference between the new amortised cost and the maturity amount is also amortised over the remaining life of the asset using the effective interest rate. If the asset is subsequently determined to be impaired, then the amount recorded in equity is reclassified to the statement of profit or loss.

Impairment of financial assets

The Group assesses at the end of each reporting period whether there is any objective evidence that a financial asset or a group of financial assets is impaired. An impairment exists if one or more events that occurred after the initial recognition of the asset have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

倘由於(a)合理公允值估計範圍之變動對該投資而言屬重大，或(b)在該範圍內不同估計之可能性不能合理評估，並用作評估公允值，致令非上市股本投資之公允值不能可靠計量，則有關投資會按成本值減任何減值虧損列賬。

本集團評估在短期內出售可供出售金融投資之能力及意圖是否適當。基於市場淡靜致本集團未能買賣此類金融資產，若管理層有能力及有意在可預見將來持有有關資產或持有有關資產至到期，本集團於罕有情況下可選擇重新分類此等金融資產。

就自可供出售類別中重新分類之金融資產而言，於重新分類日期之公允值賬面數額成為其新攤銷成本，且該資產早前已於權益確認之任何收益或虧損，乃於投資之剩餘年期按照實際利率攤銷至損益。經攤銷之新成本與到期金額之差額，亦在該資產之剩餘年期按照實際利率攤銷。倘該資產其後釐定減值，則原計入權益之金額乃重新分類至損益表。

Financial assets carried at amortised cost

For financial assets carried at amortised cost, the Group first assesses whether impairment exists individually for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

The amount of any impairment loss identified is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not yet been incurred). The present value of the estimated future cash flows is discounted at the financial asset's original effective interest rate (i.e., the effective interest rate computed at initial recognition).

The carrying amount of the asset is reduced through the use of an allowance account and the loss is recognised in the statement of profit or loss. Interest income continues to be accrued on the reduced carrying amount using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. Loans and receivables together with any associated allowance are written off when there is no realistic prospect of future recovery and all collateral has been realised or has been transferred to the Group.

If, in a subsequent period, the amount of the estimated impairment loss increases or decreases because of an event occurring after the impairment was recognised, the previously recognised impairment loss is increased or reduced by adjusting the allowance account. If a write-off is later recovered, the recovery is credited to the statement of profit or loss.

Assets carried at cost

If there is objective evidence that an impairment loss has been incurred on an unquoted equity instrument that is not carried at fair value because its fair value cannot be reliably measured, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the current market rate of return for a similar financial asset. Impairment losses on these assets are not reversed.

Available-for-sale financial investments

For available-for-sale financial investments, the Group assesses at the end of each reporting period whether there is objective evidence that an investment or a group of investments is impaired.

If an available-for-sale asset is impaired, an amount comprising the difference between its cost (net of any principal payment and amortisation) and its current fair value, less any impairment loss previously recognised in the statement of profit or loss, is removed from other comprehensive income and recognised in the statement of profit or loss.

In the case of equity investments classified as available for sale, objective evidence would include a significant or prolonged decline in the fair value of an investment below its cost. "Significant" is evaluated against the original cost of the investment and "prolonged" against the period in which the fair value has been below its original cost. Where there is evidence of impairment, the cumulative loss – measured as the difference between the acquisition cost and the current fair value, less any impairment loss on that investment previously recognised in the statement of profit or loss – is removed from other comprehensive income and recognised in the statement of profit or loss. Impairment losses on equity instruments classified as available for sale are not reversed through the statement of profit or loss. Increases in their fair value after impairment are recognised directly in other comprehensive income.

The determination of what is "significant" or "prolonged" requires judgement. In making this judgement, the Group evaluates, among other factors, the duration or extent to which the fair value of an investment is less than its cost.

In the case of debt instruments classified as available for sale, impairment is assessed based on the same criteria as financial assets carried at amortised cost. However, the amount recorded for impairment is the cumulative loss measured as the difference between the amortised cost and the current fair value, less any impairment loss on that investment previously recognised in the statement of profit or loss. Future interest income continues to be accrued based on the reduced carrying amount of the asset using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. The interest income is recorded as part of other income. Impairment losses on debt instruments are reversed through the statement of profit or loss if the subsequent increase in fair value of the instruments can be objectively related to an event occurring after the impairment loss was recognised in the statement of profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the assets or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings, net of directly attributable transaction costs.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Loans and borrowings

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

倘現行存在合法可強制執行之權利以抵銷已確認金融資產及金融負債金額及有意按淨額基準結算，或可同時變現資產並結算負債，則金融資產及金融負債可互相抵銷，抵銷淨額於財務狀況表內呈報。

就綜合現金流量表而言，現金及現金等值項目包括持有現金及活期存款及短期高度流通之投資，該等投資可隨時兌換為可知數額之現金，而該等現金毋須承受價值變動之重大風險，而到期期限一般在購入起計三個月內，及減去按要求償還之銀行透支，而該等銀行透支乃本集團現金管理之一部份。

就綜合財務狀況表而言，現金及現金等值項目指持有現金及銀行存款（包括定期存款及與現金性質相似之資產），其用途並無限制。

撥備

因過去發生之事件而導致目前須承擔責任（法律或推定責任），並可能導致將來有資源流失以支付該責任，而該責任之金額能夠可靠估計時，撥備即予確認。

當有重大折現影響時，會就預期須用作支付責任之未來開支於報告期末確認其現值作撥備。因時間值所導致折現現值之金額增加，會列入損益表之財務費用。

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associates and joint ventures when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

所得稅包括即期及遞延稅項。於損益外確認之各項目，其有關所得稅於其他全面收益或直接於權益內確認。

即期稅項資產及負債乃經考慮本集團經營所在國家之現行詮釋及慣例，根據於報告期末之已制訂或實際已制定之稅率（及稅務法例），按預期可自稅務機關收回或付予稅務機關之數額計量。

於報告期末，資產與負債之稅基與其作為財務申報用途之賬面值之間之所有暫時差額，須按負債法就遞延稅項作出撥備。

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of each reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to the income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Revenue recognition

Revenue is recognised when it is probable that the economic benefits will flow to the Group and when the revenue can be measured reliably, on the following bases:

- (a) revenue from the sale of properties is recognised when the significant risks and rewards of the properties are passed to the purchasers when (i) an irrevocable sale and purchase contract has been entered into by both the buyer and the seller; (ii) the seller has received or obtained the right to receive all the consideration of the sale; (iii) the construction has been completed, and its quality has been inspected and accepted by the relevant government authorities; and (iv) the ready-for-delivery conditions under the sale and purchase contract have been fulfilled;
- (b) operating lease rental income is recognised on a time proportion basis over the lease terms;
- (c) property management fee income, entrusted management fee income, utility income and consulting services income are recognised when the services are rendered; and
- (d) interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial assets.

- (c) 物業管理費收入、運營託管費收入、公共業務使用費收入及顧問服務收入於提供服務時確認；及
- (d) 利息收入及持至到期之投資收入以實際利率法按應計基準於產生時確認，方法為採用將金融工具整個預計年內或較短期間（如適用）之估計未來現金流入實質貼現至金融資產賬面淨值之利率。

Employee benefits

(a) Retirement benefit costs

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all eligible employees. Contributions are made based on a percentage of the employees' salaries, allowances and other benefits and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group's employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute 18% to 30% of their payroll costs to the central pension scheme. These contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

(b) Employee leave pay and compensation entitlements

Employee entitlements to annual leave and long service payment are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service payment as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of taking leave.

本集團根據強制性公積金計劃條例，為其所有合資格僱員設立一項既定供款之強制性公積金退休保障計劃（「強積金計劃」）。按強積金計劃條例規定，供款額須按僱員薪金、津貼及其他福利之若干百分比計算，並於應付時在損益表中列賬。強積金計劃之資產與本集團之資產乃分開處理，並由獨立管理基金負責管理。本集團之僱主供款全數與僱員供款歸屬於強積金計劃內，惟根據強積金計劃之規定，屬本集團之僱主自願性供款則除外，該等供款乃僱員於供款全數歸屬前離職之情況下退還本集團。

本集團於中國大陸營運之附屬公司所聘僱員須參與由當地市政府運作之中央退休金計劃。該等附屬公司須按薪金成本之18%至30%作為中央退休金計劃供款。該等供款於其根據中央退休金計劃之規則應付時於損益表內列賬。

(b) 僱員休假權益及補償權利

僱員之年假及長期服務金權益於應享時確認。本集團就截至報告期末僱員已提供服務而產生之年假及長期服務金之估計負債作出撥備。

僱員之病假及產假在僱員正式休假前不予確認。

(c) Share-based payments

The Company operates share option schemes for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including Directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model,

The cost of equity-settled transactions is recognised in employee benefit expenses, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

(c) 以股份付款

本公司採納購股權計劃，向為本集團之成功經營作出貢獻之合資格參與者提供激勵及獎勵。本集團之僱員（包括董事）獲得以股份付款形式之薪酬，據此，僱員以提供服務作為權益工具（「以權益結算之交易」）之代價。

於2002年11月7日以後授出與僱員有關之以權益結算交易，其成本計量乃參照授出當日之公允值。公允值由外聘估值師根據二項式模式釐定。

以權益結算交易之成本於職務及／或服務條件達成時與相應之權益增加一併於僱員福利之開支內確認。於各報告期末直至歸屬日期就以權益結算交易確認之累積開支，反映歸屬期間已屆滿及本集團將最終歸屬之權益工具數目之最佳估計。於一段期間內在損益表扣除或計入之金額指於該期間之期初及期末確認之累積開支變動。

釐定獎勵之授出日公允值並不考慮服務及非市場表現條件，惟能達成條件之可能性則被評定為將最終歸屬為本集團權益工具數目之最佳估計之一部份。市場表現條件將反映在授出日之公允值。附帶於獎勵中但並無相關聯服務要求之其他任何條件皆視為非歸屬條件。反映非歸屬條件之獎勵公允值若當中不包含服務及／或表現條件乃即時予以支銷。

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the awards are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employees are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

(d) Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

因未能達至非市場表現及／或服務條件，而導致最終並無歸屬之獎勵並不會確認支銷，惟包括一項市場或非歸屬條件之獎勵，無論市場或非歸屬條件是否達成，其均會被視為已歸屬，前提是所有其他表現及／或服務條件須已達成。

倘以權益結算獎勵之條款予以修訂，則倘獎勵之原定條款獲達成，開支會按最低金額予以確認，猶如條款並未修改。此外，倘任何修訂會增加以股份付款之公允值總額，或於修訂日期計量時有利於僱員，則會確認為開支。

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Foreign currencies

The Company's functional currency is the Hong Kong dollar ("HK\$"), while these financial statements are presented in RMB, which is the Company's presentation currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to the statement of profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

借貸成本

收購、建造或生產符合條件之資產(即必需經過一段相當長之時間方可達到擬定用途或出售之資產)之直接應佔借貸成本,均撥作資本性費用作為資產成本之一部份。當資產實質上達到擬定用途或可供出售時,撥作資本性借貸成本將予以終止。專用貸款(用於支付合資格資產開支)之臨時投資所賺取之投資收入於已撥充資本之借貸成本中扣除。所有其他借貸成本於其產生期間支銷。借貸成本包括實體因資金借貸產生之利息及其他成本。

股息

末期股息於股東大會上獲股東批准後才確認為負債。建議之末期股息在財務報表附註中披露。

外幣

本公司之功能貨幣為港幣(「港幣」),而該等財務報表乃以人民幣(即本公司之呈列貨幣)呈列。本集團屬下各企業自行釐定其本身之功能貨幣,而各企業之財務報表項目均以功能貨幣計算。本集團屬下企業之外幣交易初始按交易當日適用之功能貨幣匯率入賬。以外幣列賬之貨幣資產及負債按於報告期末適用之功能貨幣匯率重新換算。結算或換算貨幣項目所產生之差額於損益表內確認。

結算或換算貨幣項目所產生之差額計入損益表,惟不包括被指定作為本集團之海外業務淨投資之部份對沖之貨幣項目。有關差額乃於其他全面收益中確認,直至售出淨投資為止,屆時,累計金額會於損益表中重新分類。該等貨幣項目之匯兌差額應佔稅項支出及抵免亦會於其他全面收益入賬。

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

The functional currencies of the Company, certain subsidiaries and certain joint ventures are currencies other than RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserves. On disposal of an operation with functional currency other than RMB, the component of other comprehensive income relating to that particular operation is recognised in the statement of profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of the Company and certain subsidiaries with functional currencies other than RMB are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of the Company and those subsidiaries which arise throughout the year are translated into RMB at the average exchange rates for the year.

外幣 (續)

以外幣歷史成本計算之非貨幣項目，採用於初始交易日之匯率換算。按公允值計算之非貨幣項目，採用釐訂公允值當日之匯率換算。換算按公允值計算之非貨幣項目所產生之收益或虧損乃按照就該項目公允值變動確認之收益或虧損予以處理（例如，其公允值收益或虧損被確認為其他全面收益或溢利或虧損之項目之換算差額亦分別被確認為其他全面收益或溢利或虧損）。

本公司、若干附屬公司及若干合營公司之功能貨幣為人民幣以外之貨幣。於報告期末，該等實體之資產及負債已按於報告期之匯率換算為人民幣，其損益表已按年內平均匯率換算為人民幣。產生之匯兌差額於其他全面收益內確認及累計至匯兌變動儲備。於出售以人民幣以外貨幣為功能貨幣之業務時，與該特定業務有關之各項其他全面收益乃於損益表確認。

就綜合現金流量表而言，以人民幣以外貨幣為功能貨幣之本公司及若干附屬公司，其現金流量按現金流量當日之匯率換算為人民幣。本公司及該等附屬公司於整個年度頻密產生之經常現金流量，則按本年度之平均匯率換算為人民幣。

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Impairment of assets

In determining whether an asset is impaired or the event previously causing the impairment no longer exists, the Group has to exercise judgement in the area of asset impairment, particularly in assessing: (1) whether an event has occurred that may affect the asset value or such event affecting the asset value does not exist; (2) whether the carrying value of an asset can be supported by the net present value of future cash flows which are estimated based upon the continued use of the asset or derecognition; and (3) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management to determine the level of impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test.

Impairment of other receivables and loans receivable

The policy for the impairment of other receivables and loans receivable of the Group is based on the evaluation of collectability and ageing analysis of accounts and on management's judgement. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables including the current creditworthiness and the past individual collection history. If the financial condition of the Group's other receivables and loans receivable was deteriorated, resulting in an impairment of their abilities to make payments, additional allowances may be required.

Land appreciation tax

Under the Detailed Rules for the Implementation of Provisional Regulations on Land Appreciation Tax ("LAT") of the PRC on 27 January 1995, all gains arising from the transfer of real estate property in Mainland China effective from 1 January 1994 are subject to LAT at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from sales of properties less deductible expenditures including amortisation of land use rights, borrowing costs and all property development expenditures.

The subsidiaries of the Group engaging in property development business in Mainland China are subject to LAT. However, the implementation and settlement of LAT vary amongst Mainland China cities and the Group has not finalised its LAT calculation and payments with various tax authorities. Accordingly, significant judgement is required in determining the amount of land appreciation and related taxes. The ultimate tax determination is uncertain during the ordinary course of business. The Group recognises these liabilities based on management's best estimates. When the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the provisions for LAT in the period in which such determination is made.

其他應收賬款及應收貸款減值

本集團其他應收賬款及應收貸款之減值政策乃根據賬目之可收回性評估及賬齡分析以及按管理層之判斷而釐定。評估該等應收款項之最終變現能力需作出大量判斷，包括各自之當前信譽及過往收款歷史。倘本集團之其他應收賬款及應收貸款之財務狀況惡化，從而削弱其付款能力，則可計提額外撥備。

土地增值稅

根據於一九九五年一月二十七日所頒佈之中國土地增值稅(「土地增值稅」) 暫行條例實施細則，於中國大陸轉讓房地產物業產生之所有收益自一九九四年一月一日起土地增值稅額須按介乎30%至60%之土地增值稅累進比率，繳納土地增值稅。土地增值稅指出售物業所得款項減可扣減開支，包括土地使用權攤銷、借貸成本及所有物業發展開支。

本集團附屬公司於中國大陸從事物業發展業務亦須繳納土地增值稅。然而，中國大陸不同城市對土地增值稅之實施及結算不盡相同，而本集團尚未與各稅務機關落實土地增值稅之計算及付款。因此，於釐定土地增值及相關稅項時須作出重大判斷。由於釐定最終稅項未能於日常業務中確定，本集團乃基於管理層之最佳估計確認此等負債。若最終稅項支出與初始列賬之數額出現差異時，該等稅項差額將於有關稅項落實期間影響土地增值稅撥備。

Operating lease commitments – Group as lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, that it retains all the significant risks and rewards of ownership of these properties which are leased out on operating leases.

Unlisted equity investment

The Group's unlisted equity investment has been stated at cost less impairment because the range of reasonable fair value estimates is so significant that management is of the opinion that its fair value cannot be measured reliably.

Determining whether the acquisition of subsidiaries constituted a business combination

Management determines whether the acquisition of subsidiaries constituted acquisition of assets and liabilities or business combination by assessing if there is business acquired. The three elements of business are input, process and output. Management exercises judgements to determine if these elements were acquired in each acquisition. If the acquired subsidiaries did not contain these elements, management will account for the acquisition of subsidiaries as acquisition of assets and liabilities.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below:

經營租約承擔 – 本集團作為出租人

本集團已就其投資物業組合訂立商用物業租約。本集團已根據安排條款及條件之評估確定其保留所有以經營租約方式出租之此等物業之絕大部份風險及回報。

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in note 33(a) to the financial statements.

Estimation of fair value of investment properties

The best evidence of fair value is current prices in an active market for similar lease terms and other contracts. In the absence of such information, management has determined the amounts within a range of reasonable fair value estimates. In making its estimation, management considers information from (i) current prices in an active market for properties of different nature, conditions or locations, adjusted to reflect those differences; (ii) recent prices of similar properties in less active markets, with adjustments to reflect any changes in economic conditions since the date of transactions that occurred at those prices; and (iii) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) from external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of cash flows.

The Group's investment properties were revalued on 31 December 2017 by independent, professionally qualified valuers, Shenzhen Touchstone Evaluation and Consultancy Co., Ltd. and CBRE Inc., on an open market, existing use basis.

Further details, including the key assumptions used for fair value measurement and a sensitivity analysis, are given in note 13 to the financial statements.

本集團至少每年測試一次商譽是否存在減值。釐定商譽是否減值須對獲分配商譽之現金產生單位之使用價值作出估計。本集團就使用價值之估計須對來自現金產生單位之預期未來現金流量進行估算，並選擇適當之貼現率以計算該等現金流量之現值。進一步詳情載於財務報表附註33(a)。

投資物業公允值之估計

公允值之最佳證明為同類租約及其他合約於活躍市場之現行價格。倘欠缺有關資料，管理層會根據合理公允值估計範圍釐定有關數額。在作出有關估算時，管理層會考慮下述資料：(i)不同性質、情況或地區物業於活躍市場之現行價格，並就不同處作出相應調整；(ii)同類物業於較不活躍市場之現行價格（已就按該價格進行交易當日起之任何經濟狀況變化作出調整）；及(iii)根據任何現有租約及其他合約之條款以及（如可行）外在證據（如同區狀況相同之同類物業當時之市場租金）所得，及採用反映當前市場對現金流量金額及時間之不確定性評估之貼現率所計算未來現金流量之可靠估計。

Fair value of unlisted available-for-sale financial investments measured at fair value

The unlisted available-for-sale financial investments have been valued based on the expected cash flows discounted at current rates applicable for items with similar terms and risk characteristics. This valuation requires the Group to make estimates about expected future cash flows, credit risk, volatility and discount rates, and hence they are subject to uncertainty. The fair value of the unlisted available-for-sale financial investments measured at fair value at 31 December 2017 was nil (2016: RMB1,300,000,000). Further details are included in note 20 to the financial statements.

Current taxes and deferred taxes

The Group is subject to income taxes in numerous jurisdictions. Significant estimation and judgement were required in determining the amount of the provision for tax and the timing of payment of the related taxes. There were transactions and calculations for which the ultimate tax determination was uncertain during the ordinary course of business.

As detailed in the Company's accounting policies, deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Where the final tax outcomes of these matters are different from the amounts that were initially recorded, such differences will impact on the income tax and deferred tax provisions in the periods in which such determination is made.

Provision

A provision is recognised when a present obligation has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate of the amount of the obligation can be made. Significant estimation is required in determining the amount of certain obligations. Where the final outcomes of these obligations are different from the amounts that were initially recognised, adjustments will be made according to the latest information available.

Estimation of total budgeted costs and costs of completion for properties under development

Total budgeted costs for properties under development comprise (i) prepaid land lease payments; (ii) building costs; and (iii) any other direct costs attributable to the development of the properties. In estimating the total budgeted costs for properties under development, management makes reference to information such as (i) current offers from contractors and suppliers; (ii) recent offers agreed with contractors and suppliers; and (iii) professional estimation on construction and material costs.

4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has three reportable operating segments as follows:

- (a) the property development segment – development and sale of residential and commercial properties;
- (b) the property investment and management segment – investment and management of business parks and commercial properties; and
- (c) the corporate segment – the Group's corporate management services to the residential, commercial and business park projects.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/(loss), which is a measure of adjusted profit/(loss) before tax. The adjusted profit/(loss) before tax is measured consistently with the Group's profit before tax except that bank interest income and finance costs are excluded from such measurement.

Segment information is presented by way of the Group's primary segment reporting basis, by business segment. No geographical segment information is presented as over 90% (2016: over 90%) of the Group's revenue is derived from customers based in Mainland China, and over 90% (2016: over 90%) of the Group's assets are located in Mainland China.

Segment assets exclude deferred tax assets, certain deposits, bank and cash balances, and prepaid tax as these assets are managed on a group basis. Segment liabilities exclude certain interest-bearing bank and other borrowings, tax payable, deferred tax liabilities, amounts due to the ultimate holding company, non-controlling shareholders, fellow subsidiaries and a related company, and loans from a fellow subsidiary as these liabilities are managed on a group basis.

During the current and prior years, there were no intersegment transactions.

4. 經營分部資料

為方便管理，本集團按其產品及服務基準來分類業務單位，現有三個可呈報經營分部如下：

- (a) 物業發展分部 – 發展及銷售住宅及商用物業；
- (b) 物業投資及管理分部 – 投資及管理商業園及商用物業；及

管理層獨立監察本集團經營分部業績，以便就資源配置及績效評估制定決策。分部績效按可呈報分部溢利／(虧損)作評估，即計量除稅前經調整之溢利／(虧損)。除稅前經調整溢利／(虧損)之計量，與本集團之除稅前溢利一致，惟銀行利息收入及財務費用則不計算在內。

本集團分部資料按本集團主要分部報告基準—業務分部呈列。由於本集團逾90% (2016年：逾90%) 之收入乃來自中國大陸之客戶，且本集團逾90% (2016年：逾90%) 之資產位於中國大陸，故並無進一步呈列地區分部資料。

分部資產不包括遞延稅項資產、若干存款、銀行及現金結餘以及預付稅金，因該等資產乃按集團基準管理。分部負債不包括若干附息銀行及其他貸款、應付稅項、遞延稅項負債、應付最終控股公司、非控股股東、同系附屬公司及關連公司款項，以及應付同系附屬公司貸款，原因為該等負債乃按集團基準管理。

於本年度及上年度內，各業務分部間並無進行任何交易。

Under the income approach, the valuation takes into account the net rental income of the properties derived from the existing leases and/or achievable in the existing market with due allowance for the reversionary income potential of the leases, which has been then capitalised to determine the market value at an appropriate capitalisation rate.

The residual method is based on the assumption that the property is newly completed in accordance with the development proposal in terms of property uses, respective saleable areas and construction schedules to establish the gross development value (“GDV”). The total development costs including construction costs, professional fees, infrastructure costs, management costs, financial costs and developer’s profit are estimated and deducted from the established GDV. The resultant residual figure is then adjusted back to the valuation date to arrive at the market value of the property interest concerned. The income approach has been used in estimating the GDV.

A significant increase/(decrease) in the reversionary rental value and GDV would in isolation result in a significant increase/(decrease) in the fair value of the investment properties. A significant increase/(decrease) in the vacancy rate, yield rate, development costs, construction period and deducted sales profit rate in isolation would result in a significant (decrease)/increase in the fair value of the investment properties. Generally, a change in the assumption made for the reversionary rental value is accomplished by a directionally similar change in the yield rate and an opposite change in the vacancy rate.

The market comparison approach is adopted by making reference to comparable market transactions in the assessment of the fair value of a property interest. The approach rests on the wide acceptance of the market transactions as the best indicator and pre-supposes that evidence of relevant transactions in the market place can be extrapolated to similar properties, subject to allowances for variable factors, including the transaction date, location, traffic condition, environmental factors, commercial atmosphere and size of land, etc. Moreover, the incurred costs are also considered in the valuation.

The cost method is a method to measure the replacement cost or reconstruction cost and depreciation of a property at the time of value, and to deduct the depreciation of the replacement cost or reconstruction cost to obtain the value or price of the property.

Deferred tax assets in respect of tax losses of RMB426,744,000 (2016: RMB445,608,000), RMB55,615,000 (2016: RMB40,470,000) and RMB115,540,000 (2016: RMB52,990,000) arising in Hong Kong, Mainland China and the United States, respectively, have not been recognised as they have arisen in subsidiaries that have been loss-making for some time and it is not considered probable that taxable profits will be available against which the tax losses can be utilised.

Pursuant to the PRC Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

At 31 December 2017, no deferred tax has been recognised for withholding taxes that would be payable on certain of the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries and joint ventures established in Mainland China. In the opinion of the Directors, it is not probable that these subsidiaries and joint ventures will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with investments in subsidiaries and joint ventures in Mainland China for which deferred tax liabilities have not been recognised was RMB175,991,000 at 31 December 2017 (2016: RMB205,266,000).

There are no income tax consequences attaching to the payment of dividends by the Company to its shareholders.

Since the acquisition, Meihao Jiayuan, Kairui and Key Dragon contributed RMB6,666,000, RMB18,664,000 and nil, respectively, to the Group's revenue for the year ended 31 December 2016 and loss of RMB2,693,000, RMB2,617,000 and RMB6,319,000, respectively, to the Group's consolidated profit for the year ended 31 December 2016. Had the combinations taken place at the beginning of the prior year, the revenue of the Group and the consolidated profit of the Group for the prior year would have been RMB8,756,139,000 and RMB1,971,966,000, respectively.

(a) Goodwill on acquisition

None of the goodwill recognised is expected to be deductible for income tax purposes. Goodwill acquired through business combination is allocated to the property investment and management cash-generating unit ("CGU") for impairment testing. The carrying amount of the CGU included goodwill of RMB4,889,000 (2016: RMB19,235,000) and intangible assets of RMB14,461,000 (2016: RMB38,950,000) as at 31 December 2017. The recoverable amount of the CGU of RMB14,745,000 (2016: RMB39,450,000) has been determined based on a value in use calculation using cash flow projections based on financial budgets covering a six-year period approved by management. The Directors have consequently determined to recognise an impairment loss on goodwill directly related to the property investment and management business amounting to RMB4,889,000 (2016: RMB19,235,000). No other significant write-down of other intangible assets of the property investment and management business of the Group is considered necessary.

This growth rate is based on the relevant industry growth forecasts and the average long-term growth rate for the relevant industry.

Assumptions were used in the value in use calculation of the property investment and management CGU for 31 December 2017 and 2016. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

Budgeted gross margins – The basis used to determine the value assigned to the budgeted gross margins is the average gross margins achieved in the year immediately before the budget year, increased for expected efficiency improvements, and expected market development.

Discount rate – The discount rate used is before tax and reflects specific risks relating to the CGU.

The values assigned to the key assumptions on market development of the property investment and management industry and the discount rate are consistent with external information sources.

On 24 August 2017, a wholly-owned subsidiary of the Company acquired a 100% equity interest in 上海利爾新材料有限公司 (Shanghai Lier Modern Material Company Limited*) (“Lier”), from an independent third party, at a cash consideration of RMB86,575,000. Lier is engaged in property development in Mainland China.

On 21 January 2016, a wholly-owned subsidiary of the Company acquired an 85% equity interest in 上海信能度爾信息科技有限公司 (Shanghai Xinneng Duer Information Technology Company Limited*) (“Xinneng”), from an independent third party, at a cash consideration of RMB166,600,000. As at 31 December 2017, the Group's outstanding guarantees amounted to RMB3,148,594,000 (2016: RMB639,580,000).

The Directors consider that the fair value of the guarantees is not significant and in case of defaulting payments, the net realisable value of the related properties will be sufficient to cover the outstanding mortgage principals, the accrued interest and penalty. Therefore, no provision has been made in the financial statements for the year ended 31 December 2017 (2016: Nil) for these guarantees.

- (b) At the end of the reporting period, the Group provided a maximum guarantee of US\$70,950,000 (equivalent to RMB463,601,000) (2016: US\$70,950,000 (equivalent to RMB492,180,000)) to a group of financial institutions for a facility granted to a joint venture of the Group in the United States of America. As at 31 December 2017, the facility guaranteed by the Group to a joint venture was utilised to the extent of approximately RMB463,601,000 (2016: RMB414,641,000).

43. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise interest-bearing bank and other borrowings, loans to/(from) related parties and cash and short term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations. It is, and has been throughout the year under review, the Group's policy that no trading in financial instruments shall be undertaken.

The main risks arising from the Group's financial instruments are foreign currency risk, interest rate risk, credit risk and liquidity risk. The Group's policies for managing each of these risks are summarised below.

Foreign currency risk

The Group mainly operates in Mainland China and most of the transactions, assets and liabilities are denominated in RMB. The Group had certain deposits and bank balances, advanced receipts, accruals and other payables, and interest-bearing bank and other borrowings denominated in currencies other than the functional currency to which they relate.

On 31 December 2017, assuming that RMB depreciated by 7% (2016: 6%) against HK\$ and US\$, respectively, and all other factors remained unchanged, then the profit after tax of the Group would have increased by RMB3,876,000 and RMB3,661,000 (2016: RMB9,872,000 and RMB4,796,000), respectively.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's bank and other borrowings, loans from the ultimate holding company, a non-controlling shareholder and joint ventures, and loans to joint ventures, non-controlling shareholders and related companies with floating interest rates. The interest rates and terms of repayment of the Group's borrowings are disclosed in notes 28 and 29 to the financial statements. The Group's policy is to obtain the most favourable interest rates available for its borrowings. Management monitors interest rate exposure and will consider hedging significant interest rate exposure should the need arise.

於2017年12月31日，假設人民幣兌港幣及美元分別貶值7%（2016年：6%），而其他因素仍維持不變，則本集團之除稅後溢利將分別增加人民幣3,876,000元及人民幣3,661,000元（2016年：人民幣9,872,000元及人民幣4,796,000元）。

利率風險

本集團所面對市場利率變動風險主要與本集團浮息之銀行及其他貸款、應付最終控股公司、應付非控股股東及應付合營公司貸款，以及應收合營公司、應收非控股股東及應收關連公司貸款有關。本集團貸款之利率及償還期於財務報表附註28及29內披露。本集團之政策乃為其貸款爭取最優惠利率。管理層負責監控利率風險，倘有需要將考慮對沖重大之利率風險。

Credit risk

The Group trades only with recognised and creditworthy third and related parties. Except for the sales of properties, for which no credit is given to the customers, it is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

The credit risk of the Group's other financial assets, which comprise deposits and other receivables, available-for-sale financial investments, loans to joint ventures, loans to related companies, loans to non-controlling shareholders, an amount due from the ultimate holding company, amounts due from fellow subsidiaries, amounts due from joint ventures, amounts due from associates, amounts due from non-controlling shareholders, amounts due from related companies, restricted cash, and deposits, bank and cash balances, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

Since the Group trades only with recognised and creditworthy third and related parties, there is no requirement for collateral. There are no significant concentrations of credit risk within the Group as the Group's trade receivables are widely dispersed in different sectors.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables, deposits and other receivables are disclosed in notes 21 and 22 to the financial statements.

Liquidity risk

The Group monitors its risk to a shortage of funds using a recurring liquidity planning tool. This tool considers the maturity of both its financial instruments and financial assets (e.g., trade receivables) and projected cash flows from operations.

The Group's objective is to maintain a balance between continuity of funding and flexibility through the use of loans from related parties and interest-bearing bank and other borrowings. The Group will consistently maintain a prudent financing policy and ensure that it maintains sufficient cash and credit lines to meet its liquidity requirements. Through maintaining a reasonable proportion in its asset and liability structure, the Group is able to meet its ongoing financial needs. At 31 December 2017, 68% (2016: 99%) of the Group's debts, which comprise loans from related parties, and interest-bearing bank and other borrowings (2016: loans from related parties, and interest-bearing bank and other borrowings), would mature in less than one year from the reporting date based on the carrying values of borrowings reflected in the financial statements.

Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to run operations on a going concern basis and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2017 and 31 December 2016.

The Group monitors capital using a gearing ratio, which is the total of loans from related parties and interest-bearing bank borrowings divided by total equity. The Group's policy is to maintain the gearing ratio at less than 150% and comply with the relevant requirements of bank loan agreements.
