- (iii) by personal delivery to the Company’s Hong Kong Branch Share Registrar of 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong SAR.

You may at any time by reasonable notice in writing or by email to the Company’s Hong Kong Branch Share Registrar at (gentinghk.ecom@computershare.com.hk) change your choice of language or means of receipt of the Company’s future Corporate Communication ^(Note). For this purpose, you may simply complete **Part B** of the Change Request Form and return it by one of the abovementioned methods to the Company’s Hong Kong Branch Share Registrar. Shareholders are encouraged to select the option of Website Version, which will help preserve the environment and save printing and mailing costs for the Company. The Change Request Form may also be downloaded from the Company’s website at (www.gentinghk.com) or the Stock Exchange’s website at (www.hkexnews.hk).
