UNAUDITED CONSOLIDATED RESULTS FOR THE THREE MONTHS ENDED 31 MARCH 2018

The board of directors (the "**Board**") of China Longyuan Power Group Corporation Limited* (the "**Company**") announces the unaudited consolidated results for the three months ended 31 March 2018 of the Company and its subsidiaries (the "**Group**").

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

For the three months ended 31 March 2018, revenue of the Group amounted to RMB6,862 million, representing an increase of 12.90% over the corresponding period of last year. In particular, revenue from our wind power business (excluding revenue from concession services) amounted to RMB4,988 million, representing an increase of 30.95% over the corresponding period of last year, whereas revenue from our coal power business amounted to RMB1,768 million, representing a decrease of 16.49% over the corresponding period of last year, and revenue from other business departments amounted to RMB104 million, representing a decrease of 21.80% over the corresponding period of last year. Net profit attributable to equity holders of the Company amounted to RMB1,901 million, representing an increase of 67.05% over the corresponding period of last year. Power generation on consolidated basis amounted to 13,603,763 MWh, representing an increase of 20.61% over the corresponding period of last year. In particular, wind power generation amounted to 10,976,883 MWh, representing an increase of 33.16% over the corresponding period of last year, whereas coal power generation amounted to 2,500,178 MWh, representing a decrease of 13.42% over the corresponding period of last year, and other renewable energy power generation amounted to 126,702 MWh, representing a decrease of 14.25% from the corresponding period of last year.
