REQUEST FOR REVIEW OF THE FIRST DELISTING STAGE DECISION

This announcement is made by State Energy Group International Assets Holdings Limited (the “**Company**”, together with its subsidiaries, collectively referred to as the “**Group**”) pursuant to the Inside Information Provisions (as defined in the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance, Chapter 571 of the Hong Kong laws and Rule 13.09 of the Listing Rules.

Reference is made to the announcement (the “**Announcement**”) of the Company dated 11 June 2018 in relation to the decision of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) to suspend trading in the Company’s shares under Rule 6.01(3) of the Listing Rules and place the Company in the first delisting stage under Practice Note 17 of the Listing Rules. Capitalized terms used herein shall bear the same meanings as defined in the Announcement unless otherwise stated.

After seeking professional advice, on 15 June 2018, the Company submitted a written request to the Listing Committee of the Stock Exchange for the Decision to be referred to the Listing Committee for review (the “**Review Request**”) pursuant to Rule 2B.06(1) of the Listing Rules.

The board of directors of the Company hereby reminds the shareholders and potential investors of the Company that the outcome of such Review Request is uncertain.

Should there be any material development of this matter, further announcement(s) will be made by the Company as and when appropriate and in accordance with the requirements of the Listing Rules. Shareholders and potential investors of the Company who have any queries about the implications of the Review Request or the Decision are advised to seek professional advice as they may consider appropriate.
