On behalf of the Board of Directors of Allan International Holdings Limited (the "Company"), I am pleased to present the audited consolidated financial statements of the Company and its subsidiaries (collectively, the "Group") for the year ended 31 March 2018.

For the year ended 31 March 2018, the Group's sales turnover decreased by 1.5% to HK\$1,305.2 million (2017: HK\$1,325.1 million) and the consolidated net profit decreased by 35.9% to HK\$46.8 million (2017: HK\$72.9 million). Basic earnings per share of the Group for the year ended 31 March 2018 was HK13.9 cents (2017: HK21.7 cents). The Board of Directors has resolved to recommend at the forthcoming Annual General Meeting the payment of a final dividend of HK6.0 cents (2017: HK10.5 cents) per share for the year ended 31 March 2018 to the shareholders on 12 September 2018 whose names appear on the Register of Members of the Company on 24 August 2018. Together with the interim dividend of HK2.0 cents per share paid in January this year, the total dividend for the year ended 31 March 2018 will be HK8.0 cents per share (2017: HK12.5 cents).

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

The Group is engaged in design, manufacturing and trading of a wide range of household electrical appliances.

Business environment for the year ended 31 March 2018 continued to be difficult and challenging. Sales turnover dropped across all 3 major markets with weak demands. Fierce competition and pressure from customers for lower product selling prices have affected the sales turnover adversely.

During the year under review, sales turnover decreased by 1.5% to HK\$1,305.2 million. Sales turnover to Europe decreased by 1.3% to HK\$646.7 million representing 49.5% of the Group's sales turnover. Sales turnover to Asia decreased by 1.7% to HK\$327.0 million representing 25.1% of the Group's sales turnover. Sales turnover to America decreased by 2.7% to HK\$293.6 million representing 22.5% of the Group's sales turnover. Sales turnover to other markets increased by 6.5% to HK\$37.9 million representing 2.9% of the Group's sales turnover.

截至二零一八年三月三十一日十年度,本集 團之銷售營業額下跌1.5%至13億520萬港元 (二零一七年:13億2,510萬港元)及綜合純 利下跌35.9%至4,680萬港元(二零一七年: 7,290萬港元)。本集團截至二零一八年三月 三十一日止年度之每股基本盈利為13.9港仙 (二零一十年:21.7港仙)。董事會已決議於 應屆股東周年大會上建議派發截至二零一八 年三月三十一日止年度之末期股息每股6.0 港仙(二零一七年:10.5港仙),末期股息將 於二零一八年九月十二日派發予於二零一八 年八月二十四日名列在本公司股東名冊上 之股東。連同已於本年一月份派發之中期股 息每股2.0港仙,截至二零一八年三月三十一 日止年度之股息總額將為每股8.0港仙(二 零一十年:12.5港仙)。

管理層討論與分析

業務回顧

本集團從事設計、製造及銷售多種家庭電 器。

截至二零一八年三月三十一日止年度的一年,營商環境仍然舉步維艱及極具挑戰性,由於需求疲弱以致橫跨三個主要市場的銷售營業額均下降。劇烈競爭及客戶對產品要求降低售價帶來之壓力均打擊銷售營業額。

於回顧年度,銷售營業額下跌1.5%至13億520萬港元。歐洲銷售營業額下跌1.3%至6億4,670萬港元,佔本集團銷售營業額49.5%。亞洲銷售營業額下跌1.7%至3億2,700萬港元,佔本集團銷售營業額25.1%。美洲銷售營業額下跌2.7%至2億9,360萬港元,佔本集團銷售營業額22.5%。其他市場銷售營業額上升6.5%至3,790萬港元,佔本集團銷售營業額2.9%。

Gross profit for the year ended 31 March 2018 decreased by 32.7% to HK\$128.9 million. Gross profit margin decreased from 14.5% to 9.9%. The deterioration in gross profit margin was mainly due to increase in raw material costs, appreciation in Renminbi, shortage of skilled labour and increase in manufacturing costs in the PRC. Due to immense competition, we were not able to pass on these cost impacts onto our customers.

The Group continued to apply stringent control on all costs and expenses. Selling and distribution expenses decreased by 0.5% to HK\$24.6 million. As a percentage to sales turnover, selling and distribution expenses maintained at 1.9% for both years. Administration expenses decreased by 7.8% to HK\$108.7 million. As a percentage to sales turnover, administration expenses decreased from 8.9% to 8.3% compared to last year.

On 13 January 2016, the Group entered into a sale and purchase agreement with an independent third party to disposal of a property, namely, all that 12th floor of Zung Fu Industrial Building, 1067 King's Road, Hong Kong at a cash consideration of HK\$179.0 million. In addition, pursuant to the agreement, upon completion of the transaction, the Group continues to occupy the property by entering into a tenancy agreement with the Purchaser in respect of the Property for three years commencing from the date of completion, 3 March 2016. This sale and leaseback arrangement resulted in a gain of HK\$110.8 million recognised in the year ended 31 March 2016. Amortization of deferred income arising thereof for the year ended 31 March 2018 was HK\$19.3 million (2017: HK19.3 million).

The investment property located in Wanchai, Hong Kong was revaluated at HK\$281 million at 31 March 2018 (2017: HK\$250.8 million) giving rise to an increase in fair value of HK\$30.2 million in the consolidated statement of profit or loss and other comprehensive income.

Net Profit for the year decreased by 35.9% to HK\$46.8 million (2017: HK\$72.9 million). Net profit margin decreased from 5.5% to 3.6% compared to last year.

截至二零一八年三月三十一日止年度之毛利下跌32.7%至1億2,890萬港元。毛利率由14.5%下跌至9.9%。毛利率轉差主要是由於原材料成本上升、人民幣升值、中國熟練工人短缺及生產成本上漲所致。由於競爭激烈,我們未能將此等成本壓力轉嫁予客戶。

本集團繼續對所有成本及開支實施嚴格的控制。銷售及分銷開支減少0.5%至2,460萬港元。銷售及分銷開支佔銷售營業額之百分比這兩年維持在1.9%水平。行政開支減少7.8%至1億870萬港元。行政開支佔銷售營業額之百分比由去年之8.9%減少至8.3%。

於二零一六年一月十三日,本集團與一獨立第三方訂立一份買賣合約,出售香港英皇道1067號仁孚工業大廈12樓整層,現金代價為1億7,900萬港元。此外,根據合約協議,在完成交易後,本集團與買方就該物業可可租約,租賃期為三年,由交易完成日,即二零一六年三月三日起計,可繼續本至,即二零一六年三月三十一日止年內確認。截至二零一八年三月三十一日止年度,遞延收入難為1,930萬港元(二零一七年:1,930萬港元)。

位於香港灣仔的投資物業已於二零一八年 三月三十一日重估為2億8,100萬港元(二零一七年:2億5,080萬港元),導致公平值增加 3,020萬港元,已計入綜合損益及其他全面 收益表內。

本年度純利減少35.9%至4,680萬港元(二零一七年:7,290萬港元)。純利率由去年之5.5%下降至3.6%。

PROSPECTS

It is impossible to predict how the on-going trade dispute among China and US and the European Union would affect the global economy. The impact on Allan and our customers are therefore unknown yet. As such, we expect the business environment to be highly volatile and full of many challenges. We expect the adverse conditions of rising raw material costs, shortage in skilled labour, rising manufacturing costs and currency fluctuations would continue. On top of this, we are recently facing the issue of a sudden increase in leadtime and limited supply in certain electronic components. This will inevitably drive up the costs of these electronic components and will cause delay in our delivery schedules to our customers. We are currently working closely with our customers and suppliers to mitigate the negative impact.

All in all, we will stay vigilant and versatile in our manufacturing capacity and resources planning in response to fluctuations in market demands. We would strive to stay slim and efficient through automation, manpower streamlining and process improvements. We would invest in our engineering and R&D capabilities to offer total project management with unique and innovative product platforms to our customers. Stringent cost and expense control, productivity efficiency improvements, persistence in quality products and engineering and R&D capabilities would continue to be our focus and top priorities. We continue to seek growth opportunities through new customers and new product categories. We will also look for business opportunities to create higher value to our shareholders.

With our prudent and pragmatic business approach, financial strength and commitment to excel, we will strive on and tread cautiously to ride through the current and coming difficulties and challenges.

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2018, the Group had total assets of HK\$1,587.4 million (2017: HK\$1,608.2 million) which was financed by current liabilities of HK\$405.4 million (2017: HK\$417.9 million), long-term liabilities, deferred income and taxation of HK\$44.0 million (2017: HK\$72.1 million) and shareholders' equity of HK\$1,138.0 million (2017: HK\$1,118.2 million).

展望

流動資金及財務資源

於二零一八年三月三十一日,本集團之總資產為15億8,740萬港元(二零一七年:16億820萬港元),資金來源包括流動負債4億540萬港元(二零一七年:4億1,790萬港元)、長期負債、遞延收入及税項為4,400萬港元(二零一七年:7,210萬港元)及股東權益11億3,800萬港元(二零一七年:11億1,820萬港元)。

The Group continued to maintain a strong financial position and a healthy liquidity position. As at 31 March 2018, the Group held HK\$597.0 million (2017: HK\$731.3 million) in cash and bank deposits. They were mainly placed in Renminbi and US dollar short term deposits, except for temporary balances held in other currencies as required pending specific payments. For the year ended 31 March 2018, the Group generated net cash outflow from operating activities of HK\$32.4 million (2017: inflow HK\$152.4 million). As at the same date, total borrowings were HK\$41.4 million (2017: HK\$46.5 million) and the gearing ratio (ratio of total borrowings to shareholders' equity) was 3.6% (2017: 4.2%).

We continue to apply stringent control over the working capital cycle. The inventory balance as at 31 March 2018 increased from HK\$88.2 million to HK\$98.9 million. Inventory turnover increased from 26 days to 29 days compared to last year. The trade receivables balance as at 31 March 2018 increased from HK\$254.2 million to HK\$289.0 million. Trade receivables turnover increased from 70 days to 81 days compared to last year. The trade payables balance as at 31 March 2018 increased from HK\$188.7 million to HK\$193.2 million. Trade payables turnover decreased from 61 days to 60 days.

Funding for day-to-day operational working capital and capital expenditures are to be serviced by internal cash flow and available banking facilities. For the year ended 31 March, 2018, the group invested HK\$32 million (2017: HK\$22 million) in plant and machinery, moulds and tools, equipment, computer systems and other tangible assets for expansion and upgrade to our manufacturing facilities. The Group's capital expenditures were funded by internal resources and bank loans. With a healthy financial position and available banking facilities, the Group is able to provide sufficient financial resources for our current commitments, working capital requirements, further expansions of the Group's business operations and future investment opportunities, as and when required.

本集團持續保持雄厚財務狀況,流動資金狀況亦相當穩健。於二零一八年三月三十一日,本集團持有現金及銀行存款5億9,700萬港元(二零一七年:7億3,130萬港元)。除為支付特定付款而須持有之臨時其他貨幣外,大部分存入人民幣及美元短期存款戶口。報至二零一八年三月三十一日止年度,本集團來自經營業務之現金流出淨額為3,240萬港元(二零一七年:流入1億5,240萬港元)。同日,借貸總額為4,140萬港元(二零一七年:4,650萬港元),而資產負債比率(即借貸總額除以股東權益)為3.6%(二零一七年:4.2%)。

本集團繼續對營運資金周期實施嚴格監控。 於二零一八年三月三十一日,存貨結餘由 8,820萬港元增加至9,890萬港元。與去年相 比,存貨周轉率由26天增加至29天。於二零 一八年三月三十一日,應收貿易賬款結餘由 2億5,420萬港元增加至2億8,900萬港元。與 去年相比,應收貿易賬款周轉率由70天增加 至81天。於二零一八年三月三十一日,應付 貿易賬款結餘由1億8,870萬港元增加至1億 9,320萬港元。應付貿易賬款周轉率從61天 減少至60天。

就日常營運所需之營運資金及資本開支而言,資金來源為內部流動現金及備用銀行信貸。截至二零一八年三月三十一日止年度,本集團投資約3,200萬港元(二零一七年:2,200萬港元)於廠房及機器、模具及工具、設備、電腦系統及其他有形資產,用於之足,與備、電腦系統及其他有形資產本開支之,與一個人。本集團資本集團資本集團資本集團,並於有需要時,供本集團進一步擴展業務及掌握未來投資商機。

The majority of the Group's assets and liabilities and business transactions were denominated in Hong Kong dollars, US dollars, Renminbis. Currently the Group does not implement hedging activity to hedge against foreign currency exposure. However, we will closely monitor foreign currency exposure and consider hedging significant foreign currency exposure should the need arise.

As at 31 March 2018, the Group did not have any significant contingent liabilities.

As at 31 March 2018, the Group employed approximately 3,440 employees (2017: 3,770). The majority of our employees work in the PRC. The Group remunerated our employees based on their performances, experiences and prevailing market rates while performance bonuses are granted on a discretionary basis. Share options may also be granted to employees based on individual performance and attainment of certain set targets.

Cheung Lai Chun, Maggie, aged 60, was appointed as Chairman of the Group on 17 March 2017 and joined the Group in 1984. She obtained a degree in Bachelor of Science from Kingston University London, England. She is responsible for formulating the Group's overall strategic planning and development, and also in charge of the overall manufacturing operations of the Group.

Ms. Cheung Lai Chun, Maggie is the daughter of Mr. Cheung Lun, the Honorary Chairman of the Group; sister of Mr. Cheung Shu Wan, the Managing Director, Ms. Cheung Lai See, Sophie, an Executive Director, Dr. Cheung Shu Sang, William, an Executive Director and Mr. Cheung Shu Chun, Simon, the Director of Cost Innovation; and also the cousin of Mr. Cheung Pui, an Executive Director of the Group.

Ms. Cheung is a Director of all subsidiaries of the Company. She is also a Director of Unison Associates Limited and Allan Investment Company Limited, controlling shareholders of the Company. As at 31 March 2018, according to the register maintained by the Company pursuant to section 352 of the Securities and Futures Ordinance ("SFO"), Ms. Cheung had personal interest in 600,000 shares and The Cheung Lun Family Trust (the beneficiaries of which include Ms. Cheung and other family members other than spouse) directly and indirectly had interest in 156,349,960 Shares. Details of her interests are set out in the "Directors' and Chief Executives' Interests and Short Positions in Shares, Underlying Shares and Debentures" of this report.

Cheung Shu Wan, aged 57, is the Managing Director of the Group and joined the Group in 1983. He obtained a degree in Bachelor of Science from the University of London, England. He is responsible for the sales & marketing functions of the Group. He also assists the Chairman in corporate strategic planning and development.

The Company recognizes that good corporate governance is vital to the success of the Group and the sustained development of the Group. The Company aims at complying with, where appropriate, all code provisions as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

本公司深明良好企業管治對本集團之成功及持續發展十分重要。本公司致力遵守(在適當情況下)香港聯合交易所有限公司證券上市規則(「上市規則」)附錄14所載之「企業管治守則」(「企管守則」)中所有守則條文。

The Company's corporate governance practices are based on the principles and the code provisions as set out in the CG Code. The Company has, throughout the year ended 31 March 2018, applied and complied with most of the code provisions save for certain deviations from the code provisions in respect of code provisions A.4.1, A.4.2, A.5.1, A.6.7 and E.1.2, details of which are explained below.

There is a clear division of responsibilities between the Board and the management. The Board is responsible for providing high-level guidance and effective oversight of the management while day-to-day management of the Group is delegated to the management team of each respective subsidiary. Generally speaking, the Board is responsible for:

- Formulating the Group's long term strategy and monitoring the implementation thereof
- Approval of interim and year end dividend
- Reviewing and approving the annual and interim reports
- Ensuring good corporate governance and compliance
- Monitoring the performance of the management
- Reviewing and approving any material acquisition and assets disposal

The Board authorises the management to carry out the strategies that have been approved.

The Board meets regularly at least four times a year and additional meetings or telephone conferences are convened as and when the Board considers necessary. During the year, four board meetings were held. Details of the Directors' attendance record in the year are as follows:

The Company has complied with the Rules 3.10(1), 3.10(2) and 3.10A of the Listing Rules relating to the appointment of at least three Independent Non-Executive Directors and one of the Independent Non-Executive Directors has appropriate professional qualifications or accounting or related financial management expertise. Each of the Independent Non-Executive Directors has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all Independent Non-Executive Directors meet the independence guidelines set out in Rule 3.13 of the Listing Rules.

Permitted Indemnity Provision

The Company has arranged for directors and officers liability insurance to indemnity its directors against liabilities arising out of corporate activities. The insurance coverage is reviewed on an annual basis.

Chairman and Chief Executive

The Board considered that the duties of the Managing Director, Mr. Cheung Shu Wan ("MD") were no different from that required of a chief executive stipulated under the code provision A.2.1 of the CG Code. The management would regard that the term MD will have the same meaning as the chief executive of the Company.

Ms. Cheung Lai Chun, Maggie, the Chairman of the Board, is an Executive Director who is responsible for the leadership and effective running of the Board, and ensuring that all significant and key issues are discussed and where required, resolved by the Board timely and constructively.

The MD of the Board is delegated with the authority and responsibility to run the Group's business and day-to-day operation, and implement the Group's strategy with respect to the achievement of its business objectives with the assistance of the executive directors and senior management.

Appointment and Re-election of Directors

Code provision A.4.1 stipulates that Non-Executive Directors should be appointed for a specific term, subject to re-election.

Currently, neither the Non-Executive Director nor three Independent Non-Executive Directors of the Company is appointed for a specific term. This constitutes a deviation from the CG Code. In accordance with the provisions of the Bye-laws of the Company, any director appointed by the Board during the year shall retire and submit themselves for re-election at the first general meeting immediately following his/her appointment. Further, at each annual general meeting, one-third of the directors for the time being, or if their number is not three or multiple of three, then the number nearest to but not exceeding one-third, shall retire from office. The directors to retire by rotation shall be those who have been longest in office since their last re-election or appointment. As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are similar to those in the CG Code.

董事會董事總經理獲授予權限及責任,管理 本集團業務之營運及日常運作,並在執行董 事和高級管理層協助下,執行本集團為達致 其業務目標所訂之策略。

董事之委任及重選

守則條文第A.4.1條規定非執行董事的委任 應有指定任期,並需接受重新選舉。

現時,非執行董事及三名獨立非執行董事並 無指定任期,構成與企管守則有所偏差。根 據本公司細則之條文,董事會年內獲委任之 任何董事須於緊隨其獲委任後首次股東屆 會上輪值告退及膺選連任。此外,於每屆 東周年大會上,當時三分之一董事(成者, 數並非三或三之后數時,則為最接近者, 數並非三或三之后數時,則為最接近者, 不得多於三分之一的人數)應輪值告退。 值告退之董事須為自上次獲重選或任 來任期最長之董事。因此,本公司認為已採 取足夠措施,確認本公司之企業管治常規與 企管守則內所載者相若。

Code provision A.4.2 stipulates that all directors appointed to fill a casual vacancy should be subject to election by shareholders at the first general meeting after their appointment, and every director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years.

According to the Bye-laws of the Company, the chairman and/or the managing director is not subject to retirement by rotation or taken into account in determining the number of directors to retire. This constitutes a deviation from the CG Code. As continuation is a key factor to the successful implementation of any long term business plans, the Board believes that, the present arrangement is most beneficial to the Company and the shareholders as a whole.

Directors' Training

All Directors participate in continuous professional development to develop and refresh their knowledge and skills. This is to ensure that their contribution to the Board remains informed and relevant. All directors participate in appropriate continuous professional development activities by ways of attending training or reading material relevant to the Company's business or to the directors' duties and responsibilities. During the year ended 31 March 2018, the Company has provided an update on the latest development and changes of the Listing Rules, applicable laws, rules and regulations relating to directors' duties and responsibilities to each of Ms. Cheung Lai Chun, Maggie, Mr. Cheung Shu Wan, Ms. Cheung Lai See, Sophie, Mr. Cheung Pui, Dr. Cheung Shu Sang, William, Mr. Cheung Lun, Dr. Chan How Chun, Rita, Mr. Lai Ah Ming, Leon and Professor Lo Chung Mau to keep themselves update on the roles, functions and duties of a listed company director. The Company has received the records of training from all directors.

The Audit Committee was established in 1999 and comprises three Board members, all of whom are independent non-executive directors. The Audit Committee has adopted the same terms of reference, which describe the authority and duties of the Committee, as quoted under code provision C.3.3 of the CG Code.

The Audit Committee will meet at least twice each year. During the year, the Audit Committee met twice considering the annual results of the Group for the financial year ended 31 March 2018 and the interim results of the Group for the 6 months ended 30 September 2017, assessing any changes in accounting policies and practices, major judgmental areas and compliance with applicable legal and accounting requirements and standards, discussing with the auditor of the Company on the risk management and internal control systems.

Nomination of Directors

Code provision A.5.1 stipulates that the Company should establish a nomination committee. Currently, the Company does not have a nomination committee. The Board will identify individuals suitably qualified to become board members when necessary. The Board will give due consideration to the suitability of a candidate for directorship after taking into account of his/her experience, qualification and other relevant factors. All candidates must also meet the standards as set forth in Rules 3.08 and 3.09 of the Listing Rules. A candidate who is to be appointed as an independent non-executive director should also meet the independence criteria set out in Rule 3.13 of the Listing Rules.

Corporate Governance Functions

The Board is responsible to develop and review the Company's policies and practices on corporate governance; review and monitor the training and continuous professional development of directors and senior management; review and monitor the Company's policies and practices on compliance with legal and regulatory requirements; review and monitor the code of conduct applicable to employees and directors; and review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

Company Secretary

Ms. Wong Lai Yung joined the Company since 2006 and was appointed as the Company Secretary in 2012. Ms. Wong is responsible to update and provide advice to the Board in relation to directors' obligations under the Listing Rules, applicable laws and regulations, and corporate governance matters. Ms. Wong has provided her training records to the Company indicating her compliance with the training requirement under Rule 3.29 of the Listing Rules. Ms. Wong's biographical details are provided in the "Directors and Senior Management" section of this Annual Report.

Risk Management and Internal Controls

The Board acknowledges that it is its duty to monitor the risk management and internal control systems of the Group on an ongoing basis and review their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board, through the Audit Committee, conducted an annual review of both design and implementation effectiveness of the risk management and internal control systems of the Group, covering all material controls, including financial, operational and compliance controls, with a view to ensuring that resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions are adequate. In this respect, the Audit Committee communicates any material issues to the Board.

In light of the size, nature and complexity of the business of the Group, the Directors are of the view that it would be more cost effective to appoint external independent professionals to perform internal audit function for the Group in order to meet its needs. The Group does not have an internal audit department and will continue to review the need for an internal audit function.

During the year, the Group appointed KLC Transactions Limited ("KLC") as an external independent professional to:

- assist in identifying and assessing the risks of the Group through a series of interviews; and
- independently perform internal control reviews and assess effectiveness of the Group's risk management and internal control systems.

風險管理及內部監控

董事會確認,其有責任持續監察本集團之風險管理及內部監控系統,並檢討其有效性。 有關系統旨在管理而非消除未能達成業務 目標的風險,並僅可就重大的失實陳述或損 失作出合理而非絕對保證。

董事會透過審核委員會,每年檢討本集團風險管理及內部監控系統的設計及實施成效,涵蓋所有重大監控措施,包括財務、營運及合規控制,以確保本集團的會計、內部審核及財務報告職能均具備充足的資源、員工資歷及經驗、培訓項目及預算。在此方面,審核委員會向董事會通報任何重大事項。

考慮本集團業務之規模、性質及結構而言, 董事認為聘用外部獨立專業人士為本集團 進行內部審核工作以滿足需求,更具成本效 益。本集團目前並無內部審計部門,會持續 審視設立內部審計部門之需要。

年內,本集團委任禮恒企業財務服務有限公司(「禮恒企業財務服務」)擔任外部獨立專業人士以:

- 透過一系列訪談,協助識別及評估本集 團的風險;及
- 獨立進行內部監控審核並評估本集團 的風險管理及內部監控系統之有效性。

The results of the independent review and assessment were reported to the Audit Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by KLC to enhance the risk management and internal control systems of the Group and mitigate risks of the Group were adopted by the Board. Based on the findings and recommendations of KLC as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems effective and adequate.

The Group has established internal control procedures for the handling and dissemination of inside information in order to comply with Chapter 13 of the Listing Rules as well as Part XIVA of the SFO. The internal control mechanism includes information flow and reporting processes, confidentiality arrangements, disclosure procedures, and staff training arrangements, etc.

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management and further enhance the Group's internal control and risk management systems as appropriate.

Shareholders' Rights

On the requisition of shareholders of the Company holding not less than one-tenth of the paid-up capital of the Company, the Board may convene a special general meeting to address specific issues of the Company within 21 days from the date of deposit of written notice to the registered office of the Company. The requisition must state the purposes of the meeting, and must be signed by the requisitionist(s).

Shareholders holding not less than one-twentieth of the total voting rights of all the shareholders or not less than 100 shareholders may propose any resolution at the annual general meeting and circulate to other shareholders written statement with respect to the matter to be dealt with at the annual general meeting.

獨立審核及評估結果已呈報予審核委員會及董事會。此外,禮恒企業財務服務所建議為提高本集團風險管理及內部監控系統及減低本集團風險的內部監控及風險管理措施的改進工作已獲董事會採納。根據禮恒企業財務服務之調查結果及推薦意見以及審核委員會之意見,董事會認為內部監控及風險管理系統屬有效及充分。

本集團已就處理及發佈內幕消息制訂內部 監控程序,以遵守上市規則第13章及證券及 期貨條例第XIVA部。內部監控機制包括消息 流向與申報流程、保密安排、披露程序及員 工培訓安排等。

The Group's investment properties amounted to HK\$281,000,000 as at 31 March 2018 and a gain from changes in fair value of investment properties of HK\$30,200,000 was recognised in the consolidated statement of profit or loss and other comprehensive income for the year then ended.

As disclosed in Note 14 to the consolidated financial statements, all of the Group's investment properties were stated at fair value based on a valuation performed by a firm of independent qualified professional surveyors ("Surveyors"). The fair value of the Group's investment properties was determined by adopting the direct comparison method. The valuation is sensitive to the market unit rate of comparable properties and adjustment factors for size, view and floor level of property and timing of the comparable transactions.

1. General

Allan International Holdings Limited (the "Company") is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Its immediate holding company is Allan Investment Company Limited, a private company incorporated in Hong Kong; and its ultimate holding company is Credit Suisse Trust Limited, who is a trustee of The Cheung Lun Family Trust ("Trust"), the discretionary beneficiaries of which are, among other family members, the directors of the Company, Mr. Cheung Shu Wan, Ms. Cheung Lai Chun, Maggie, Ms. Cheung Lai See, Sophie and Dr. Cheung Shu Sang, William. The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section of the annual report.

The Company acts as an investment holding company and provides corporate management services to its subsidiaries. The principal activities of its subsidiaries are manufacturing and trading of household electrical appliances.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

HKFRS 15 Revenue from Contracts with Customers

HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 *Revenue*, HKAS 11 *Construction Contracts* and the related interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

In 2016, the HKICPA issued Clarifications to HKFRS 15 in relation to the identification of performance obligations, principal versus agent considerations, as well as licensing application guidance.

The directors of the Company anticipate that the application of HKFRS 15 in the future may result in more disclosures, however, the directors of the Company do not anticipate that the application of HKFRS 15 in the future will have a material impact on the timing and amounts of revenue recognised in the respective reporting periods.

HKFRS 16 Leases

HKFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. HKFRS 16 will supersede HKAS 17 *Leases* and the related interpretations when it becomes effective.

HKFRS 16 distinguishes lease and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the Group currently presents upfront prepaid lease payments as investing cash flows in relation to leasehold lands for owned use while other operating lease payments are presented as operating cash flows. Upon application of HKFRS 16, lease payments in relation to lease liability will be allocated into a principal and an interest portion which will be presented as financing cash flows by the Group.

Under HKAS 17, the Group has already recognised an asset for finance lease arrangement and prepaid lease payments for leasehold lands where the Group is a lessee. The application of HKFRS 16 may result in potential changes in classification of these assets depending on whether the Group presents right-of-use assets separately or within the same line item at which the corresponding underlying assets would be presented if they were owned.

In contrast to lessee accounting, HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by HKFRS 16.

As at 31 March 2018, the Group has non-cancellable operating lease commitments of HK\$3,398,000 as disclosed in Note 31. A preliminary assessment indicates that these arrangements will meet the definition of a lease under HKFRS 16. Upon application of HKFRS 16, the Group will recognise a right-of-use asset and a corresponding liability in respect of all these leases unless they qualify for low value or short-term leases.

In addition, the Group currently considers refundable rental deposits received of HK\$2,032,000 as rights and obligations under leases to which HKAS 17 applies. Adjustments to refundable rental deposits received would be considered as advance lease payments.

Furthermore, the application of new requirements may result in changes in measurement, presentation and disclosure as indicated above.

The consolidated financial statements have been prepared on the historical cost basis except for investment properties and certain financial instruments that are measured at fair values at the end of the reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are within the scope of HKAS 17 Leases, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for estimated customer returns, rebates and other similar allowances.

Revenue from sale of goods is recognised when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the Group and when the goods are delivered and titles have passed.

Interest income is accrued on a time apportionment basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Service income is recognised when services are provided.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease.

Operating lease payments, including the cost of acquiring land held under operating leases, are recognised as an expense on a straight-line basis over the lease term.

When a sale and leaseback transaction results in an operating lease, and the sale price is above fair value, the excess over fair value shall be deferred and amortised over the period for which the asset is expected to be used.

Leasehold land and building

When the Group makes payments for a property interest which includes both leasehold land and building elements, the Group assesses the classification of each element separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire property is accounted as an operating lease. Specifically, the entire consideration (including any lump-sum upfront payments) are allocated between the leasehold land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis except for those that are classified and accounted for as investment properties under the fair value model. When the payments cannot be allocated reliably between the leasehold land and building elements, the entire property is generally classified as if the leasehold land is under finance lease.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Retirement benefit costs

Payments to defined contribution retirement benefit plans, state-managed retirement benefit schemes and Mandatory Provident Fund Scheme are recognised as an expense when employees have rendered service entitling them to the contributions.

Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit before tax" as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Investment properties

Investment properties are properties held to earn rentals and/ or for capital appreciation.

All of the Group's property interests held under operating leases to earn rentals or for capital appreciation purposes are accounted for as investment properties and are measured using the fair value model. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Loans and receivables (including trade receivables and bills receivable, other receivables, short-term deposits and bank balances and cash) are measured at amortised cost using the effective interest method, less any impairment (see accounting policy on impairment loss on financial assets below).

Therefore, in measuring the Group's deferred taxation on investment properties, the directors of the Company have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. The Group has not recognised any deferred taxes on changes in fair value of investment properties as the Group is not subject to any income taxes on the fair value changes of the investment properties on disposal.

In relying on the valuation report, the directors of the Company have exercised their judgement and are satisfied that the method of valuations are reflective of the current market conditions. Note 14 provides detailed information about the valuation techniques, inputs and key assumptions used in the determination of the fair value of investment properties.

Fair value measurements and valuation processes

Some of the Group's assets and liabilities are measured at fair value for financial reporting purposes.

In estimating the fair value of an asset or a liability, the Group uses market-observable data to the extent if it is available. Where Level 1 inputs are not available, the Group looks for other appropriate valuation techniques and inputs for fair value measurement.

9. Deferred Income

On 13 January 2016, the Group entered into a sale and purchase agreement with an independent third party (the "Purchaser") to dispose of a property, namely, all that 12th Floor of Zung Fu Industrial Building, No. 1067 King's Road, Hong Kong (the "Property"), with a carrying amount of HK\$9,212,000 at a cash consideration of HK\$179,000,000. The fair value of the Property at the date of disposal was approximately HK\$120,000,000 based on the valuation carried out by RHL Appraisal Limited, an independent qualified professional surveyor not connected with the Group.

RHL Appraisal Ltd. is a member of The Hong Kong Institute of Surveyors. The fair value was determined based on the direct comparison method assuming sales of each of the properties in its existing state and by making reference to comparable sales evidence of similar nature properties available in the relevant market.

In addition, pursuant to the agreement, upon completion of the transaction, the Group continues to occupy the property by entering into a tenancy agreement with the Purchaser in respect of the Property for three years commencing from the date of completion, 3 March 2016. This sale and leaseback transaction resulted in an operating lease.

Since the sales price of the Property is above its fair value, the excess over fair value of HK\$57,757,000 is deferred and amortised over the lease period of three years.

A significant increase in market unit rate would result in a significant increase in the fair value and vice versa. The key inputs used in valuing car park spacing is consideration for comparable transaction adjusted for timing of the comparable transaction and accessibility of the car park spacing.

The sensitivity analyses below have been determined based on the exposure to interest rates for variable-rate secured bank loan at the end of the reporting period. The analysis is prepared assuming the secured bank loan outstanding at the end of the reporting period were outstanding for the whole year. A 10 basis point (2017: 10 basis point) increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 10 basis point (2017: 10 basis point) higher/lower and all other variables were held constant, the Group's post-tax profit for the year ended 31 March 2018 would decrease/increase by HK\$35,000 (2017: decrease/increase by HK\$39,000). This is attributable to the Group's exposure to interest rates on its secured bank loan.

Other price risk

The Group is exposed to interest rate risk and credit risk through its listed and unlisted debt investments and investment funds classified as available-for-sale investments and designated at FVTPL. Credit risk

The Group's maximum exposure to credit risk in the event of the counterparties' failure to perform their obligations at 31 March 2018 in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its trade receivables and the Group has been largely dependent on a small number of customers for a substantial portion of its business. The top three customers represent over 83% (2017: 84%) of the trade receivables at 31 March 2018. The failure of these customers to make required payment could have a substantial negative impact on the Group's profits and liquidity.

In order to minimise the credit risk, the management of the Group has credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on bank balances, liquid funds and unlisted debt securities are limited because the counterparties are reputable banks in Hong Kong or financial institutions with high credit ratings assigned by international credit-rating agencies.

Other than concentration of credit risk on trade receivables set out above, and liquid funds which are deposited with several banks or financial institutions with high credit ratings, the Group does not have any other significant concentration of credit risk.

Pursuant to the Company's share option scheme (the "Scheme") adopted on 8 August 2012 for the primary purpose of providing incentives to directors of the Company and eligible employees, the directors and employees of the Company may, at the discretion of the directors of the Company, be granted options (the "Options") to subscribe for shares in the Company (the "Shares") at a price determined by its directors, but shall not be less than the highest of (i) the closing price of the Shares as stated in the Stock Exchange's daily quotation sheet on the date of the offer of grant, which must be a trading day; (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotation sheet for the five trading days immediately preceding the date of the offer of grant; and (iii) the nominal value of the Shares.

Without prior approval from the Company's shareholders, the total number of shares in respect of which options may be granted under the Scheme is not permitted to exceed 10% of the shares of the Company in issue at any point in time, and the number of shares in respect of which options may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time.

The Scheme will remain in force for a period of ten years from the date of its adoption. Options granted must be taken up not later than 28 days after the date of grant. A consideration of HK\$1 is payable on acceptance of the offer of grant of an option. An option is exercisable on the date when the offer for the grant of options is made but shall end in any event not later than 10 years from the date of grant of the options.

No options have been granted during both years under the Scheme.

The MPF Scheme is available to all employees aged 18 to 65 and with at least 59 days of service under the employment in Hong Kong. The Group contributes at the lower of 5% of relevant payroll costs monthly to the MPF Scheme, subject to a maximum amount of HK\$1,500 per month for each employee, which contribution is matched by employees.

The employees of the subsidiaries operating in the PRC are required to participate in a central pension scheme operated by the local municipal government. The contributions for the scheme in the PRC are made based on a percentage of the average salary as advised by the relevant authority in the PRC. The contributions are charged to the consolidated statement of profit or loss and other comprehensive income as they become payable in accordance with the rules of the central pension scheme. The subsidiaries operating in the PRC also contributed to a local municipal government retirement scheme for all qualified employees in the PRC. The employer and its employees are each required to make contributions to the scheme at the rates specified in the rules.

The only obligation of the Group with respect to the retirement schemes in the PRC is to make the retired contributions under the schemes. No forfeited contribution is available to reduce the contribution payable in the future years.
