

CHAIRMAN'S STATEMENT 主席報告書

On behalf of the board of directors (the "Board") of Hanison Construction Holdings Limited (the "Company"), I am pleased to present to our shareholders the results of the Company and its subsidiaries (collectively the "Group" or "Hanison") for the year ended 31 March 2018.

RESULTS FOR THE FINANCIAL YEAR ENDED 31 MARCH 2018

For the year ended 31 March 2018, the Group recorded turnover of HK\$2,849.5 million, representing a yearon-year decline of 11.4% from HK\$3,216.1 million recorded in the previous financial year. Despite the drop in turnover, mainly from the Property Development Division, the Group recorded consolidated profit attributable to owners of the Company totalled HK\$616.3 million (2017: HK\$516.9 million), an increase of 19.2% over the profit attained last year. During the current financial year, the Group has been very active in the acquisitions and disposals of investment properties, both by its own or through joint ventures. The disposal of 50% interest of its own investment property, PeakCastle, has contributed a substantial amount of profit to the Group, while the increase in gain on change in fair value of other investment properties held by the Group and through joint ventures at this financial year end have also accounted for a significant increase in profit for the year. The above positive returns have more than sufficient to cover the decrease in contribution from sales of properties from the Property Development Division of the Group and increase in equity-settled share-based payments recognised for the year ended 31 March 2018.

The basic earnings per share and diluted earnings per share for the year were HK62.4 cents and HK60.7 cents, representing increases of 22.4% and 19.7% respectively when compared with HK51.0 cents and HK50.7 cents respectively last year.

截至二零一八年三月三十一日止財 政年度之業績

截至二零一八年三月三十一日止年度,本集 團錄得營業額港幣2,849,500,000元,較上一 財政年度錄得之港幣3,216,100,000元同比下 降11.4%。儘管營業額下降主要來自物業發展 部,本集團錄得本公司擁有人應佔綜合溢利 總額為港幣616,300,000元(二零一七年:港幣 516,900,000元),較去年溢利增加19.2%。於 本財政年度內,本集團一直積極從事透過自有 或合營企業收購及出售投資物業。出售自有投 資物業PeakCastle的50%權益為本集團貢獻了 重大溢利,而於本財政年度末,本集團持有及 透過合營企業持有之其他投資物業之公平值變 動之收益增加亦為年內溢利帶來顯著增長。上 述收益足以抵銷本集團物業發展部物業銷售 貢獻減少及於截至二零一八年三月三十一日 止年度確認的以權益結算及以股份支付之款 項增加。

本年度每股基本盈利及每股攤薄盈利為港幣62.4仙及港幣60.7仙,較去年分別為港幣51.0 仙及港幣50.7仙分別增加22.4%及19.7%。

值為港幣3,725,700,000元(二零一七年:港幣

3.066.600.000元),較去年增加21.5%。於二

零一八年三月三十一日,每股資產淨值為港幣

3.56元(二零一七年:港幣2.95元)。

As at 31 March 2018, the net asset value of the Group amounted to HK\$3,725.7 million (2017: HK\$3,066.6 million), representing an increase of 21.5% over last year. Net asset value per share as at 31 March 2018 was HK\$3.56 (2017: HK\$2.95).

DIVIDEND

The Board has recommended a final dividend of HK5.0 cents per share for the year ended 31 March 2018 (2017: HK5.0 cents per share) to shareholders whose names appear on the register of members of the Company on 30 August 2018. This, together with an interim dividend of HK2.2 cents per share (2017: HK2.2 cents per share) distributed during the year, gives a total dividend of HK7.2 cents per share for the year (2017: HK7.2 cents per share). The proposed final dividend will be paid on 12 September 2018 following approval at the annual general meeting scheduled to be held on 21 August 2018.

BUSINESS REVIEW

During the latest financial year, the global economy continued to improve, realising growth of approximately 3.0% compared with 2.4% in 2016, according to findings from the World Bank. The USA, Eurozone and Japan all achieved economic recoveries, while China's economy was able to maintain growth momentum at 6.9%, leading to the bolstering of trade in Asia.

業務概覽

於本財政年度,根據世界銀行的研究結果,全球經濟繼續保持增長,相比二零一六年的2.4%,實現增長約3.0%。美國、歐元區及日本均實現經濟復甦,而中國經濟成功保持6.9%的增長勢頭,亞洲貿易得到鞏固。

In Hong Kong, the combination of full employment and the positive wealth effect from the rising property prices led to a rise in consumer confidence. Correspondingly, private consumption in 2017 grew by 5.4% in real terms, with investment expenditure increasing as well by 4.2% in real terms during the same period. Furthermore, owing to better-than-expected outturn abroad, the Hong Kong economy grew by 3.8%, thus exceeding the Hong Kong Government's forecast.

於香港,充分的就業及物業價格上漲帶來的正 財富效應令消費者信心上升。相應地,私人消 費於二零一七年實質增長5.4%,同期投資支出 亦實質增加4.2%。此外,受益於海外經濟表現 好於預期,香港經濟增長3.8%,超出香港政府 的預測。

In respect of the real estate sector in China, property prices remained high despite cooling measures introduced by the government, and was driven largely by smaller cities. Property investment market experienced a growth spurt, rising by 9.9% for the January to February period in 2018, according to the National Bureau of Statistics, thus achieving a three-year high.

In Hong Kong, property prices have continued to climb, with the property price index rising by 3.7 points or 1.01% to 368.4 in March 2018, according to data from the Rating and Valuation Department. Such an increase marked the index's 24th consecutive monthly rise, representing a cumulative increase of 35.7%. The exuberant market clearly proves that the interest rate hikes by the US Federal Reserve has had limited impact locally, where mortgage rates are still considered low. Aggressive bidding at government auctions and tenders has resulted in record-breaking transactions for land parcels.

The flourishing property market has stimulated the construction industry, resulting in excessive demand for construction workers and urgent requirement for improvement in construction technologies. The Government of Hong Kong Special Administrative Region (the "HKSAR Government" or the "Government") has been promoting innovation within the construction industry via the Construction Industry Council. The statutory body subsequently established the Construction Innovation and Technology Application Centre in 2017, to provide information on the latest construction technologies, assist enterprises and practitioners in adopting new technologies as well as encourage the industry to employ innovative technologies to bring greater productivity, sustainability and safety in construction industry.

就中國的房地產行業而言,儘管政府推出降溫措施,物業價格依然高企,且主要受小城市影響。根據國家統計局的數據,物業投資市場出現急劇增長,二零一八年一月至二月期間上升9.9%,達到三年來的最高點。

在香港,根據差餉物業估價署的數據,物業價格持續攀升,物業價格指數於二零一八年三月上升3.7點或1.01%至368.4,標誌著該指數連續24個月上升,累計升幅達35.7%。旺盛的市場清楚地表明,美國聯邦儲備局的加息對本地影響有限,按揭利率仍被視為較低。政府拍賣及招標反響熱烈,地塊交易屢破紀錄。

繁榮的物業市場振興建築業,導致建築工人需求過旺,迫切需要改進建築技術。香港特別行政區政府(「香港特區政府」或「政府」)一直在通過建造業議會推動建築業的創新。議會隨後於二零一七年成立建造業創新及科技應用中心,以提供有關最新建築技術的資料,協助企業及從業人員採用新科技以及鼓勵行業應用創新技術,以提升建築業的生產力、可持續性及安全。

Besides assisting in the advancement of the construction industry, the HKSAR Government remains committed to ensuring that the housing market avoids overheating and the creation of a housing bubble. Among the measures that it will take to curb rising property prices include increasing land supply, as well as expediting development of land, public housing and public rental housing. However, it takes time to adjust the situation of demand over supply of properties, therefore, the Hong Kong property market is expected to remain hot in the coming years.

除協助推動建築業進步外,香港特區政府繼續致力於確保房地產市場避免過熱及出現房地產泡沫。政府將用於抑制物業價格攀升的措施包括增加土地供應以及加快土地及公屋開發。然而,調整物業供不應求的狀況需要時間,因此,預期香港物業市場未來數年仍會保持火熱。

HIGHLIGHTS OF CORPORATE ACTIVITIES

During the financial year, the Construction Division performed stably, undertaking projects from both the public and private sectors. In total, the Division held contracts amounting to HK\$3,480.2 million as at the year end, thereby retaining its position as top revenue generator of the Group.

With regard to the Property Development Division, the last two residential units of The Austine Place as well as the remaining one unit and three car parking spaces of The Bedford were sold during the year. As for Mount Vienna, the low-density residential project in Fo Tan, New Territories in which the Group has 25% interest, the Group recorded the pre-sales of 6 out of the total 12 units by the financial year end and 3 more units subsequent to the financial year end. Up to the date of this annual report, 8 units have been delivered to customers. The Group will complete the acquisition of Central Industrial Building, located in Kwai Chung, New Territories, through a 50:50 joint venture with a private investment fund in late June 2018. As the property's project manager, building contractor, marketing manager and estate manager, the Group will provide its skills and experience to monitor the overall progress and ensure the satisfactory completion of this proposed redevelopment project.

企業活動摘要

於本財政年度,建築部承接公營及私營部門的項目,表現穩定。建築部年末持有的合約價值合計為港幣3,480,200,000元,因而守住本集團最大收入來源的位置。

Our Property Investment Division continued to deliver favourable returns to the Group. Besides the usual rental yields from these investment properties, the Group derived significant gains from the disposals of 50% interest of the Group's own property, PeakCastle, during the financial year, and a joint venture property, Success Centre, in which the Group held 50% interest, in April 2018. To strengthen the investment property portfolio, the Group acquired Ying Yu Building during the financial year and purchased a property located at No. 222 Hollywood Road in April 2018. We will continue to actively explore opportunities to acquire properties and enhance their value through renovation and improvement in property management.

我們的物業投資部繼續為本集團帶來可觀的回報。除來自該等投資物業的正常租金回報外,本集團於本財政年度出售自有物業PeakCastle的50%權益,於二零一八年四月出售本集團持有50%權益的合營企業物業成功中心,從中獲得大量收益。為加強投資物業組合,本集團於本財政年度收購應如大廈,並於二零一八年四月收購位於荷里活道222號的一項物業。我們將繼續積極尋找機會收購物業,並通過翻新及完善物業管理提升其價值。

During the financial year, the Group has purchased 20/F, 21/F and 22/F of Kings Wing Plaza 1. The whole floor of 20/F and 22/F and half floor of 21/F were acquired for the Group's office use, while the remaining half floor of 21/F was leased out to third party tenants as investment property.

於本財政年度,本集團收購京瑞廣場一期20樓、21樓及22樓。20樓及22樓整層以及21樓半層乃收購作本集團的辦公室用途,而21樓的餘下半層作為投資物業出租予第三方租戶。

For the proposed spin-off and separate listing of the Company's aluminium windows, doors and curtain walls business on the main board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (the "Proposed Spin-off"), the Stock Exchange has agreed, in principle, that the Company may proceed with the Proposed Spin-off. Preparation for the Proposed Spin-off is underway.

就建議分拆本公司的鋁窗、門及幕牆業務於香港聯合交易所有限公司(「聯交所」)主板獨立上市(「建議分拆」)而言,聯交所已原則上同意本公司進行建議分拆。建議分拆的準備工作正在進行中。

PROSPECTS

In the coming year, the global economy is expected to maintain positive, mirroring the upturn of major economies around the world. This outlook corresponds with the latest International Monetary Fund forecast of global economic growth, set at 3.9% for 2018, which will be the fastest since 2011. Despite the favourable outlook, we remain cautious of potential uncertainties on the horizon, including risks associated with the political tension between USA and North Korea, the rising protectionism and trade tension between China and USA.

In China, the nation will continue to undergo structural reforms to realise economic transformation and advancement, extending to the controlling and preventing of financial risk. Such efforts are expected to enable China to maintain a medium-to-high rate of economic growth, which in turn will allow it to serve as the main engine for global economic growth.

Back in Hong Kong, the expected global upturn and resultant rise in demand from major economies are set to drive Asian exports, and this knock-on effect will also benefit Hong Kong. A recovering tourism industry, if sustainable, will likewise benefit the city, particularly in reviving the retail sector. Given that the local employment level and personal incomes remain stable, consumption should also increase in the coming year. Besides favourable consumption sentiment, more positive economic and business outlook should lead to investment growth, with the government forecasting GDP expanding by between 3-4% in 2018.

展望

在未來的一年裡,預期全球經濟將保持積極勢態,從中窺見世界主要經濟體亦將復甦。國際貨幣基金組織最新預測二零一八年全球經濟將錄得自二零一一年以來最快的增速,達3.9%,上述前景與之一致。儘管前景良好,我們仍對初露端倪的潛在不確定因素持審慎態度,包括與美國及朝鮮之間的政治緊張局勢、保護主義抬頭及中國與美國之間的貿易緊張局勢有關的風險。

中國將繼續進行結構改革,以實現經濟轉型發展,且有關改革將擴大至金融風險防控領域。 預期這些努力將讓中國維持中高速經濟增長, 同時亦將讓中國成為推動全球經濟增長的主要引擎。

在香港,預期全球復甦及由此引致的主要經濟體需求上升將推動亞洲出口,該連鎖反應亦將讓香港受益。旅遊業不斷好轉,若能持續,香港亦同樣受益,尤其能夠推動零售業復甦。鑒於本地就業率及個人收入保持穩定,未來一年的消費亦會增加。除有利的消費氛圍外,更多正面的經濟及業務前景將令投資增長,政府預計於二零一八年本地生產總值將增加3%至4%。



CHAIRMAN'S STATEMENT 主席報告書

In view of the encouraging economic outlook for Hong Kong and the world in general, as well as a steadily growing property market in China and Hong Kong, we maintain optimistic in the Group's prospects in the coming year. However, in our investment decisions in Hong Kong, we must factor in the possibility of interest rate rise. The US Federal interest rate has gone up several times and is still on the upward trend. It would likely push up the interest rate in Hong Kong, which is bound by the dollar peg to follow the interest rate rise in USA. We will stay alert to the uncertainties as we move forward in the years ahead

鑒於香港及世界整體經濟前景令人鼓舞,加上中國及香港物業市場穩定增長,我們對本集團未來一年的前景保持樂觀。然而,在作出有關香港的投資決策時,我們須將加息的可能性納入考慮之中。美國聯邦利率已經過多次加息,目前仍呈上升趨勢。由於香港利率受制於與美元掛鉤的匯率政策,須跟隨美國加息,香港的利率可能因此被推高。我們將在未來的發展中對有關不確定因素保持警惕。







Outlook

Hong Kong's construction industry has been doing well in recent years with the determination of the HKSAR Government to curb the continuously rising housing prices by increasing housing supply. In its 2018 Budget, the Government stated the target of providing about 100,000 public housing units in the next five years, higher than the last year's budget. Also, the private sector will complete an estimated 20,800 residential units on average in each of the next five years, 50% more than that in the past five years.

In the short to medium term, the Government will provide about 380,000 residential flats in all resorting to rezoning sites, increasing residential density as appropriate, and with supply anticipated from projects at the Kai Tak Development Area, Anderson Road Quarry, railway property development projects and urban renewal projects. And, in the medium to long term, by pressing ahead with projects in new development areas and from railway property development projects in such as Siu Ho Wan, it will be able to provide about 220,000 residential units. The Company believes that there will be continuing strong demand for the services of the construction industry.

However, findings of a Hong Kong Construction Association survey conducted in November 2017 showed that the sector continues to face pressure from an aging workforce. The construction industry in Hong Kong was short of hands by 7.64% in 2017, similar to the level a year ago, but when looking at workers' age, 41.5% of them were over 50 and less than 16.5% were aged below 30.

展望

近年來,隨著香港特區政府決定通過增加住房供應抑制不斷上漲的住房價格,香港建築業一直表現良好。於二零一八年的預算中,政府宣佈未來五年提供約100,000個公屋單位的目標,高於去年的預算。此外,預計私營部門將於未來五年每年平均完成20,800個住宅單位,比過去五年的平均數增加50%。

從中短期來看,政府將在所有重新分類規劃地區提供約380,000個住宅單位,適當增加住宅密度,預期供應量來自啟德發展計劃、安達臣道石礦場、鐵路物業發展項目及市區重建項目。從中長期來看,通過推進新開發區的項目及小濠灣等地鐵物業開發項目,其將能提供約220,000個住宅單位。本公司相信,建築業的服務需求將保持強勁。

然而,香港建造商會於二零一七年十一月的調查結果顯示,該部門繼續面臨勞動力老齡化的壓力。二零一七年香港建造業人手短缺7.64%,與一年前的水平相似,但就工人年齡而言,41.5%的工人超過50歲,只有不到16.5%的工人在30歲以下。



Aware of the situation, the Government and the Construction Industry Council (the "CIC") have been developing measures to attract young people to the industry, including boosting training for local construction workers, and through the Supplementary Labour Scheme fast-tracking import of skill workers required by public works contractors.

意識到上述情況後,政府及建造業議會(「建造業議會」)一直在制訂措施吸引年輕人加入該行業,包括為本地建築工人加強培訓,及通過補充勞工計劃快速引進公共工程承包商所需的熟練工人。

On top of hoping to see those government measures bear fruit and the situation of the sector as a whole improve, the Group believes in training and helping employees develop, as its staff is its most valuable asset. The Group offers apprenticeship programmes in collaboration with such parties as the Hong Kong Construction Association and the Vocational Training Council to provide professional development opportunities to young workers in the sector, thereby develop a loyal and professional workforce.

本集團不單期待有關政府措施能取得成功及 部門狀況整體改善,亦重視培訓及幫助僱員發展,視員工為最寶貴的資產。本集團與香港建 造商會及職業培訓局等機構合作推出學徒計劃,以為該部門的年輕工人提供專業發展機會,藉以建立一支忠誠及專業的員工隊伍。

Pre-fabrication is a way to decrease the number of workers on site and increase the efficiency of the projects. The majority of pre-fabrication is out-sourced across the border in Mainland China or in neighboring countries where lower labour costs are taken advantage of. This method can ease the demand for local workers.

Technological progress and innovation is a partial solution to relieve the high demand for skilled labour as well as to improve the industry's image. The CIC has established the Construction Innovation and Technology Application Centre in 2017, to provide information on the latest construction technologies as well as encourage industry players to bring together such technologies and applications. To set an example, the Government will begin adopting building information modelling (the "BIM") technology in the design and construction of major government capital project works. Furthermore, the CIC will establish BIM technical standards and help the construction industry in equipping and utilising the technology in private works projects.

技術進步及創新是緩解熟練勞工嚴重短缺及提升行業形象的部分解決方案。建造業議會於二零一七年成立建造業創新及科技應用中心,以提供有關最新建築技術的資料,以及鼓勵從業人員分享匯集有關技術及應用。為樹立榜樣,政府將在設計及建造主要政府出資項目工程時採用建築信息模擬(「BIM」)技術。此外,建造業議會將制訂BIM技術標準,支援建造業裝備,並鼓勵私人工程項目採用此技術。

Still other efforts that the Government is making to advance the construction industry include the proposed establishment of a Construction Innovation and Technology Fund. Valued at HK\$1 billion, the fund would assist enterprises and practitioners in adopting new technologies as well as in encouraging the industry to employ innovative technologies. The fund would also support training on innovative construction technologies for both veterans and new entrants alike.

政府還正作出其他努力推動建築業的進步,包括建議成立建造業創新及科技基金。基金獲撥資港幣10億元,將協助企業及從業員採用新技術以及鼓勵行業應用創新技術。該基金亦會支援從業員及新進入者接受創新建築技術培訓。

Covering all the bases, the Government will also be assisting the industry by way of establishing large-scale highly automated steel reinforcing bar prefabrication yards, and will also spearhead Modular Integrated Construction ("MiC") of public projects. To encourage the adoption of MiC, the Government will consider extending the gross floor area concessions originally made for promoting green and innovation buildings to include buildings that employ MiC. What is more, it is conducting studies and examining which manufacturing facilities are capable of supporting MiC, hence can promote its wider adoption in Hong Kong.

政府面面俱到,亦將協助業界建立具規模和高度自動化的鋼筋預製工場,在公營項目率先試行組裝合成建築法(「MiC」)。為鼓勵採用MiC,政府將考慮將原適用於推廣環保及創新樓宇的總樓面面積寬免措施,擴展至應用MiC的建築。此外,政府正在研究及驗證能夠支持MiC的生產設施,推動該建築方法在香港更廣泛地應用。

The Group realises that if we wish to remain competitive amongst our competitors, factors such as technological progress, vocational training and attractiveness of the industry for the younger generation are essential. We are fortunate to have a team of loyal and experienced construction workers who have been working in our Construction Division since its commencement of business. We will continue to recruit, retain and train new workers to reinforce our workforce as we undertake more construction project works. On the innovation and technological side, we have formed a special team of talented staff to cope with the new innovation and technologies of the construction industry.

Going forward, apart from looking to capture the massive opportunities in the large pipeline of residential housing supply, both public and private, the Group will also explore different types of public sector projects including infrastructure and public facilities. It will continue to focus on projects that require high-quality work, adopt cost control measures to improve overall efficiency and profitability, as well as enhance workplace safety standards to give employees a healthy environment to work in that they may contribute to the Group's sustainable growth.

Outlook

The demand for building maintenance and renovation contracting services in Hong Kong has been growing in recent years, with property owners more and more willing to renovate and keep their properties in good shape to enhance their value. A combination of other favourable factors such as the improving economy, continual prosperity of the property market, a close to full employment job market, and increase in household income have opened up more opportunities and provided positive business environment for the interior and renovation industry. Government initiatives such as the Mandatory Building Inspection Scheme have also boosted demand for such services.

According to the Development Bureau, in 2017, there were about 9,300 private buildings of at least 30 years old in the Metro Area (i.e. Hong Kong Island, Kowloon, Tsuen Wan and Kwai Tsing) of Hong Kong and the number is expected to go up by 50% in 10 years, which will translate into demand for building maintenance and renovation contracting services.

展望

近年來,隨著物業業主更加願意裝修及維修其物業以提升物業價值,香港樓宇維修及裝修合約服務之需求不斷增加。經濟改善、物業市場持續繁榮、接近充分就業的就業市場及家庭收入增加等其他有利因素為裝飾及維修行業提供更多機會,並為之營造積極的營商環境。強制驗樓計劃等政府舉措亦提振有關服務的需求。

根據發展局的資料,於二零一七年,香港都會區(即香港島、九龍、荃灣及葵青區)有約9,300幢房齡至少30年的私人樓宇,且預期該數字將在10年內攀升50%,而此將轉化為對樓宇維修及裝修合約服務的需求。



Similar to the construction industry, the major problems affecting the interior and renovation industry continue to be the shortage of experienced and skilled labour and the increasing labour, material, and operating costs. However, we have competitive advantages over our competitors in that we have more advanced machineries and equipments. Our mast-climbing tower platform offers benefits such as better ventilation, environmental hygiene and living quality improvement to customers during the project operating period. These benefits may add credits to us in our project tendering.

At the core of our Interior and Renovation Division is the desire to deliver quality service, creative design and competitive pricing to satisfied customers to suit their budgets and styles. Renovation faults and oversights are particularly frustrating to resolve, because they are so costly and difficult to rectify. Therefore, while our senior management will be involved in every stage of the renovation work to ensure everything is right, we emphasise on the collaborative efforts and team works. We need to be on the same page and understand what we have to achieve.





The total amount of contracts on hand of Million Hope as at 31 March 2018 amounted to HK\$655.1 million.

Outlook

The Group's design, supply and installation of aluminium windows and curtain walls business has recorded significant growth in recent years, and that has contributed to the continuing growth of the Building Materials Division. The credit of such growth goes to the rising demand for premium or high quality building materials for private residential projects.

Curtain wall systems, a major product of the Building Materials Division, have been a growth driver of the division. With an elegant appearance and effective in keeping air-conditioning and heating cost low, they are widely used in construction of a good variety of buildings, including offices, hotels, shopping centres and residential buildings. For Million Hope, curtain wall business is expanding rapidly over the recent years. Our factory in Huizhou can manufacture the stick curtain walling. Under such system, component parts are fabricated in our factory and delivered to construction sites, to be assembled with glass and accessories, etc on sites.

展望

近年來,本集團之設計、供應及安裝鋁窗及幕 牆業務錄得大幅增長,繼而令建築材料部持續 增長。有關增長可歸因於私人住宅項目對優質 或高質量建築材料之需求增加。


幕牆系統為建築材料部之主要產品,亦為該部門之增長動力。幕牆系統外觀優美,且能有效降低空調及熱能成本,因此廣泛用於各類樓宇建築,包括辦公室、酒店、購物中心及住宅樓宇。就美亨而言,幕牆業務近幾年快速擴展。我們位於惠州的工廠可生產框架幕牆,而該系統之零部件於工廠製造,並運至建築工地,接著在工地與玻璃及配件等加以組裝。

Another system which is widely used in the market is the unitised curtain walling which is a panel system of glazing that is fully fabricated and assembled in a controlled factory environment and delivered to construction sites in a whole unit for erection on the building. This system has certain advantages over the stick system such as better quality control, quicker installation, and requires less manpower on sites. However, it needs more factory spaces for fabricating the products. At the moment, the Group appoints subcontractors for fabricating these products. For better quality and timing control, the Group may look for a bigger factory to accommodate the manufacture of these products.

另一廣泛用於市場的系統為單元式幕牆。單元式幕牆為玻璃面板系統,於受控的廠房環境全面製造及組裝,並整個單元運至建築工地供安裝在樓宇之上。該系統較框架系統具備若干優勢,如更完善之質量控制、更快速安裝以及工地所需人力較低。然而,製造該產品需要更大的工廠。本集團現時委聘分包商製造該等產品。為達致更完善之質量及時間控制,本集團或需另尋更大的工廠,以配合生產該等產品。

Our aluminium windows and curtain walls supply and installation works have earned us good reputation and wide recognition in the market. The Group is confident of capturing opportunities for the business bred by the rising housing supply in Hong Kong.

PROPERTY DEVELOPMENT DIVISION

The Property Development Division recorded a turnover of HK\$73.1 million for the year ended 31 March 2018 (2017: HK\$331.3 million).

During the year, the Group sold the remaining 1 unit at ground floor and 3 car parking spaces of The Bedford and the last 2 residential units of The Austine Place.

As for Mount Vienna, the low-density residential project in Fo Tan, New Territories in which the Group has 25% interest, the Group recorded the pre-sales of 6 out of the total 12 units by the financial year end and 3 more units subsequent to the financial year end. The Certificate of Compliance issued by Lands Department has been obtained in May 2018. Up to the date of this annual report, 8 units have been delivered to customers.


The Group acquired a parcel of land together with messuage, erections and buildings situated at No. 57A Nga Tsin Wai Road, Kowloon Tong, Kowloon in April 2017 with the objective of developing the property into a premium residential project. Lease modification for redevelopment has been applied and we are waiting for the offer of land premium.

Outlook

Despite the efforts of the Government to increase housing supply and control property prices and with the anticipated interest rate rise, housing prices in Hong Kong have continued to climb. The soaring property market shows no signs of cooling off with continued enthusiasm for new properties. According to Rating and Valuation Department data, private home prices in Hong Kong have increased for 24 consecutive months and kept reaching new high for 17 consecutive months up to March 2018. As the demand for residential properties consistently outstrips supply, the upward trend of the property prices and prosperity of the property market are expected to continue in the near future.

The US Federal Reserve had recently raised the US interest rate several times. It is generally expected that the Hong Kong Monetary Authority would react to such rises and raise the interest rate in Hong Kong as Hong Kong dollar is pegged to the United State dollar. Certainly, higher interest rates could impede home price growth to some extent, but it would be insufficient to cause downturn of the housing market. As a result, the impact of possible interest rate rise in Hong Kong is believed to be relatively insignificant to the booming property market.

The Group is confident about the Hong Kong property market, and thus the prospects of its Property Development Division. After the success it had with The Austine Place and The Bedford, other than the retail shops in the Austine Place held for property investment purpose, which were sold out up to the current financial year end, the Group will move on to explore more opportunities for the Division, aiming to expand its land bank and identify more profitable investment opportunities.

展望

儘管政府努力增加住房供應及控制物業價格,並預期加息,但香港物業價格繼續攀升。房地產市場飆升並沒有顯示出降溫的跡象,反而對新物業保持持續熱情。根據差餉物業估價署之數據,香港私人住宅價格連續24個月上漲,截至二零一八年三月連續17個月達到新高。由於住宅物業的需求持續超過供應,預計在不久的將來,房地產價格將繼續上漲趨勢且房地產市場將持續繁榮。

美國聯邦儲備局最近多次提高美國利率。因港元與美元掛鉤,普遍預期香港金融管理局會對該升幅做出反應,並提高香港利率。當然,較高的利率可能會在一定程度上阻礙房價的增長,但這不足以導致房地產市場的低迷。因此,香港的可能加息對房地產市場蓬勃發展的影響相對較小。

本集團對香港房地產市場充滿信心,因此對 其物業發展部的前景充滿信心。在經歷The Austine Place及The Bedford的成功後(除位 於Austine Place的持作物業投資用途的零售 店舖外,有關物業於本財政年度末已售罄), 本集團將繼續為該部門探索更多機會,旨在擴 大其土地儲備並識別更多有利的投資機會。

In Hong Kong, the Group will continue the sale of Mount Vienna in which the Group has 25% interest and to develop the land at No. 57A on Nga Tsin Wai Road, Kowloon Tong, Kowloon into a premium residential project. Also, the Group will complete the acquisition of Central Industrial Building in late June 2018, with plans to re-develop it into a new industrial building. The Central Industrial Building project is a joint venture project with a private investment fund, in which the Group has 50% interest. The Group will provide project management, building construction service, marketing and property management services for this project.

In China, the Group will continue to lease out units of LUXÉAST in Haining, Zhejiang, through its 49%-owned joint venture, with the objective of ultimately selling them at the most favourable prices.

PROPERTY INVESTMENT DIVISION

The Property Investment Division recorded a turnover of HK\$59.0 million for the year ended 31 March 2018 (2017: HK\$49.1 million).

To diversify its investment portfolio, the Group entered into a memorandum of agreement on 28 June 2017 and a sale and purchase agreement on 31 July 2017 for acquisition of a commercial property located at Nos. 99-101 Lai Chi Kok Road, Mong Kok, Kowloon (namely "Ying Yu Building") and various office units on 21st Floor and car parking spaces of a commercial property, namely Kings Wing Plaza 1, situated in Shatin, New Territories ("Kings Wing Plaza") respectively. The Division started to receive rental income derived from Ying Yu Building and Kings Wing Plaza upon completion of the respective acquisitions in September 2017 and August 2017. Recently, Ying Yu Building is under renovation to improve the rental income and to enhance the property value.

為使投資組合多元化,本集團於二零一七年六月二十八日訂立一份協議備忘錄及於二零一七年七月三十一日訂立一份買賣協議,以分別收購位於九龍旺角荔枝角道99號至101號之一幢商業物業(即「應如大廈」)及位於新界沙田之一幢商業物業(即京瑞廣場一期)21樓之若干辦公室單位及停車位(「京瑞廣場」)。於二零一七年九月及二零一七年八月完成有關收購後,本部門已開始獲得應如大廈及京瑞廣場產生的租金收入。近期,應如大廈正在進行翻新,以提高租金收入及提升物業價值。

On 2 March 2018, the Group entered into a sale and purchase agreement with an independent third party to acquire the whole block of residential-cum retail composite property located at No. 222 Hollywood Road, Hong Kong. The transaction was completed on 12 April 2018 and rental income has been derived after the completion.




On 9 May 2018, a joint venture of the Group in which the Group has 40% interest entered into the sale and purchase agreement to dispose its wholly owned subsidiary which directly hold a serviced apartment, Queen Central, located at No. 338 Queen's Road Central, Hong Kong. The transaction is expected to be completed in October 2018.

Investment properties of the Group include various units at Shatin Industrial Centre, One Eleven in Sai Ying Pun, No. 31 Wing Wo Street in Sheung Wan, some units at Kin Wing Industrial Building in Tuen Mun, various land lots in D.D. 76 Ping Che in Fanling, retail shops of The Austine Place in Tsim Sha Tsui, Hoi Bun Godown in Tuen Mun in which the Group has 50% interest and PeakCastle in Cheung Sha Wan in which the Group has 50% interest, all contributed satisfactory income to the Group during the financial year.

Investment properties including West Castle and West Park are now under renovation in order to improve the respective rental incomes and to enhance the property value. 投資物業包括West Castle及West Park正在進行翻新,以提高有關租金收入及提升物業價值。

Outlook

The Group continues to be optimistic about the investment property market in Hong Kong, as the demand for residential and commercial properties is still strong while supply is limited. According to the Rating and Valuation Department, rental index for private residential properties in March 2018 climbed 6.4% year-on-year and that for private offices was up 2.0% in February 2018. Also, financing cost has remained low because of the low interest rate environment and that makes property investment attractive.

Improving economic fundamentals in the United States of America and Mainland China, along with new cross-border infrastructure, record-breaking land sales, mega property acquisition transactions and a big pool of Chinese capital chasing for prestigious buildings will bring strong demand and contribute to the upbeat market sentiment for the commercial and industrial property markets in Hong Kong in 2018.

In its 2017-18 Land Sale Programme, the HKSAR Government stated the intention to launch 28 residential sites that can provide potentially 18,900 flats, three commercial or business sites that can supply space of about 172,000 square meters and a site for a hotel with about 550 rooms. Such numbers reflect the Government's determination to ensure healthier market development by increasing the supply of residential and commercial spaces in Hong Kong.

展望

因住宅及商業物業的需求仍然強勁,而供應有限,本集團繼續對香港投資物業市場持樂觀態度。根據差餉物業估價署之資料,二零一八年三月私人住宅物業的租金指數較去年上升6.4%,而私人辦公室的租金指數則於二零一八年二月上升2.0%。此外,由於利率偏低,融資成本維持低位,從而使得物業投資具有吸引力。

美國及中國大陸經濟基礎的改善以及新的跨境基礎設施、破紀錄的土地銷售、大型房地產收購交易以及大量追逐著名建築的中國資本將帶來強勁的需求,並為二零一八年香港商業及工業物業市場帶來樂觀市場氛圍。

根據二零一七至一八年度賣地計劃,香港特區政府表明將推出可潛在提供18,900個單位之28幅住宅用地;三幅可提供約172,000平方米空間之商業或商貿用地;及一幅可容納約550個房間之酒店用地。該等數字反映政府增加香港住宅及商業空間供應以確保健康之市場發展之決心。

The Group has been very active in the investment property market, making transaction after transaction in recent years. The satisfactory return of the Property Investment Division is a proof of the effectiveness the Group's strategy of enhancing the asset value of purchased properties via renovation and improving property management. The Group will adhere to this strategy while exploring more investment opportunities and joint venture opportunities with third parties to make the best use of the resources for investment. The Group will ensure that its financial position is healthy and its gearing ratio is reasonable. Meanwhile, the Group will retain certain high rental yield properties to provide recurrent rental income to the Group.

本集團近年來在投資物業市場非常活躍,交易接二連三。物業投資部的回報令人滿意,證明本集團通過改造及改善物業管理,從而提升所購物業資產價值之策略的成效。本集團將堅持這一策略,同時探索更多的投資機會及與第三方的合資機會,以充分利用投資資源。本集團將確保其財務狀況穩健,資產負債率合理。同時,本集團將保留若干高租金收益物業以向本集團提供經常性租金收入。

During the current financial year, the Group has disposed of 50% interest of subsidiaries in which the fair value of its investment property, PeakCastle, was HK\$1,600.0 million, realising a significant amount of profit. After the financial year end, the Group acquired companies which hold a property at No. 222 Hollywood Road at fair value of approximately HK\$506.4 million and disposed of a 50% interest joint venture and its subsidiary which hold a property, Success Centre at fair value of HK\$1,038.0 million.

於本財政年度內,本集團出售附屬公司的50%權益,其中其投資物業PeakCastle的公平值為港幣1,600,000,000元,實現相當數量的溢利。於財政年度結束後,本集團收購持有位於荷李活道222號的物業(其公平值為約港幣506,400,000元)的公司,並出售持有物業成功中心(其公平值為港幣1,038,000,000元)的本集團擁有50%權益的合營企業及其附屬公司。

PROPERTY AGENCY AND MANAGEMENT DIVISION

The turnover of the Property Agency and Management Division for the year ended 31 March 2018 was HK\$43.1 million (2017: HK\$20.5 million).

In Hong Kong, the Property Agency and Management Division acted as the marketing and project manager for The Grampian at No. 11 Grampian Road, Mount Vienna at Lok Lam Road and two of the Group's redevelopment projects, The Bedford at Nos. 91-93 Bedford Road and The Austine Place at No. 38 Kwun Chung Street. This Division also provides property management services to The Austine Place in Tsim Sha Tsui, The Bedford in Tai Kok Tsui, Eight College and One LaSalle in Kowloon Tong, Golf Parkview in Sheung Shui (which was terminated on 28 December 2017), One Eleven in Sai Ying Pun and PeakCastle in Cheung Sha Wan.

Other services of this Division include rental collection and leasing agency services to 8 Hart Avenue and The Cameron in Tsim Sha Tsui, One Eleven in Sai Ying Pun and PeakCastle in Cheung Sha Wan.

Outlook

The Property Agency and Management Division complements the Group's property development and property investment businesses. It provides high quality and efficient property management, rental collection and leasing agency services, adding value to the Group's properties. Going forward, the division will continue to optimise its operational platform and improve its services.

HEALTH PRODUCTS DIVISION

Made up of two subsidiaries of the Group, namely Care & Health Limited ("Care & Health") and Retailcorp Limited ("Retailcorp"), the Health Products Division focuses on wholesale of Chinese and Western nutritional supplements and management of relevant retail chain stores.

For the year ended 31 March 2018, the Division recorded turnover of HK\$59.6 million, compared to HK\$55.1 million last year.

Retailcorp manages the "HealthPlus" retail chain. As at 31 March 2018, the chain had 10 outlets (including a HealthPlus shop at St. Teresa's Hospital) and 1 service centre in operation. During the year under review, one poor-performing shop was closed.

Key products such as the "Lingzhi Master" series, which includes the Ganoderma Bioactive Essence, Ganoderma Spore Bioactive Lipid and Ganoderma Spores, has been wearing the "STC tested Mark" since June 2014 and "Buyickfong 28 Chinese Herbal Soup for Postnatal Women" has prided the label since November 2012.

Aware of the fast growing popularity of online shopping, the Group has developed its e-commerce business using social media platforms to conduct marketing activities and serve customers, as well as to improve customer relationship and relay product information more effectively. The Group sees e-commerce platforms as an effective sales channel as they allow customers to make purchases anytime, anywhere. With better located retail shops and its e-commerce business gaining strength, the Group has devised a comprehensive marketing strategy to make sure it can serve customers more effectively using both traditional and modern channels.

健康產品部

健康產品部由本集團的兩間附屬公司,即康而健有限公司(「康而健」)及零售企業有限公司(「零售企業」)組成,專注於批發中西式營養保健產品及管理相關零售連鎖店。

截至二零一八年三月三十一日止年度,本部門 錄得營業額港幣59,600,000元,而去年則為港 幣55,100,000元。

零售企業管理「健怡坊」零售連鎖。於二零一八年三月三十一日,該連鎖有10間店(包括聖德勒撒醫院內的健怡坊店)及一間在營服務中心。於回顧年度內,已關閉一間表現欠佳的店舖。

主要產品如「學者靈芝」系列,包括紫雲赤芝 精華、純靈芝孢子油及純靈芝孢子粉,自二零 一四年六月起戴上優質「正」印,而「產後進補 廿八方」自二零一二年十一月起榮獲該印。

有見及於網上購物日益普及,本集團已利用社 交媒體平台發展其電子商貿業務,進行市場推 廣活動及服務客戶,並改善客戶關係及更有效 地傳遞產品資訊。本集團視電子商貿平台為有 效的銷售渠道,因為其令客戶能夠隨時隨地購 買。隨著將零售店舖佈局於更佳位置及電子商 貿業務佔據優勢,本集團制定了全面的市場推 廣策略,以確保其能夠更有效地利用傳統及現 代渠道服務客戶。

Outlook

Both HealthPlus and Care & Health live up to their names for their commitment as social caring companies to bring better health to the community. Over years, they have been striving to source reliable and effective health products for our customers, and they will continue their mission as such in future.

High rental and operating costs will continue to be the main challenge to the health product retail business. Many mega stores are fragmented into smaller stores and move to less centralized area with lower rental charges. At the same time, to keep pace with the changing behaviour and shopping preferences of the customers, many health product companies have speedily shift to online shopping platforms.

To stay competitive in this business, we must be persistent in our pursuit for reliable and quality health products and keep pace with the customers' changing needs and shopping behavior.

Going forward, the management is optimistic about the development of the Group's health product business, taking into account Hong Kong's aging population and the growing wealth and health consciousness among Hong Kong people. Also, the Group's products enjoy strong brand awareness now thanks to the consistent promotional efforts and personal recommendations by the users of the Group's products. The Group will prudently use its resources, for example, when launching promotional campaigns, and look for opportunities to effect better market penetration.

展望

健怡坊及康而健均承諾為關懷社會及為社區帶來健康的企業,並一直恪盡職守。多年來,彼等一直努力為我們的客戶提供可靠及有效的健康產品,並且彼等將在未來繼續履行其使命。

高租金及運營成本仍將是健康產品零售業務面臨的主要挑戰。許多大型店舗被分割成較小的店舗,並轉移到租金較低的較不集中的區域。同時,為了跟上客戶不斷變化的行為及購物偏好,許多健康產品公司已經迅速轉向網上購物平台。

為保持該業務的競爭力,我們必須堅持追求可 靠及優質的健康產品,並跟上客戶不斷變化的 需求及購物行為。

展望未來,考慮到香港人口老齡化及香港人日益增長的財富及健康意識,管理層對本集團健康產品業務的發展感到樂觀。此外,由於不斷的宣傳投入及本集團產品使用者的個人推薦,本集團的產品現時享有強大的品牌知名度。例如,在推出宣傳活動時,本集團將謹慎地使用其資源,並尋找機會實現更好的市場滲透。

Summary of Results

For the year ended 31 March 2018, Hanison Construction Holdings Limited (the "Company") and its subsidiaries (collectively the "Group") recorded turnover of HK\$2,849.5 million, representing a year-on-year decline of 11.4% from HK\$3,216.1 million recorded in the previous financial year. Despite the drop in turnover mainly from the Property Development Division, the Group recorded consolidated profit attributable to owners of the Company totalled HK\$616.3 million (2017: HK\$516.9 million), an increase of 19.2% over the profit attained last year. During the current financial year, the Group has been very active in the acquisitions and disposals of investment properties, both by its own or through joint ventures. The disposal of 50% interest of its own investment property, PeakCastle, has contributed a substantial amount of profit to the Group, while the increase in gain on change in fair value of other investment properties held by the Group and through joint ventures at this financial year end have also accounted for a significant increase in profit for the year. The above positive returns have more than sufficient to cover the decrease in contribution from sales of properties from the Property Development Division of the Group and increase in equity-settled share-based payments recognised for the year ended 31 March 2018.

The basic earnings per share and diluted earnings per share for the year were HK62.4 cents and HK60.7 cents, representing an increase of 22.4% and 19.7% respectively when compared with HK51.0 cents and HK50.7 cents respectively last year.

As at 31 March 2018, the net asset value of the Group amounted to HK\$3,725.7 million (2017: HK\$3,066.6 million), representing an increase of 21.5% over last year. Net asset value per share as at 31 March 2018 was HK\$3.56 (2017: HK\$2.95).

財務回顧

業績概要

截至二零一八年三月三十一日止年度, Hanison Construction Holdings Limited (興 勝創建控股有限公司)(「本公司」)及其附 屬公司(統稱為「本集團」)錄得營業額港 幣2,849,500,000元,較上一財政年度錄得 之港幣3,216,100,000元同比下降11.4%。 儘管營業額下降主要來自物業發展部,但 本集團錄得本公司擁有人應佔綜合溢利總 額為港幣616,300,000元(二零一七年:港幣 516,900,000元),較去年溢利增加19.2%。於 本財政年度內,本集團一直積極從事透過自有 或合營企業收購及出售投資物業。出售其自有 投資物業PeakCastle的50%權益為本集團貢獻 了重大溢利,而於本財政年度末,本集團持有 及透過合營企業持有之其他投資物業之公平 值變動之收益增加亦為年內溢利帶來顯著增 長。上述收益足以抵銷本集團物業發展部物業 銷售貢獻減少及於截至二零一八年三月三十一 日止年度確認以權益結算及以股份支付之款 項增加。

本年度每股基本盈利及每股攤薄盈利為港幣62.4仙及港幣60.7仙,較去年分別為港幣51.0仙及港幣50.7仙分別增加22.4%及19.7%。

於二零一八年三月三十一日,本集團之資產淨值為港幣3,725,700,000元(二零一七年:港幣3,066,600,000元),較去年增加21.5%。於二零一八年三月三十一日,每股資產淨值為港幣3.56元(二零一七年:港幣2.95元)。

Group Liquidity and Financial Resources

The Group's liquidity and financing requirements are regularly reviewed.

For day-to-day liquidity management and to maintain flexibility in funding, the Group has access to facilities from banks and an insurance company with an aggregate amount of HK\$2,835.5 million (HK\$685.5 million was secured by first charges over certain leasehold land and buildings and investment properties of the Group), of which HK\$395.5 million bank loans have been drawn down and approximately HK\$339.6 million has been utilised mainly for the issuance of letters of credit and performance bonds as at 31 March 2018. The bank loans under these banking facilities bear interest at prevailing market interest rates.

The Group follows a prudent policy in managing its cash balance, and endeavours to maintain its sound cash flow generating capability, its ability to take on investments and acquisition projects, in order to enhance shareholder wealth. The total cash and bank balances of the Group amounted to HK\$1,070.1 million as at 31 March 2018 (2017: HK\$840.1 million), and accounted for 43.7% of the current assets (2017: 44.0%).

During the year, the Group has a net cash inflow of HK\$102.0 million in its operating activities (mainly due to the decrease in progress payment receivable, properties held for sale and retention money receivable and increase in amounts payable on contract work, netting off increase in properties under development for sale and debtors, deposits and prepayments), a net cash outflow of HK\$345.7 million in its investing activities (mainly due to net cash outflow on acquisitions of subsidiaries, purchase of investment properties, deposit paid for acquisition of a subsidiary and loans to joint ventures, netting off net cash inflow on disposal of subsidiaries and withdrawal of pledged bank deposits), and a net cash inflow of HK\$470.0 million in its financing activities (mainly due to new bank and other loans raised, netting

集團流動資金及財務資源

本集團定期評估其流動資金及融資需求。

為了方便日常流動資金管理及維持融資之靈活性,於二零一八年三月三十一日,本集團可動用銀行及一間保險公司之融資總額為港幣2,835,500,000元(其中港幣685,500,000元是以本集團之若干租賃土地及樓宇以及投資物業作第一抵押),其中港幣395,500,000元銀行貸款已提取,而約港幣339,600,000元已主要用作發出信用狀及履約保證。該等銀行融資下之銀行貸款按現行市場利率計算利息。

本集團於管理其現金結餘時奉行審慎政策,並致力維持本集團之穩健現金產生能力、本集團參與投資和收購項目之能力,以提升股東財富。於二零一八年三月三十一日,本集團之現金及銀行結餘總額為港幣1,070,100,000元(二零一七年:港幣840,100,000元),並佔流動資產43.7%(二零一七年:44.0%)。

年內,本集團營運業務之淨現金流入為港幣102,000,000元(主要由於應收進度款項、持作待售物業及應收保固金減少以及應付合約工程款項增加,抵銷發展中之待售物業以及應好合約項增加所致),投資業務項、按金及預付款項增加所致),投資業務項金流出為港幣345,700,000元(主要由於物數、已付收購附屬公司按金及合營企業貸款,抵銷出售附屬公司之現金流入淨額及提取仓稅,以及融資業務淨現金流入為港幣470,000,000元(主要由於新增銀行及

off dividends paid to shareholders and repayment of bank loans). As at 31 March 2018, the Group was in a net cash position, calculated on the basis of total cash and bank balances less total bank and other loans. As at year-end date, the Group was with a net current assets of HK\$840.9 million (2017: net current liabilities of HK\$7.9 million) and the current ratio (current assets divided by current liabilities) was 1.52 times (2017: 1.00 times).

With its cash holdings and available facilities from banks and an insurance company, the Group's liquidity position will remain healthy in the coming year, with sufficient financial resources to meet its obligations, operation and future development requirements.

Treasury Policy

The aim of the Group's treasury policy is to minimise its exposure to fluctuations in the exchange rate and not to engage in any highly leveraged or speculative derivative products. Treasury transactions unrelated to underlying financial exposure are not undertaken. Foreign currency exposures of the Group arise mainly from the purchase of goods. The Group will determine if any hedging is required, on an individual basis, depending upon the size and nature of the exposure, and the prevailing market circumstances.

In order to enhance the deployment of internal funds with maximum benefit, to achieve better risk control, and to minimise cost of funds, the Group's treasury activities are centralised and scrutinised by the top management.

The surplus cash which is generally placed with reputable financial institutions is mostly denominated in Hong Kong dollar. Most of the income, expenses, assets and liabilities of the Group are denominated in Hong Kong dollar. The Group therefore does not have any significant exposure to gains or losses arising from the movement of foreign currency exchange rate against the Hong Kong dollar.

財資管理政策

本集團之財資管理政策旨在減低匯率波動之 風險及不參與任何高槓桿比率或投機性衍生 產品交易。本集團並無進行與潛在財務風險無 關之財資交易。本集團之外幣風險,主要因購 買貨物而起。在決定是否有對沖之需要時,本 集團將按個別情況,視乎風險之大小及性質, 以及當時市況而作決定。

為最有效地運用本集團之內部資金,達致更佳 之風險監控及盡量減低資金成本,本集團之財 資事務乃由最高管理層主管,並受其嚴密監 督。

現金盈餘一般會存入信譽良好之金融機構,主要以港幣計值。本集團大部份收益、開支、資產與負債均以港幣計值,因此本集團於外幣兑港幣之外匯兑換率變動所產生之損益不會有任何重大風險。

Shareholders' Funds

At the year-end date, shareholders' funds of the Group were HK\$3,725.7 million including reserves of HK\$3,621.1 million, an increase of HK\$658.3 million from HK\$2,962.8 million at 31 March 2017. On that basis, the consolidated net asset value of the Group as at 31 March 2018 was HK\$3.56 per share, compared to the consolidated net asset value of HK\$2.95 per share as at 31 March 2017. The increase in shareholders' funds was mainly attributable to profits retained after the payments of dividends, exercise of share options and recognition of equity-settled sharebased payments.

Capital Structure

The Group intends to keep an appropriate mix of equity and debt to ensure an efficient capital structure over time. As at 31 March 2018, the Group borrowed Hong Kong dollar loans amounting to HK\$395.5 million from the banks (at 31 March 2017: HK\$815.1 million). The borrowings have been used as general working capital for financing the properties for development and investment purposes over the years. The maturity profile of the loans spread over a period of two years with HK\$52.6 million repayable within the first year and HK\$342.9 million repayable within the second year. Bank loans that are repayable more than one year after the end of the reporting period but contain a repayment on demand clause with carrying amount of HK\$342.9 million have been classified as current liabilities. Interest is based on Hong Kong Interbank Offered Rate plus a competitive margin. As at 31 March 2017, other loan of Renminbi 6.3 million (equivalent to approximately HK\$7.0 million) (at 31 March 2018: nil) was repayable within one year and interest bearing at a fixed interest rate of 4.9% per annum.

股東資金

於年結日,本集團之股東資金為港幣3,725,700,000元,當中包括港幣3,621,100,000元之儲備,較於二零一七年三月三十一日之港幣2,962,800,000元增加港幣658,300,000元。以此為基準,於二零一八年三月三十一日,本集團之每股綜合資產淨值為港幣3.56元,而於二零一七年三月三十一日之每股綜合資產淨值為港幣2.95元。股東資金增加之主因是派發股息後保留溢利、行使購股權及確認以權益結算及以股份支付之款項所致。

資本結構

本集團力求保持適當之股本及債務組合,以 確保未來能維持一個有效之資本結構。於二 零一八年三月三十一日,本集團獲得銀行貸 款達港幣395,500,000元(於二零一七年三月 三十一日:港幣815,100,000元)。此貸款乃 用作一般營運資金,為歷年來物業作發展及 投資用途之融資。貸款之還款期攤分兩年, 於首年內須償還港幣52,600,000元,於第二年 內須償還港幣342,900,000元。賬面值為港幣 342,900,000元須於報告期末起計一年以後償 還,但載有按要求還款條款的銀行貸款因而分 類為流動負債。利息是根據香港銀行同業拆息 附以吸引利率差幅計算。於二零一七年三月 三十一日,其他貸款人民幣6,300,000元(相等 於約港幣7,000,000元)(於二零一八年三月 三十一日:無)須於一年內償還,按固定年利率 4.9%計息。

Major Acquisitions and Disposals

On 13 July 2017, an indirect wholly owned subsidiary of the Company, Heroic Elite Investments Limited, entered into a sale and purchase agreement with an independent third party to acquire the entire issued share capital of Waller Holdings Limited together with the shareholder's loan at a consideration of approximately HK\$145.4 million. The acquisition was completed on 14 August 2017. The major assets of Waller Holdings Limited together with its wholly owned subsidiary, Rich Victory (Hong Kong) Limited, are office units at 20/F and certain car parking spaces of a commercial property, namely Kings Wing Plaza 1, situated in Shatin, New Territories. Waller Holdings Limited was acquired so as to relocate the Group's office to the commercial property.

On 13 July 2017, an indirect wholly owned subsidiary of the Company, Oriental Elite Global Limited, entered into a sale and purchase agreement with an independent third party to acquire the entire issued share capital of Faithful Sun Limited together with the shareholder's loan at a consideration of approximately HK\$149.9 million. The acquisition was completed on 14 August 2017. The major assets of Faithful Sun Limited are office units at 22/F and certain car parking spaces of a commercial property, namely Kings Wing Plaza 1, situated in Shatin, New Territories. Faithful Sun Limited was acquired so as to relocate the Group's office to the commercial property.

On 31 July 2017, an indirect wholly owned subsidiary of the Company, Keen Elite Developments Limited, entered into a sale and purchase agreement with an independent third party to acquire the entire issued share capital of Ultimate Elite Investments Limited together with the shareholder's loan at a consideration of approximately HK\$149.7 million. The acquisition was completed on 28 August 2017. The major assets of Ultimate Elite Investments Limited together with its wholly owned subsidiary, Vision Smart Limited, are office units at 21/F and certain car parking spaces of a commercial property, namely Kings Wing Plaza 1, situated in Shatin, New Territories, which were classified as investment properties.

主要收購及出售事項

於二零一七年七月三十一日,本公司之間接全資附屬公司傑建發展有限公司與一名獨立第三方訂立買賣協議,以收購Ultimate Elite Investments Limited全部已發行股本及股東貸款,代價約為港幣149,700,000元。該收購事項於二零一七年八月二十八日完成。Ultimate Elite Investments Limited連同其全資附屬公司Vision Smart Limited之主要資產為位於新界沙田之一幢商業物業(即京瑞廣場第一期)21樓之辦公室單位及若干停車位(已分類為投資物業)。

On 21 February 2018, a wholly owned subsidiary of the Company, Hanison Construction Holdings (BVI) Limited, entered into a sale and purchase agreement with an independent third party to dispose of its 50% equity interests in and shareholder's loan to Gallant Elite Enterprises Limited ("Gallant Elite") together with its wholly owned subsidiaries, Nimble Run Limited and Trillion Mart Development Limited ("Trillion Mart"). Trillion Mart is engaged in property investment. The major asset of Trillion Mart represented a commercial property "PeakCastle" situated at No. 476 Castle Peak Road, Kowloon. The consideration for the disposal is HK\$332.7 million. The disposal was completed on 28 March 2018. Subsequent to the disposal, Gallant Elite became a joint venture of the Group.

Collateral

As at 31 March 2018, certain leasehold land and buildings and investment properties of the Group, at the carrying value of approximately HK\$1,081.5 million (at 31 March 2017: HK\$1,908.8 million), were pledged to the banks to secure the Hong Kong dollar loans of HK\$395.5 million (at 31 March 2017: HK\$605.1 million). At 31 March 2017, bank deposits of HK\$139.3 million (at 31 March 2018: nil) were pledged for a banking facility granted to a joint venture.

Contingent Liabilities

During the year ended 31 March 2004, legal actions in respect of allegations of copyright infringement and defamation were taken against certain subsidiaries of the Company carrying on its health products business. No further steps have been taken against the Group in respect of such actions after the court hearing for directions to appoint experts and exchange witness statements since 2004. At 31 March 2018 and 2017, the directors of the Company are of the opinion that in view of the uncertainty of the outcome, it is not practicable to assess the financial effect.

抵押品

於截至二零零四年三月三十一日止年度內,本公司若干從事健康產品業務之附屬公司就侵犯版權及誹謗之指控被提出法律訴訟。自二零四年就委任專家及交換證人陳述書所召開之指示聆訊後,至今尚未就有關訴訟對本集團採取進一步行動。於二零一八年及二零一七年三月三十一日,本公司董事認為,鑑於其結果之不確定性,故不能切實地評估其財務影響。

As at 31 March 2018, the Group has an outstanding corporate guarantee issued to a bank in respect of banking facilities granted to a joint venture of approximately HK\$67,125,000 (2017: HK\$53,181,000), which represents the Group's proportionate share of the banking facilities utilised as at 31 March 2018. In the opinion of the directors of the Company, the fair values of these financial guarantee contracts are insignificant at initial recognition and no provision for financial guarantee contracts has been made at the end of the reporting period.

As at 31 March 2018, the Group has an outstanding counter indemnity in favour of the partners of a joint venture amounting to HK\$62,000,000 (2017: HK\$62,000,000) which represents the Group's maximum liability. This maximum liability was determined among the parties to the counter indemnity with reference to the Group's proportionate share of estimated amount of interest payment under the banking facilities granted to the joint venture and the cost overrun in respect of the renovation, management and marketing and leasing of the property held by the joint venture. In the opinion of the directors of the Company, the fair value of the counter indemnity is insignificant at initial recognition and no provision for counter indemnity has been made at the end of the reporting period.

FINANCIAL REVIEW 財務回顧

EMPLOYEES AND REMUNERATION POLICY

The Group is implementing a manpower policy that aims to maximise the output of existing staff resources in order to achieve productivity gains. We believe that through improving our staff's job-related competencies, our overall operational efficiency can be improved without the need for substantial increase in headcount.

As at 31 March 2018, the Group (excluding its joint ventures) had 943 full time employees (of which 146 employees were in Mainland China). The Group offers competitive remuneration packages, including discretionary bonus, share option scheme and share award scheme, to its employees, commensurable to market level and their qualifications. The Group also provides retirement schemes, medical benefits and both in-house and external training courses for employees.

Employees and directors are remunerated according to individual and the Group's performance, industry trends, prevailing market conditions, the nature of the job and value creation. The Group recruits and promotes individuals based on their development potential, merits and competencies, and ensures that their remuneration packages are at a reasonable market level. The directors, full time employees and consultants of the Group are entitled to participate in the share option scheme and share award scheme of the Company. The principal terms of the share option scheme and share award scheme are summarised in the Report of the Directors.

Good corporate governance practices are crucial to enhancing shareholder value. With this in mind, the directors of the Company are keen on maintaining high standards of corporate governance. This is reflected in terms of a quality Board and the emphasis on transparency and accountability. 推行優良的企業管治常規,對提高股東價值至關重要。因此,本公司的董事均致力維持優質企業管治之水平,從強調有一個高質素的董事會,重視透明度及問責性中,可反映出來。

COMPLIANCE WITH CORPORATE GOVERNANCE CODE

Throughout the year ended 31 March 2018, the Company has complied with all the Code Provisions of the Corporate Governance Code (the "CG Code") as set out in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules"), except for the following deviations:

(a) Code Provision A.4.1 of the CG Code stipulates that non-executive directors should be appointed for a specific term, subject to re-election. The nonexecutive directors (including the independent non-executive directors) of the Company were not appointed for a specific term prior to 14 November 2017. However, all directors of the Company are subject to retirement at least once every three years pursuant to the articles of association of the Company. The appointment of each of the nonexecutive directors (including the independent non-executive directors) of the Company has been fixed for a three year term with effect from 14 November 2017, subject to the retirement by rotation provisions as set out in the Company's memorandum and articles of association and the Listing Rules.

BOARD OF DIRECTORS

Board and Management

The Board is responsible for leadership and control of the Company and oversees the businesses of the Group, and assumes responsibility for strategy formulation, corporate governance and performance monitoring. It develops and reviews the Group's strategies and policies, formulates business plans and evaluates performance of the operating divisions against agreed budgets and targets through regular discussion on key and appropriate issues in a timely manner. It also exercises a number of reserved powers, including (i) approval of annual and interim results and significant changes in accounting policy or capital structure, risk management and internal control systems, material transactions (in particular those which may involve conflict of interests), major capital projects; (ii) setting the Group's remuneration policy, dividend policy; (iii) appointment of directors; and (iv) supervision of management and other significant financial and operational matters.

The day-to-day management, administration and operation of the Company are delegated to the Managing Director and the senior management, who fulfill their duties within their scope of authority and responsibility. Divisional heads are responsible for different aspects of the businesses. Major functions delegated to management include preparation of annual and interim results; execution of business strategies and initiatives adopted by the Board; implementation of adequate risk management and internal control systems; and compliance with the relevant statutory requirements.

The Board and each director also have separate and independent access to the senior management whenever necessary. The directors receive regular supply of information about the business activities, financial highlights and operations review so that they are well informed prior to participation in Board meetings.

The financial controller attended all regular Board meetings and when necessary, other Board and committee meetings to advise on business developments, financial and accounting matters, statutory compliance, corporate governance and other major aspects of the Group.

During the year, the Board, as supported by the Audit Committee and the Risk Management Committee, has conducted an annual review of the effectiveness of the Group's risk management and internal control systems covering all material controls, including financial, operational and compliance controls. The Group's risk management and internal control systems are designed to provide reasonable, but not absolute, assurance against material misstatement or loss; to manage rather than completely eliminate the risk of system failure; and to assist in the achievement of the Group's agreed objectives and goals. The risk management and internal control systems of the Group are considered effective and adequate.

During the year and subsequent to the year end, the Board engaged external consultants and professionals to assist the Company in performing risk assessment and to conduct an agreed review over the Group's internal control systems for evaluating the effectiveness of the systems. No significant risk issues were identified and appropriate measures have been taken to address the identified areas for improvement. The Company adopted a risk management policy and formed the Risk Management Committee chaired by the Managing Director and with members comprising the General Manager and various divisions' senior staff members. Systems and procedures are put in place to identify. evaluate, manage and monitor the risks of different businesses and activities. Regular monitoring of the risk management and internal control systems is mainly performed by each of the key divisions/business units who are required to conduct risk self-assessment and to submit risk assessment results and action plans to the Risk Management Committee. The Audit Committee and the Risk Management Committee monitor and assess the risk management systems and the risk management issues, support and advice from external consultants and professionals (internal audit function as outsourced) to perform independent reviews on the risk management systems are sought as and when required. Review on the risk management and internal control systems has to be performed at least annually to assess the effectiveness of the systems in monitoring and managing risks.

The Company has also maintained a tailored governance structure with clear lines of responsibility and appropriate delegation of responsibility and authority to the senior management, who are accountable for the conduct and performance of the respective business divisions under their supervision.

A centralised cash management system is maintained to oversee the Group's investment and borrowing activities. There are established guidelines and procedures for the approval and control of expenditures. The aim is to keep the expenditure level in line with the annual budget and within the cost budget of an approved project. Expenditures are subject to overall budget control with various approval levels set by reference to the level of responsibility of each manager and officer. Depending on the nature and value, procurement of certain goods and services are required to go through the tendering process. No individual in the Group, irrespective of their rank and position, are allowed to dominate the entire expenditure process from commitment to payment.

SHAREHOLDER RIGHTS AND INVESTOR RELATIONS

The general meetings of the Company provide a forum for exchange of views between the shareholders and the Board. The Chairman of the Board as well as Chairmen of the Audit Committee, Nomination Committee and Remuneration Committee, or in their absence, other members of the Board or the respective committees, and where applicable, the independent Board committee, are available to answer questions at the shareholders' meetings.

Separate resolutions are proposed at shareholders' meetings on each substantial issue, including the election of individual directors.

To ensure compliance with the CG Code, the notice of annual general meeting, the annual report and the circular containing information on the proposed resolutions will be sent to shareholders at least twenty clear business days before the meeting. Voting at annual general meeting or other general meeting will be conducted by way of a poll. The results of the poll will be published on the day of shareholders' meeting by posting on both the Stock Exchange's and the Company's websites.

The Board has recommended the declaration of a final dividend of HK5.0 cents per share for the year ended 31 March 2018 amounting to not less than HK\$52,308,800 to the shareholders whose names appear on the branch register of members in Hong Kong and the principal register of members in the Cayman Islands on 30 August 2018. The proposed final dividend will be paid on 12 September 2018 following approval at the annual general meeting.

Under the articles of association of the Company, dividends may be declared and paid out of the profits of the Company, realised or unrealised, or from any reserves set aside from profits which the directors of the Company determine is no longer needed. With the sanction of an ordinary resolution, dividends may also be declared and paid out of share premium account subject to a solvency test as set out in section 34 of the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands.

These policies set the direction and guidelines for corresponding subsidiaries of the Company to follow on gradual basis.

We strive for better environmental performances every year, and in 2017/2018 our performances are recognised. Our Construction Division has obtained several green awards such as Environmental Protection Department Indoor Air Quality Certificate – Excellent Class for head office 2017, Architectural Services Department Green Contractor Award 2017.

Social Policy and Performance

In 2012, corporate social responsibility statement was signed by the Managing Director outlining the Group's determination and direction on carrying out our social performances. The CSR Committee regularly reviews the statement to ensure it is aligned with our company vision, mission and values.

We have been investing in community via organizing or participating activities serving underprivileged, elderly, children, youth and schools. Sponsorship and donation in terms of financial or in-kind is made for charity organizations or non-government organizations. Our corporate volunteer team has also been formed and grows gradually with the support from the Group's staff and their family members.

A long-standing relationship with business partners brings benefits for the Group as well as suppliers and customers. Apart from the connection in business relationship, we also engage our business partners to collaborate for a better performance in business operation, environment, and community investment.

The Group encourages staff volunteering and sponsorship and engages staff in community. Positive site-community relationship is definitely our priority. Therefore, close communications with relevant parties and programmes are initiated and conducted addressing community concern.

SHARE AWARD SCHEME

The share award scheme (the "Share Award Scheme") was adopted by the Board on 28 July 2016 (the "Adoption Date") to recognise the contributions of certain employees and directors of the Group and help retain them for the continuing operation and further development of the Group. The Share Award Scheme shall be valid until 28 July 2019 and is subject to the administration of the Board and the trustee in accordance with the rules relating to the Share Award Scheme and the trust deed.

The Company would contribute a maximum of HK\$74,000,000 to the trust for the purchase of shares under the Share Award Scheme. The maximum number of shares which can be awarded under the Share Award Scheme (the "Award Shares") is 5% of the number of the Company's shares in issue as at the Adoption Date.

During the year ended 31 March 2017, the trustee purchased an aggregate of 51,700,000 shares of the Company from the market at a total consideration of approximately HK\$71,995,000 (including directly attributable incremental costs) and a total of 51,542,000 shares were granted to 88 eligible participants on 10 March 2017 pursuant to the Share Award Scheme, representing approximately 4.97% of the total number of issued shares of the Company as at 31 March 2017.

股份獎勵計劃

股份獎勵計劃(「股份獎勵計劃」)乃由董事會 於二零一六年七月二十八日(「採納日期」)採 納,以認可本集團若干僱員及董事之貢獻並有 助於挽留彼等致力於本集團之持續運營及進 一步發展。股份獎勵計劃有效期至二零一九年 七月二十八日,並須根據有關股份獎勵計劃及 信託契據之規則由董事會及信託人管理。

SHARE OPTION SCHEME

Pursuant to the Company's existing share option scheme (the "Scheme") which was adopted and became effective on 21 September 2011, all directors (including independent non-executive directors), full-time employees and consultants of the Company, its subsidiaries and/or its associated companies/associates are eligible to participate in the Scheme.

The purpose of the Scheme is to provide the participants who have been granted options under the Scheme to subscribe for ordinary shares in the Company with the opportunity to acquire proprietary interest in the Company and to encourage them to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole.

(a) Maximum number of shares available for issuance

The maximum number of shares which may be issued upon exercise of all options to be granted under the Scheme and any other schemes of the Company shall not exceed 10% of the number of the Company's shares in issue as at the date of approval of the Scheme, subject to renewal as approved by the shareholders of the Company. Upon the refreshment of the Scheme mandate limit at the annual general meeting of the Company held on 23 August 2016, the maximum number of new share options that can be granted under the Scheme was 103,654,057 (the "Refreshed Share Option Limit"). As at the date of this annual report, the total number of shares that may be issued under the remaining Refreshed Share Option Limit is 55,942,057, representing approximately 5.35% of the number of the Company's shares in issue at that date.

Taking into account the remaining Refreshed Share Option Limit to subscribe for 55,942,057 shares and the 54,415,725 shares that may be issued upon exercise of the outstanding share options granted and yet to be exercised under the Scheme, the cumulative total number of shares that may be issued under the Scheme is 110,357,782 shares, representing approximately 10.55% of the number of the Company's shares in issue as at the date of this annual report.

such grant of option shall be subject to prior approval of the shareholders of the Company who are not connected persons of the Company as defined in the Listing Rules.

(c) Period within which the shares must be taken up under an option

Within ten years from the date on which an option is granted or such shorter period as the Board or the relevant committee thereof may specify.

(d) Minimum period, if any, for which an option must be held before it can be exercised

At the time of granting an option, the Board or the relevant committee thereof must specify the minimum period(s) (if any) and achievement of performance target(s) (if any), for which an option must be held before it can be exercised in whole or in part.

(f) Amount payable upon acceptance of the option

A consideration of HK\$1 shall be paid upon the acceptance of the option.

(g) Basis of determining exercise price of the option

The exercise price of the option shall be no less than the highest of:

- the closing price of the shares of the Company as stated in the daily quotations sheet issued by the Stock Exchange on the date of grant, which must be a business day;

Mr. Lo stands to receive incentive bonuses under the Company's incentive bonus scheme of such amount to be recommended by the Managing Director and the General Manager of the Company and then approved by the Remuneration Committee, should either of these types of corporate transaction transpire, such payments to be made, subject to his remaining employed at the relevant time, pursuant to his service contract.
- (3) The monthly salaries of the executive directors, namely Mr. Wong Sue Toa, Stewart, Mr. Tai Sai Ho and Mr. Lo Kai Cheong, were increased by 3.5%, 3.5% and 23.76% respectively, all with effect from 1 April 2018 as compared with those of the last year.

1. GENERAL

Hanison Construction Holdings Limited (the "Company") is an exempted company incorporated in the Cayman Islands with limited liability under the Companies Law (2001 Second Revision), Chapter 22 of the Laws of Cayman Islands. Its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section of the annual report.

The consolidated financial statements are presented in Hong Kong dollar ("HK\$"), which is the functional currency of the Company.

The Company is an investment holding company and the principal activities of its subsidiaries are construction, interior and renovation works, supply and installation of building materials, property investment, property development, provision of property agency and management services and sale of health products.

In general, the directors of the Company anticipate that the application of the expected credit loss model of HKFRS 9 will result in earlier provision of credit losses which are not yet incurred in relation to the Group's financial assets measured at amortised costs and other items that subject to the impairment provisions upon application of HKFRS 9 by the Group.

The Group expects to apply the simplified approach to recognise lifetime expected credit losses for its financial assets measured at amortised cost as required or permitted under HKFRS 9. The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

香港財務報告準則第十五號的核心原則 乃一個實體應確認收入以體現向客戶轉 讓承諾貨品或服務的數額,並反映實體預 期交換該等貨品或服務而應得的代價。 具體來說,該準則引入了五步法來確認收 入:

- 第1步:確定與一個客戶的合約
- 第2步:確定合約內的履約義務
- 第3步: 釐定交易價格

- 第5步: 當實體符合履約義務時確認 收入

根據香港財務報告準則第十五號,當一個實體符合履約義務時確認收入,即當貨品或服務按特定的履約義務轉移並由客戶「控制」時。更為規範的指引已加入香港財務報告準則第十五號內以處理特定情況。此外,香港財務報告準則第十五號亦要求較廣泛的披露。

In 2016, the HKICPA issued clarifications to HKFRS 15 in relation to the identification of performance obligations, principal versus agent considerations, as well as licensing application guidance.

As regards to the construction contracts, interior and renovation contracts and installation of building materials contracts, the directors of the Company specifically consider the guidance of HKFRS 15 on contract combinations, contract modifications arising from variation orders, variable consideration, and the assessment of whether there is significant financing component in the contracts, particularly taking into account the reason for the difference in timing between the transfer of control of goods and services to customers and timing of relate payments. The directors of the Company have assessed that as performance obligation is satisfied over time therefore revenue from these contracts should be recognised over time during the course of construction by the Group. Furthermore, the directors of the Company consider that the output method currently used to measure the progress towards complete satisfaction of these performance obligations will continue to be appropriate under HKFRS 15. However, the directors of the Company are assessing whether the current accounting policy adopted by the Group in recognising the construction costs charged to profit or loss by reference to the stage of completion of the contract activity at the end of the reporting period is different from the recognition of construction costs in profit or loss based on the actual construction costs incurred under the guidance of HKFRS 15, and also the potential financial impact. Furthermore, the application of HKFRS 15 may result in changes in presentation of certain line items in the consolidated statement of financial position.

The directors of the Company intend to apply the limited retrospective method with cumulative effect of initial application recognised in the opening balance of equity at 1 April 2018. Apart from the recognition of construction costs and changes in presentation as explained above and providing more extensive disclosure on the Group's revenue transactions, the directors of the Company do not anticipate that the application of HKFRS 15 will have a significant impact on the financial position and/or financial performance of the Group.

HKFRS 16 "Leases"

HKFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. HKFRS 16 will supersede HKAS 17 "Leases" and the related interpretations when it becomes effective.

HKFRS 16 distinguishes lease and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the Group currently presents upfront prepaid lease payments as investing cash flows in relation to leasehold lands and those classified as investment properties while other operating lease payments are presented as operating cash flows. Under the HKFRS 16, lease payments in relation to lease liability will be allocated into a principal and an interest portion which will be presented as financing and operating cash flows by the Group, respectively.

Under HKAS 17, the Group has already recognised prepaid lease payments for leasehold lands where the Group is a lessee. The application of HKFRS 16 may result in potential changes in classification of these assets depending on whether the Group presents right-of-use assets separately or within the same line item at which the corresponding underlying assets would be presented if they were owned.

In contrast to lessee accounting, HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by HKFRS 16.

As at 31 March 2018, the Group has non-cancellable operating lease commitments of HK\$13,182,000 as disclosed in note 43. A preliminary assessment indicates that these arrangements will meet the definition of a lease. Upon application of HKFRS 16, the Group will recognise a right-of-use asset and a corresponding liability in respect of all these leases unless they qualify for low value or short-term leases.

In addition, the Group currently considers refundable rental deposits paid of HK\$1,495,000 and refundable rental deposits received of HK\$7,300,000 as rights and obligations under leases to which HKAS 17 applies. Based on the definition of lease payments under HKFRS 16, such deposits are not payments relating to the right to use the underlying assets, accordingly, the carrying amounts of such deposits may be adjusted to amortised cost and such adjustments are considered as additional lease payments. Adjustments to refundable rental deposits paid would be included in the carrying amount of right-of-use assets. Adjustments to refundable rental deposits received would be considered as advance lease payments.

Furthermore, the application of new requirements may result in changes in measurement, presentation and disclosure as indicated above.

Amendments to HKAS 40 "Transfers of Investment Property"

The amendments clarify that a transfer to, or from, investment property necessitates an assessment of whether a property meets, or has ceased to meet, the definition of investment property, supported by observable evidence that a change in use has occurred. The amendments further clarify that situations other than the ones listed in HKAS 40 may evidence a change in use, and that a change in use is possible for properties under development and properties held for sale. For example, change in use for transfer from properties held for sale in the ordinary course of business to investment properties could be evidenced by inception of an operating lease to another party. Currently, the Group accounts for such transfer only upon commencement of an operating lease.

The directors of the Company anticipate that the application of these amendments will result in early recognition of such transfers on the Group's consolidated financial statements in future periods should there be a change in use of any of its properties, which may not have significant impact on the Group's transfers of investment properties.

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited ("Listing Rules") and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis, except for the investment properties and certain financial instruments, which are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are within the scope of HKAS 17 "Leases", and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets".

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For investment properties which are transferred at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets, liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Changes in the Group's ownership interests in existing subsidiaries

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKAS 39, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 "Income Taxes" and HKAS 19 "Employee Benefits" respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 "Share-based Payment" at the acquisition date (see the accounting policy below); and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 "Noncurrent Assets Held for Sale and Discontinued Operations" are measured in accordance with that standard.

Acquisition of a subsidiary not constituting a business

When the Group acquires a group of assets and liabilities that do not constitute a business, the Group identifies and recognises the individual identifiable assets acquired and liabilities assumed by allocating the purchase price first to investment properties which are subsequently measured under fair value model and financial assets and financial liabilities at the respective fair values, the remaining balance of the purchase price is then allocated to the other individual identifiable assets and liabilities on the basis of their relative fair values at the date of purchase. Such a transaction does not give rise to goodwill or bargain purchase gain.

Interests in an associate and joint ventures

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of an associate or joint ventures are incorporated in these consolidated financial statements using the equity method of accounting, except when the investment is classified as held for sale, in which case it is accounted for in accordance with HKFRS 5 "Non-current Assets Held for Sale and Discontinued Operations". The financial statements of an associate and joint ventures used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate or a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture. Changes in net assets of the associate/ joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate or joint venture exceeds the Group's interest in that associate or joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate or joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture.

An investment in an associate or a joint venture is accounted for using the equity method from the date on which the investee becomes an associate or a joint venture. On acquisition of the investment in an associate or a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate or a joint venture. When necessary, the entire carrying amount of the investment is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

Therefore, if a gain or loss previously recognised in other comprehensive income by that associate or joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal of the relevant associate or joint venture.

When a group entity transacts with an associate or a joint venture of the Group, profits and losses resulting from the transactions with the associate or joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the associate or joint venture that are not related to the Group.

Non-current assets held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving disposal of an investment in a joint venture, the investment that will be disposed of is classified as held for sale when the criteria described above are met, and the Group discontinues the use of the equity method in relation to the portion that is classified as held for sale from the time when the investment is classified as held for sale.

Non-current assets (and disposal groups) classified as held for sale are measured at the lower of their previous carrying amount and fair value less costs to sell. Investment properties classified as held for sale are measured at their fair values using the fair value model.

Revenue recognition

Revenue is measured at fair value of the consideration received or receivable. Revenue is reduced for estimated customer returns, rebates and other similar allowances.

Revenue is recognised when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the Group and when specific criteria have been met for each of the Group's activities, as described below.

Revenue from construction contracts, interior and renovation contracts and building materials installation contracts is recognised using the percentage of completion method by reference to the value of work carried out during the year as determined by independent surveyors' reports.

Revenue from sale of properties in the ordinary course of business is recognised when the respective properties have been completed and delivered to the buyers.

Revenue from sale of goods is recognised when the goods are delivered and titles have passed.

Property agency and management service income is recognised when services are provided.

Dividend income from investments is recognised when the shareholders' rights to receive payment have been established.

Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at their fair values. All of the Group's property interests held under operating leases to earn rentals or for capital appreciation purposes are classified and accounted for as investment properties and are measured using the fair value model. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise.

Transfer from investment property to owneroccupied property

An investment property is transferred to property, plant and equipment when it is evidenced by the commencement of owner-occupation. The property's deemed cost for subsequent accounting is its fair value at the date of change in use. The property interest held under an operating lease which is previously classified as investment property under the fair value model is continued to account for as a finance lease after the transfer.

Property, plant and equipment

Property, plant and equipment including leasehold land and buildings held for own use are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

If an item of property, plant and equipment becomes an investment property because its use has changed as evidenced by end of owner-occupation, any difference between the carrying amount and the fair value of that item (including the relevant prepaid lease payments) at the date of transfer is recognised in other comprehensive income and accumulated in property revaluation reserve. On the subsequent sale or retirement of the asset, the relevant revaluation reserve will be transferred directly to accumulated profits.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease.

The Group as lessee

Operating lease payments, including the cost of acquiring land held under operating leases, are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

Leasehold land and building

When the Group makes payments for a property interest which includes both leasehold land and building elements, the Group assesses the classification of each element separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire property is accounted as an operating lease. Specifically, the entire consideration (including any lump-sum upfront payments) are allocated between the leasehold land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis except for those that are classified and accounted for as investment properties under the fair value model. When the lease payments cannot be allocated reliably between the leasehold land and buildings elements, the entire property is generally classified as if the leasehold land is under finance lease.

Prepaid lease payments

Prepaid lease payments represent the up-front payments to lease medium-term leasehold land interests in the People's Republic of China (the "PRC") and are charged to the consolidated statement of profit or loss on a straight-line basis over the term of the relevant lease.

Inventories

Properties under development for sale

Properties under development for sale are carried at the lower of cost and net realisable value. Cost include land cost, development costs and directly attributable costs including, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy.

Properties held for sale

Properties held for sale are completed properties and are classified under current assets. They are stated at the lower of cost and net realisable value. Costs relating to the development of properties, comprising land costs and development costs, are included in properties held for development for sale until such time when they are completed. Net realisable value represents the estimated selling price less all anticipated cost to be incurred in marketing and selling.

The Group transfers a property from inventories to investment property when there is a change in use to hold the property to earn rentals or/and for capital appreciation rather than for sale in the ordinary course of business, which is evidenced by the commencement of an operating lease to another party. Any difference between the fair value of the property at the date of transfer and its previous carrying amount is recognised in profit or loss.

Others

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are calculated using the weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Construction, interior and renovation and installation of building materials contracts

Where the outcome of a construction, interior and renovation or installation of building materials contract can be estimated reliably, revenue and costs are recognised by reference to the stage of completion of the contract activity at the end of the reporting period, as measured by surveys of work performed. Variations in contract work are included to the extent that the amount can be measured reliably and its receipt is considered probable.

Where the outcome of a construction, interior and renovation or installation of building materials contract cannot be estimated reliably, contract revenue is recognised to the extent of contract costs incurred that it is probable will be recoverable. Contract costs are recognised as expenses in the period in which they are incurred.

When it is probable that total contract costs will exceed total contract revenue, the expected loss is recognised as an expense immediately.

Where contract costs incurred to date plus recognised profits less recognised losses exceed progress billings, the surplus is shown as amounts receivable on contract work. For contracts where progress billings exceed contract costs incurred to date plus recognised profits less recognised losses, the surplus is shown as amounts payable on contract work. Amounts received before the related work is performed are included in the consolidated statement of financial position, as a liability, as other payables. Amounts billed for work performed but not yet paid by the customer are included in the consolidated statement of financial position under progress payments receivable.

Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Impairment losses on tangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs to sale and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before taxation' as reported in the consolidated statement of profit or loss because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profit will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, and interests in an associate and joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purpose of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered through sale unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose business objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deductible from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using the exchange rate prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period unless exchange rate fluctuate significantly during that period, in which case the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgement in applying accounting policies

The following is the critical judgement, apart from those involving estimations, that the directors of the Company have made in the process of applying the Group's accounting policies and that have the significant effect on the amounts recognised in the consolidated financial statements.

For the purpose of measuring deferred tax liabilities arising from investment properties that are measured using the fair value model, the directors of the Company have reviewed the investment property portfolio of the Group's subsidiaries, associate and joint ventures and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in determining the Group's deferred taxation on investment properties, the directors of the Company have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. The Group has not recognised any deferred taxes on changes in fair value of investment properties as the Group is not subject to any income taxes on the fair value changes of the investment properties on disposal.

Investment properties are carried in the consolidated statement of financial position at 31 March 2018 at their fair value of HK\$1,712,360,000 (2017: HK\$2,399,700,000) (note 15) based on valuation of these properties conducted by Jones Lang LaSalle Limited and Colliers International (Hong Kong) Limited, independent property valuers. In determining the fair values of the Group's investment properties, the valuers applied a market value basis which involves, inter-alia, significant unobservable inputs and significant judgements, representing appropriate market rent, capitalisation rate and adjusted market price that has taken into account of property-specific adjustments including location, land quality and timing of reference transactions.

The Group recognised revenue and costs from construction contracts, interior and renovation contracts and installation of building materials contracts ("contracts") using percentage of completion method, which were derived from the latest available budgets of the contracts including variations on contract work based on the overall performance of each contracts and the management's best estimates and judgments. Estimated construction income is determined in accordance with the terms set out in the relevant contracts. Estimated construction costs which mainly comprise material costs, labour costs and subcontracting fees based on the quotations from time to time provided by the major contractors/ suppliers/vendors involved and the experience of the management. Because of the nature of the construction industry, the management regularly reviews the progress of the contracts and the estimated construction income and costs.

The fair values of the Group's investment properties at 31 March 2018 and 2017 have been arrived at on the basis of a valuation carried out on the respective date by Jones Lang LaSalle Limited ("JLL") and Colliers International (Hong Kong) Limited ("Colliers"), independent property valuers not connected with the Group. JLL and Colliers have appropriate qualifications and recent experience in the valuation of similar properties in the relevant locations. In estimating the fair value of the properties, the highest and best use of the properties is their current use. The valuation of properties amounting to HK\$44,400,000 (2017: HK\$43,700,000) was arrived at by reference to market evidence of transaction prices of similar properties. The valuations of other properties amounting to HK\$1,667,960,000 (2017: HK\$2,356,000,000) were arrived at by reference to the income capitalisation method which is based on the capitalisation of the net income potential by adopting an appropriate capitalisation rate, which is derived from analysis of sale transactions and interpretation of prevailing investor requirements or expectations.

# **Summary of fair value hierarchy and Level 3 fair value measurements**

All of the Group's property interests held under operating leases to earn rentals or for capital appreciation purposes are measured using the fair value model and are classified and accounted for as investment properties. All investment properties of the Group are valued by reference to a Level 3 fair value measurement.

There are no transfers between different levels within the fair value hierarchy during both years.

Proceeds from property sales are receivable pursuant to the terms of the sale and purchase agreements. For the business of building materials and others, the Group generally allows a credit period of 30 to 90 days and not more than 90 days (2017: 30 to 90 days and not more than 90 days) to its customers. Before accepting any new customer, the Group will internally assess the credit quality of the potential customers and define appropriate credit limit. Other receivables are unsecured, interest-free and repayable on demand.

Management closely monitors the credit quality of trade debtors. 83% (2017: 92%) of the trade debtors that are neither past due nor impaired to be of a good credit quality based on their historical repayments. Included in the trade debtors balance are trade debtors with aggregate carrying amount of HK\$19,479,000 (2017: HK\$3,404,000) which are past due at the end of the reporting period for which the Group has not provided for impairment loss. The Group does not hold any collateral over these balances. There are no balances included in other receivables which are past due.

The directors of the Company assessed whether the held-for-sale criteria set out in HKFRS 5 "Non-current Assets Held for Sale and Discontinued Operations" were met. Taking into account (a) the fact that the subject equity interests and shareholder's loan were immediately available for sale, and (b) the conditions to be met to complete the disposal as set out in the terms of the relevant agreements, the carrying amount of 50% interests in the joint venture of HK\$282,067,000 as at 31 March 2018 was reclassified from interests in a joint venture to assets classified as held for sale. The disposal has been completed on 10 April 2018.

On 22 March 2017, an indirect wholly owned subsidiary of the Company entered into two provisional agreements for sale and purchase ("agreements") with independent third parties to dispose of certain investment properties. On 13 July 2017, an indirect wholly owned subsidiary of the Company, Heroic Elite Investments Limited, entered into a sale and purchase agreement with an independent third party to acquire the entire issued share capital of Waller Holdings together with the shareholder's loan at a consideration of approximately HK\$145,395,000. The acquisition was completed on 14 August 2017. The major assets of Waller Group are office units and car parking spaces of a commercial property, Kings Wing Plaza 1, situated in Shatin, New Territories. Waller Holdings was acquired so as to relocate the Group's office to the commercial property.

On 13 July 2017, an indirect wholly owned subsidiary of the Company, Oriental Elite Global Limited, entered into a sale and purchase agreement with an independent third party to acquire the entire issued share capital of Faithful Sun together with the shareholder's loan, at a consideration of approximately HK\$149,878,000. The acquisition was completed on 14 August 2017. The major assets of Faithful Sun are office units and car parking spaces of a commercial property, namely Kings Wing Plaza 1, situated in Shatin, New Territories. Faithful Sun was acquired so as to relocate the Group's office to the commercial property.

During the year ended 31 March 2017, there were two acquisitions entered into by the Group including (i) Befit Limited ("Befit"); (ii) Honour Tower Holdings Limited together with its wholly owned subsidiary, Westpac Limited, (collectively referred to as "Honour Tower Group") and Reliable Worldwide Limited together with its wholly owned subsidiary, Golden Years Limited, (collectively referred to as "Reliable Worldwide Group"). On 21 February 2018, a wholly owned subsidiary of the Company, Hanison Construction Holdings (BVI) Limited ("Hanison BVI"), entered into a sale and purchase agreement with an independent third party (the "Purchaser") to dispose of its 50% equity interests in and shareholder's loan to Gallant Elite Enterprises Limited ("Gallant Elite") together with its wholly owned subsidiaries, Nimble Run Limited and Trillion Mart Development Limited ("Trillion Mart"). Trillion Mart is engaged in property investment. The major asset of Trillion Mart represented commercial property "PeakCastle" situated at No. 476 Castle Peak Road, Kowloon, Hong Kong. The consideration for the disposal is approximately HK\$332,651,000. The disposal was completed on 28 March 2018. Subsequent to the disposal, Gallant Elite became a joint venture of the Group.

According to the sale and purchase agreement, the Group granted a put option to the Purchaser, and pursuant to which the Purchaser is entitled to, sell back 50% interests in Gallant Elite and any shareholder loan made available by the Purchaser and for the time being outstanding or due owing from Gallant Elite (the "Put Interests") to the Group at the Purchaser's discretion. The put option is exercisable by the Purchaser at any time during the period starting after (and exclusive of) 28 June 2020 and ending on (and inclusive of) 28 September 2020.

#### **38. SHARE OPTION SCHEME**

Pursuant to the Company's share option scheme (the "Scheme") which was adopted and became effective on 21 September 2011, all directors (including independent non-executive directors), full-time employees and consultants of the Company, its subsidiaries and its associated companies are eligible to participate in the Scheme.

The purpose of the Scheme is to provide the participants who have been granted options under the Scheme to subscribe for ordinary shares in the Company with the opportunity to acquire proprietary interest in the Company and to encourage them to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole.

## (a) Maximum number of shares available for issuance

The maximum number of shares which may be issued upon exercise of all options to be granted under the Scheme and any other schemes of the Company shall not exceed 10% of the shares of the Company in issue as at the date of approval of the Scheme, subject to renewal as approved by the shareholders of the Company. Upon the refreshment of the Scheme mandate limit at the annual general meeting of the Company held on 23 August 2016, the maximum number of new share options available for issue under the Scheme was 103,654,057 (the "Refreshed Share Option Limit"). As at the date of this annual report, the total number of shares that may be issued under the remaining Refreshed Share Option Limit is 55,942,057, representing approximately 5.35% of the number of the Company's shares in issue at that date.

The directors of the Company shall not grant further awards if they would result in the number of Award Scheme exceeding 5% of the total number of shares in issue as at the date of the Adoption Date.

The Company established a trust to purchase shares of the Company for the benefit of employees and the directors of the Company and its subsidiaries under the Share Award Scheme (the "Award Shares"). Pursuant to the rules of the Share Award Scheme, the Company has appointed a trustee, Computershare Hong Kong Trustees Limited ("Trustee"), to administer the Share Award Scheme and to purchase and hold the Award Shares during the Award Period. The Company would contribute a maximum of HK\$74,000,000 to the trust for the purchase of shares under the Share Award Scheme.

#### **47. CAPITAL RISK MANAGEMENT**

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balances. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of net debt, which includes bank and other loans disclosed in note 32, net of cash and cash equivalents, and equity, comprising issued share capital, reserves and accumulated profits.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends and new share issues, as well as the issue of new debts and the redemption of existing debts.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual debt at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the majority of counterparties are banks with high credit-ratings assigned by international credit-rating agencies.

The Group has concentration of credit risk with 85% (2017: 85%) of the total progress payments receivable was due from the Group's three (2017: three) largest customers, engaged in property construction business in Hong Kong, within the construction segment.

#### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank and other loans and ensures compliance with loan covenants.

The Group relies on bank and other loans as a significant source of liquidity. As at 31 March 2018, the Group has available unutilised borrowing facilities of approximately HK\$2,100,389,000 (2017: HK\$1,781,920,000). Details of bank and other loans are set out in note 32.

As at 31 March 2018, the aggregate undiscounted principal amounts of these bank loans amounted to HK\$395,507,000 (2017: HK\$815,127,000), Taking into account the Group's financial position, the directors of the Company do not believe that it is probable that the banks will exercise their discretionary rights to demand immediate repayment. The directors of the Company believe that such bank loans as at 31 March 2018 will be repaid within two (2017: four) years after the reporting date in accordance with the scheduled repayment dates set out in the loan agreements.
