The Share Offer comprises the Public Offer of initially 40,000,000 Public Offer Shares (subject to reallocation), representing 10% of the total number of Offer Shares made available under the Share Offer, and the Placing of initially 360,000,000 Placing Shares (subject to reallocation), representing 90% of the total number of Offer Shares under the Share Offer.
