BNP PARIBAS ISSUANCE B.V. (the "**Issuer**") gives notice that under the terms and conditions of the CBBCs (the "**Conditions**"), following the occurrence of the Mandatory Call Event ("**MCE**") of the CBBCs at 09:20:00 in the pre-opening session on 15 October 2018, the Residual Value has been determined to be HK\$0.0 per Board Lot (such Board Lot being **10,000** CBBCs).

The Residual Value is determined by the Issuer by reference to the following formula:

$$\text{Residual Value per Board Lot} = \frac{\text{Entitlement} \times (\text{Minimum Trade Price} - \text{Strike Price}) \times \text{one Board Lot}}{\text{Number of CBBC(s) per Entitlement}}$$

Where:

- (a) "**Strike Price**" is HK\$297.50;
- (b) "**Minimum Trade Price**" means the lowest Spot Price of the Shares during the MCE Valuation Period, being HK\$278.00;
- (c) "**Entitlement**" means 1 share(s); and
- (d) "**Number of CBBC(s) per Entitlement**" means 100 CBBCs;

Subject to Settlement Disruption Event, all eligible CBBC holders will receive the Residual Value (if any)(net of any Exercise Expenses) on 19 October 2018, being three CCASS Settlement Days following the MCE Valuation Date.
