ANNOUNCEMENT

POWER GENERATION FOR THE THIRD QUARTER OF 2018

The announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for the third quarter of 2018 on consolidated basis amounted to 3,363,950 MWh, representing an increase of 9.83% compared with that of the corresponding period of 2017, of which, the wind power generation amounted to 3,293,718 MWh, representing an increase of 9.76% compared with that of the corresponding period of 2017, and other renewable energy power generation amounted to 70,232 MWh, representing an increase of 13.13% compared with that of the corresponding period of 2017. As of 30 September 2018, the total power generation of the Group for 2018 amounted to 12,915,662 MWh, representing an increase of 24.15% compared with that of the corresponding period of 2017, of which, the wind power generation amounted to 12,695,295 MWh, representing an increase of 24.35% compared with that of the corresponding period of 2017, and other renewable energy power generation amounted to 220,367 MWh, representing an increase of 13.94% compared with that of the corresponding period of 2017.
