Chairman's Statement 主席報告



On behalf of the Board ("Board") of Directors ("Directors", each being a "Director"), I am pleased to announce that Zhejiang Tengy Environmental Technology Co., Ltd ("Company" or "Tengy Environmental") and its subsidiaries (collectively the "Group") recorded solid financial results for the year ended 31 December 2018 ("Year").

The Group is a well-established integrated atmospheric pollution control solution provider, with a primary focus on particulate emission control by offering mega-sized precipitators to customers in various industries.

The Group is with over 20 years of industry experience and continue to innovate in industrial technologies.

The Group's operating income during the Year increased by 8.4% to approximately RMB858.8 million, while the profit before tax during the Year decreased by 61.5% compared to the corresponding period of last year, to approximately RMB46.4 million. Meanwhile, the profit attributable to shareholders of the Company ("**Shareholders**", each being a "**Shareholder**") was approximately RMB31.2 million, representing a decrease of 62.5% compared to the corresponding period of last year.

本人謹代表董事(「董事」)會(「董事會」)欣然宣 佈浙江天潔環境科技股份有限公司(「本公司」或 「天潔環境」)及其附屬公司(統稱為「本集團」)於 截至二零一八年十二月三十一日止年度(「本年 度」)錄得穩健的財務業績。

本集團為著名的綜合大氣污染防治解決方案供應 商,主要專注於顆粒物的排放控制,在多個行業 為客戶提供特大型除塵器。

本集團擁有超過20年的行業經驗且在行業技術方面持續追求創新。

本集團於本年度的營業收入增加8.4%至約人民幣 858.8百萬元,而本年度的税前溢利則較去年同期 減少61.5%至約人民幣46.4百萬元。同時,本公司 股東(「**股東**」)應佔溢利約為人民幣31.2百萬元, 較去年同期減少62.5%。

Approximately 79% of the revenue for the Year of the Group is from the sales of electrostatic precipitator (63%) and electrostatic-bag composite precipitator (16%), amounting to RMB537.2 million and RMB132.7 million respectively.

The Group believes that, with its leveraging years of industry experience and continual innovation in industrial technologies, the Group can obtain more new projects from customers in the national electricity industries and also from other industries due to its enhanced reputation as reliable atmospheric pollution control solution provider.

The Company has now possessed a grade A environmental engineering design (air pollution control project) qualification certificate (甲級環境工程設計專項(大氣污染防治工程)資 質證書) issued by the Ministry of Housing and Urban-Rural Development in the People's Republic of China (中華人民 共和國住房和城鄉建設部), a grade A air pollution control engineering design service capability evaluation certificate (甲級大氣污染治理工程專項設計服務能力評價證書) and a grade A air pollution control main contractor service capability evaluation certificate (甲級大氣污染治理工程總承 包服務能力評價證書) both issued by Zhejiang Environmental Protection Industry Association in the People's Republic of China, which allow the Company to tender for more projects in the future.

Besides, the Group possesses a competitive advantage over existing market competitors as well as new entrants in new projects due to its extensive project experience over the years.

The People's Republic of China ("**PRC**") currently continues to strengthen its effort in environmental protection by strictly control the emission of air pollutants due to the fact that the large amount of major pollutants produced during the coal combustion process of coal-fired power plants, including particulates, sulfur dioxide, nitrogen oxides and etc. A stringent accountability system was rolled out with the aim to achieve the governance effect. 本年度,本集團約79%的收益來自靜電除塵器 (63%)及電袋複合除塵器(16%)的銷售,分別為人 民幣537.2百萬元及人民幣132.7百萬元。

本集團相信,憑著多年的行業經驗且在行業技術 方面持續追求創新,再加上其作為可靠大氣污染 防治解決方案供應商日益提高的聲譽,本集團可 獲取更多來自國家電力企業以及其他行業客戶的 新項目。

本公司現持有由中華人民共和國住房和城鄉建設 部頒發的甲級環境工程設計專項(大氣污染防治 工程)資質證書、由中華人民共和國浙江省環保 產業協會頒發的甲級大氣污染治理工程專項設計 服務能力評價證書及甲級大氣污染治理工程總承 包服務能力評價證書,該等證書令本公司日後可 投標更多項目。

此外,本集團多年來積累的豐富項目經驗,將使 本集團在爭取新項目時較現有市場競爭對手以及 新入行者更具競爭優勢。

由於燃煤電廠的燃煤過程中產生大量主要污染物 (包括顆粒物、二氧化硫、氮氧化物等),故中華 人民共和國(「**中國**」)現時繼續加強其環保力度, 嚴格控制氣體污染物排放量,並推出嚴格問責制 度,有望落實治理效果。

With increasingly stringent environmental protection inspection, the environmental protection equipment which does not meet the requirements must be upgraded and modified immediately, which in turn will give significant rise to a certain demand for precipitators.

Looking forward, more effort will be put by the Group to enhance its research and development capabilities, to develop new technologies and to expand the product portfolio.

Simultaneously, the Group will seek for the growing opportunities in the air pollution control solutions industry of the PRC, as well as of overseas markets to expand its market share in different markets.

OVERVIEW

The Group is a well-established integrated atmospheric pollution control solution provider, with a primary focus on particulate emission control by offering mega-sized precipitators to customers in various industries. The Group has years of industry experience and record of continual innovation in industrial technologies.

During the Year, the Group generated its revenue primarily from (i) sales of environmental protection equipment; (ii) sales of materials; and (iii) rendering of services.

The Group's sales of environmental protection equipment represented tailor-made and integrated atmospheric pollution control solutions offered by the Group to its customers, comprising engineering design, equipment procurement and manufacturing, supervision of installation and commissioning, customer training, and repair and maintenance services provided to its customers on a project basis. During the Year, the Group mainly offered three types of precipitators: electrostatic precipitators, bag filter precipitators and electrostatic-bag composite precipitators.

The Group's sales of materials represented sales of materials, including raw materials, spare parts and components and scrap materials to related parties or independent third parties.

The Group's rendering of services represented its technology consultancy services provided to its customers on a stand-alone basis, which include repair and replacement, and on-site engineering and maintenance services for those projects which were not constructed by the Group.

Precipitators are widely installed at coal-fired power plants, metallurgical plants, paper mills and other industrial production plants. As such, the Group has an extensive range of customers including the project owners of power plants and industrial production plants, or contractors who undertake the construction work of power plants and industrial production plants.

概述

本集團為著名的綜合大氣污染防治解決方案供應 商,主要專注於顆粒物的排放控制,在多個行業 為客戶提供特大型除塵器。本集團擁有多年的行 業經驗且在行業技術方面持續追求創新。

本年度,本集團的收益主要產生自(i)銷售環保設備;(ii)銷售材料;及(iii)提供服務。

本集團銷售環保設備指本集團為客戶提供的度身 定製的綜合大氣污染防治解決方案,包括按項目 向客戶提供工程設計、設備採購及製造、指導安 裝及調試、客戶培訓及維修與維護服務。本年度, 本集團主要提供三種除塵器:靜電除塵器、袋式 除塵器及電袋複合除塵器。

本集團銷售材料指向關聯方或獨立第三方銷售的 材料,包括原材料、備件和部件及廢料。

本集團提供服務指本集團按獨立基準向客戶提供 技術諮詢服務,包括向並非由本集團建造的項目 提供維修及更換,以及現場工程及維護服務。

由於除塵器已在燃煤電廠、冶金廠、造紙廠及其 他工業生產廠房廣泛安裝,因此,本集團的客戶 群極為廣泛,包括發電廠及工業生產廠房的項目 擁有人,或承包發電廠及工業生產廠房的建造工 程的承包商。

BUSINESS REVIEW

The PRC is currently the second largest economy in the world. Currently coal consumption is still in a dominant position in the energy consumption composition of the PRC. Under such circumstances, the most severe atmospheric pollution problem in the PRC is coal-burning pollution, which is mainly caused by pollutants such as dust, smoke dust, sulfur dioxide and nitrogen oxides. Since the 21st century, the emission volume of air pollutants, such as smoke dust (dust) and sulfur dioxide, has generally declined. This is mainly due to the fact that the PRC continues to strengthen its effort in environmental protection by strictly controlling the emission of air pollutants in recent years.

The year 2018 marks the opening year for "Defending the blue sky" by the Party Central Committee, the State Council, the Provincial Party Committee and the Provincial Government. Guided by the decisions and arrangements of the Party Central Committee and the Provincial Party Committee and the Provincial Government regarding "Defending the blue sky", all departments at all levels are obliged to exercise due diligence in discharging their duties, to co-ordinate with other departments and to implement various measures strictly.

In the "Opinions on Strengthening the Protection of the Ecological Environment in All Aspects and Firmly Winning the Battle of the Preventing and Controlling Environmental Pollution" promulgated in June 2018, the guiding ideology, mission and objective of strengthening the protection of the ecological environment in all aspects, and firmly winning the battle of the preventing and controlling environmental pollution have been deployed and requested uniformly. The overall targets and requirements indicate that the quality of ecological environment on the whole will be improved by 2020, with a significant reduction in emissions of key pollutants.

業務回顧

中國目前是世界第二大經濟大國。目前,我國的 能源構成依然以煤炭消費為主,該結構決定了我 國的大氣污染主要以煤煙型污染為主,主要由粉 塵、煙塵、二氧化硫及氮氧化物等污染物造成。 二十一世紀來我國煙(粉)塵、二氧化硫等氣體污 染物排放量總體呈現下降的趨勢,這是由於近年 來國家加強環保力度,嚴格控制氣體污染物排放 量的成果。

二零一八年是黨中央、國務院和省委省政府打贏 藍天保衛戰的開局年。各級各部門按照中央和省 委省政府關於打贏藍天保衛戰決策部署,盡職履 責,協同配合,嚴格落實各項措施。

二零一八年六月,發佈的《中共中央、國務院關於 全面加強生態環境保護,堅決打好污染防治攻堅 戰的意見》,對全面加強生態環境保護,堅決打好 污染防治攻堅戰的指導思想、任務和目標進行了 統一部署和要求。總體目標要求到二零二零年, 生態環境品質總體改善,主要污染物排放總量大 幅減少。

Management Discussion and Analysis

管理層討論及分析

The State Council issued the Notice regarding the "Three-Year Action Plan for Winning the Battle for a Blue Sky" (Guo Fa 2018 No.22) on 27 June 2018, so as to improve the air quality conditions and make every effort to defend blue sky. The action plan aims to reduce the total emissions of major air pollutants and greenhouse gas emissions synergistically, to further reduce the PM2.5 density, lower the number of days of heavy pollution and improve the air quality conditions significantly through three years' unremitting efforts. It is proposed to reduce the PM2.5 concentrations in cities at prefectural level or above, which failed to meet the national standards, by over 18% and the total emissions of sulphur dioxide and nitrogen oxides by over 15% respectively by 2020 as compared with 2015.

With increasingly stringent environmental protection measures, the environmental protection system and equipment which does not meet the requirements and standard must be upgraded and modified immediately, which in turn has given rise to a higher demand for precipitators.

The Group believes that by leveraging on its track record and advanced technologies together with its stable workforce, its ability to secure new projects will be improved. Besides, the Group continues to expand its business and has completed various precipitators-related works in the metallurgy industry in 2018. This laid a solid foundation for the Group to secure orders in the metallurgy industry.

For the Year, the revenue and total comprehensive income of the Group amounted to approximately RMB858.8 million and approximately RMB31.2 million respectively. During the Year, the Group's gross profit amounted to approximately RMB141.2 million, representing a decrease of approximately 29.1% as compared with approximately RMB199.1 million of the corresponding period of last year; and the Group's gross margin decreased by approximately 8.7% from last year to approximately 16.4%. This decrease in the gross profit and gross margin for the Year of the Group was mainly attributable to significant increase in the price of steel, one of the major raw materials of the products produced by the Company, during the Year. 為加快改善環境空氣品質,打贏藍天保衛戰,二 零一八年六月二十七日國務院印發了《打贏藍天 保衛戰三年行動計劃》的通知(國發〔2018〕22 號)。行動計劃的目標是:經過3年努力,大幅減少 主要大氣污染物排放總量,協同減少溫室氣體排 放,進一步明顯降低細顆粒物濃度,明顯減少重 污染天數,明顯改善環境空氣品質等。提出到二 零二零年,PM2.5未達標地級及以上城市濃度比 二零一五年下降18%以上,二氧化硫、氮氧化物 排放總量分別比二零一五年下降15%以上等具體 指標。

在日趨嚴格的環保措施下,尚未符合要求及標準 的環保系統及設備勢必加快更新改造,催生出更 大的除塵設備需求。

本集團相信,本集團憑著以往的業績與先進的技 術,加上穩定的勞動力,有助增加本集團爭取新 項目的能力。另外本集團在二零一八年繼續拓展 在冶金行業的業務並完成了冶金行業大量的除塵 器工作,為在冶金行業拿到訂單奠定了結實的基 礎。

本年度,本集團的收益及全面收入總額分別為約 人民幣858.8百萬元及約人民幣31.2百萬元。本年 度,本集團毛利較去年同期的約人民幣199.1百萬 元減少約29.1%至約人民幣141.2百萬元和本集團 毛利率較去年減少約8.7%至約16.4%。本集團的 年內毛利及毛利率減少的主要由於鋼鐵(本公司 生產的產品的一項主要原材料)價格於本年度大 幅上漲所致。

Management Discussion and Analysis 管理層討論及分析

For the Year, the value of the Group's new contracts (which represents the aggregate value of the contracts it entered into during a specified period) was approximately RMB981 million. As at 31 December 2018, the Group's backlog (including applicable value-added tax) (which represents the total estimated contract value of work that remains to be completed pursuant to outstanding contracts as of a certain date and assuming performance in accordance with the terms of the contract) was approximately RMB1,908 million.

The Group's profit before tax for the Year decreased to approximately RMB46.4 million and profits attributable to owners of the Company decreased to approximately RMB31.2 million, representing a year-on-year decrease of approximately 59.5% and approximately 62.4% respectively. The aforesaid downturn is mainly due to the decrease in the gross profit and government grants to approximately RMB141.2 million and approximately RMB2.1 million for the Year respectively.

At the time of raising the amount of product sales, the Group spent great effort in enhancing cost management to make its products and solutions more cost competitive. The atmospheric pollution control solutions offered by the Group mainly comprise the atmospheric pollution control devices designed and manufactured on its own. The Group possesses the qualifications and expertise in manufacture and supply of the key atmospheric pollution control system of the projects it undertakes based on customised design proposals. The Group is dedicated to improving its manufacturing process and management system by managing the product quality and operation, reducing energy consumption and assessing the environmental impact in accordance with international standards. The quantitative management, environmental management and quality management systems of the Group were awarded with a number of ISO certificates. These systems help the company in estimating costs, smoothening project operations and improving operating efficiency.

本年度,本集團新合同的價值(即本集團於特定 期間訂立的合同總值)約為人民幣981百萬元。於 二零一八年十二月三十一日,本集團的未完成合 同額(包括適用增值税)(指根據截至某一特定 日期的未完成合同得出的有待完成工程的估計合 同總值及根據合同條款作出的假設表現)約為人 民幣1,908百萬元。

本集團於本年度的税前溢利減少至約人民幣46.4 百萬元,而本公司擁有人應佔溢利則減少至約 人民幣31.2百萬元,分別按年減少約59.5%及約 62.4%。上述減幅主要由於本年度的毛利和政府 補助分別減少至約人民幣141.2百萬元和約人民幣 2.1百萬元所致。

As at 31 December 2018, the Group had 37 registered patents (including 3 invention patents and 34 utility model patents) in the PRC. Based on its strong design and engineering capabilities, the Group primarily provides comprehensive atmospheric pollution control solutions to its customers. The Group offers a wide range of models of electrostatic precipitators which support electricity generators with capacity spanning from 6.25MW to over 1,000MW. The Group is one of the few manufacturers in the PRC which provides electrostatic precipitators for single generator unit with capacity of 1,000MW or above.

As at 31 December 2018, the Group maintained a total of 617 full-time employees (2017: 605). The remuneration payable to the Group's employees includes basic wages, bonuses and other staff benefit. The Group conducts periodic performance reviews for the employees and determine their remuneration based on factors including qualifications, contributions, years of experience and performance.

FINANCIAL REVIEW

Revenue

The revenue of the Group amounted to approximately RMB858.8 million for the Year representing an increase of approximately 8.4% from approximately RMB792.2 million of the corresponding period of last year. Revenue generated from sales of environmental protection equipment of the Group amounted to over 98% of its total revenue. Depending on the specifications and requirements of its customers, the Group may provide an integrated set of atmospheric pollution control devices comprising precipitators, desulfurisation system and/or denitrification system, or only provide one type of the said atmospheric pollution control devices on a stand-alone basis towards new installation projects or upgrading or modification projects. The Group's revenue for the Year was mainly generated from sales of electrostatic precipitator and electronstatic-bag composite precipitator. Cost of sales

The Group's costs incurred in sales of environmental protection equipment principally comprise material costs, staff costs, depreciation and overhead costs. The Group's major raw materials used in the manufacturing process of ash removal and transfer devices and desulfurisation and denitrification devices are steel, electrical instruments, filter bags and others.

The cost of sales of the Group amounted to approximately RMB717.6 million for the Year representing an increase of approximately 21.0% from approximately RMB593.1 million of the corresponding period of last year.

The Group's gross profit of the Year amounted to approximately RMB141.2 million, representing a decrease of approximately RMB57.9 million or 29.1% as compared with approximately RMB199.1 million of the corresponding period of last year. The gross margin of the Group decreased to approximately 16.4% for the Year. The decrease was attributable to significant increase in the price of steel, one of the major raw materials of the products produced by the Company, during the Year.

Other income and gains

Other income and gains of the Group during the Year decreased to approximately RMB3.7 million, representing a decrease of approximately 73.6% from approximately RMB14.1 million of the corresponding period of last year. Such decrease is mainly attributable to the following:

- (i) The bank interest income in 2018 decreased by approximately RMB4.5 million from last year to approximately RMB1.2 million; and
- (ii) Compared with last year, the income from Government grants in 2018 decreased by approximately RMB6.6 million.

Selling and distribution expenses

The Group's selling and distribution expenses of the Year amounted to approximately RMB20.7 million, representing a decrease of approximately RMB4.0 million as compared with approximately RMB24.7 million of the corresponding period of last year.

- (i) The travel expenses and business hospitality expenses in 2018 decreased by approximately RMB0.3 million, or approximately 4%, to approximately RMB6.7 million as compared with approximately RMB7.0 million of the corresponding of last year.
- (ii) The bid services expenses in 2018 was approximately RMB1 million. Compared with the corresponding period of last year, the amount for the Year decreased by approximately RMB1.7 million, or 63%, from approximately RMB2.7 million.

Administrative expenses

The administrative expenses of the Group for the Year amounted to approximately RMB71.6 million, representing an increase of approximately 5.3% as compared with approximately RMB68.0 million of the corresponding period of last year, mainly due to:

- the impairment losses in 2018 increased by approximately RMB6.8 million from 2017 to approximately RMB30.6 million, mainly due to the impairment of trade receivables; and
- (ii) the research and development expenses in 2018 decreased by approximately RMB3 million from 2017 to approximately RMB3 million, mainly due to the decrease in the number of technicians employed by the Group and the related efforts in research and development during the Year.

Finance cost

The finance cost of the Year amounted to approximately RMB6.3 million, representing an increase of 7.9% as compared with approximately RMB5.8 million of the corresponding period of last year.

Income tax expense

The Group's income tax expense of the Year amounted to approximately RMB15.2 million, representing a decrease of 51.6% as compared with approximately RMB31.3 million of the corresponding period of last year.

Trade and bills receivables

As at 31 December 2018, the trade and bills receivables of the Group were approximately RMB653.6 million, increased by approximately RMB34.3 million as compared to approximately RMB619.3 million of the corresponding period of last year, mainly due to (i) the acceleration in the launch of projects, as well as (ii) growth of revenue from continuing operations.

Inventories

As at 31 December 2018, the Group experienced a decrease of inventories by approximately RMB146.6 million to approximately RMB324.3 million when compared to approximately RMB470.9 million of the corresponding period of last year. The inventories mainly consisted of steels, filter bags, electrical instruments and other components.

Liquidity and capital resources

Cash and cash equivalents

As at 31 December 2018, the cash and cash equivalents of the Group decreased by approximately RMB31.3 million to approximately RMB16.4 million when compared to approximately RMB47.7 million of the corresponding period of last year, which was mainly due to:

- the net cash outflow of approximately RMB1.0 million used in financing activities, which mainly consists of the cash outflow of approximately RMB1.0 million on proceeds from bank borrowings and repayments of bank borrowings;
- (ii) the net cash outflow of approximately RMB2.8 million used in investing activities of the Group in the Year, which mainly consists of the cash outflow of approximately RMB1.5 million on purchase of plants and equipment to cater for the expansion of the Group's business scale and the growing sales; and
- (iii) the net cash outflow of approximately RMB27.8 million generated from the operation of the Group in the Year.

As at 31 December 2018, the Group incurred outstanding bank loans of approximately RMB109 million.

Net current assets

As at 31 December 2018, the net current assets of the Group (the difference between total current assets and current liabilities) increased by approximately 5.8% from approximately RMB528.6 million of the corresponding period of last year to approximately RMB559.3 million for the Year.

Capital expenditure

No capital expenditures of the Group were used for the purchase of property, plant and equipment in the Year.

Exchange risk

The Group has transactional currency exposures. Such exposures arise from sales by operating units in currencies other than the functional currencies adopted by the units. Approximately 0.9% (2017: 2.5%) of its sales for the Year were denominated in currencies other than the functional currencies of the operating units making the sale. At present, the Group does not intend to seek to hedge its exposure to foreign exchange fluctuations. However, the Group's management will constantly monitor the economic situation and the foreign exchange risk profile of the Group, and will consider appropriate hedging measures in the future should the need arise.

Major acquisitions and disposals

The Group did not have any material acquisition or disposals during the Year.

Significant investments

The Group did not have any significant investments during the Year.

The Group will actively seek appropriate acquisition projects to expand its capabilities of research and development, manufacturing and sales, as well as to access new markets to complement existing business of the Group.

The Company has now possessed a grade A environmental engineering design (air pollution control project) qualification certificate (甲級環境工程設計專項(大氣污染防治工程)資 質證書) issued by the Ministry of Housing and Urban-Rural Development in the People's Republic of China (中華人民 共和國住房和城鄉建設部), a grade A air pollution control engineering design service capability evaluation certificate (甲級大氣污染治理工程專項設計服務能力評價證書) and a grade A air pollution control main contractor service capability evaluation certificate (甲級大氣污染治理工程總承 包服務能力評價證書) both issued by Zhejiang Environmental Protection Industry Association in the People's Republic of China, which allow the Company to tender for more projects in the future.

The Group believes that its established customer base in the PRC and its exposure to overseas markets could help it lay a solid foundation for future expansion in both domestic and overseas markets of the Group and place it in an ideal position to capture the growth in any of those markets. Looking forward, the Group will continue to enhance its research and development capabilities, develop new technologies and expand our product portfolio (such as ash conveyers), strengthen sales and capture the growing opportunities in the atmospheric pollution control solution industry in the PRC, enhance the Group's national and international brand recognition, as well as develop potential overseas markets to expand its international market share.

BOARD OF DIRECTORS

The Board currently consists of nine members, comprising three executive Directors, three non-executive Directors and three independent non-executive Directors. The powers and duties of the Board include convening Shareholders' meetings and reporting the Board's work at Shareholders' meetings, implementing resolutions passed at Shareholders' meetings, determining the Group's business plans and investment plans, formulating the Group's annual budget and final accounts, formulating proposals for profit distributions and for the increase or reduction of share capital as well as exercising other powers, functions and duties as conferred by the articles of association of the Company ("**Articles of Association**"). Each of the Directors has entered into a service contract/letter of appointment with the Group.

Executive Directors

Mr. BIAN Yu (邊宇) ("Mr. Bian"), aged 35, is the chairman of the Board and an executive Director appointed on 28 December 2009. Mr. Bian was also appointed as general manager of the Company on 15 May 2017. Mr. Bian has approximately 14 years of experience in the business of provision of atmospheric pollution control solutions. Mr. Bian has also been the executive director of various subsidiaries of the Company including Zhuji City Tianjie Installation Engineering Co., Ltd.* (諸暨市天潔安裝工程有限公司) ("**Tianjie Installation Engineering**") and Zhuji City Tianjie Electronic and Technology Co., Ltd.* (諸暨市天潔電子科技有 限公司) and Turpan Environmental Technology Co., Ltd.* (吐 魯番天潔環境科技有限公司) since March 2008, June 2009 and July 2013 respectively.

Mr. Bian has worked as a director of Tengy Group Limited* (天潔集團有限公司)("TGL") since August 2003. He is responsible for the overall strategies, planning and business development of TGL. Particularly, he focuses on the management of the business of the provision of atmospheric pollution control solutions carried on by TGL prior to the establishment of the Company in December 2009. From September 2005 to December 2007, he served in various positions such as general commander and general manager in different departments in the subsidiaries of TGL such as Zhejiang Yaoyu Special Steel Co., Ltd.*(浙江潤 天磁性材料有限公司)("Yaoyu Special Steel"), Zhejiang Tianjie New Materials Co., Ltd.*(浙江天潔新材料有限公司) ("Tianjie New Materials") and Zhejiang Tianjie Magnetic Materials Co., Ltd*.(浙江天潔磁性材料股份有限公司) which were principally engaged in manufacturing, processing and marketing of steel blade and he was mainly responsible for the overall operation and production management.

SUPERVISORY COMMITTEE

The Supervisory Committee consists of three members, with two representatives of Shareholders and one representative of employees. The employee representative Supervisor is elected democratically by the employees representative congress, while Shareholder representative Supervisors are elected by the Shareholders. The term of office of each Supervisor is three years, which is renewable upon re-election and re-appointment. The powers and duties of the Supervisory Committee include reviewing and verifying financial reports, business reports and profit distribution proposals prepared by the Board; and if in doubt, appointing certified public accountants and practicing auditors to re-examine the Company's financial information; monitoring the financial activities of the Company, supervising the performance of the Directors, the president and other senior management members, and monitoring whether they had acted in violation of the laws, regulations and Articles of Association in the performance of their duties; requesting the Directors, the president and senior management members to rectify actions which are detrimental to the Company's interests; and exercising other rights given to them under the Articles of Association. Each of the Supervisors has entered into a service contract/ appointment letter with the Group.

Mr. Bian, an executive Director, the chairman of the Board and the general manager of the Company, is the brother of Ms. Bian Shu (an executive Director) and the son of Mr. Bian Jianguang and the brother-in-law of Mr. Zhang Yuanyuan (both are also non-executive Directors). Save as disclosed herein, there are no other financial, business, family or other material/relevant relationships among the members of the Board.

The Company is committed to the view that the Board should include a balanced composition of executive and non-executive Directors (including independent nonexecutive Directors) so that there is a strong element of independency on the Board, which facilitates the effective exercise of independent judgements in the course of decision-making. The Company is also committed to the view that the independent non-executive Directors should be of sufficient number, calibre and experience for their views to carry weight, and that they should be free of any business or other relationship which could have interfered or potentially interfere, to any material extent, with the exercise of independent judgment for the purpose of assumptions of directorship in the Company.

Mr. Bian is the chairman of the Board, the executive Director and the general manager of the Company, and is responsible for overseeing the strategic planning, policy formulations as well as corporate development of the Group as well as undertaking the principal decision-making role in the supervision and management of the Company's overall operations. The Board meets regularly to consider, discuss and review the major and appropriate issues that pertain to the operations of the Company. As such, the Board considers that sufficient measures have been taken and the vesting of the roles of Board management and the management of day-to-day business of the Company in Mr. Bian will not impair the balance of power and authority. It is believed that the said balance is ensured by the effective management of the Board, of which the structure provides the Group with strong and consistent leadership and allows for a more effective and efficient business planning, decision making as well as execution of long term business strategies.

本公司堅持認為董事會應包括適當比例的執行董 事及非執行董事(包括獨立非執行董事),致使董 事會高度獨立,從而於決策過程中有效作出獨立 判斷。本公司亦堅持認為獨立非執行董事應有足 夠人數、才幹及經驗,以使其意見具有影響力,且 彼等不應牽涉可能已對或潛在會對彼等擔任本公 司董事職務時行使獨立判斷造成重大干擾的任何 業務或其他關係。

邊先生為董事會主席、執行董事兼本公司總經理, 負責監督本集團戰略規劃、策略制定及公司發展, 並於本公司整體營運的監督管理中擔任主要決策 角色。董事會定期會面以考慮、討論及審閱有關 本公司營運的重大及適當事宜。因此,董事會認 為已採取足夠措施,而由邊先生兼任董事會管理 以至本公司日常業務管理的角色,不會削弱權力 及權責平衡。相信董事會的有效管理可確保上述 平衡,其架構為本集團提供穩健而貫徹的領導方 針,並能以更有效及更具效益的方式,作出業務 規劃及決策,以及執行長遠業務策略。

The Board sets the Group's overall objectives and strategies, monitors and evaluates its operating and financial performance and reviews its corporate governance standards. It also decides on matters such as annual and interim results, major transactions, director appointments or re-appointments, investment policies, dividend and accounting policies. The Board has delegated the authority and responsibility for implementing its business strategies and managing the daily operations of the Group's businesses to the executive Directors and the senior management of which the members should report back and obtain prior approval from the Board before making decisions or entering into any commitments for and on behalf of the Group. In compliance with the code provision D3.1 of the CG Code, the functions and powers that have been delegated are reviewed periodically to ensure that they remain appropriate to the needs of the Group.

The Board is also responsible for developing, reviewing and monitoring the policies and practices on corporate governance and legal and regulatory compliance of the Group, and the training and continuous professional development of the Directors and senior management. The Board also reviews the disclosures herein to ensure compliance.

All Board members have separate and independent access to the Group's senior management to fulfill their duties. Independent professional advice can be sought to assist the relevant Directors to discharge their duties at the Group's expense upon their request. Since November 2015, all Directors have been provided with monthly updates on the Company's performance and financial position to enable the Board as a whole and each Director to effectively discharge their duties.

All Directors are required to declare to the Board upon their first appointment of directorships or other positions concurrently held in other companies or organisations. 董事會亦負責制定、檢討及監察本集團的企業管 治政策及常規與遵守法律法規情況,以及董事及 高級管理層的培訓及持續專業發展。董事會亦審 閱本報告內的披露資料,以確保合規。

各董事會成員可分別獨立接觸本集團的高級管理 層,以履行彼等的職責。相關董事亦可要求徵詢 獨立專業意見,以協助彼等履行職責,費用由本 集團承擔。本公司自二零一五年十一月起已每月 向所有董事提供有關本公司表現及財務狀況的最 新資料,以便董事會全體及每名董事有效地履行 其職責。

全體董事須於首次獲委任時向董事會申報彼等同時在其他公司或機構擔任的董事或其他職務,有關利益申報在每年及有需要時更新。

DIRECTORS' CONTINUOUS TRAINING AND PROFESSIONAL DEVELOPMENT

All Directors are aware of their responsibilities to the Shareholders and have exercised their duties with care, skill and diligence, in pursuit of the development of the Group. Every newly appointed Director receives an induction to ensure that he has a proper understanding of the business and operations of the Group and that he is fully aware of his duties and responsibilities as a director under applicable rules and requirements.

In compliance with paragraph A.6.5 of the CG Code, during the Year, the Company, together with its legal adviser, organised training sessions to each of the Directors in relation to continuing obligations of a Hong Kong listed company and its directors. In addition, briefings and updates on the latest development regarding the Listing Rules and other applicable regulatory requirements are provided to each of the Directors during Board meetings to ensure compliance and enhance their awareness of good corporate governance practices.

INDEPENDENCE OF INDEPENDENT NON-EXECUTIVE DIRECTORS

The role of the independent non-executive Directors is to provide independent and objective opinions to the Board, giving adequate control and balances for the Group to protect the overall interests of the shareholders and the Group. They serve actively on the Board and Board Committees to provide their independent and objective views.

In compliance with Rules 3.10 (1) and 3.10A of the Listing Rules, the Company appointed three independent non-executive Directors, representing equal to one-third of the Board. One of the independent non-executive Directors has the appropriate professional qualifications in accounting or related financial management expertise as required by Rule 3.10 (2) of the Listing Rules.

董事持續培訓及專業發展

全體董事均知悉彼等對股東的責任,且於履行彼 等的職責時已傾注其關注、技術及勤勉,致力發 展本集團。每名新任董事均獲提供必要的入職培 訓,確保其對本集團的業務及營運有適當了解, 並充分理解其於適用規則及規定下身為董事的職 責及責任。

為遵守企業管治守則第A.6.5段,於本年度,本公司連同其法律顧問已為各董事舉辦有關香港上市公司及其董事的持續責任的培訓課程。此外,本公司於董事會會議上向各董事提供有關上市規則及其他適用監管規定的簡介及最新發展,以確保董事遵守有關法規,以及加深彼等對良好企業管治常規的認識。

獨立非執行董事的獨立性

獨立非執行董事的角色乃向董事會提供獨立及客 觀的意見,為本集團提供足夠的制約及平衡,以 保障股東及本集團整體利益。彼等於董事會及該 等董事會委員會上積極提供獨立及客觀的意見。

本公司已遵照上市規則第3.10(1)及3.10A條,委任 三名獨立非執行董事,佔董事會人數三分之一。 其中一名獨立非執行董事具備上市規則第3.10(2) 條所規定的適當會計專業資格或相關財務管理專 長。

Each independent non-executive Director has submitted an annual confirmation in writing on his/her independence to the Company for the Year pursuant to Rule 3.13 of the Listing Rules. NON-EXECUTIVE DIRECTORS

The Group has three non-executive Directors, being Mr. Bian Jianguang, Mr. Zhang Yuanyuan and Mr. Chen Jiancheng. At the annual general meeting convened for the year ended 31 December 2015 and held on 1 June 2016, Mr. Bian Jianguang and Mr. Zhang Yuanyuan were re-appointed. Mr. Chen Jiancheng was newly appointed at the extraordinary general meeting held on 5 December 2017.

Details of the biographies of Mr. Bian Jianguang, Mr. Zhang Yuanyuan and Mr. Chen Jiancheng are set out in the section headed "Biographies of Directors, Supervisors and Senior Management" above in this annual report. Directors emoluments for Non-executive Directors are set out in note 8 to the Financial Statements.

BOARD COMMITTEES

The Board is supported by a number of committees, including the Audit Committee, Nomination Committee and Remuneration Committee. Each Board Committee has its defined and written terms of reference approved by the Board covering its duties, powers and functions. Their terms of reference are available on the Company's website.

All Board Committees are provided with sufficient resources to discharge their duties, including access to management or professional advice if considered necessary.

(i) Audit Committee

The Audit Committee was established with terms of reference in compliance with Rule 3.21 of the Listing Rules as well as paragraph C.3 of the CG Code. The Audit Committee consists of three independent non-executive Directors, namely Mr. Fung Kui Kei, Mr. Li Jiannan and Mr. Zhang Bing. Mr. Fung Kui Kei, who has appropriate professional qualifications and experience in accounting matters, was appointed as the chairman of the Audit Committee on 30 March 2018.

The principal responsibilities of the Audit Committee are to assist the Board in providing an independent view of the effectiveness of the financial reporting process, internal control and risk management systems and relationship with external auditor of the Group, oversee the audit process and perform other duties and responsibilities as assigned by the Board. These include reviewing the Group's interim and annual reports.

Pursuant to the meeting of the Audit Committee on 29 March 2019, the Audit Committee has reviewed the consolidated financial statements of the Group for the Year ("**Financial Statements**"), including the accounting principles and practices adopted by the Group, the report prepared by the external auditor covering major findings in the course of the audit, and the selection and appointment of the external auditor. During the Year, two meetings of the Audit Committee were held. The respective attendance records of individual committee members are set out below:

(ii) Remuneration Committee

The Remuneration Committee was established with terms of reference in compliance with Rule 3.25 of the Listing Rules as well as paragraph B.1 of the CG Code. The Remuneration Committee comprises three Directors, namely Mr. Li Jiannan (independent non-executive Director), Mr. Zhang Bing (independent non-executive Director) and Mr. Chen Jiancheng (non-executive Director). Mr. Li Jiannan is the chairman of the Remuneration Committee.

The principal responsibilities of the Remuneration Committee are to review and make recommendations to the Board on the overall remuneration structure and policy for all Directors and senior management as well as the specific remuneration packages for the executive Directors and senior management and on the establishment of a formal and transparent process for developing such remuneration policy. No Director takes part in any discussion on his own remuneration. The Company's objective for its remuneration policy is to maintain fair and competitive packages based on business requirements and industry practice. In order to determine the level of remuneration and fees paid to the members of the Board, market rates and factors such as each Director's workload, performance, responsibility, job complexity and the Group's performance are taken into account.

Pursuant to the meeting of the Remuneration Committee on 29 March 2019, the Remuneration Committee reviewed the remuneration policy and structure relating to, as well as the respective service contracts/letters of appointment of, the Directors and senior management of the Company.

It is also responsible for considering and recommending to the Board any suitably qualified person to become a member of the Board, monitoring the succession planning of Directors and assessing the independence of independent non-executive Directors. The Nomination Committee also gives consideration to the board diversity policy adopted by the Board in March 2015 ("Board Diversity Policy") when identifying suitably gualified candidates to become the members of the Board, and the Board reviews the Board Diversity Policy, so as to develop and review measurable objectives for the implementation of the same and to monitor the progress on achieving these objectives.

The Nomination Committee shall, in accordance with provisions of the relevant laws and regulations and the Articles of Association, take into account the practical situations of the Company, consider the selection criteria, selection procedures and terms of office of the Directors, and record and submit the resolutions to the Board for approval. Selection of candidates is based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision is based on merit and contribution that the selected candidates is expected to bring to the Board.

SUPERVISORY COMMITTEE

The Supervisory Committee consists of three members. The employee representative Supervisor, namely Mr. Chen Xinhua, was elected by employee representatives, whilst the remaining two Supervisors were elected by the Shareholders. Mr. Chen Xinhua entered into a service contract with the Company on 1 January 2016, and each of Mr. Fu Jun and Mr. Fang Zhiguo signed a letter of appointment on 1 June 2016. Pursuant to the Articles of Association, the term of office of the Supervisors shall be three years. The functions and duties of the Supervisory Committee include, but are not limited to, reviewing and verifying financial reports and, if in doubt, appointing certified public accountant and practicing auditor to reexamine the Company's financial information; monitoring the business activities of the Company; supervising the performance of the Directors, the chairman of the Board and other senior management members, and monitoring whether they had acted in violation of the laws, regulations and Articles of Association in the performance of their duties; requesting the Directors, the chairman of the Board and senior management members to rectify actions which damage the Company's interests; and exercising other rights given to them under the Articles of Association.

During the Year, the joint company secretaries of the Company complied with the relevant professional training requirement under Rule 3.29 of the Listing Rules. The biographical details of each of the said joint company secretaries are set out in the section headed "Biographies of Directors, Supervisors and Senior Management" above in this annual report.

FINANCIAL REPORTING AND INTERNAL CONTROL

Financial reporting

The Board acknowledges its responsibility to prepare the Financial Statements which give a true and fair view of the Group's state of affairs, results and cash flows for the Year and in accordance with the Hong Kong Financial Reporting Standards issued by the HKICPA, and the disclosure requirements under the Companies Ordinance (Cap. 622 of the Laws of Hong Kong). The Company selected appropriate accounting policies and applied them consistently based on prudent and reasonable judgments and estimates. The Board considers that the Group has adequate resources to continue in business for the foreseeable future and is not aware of any material uncertainties relating to any events or conditions that may affect the business of the Group or cast doubts on its ability to continue as a going concern.

The responsibilities of Zhonghui Anda CPA Limited, the Company's external auditor, with respect to financial reporting are set out in the section headed "Independent Auditors' Report" below in this annual report.

INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for the establishment and development of the internal control and risk management framework, as well as the regular review of the internal control procedures and policies and risk management practices of the Group. The Audit Committee is responsible for advising on and overseeing the internal control and risk management issues, and assuming an active role in communicating the best practice in the aforesaid issues to the Directors and senior management of the Group. The senior management members are responsible for the execution of internal control policies and procedures as well as risk assessment practices implemented by the Group. Amid the Group's set-up of its internal audit department, the CFO and the joint company secretaries of the Group are currently carrying out the internal audit function and assisting the Board and senior management to review, maintain and advise on the internal control and risk management framework and the implementation of the relevant policies, procedures and practices of the Group.

本公司外聘核數師中匯安達會計師事務所有限公司就財務報告所承擔的責任,載於本年報下文「獨 立核數師報告」一節。

內部監控及風險管理

董事會負責建立及制訂內部監控及風險管理框 架,並定期檢討本集團的內部監控程序及政策以 及風險管理常規。審核委員會負責就內部監控及 風險管理問題提出建議並進行監察,並積極就上 述問題的最佳常規與董事及本集團高級管理層成員負責執行本集團採納的內部 監控政策及程序以及風險評估常規。在本集團設 立其內部審計部門的期間,本集團財務總監及聯 席公司秘書目前正肩負內部審計職能,協助董事 會及高級管理層檢討及維護本集團內部監控及風 險管理框架、相關政策及程序以及常規的實施, 並就此提出建議。

The Group's risk management practices are to manage the risks that it internally and externally encounters. With the assistance of the whistle blowing policies to be adhered to by all staff, the Group's risks could be kept at a manageable level.

During the Year, the Board or its representatives conducted a regular walk-through examination on internal controls and risk management throughout the Group, including analysing the internal control and risk management system as a whole, interviewing and discussing with managers on issues in which their respective departments were involved, assessing on the effectiveness of policies, procedures and practices, and taking advices from the joint company secretaries and CFO.

The Company has plans for submission of an application for listing of its Shares on the Shanghai Stock Exchange and, for such purpose, an external consultant was engaged during the Year to review the internal control and risk management framework. During the said review, the overall internal control and risk management framework were assessed, with several recommendations made to the Board and senior management.

The Board also carried out an annual review of the enhanced internal control policies and procedures as well as risk management practices of the Group in accordance with paragraph C.2.1 of the CG Code, including financial, operational and compliance controls as well as risk management functions of the Group. During the Year, the Board reviewed the effectiveness of the Group's internal control policies and procedures as well as risk management practices, and considered that they are adequate and effective.

Zhonghui Anda CPA Limited was appointed as the external auditor of the Company on 5 December 2017. During the Year, the fees period to Zhonghui Anda CPA Limited in respect of its annual audit services provided to the Group was approximately HK\$1.16 million.

There was no disagreement between the Board and the Audit Committee on the selection and appointment of the external auditor during the Year.

COMMUNICATION WITH SHAREHOLDERS AND SHAREHOLDERS' RIGHTS

The Company aims to, by virtue of its corporate governance structure, enable all Shareholders an equal opportunity to exercise their rights in an informed manner and allow them to engage actively with the Company. Under the Articles of Association, the shareholder communication policy and other relevant internal procedures of the Company, the Shareholders enjoy, among others, the following rights:

(i) Participation in general meetings

The general meetings of the Company provide an opportunity for direct communication between the Board and the Shareholders. The Company encourages the participation of the shareholders through annual general meetings and other general meetings where the Shareholders meet and exchange views with the Board, and to exercise their right to vote at meetings. The Company shall arrange notices of meetings and circulars containing details on proposed resolutions to be sent to the shareholders no less than 45 days before the meeting. At general meetings, separate resolutions are proposed on each substantial issue, including the election of individual Directors.

(i) 參加股東大會

本公司的股東大會為董事會與股東提供直 接溝通機會。本公司鼓勵股東透過出席股東 週年大會及其他股東大會參與本公司事務, 會上股東可與董事會會面及交流意見,並行 使其表決權利。本公司須安排於舉行大會前 不少於45天,向股東發出大會通告及載有提 呈決議案詳情的通函。在股東大會上,各重 大事項(包括選舉個別董事)將會提呈獨立 決議案。

(ii) Enquiries and proposals to the Board

The Company encourages Shareholders to attend Shareholders' meetings and make proposals by either directly raising questions on both operational and governance matters to the Board and Board Committees at the general meetings or providing written notice of such proposals for the attention of the Company secretary at the registered office of the Company in the PRC currently at TENGY Industrial Park, Paitou Town, Zhuji City, Zhejiang Province, The PRC or the principal place of business in Hong Kong at Unit T, 6th Floor, Union Industrial Building, 48 Wong Chuk Hang Road, Wong Chuk Hang, Aberdeen, Hong Kong.

(iii) Convening extraordinary general meetings

Pursuant to the Articles of Association, the Board shall convene an extraordinary general meeting or class meeting within two months where any Shareholder holding, severally or jointly, 10% or more of the Company's issued shares carrying voting rights requests in writing for the convening of an extraordinary general meeting or class meeting. The Shareholders holding, severally or jointly, 10% or more of voting shares at such proposed meeting may request the Board to convene an extraordinary general meeting or class meeting by signing and submitting one or several written requests with the same format and contents and specifying the agenda of the meeting. An extraordinary general meeting or class meeting shall be convened by the Board as soon as practicable upon receipt of the aforesaid written request. The aforesaid shareholding shall be calculated on the basis of the date on which the relevant Shareholders submit the written request. If the Board fails to dispatch a notice of convening such meeting within 30 days upon receipt of the aforesaid written request, the shareholder who proposed to convene the meeting is entitled to propose to the Supervisory Committee to convene a meeting. If the Supervisory Committee has not convened such a meeting for more than 90 days, the Shareholders individually or jointly holding 10% or more of the shares of the Company may convene and hold such a meeting by themselves. The procedures for convening such meeting should follow those for convening a general meeting or class meeting of Shareholders by the Board to the greatest extent practicable.

(iv) Procedures for putting forward proposals at (iv a general meeting

In overseeing and monitoring the business operation of the Company, the Shareholders have the right to put forward proposals and raise inquiries. Shareholders individually or together holding 3% or more of the Company's voting Shares have the right to put up adhoc proposals in writing to the Company ten days before the holding of the general meeting, and the Company shall include such ad-hoc proposals into the agenda for such general meeting.

The contents of the proposals to be raised shall be within the scope of duties of the general meetings. It shall have a clear topic and specific matters to be resolved on, and shall be in compliance with relevant requirements of the laws, administrative regulations and the Articles of Association.

CONSTITUTIONAL DOCUMENTS

In 2018, certain amendments were made to the Articles of Association in connection with the relevant articles of scope of business and shareholders' general meeting to reflect the needs of the Company's development after Listing. These amendments were duly passed by the Shareholders at the extraordinary general meetings of the Company held on 30 March 2018. For details of the amendments to the Articles of Association, please refer to the announcements and circulars of the Company dated 12 February 2018. Save as disclosed above, there was no change in the Articles of Association during the Year.

The Articles of Association are available on the respective websites of the Stock Exchange and the Company.

Reason for entering into the TGL Office Lease Agreement was that the Company commenced the use of the TGL Office Building four years ago mainly as its office, and any relocation would cause unnecessary costs and disruption. The annual rental payable by the Company under the TGL Office Lease Agreement was determined on normal commercial terms with reference to, and was reviewed by professional surveyors and valuers independent of the Group to be fair, reasonable and consistent with, the prevailing market rates of similar properties in the locality. Reason for entering into the subject agreement was that the Company commenced the use of the premises under the TGL Office Lease Agreement and the TGL Industrial Lease Agreement four years ago, and such premises are owned by TGL and accordingly the power supply services registered with the relevant power enterprises are in the name of TGL. Payment would be furnished to TGL on a cost basis on 25th day of each calendar month in accordance with the actual amount of electricity consumed by the Company of that particular month, and such consumption amount should be confirmed by both parties to the TGL Power Supply Agreement by jointly inspecting the readings on the relevant meters on 5th day of each calendar month. The amount of total utility payment to TGL for the Year is included in note 32 to the Financial Statements. The Group expects the total utility fees payable to TGL in 2018 under the TGL Power Supply Agreement to be capped at approximately RMB3,800,000.

1. GENERAL INFORMATION

Zhejiang Tengy Environmental Technology Co., Ltd (the "Company") was incorporated in the People's Republic of China (the "PRC") as a joint stock company with limited liability. The address of its registered office is TENGY Industrial Park, Paitou Town, Zhuji City, Zhejiang Province, PRC. The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Company and its subsidiaries (collectively the "Group") were principally engaged in design, development, manufacturing, installation and sale of environmental pollution prevention equipment and electronic products. The principal activities of the Company's subsidiaries are set out in note 34 to the consolidated financial statements.

In the opinion of the directors of the Company (the "Directors"), Tengy Group Limited, a company incorporated in the PRC, is the holding company.

2. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS

In the current year, the Group has adopted all the new and revised Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") that are relevant to its operations and effective for its accounting year beginning on 1 January 2018. HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKAS"); and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group's accounting policies, presentation of the Group's financial statements and amounts reported for the current year and prior years.

1. 一般資料

3. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared in accordance with HKFRSs, issued by the HKICPA and the applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention.

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of key assumptions and estimates. It also requires management to exercise its judgments in the process of applying the accounting policies. The areas involving critical judgments and areas where assumptions and estimates are significant to these consolidated financial statements are disclosed in note 4 to the consolidated financial statements.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill relating to that subsidiary and any related accumulated foreign currency translation reserve.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Foreign currency translation

(a)Functional and presentation currency

> Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Renminbi, which is the Company's functional and presentation currency.

(b) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair values in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

- Income and expenses are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of the net investment in foreign entities and of borrowings are recognised in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are recognised in consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

Property, plant and equipment

Buildings comprise mainly factories and offices. Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their revalued amounts less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

Construction in progress represents buildings under construction and plant and machinery pending installation, and is stated at cost less impairment losses. Depreciation begins when the relevant assets are available for use.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

Intangible assets

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses.

Patents and computer software are stated at cost less accumulated amortisation and impairment losses. Amortisation is calculated on a straight-line basis over their estimated useful lives of 10 years and 3 years respectively.

Operating leases

Leases that do not substantially transfer all the risks and rewards of ownership of assets to the Group are accounted for as operating leases. Lease payments (net of any incentives received from the lessor) are recognised as an expense on a straight-line basis over the lease term.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

Financial assets

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Transaction costs directly attributable to the acquisition of investments at fair value through profit or loss are recognised immediately in profit or loss. 3. 主要會計政策(續)

They are subsequently measured at amortised cost using the effective interest method less loss allowance for expected credit losses.

Loss allowances for expected credit losses

The Group recognises loss allowances for expected credit losses on financial assets at amortised cost and contract assets. Expected credit losses are the weighted average of credit losses with the respective risks of a default occurring as the weights.

At the end of each reporting period, the Group measures the loss allowance for a financial instrument at an amount equal to the expected credit losses that result from all possible default events over the expected life of that financial instrument ("lifetime expected credit losses") for trade receivables and contract assets, or if the credit risk on that financial instrument has increased significantly since initial recognition.

If, at the end of the reporting period, the credit risk on a financial instrument (other than trade receivables and contract assets) has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to the portion of lifetime expected credit losses that represents the expected credit losses that result from default events on that financial instrument that are possible within 12 months after the reporting period.

The amount of expected credit losses or reversal to adjust the loss allowance at the end of the reporting period to the required amount is recognised in profit or loss as an impairment gain or loss.

Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value. Bank overdrafts which are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents.

Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

Trade and other pavables

Trade and other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Revenue from contracts with customers

Revenue is measured based on the consideration specified in a contract with a customer with reference to the customary business practices and excludes amounts collected on behalf of third parties. For a contract where the period between the payment by the customer and the transfer of the promised product or service exceeds one year, the consideration is adjusted for the effect of a significant financing component.

Revenue from contracts with customers (Continued)

The Group recognises revenue when it satisfies a performance obligation by transferring control over a product or service to a customer. Depending on the terms of a contract and the laws that apply to that contract, a performance obligation can be satisfied over time or at a point in time. A performance obligation is satisfied over time if:

- (a)the customer simultaneously receives and consumes the benefits provided by the Group's performance;
- the Group's performance creates or enhances an (b) asset that the customer controls as the asset is created or enhanced; or
- the Group's performance does not create an (c) asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is satisfied over time, revenue is recognised by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the product or service.

Other income

Interest income is recognised on a time-proportion basis using the effective interest method.

Rental income is recognised on a straight-line basis over the lease term.

Employee benefits

(a) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the at the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

Pension obligations (b)

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged in profit or loss represents contributions payable by the Group to the funds.

(C) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs and involves the payment of termination benefits.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Impairment of assets

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets other than investment, inventories and receivables, to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or cashgenerating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cashgenerating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset or cash-generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined (net of amortisation or depreciation) had no impairment loss been recognised for the asset or cash-generating unit in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or nonoccurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

(a) Allowance for slow-moving inventories

Allowance for slow-moving inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/write-back in the period in which such estimate has been changed.

(b) Impairment loss for bad and doubtful debts

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of the trade and other receivables, including the current creditworthiness and the past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debt expenses in the year in which such estimate has been changed.

(c) Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits together with future tax planning strategies. (d) Property, plant and equipment and depreciation

The Group determines the estimated useful lives, residual values and related depreciation charges for the Group's property, plant and equipment. This estimate is based on the historical experience of the actual useful lives and residual values of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives and residual values are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

Additional depreciation is made if the estimated useful lives and/or the residual values of items of property, plant and equipment and investment property are different from the previous estimation. Useful lives and residual values are reviewed at each financial year end date based on changes in circumstances.

5. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the Group entities. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(b) Credit risk

The Group trades only with recognised and creditworthy third parties. Receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. For transactions that are not denominated in the functional currency of the relevant operating unit, the Group does not offer credit terms without the specific approval of the executive directors.

The credit risk of the Group's other financial assets, which comprise cash and cash equivalents, pledged deposits, and other receivables, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

Since the Group trades only with recognised and creditworthy third parties, there is no requirement for collateral. Concentrations of credit risk are managed by analysis by customer/counterparty. There are no significant concentrations of credit risk within the Group as the customer bases of the Group's trade receivables are widely dispersed.

The Group considers whether there has been a significant increase in credit risk of financial assets on an ongoing basis throughout each reporting period by comparing the risk of a default occurring as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forwarding-looking information. Especially the following information is used:

- internal credit rating;
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations;
- actual or expected significant changes in the operating results of the borrower;
- significant changes in the value of the collateral or in the quality of guarantees or credit enhancements; and
- significant changes in the expected performance and behaviour of the borrower, including changes in the payment status of borrowers.

The customers pay the contract prices to the Group according to the payment schedules as stipulated in the contracts within one month. Sales are recognised when control of the products and services have transferred, being when the products are delivered to a customer. If the service rendered by the Group exceeds the payments, a contract asset is recognised. If the payments exceed the service rendered, a contract liability is recognised.

If a contract includes the installation of hardware, revenue for the hardware is recognised at a point in time when the hardware is delivered, the legal title has passed and the customer has accepted the hardware.

The contract price is allocated to the performance obligations based on the relative stand-alone selling prices of the performance obligations. The stand-alone selling prices are determined by applying the expected cost plus a margin approach.

Sales of materials

The Group sells the materials to the customers. The products amount is repayable within one month. Sales are recognised when control of the products has transferred, being when the products are delivered to a customer, there is no unfulfilled obligation that could affect the customer's acceptance of the products and the customer has obtained legal titles to the products.

A receivable is recognised when the products are delivered to the customers as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.
