VOTING RESULTS OF CLASS MEETINGS

The Domestic Share Class Meeting and H Share Class Meeting (collectively “**Class Meetings**”) of Zhaojin Mining Industry Company Limited (the “**Company**”) were held at the conference room at Zhaojin Shunhe Hotel, Zhaoyuan City, Shandong Province, the People’s Republic of China (the “**PRC**”) on Friday, 14 June 2019 at 10:00 a.m. and 10:30 a.m., respectively. The Class Meetings were held in accordance with the requirements of the Company Law of the PRC and the articles of association of the Company (the “**Articles of Association**”).

Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as defined in the circular of the Company dated 26 April 2019.

VOTING RESULTS OF THE DOMESTIC SHARE CLASS MEETING

As at the date of the Domestic Share Class Meeting, the total number of issued Domestic Shares of the Company was 2,171,481,195 Shares. All holders of such Shares are entitled to attend and vote for or against the proposed resolution presented at the Domestic Share Class Meeting. Shareholders of the Company holding an aggregate of 2,171,481,195 Domestic Shares, representing 100% of issued Domestic Shares of the Company, attended the Domestic Share Class Meeting either in person or by proxy. There were no Shares in respect of which their holders were entitled to attend and vote only against any resolution proposed at the Domestic Share Class Meeting. There were no Shares entitling the holder to attend the Domestic Share Class Meeting and abstain from voting in favour as set out in Rule 13.40 of the Listing Rules. The chairman of the Domestic Share Class Meeting demanded voting by way of poll on the proposed resolution as set out in the notice of the Domestic Share Class Meeting dated 26 April 2019. Computershare Hong Kong Investor Services Limited, the H Share registrar and transfer office of the Company, was appointed as the scrutineer at the Domestic Share Class Meeting for the purpose of vote-taking. The proposed resolution was voted by way of a poll according to the Articles of Association and the resolution was duly passed by the attended Domestic Shareholders. There were no Shares in respect of which their holders were entitled to attend and vote only against any resolution proposed at the H Share Class Meeting. There were no Shares entitling the holder to attend the H Share Class Meeting and abstain from voting in favour as set out in Rule 13.40 of the Listing Rules. The chairman of the H Share Class Meeting demanded voting by way of poll on the proposed resolution as set out in the notice of the H Share Class Meeting dated 26 April 2019.
