2. 用途

證券持有人的個人資料可以任何方式被採用、持 有、處理及/或保存,以作下列用途:

- 處理 閣下的申請及退款支票及電子退款指示(如適用)、核實是否符合本申請表格及招股章程載列的條款和申請程序以及公佈香港發售股份的分配結果;
- 遵守香港及其他地區的適用法律及法規;
